**DESCRIPTION**

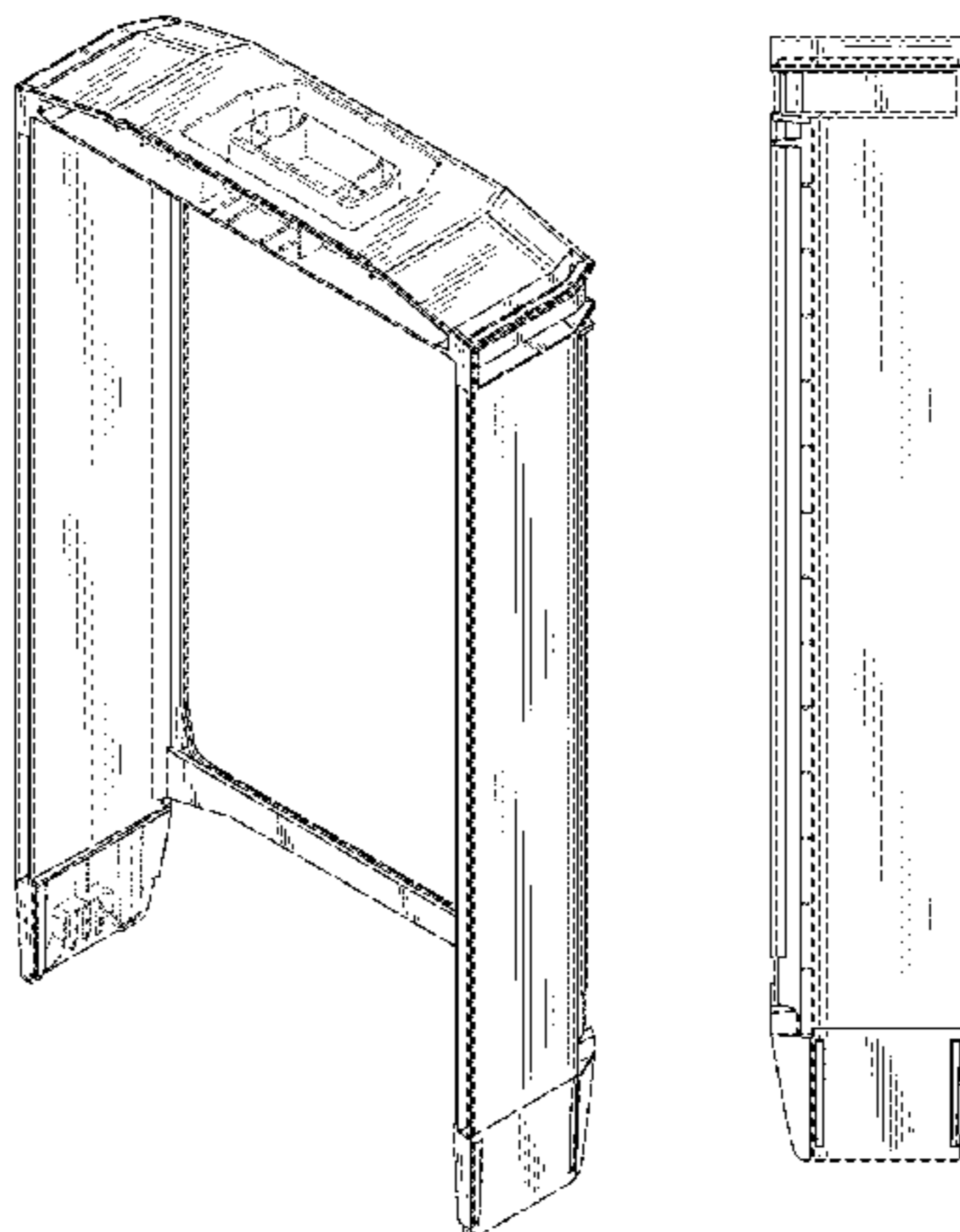
FIG. 1 is a perspective view of a stand as seen from the front, top, and right side;

 The dotted line portions of the drawings represent environmental structure only and form no part of the claimed design.

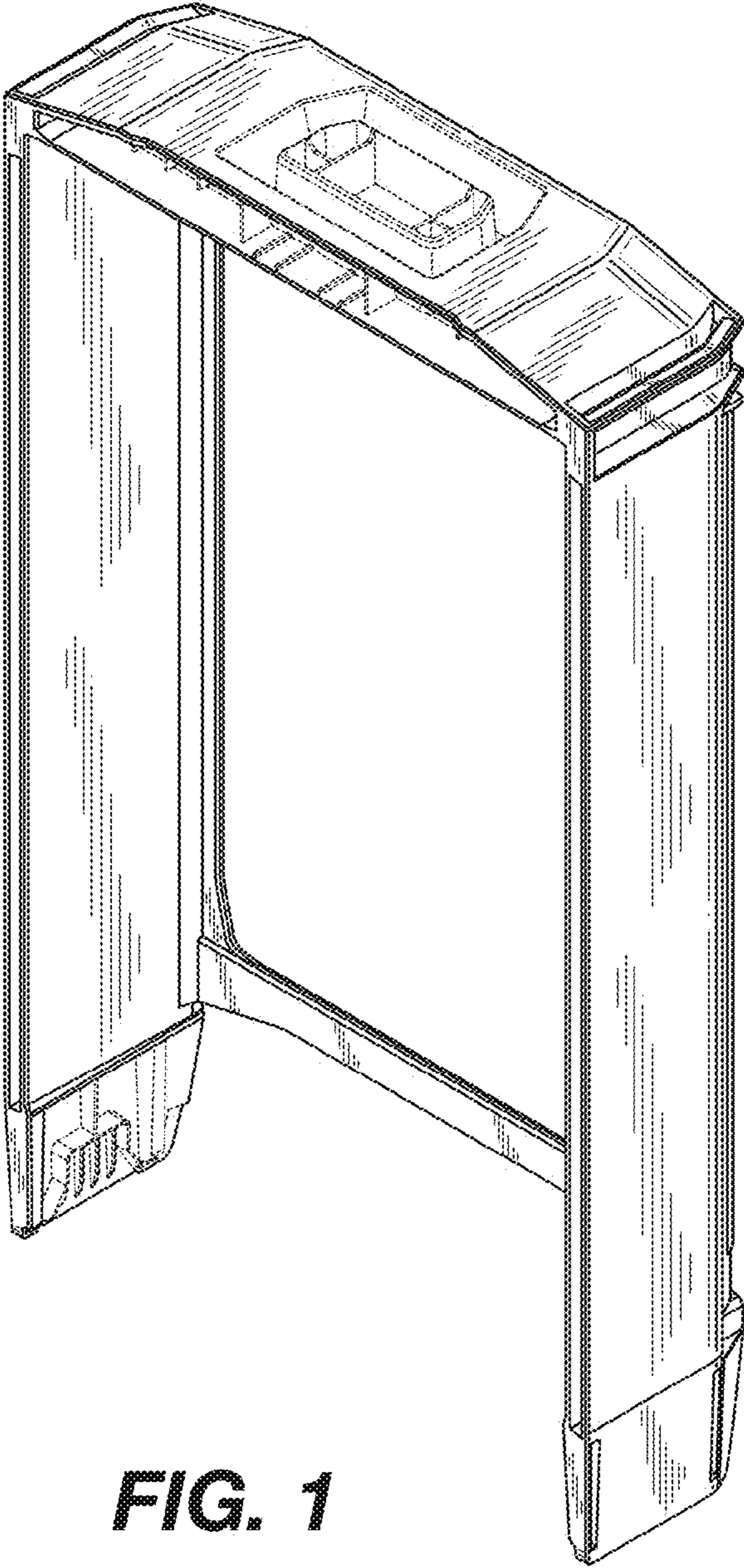

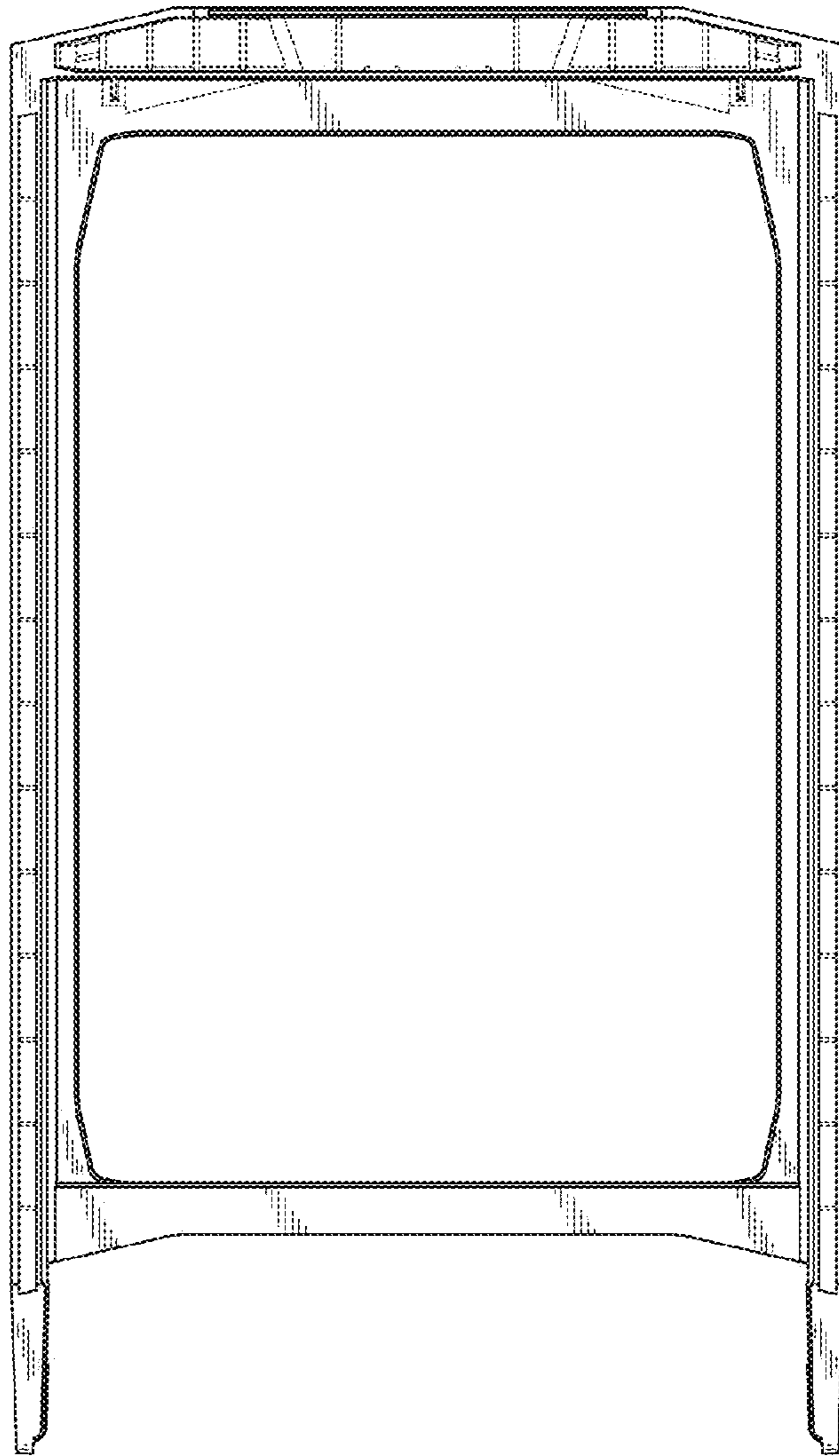

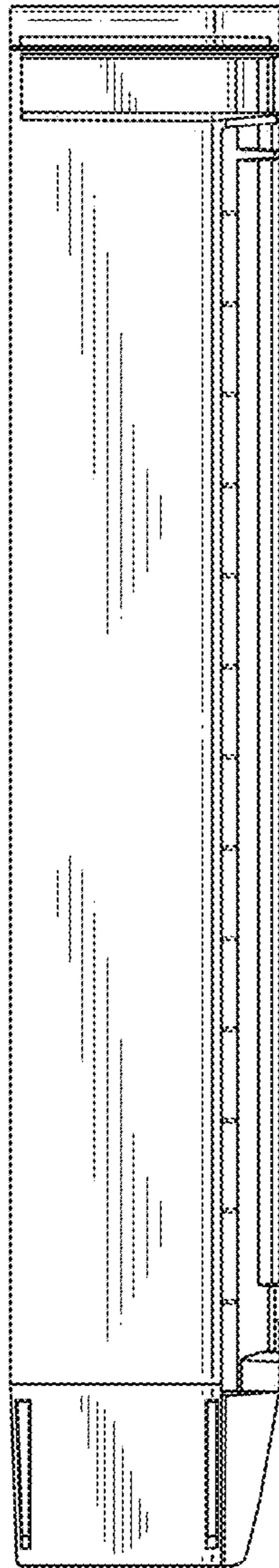




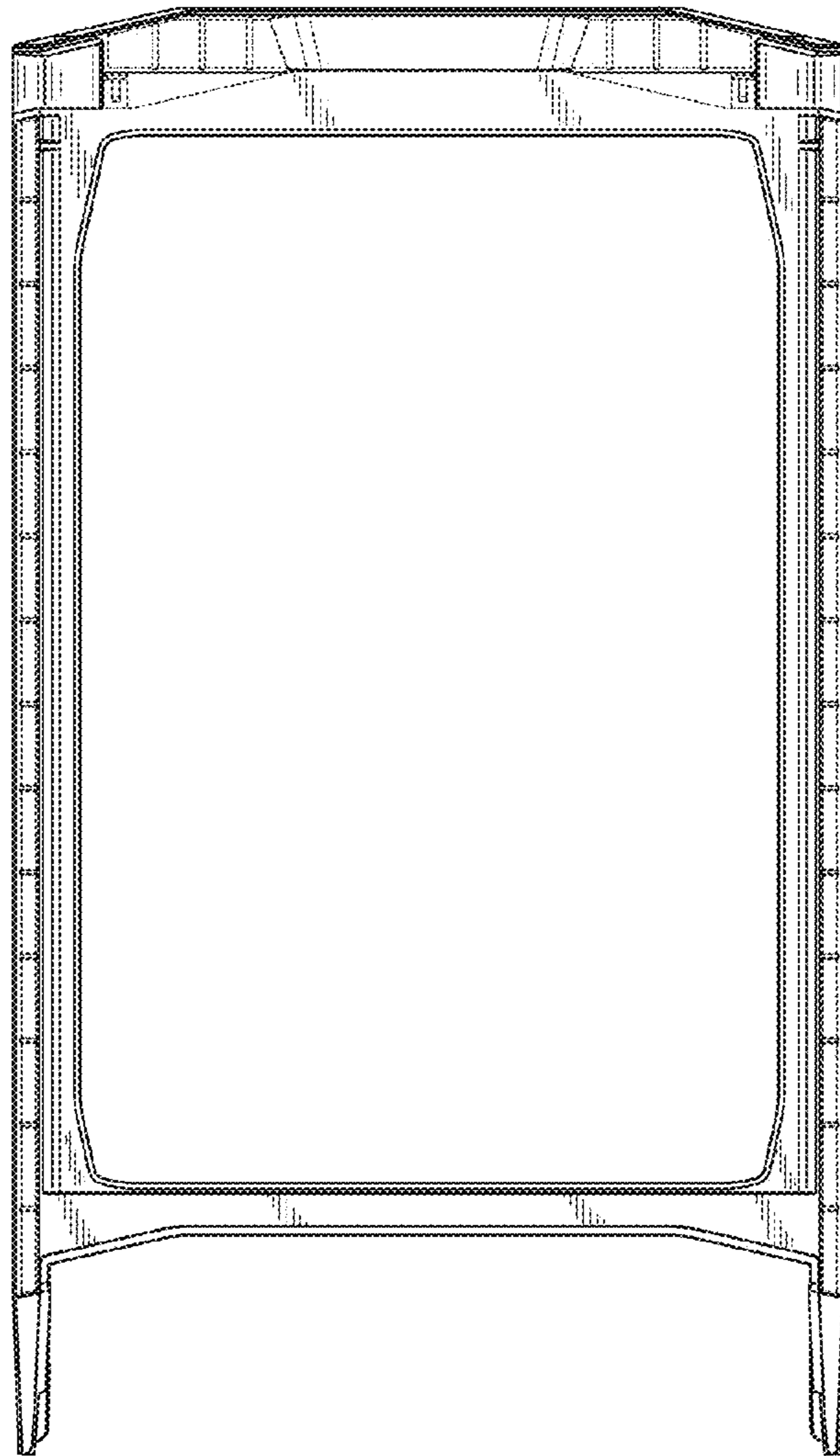

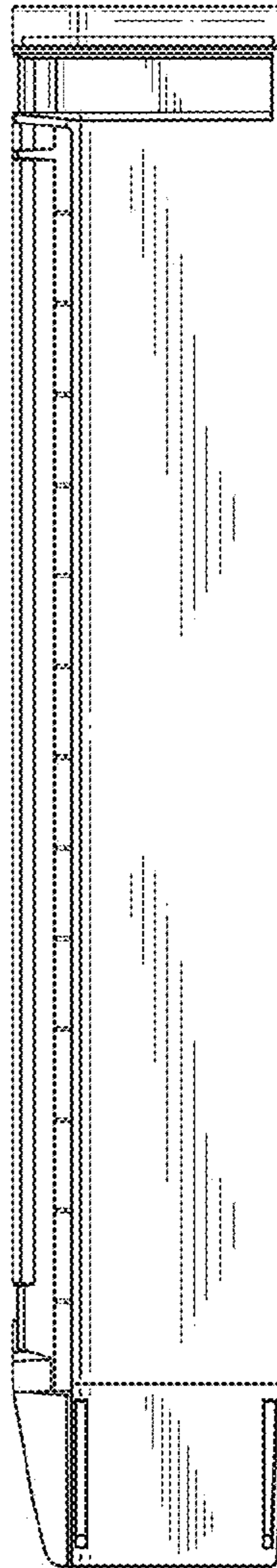

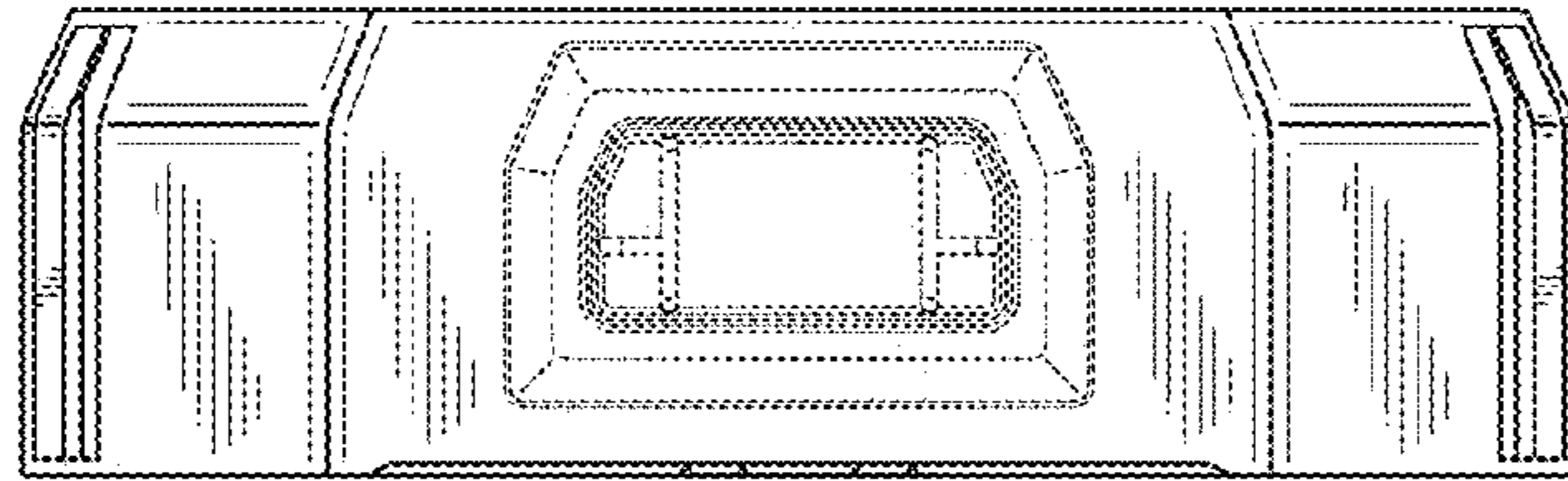

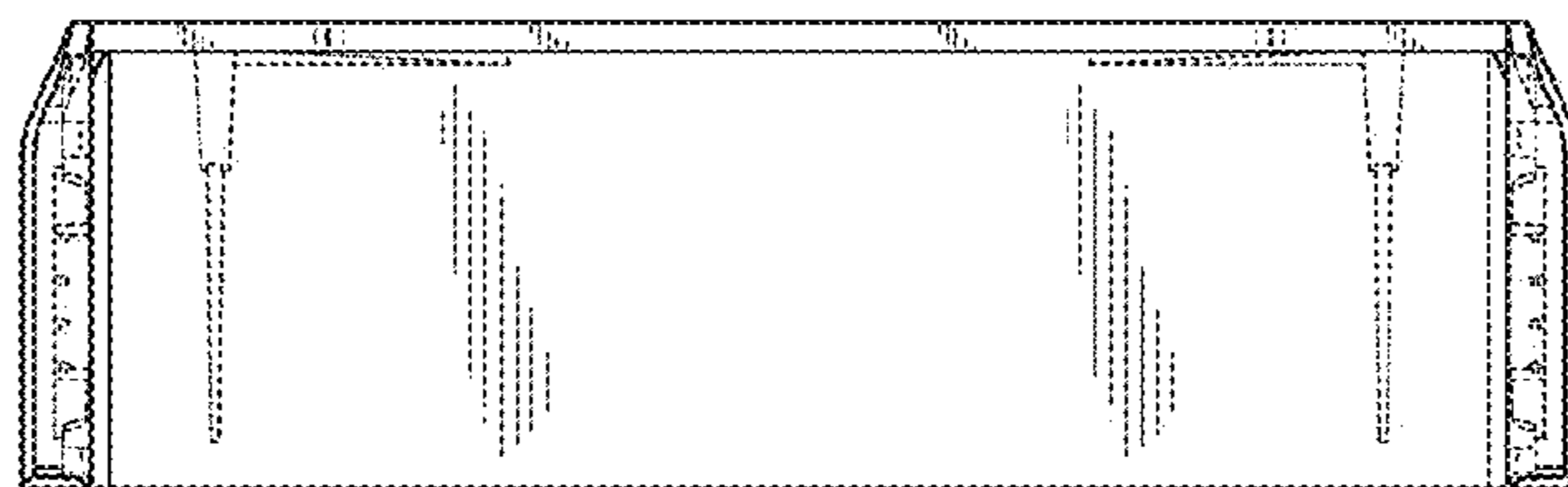
