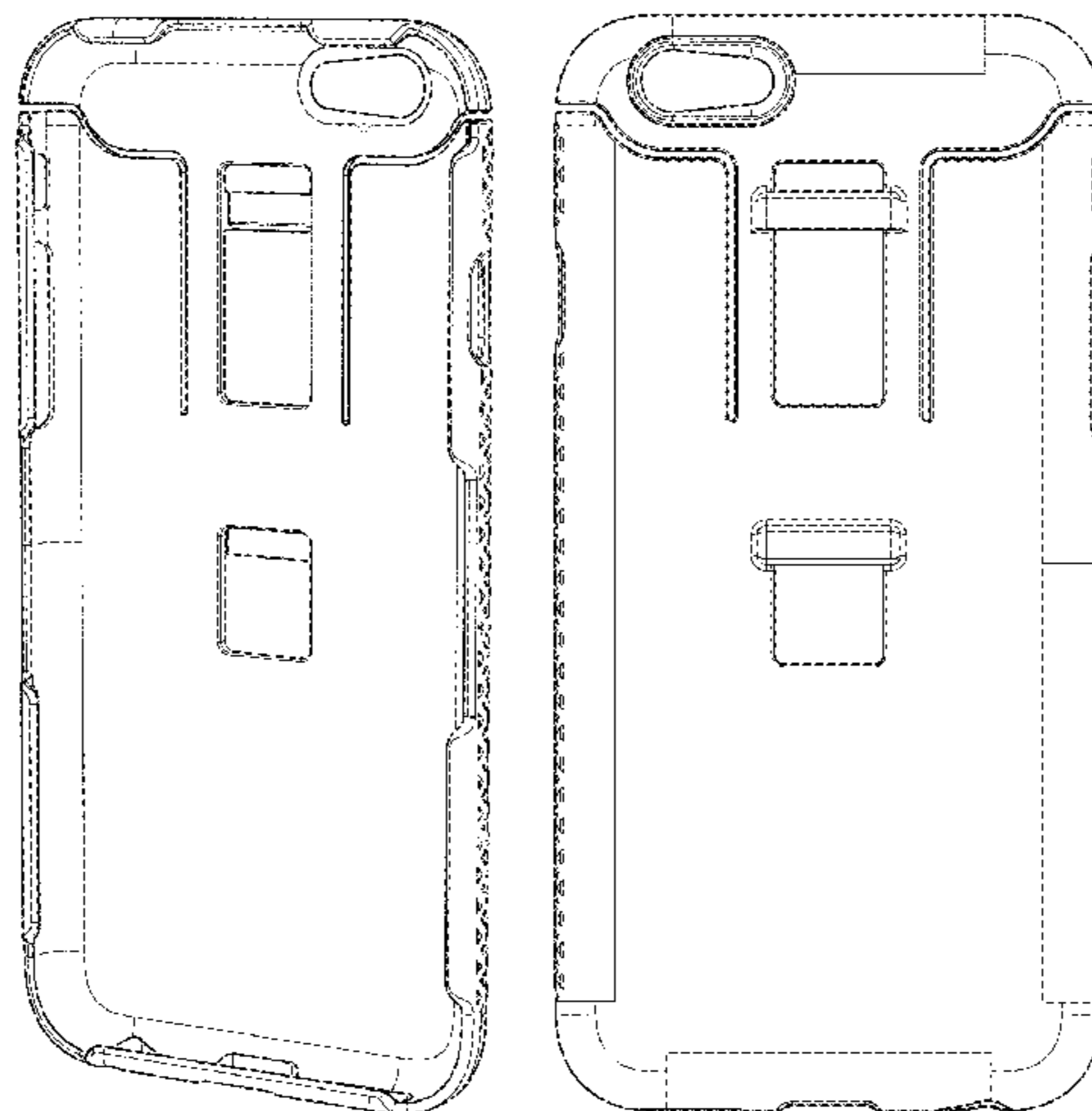
(57) **CLAIM**

The ornamental design for a case for a portable handheld electronic device, as shown and described.

**DESCRIPTION**

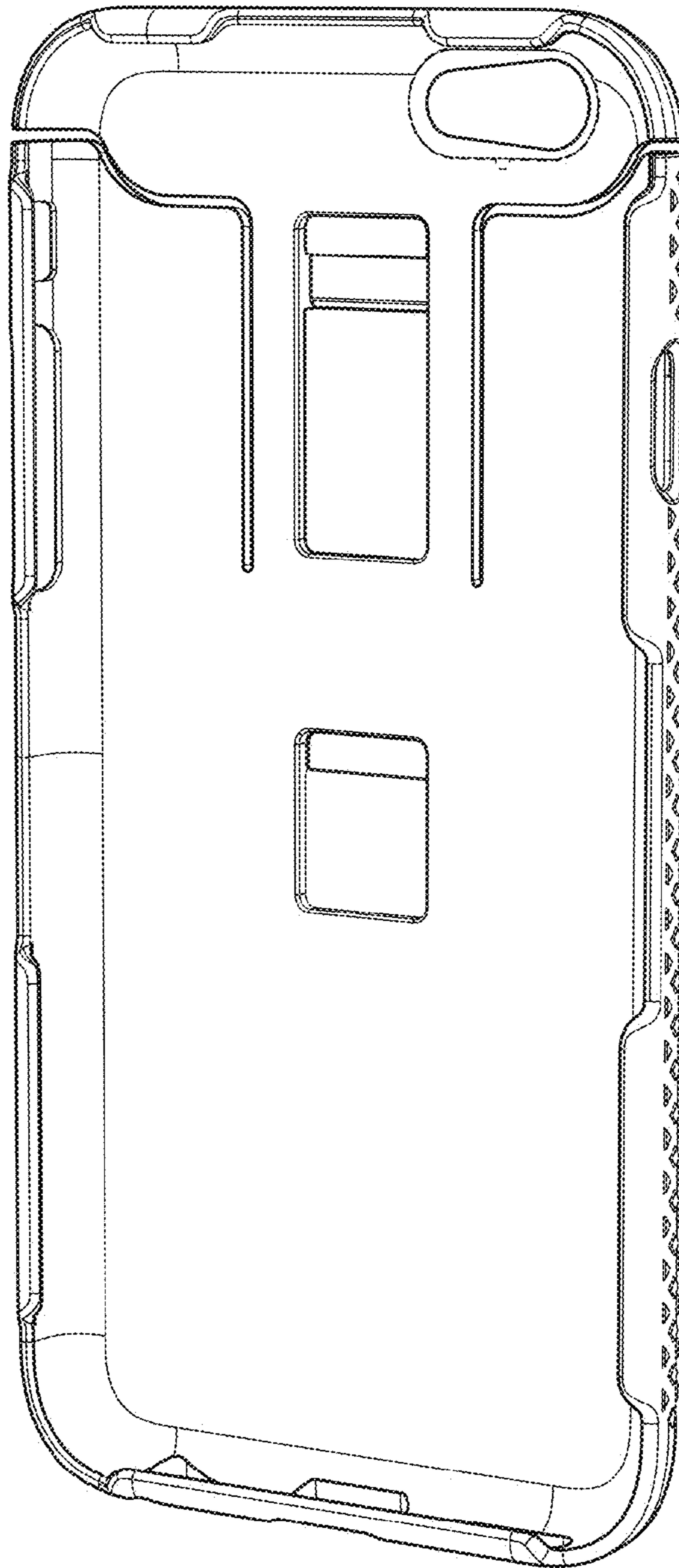

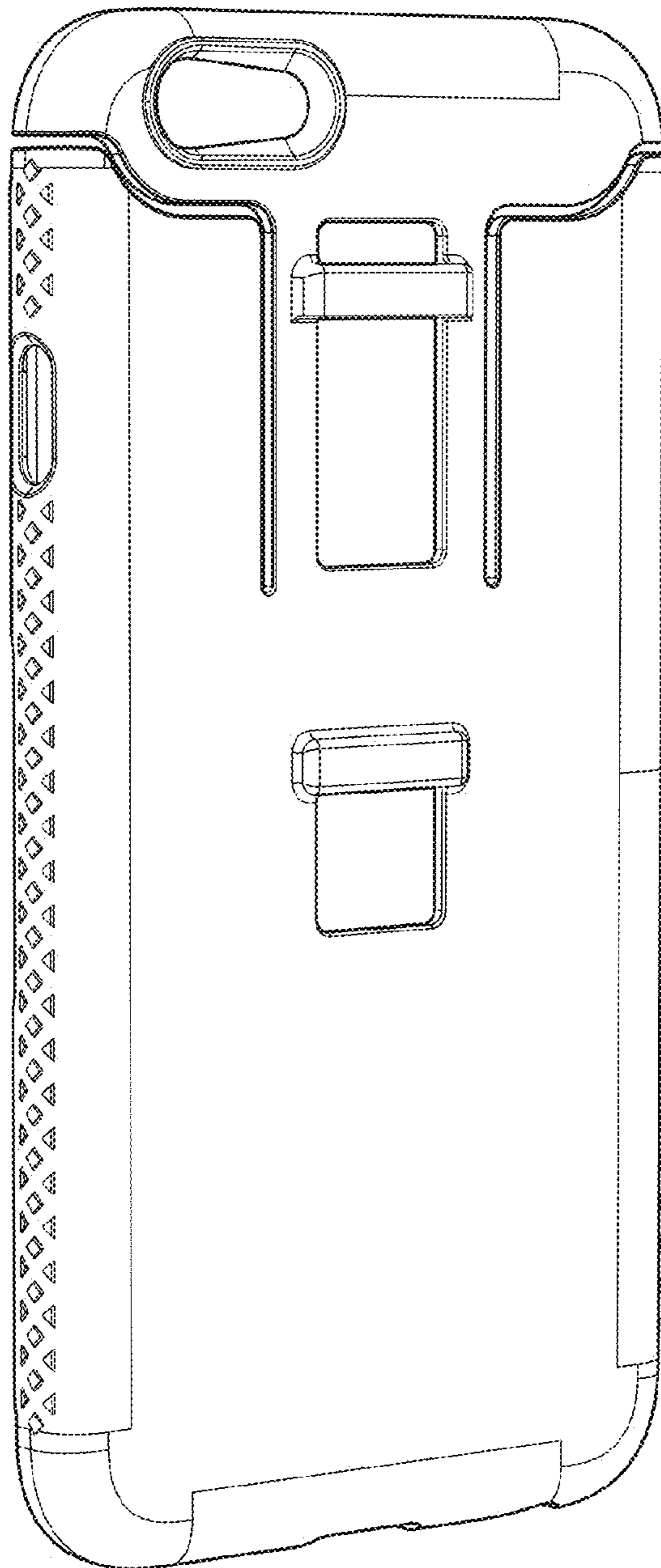

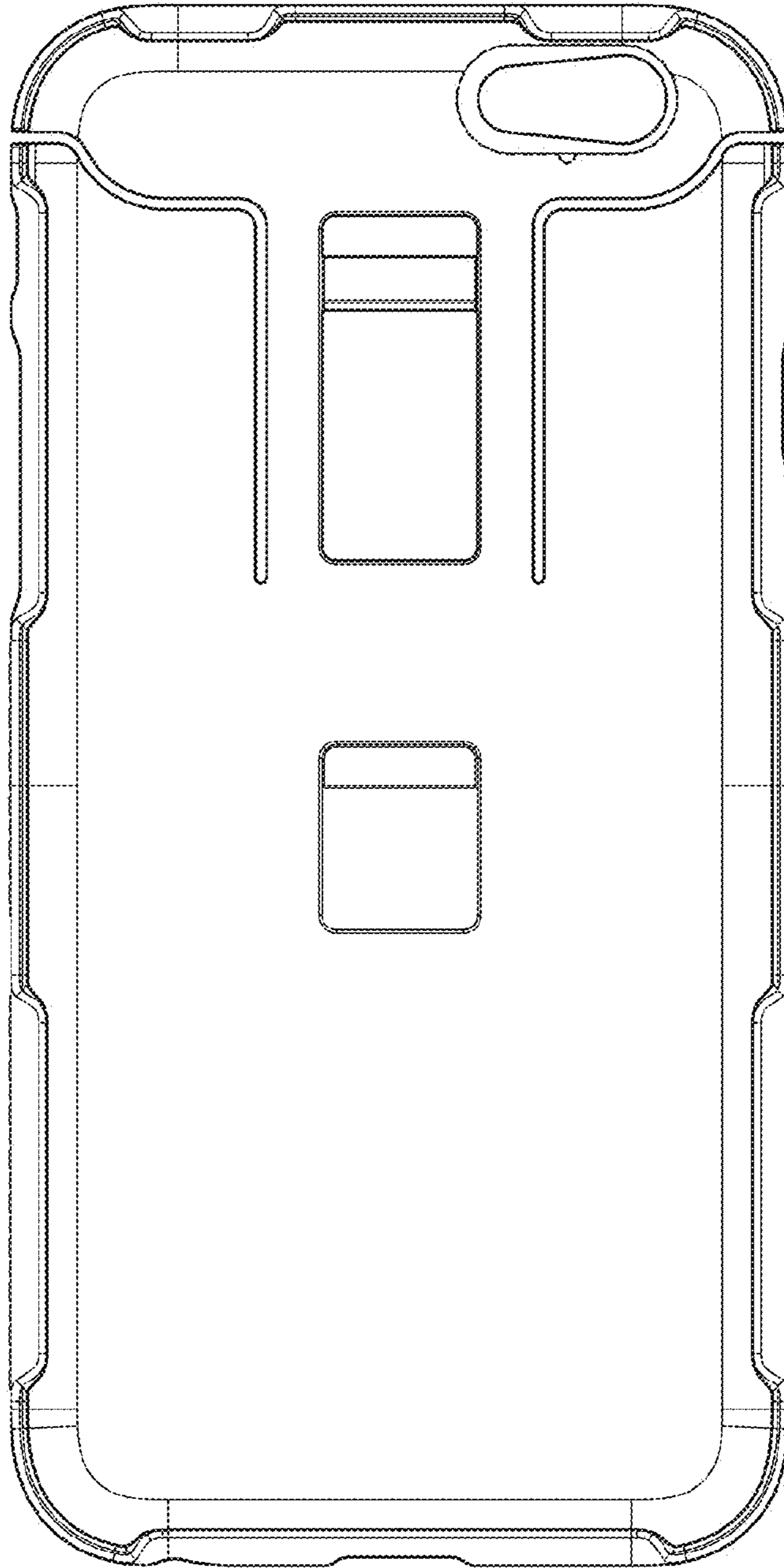

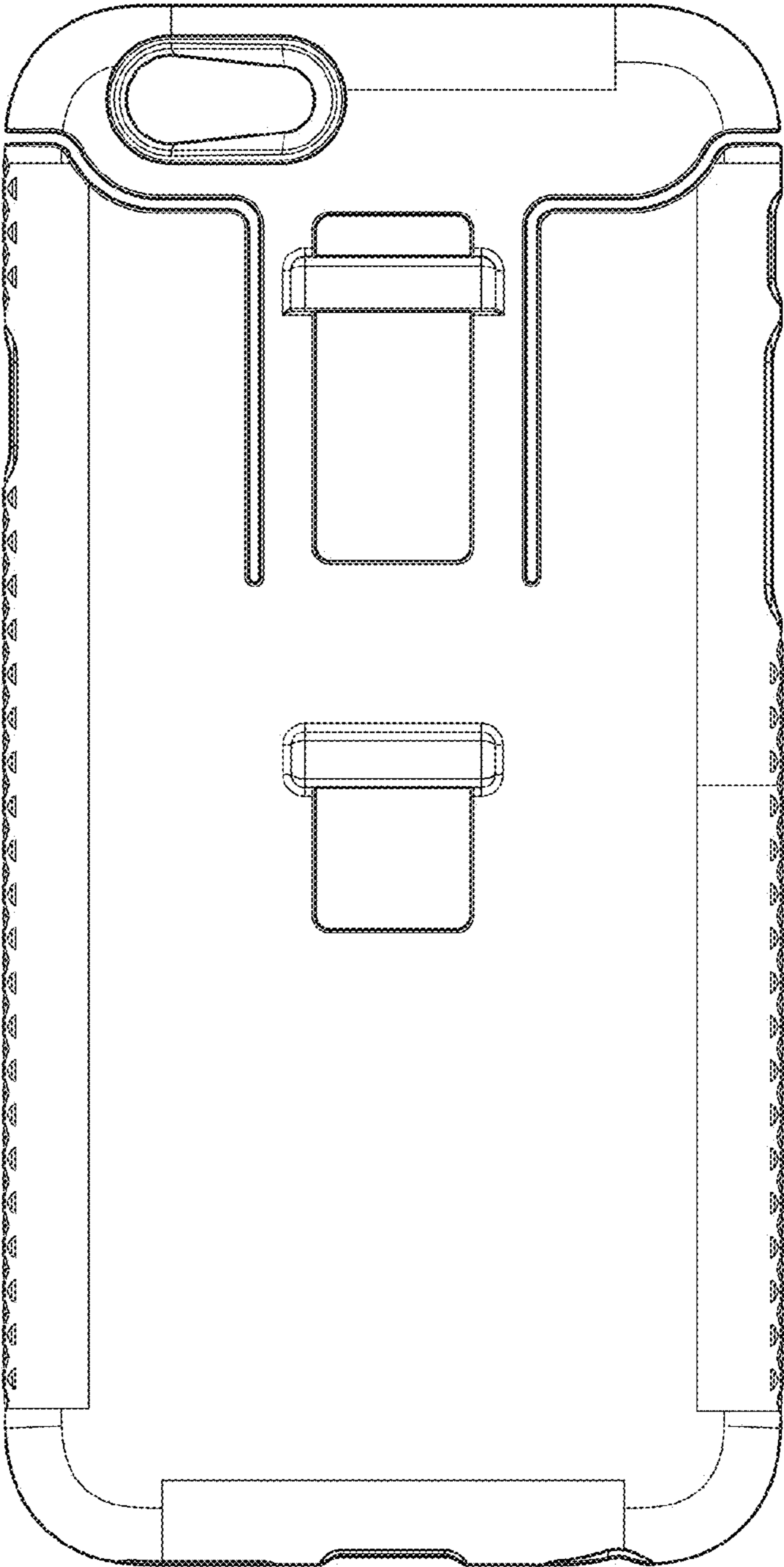

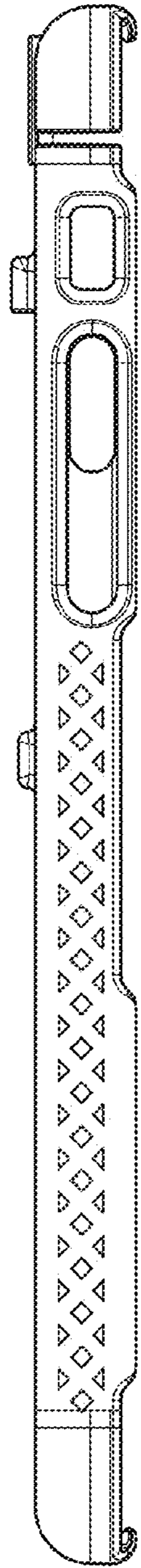
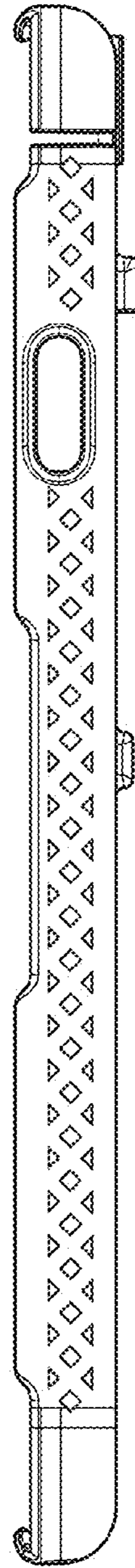
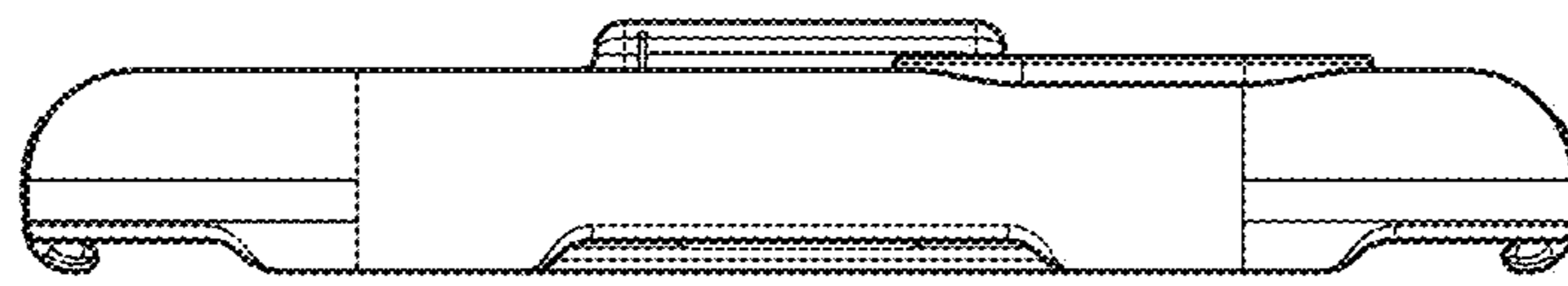
