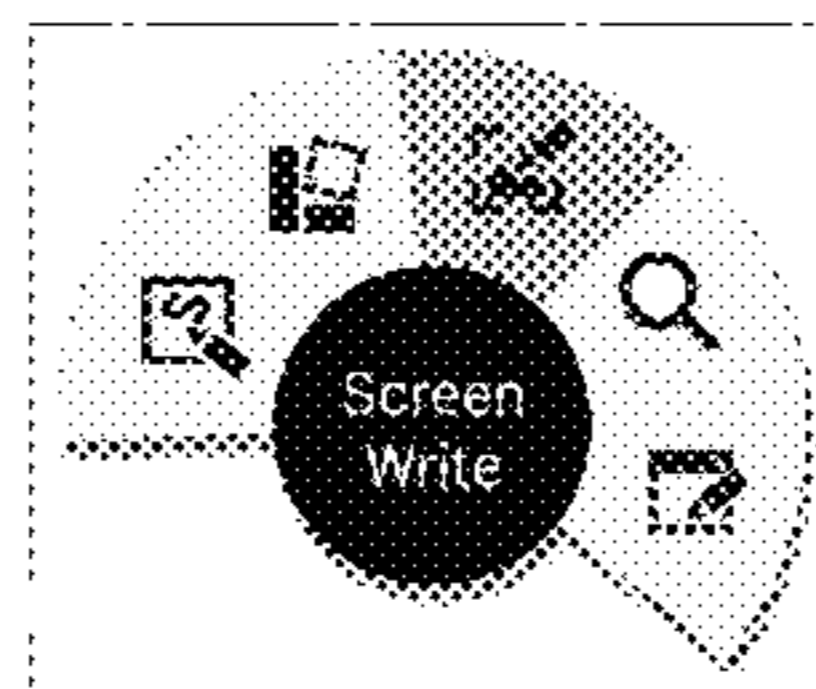
The ornamental design for a display screen or portion thereof with graphical user interface, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of a display screen or portion thereof with graphical user interface, showing our new design; and, FIG. 2 is a front view of a display screen or portion thereof with graphical user interface, showing an alternative embodiment of the new design.

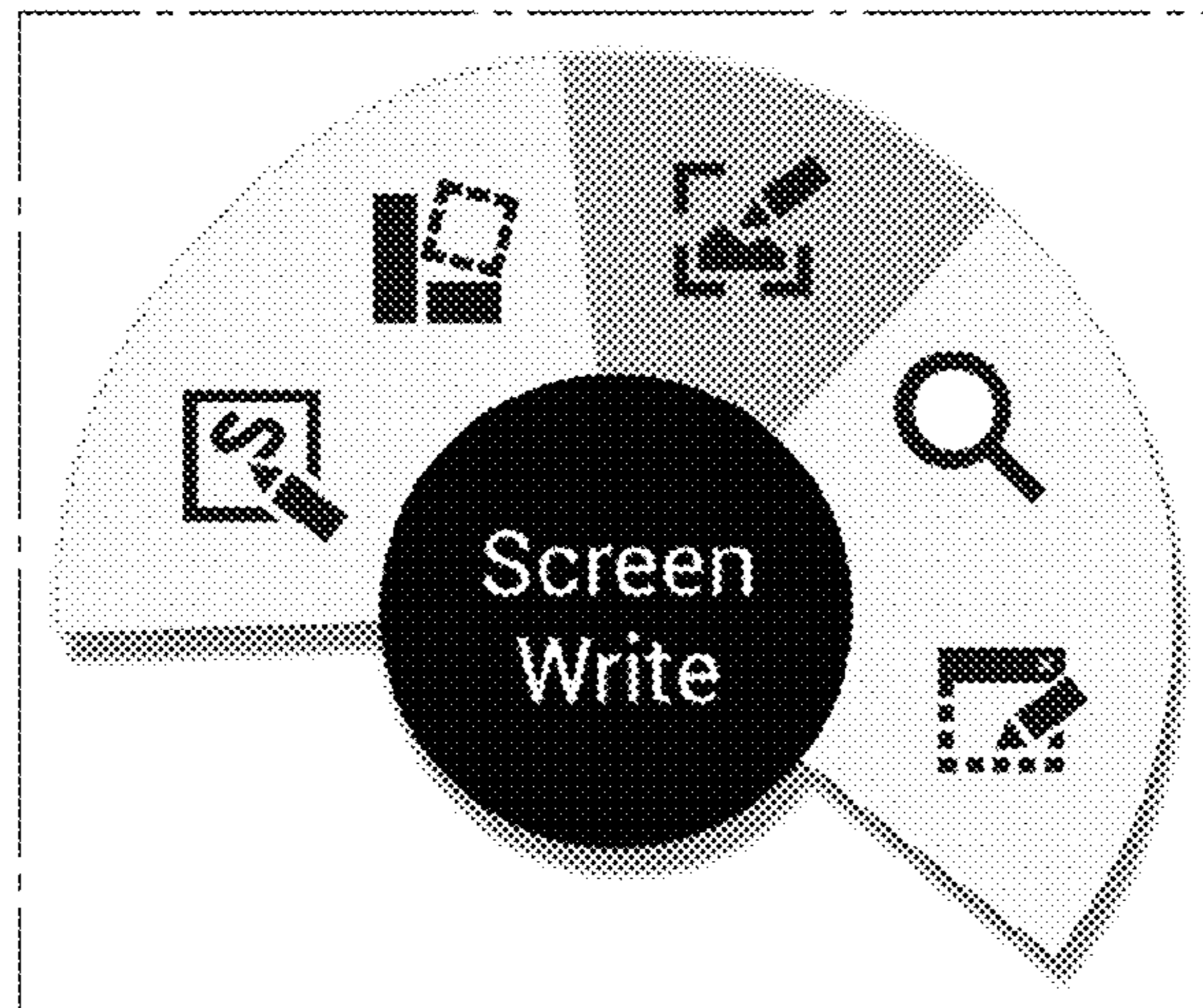

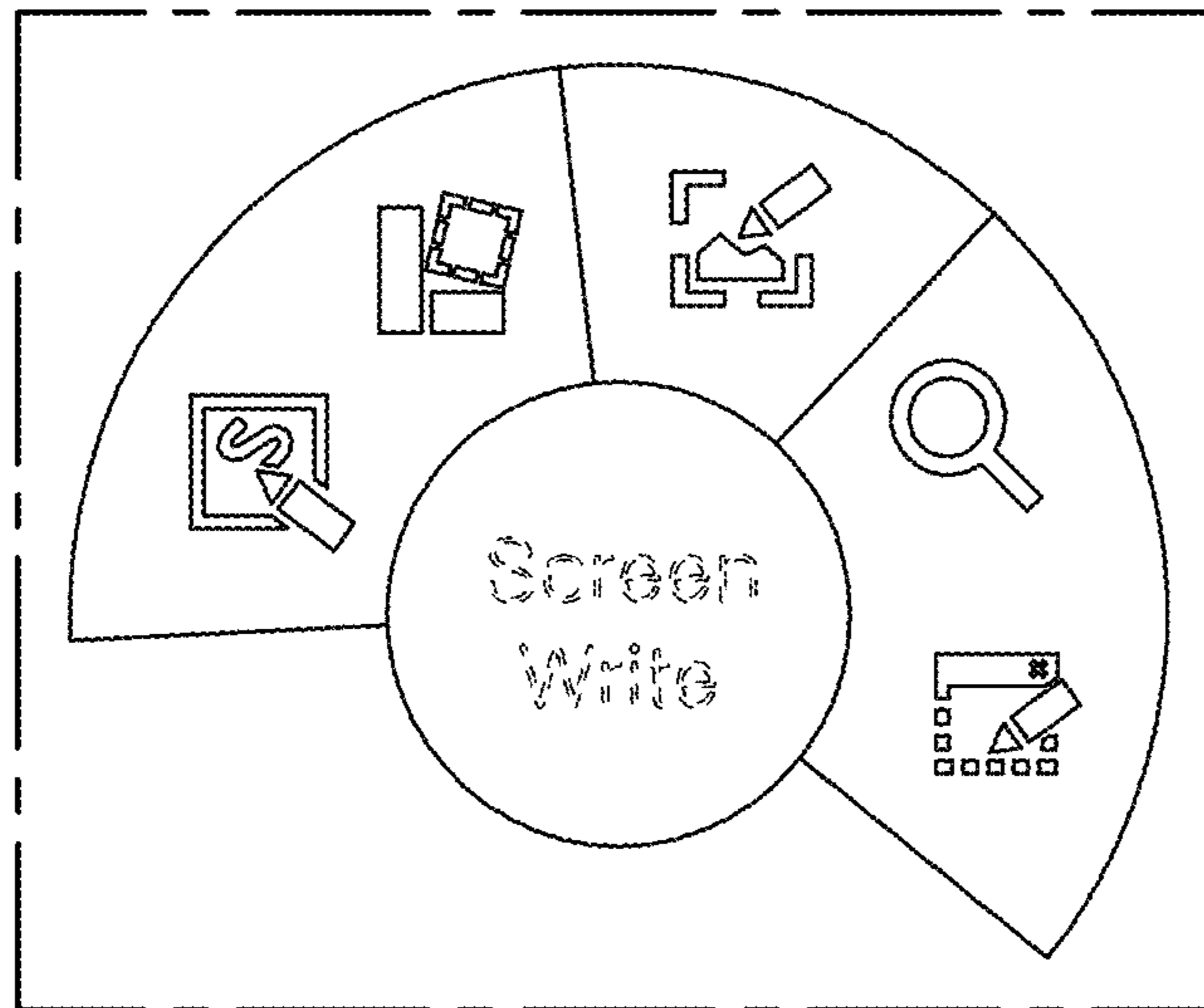
