We claim, the ornamental design for a display screen or portion thereof with graphical user interface, as shown and described.

The evenly spaced broken lines in FIG. 2 illustrate a display screen or portion thereof, and portions of a graphical user interface, and form no part of the claimed design.

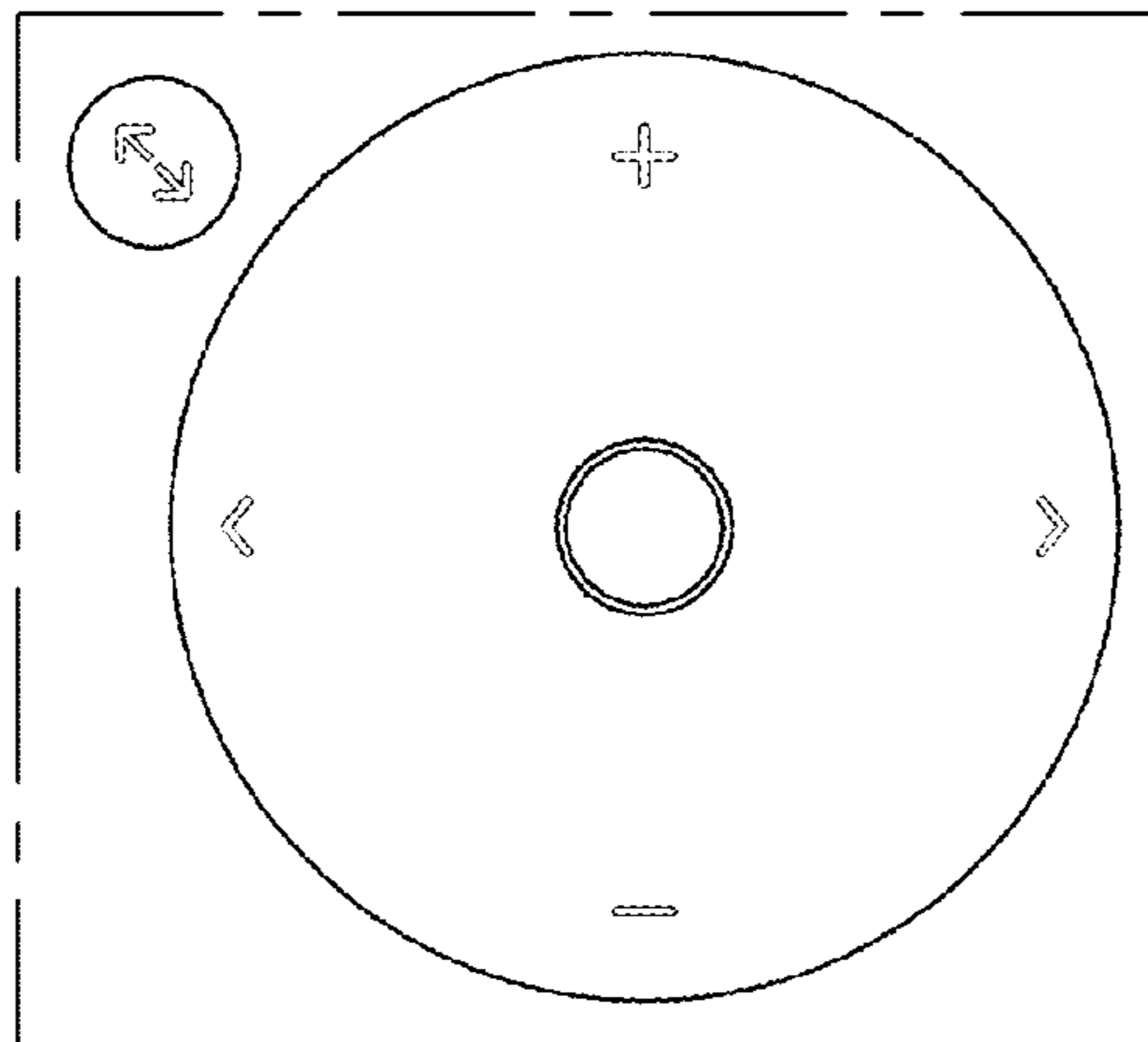

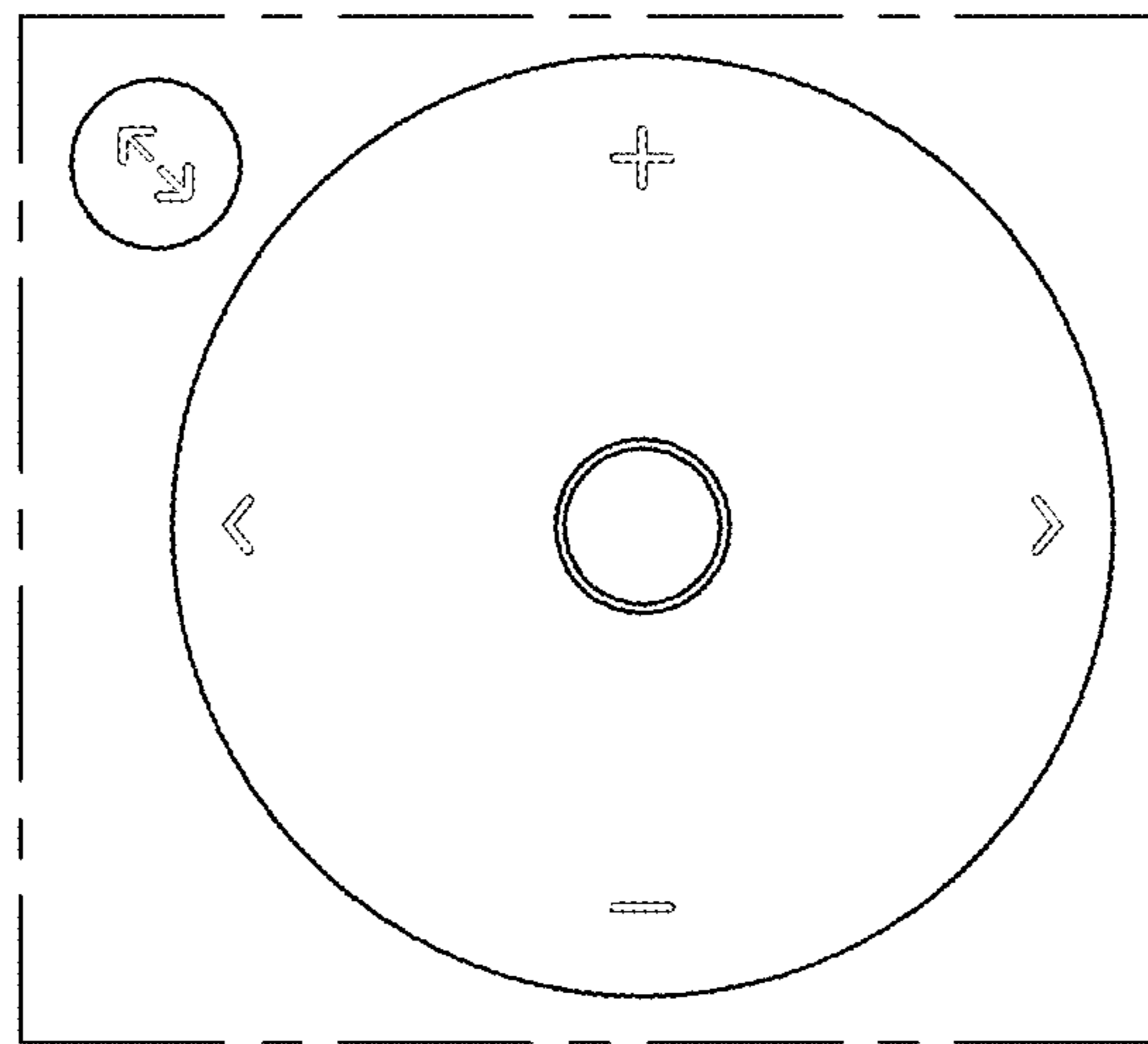
