(57) **CLAIM**

I claim, the ornamental design for a display screen or portion thereof with graphical user interface, as shown and described.

**DESCRIPTION**

FIGURE is a front view of a display screen or portion thereof with graphical user interface showing our new design. The broken lines shown in the drawings illustrate the display screen and portions of the graphical user interface that form no part of the claimed design.
