FIG. 5 is a side elevation view thereof;

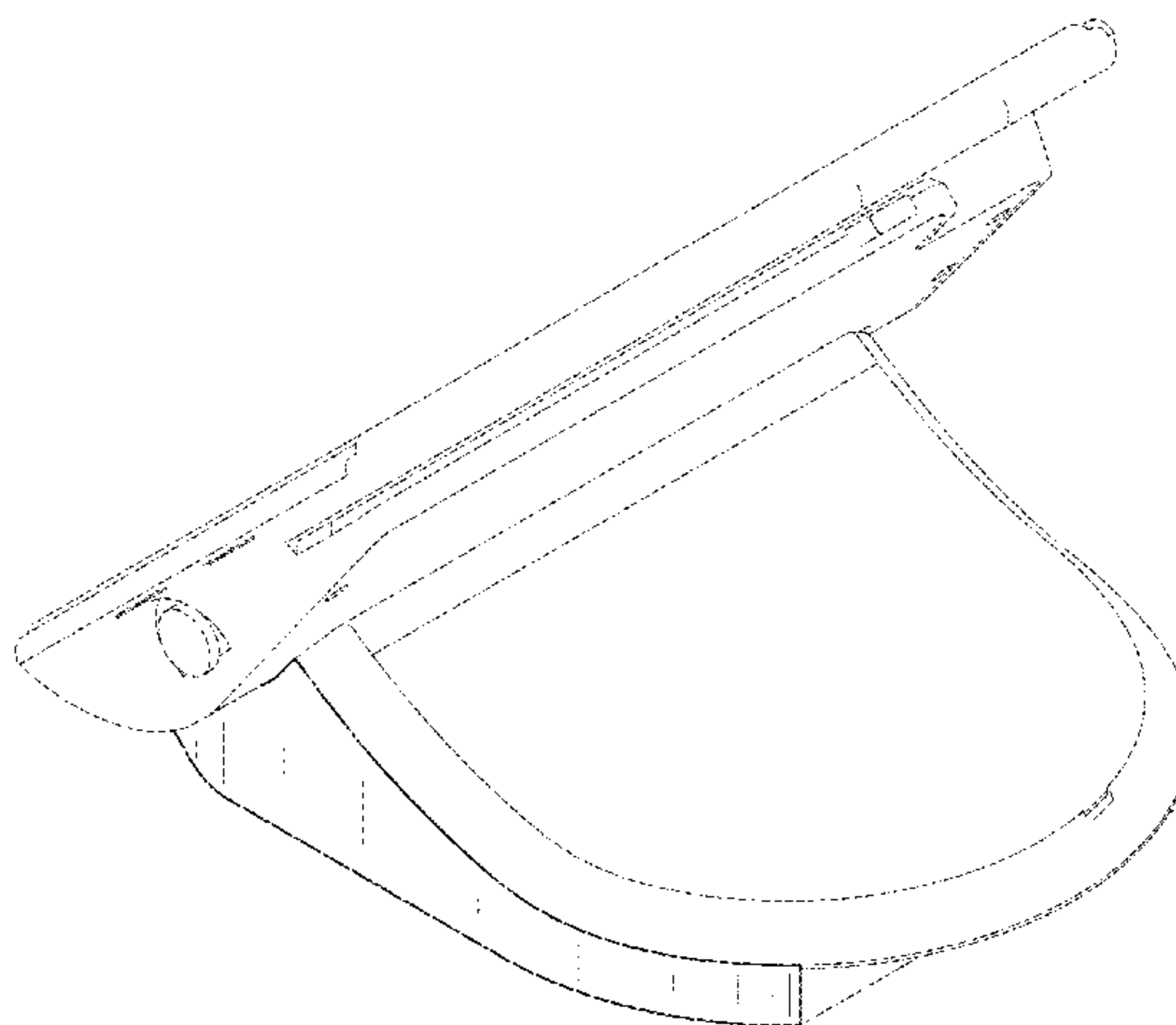
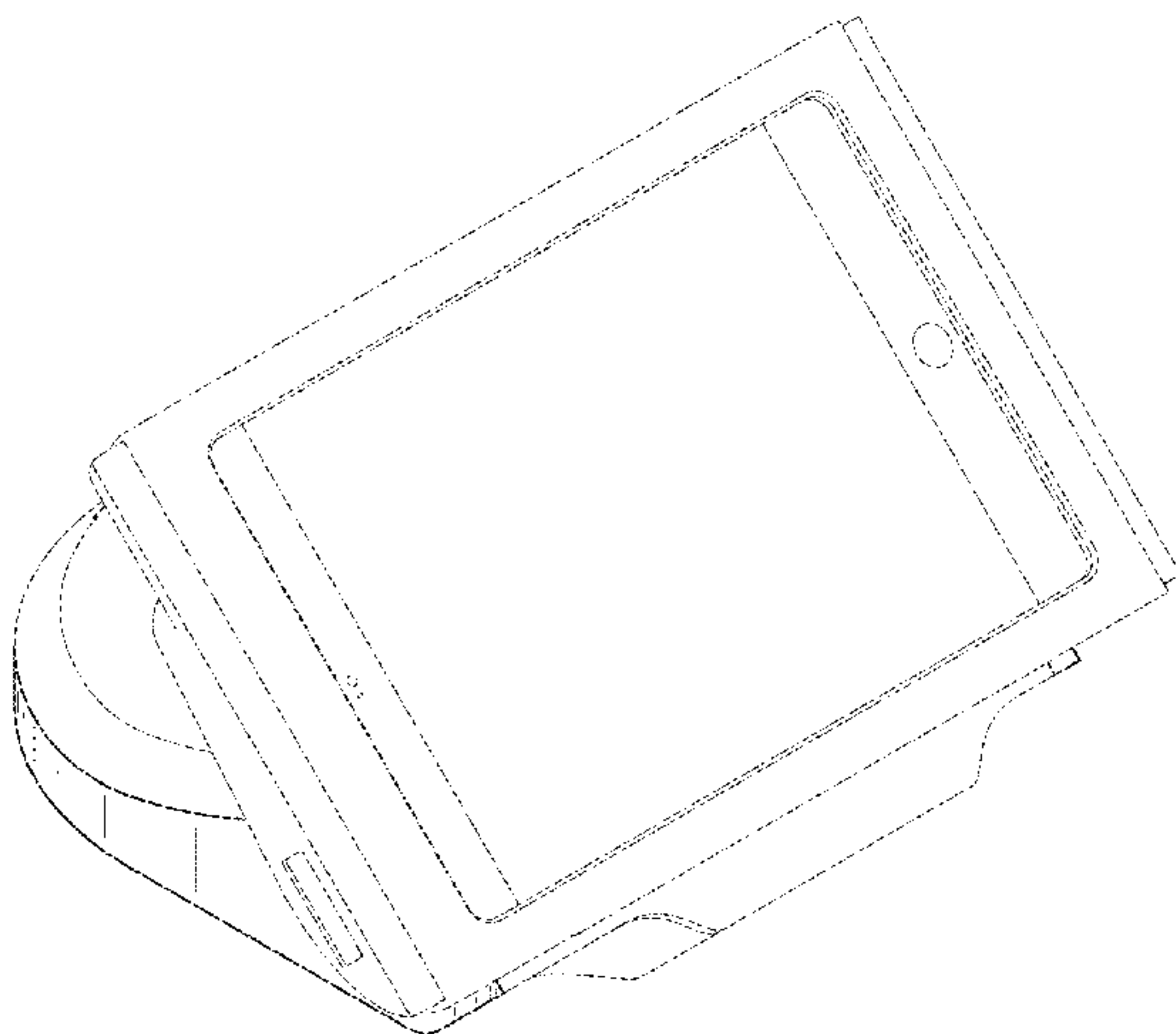
FIG. 6 is another side elevation view thereof;

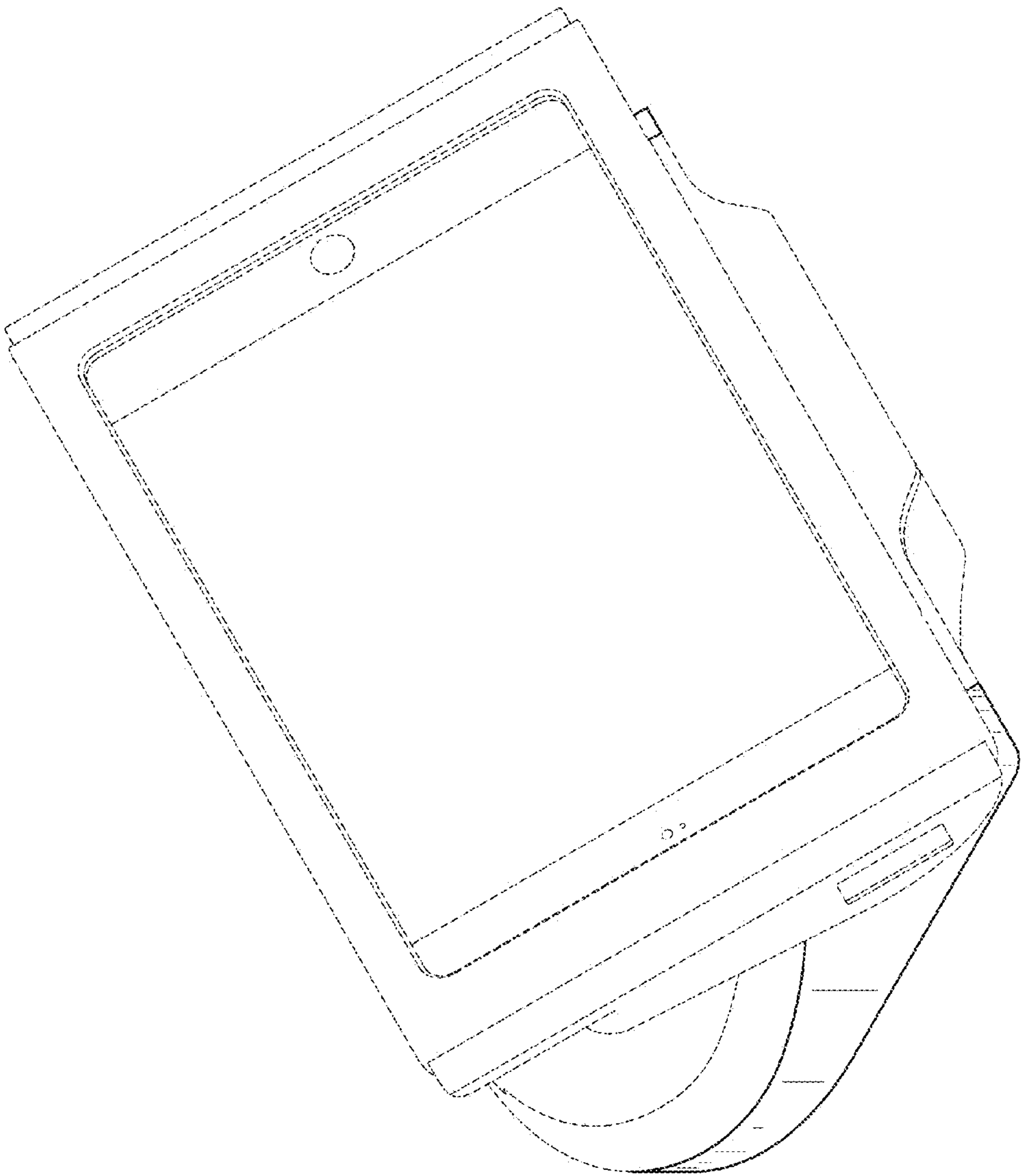

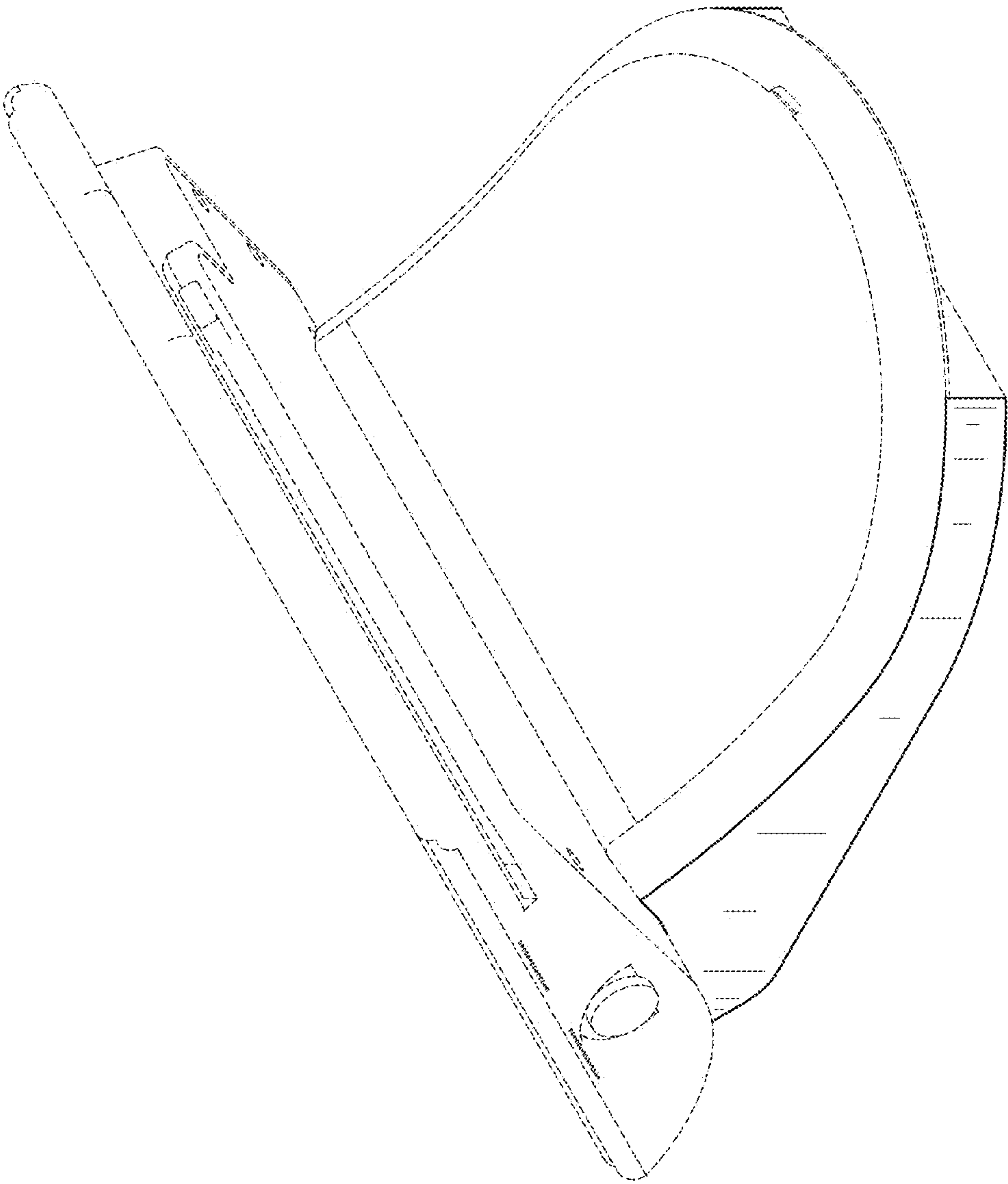

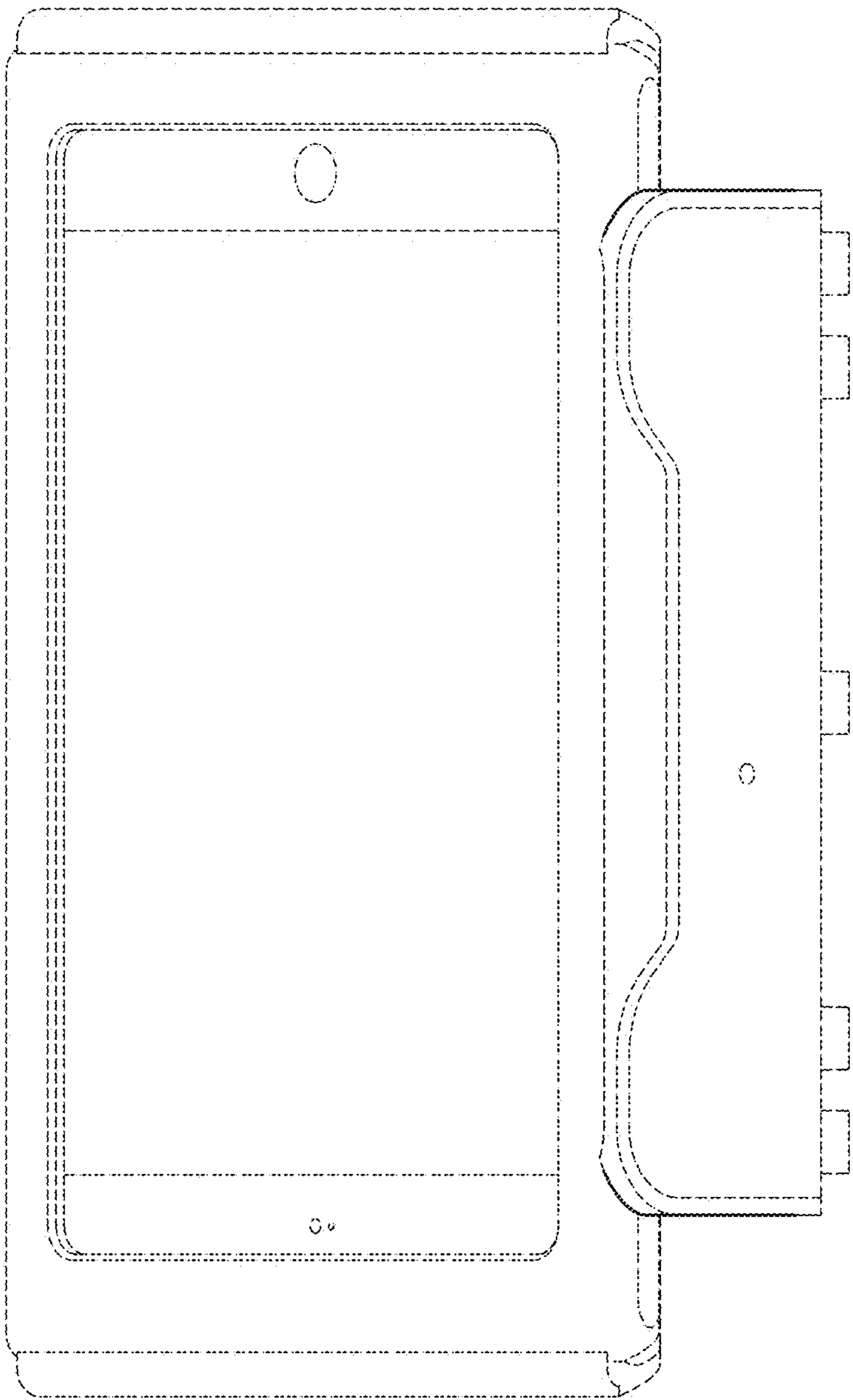

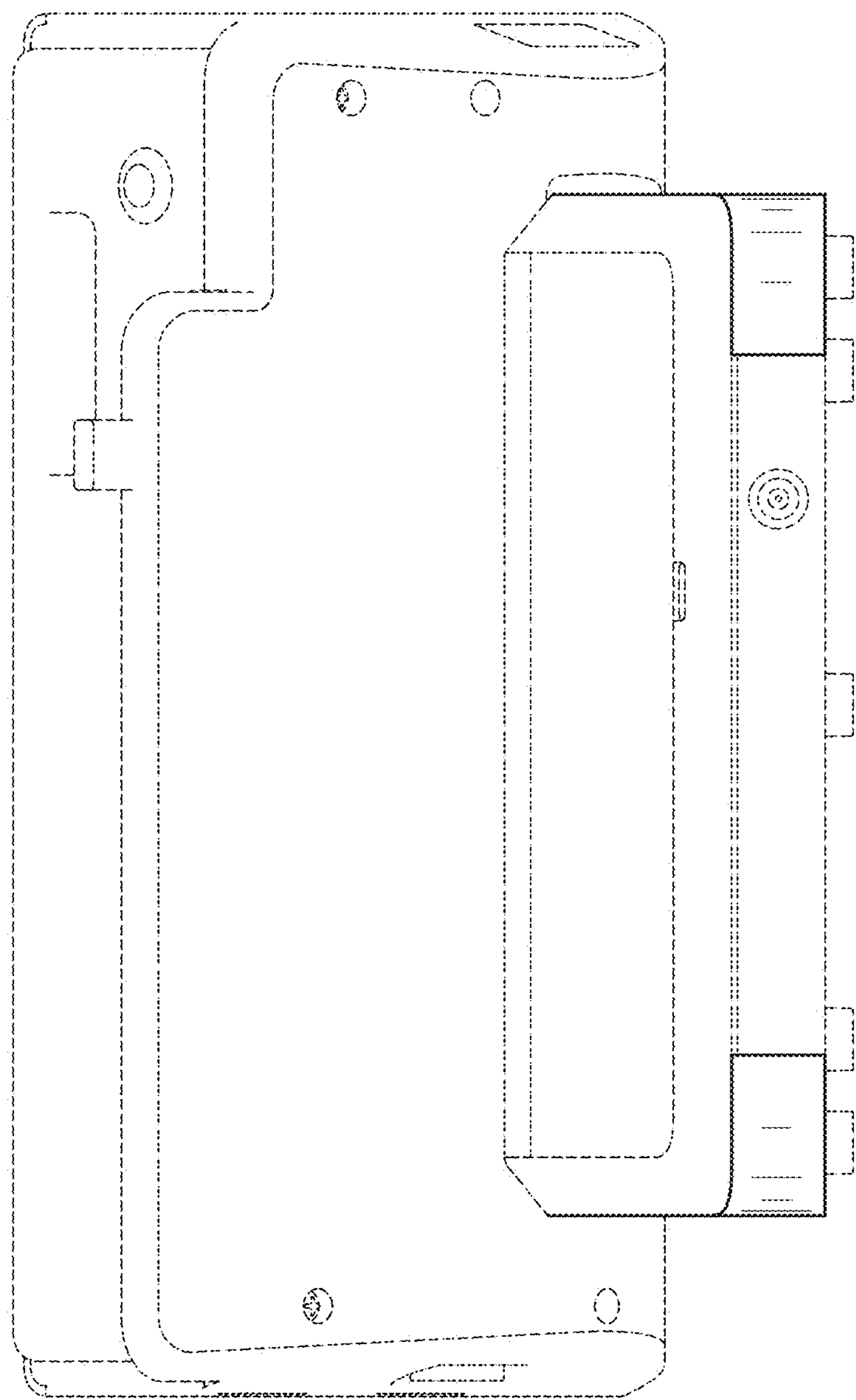

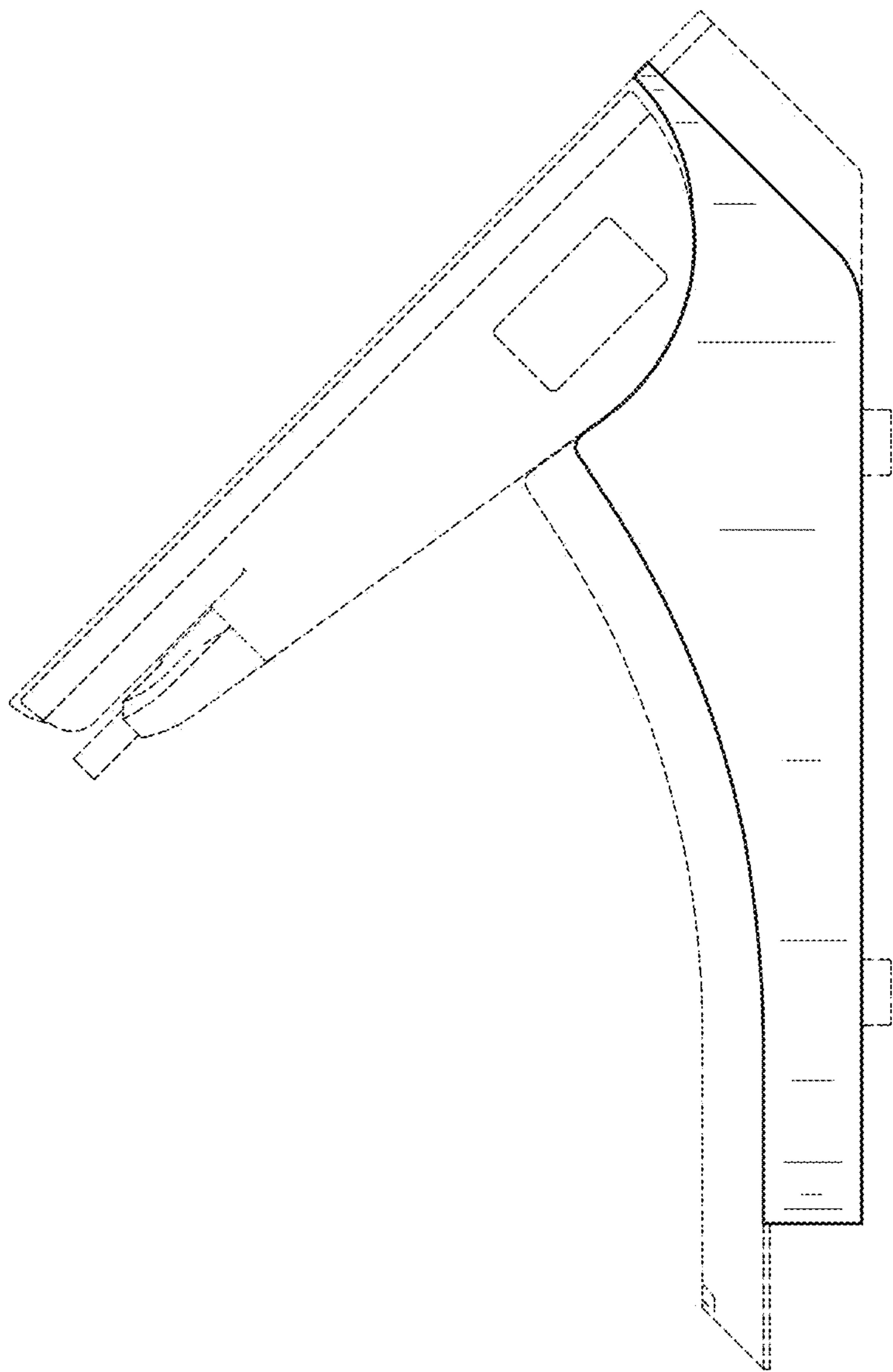

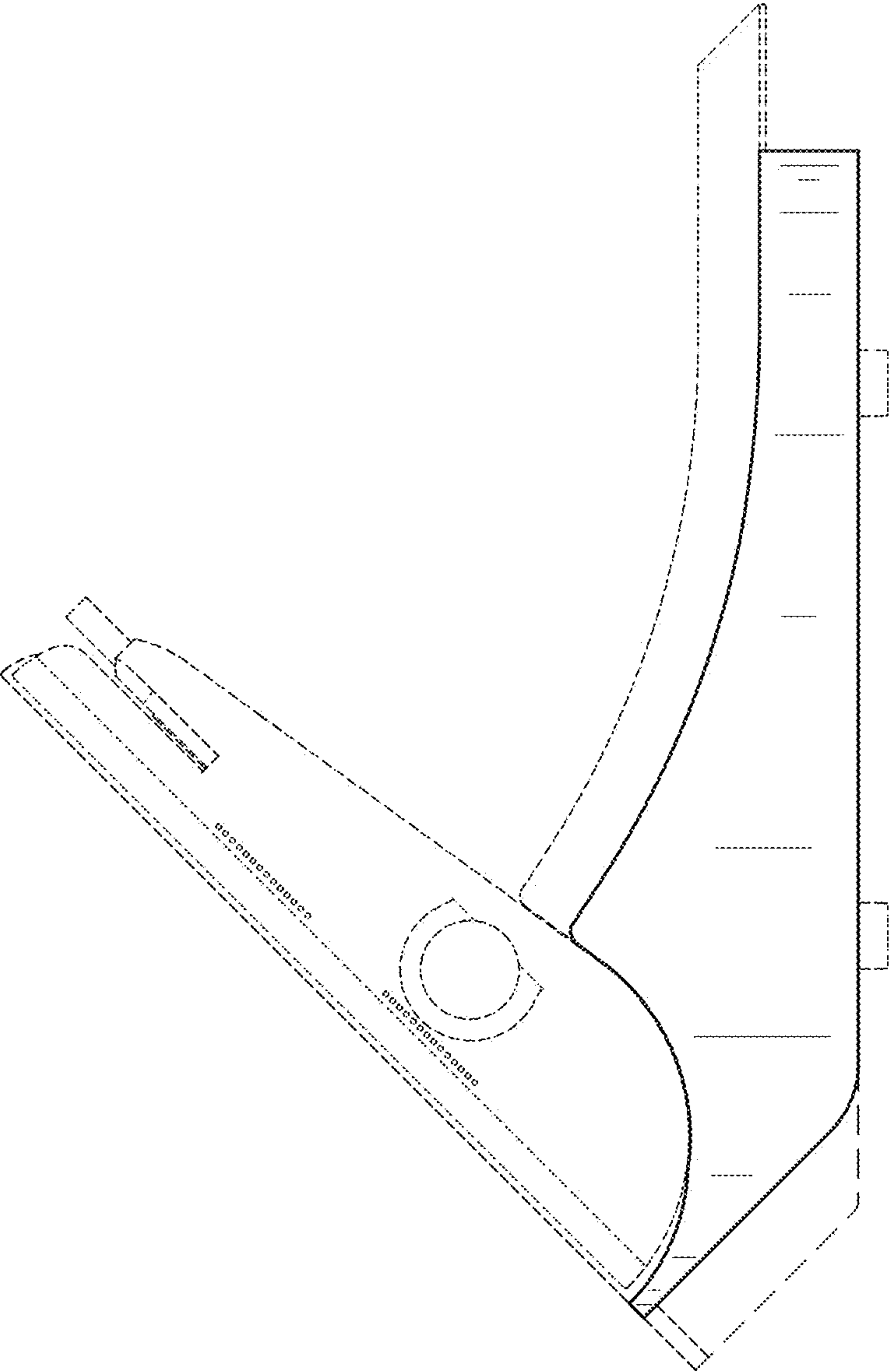

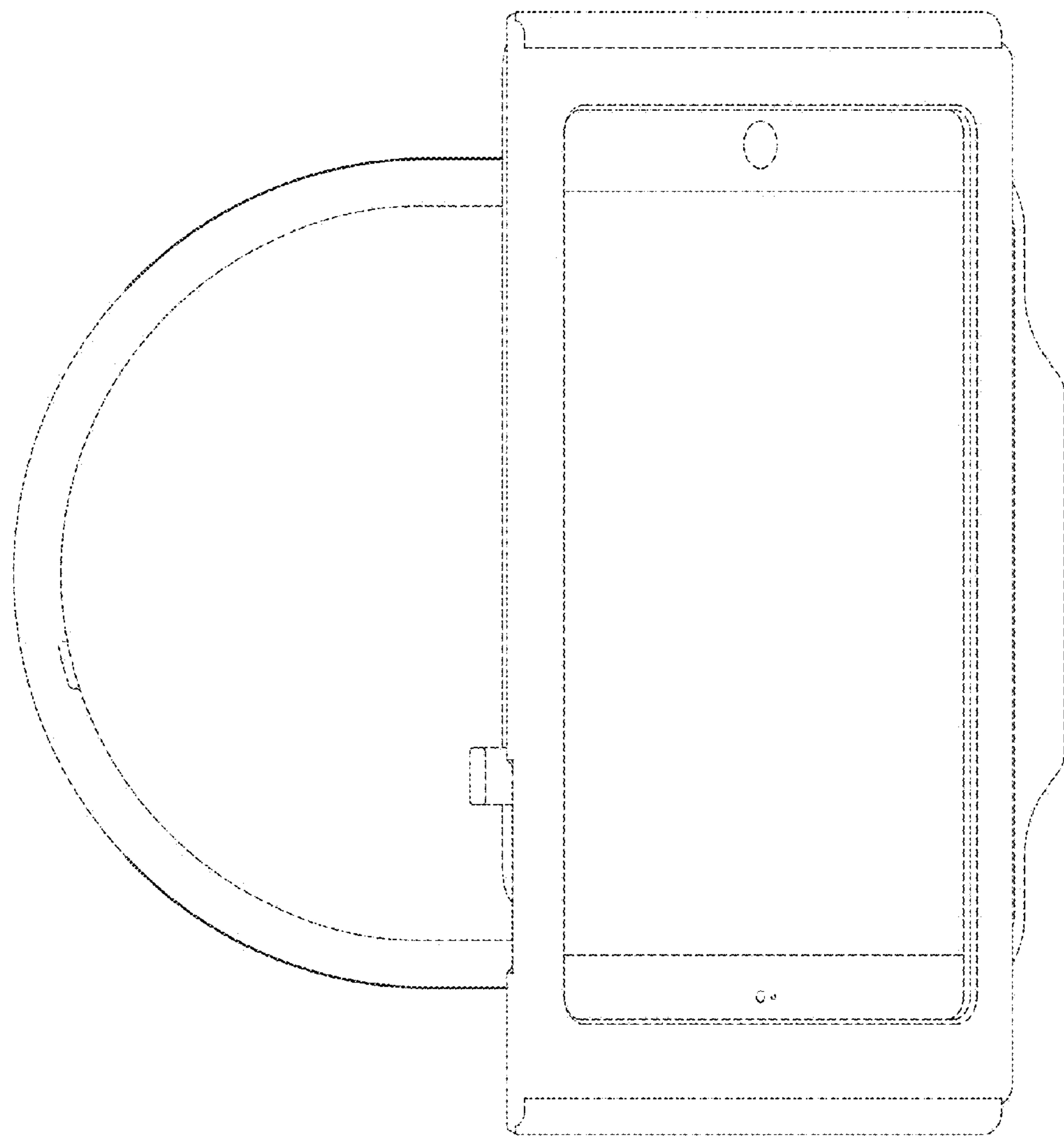

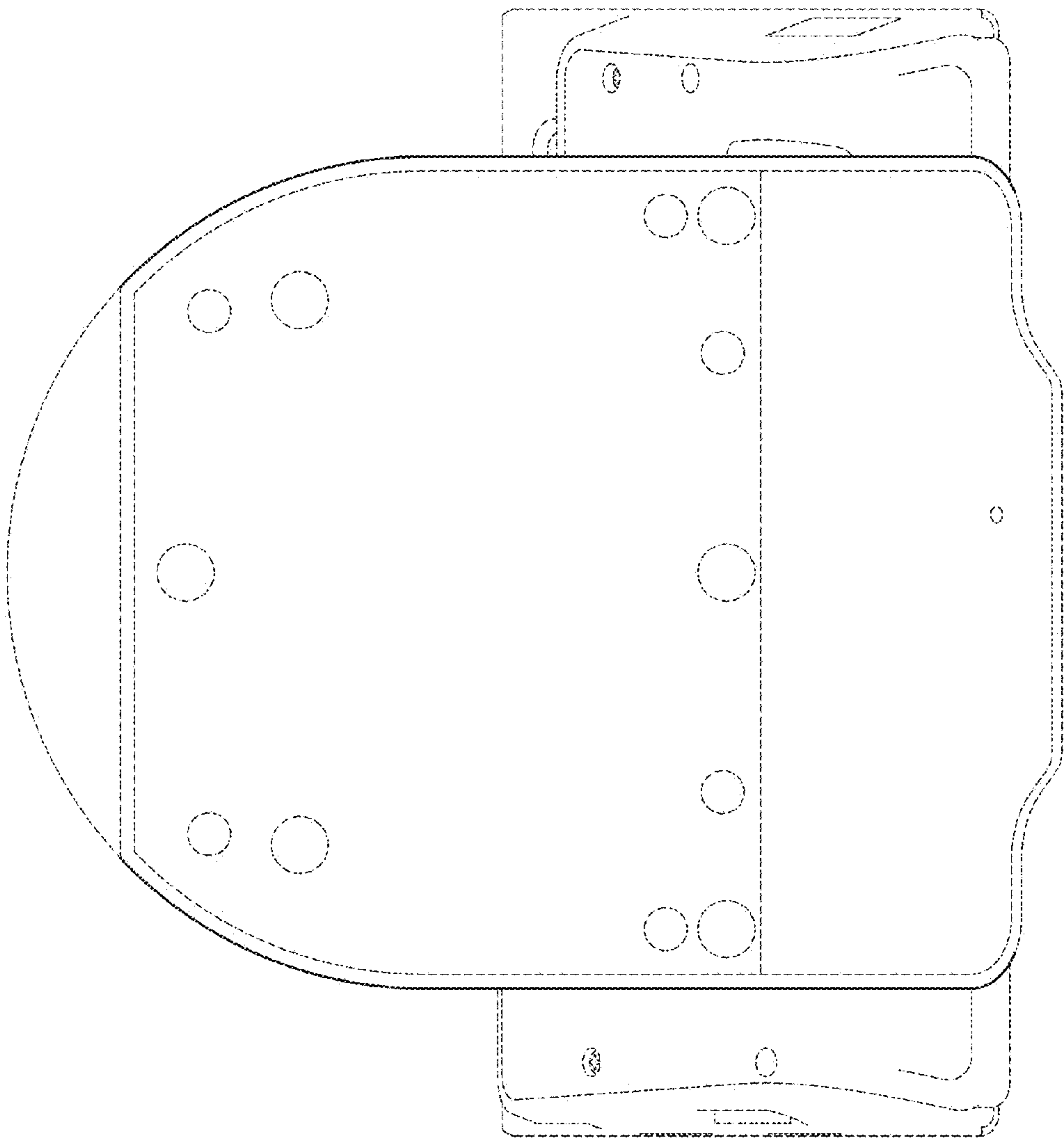
