(57) **CLAIM**

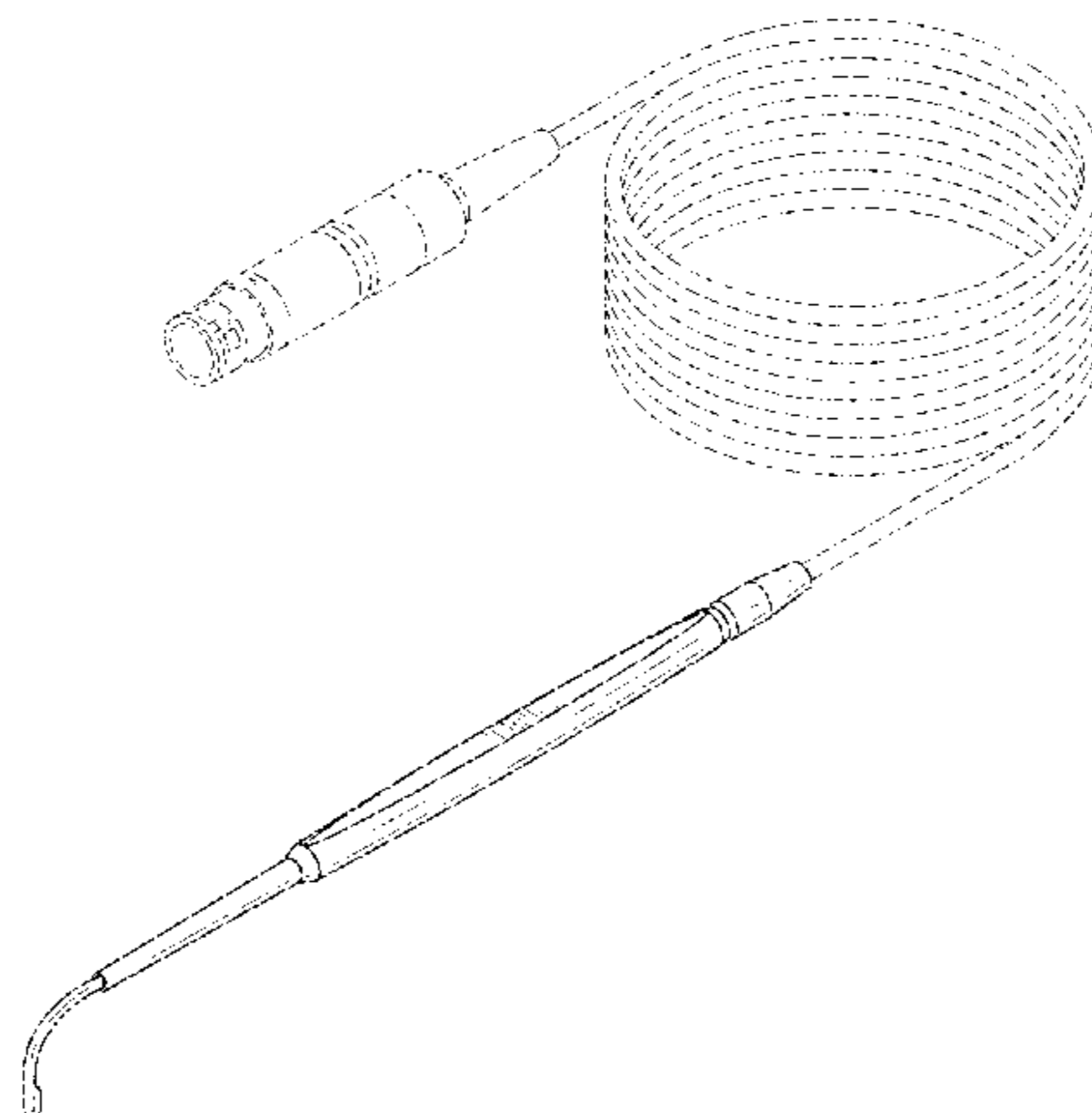
The ornamental design for a surgical navigation instrument, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a surgical navigation instrument according to the present invention.
FIG. 2 is a front view of the surgical navigation instrument of FIG. 1.
FIG. 3 is a rear view of the surgical navigation instrument of FIG. 1.
FIG. 4 is a right view of the surgical navigation instrument of FIG. 1.
FIG. 5 is a left view of the surgical navigation instrument of FIG. 1.
FIG. 6 is a top view of the surgical navigation instrument of FIG. 1; and,
FIG. 7 is a bottom view of the surgical navigation instrument of FIG. 1.

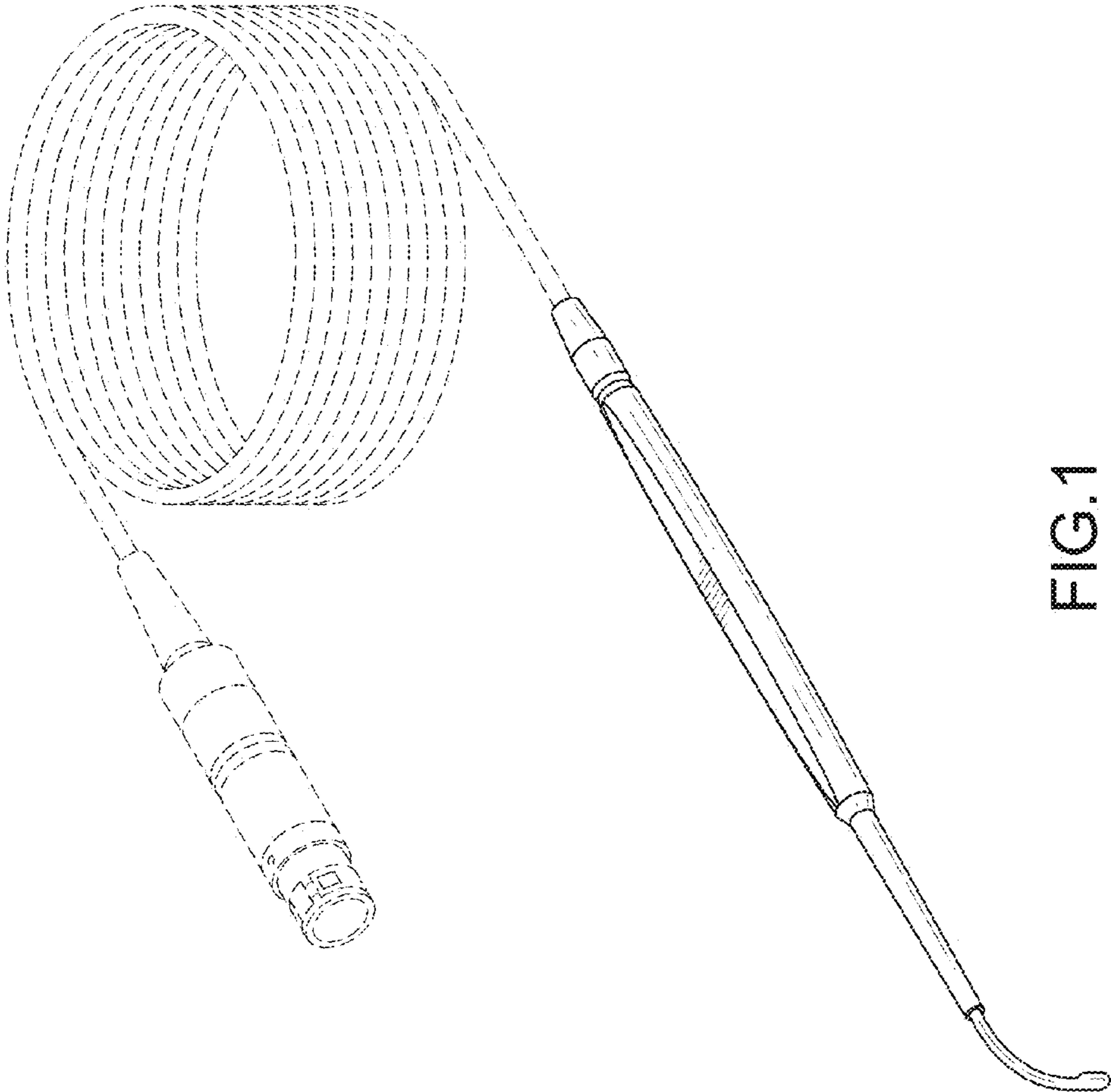

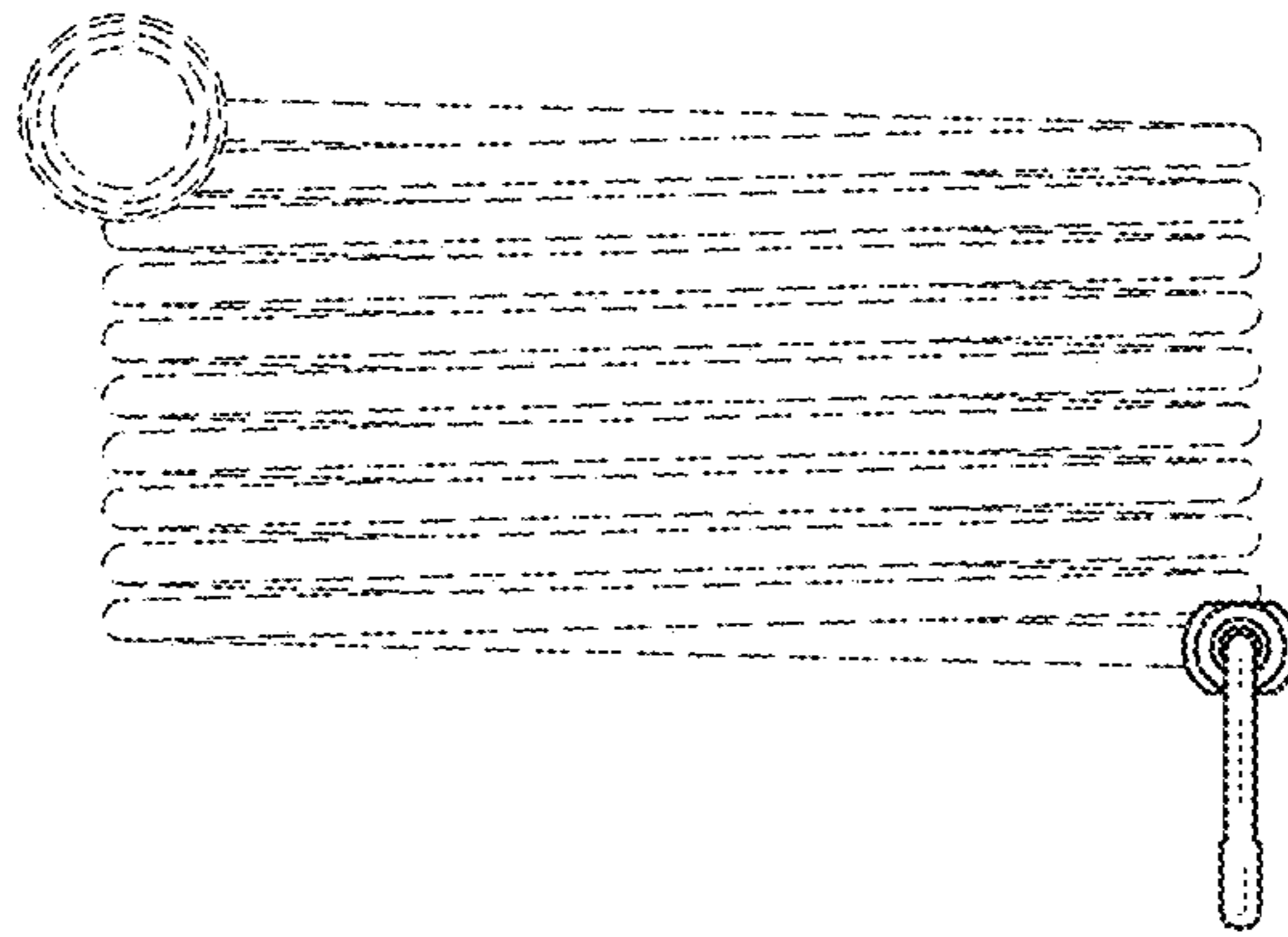

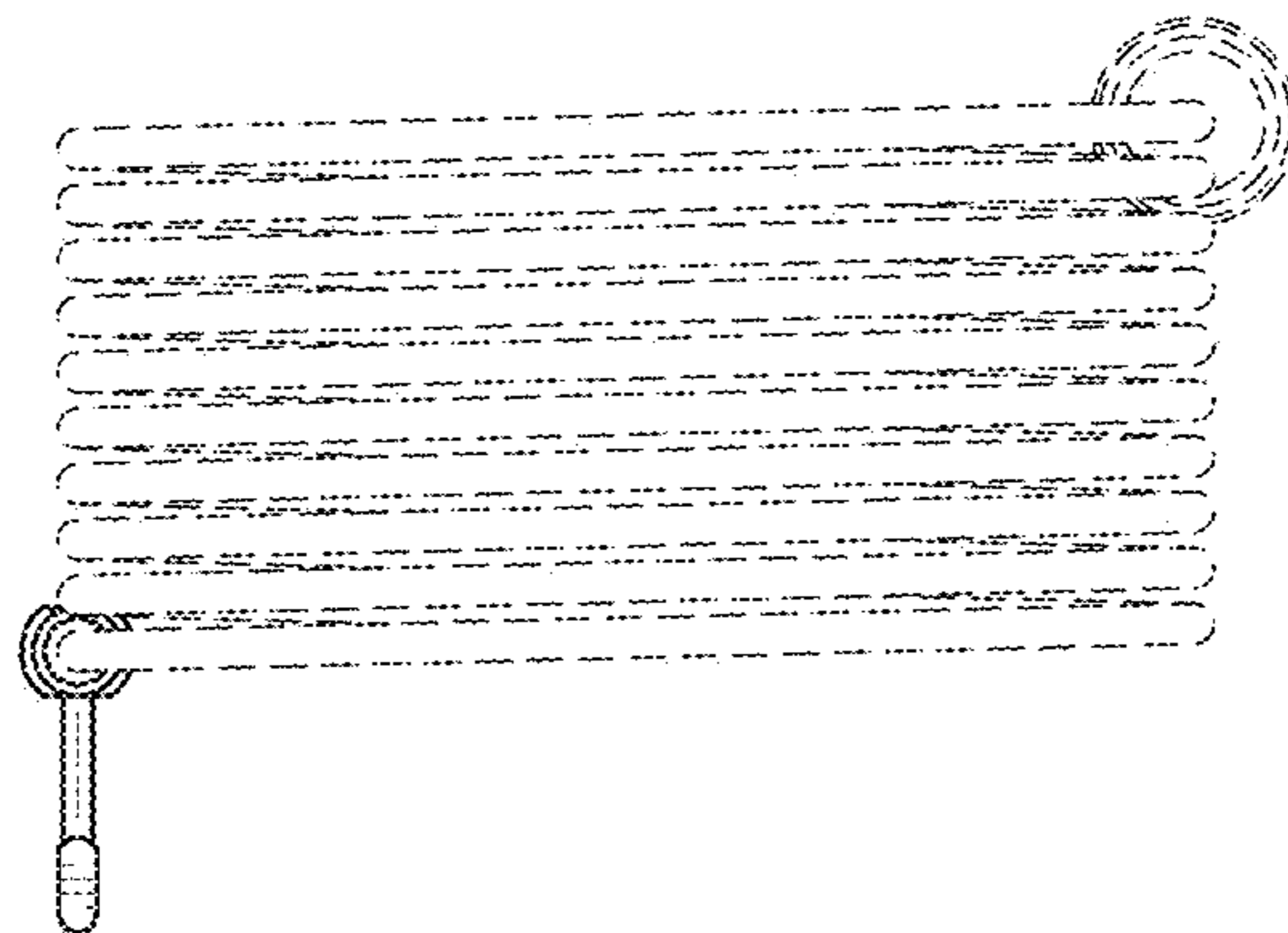

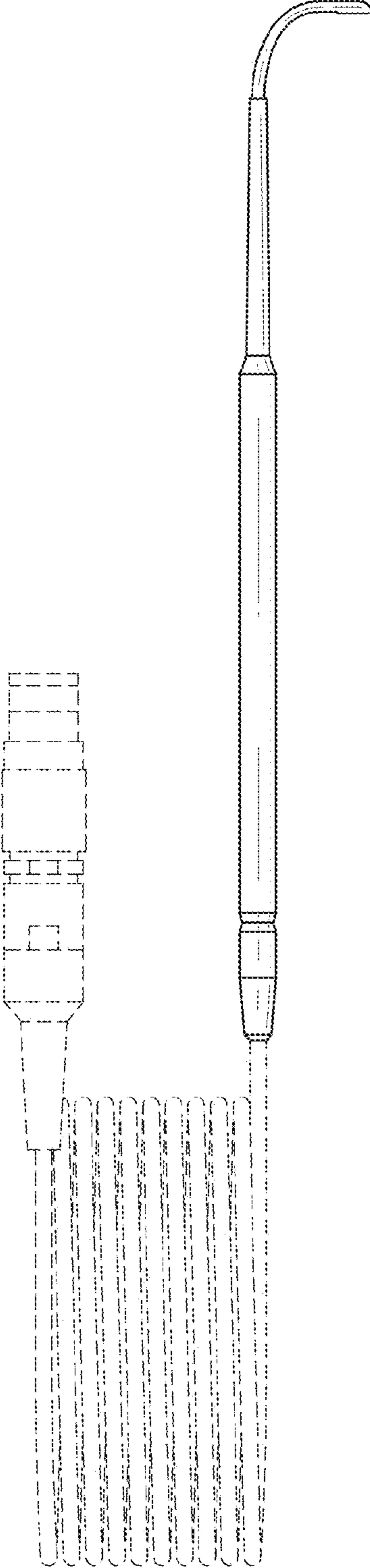

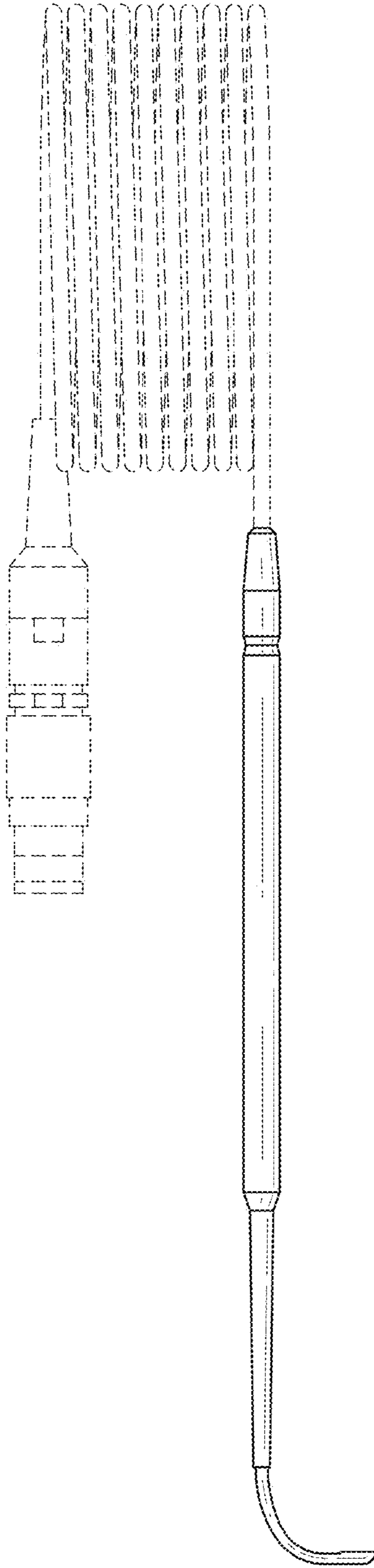

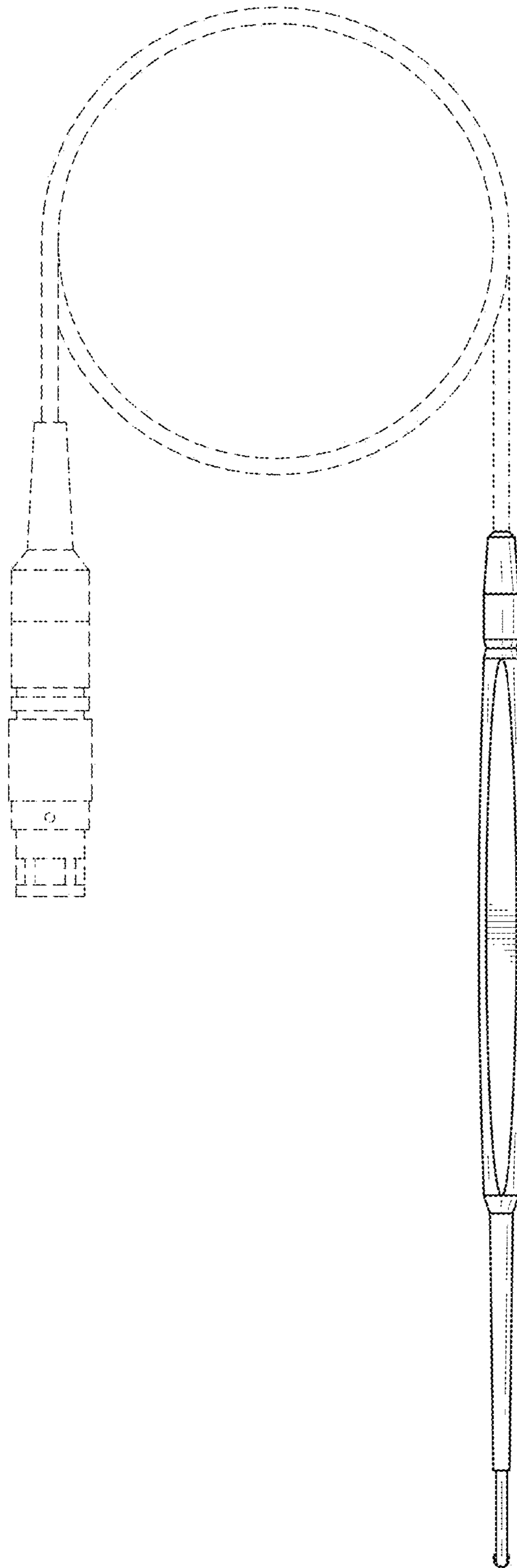

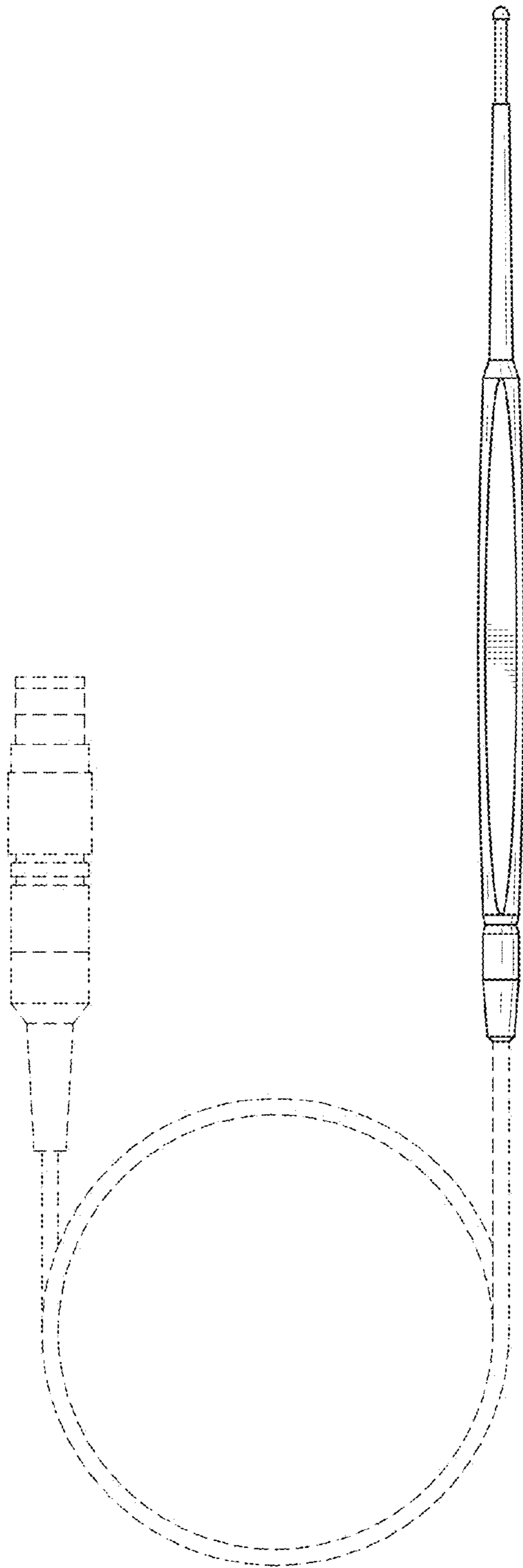
