The ornamental design for an ultrasonic probe, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the ultrasonic probe;
FIG. 2 is a front view of the ultrasonic probe of FIG. 1;
FIG. 3 is a rear view of the ultrasonic probe of FIG. 1;
FIG. 4 is a left view of the ultrasonic probe of FIG. 1;
FIG. 5 is a right view of the ultrasonic probe of FIG. 1;
FIG. 6 is an enlarged top view of the ultrasonic probe of FIG. 1; and,
FIG. 7 is an enlarged bottom view of the ultrasonic probe of FIG. 1.

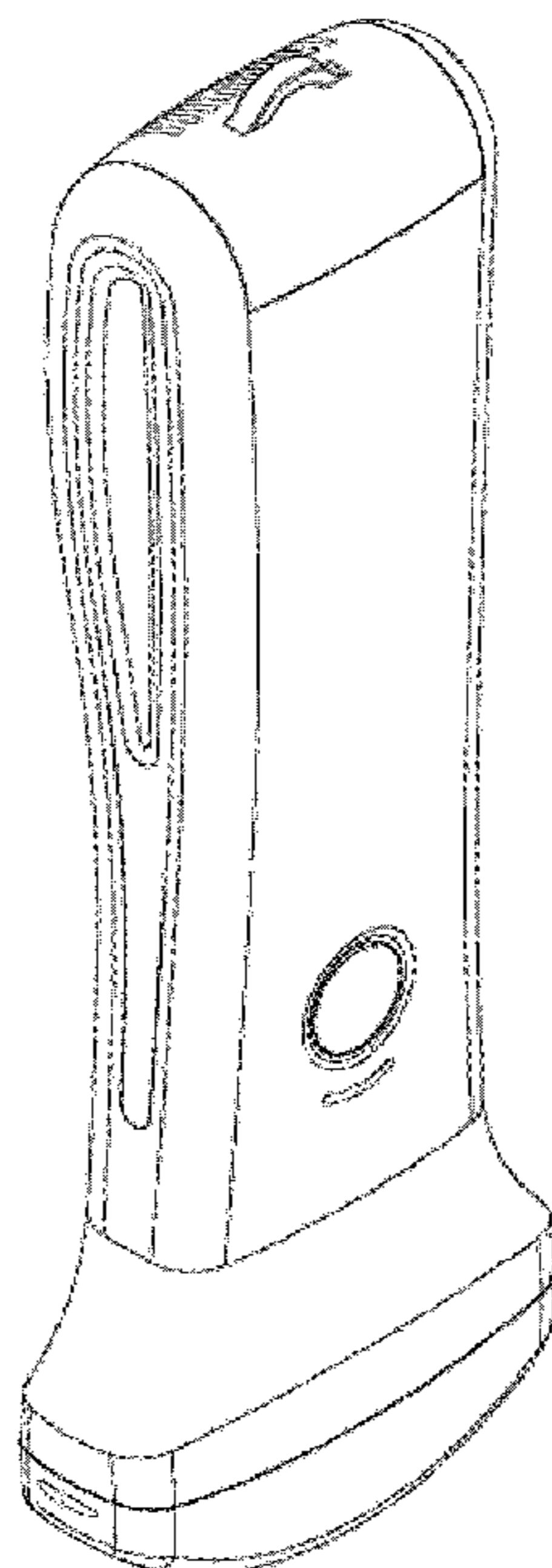

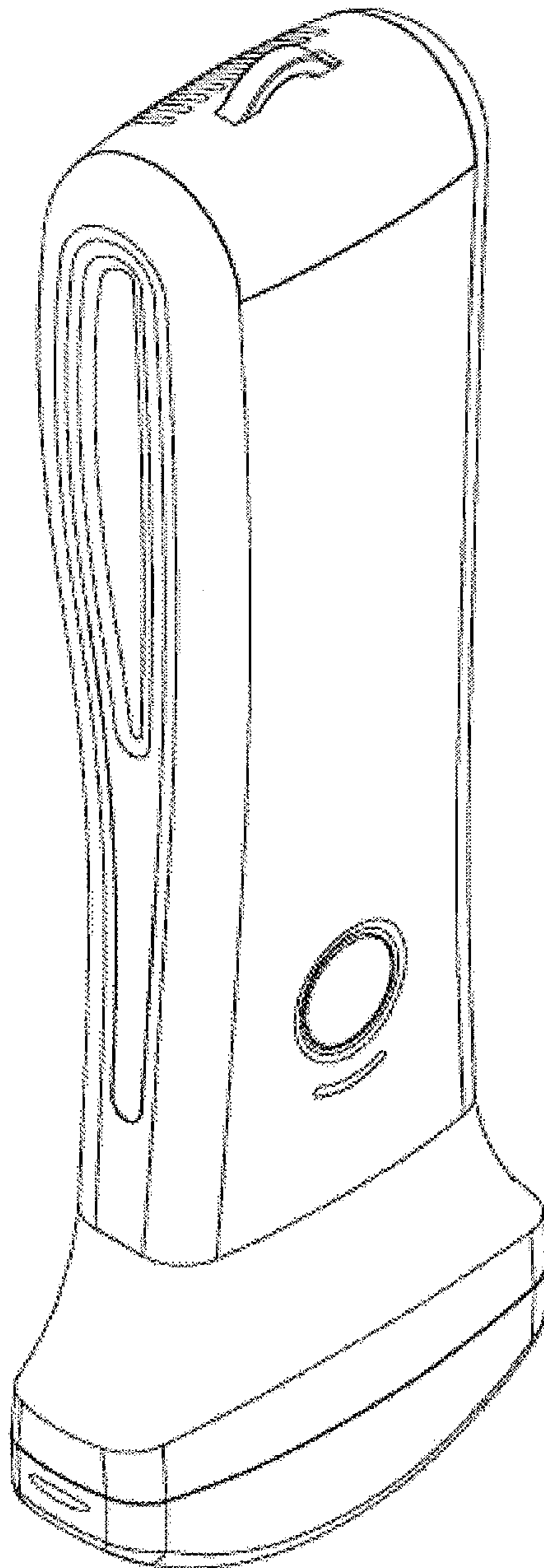

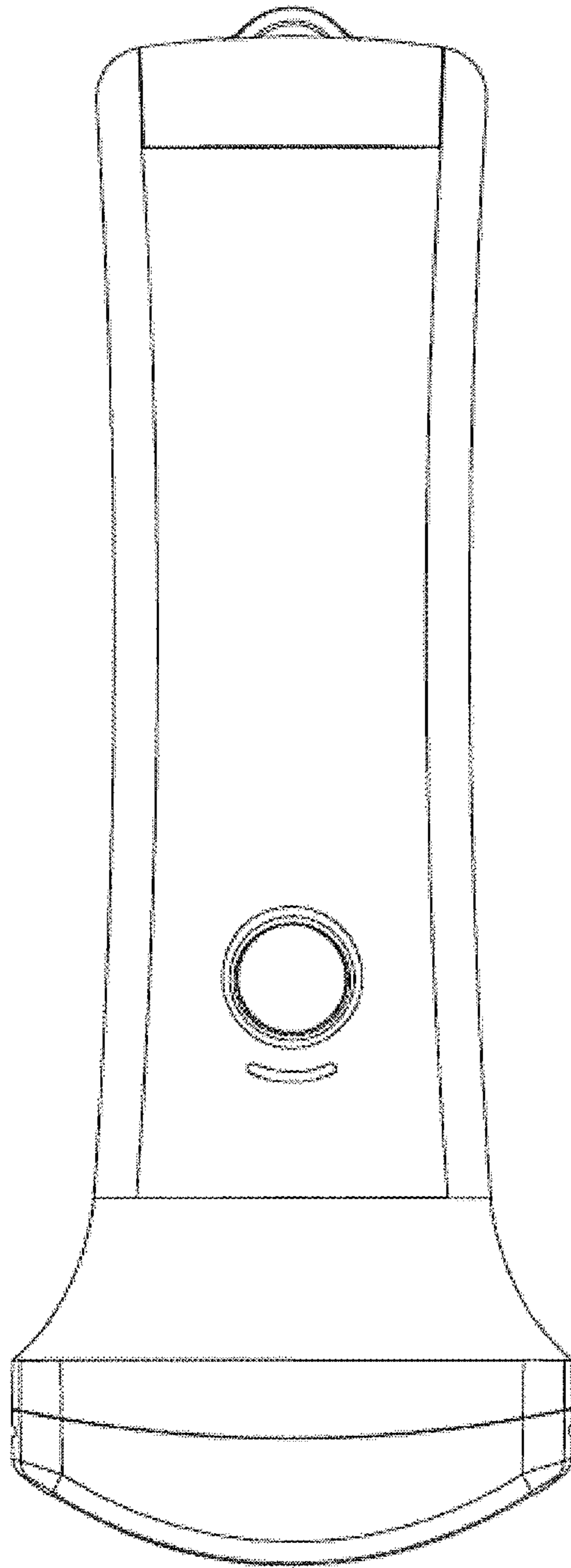

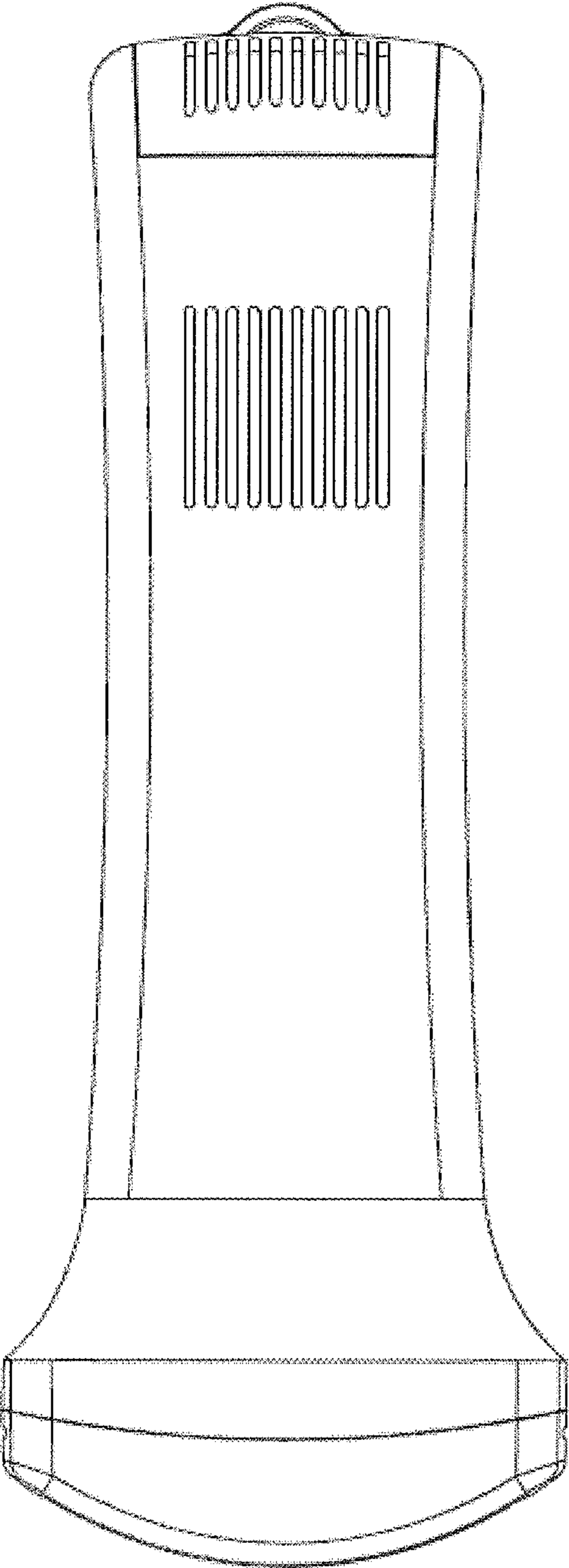

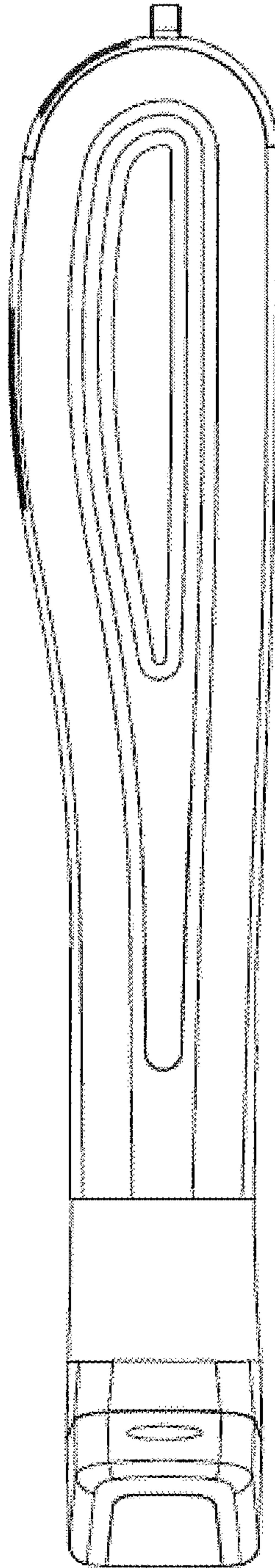

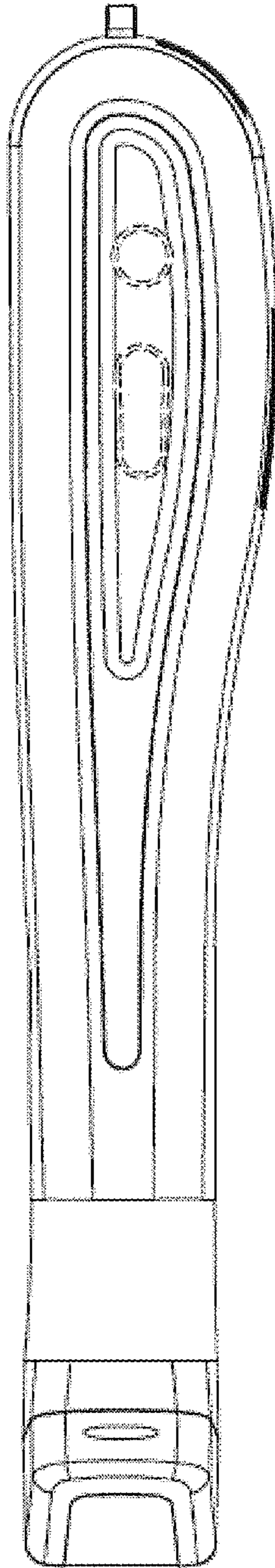

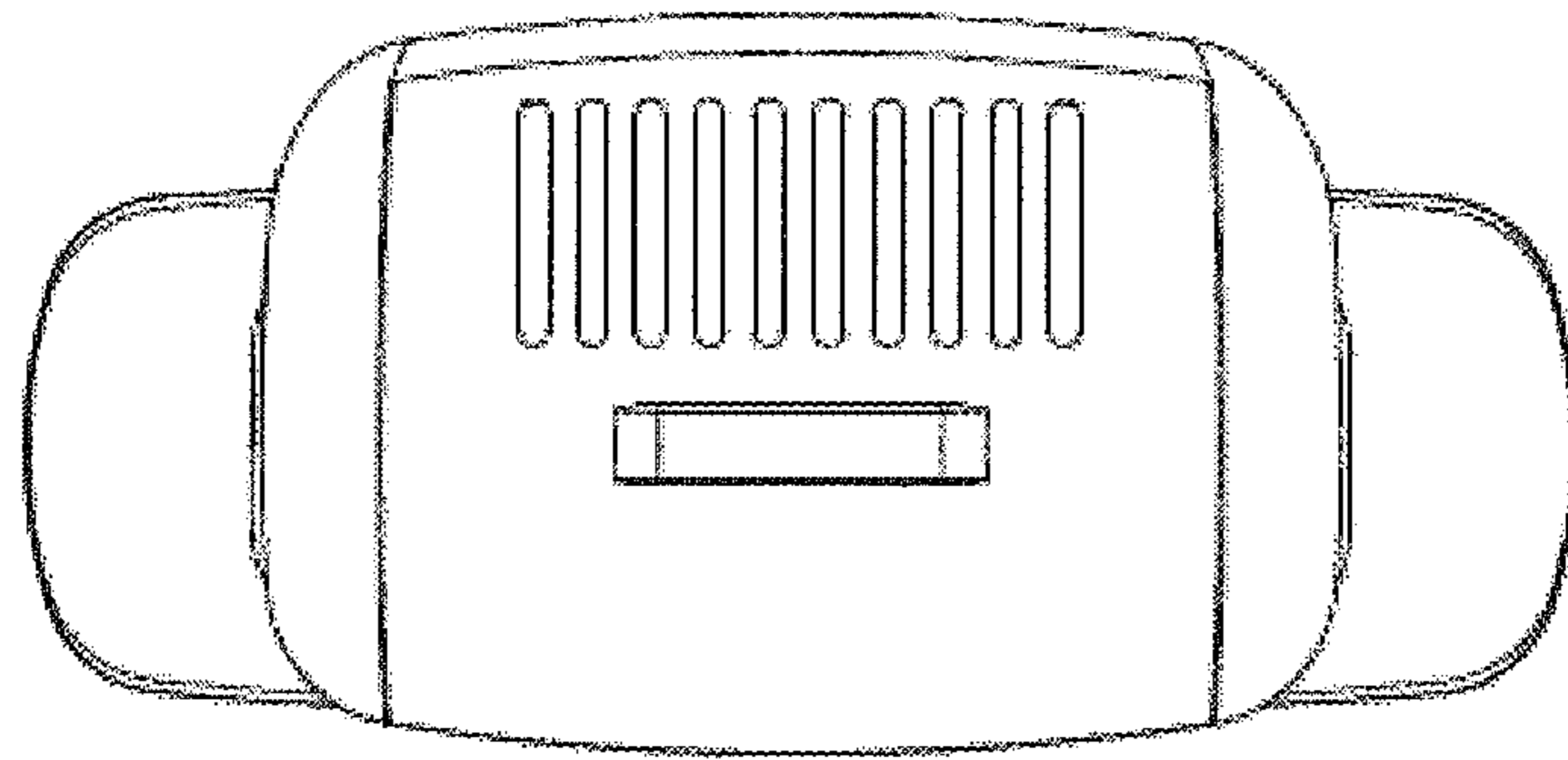
