An ornamental design for a toe separator, as shown and described.

DESCRIPTION

FIG. 11 is a right side view of the embodiment of FIG. 9;

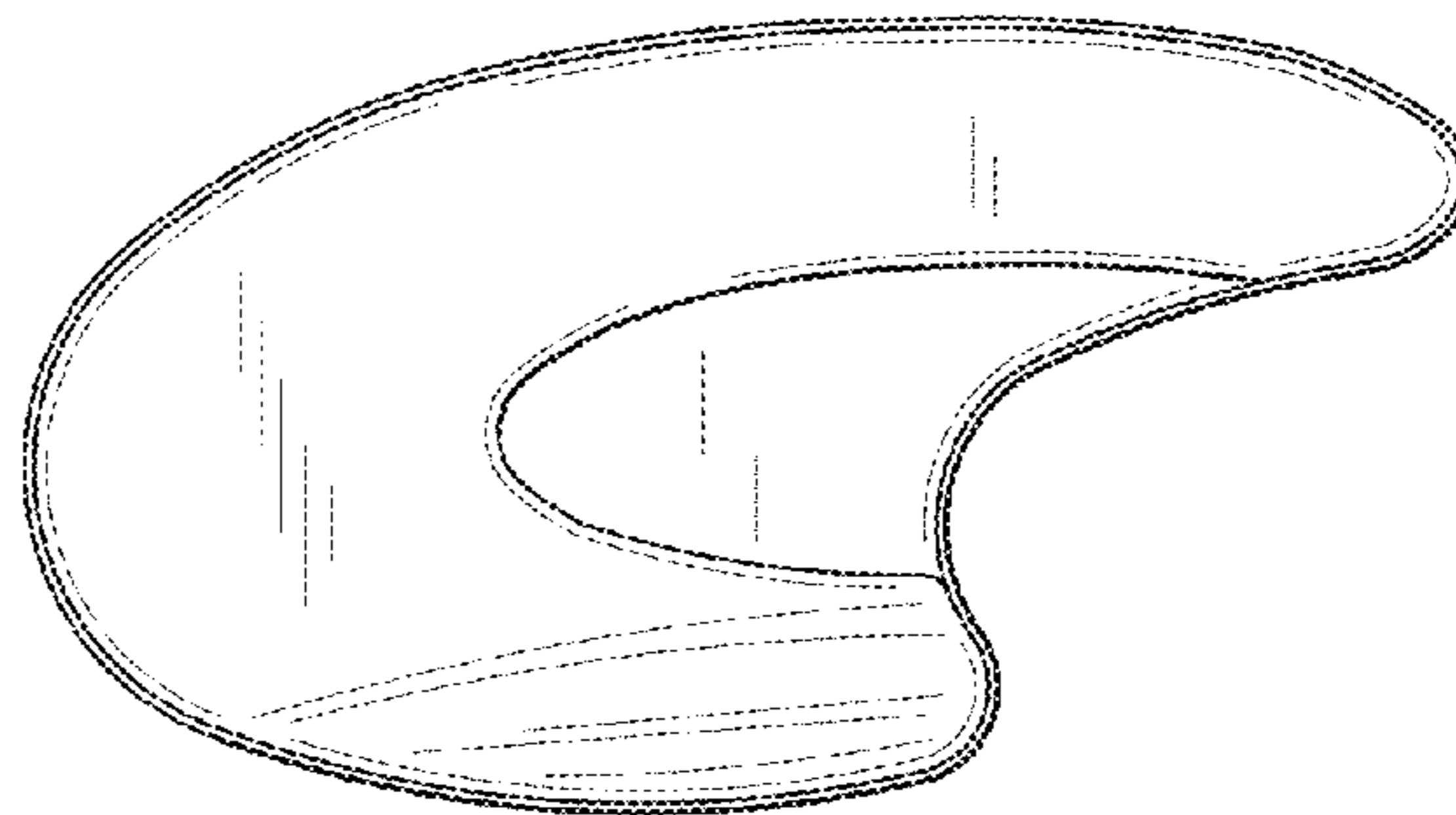
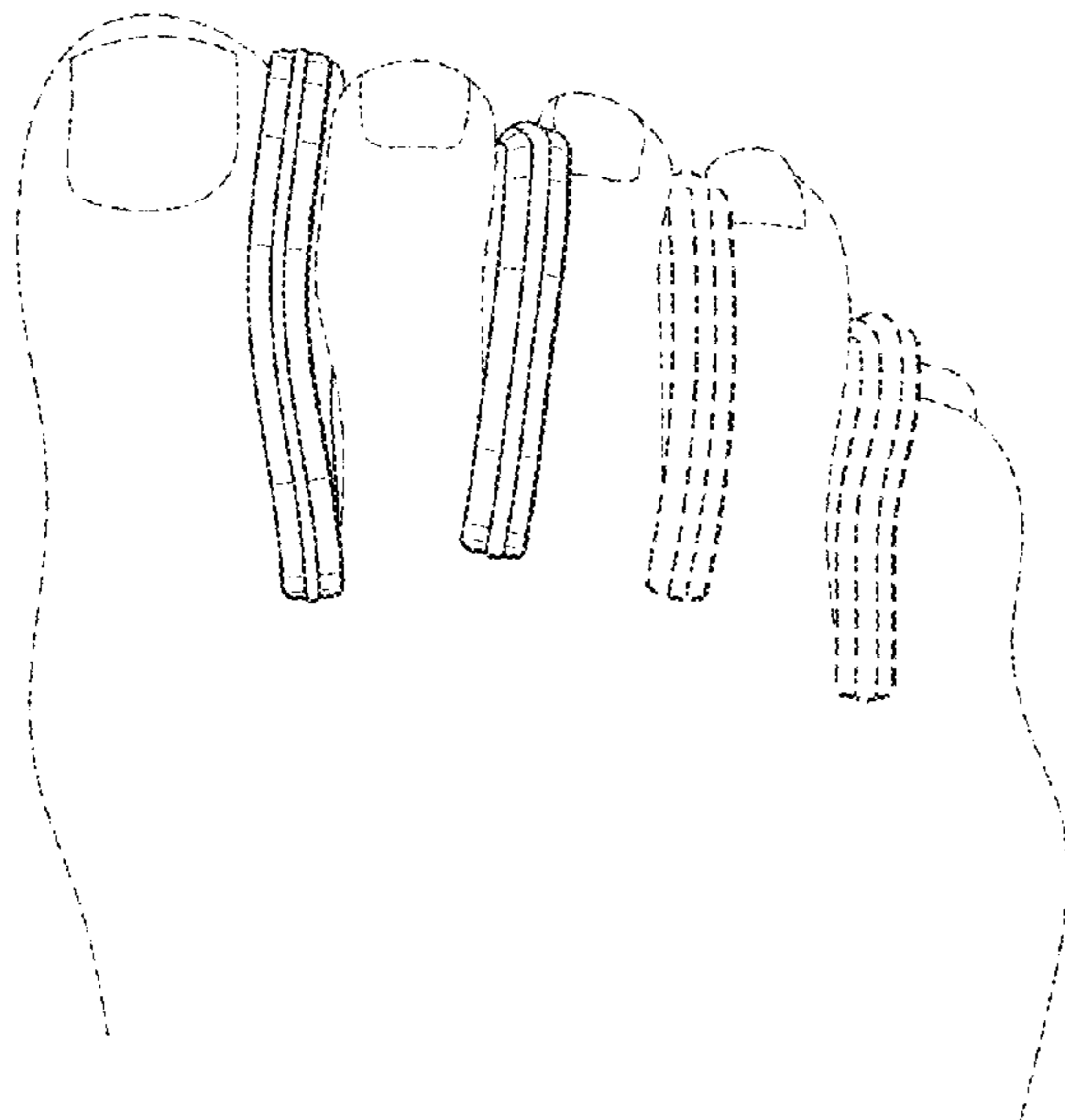
FIG. 12 is a left side view of the embodiment of FIG. 9;

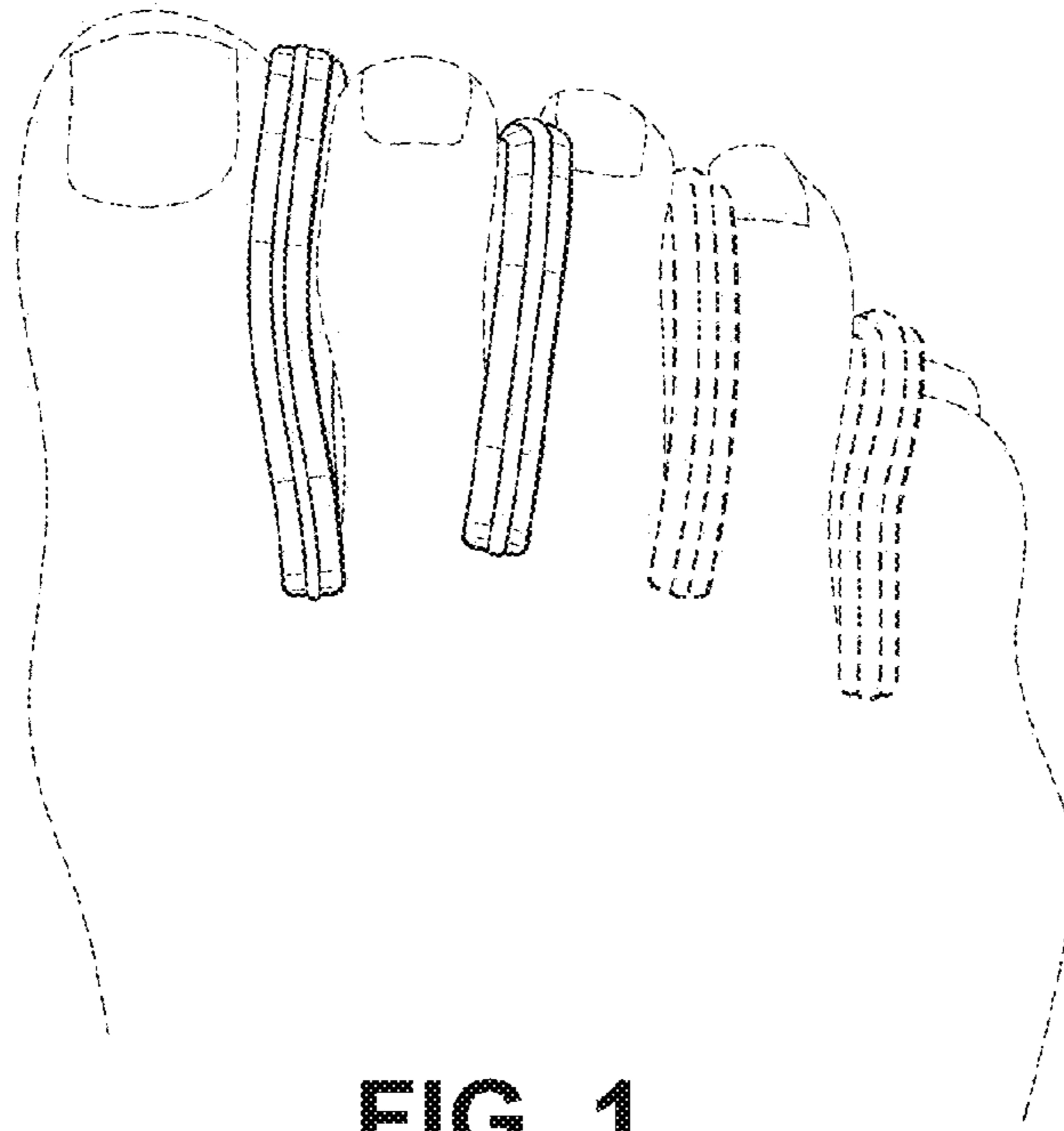

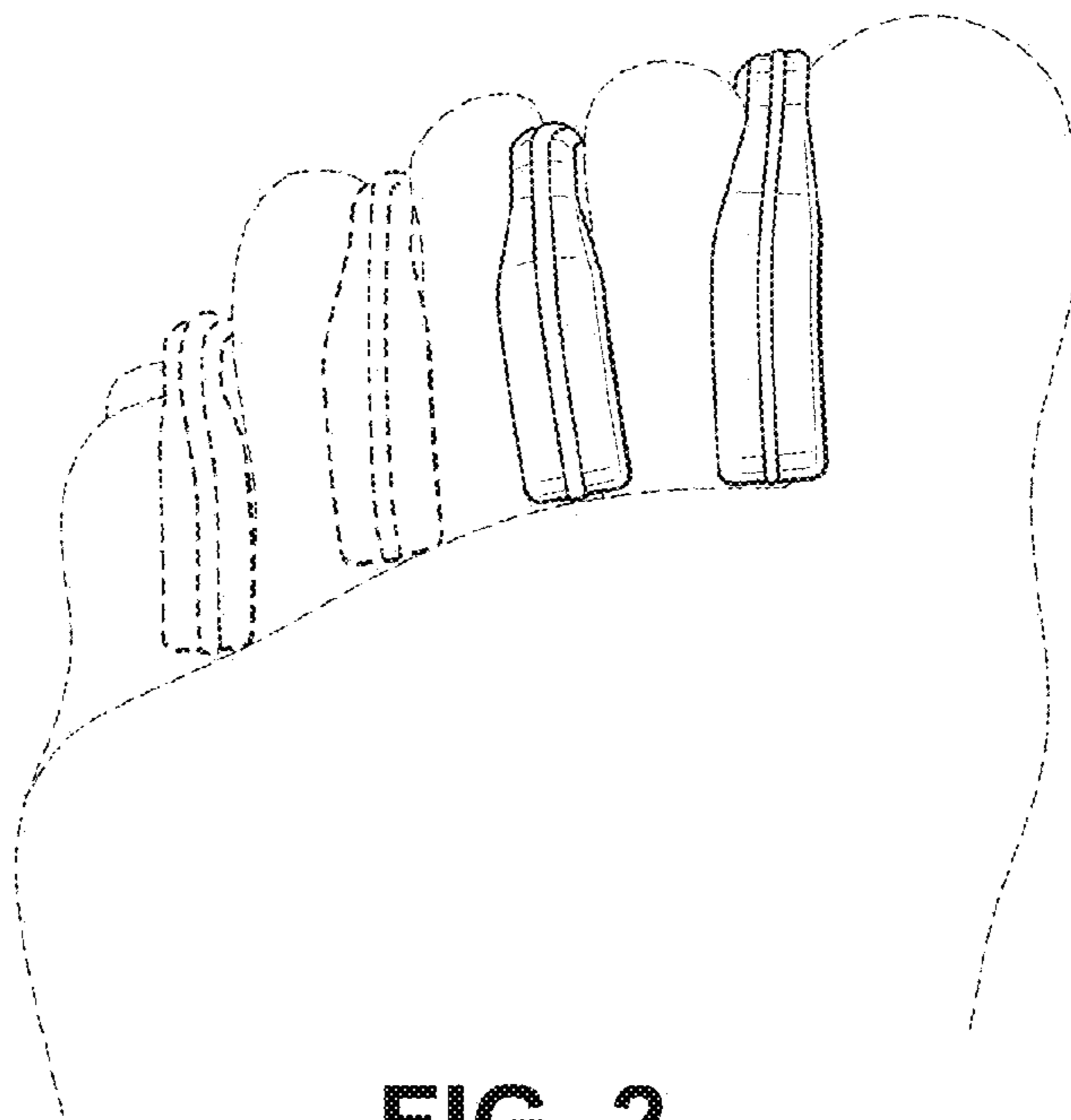

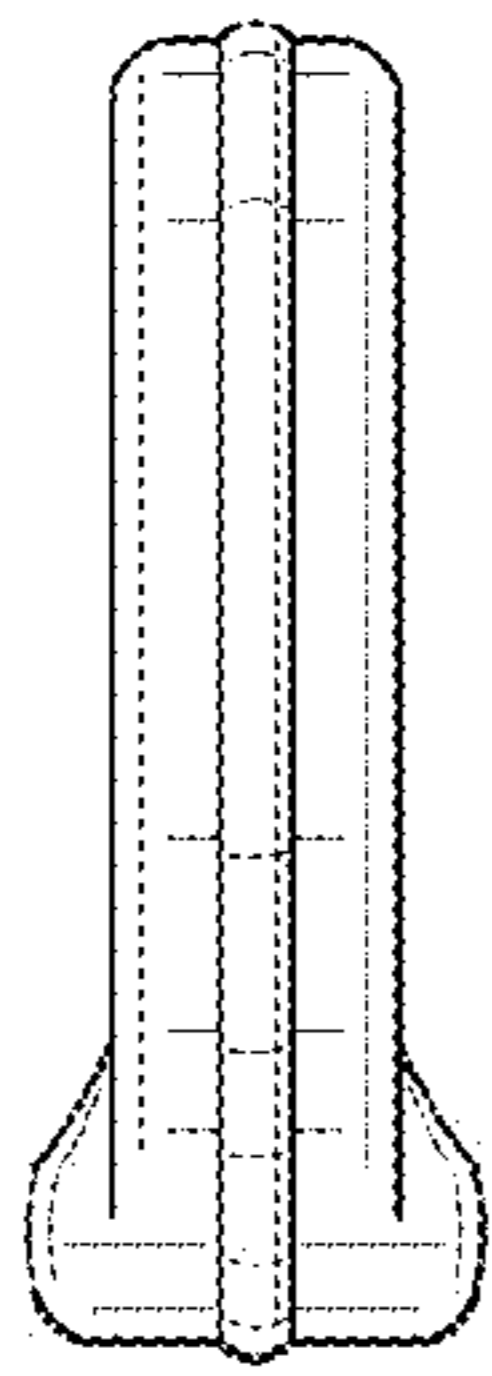

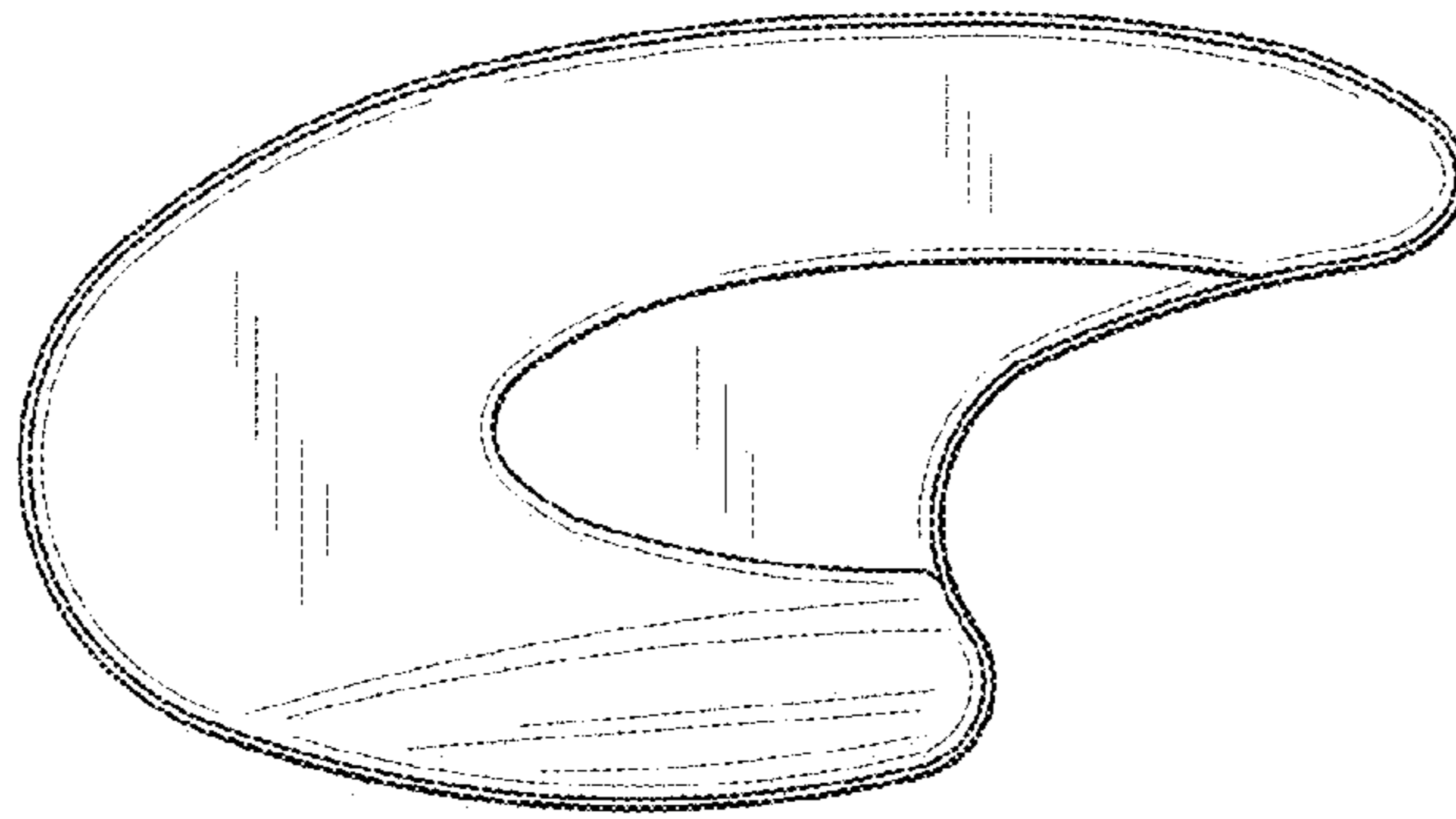

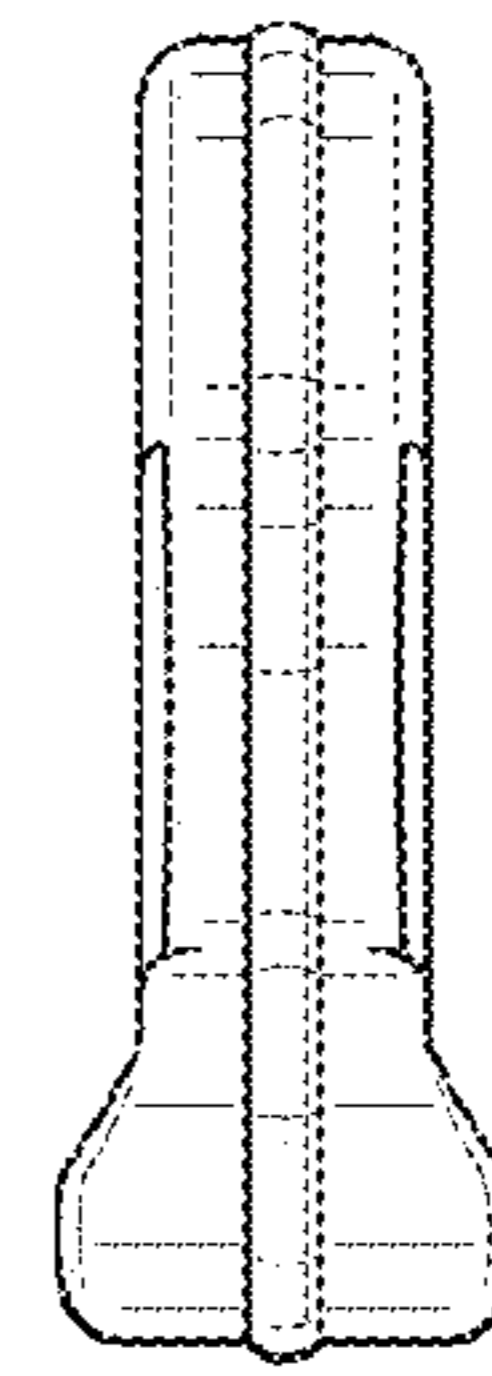

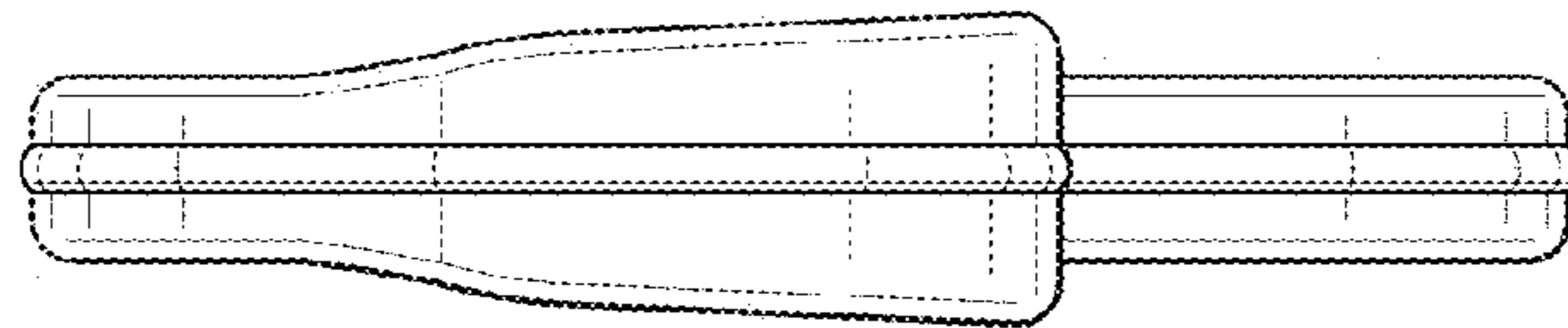

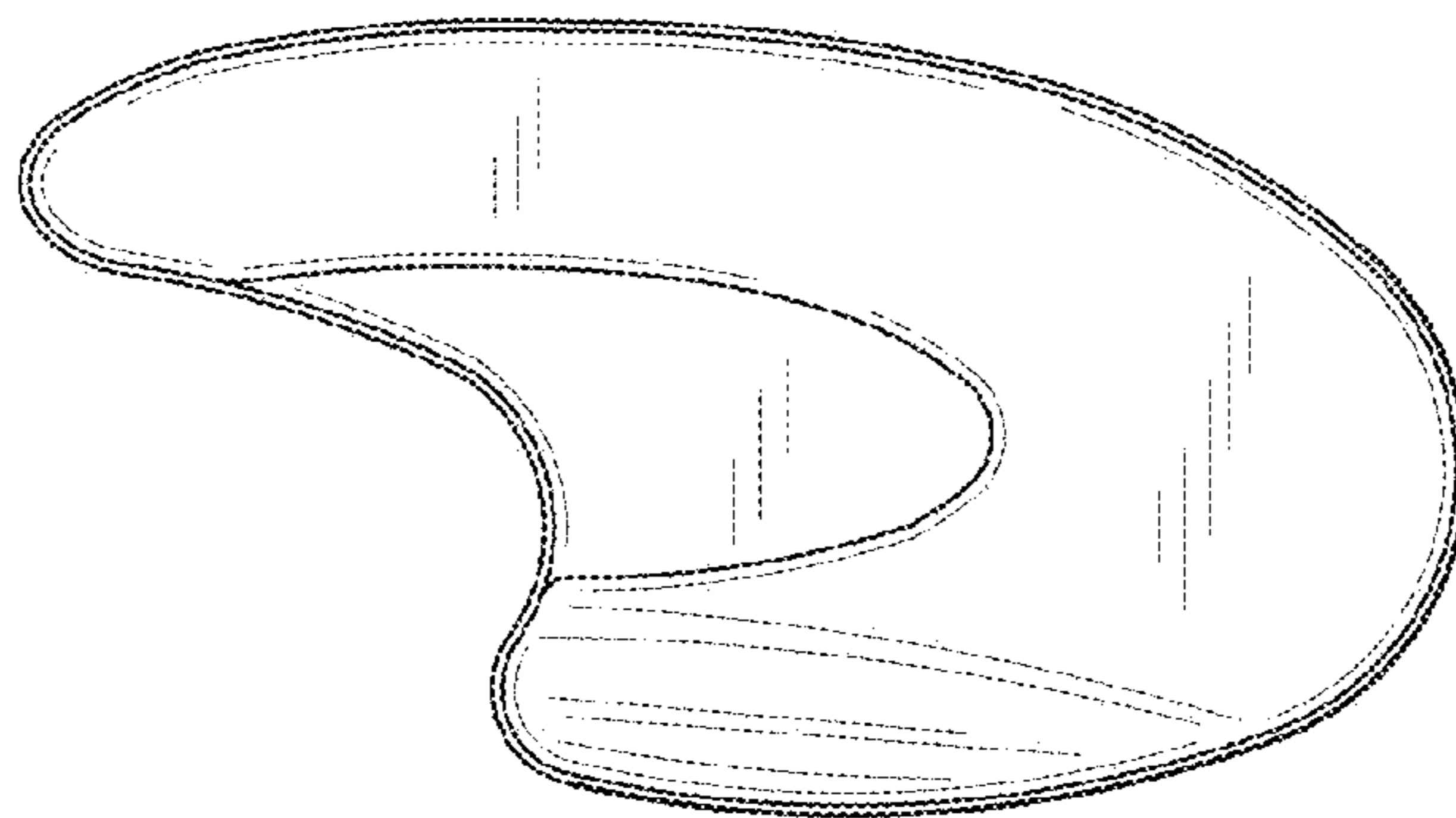

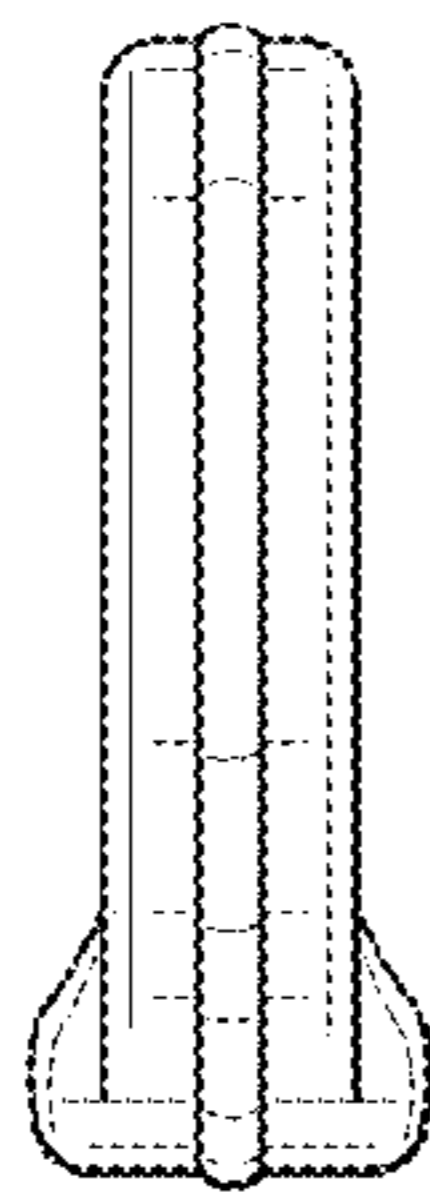

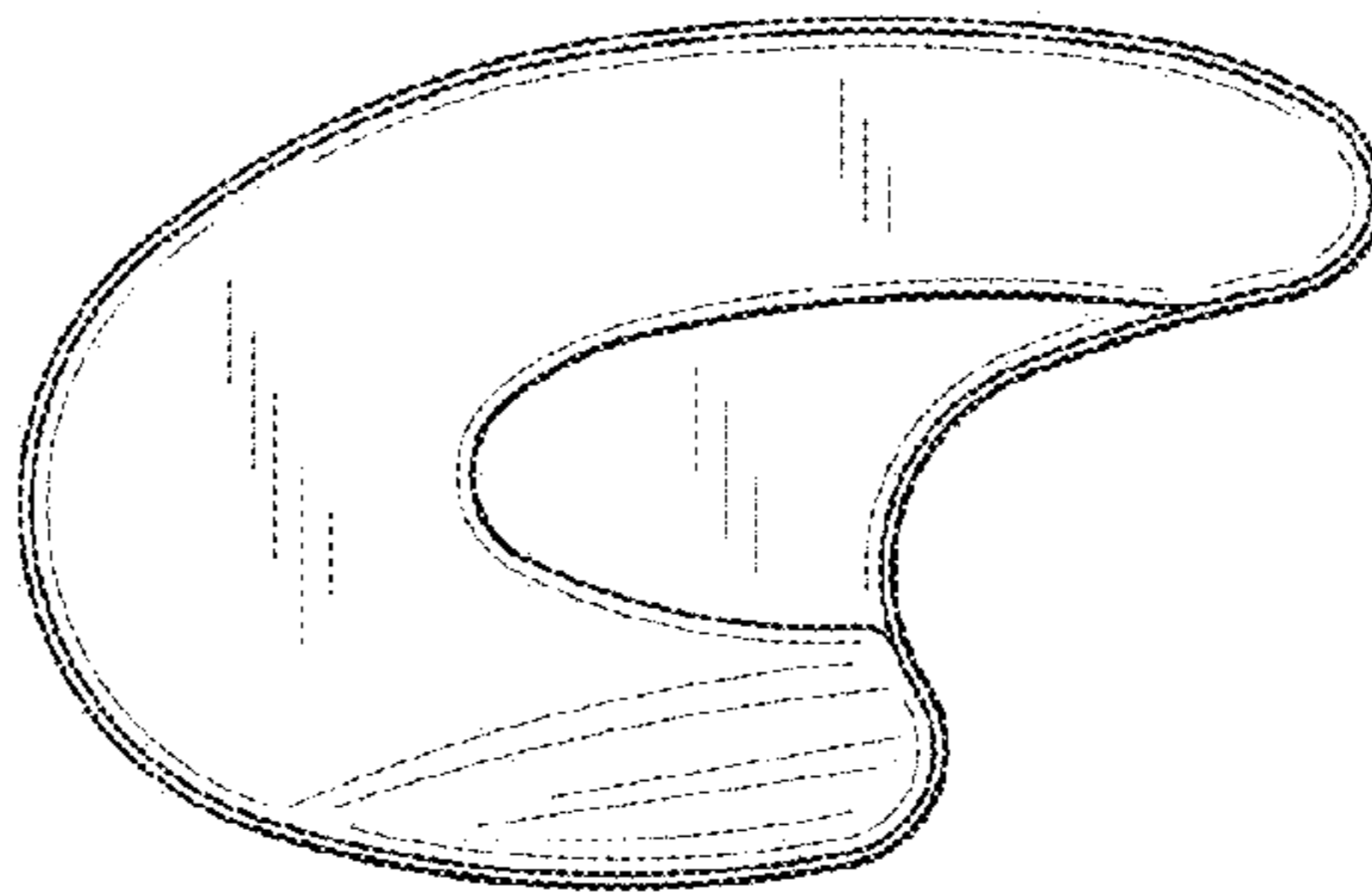

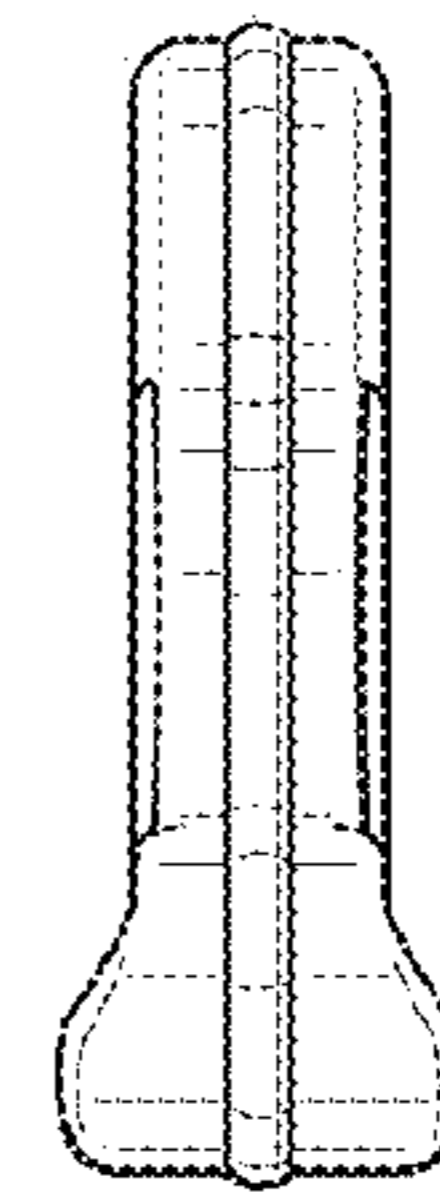

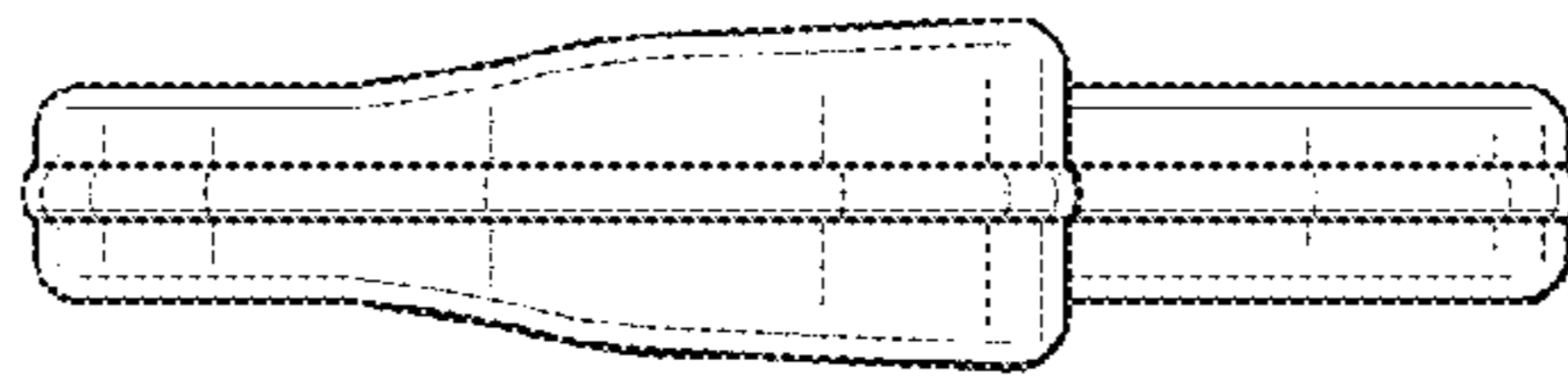

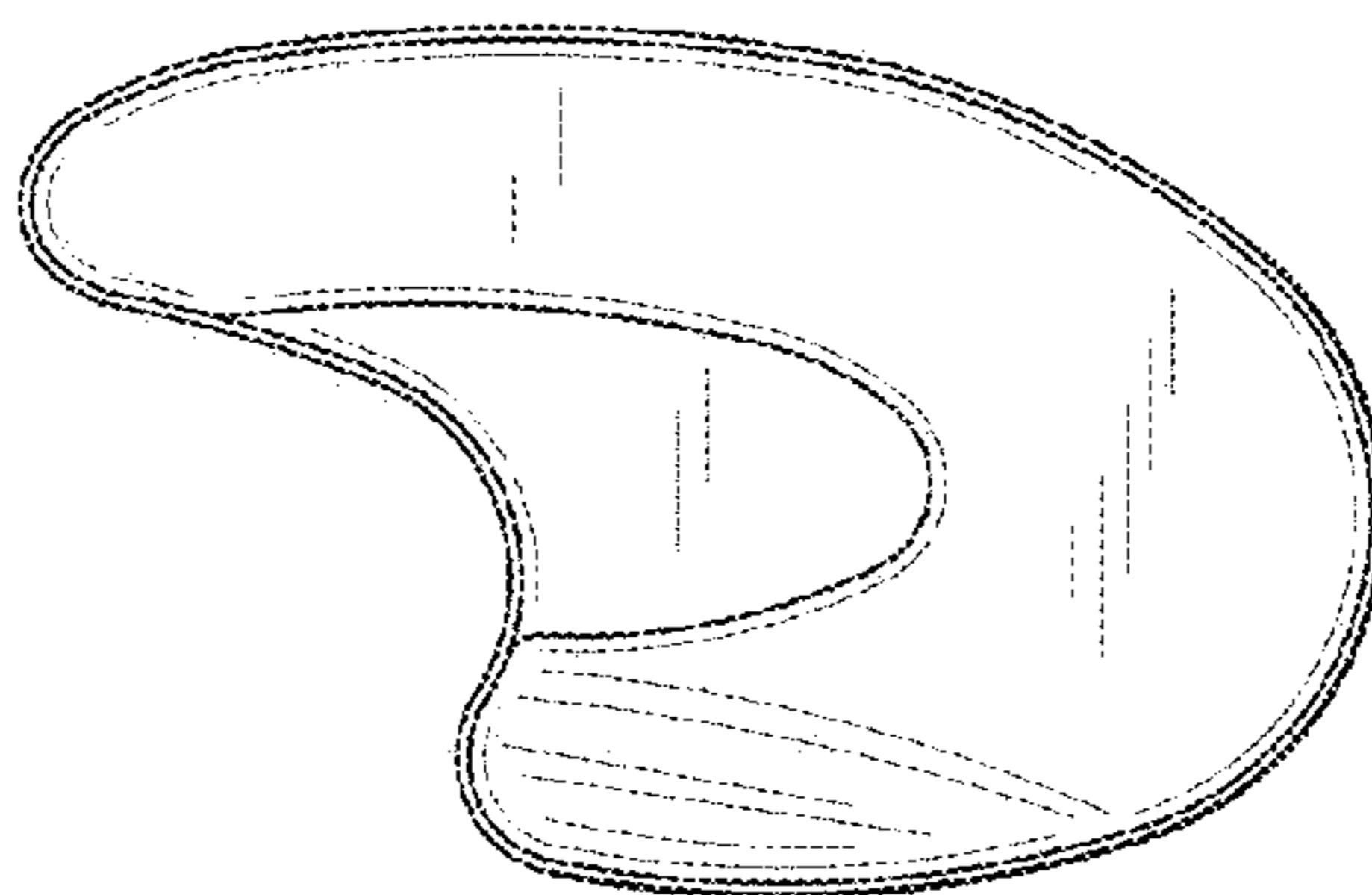
