FIG. 2 represents both right and left side elevational views as they are a mirror image of each other.

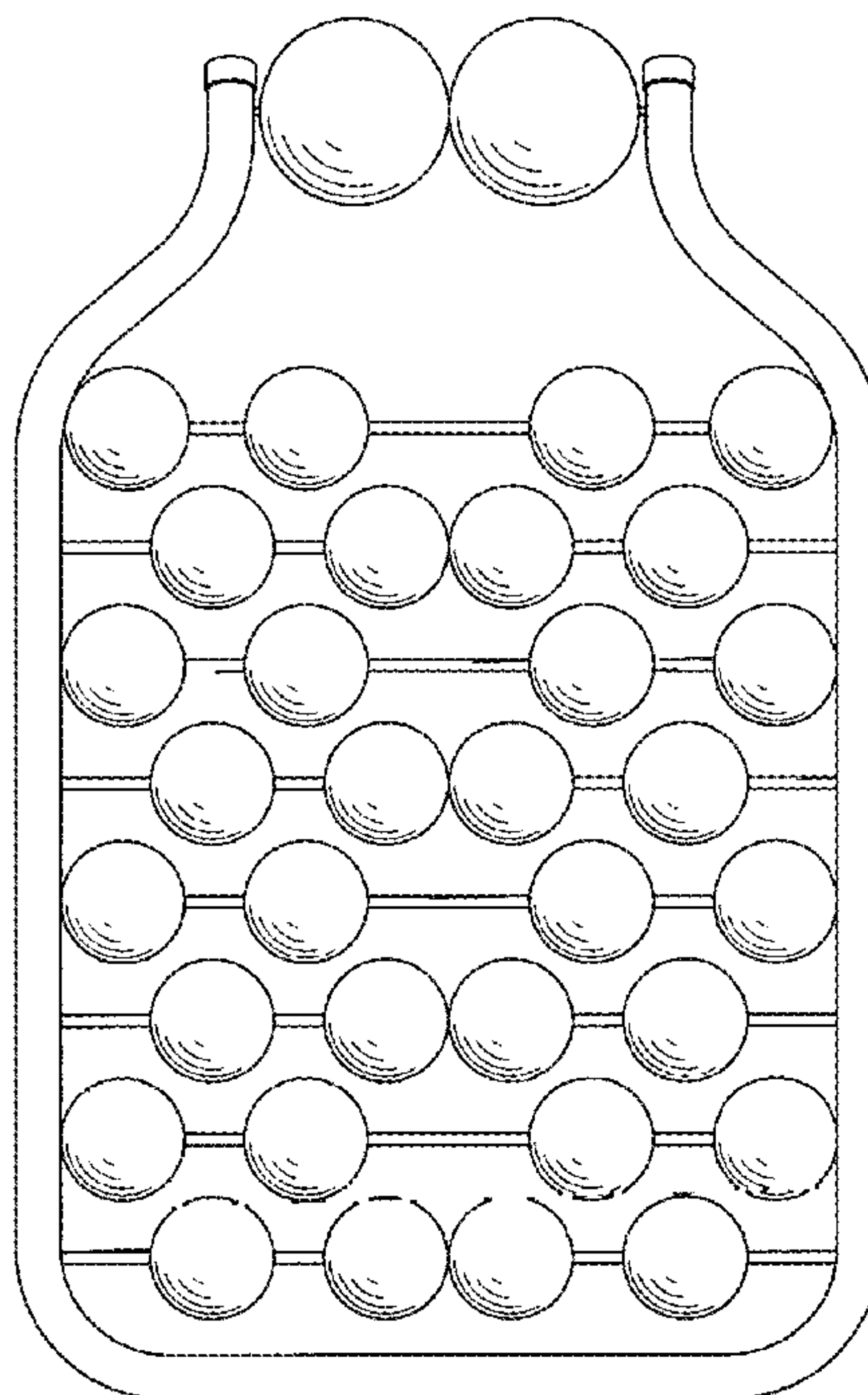
FIG. 3 represents the front elevational view; and,

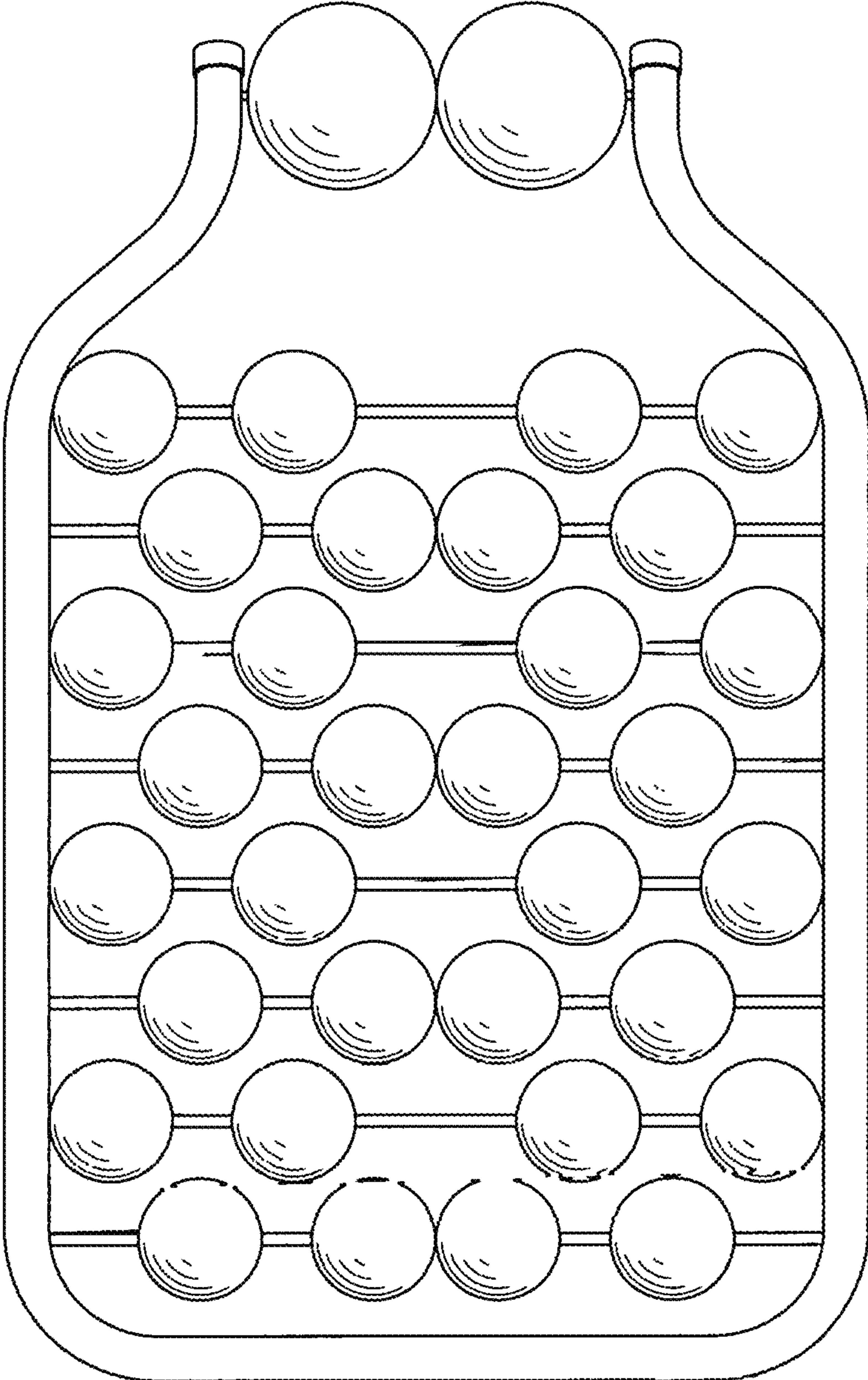

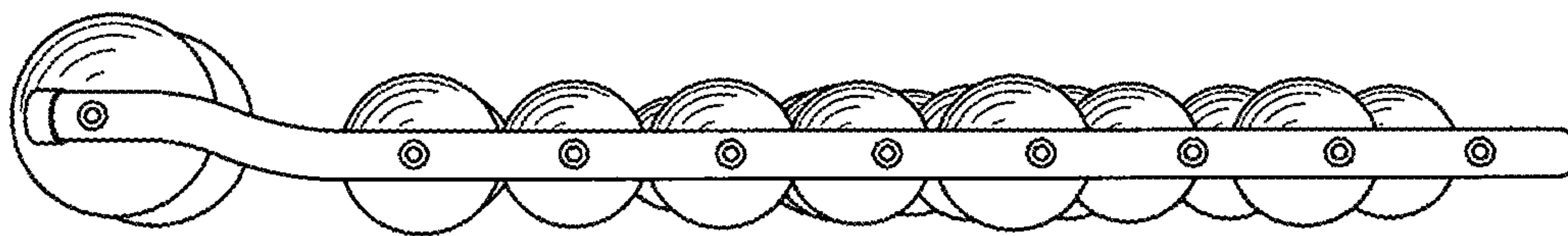

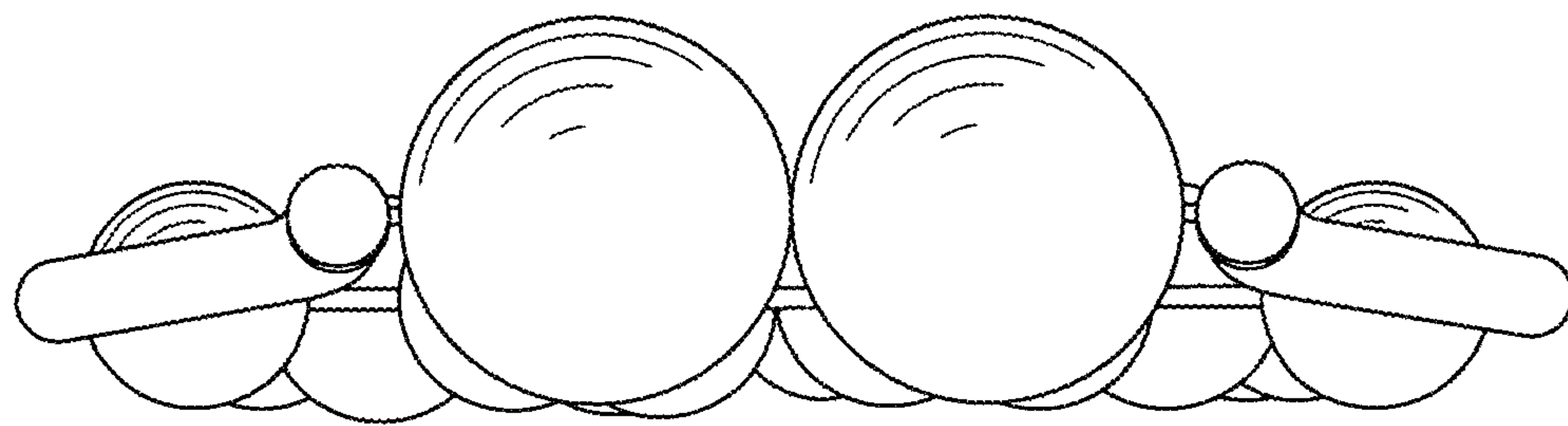

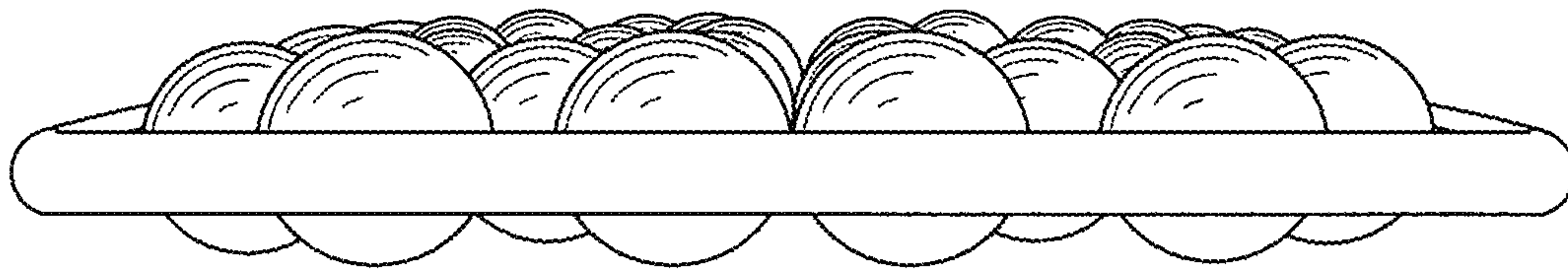
