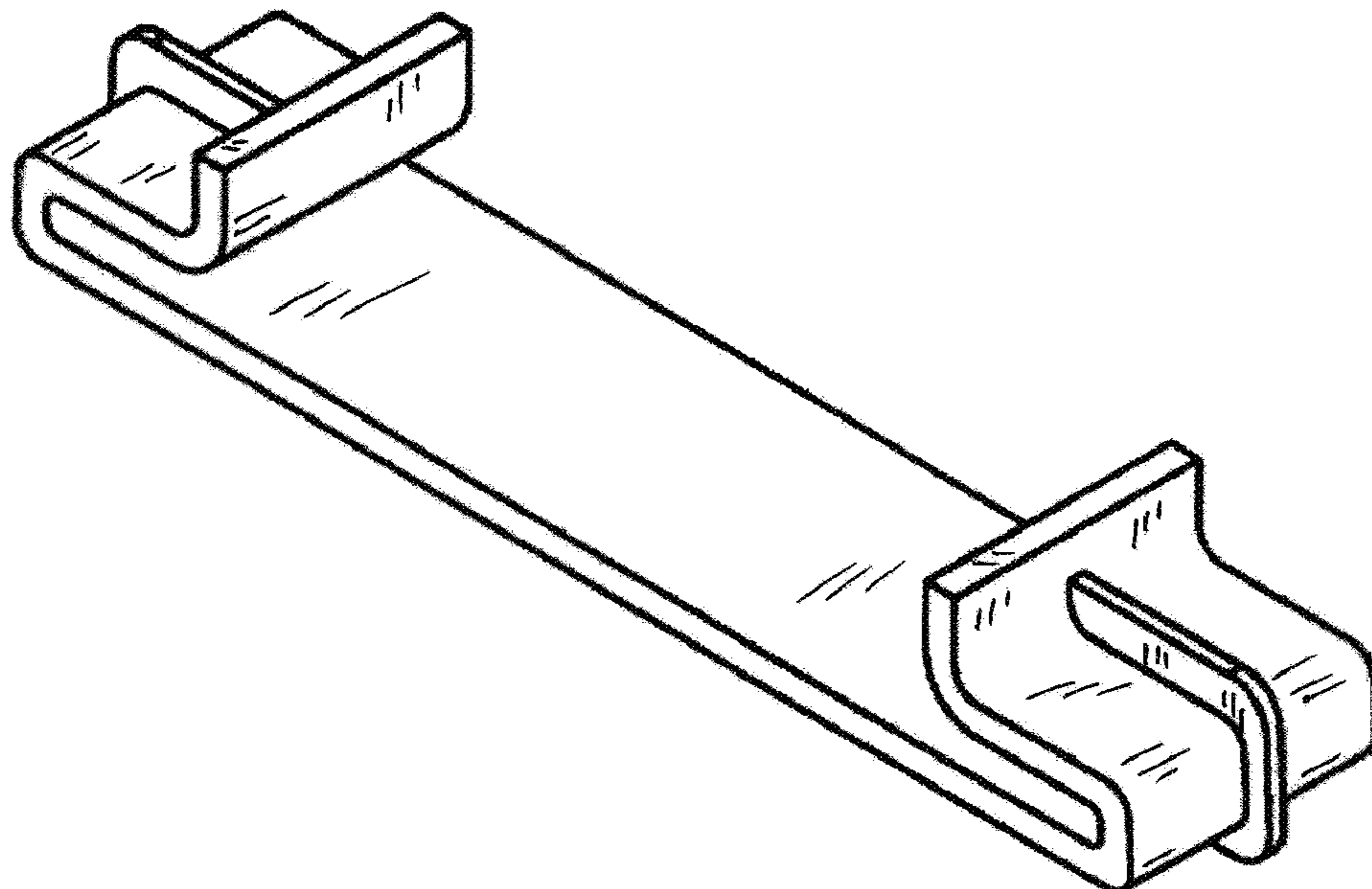
(57) **CLAIM**

The ornamental design for a siding splice joint, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a siding splice joint;  
FIG. 2 is a front elevation view thereof, which is a mirror  
image to the back elevation view thereof;  
FIG. 3 is a top plan view thereof;  
FIG. 4 is a bottom plan view thereof; and,  
FIG. 5 is a left side elevation view thereof, which is a mirror  
image of the right side elevation view.

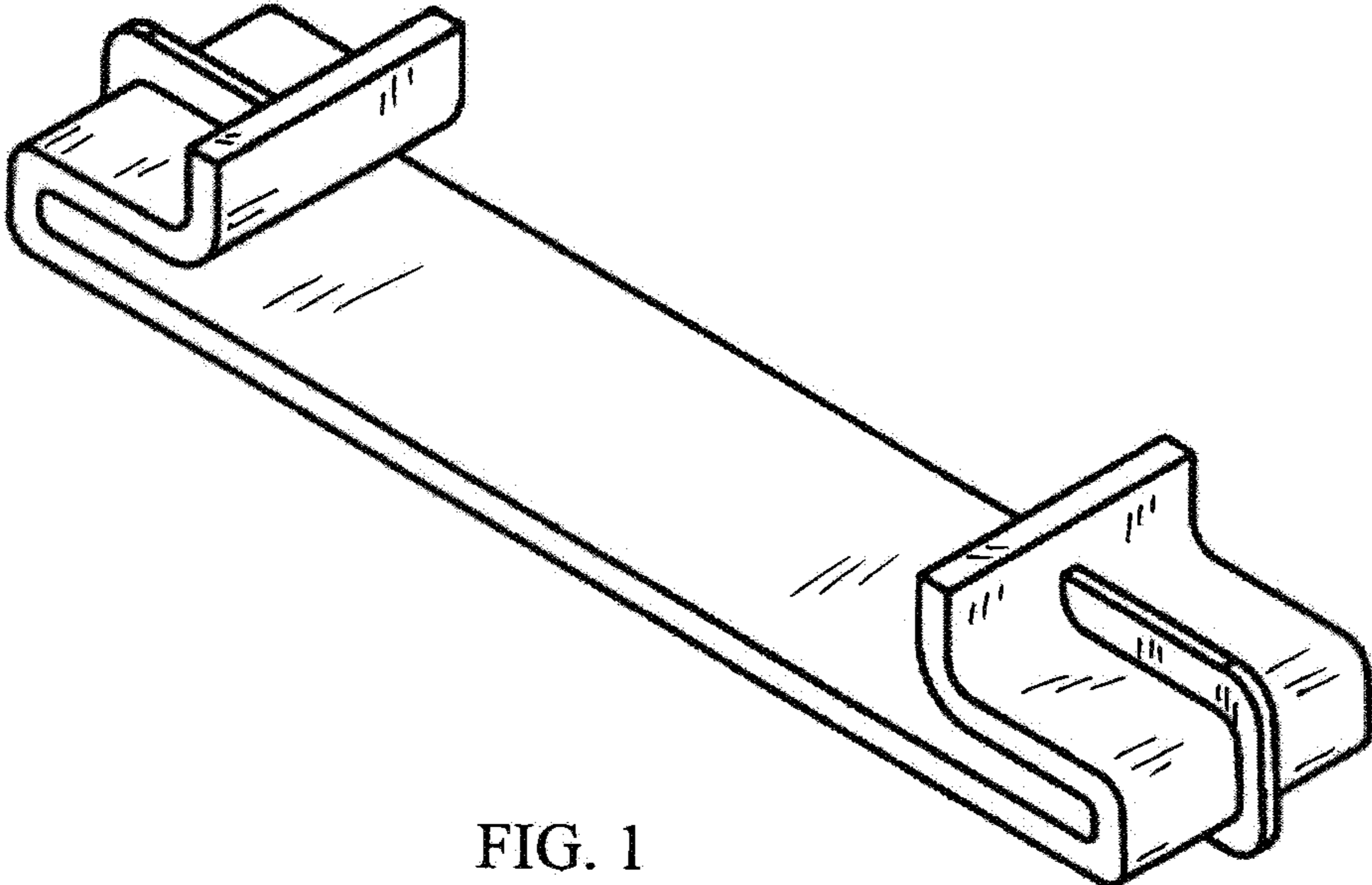

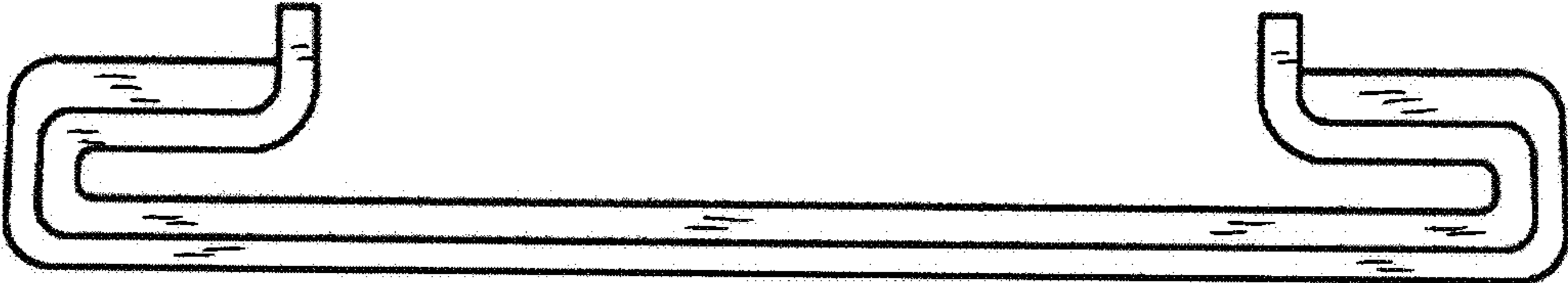

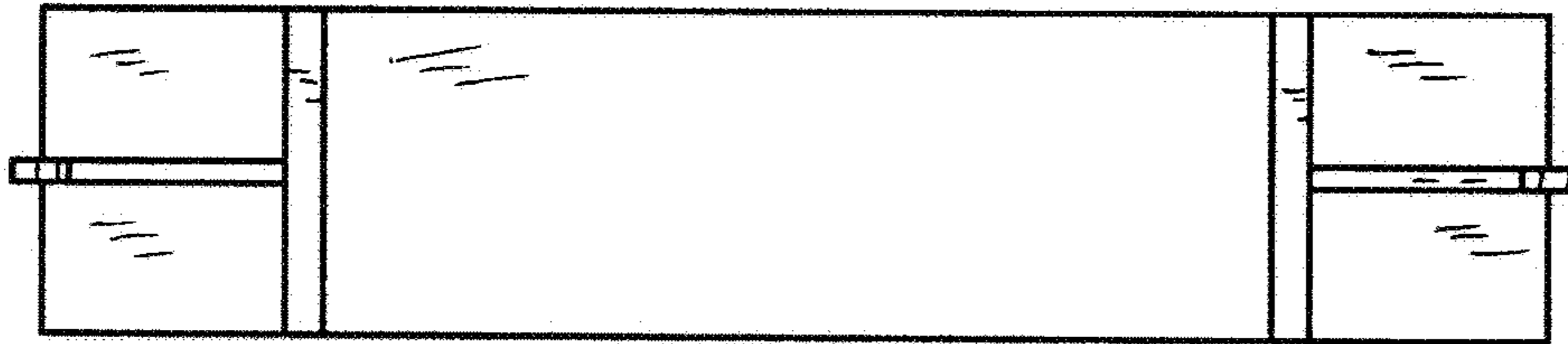

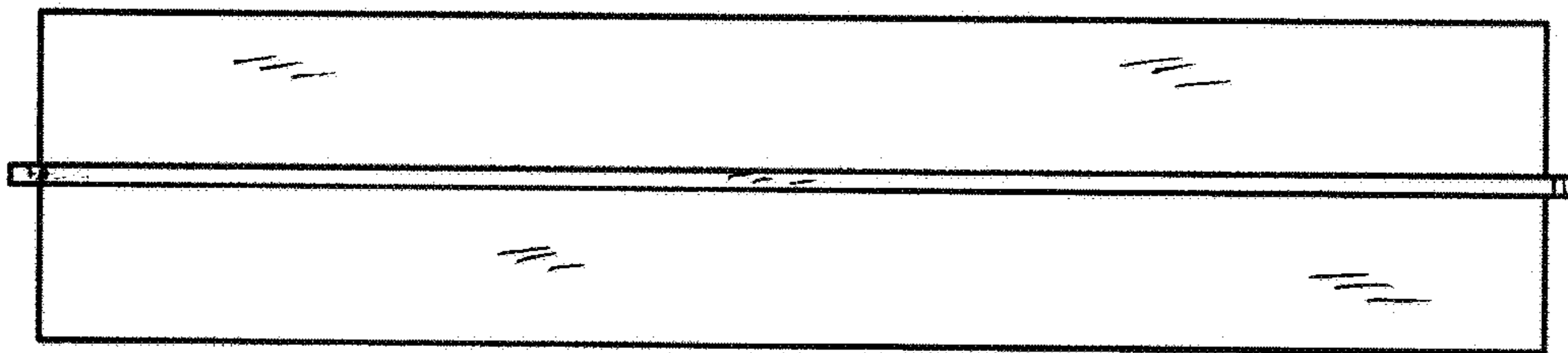

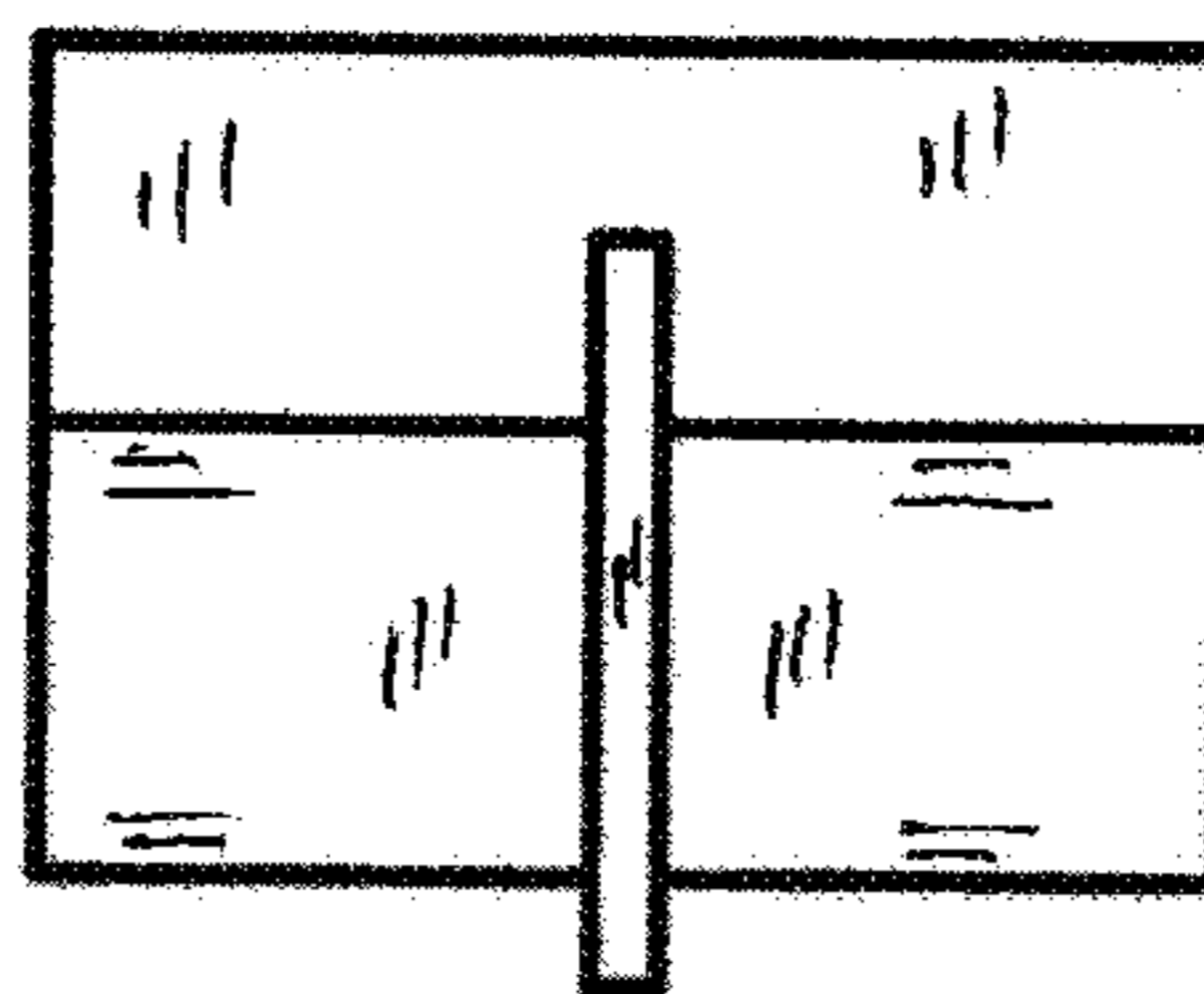
