 FIG. 7 is a bottom view thereof.

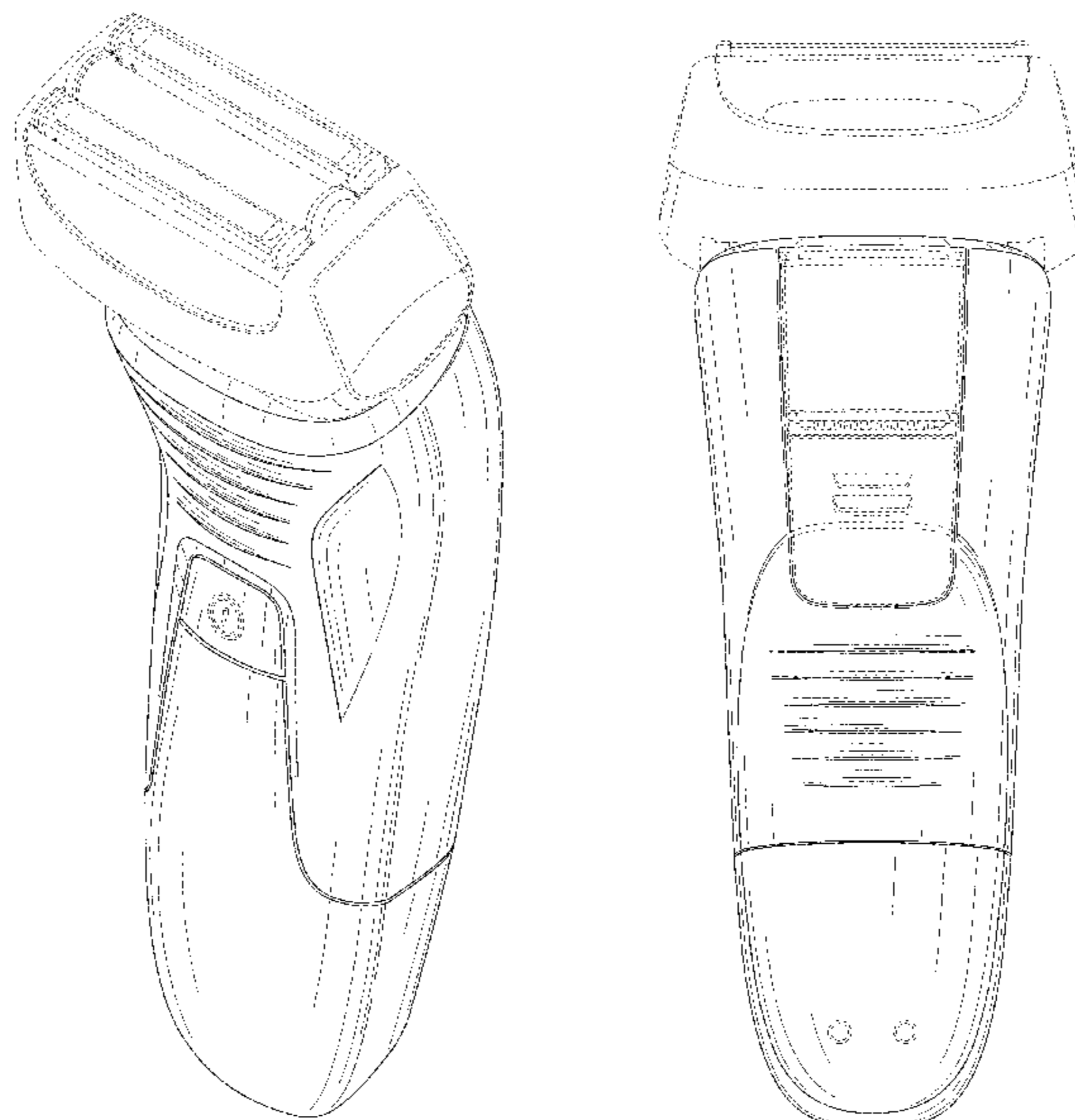
The broken lines are included for the purpose of illustrating the portions of the electronic shaver that form no part of the claimed design.

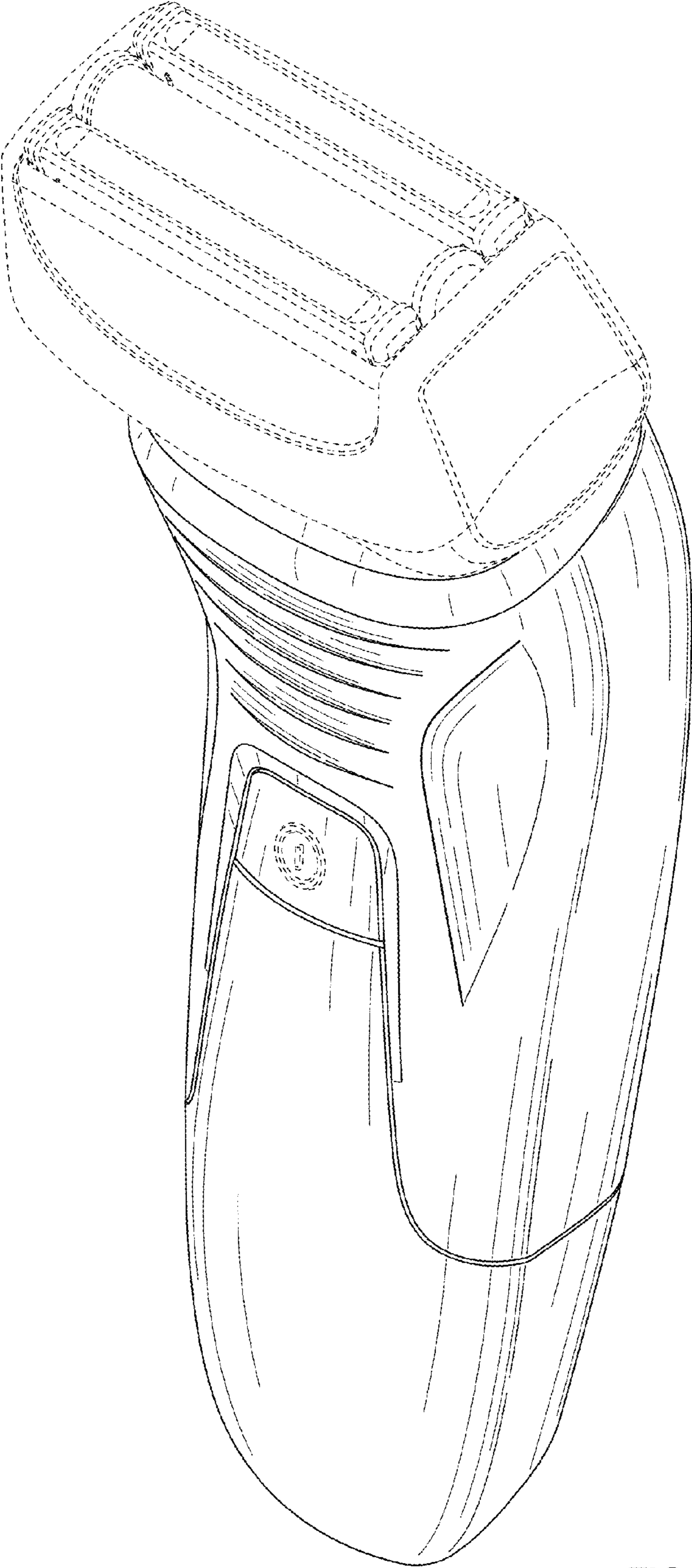

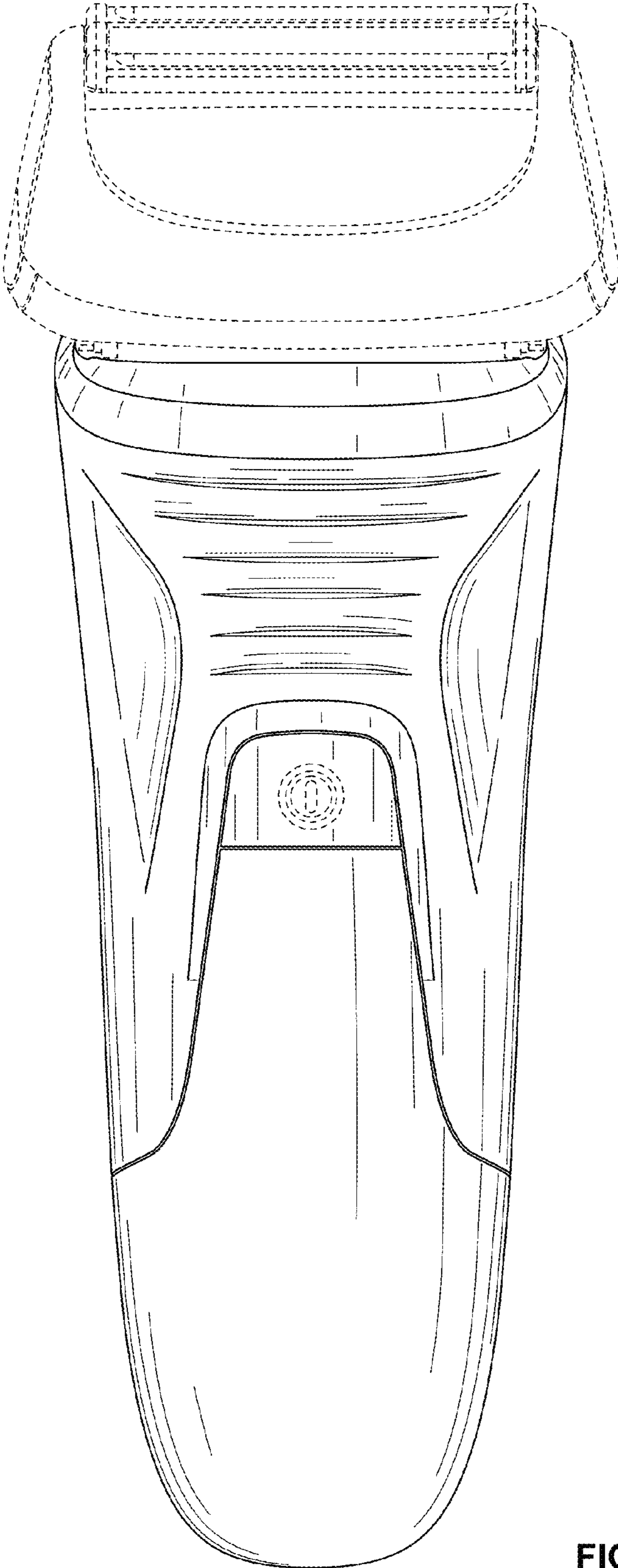

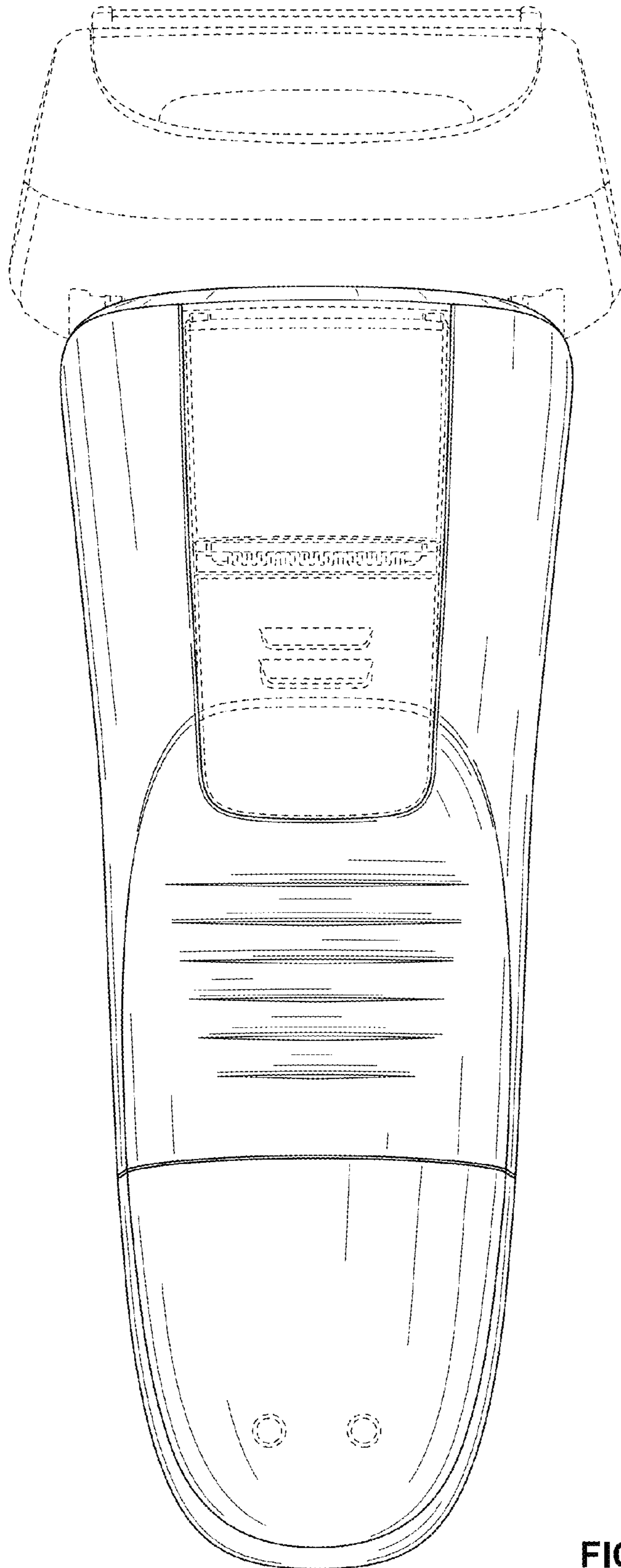

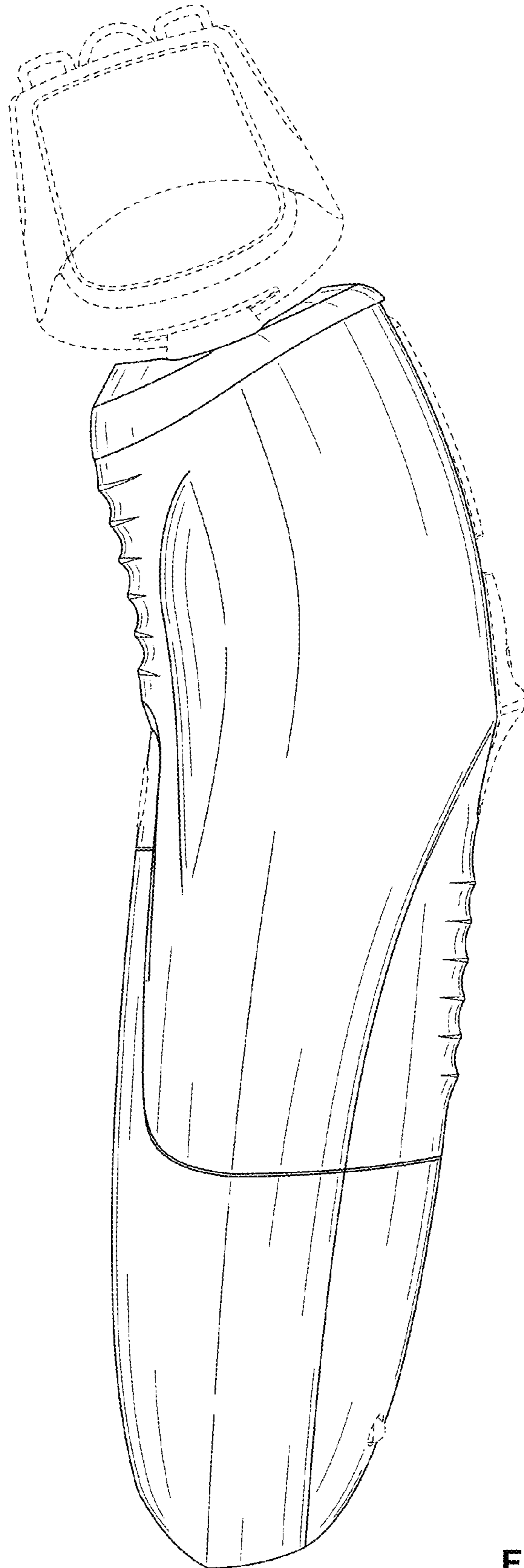

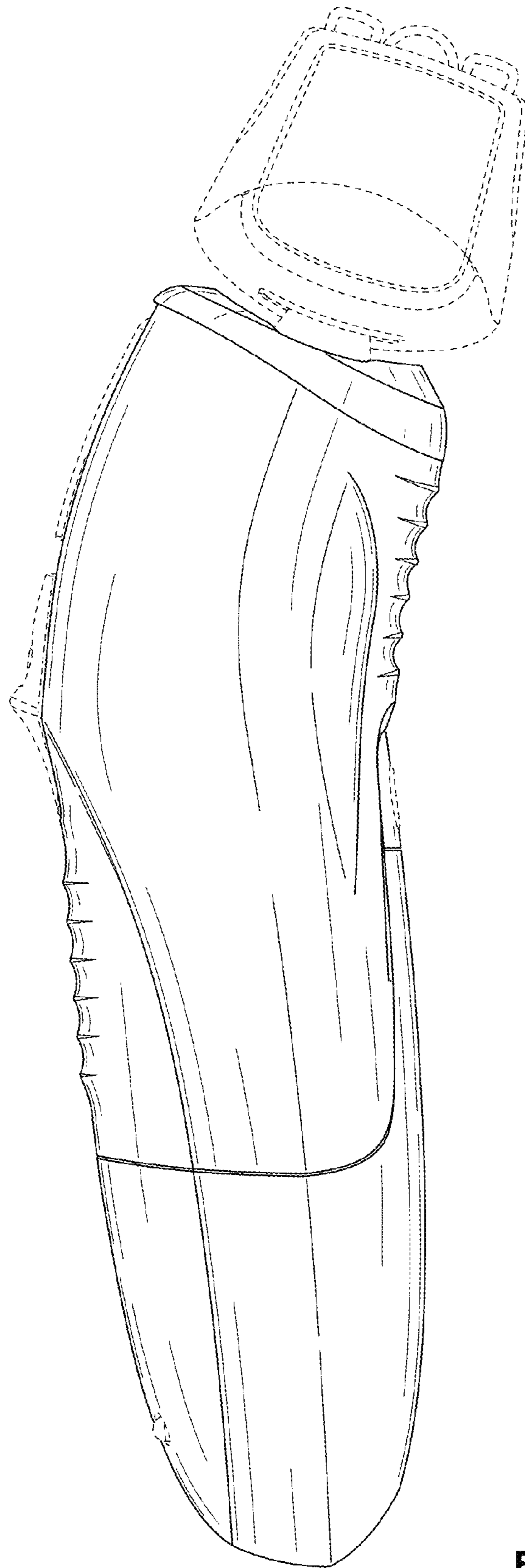

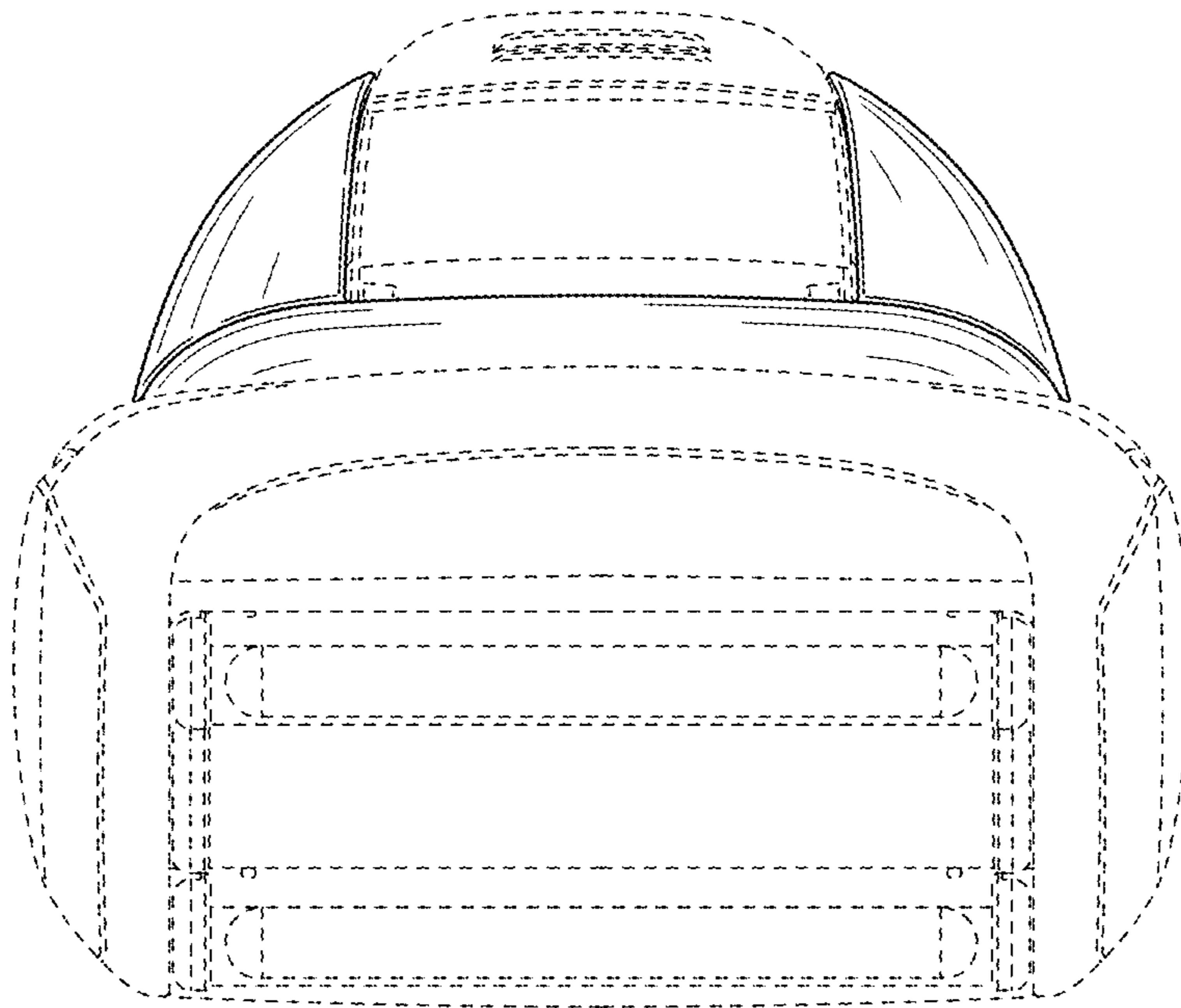

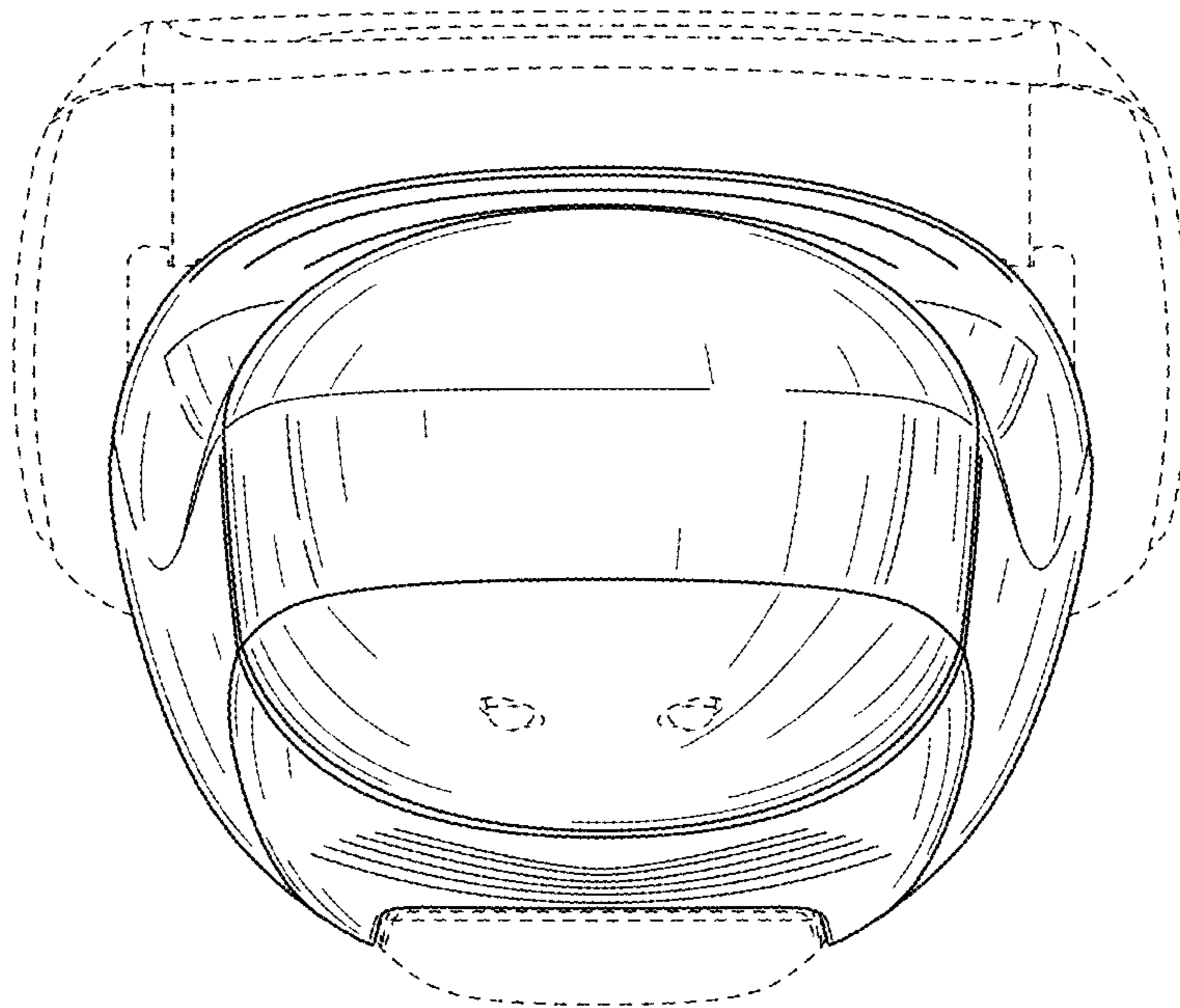
