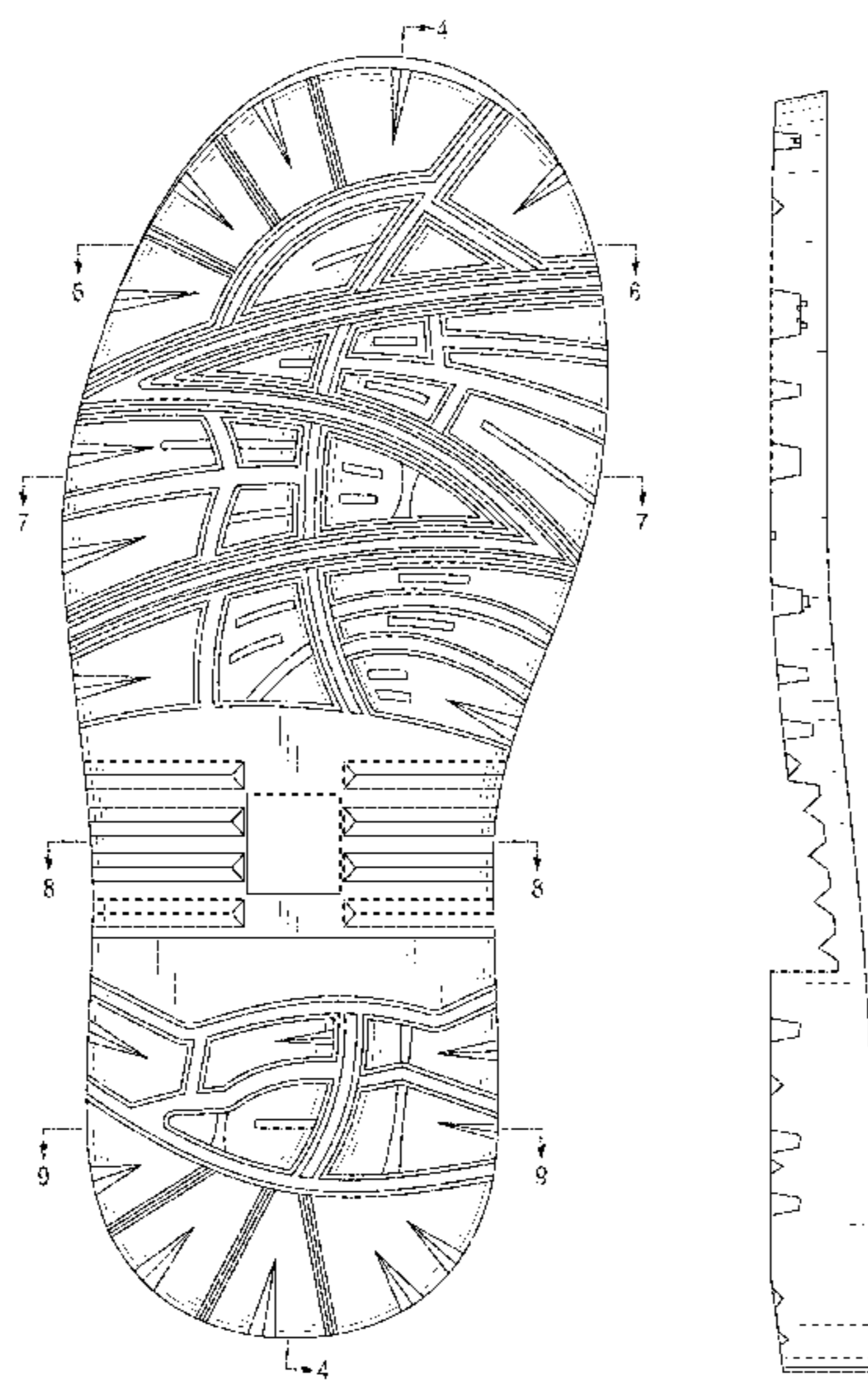
(57) **CLAIM**

What is claimed is the ornamental design for a boot outsole,
as shown and described.

DESCRIPTION

FIG. 1 is a right side view of a boot outsole showing our new design;
FIG. 2 is a bottom view thereof;
FIG. 3 is a left side view thereof;
FIG. 4 is cross-section view thereof, as indicated in FIG. 2;
FIG. 5 is a top view thereof;
FIG. 6 is a cross-section view thereof, as indicated in FIG. 2;
FIG. 7 is a cross-section view thereof, as indicated in FIG. 2;
FIG. 8 is a cross-section view thereof, as indicated in FIG. 2;
FIG. 9 is a cross-section view thereof, as indicated in FIG. 2;
FIG. 10 is a rear view thereof;
FIG. 11 is a front side view thereof; and,
FIG. 12 is a bottom perspective view thereof.
The numerals and labels of FIGS. 6-9 form no part of the claimed design.
The boot upper depicted in broken lines in FIGS. 10-12 shows the environment of the design, and forms no part of the design.

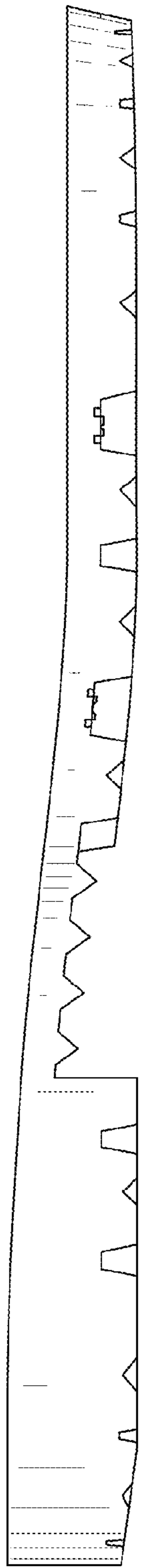

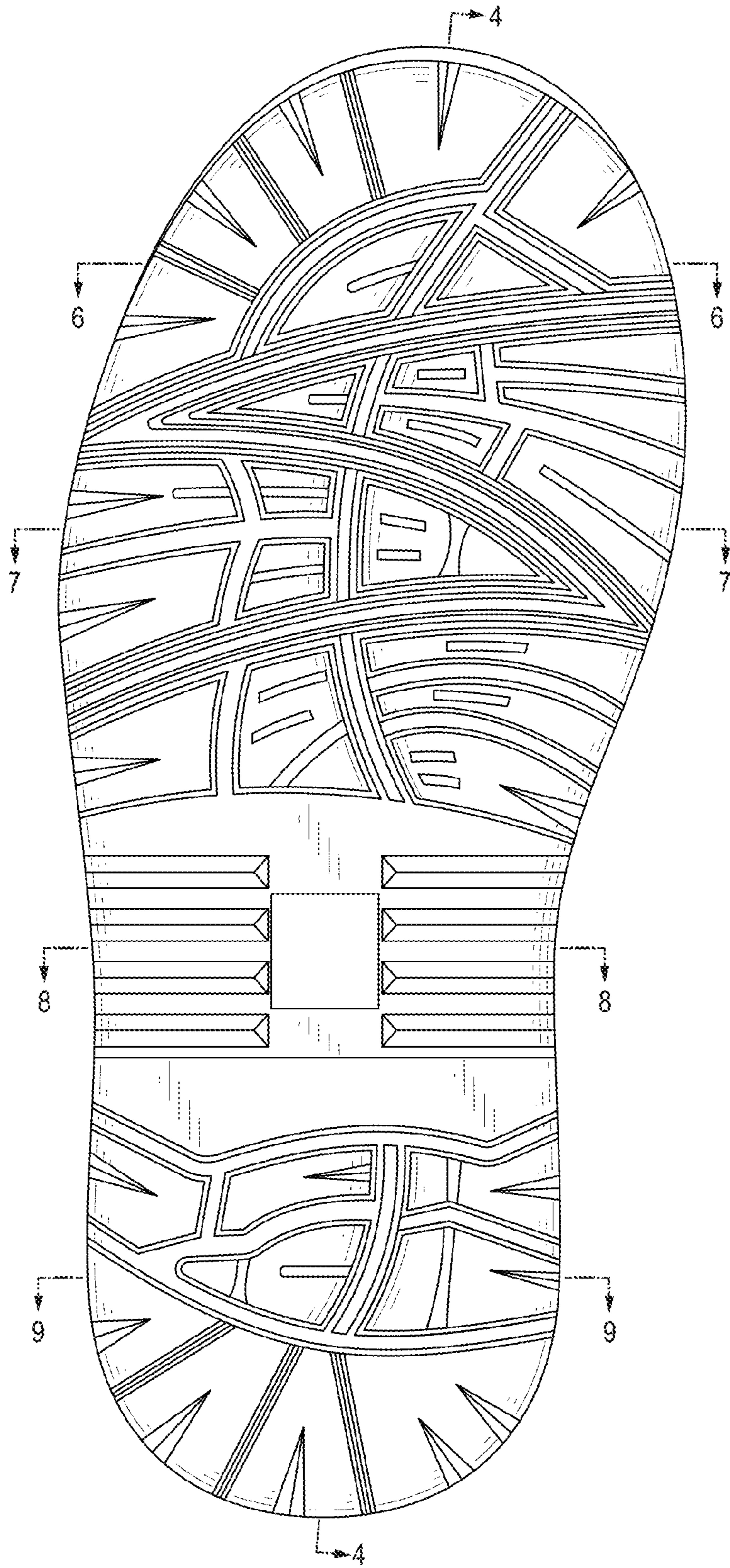

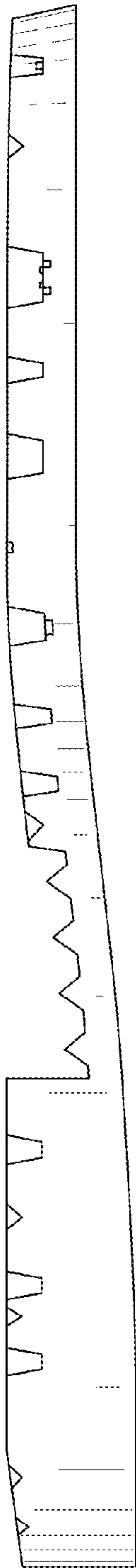

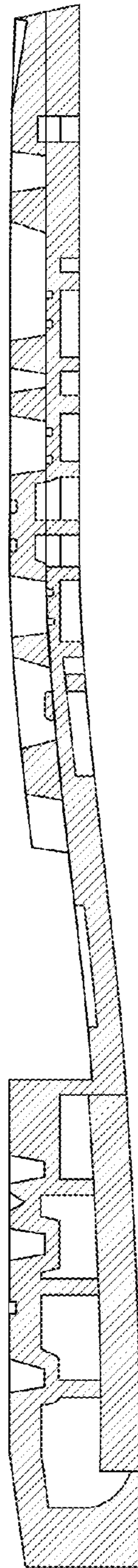

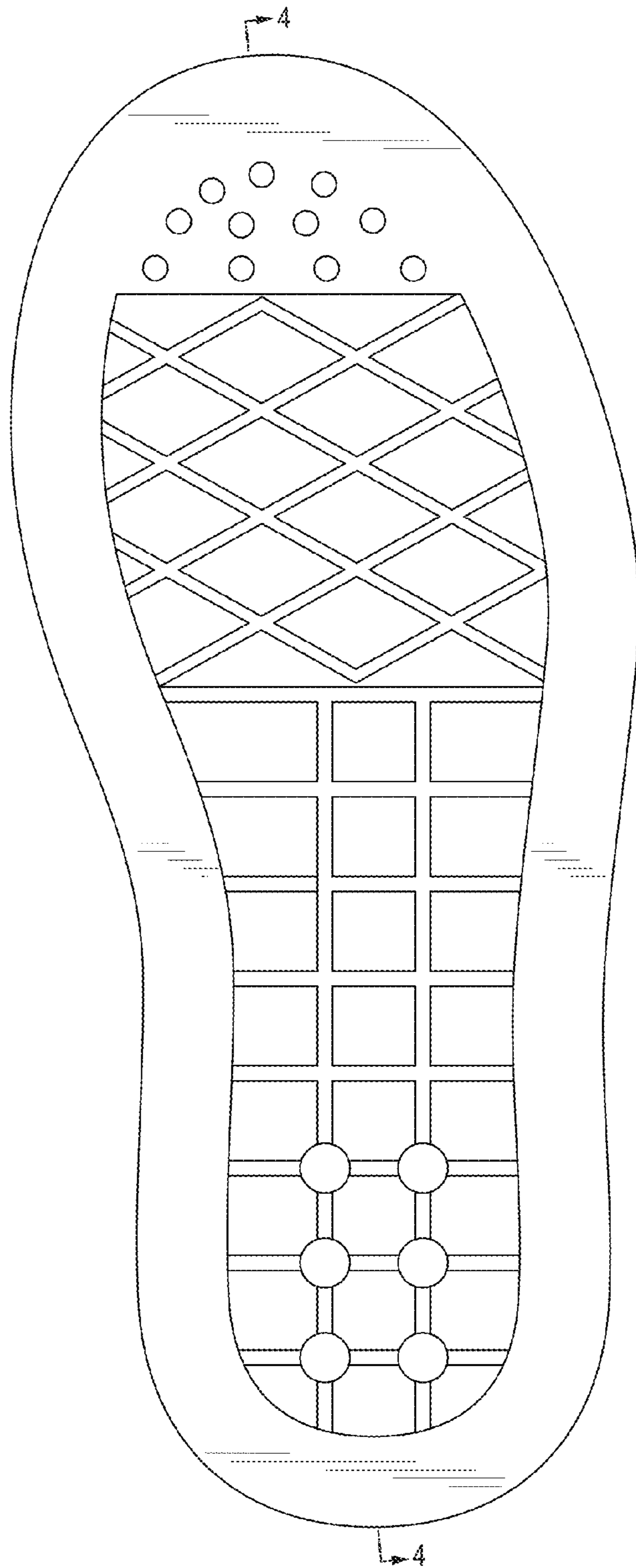

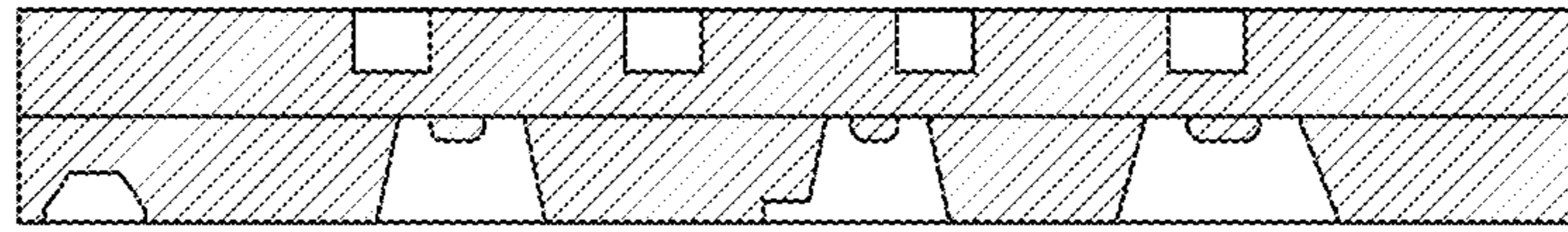

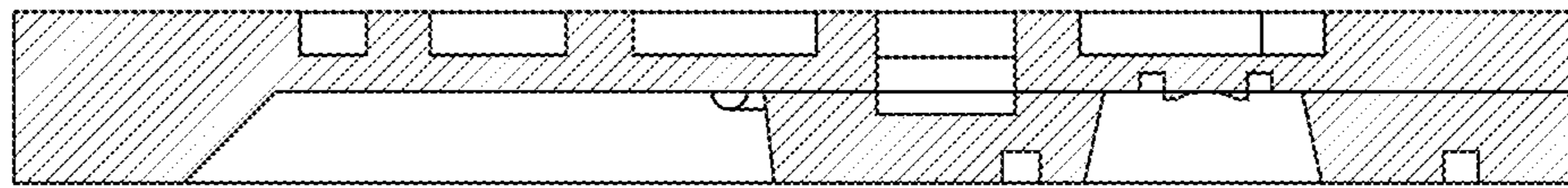

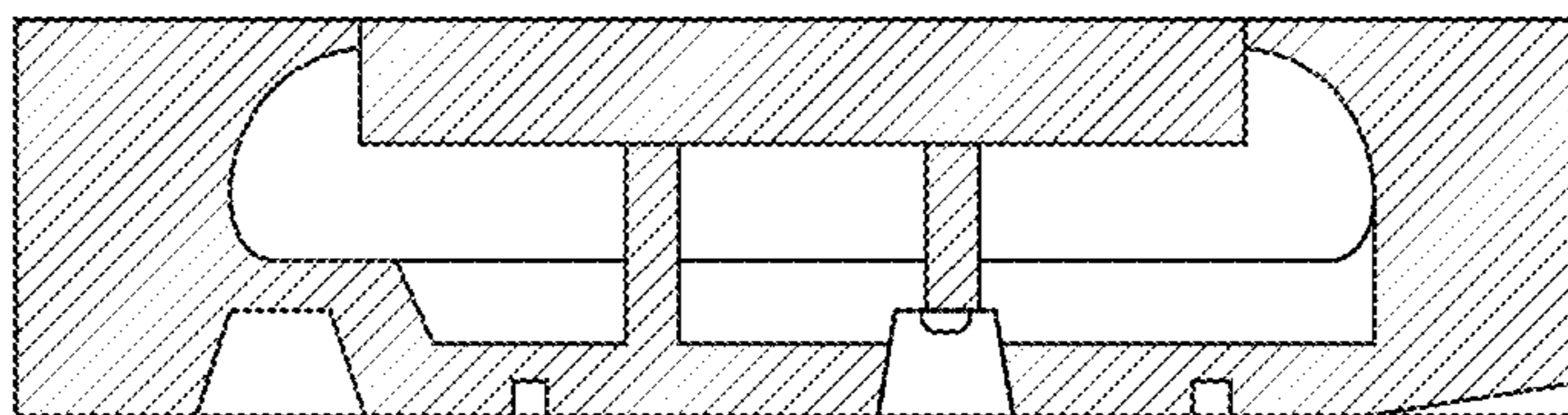

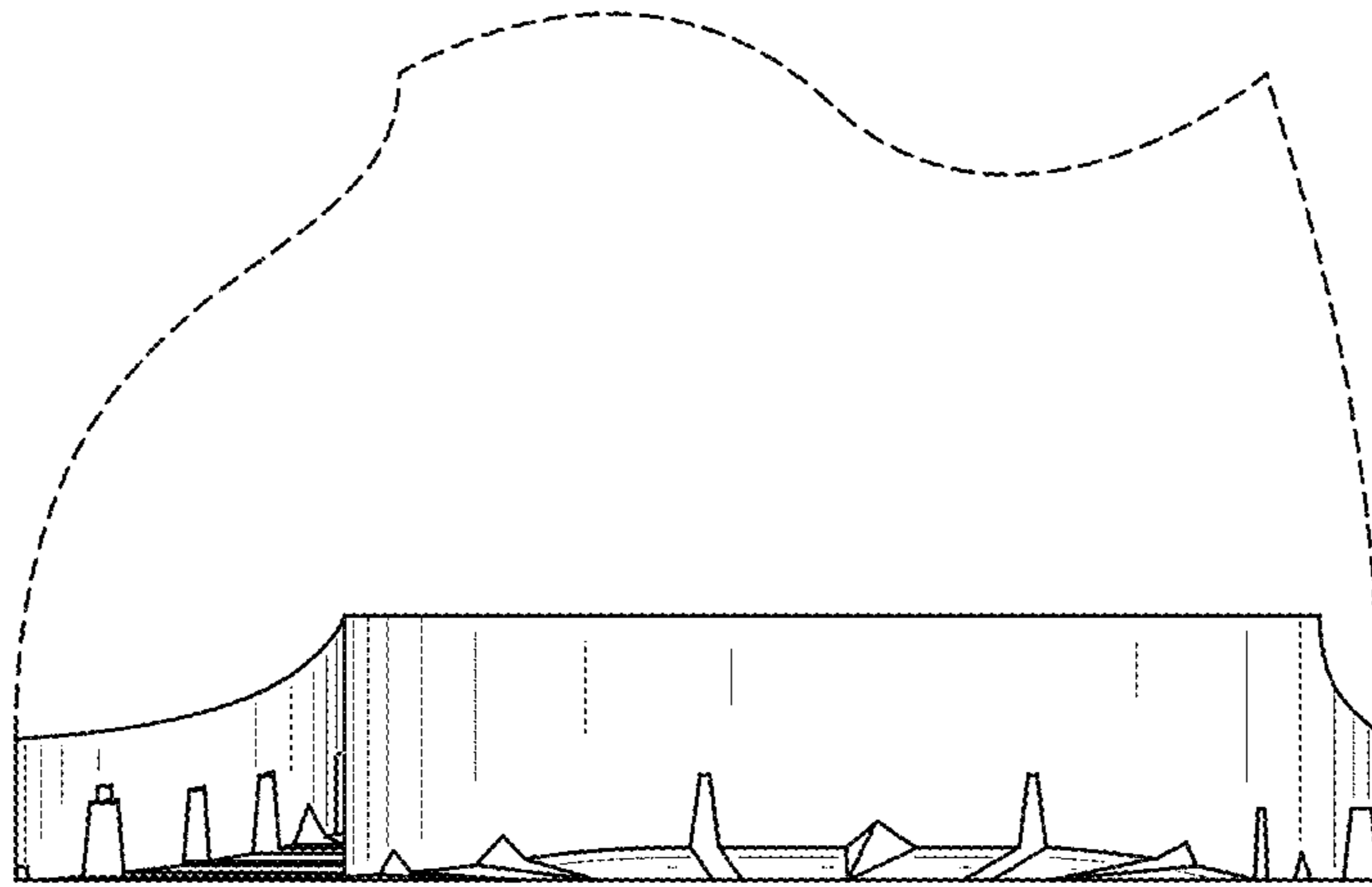

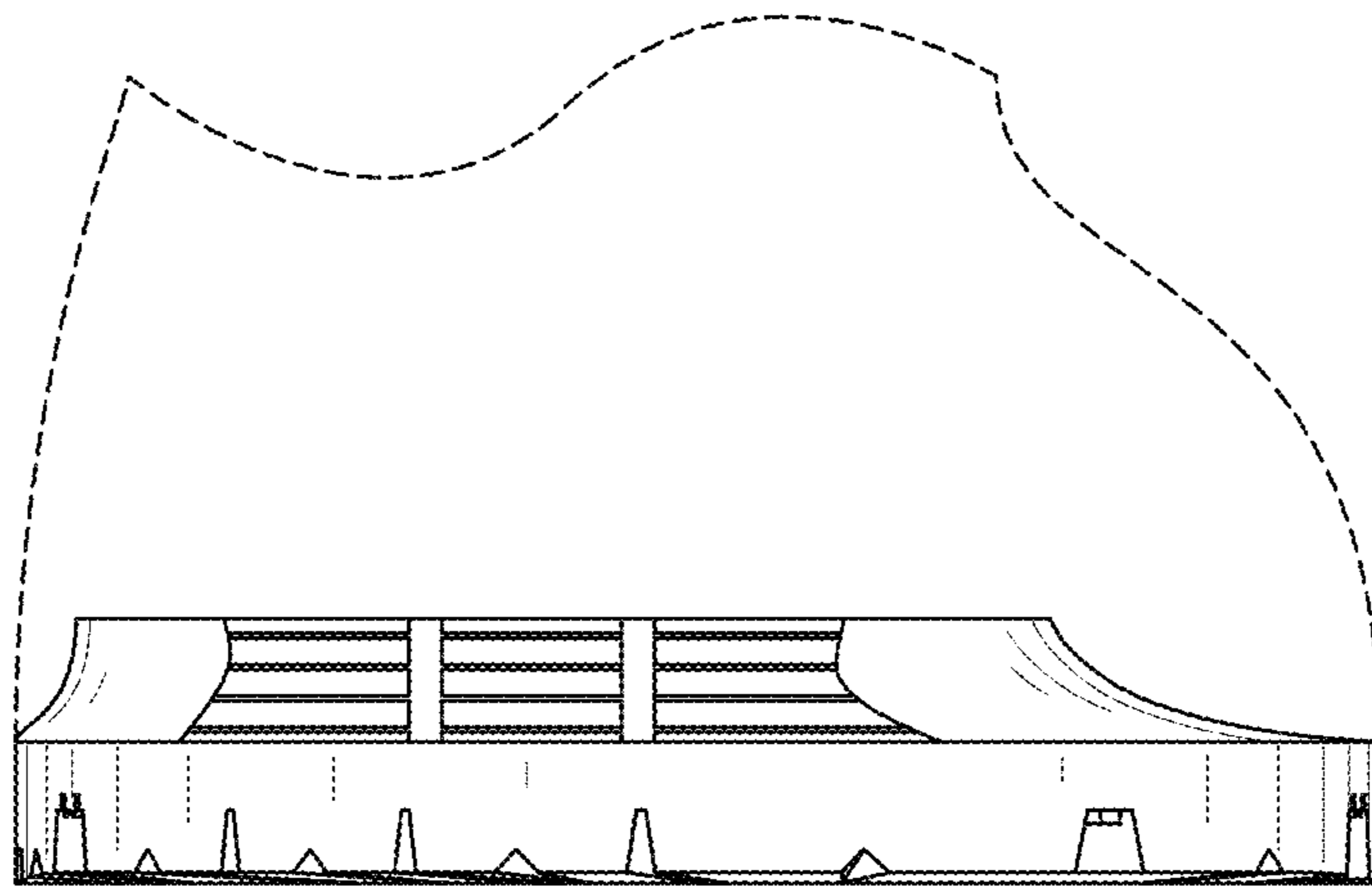

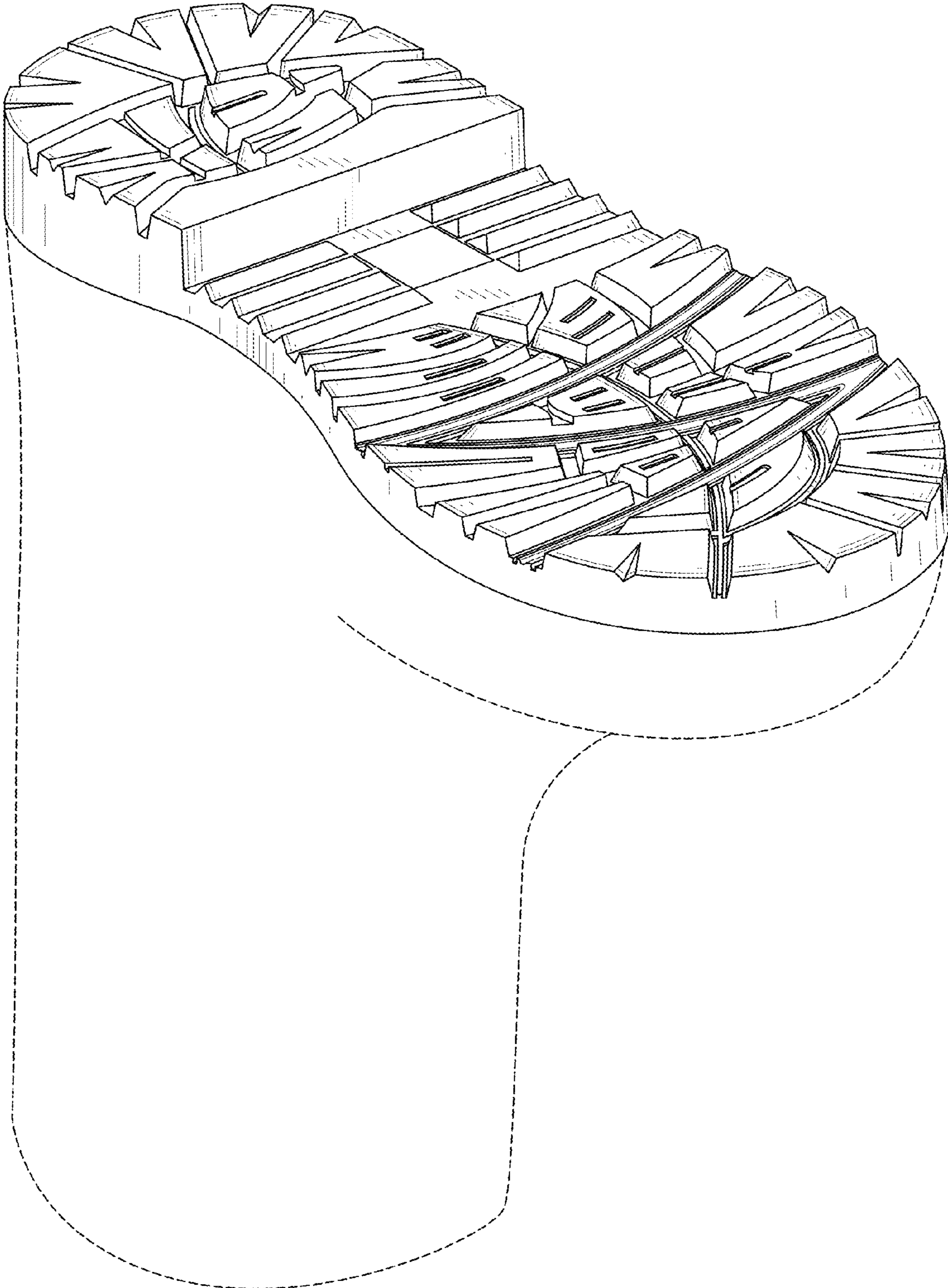
