FIG. 6 is a front view thereof.

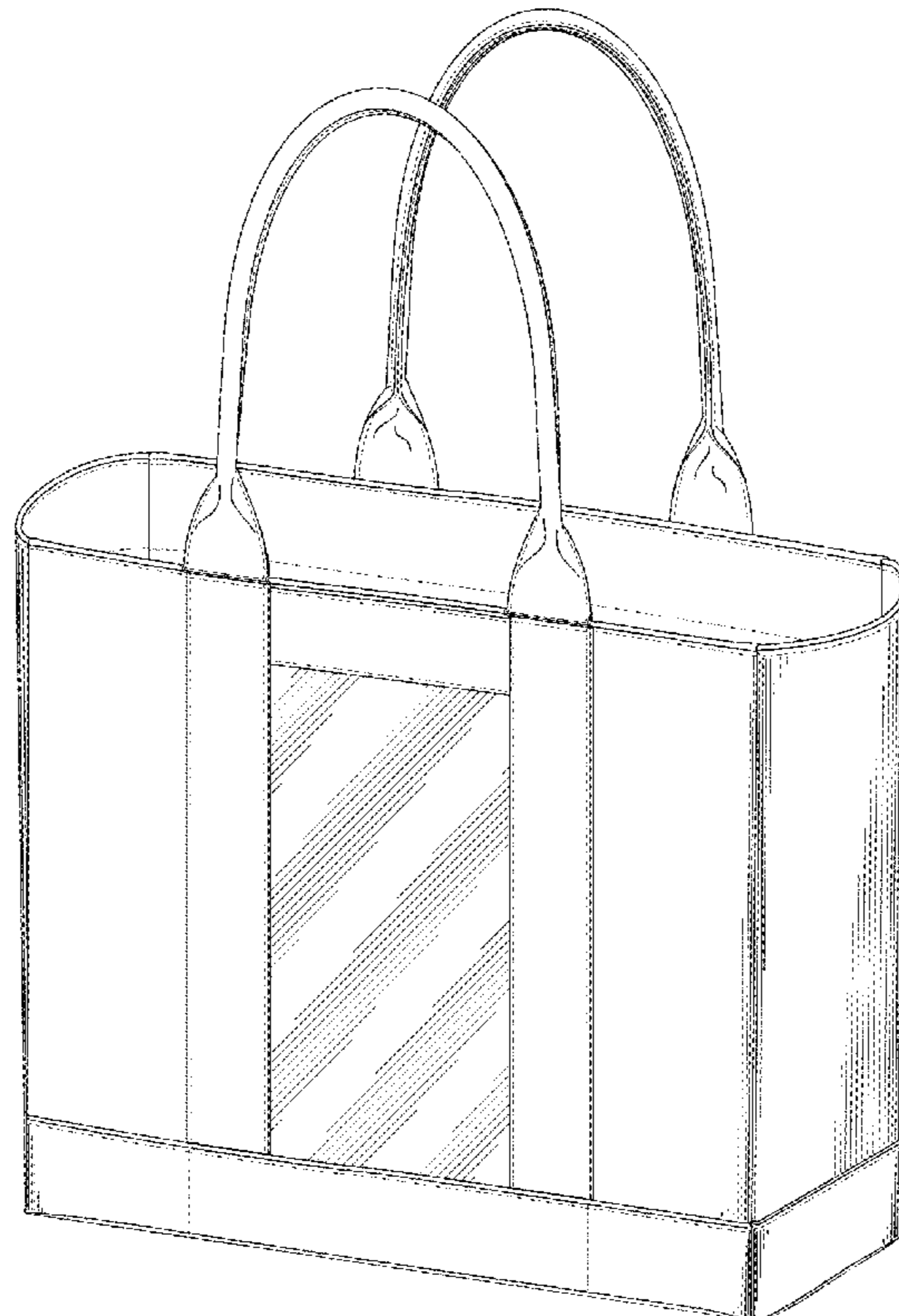
The broken lines showing a decorative pattern on the front panel and stitching are for the purposes of illustrating environment and form no part of the claimed design.

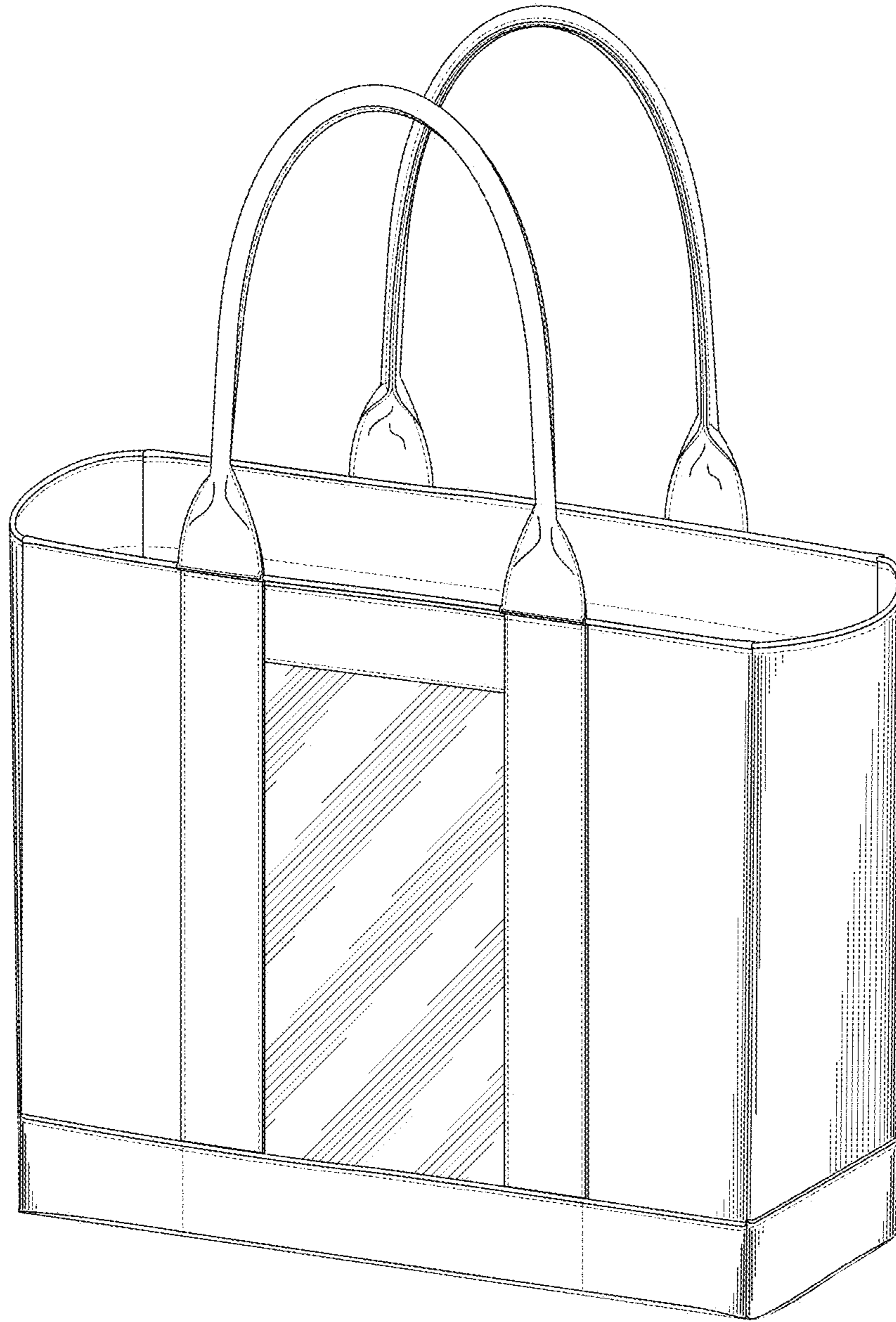

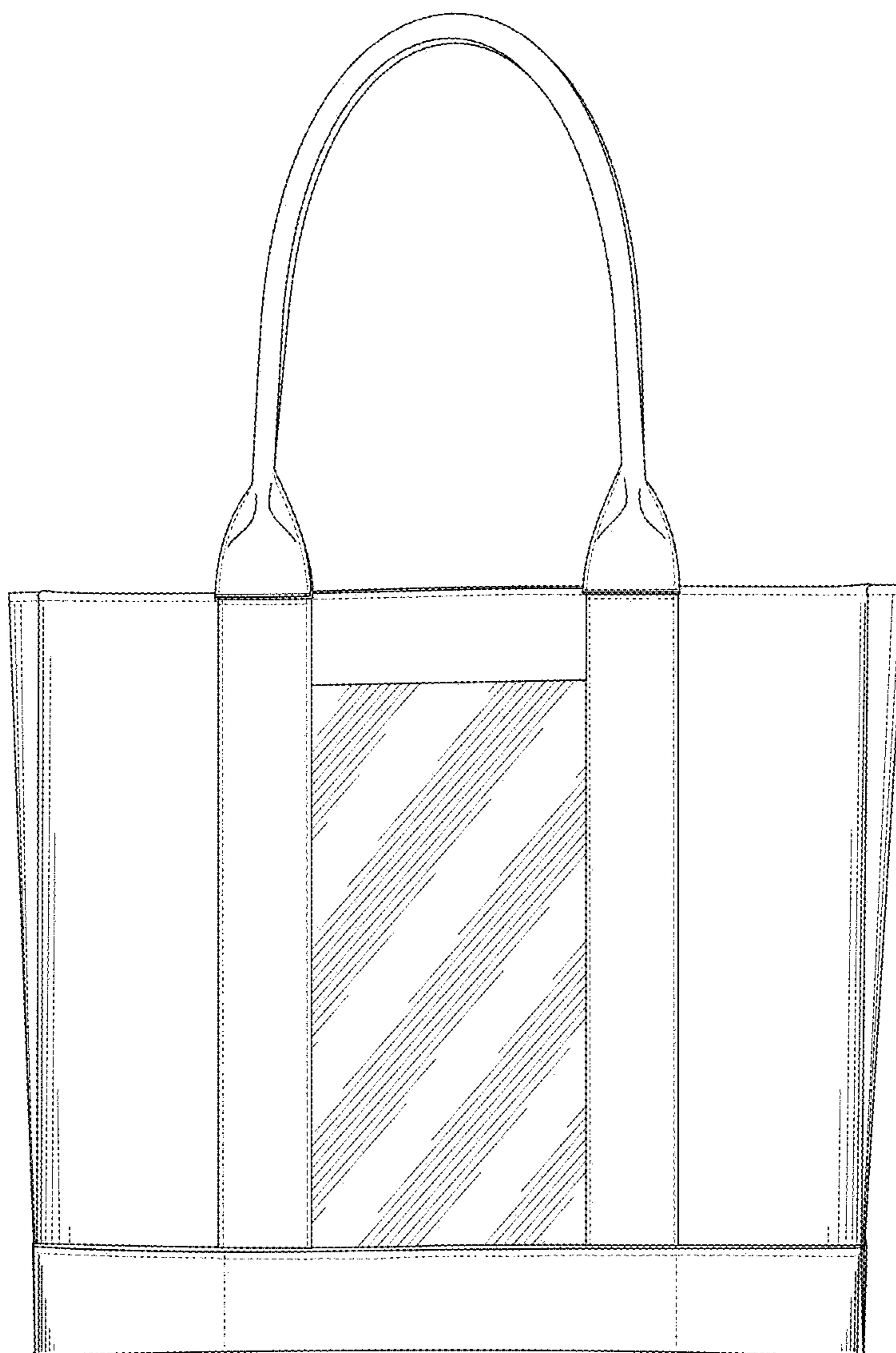

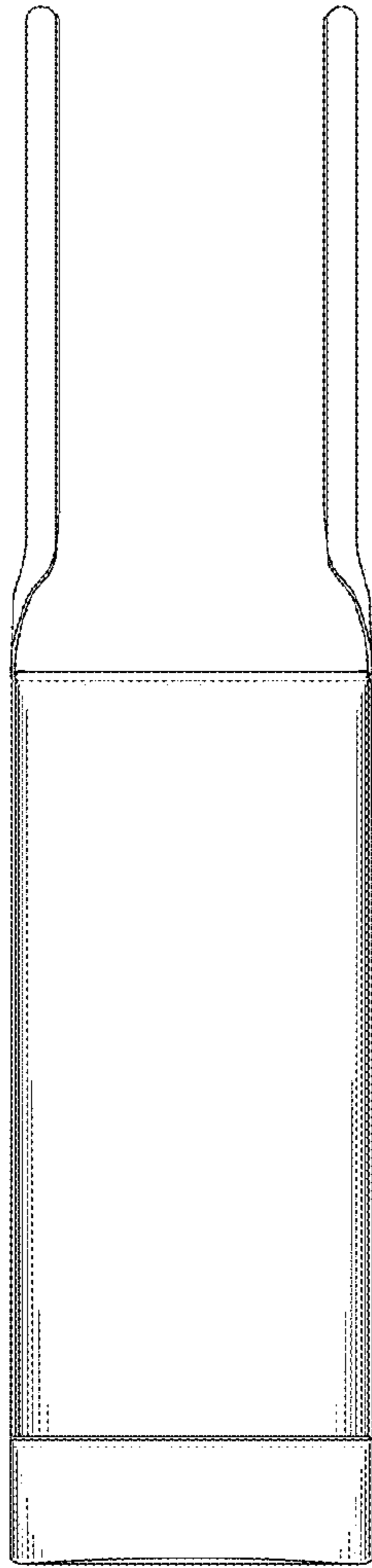

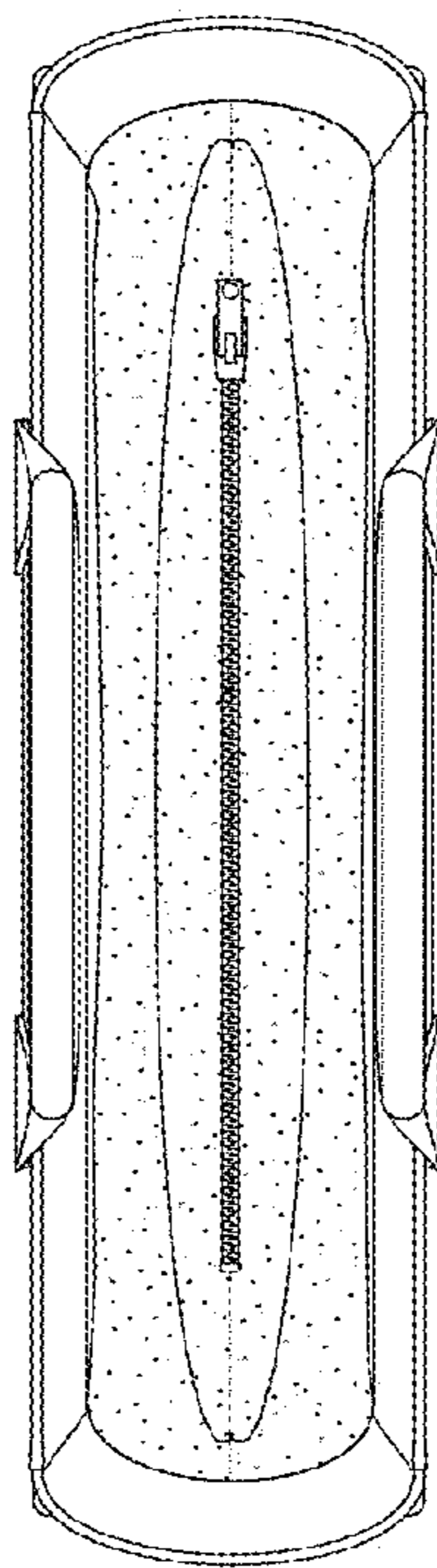

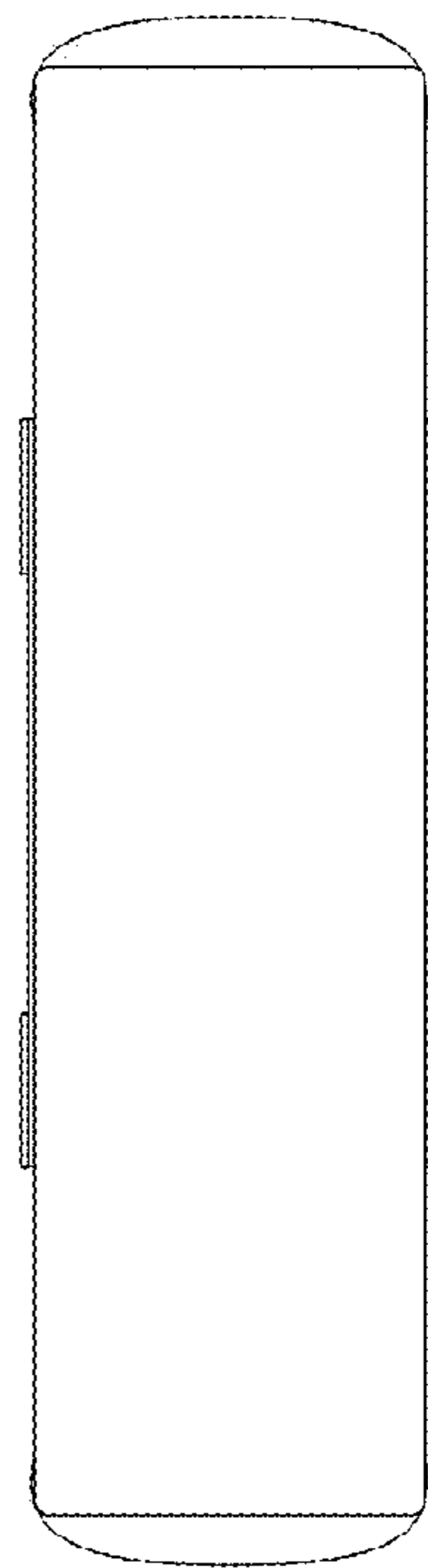

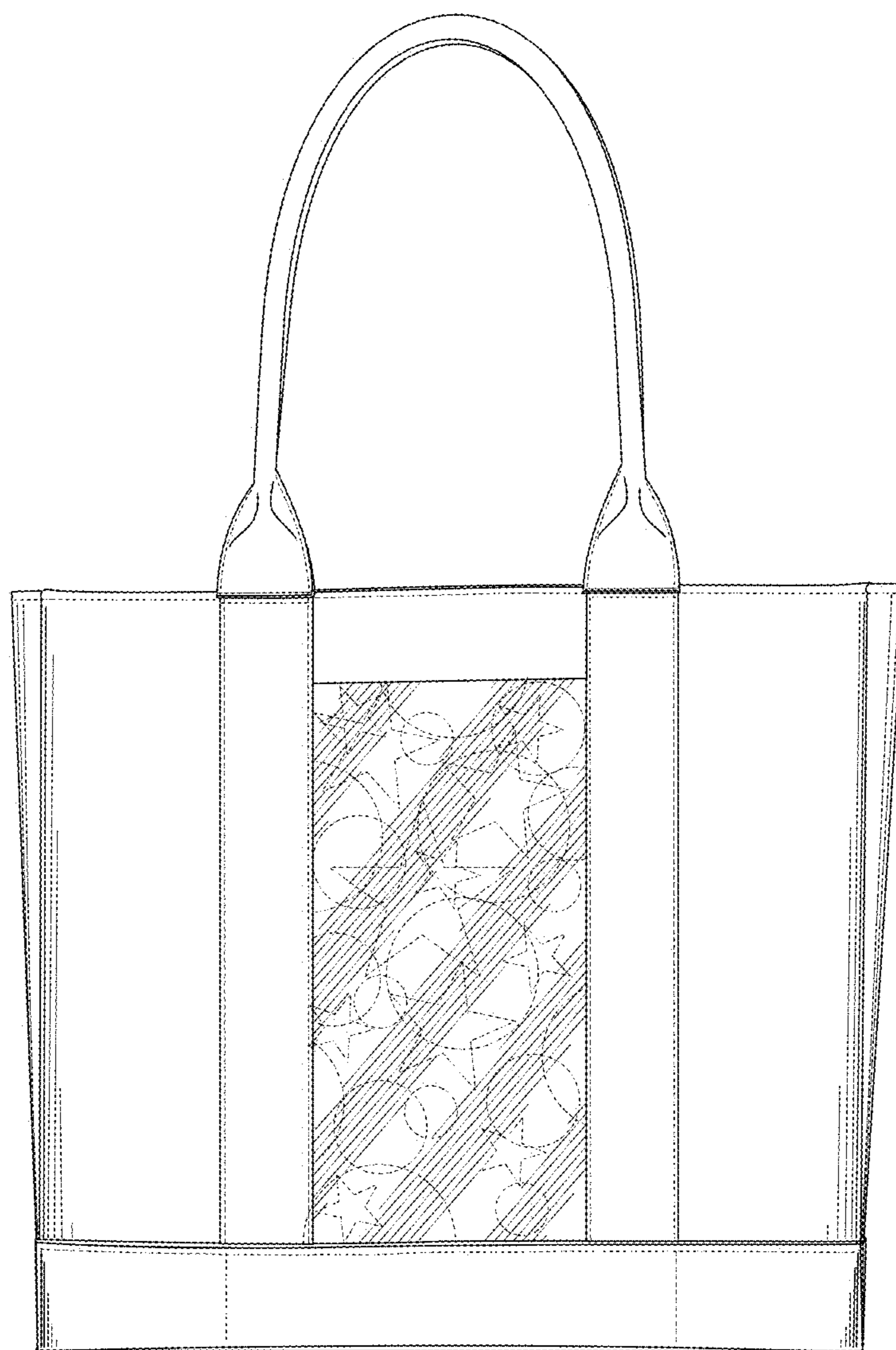
