DESCRIPTION

FIG. 1 is a perspective view of a first embodiment of a handbag of the present invention;

 FIG. 8 is a perspective view of a second embodiment of a handbag of the present invention;

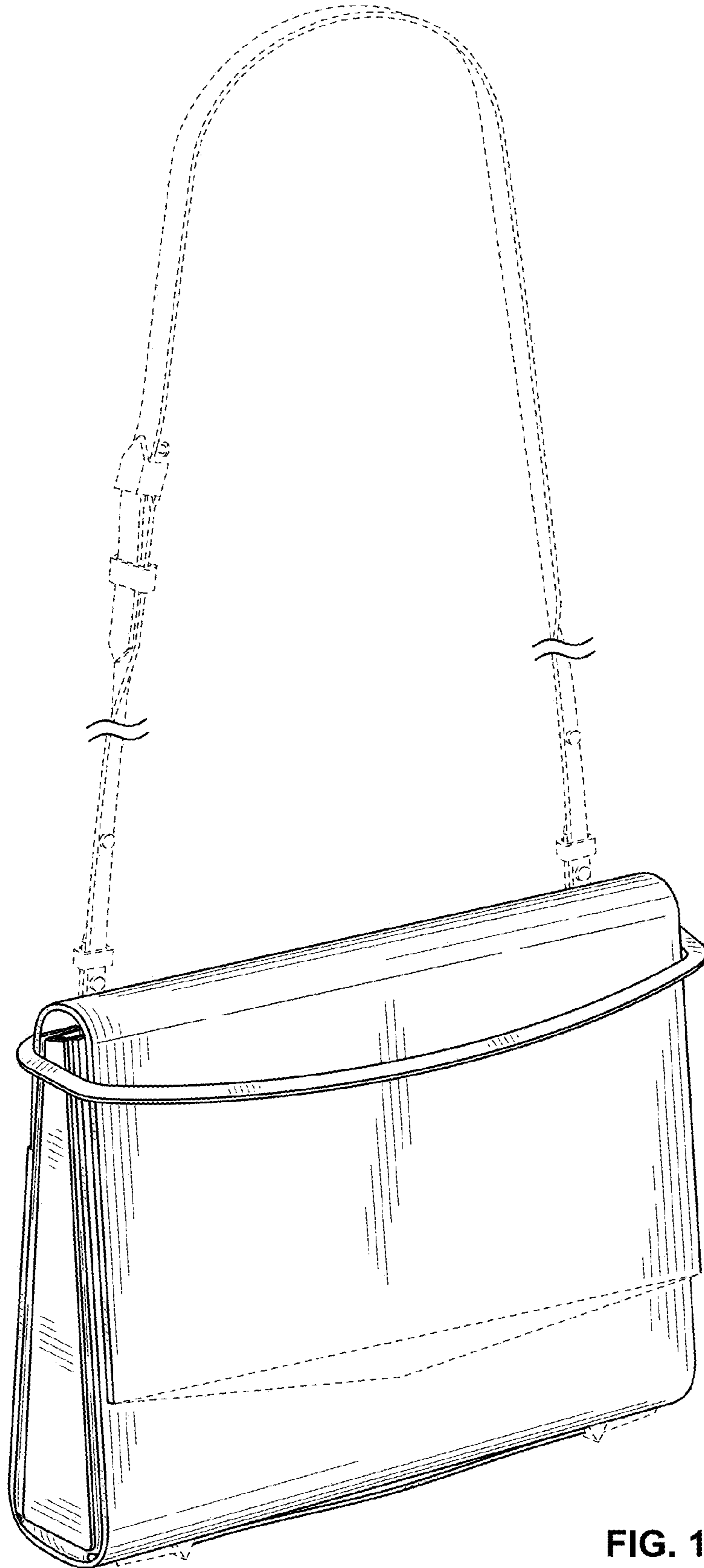

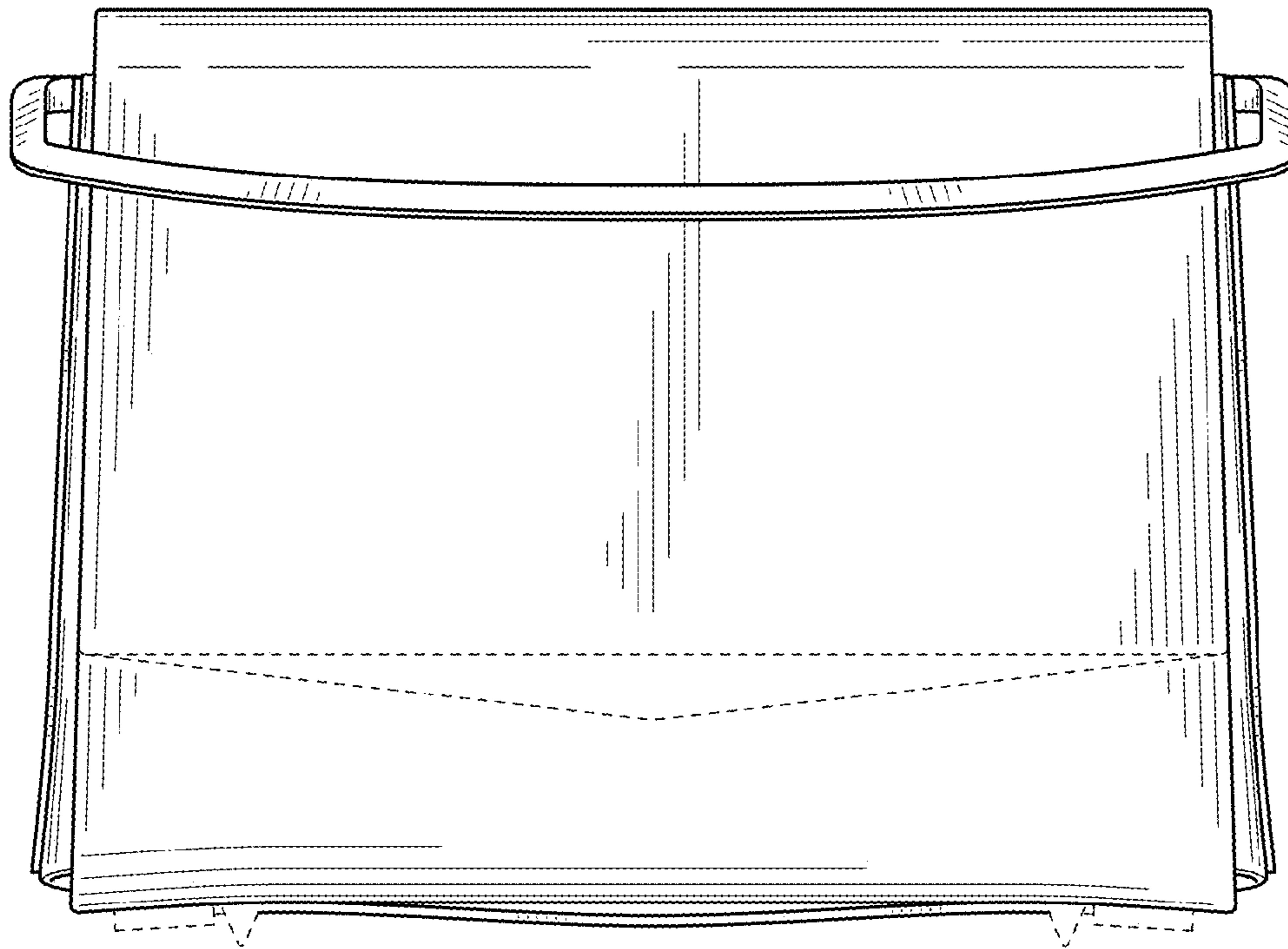

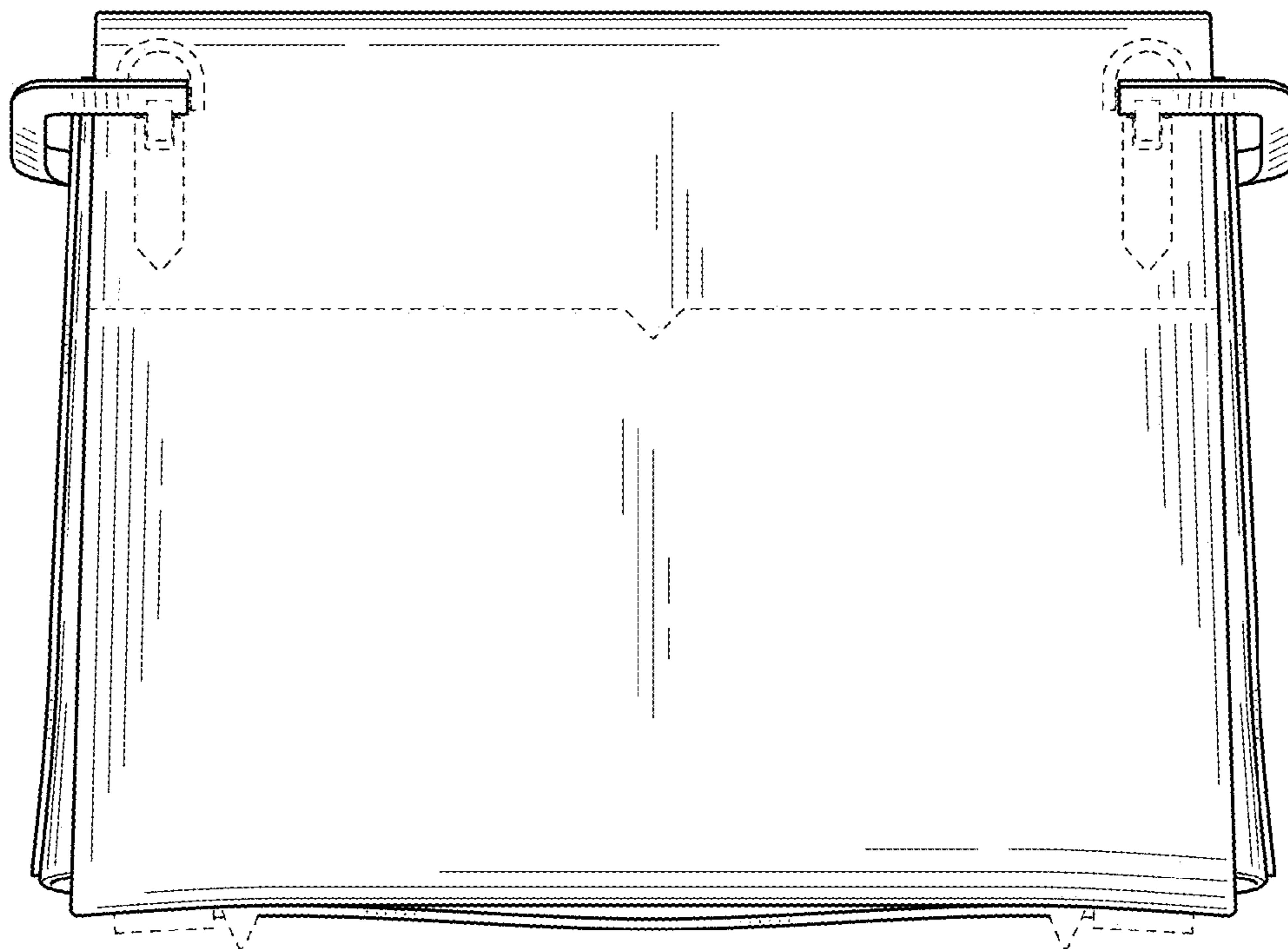

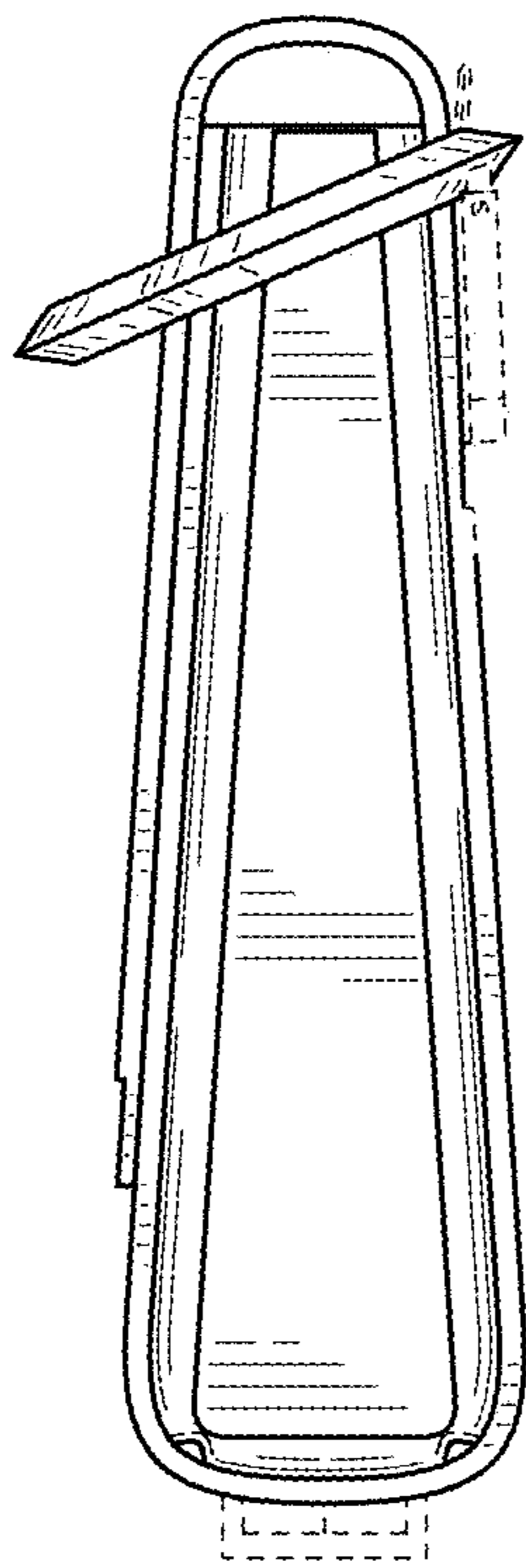

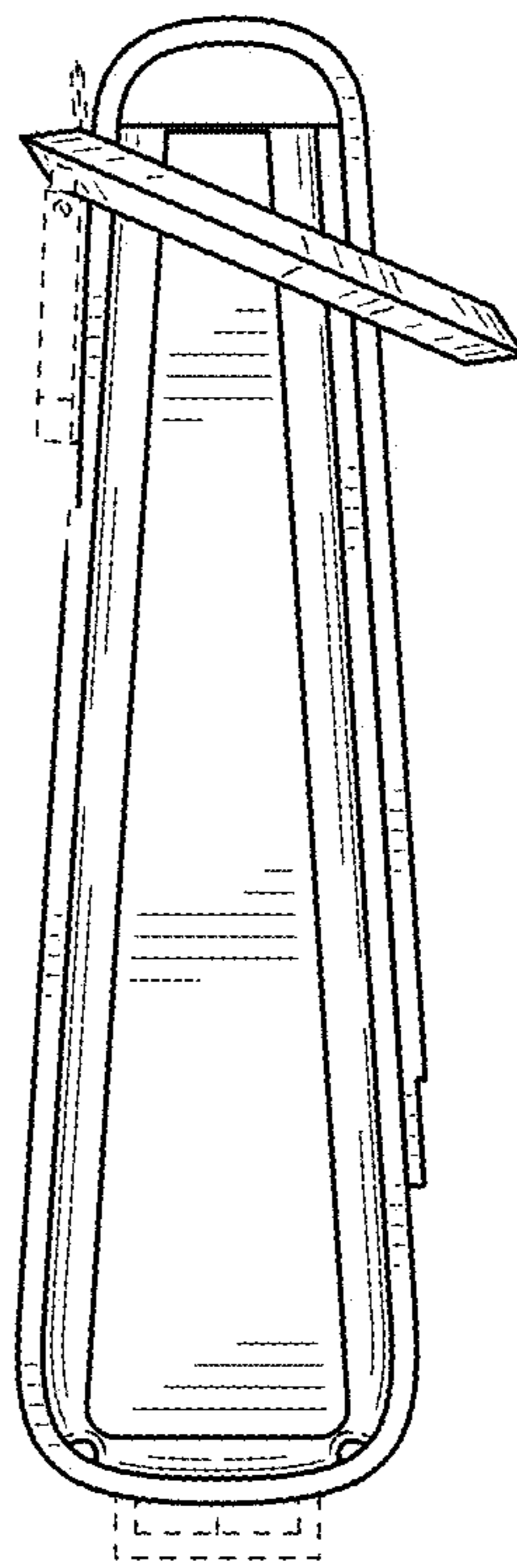

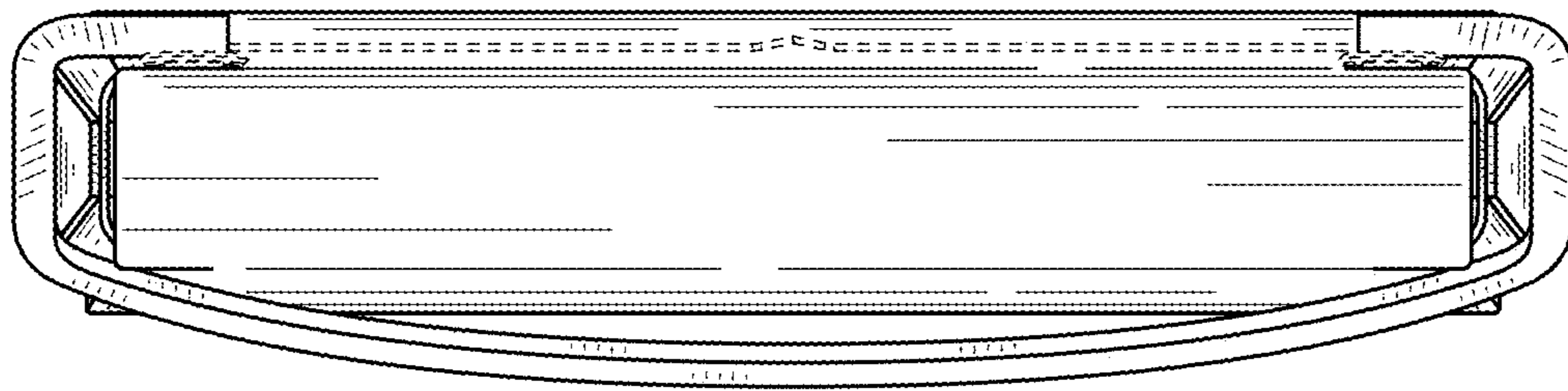

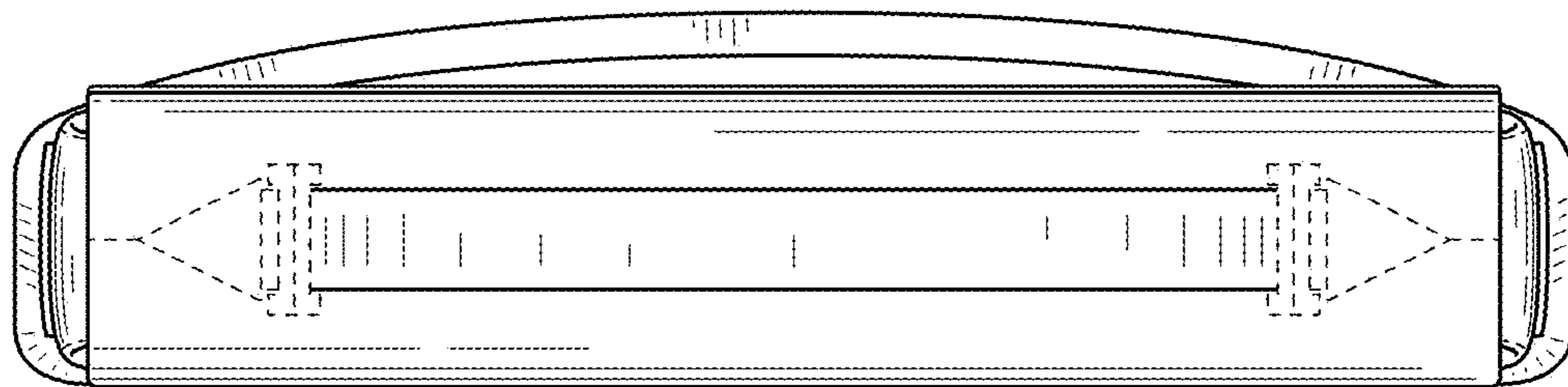

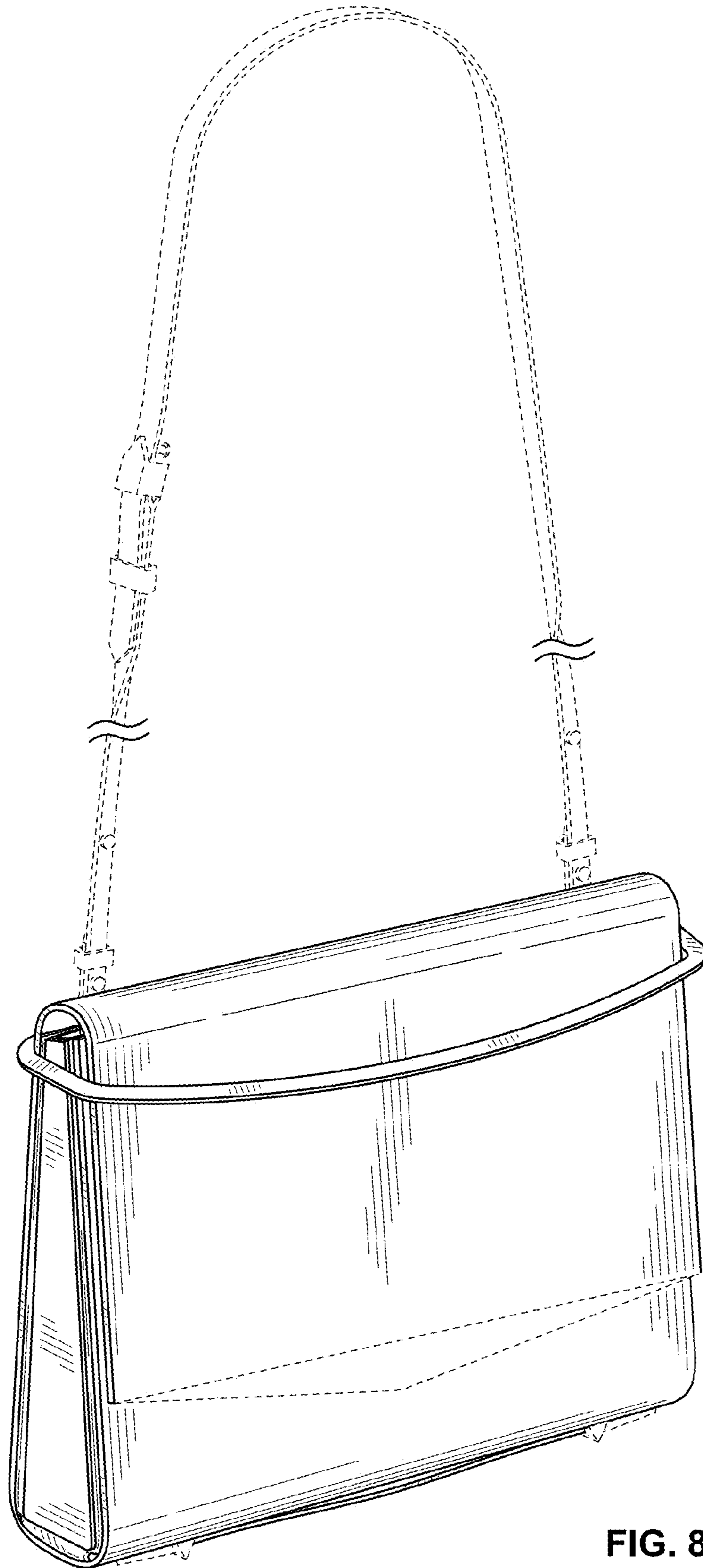

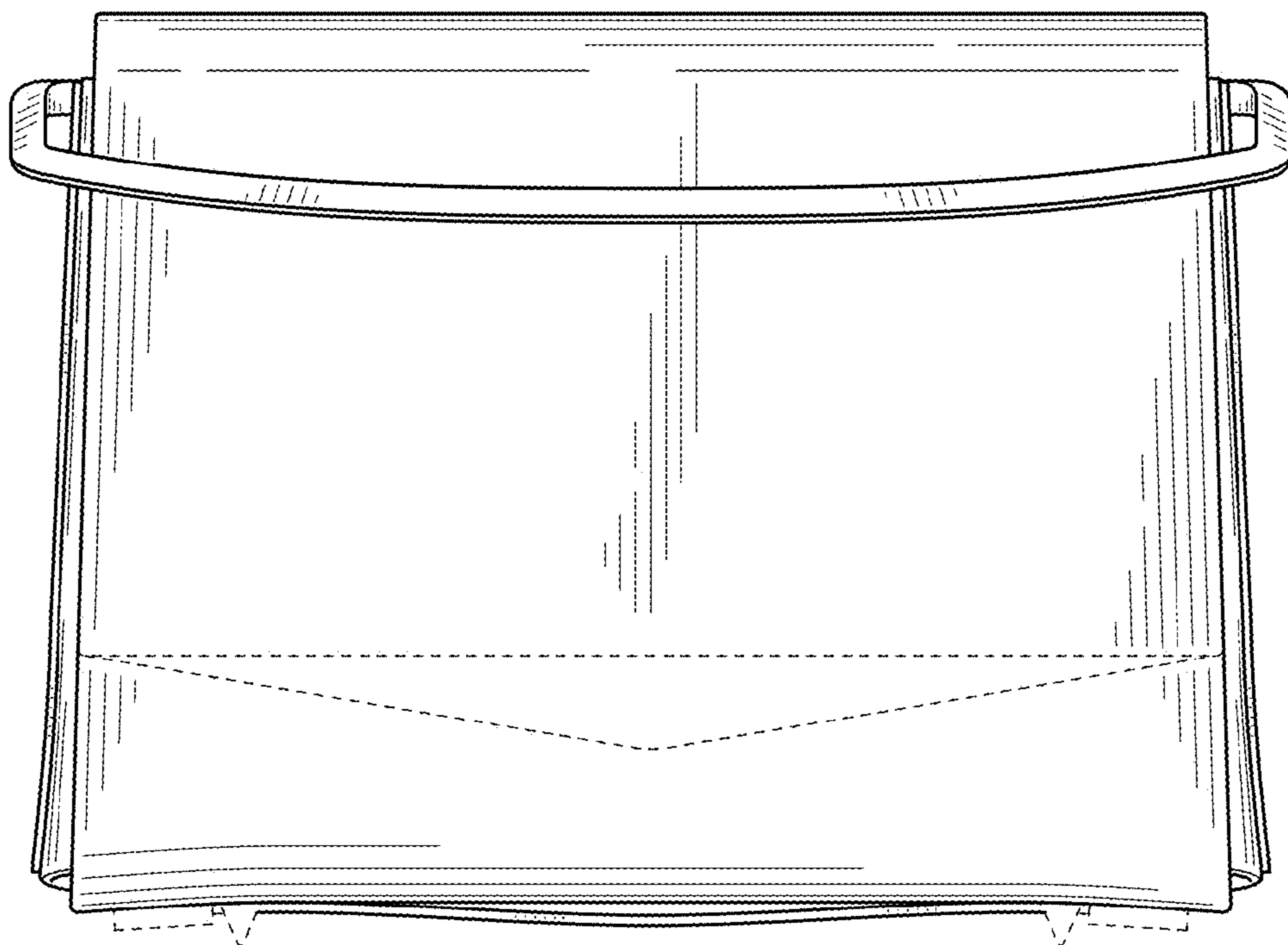

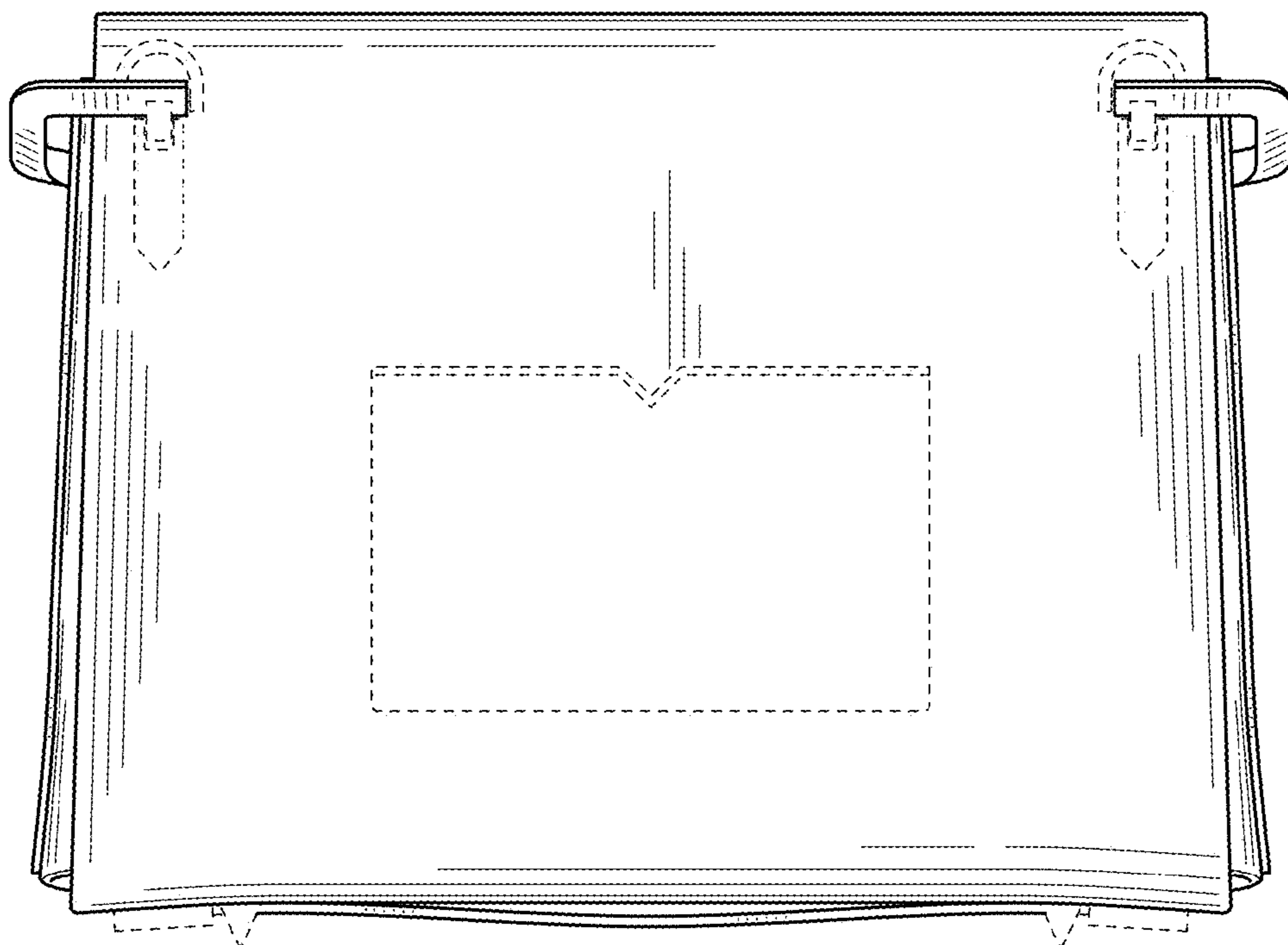

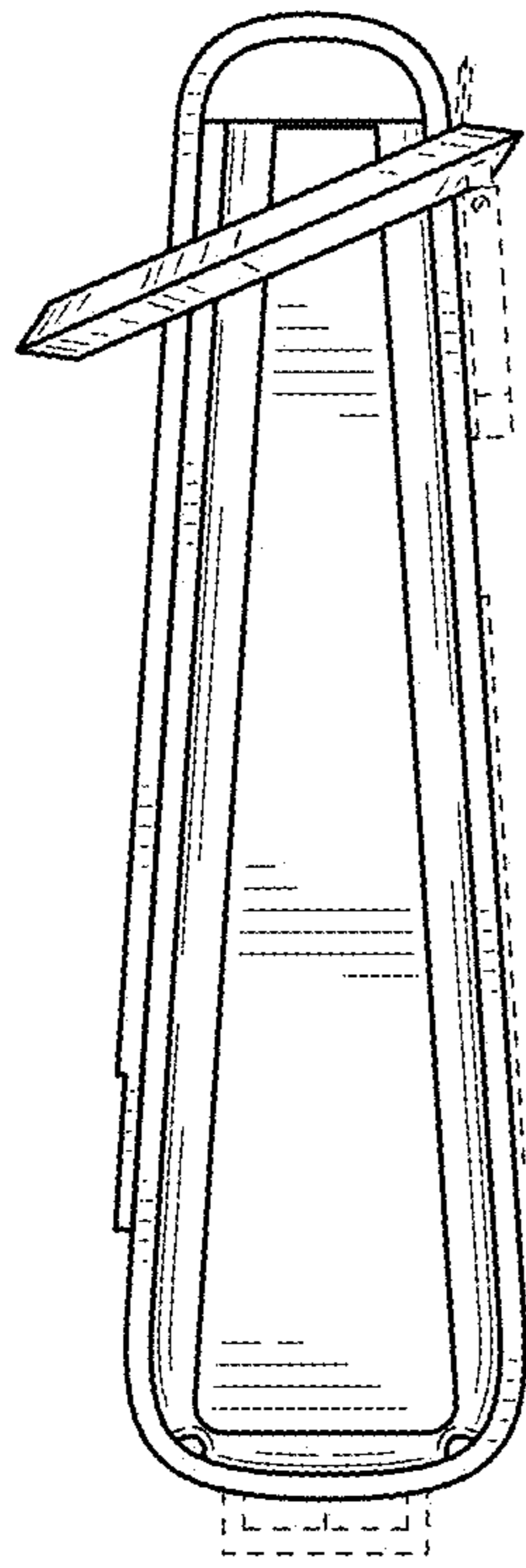

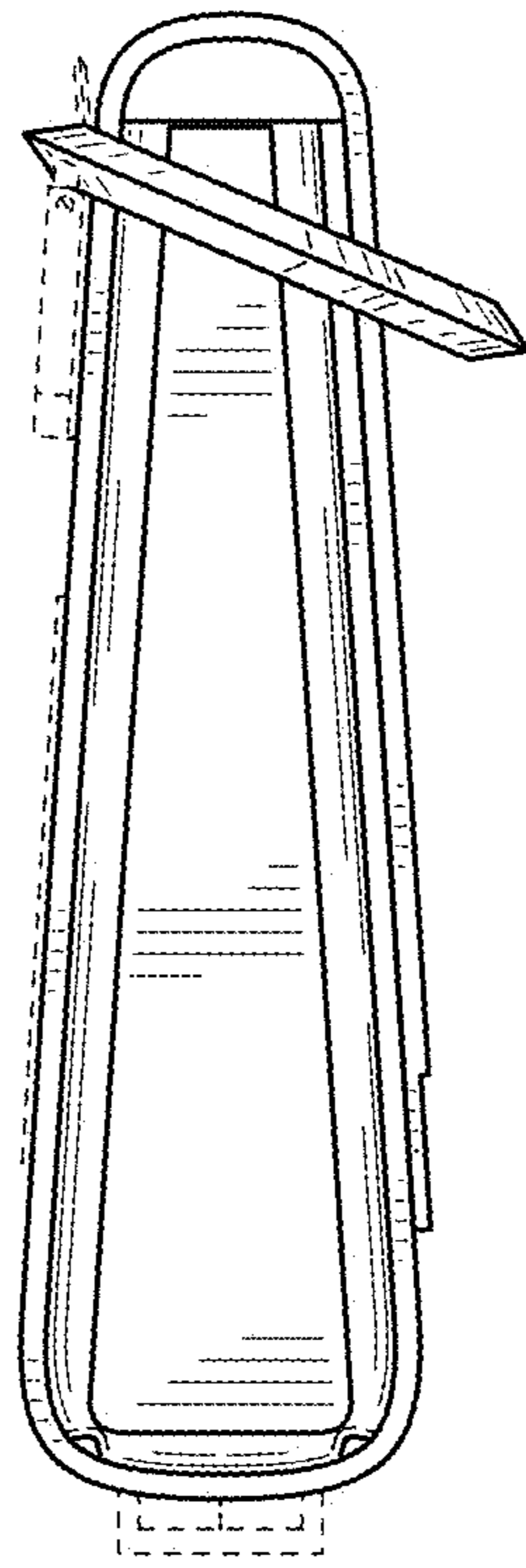

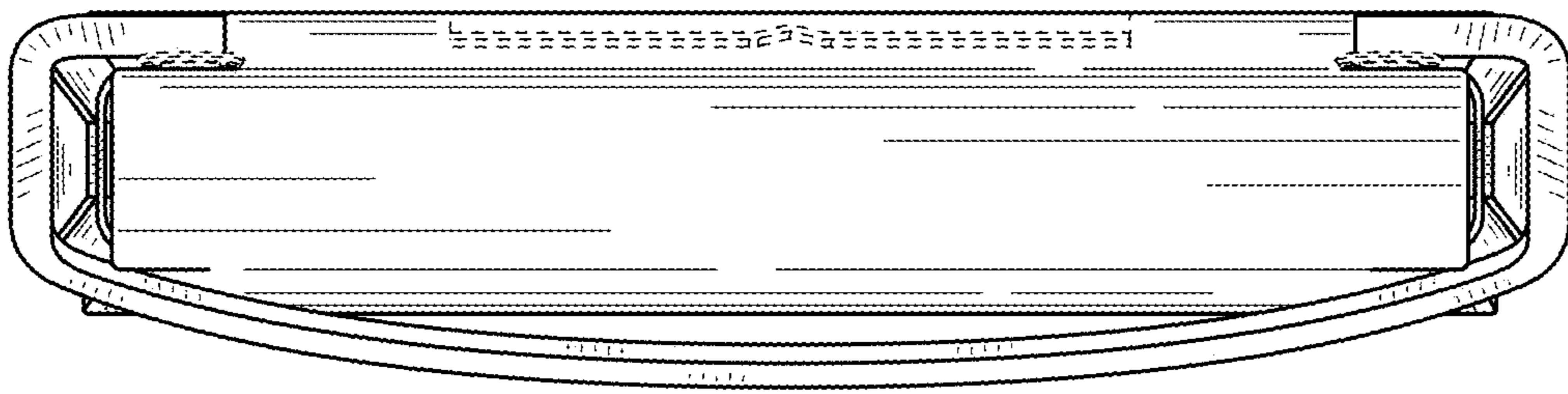

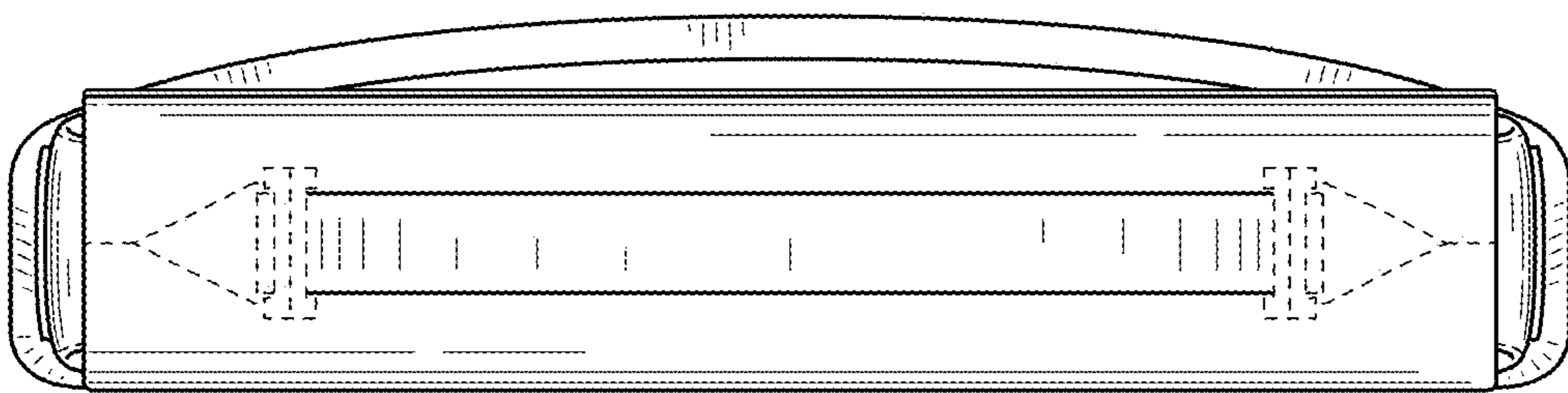
