The ornamental design for a chaise, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of a chaise showing our new design with a seat cushion shown in a retracted position;

FIG. 9 is a left side view thereof;

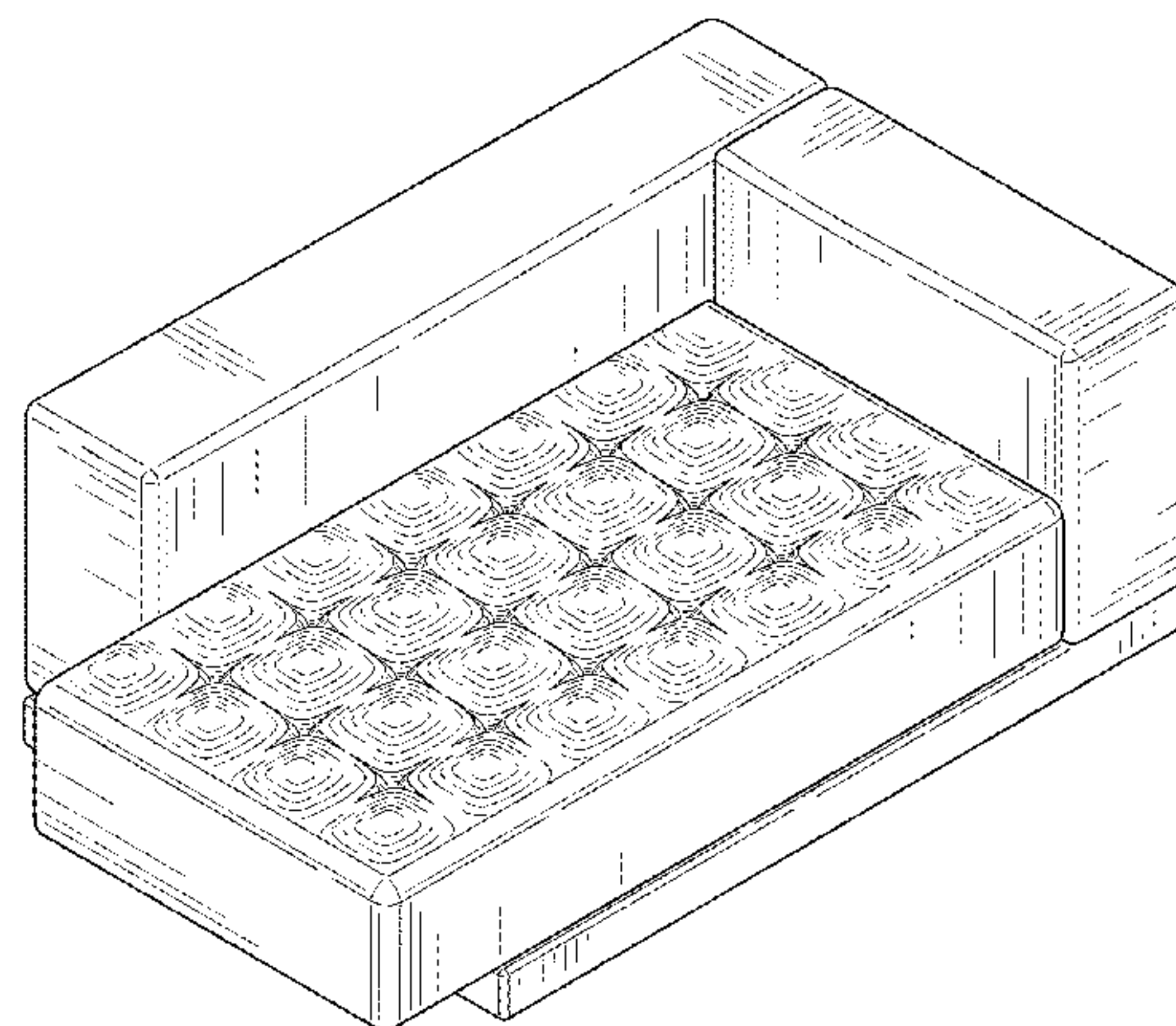
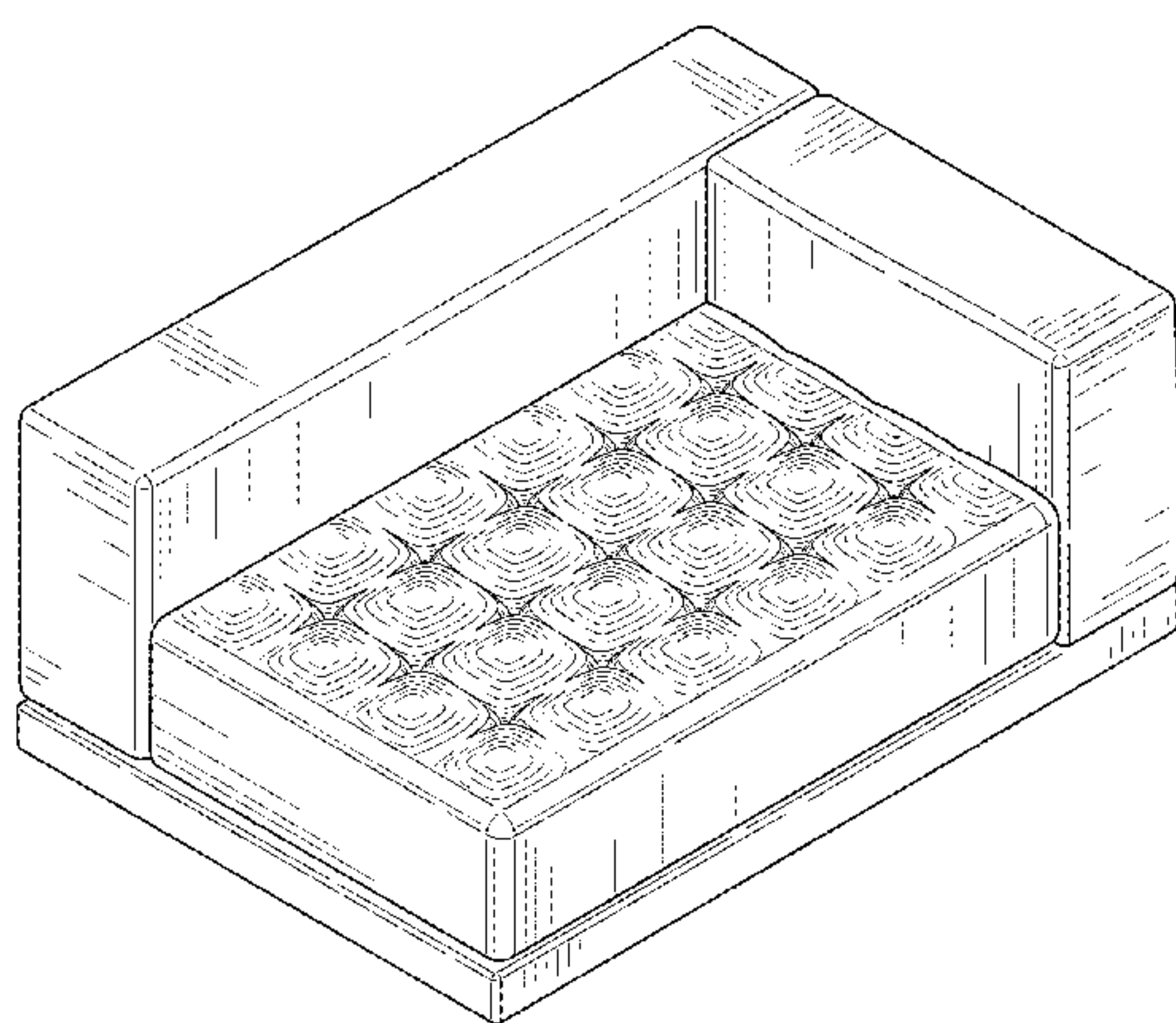
FIG. 10 is a front view thereof;

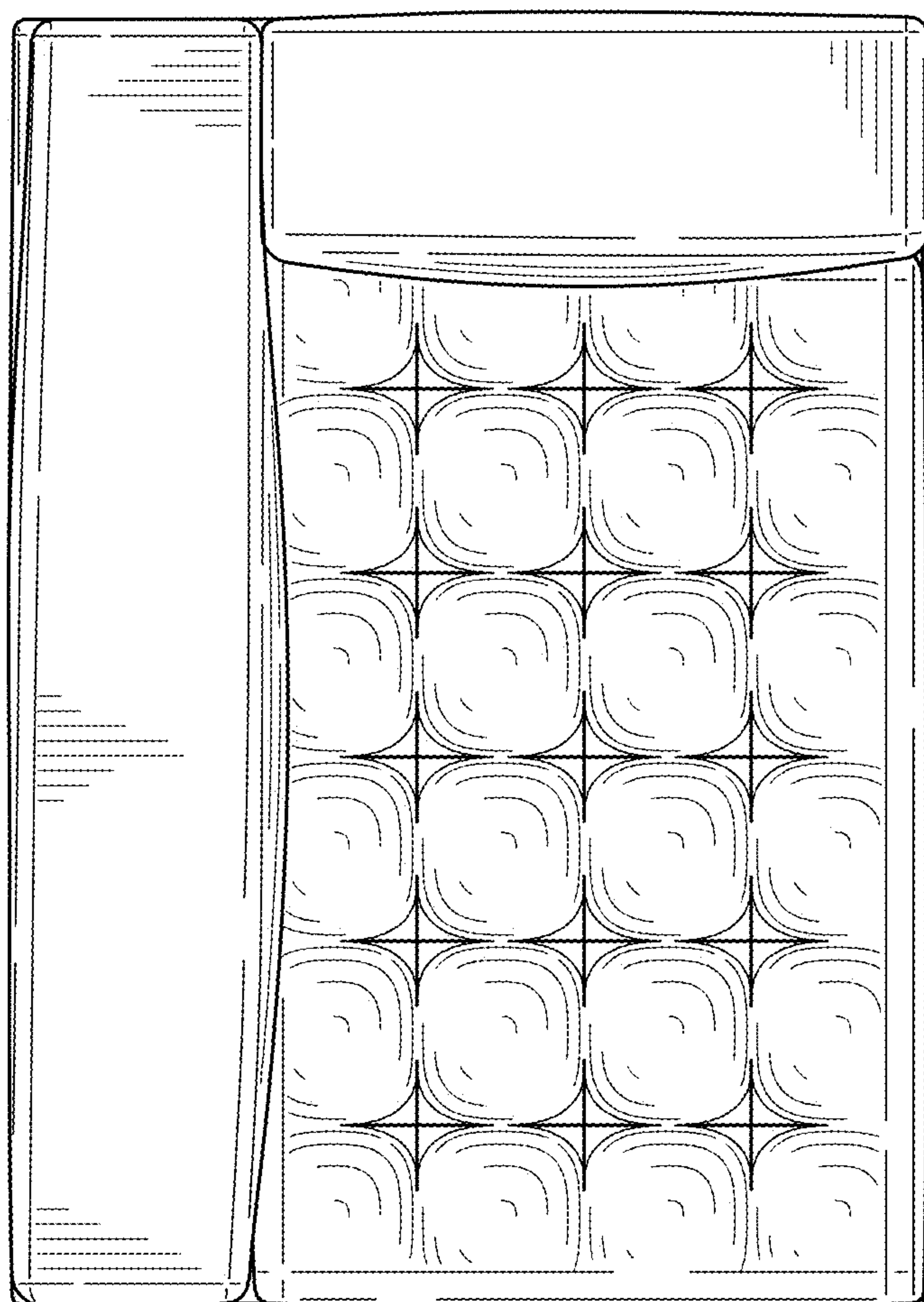

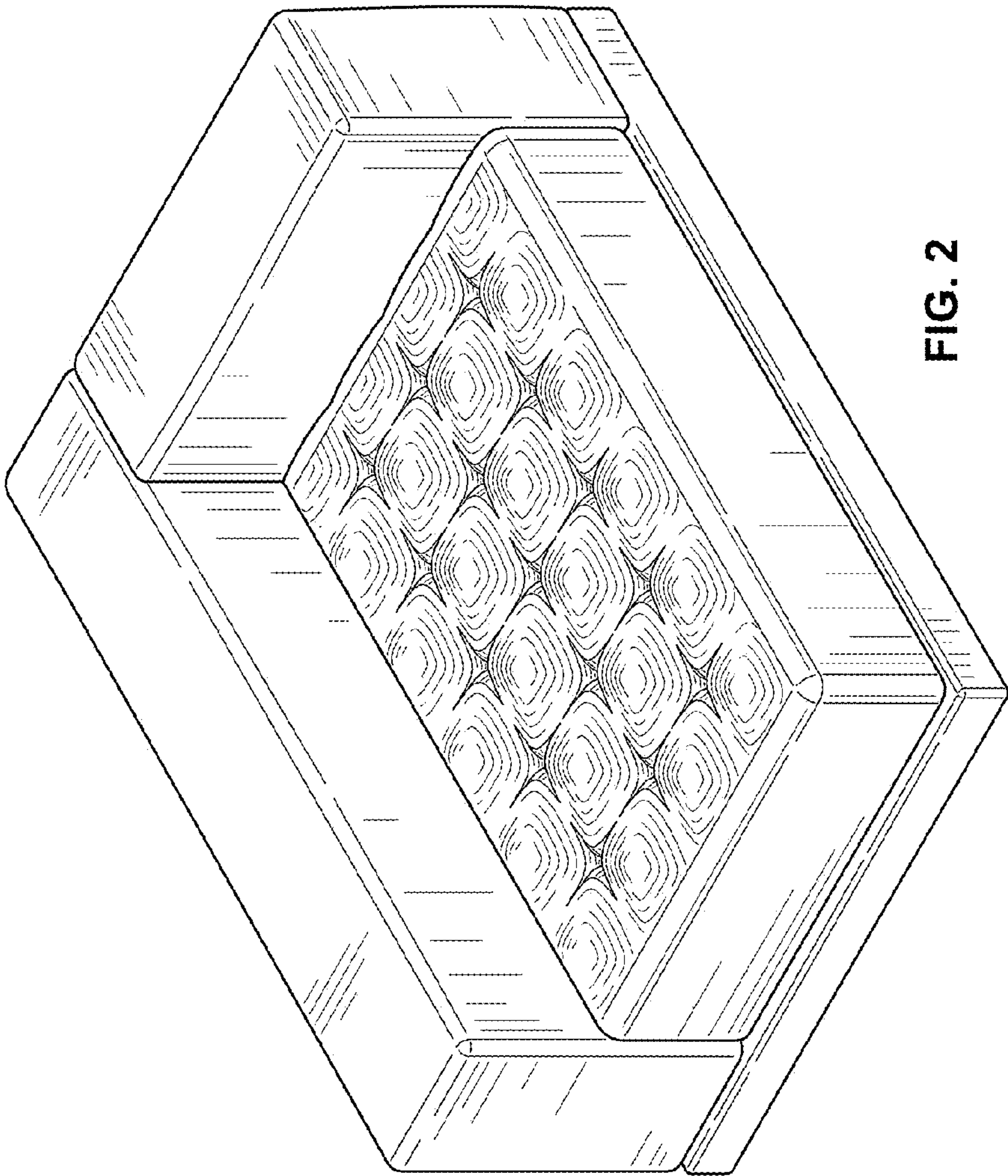

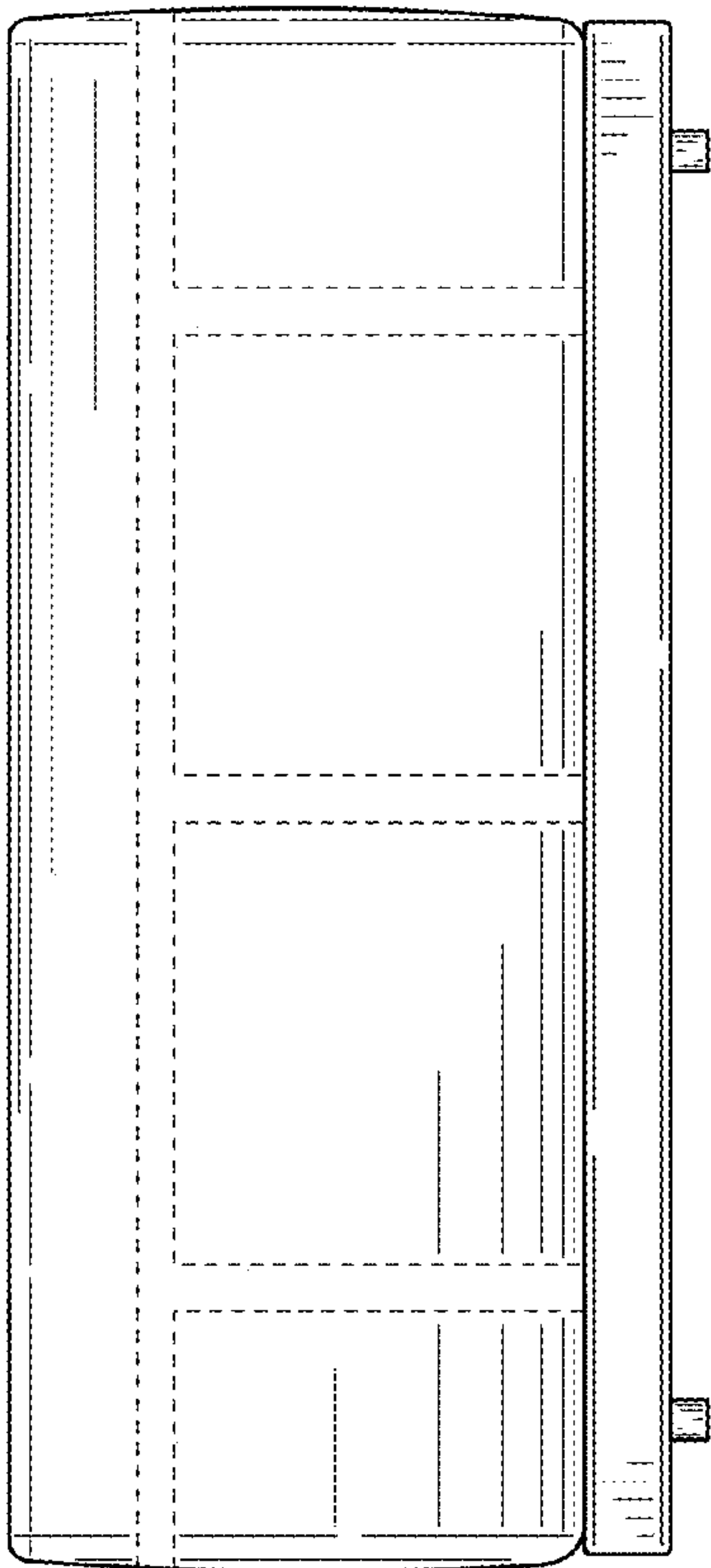

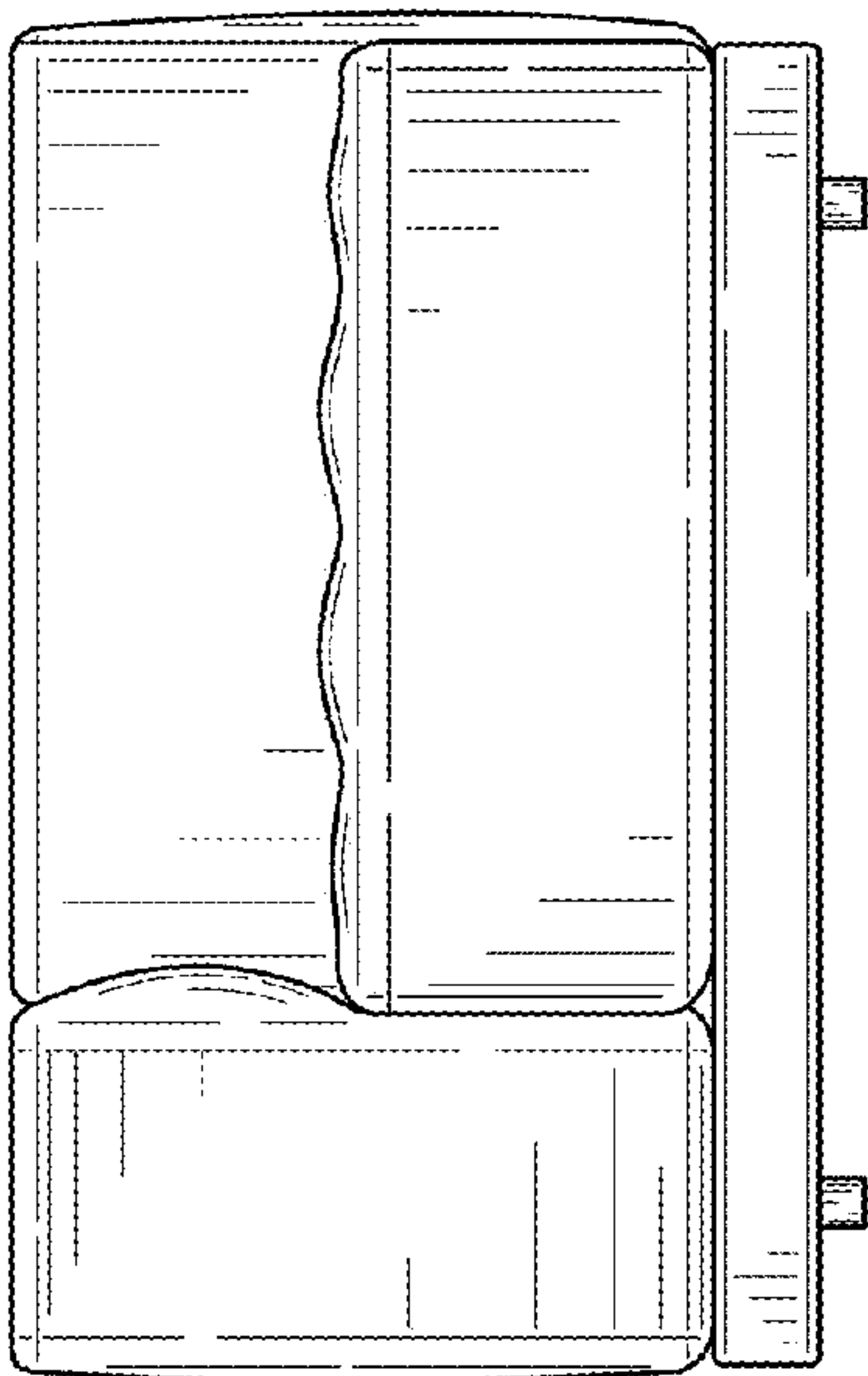

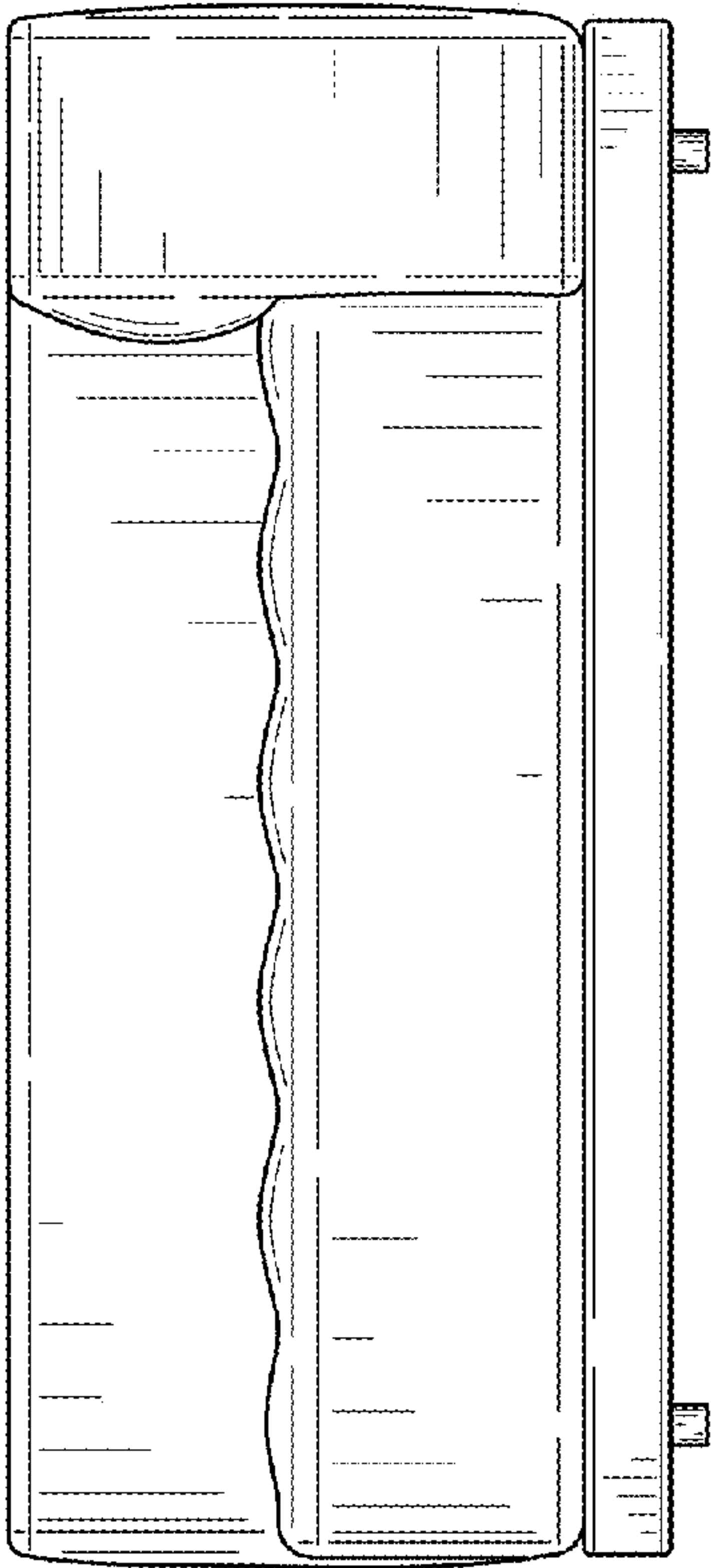

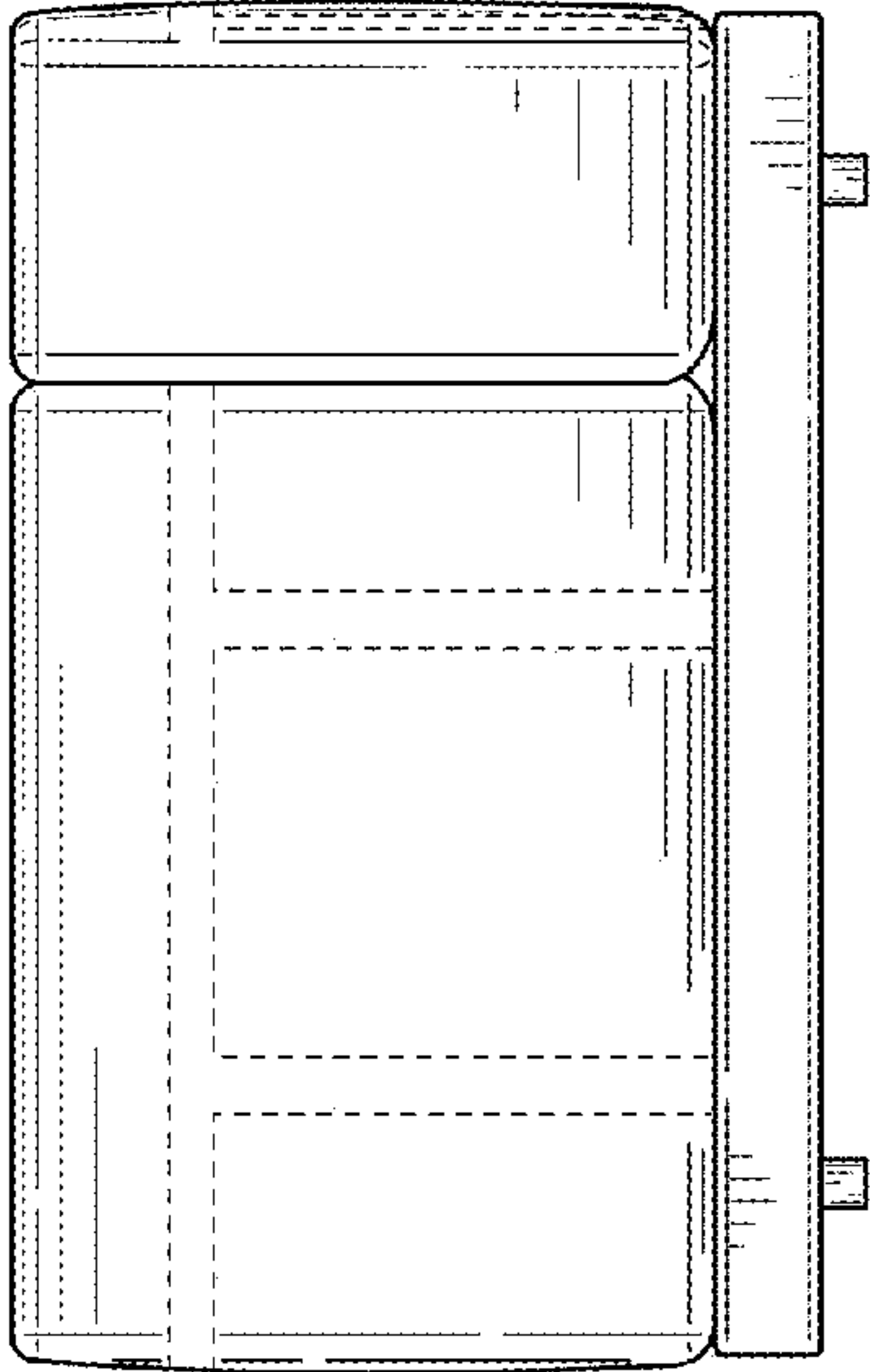

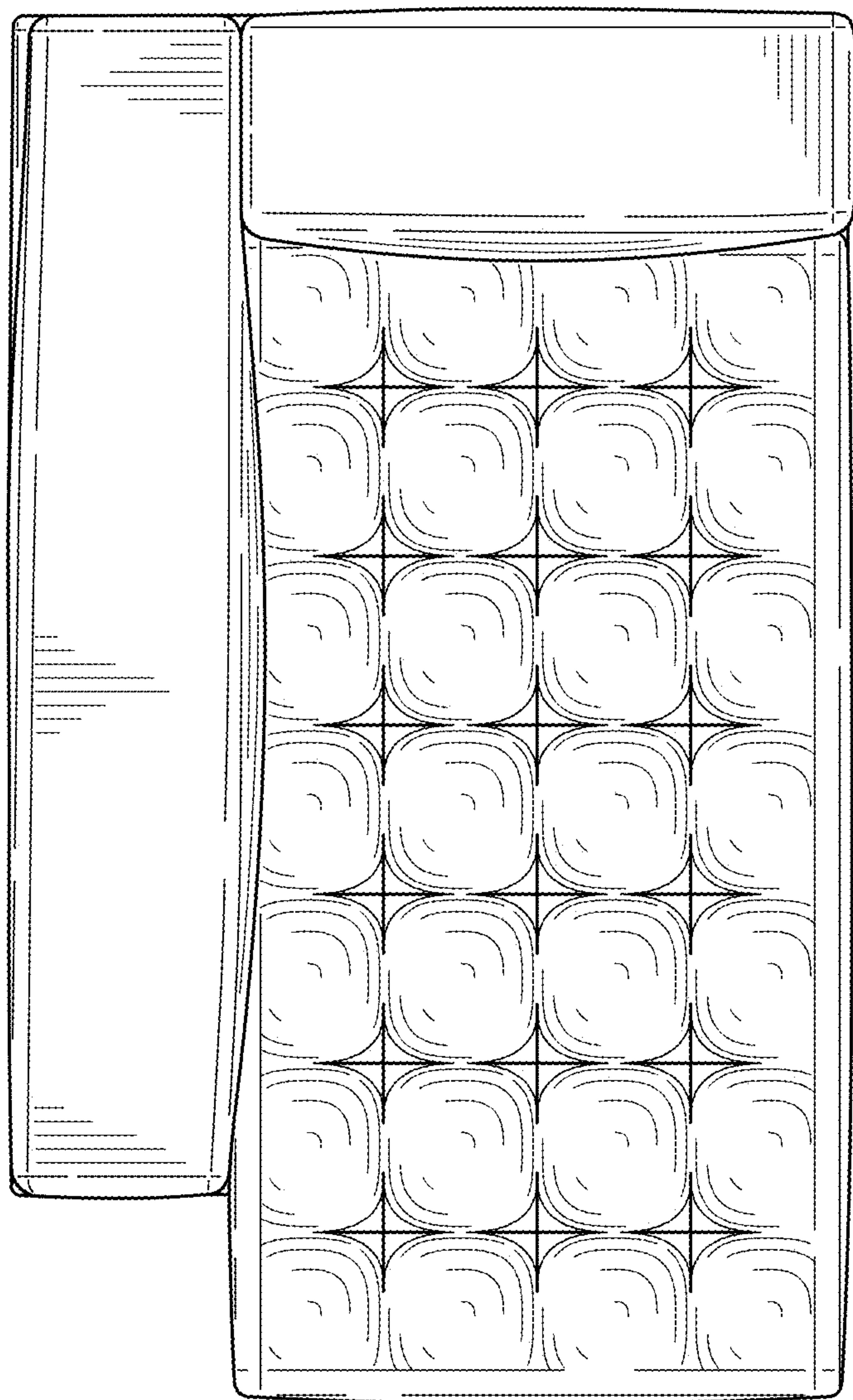

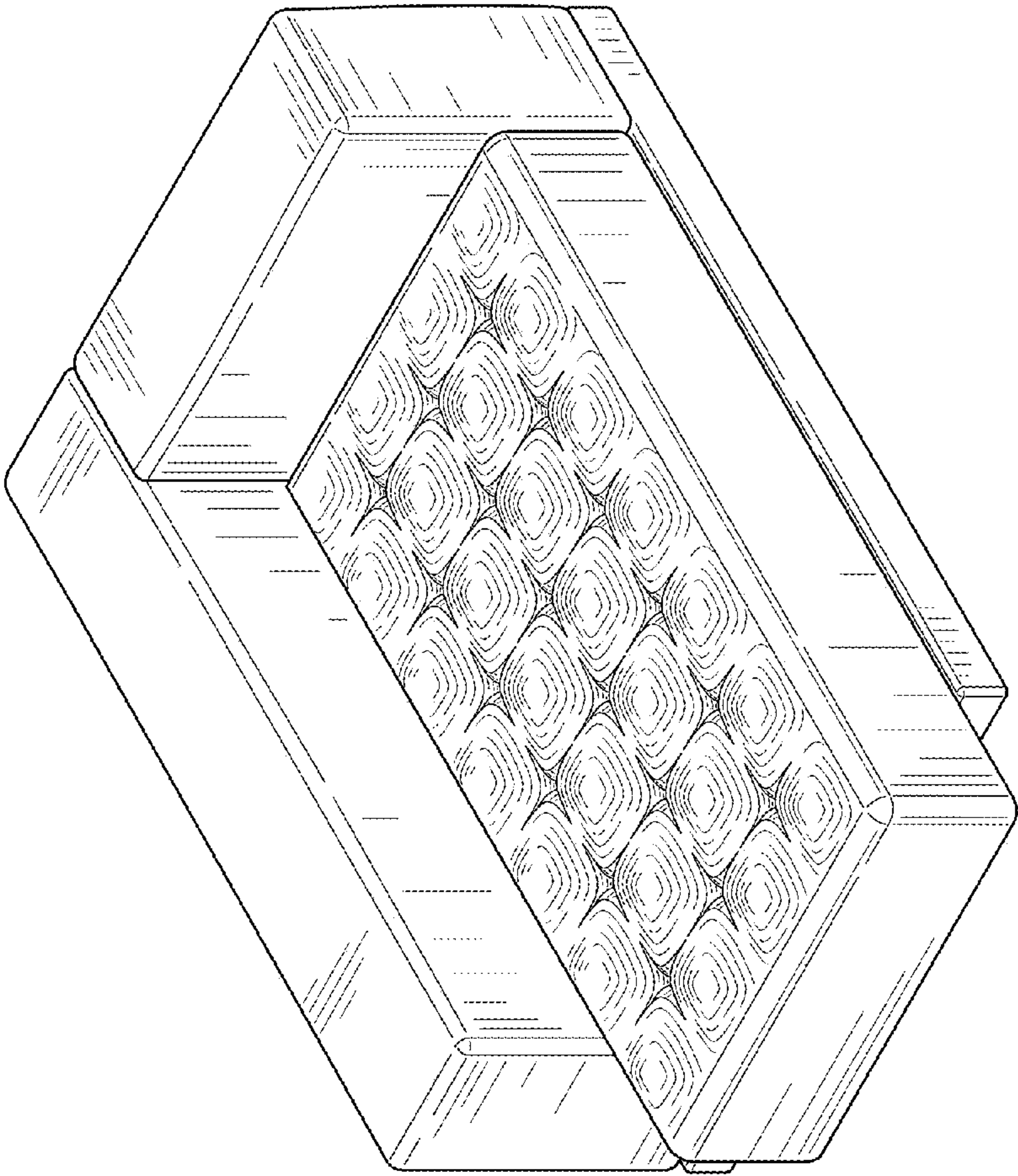

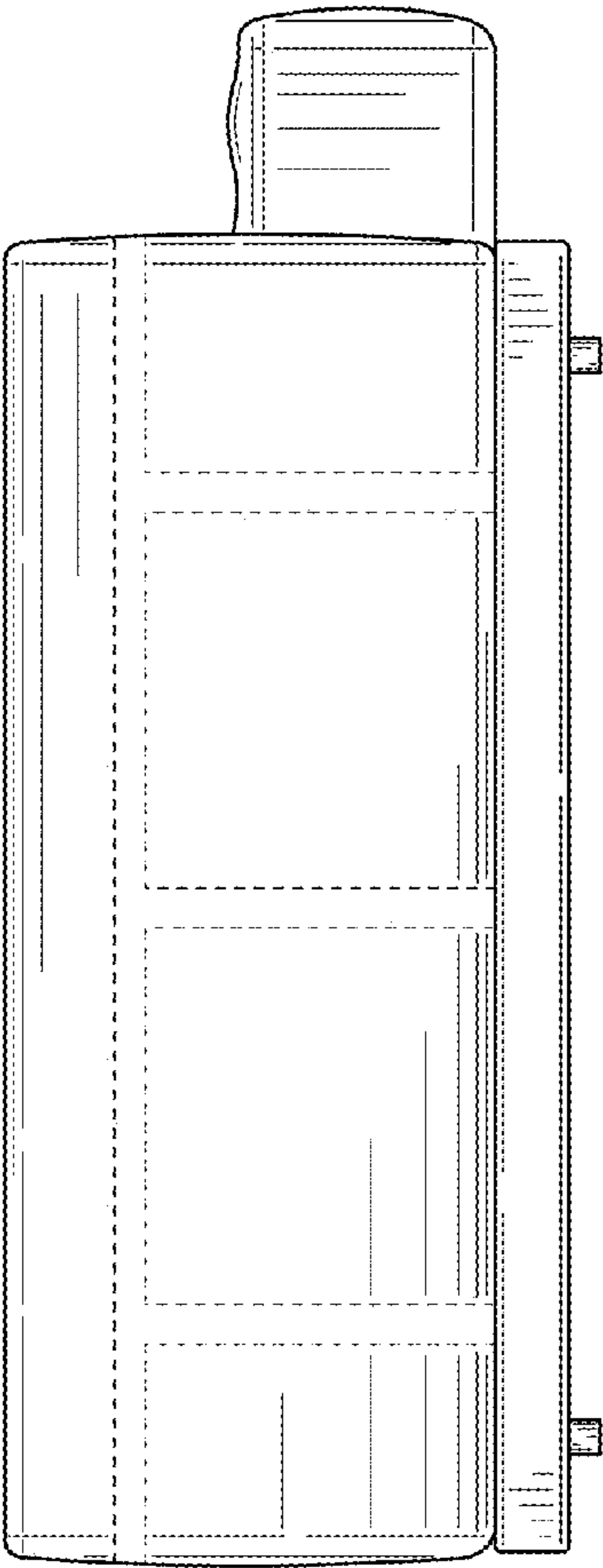

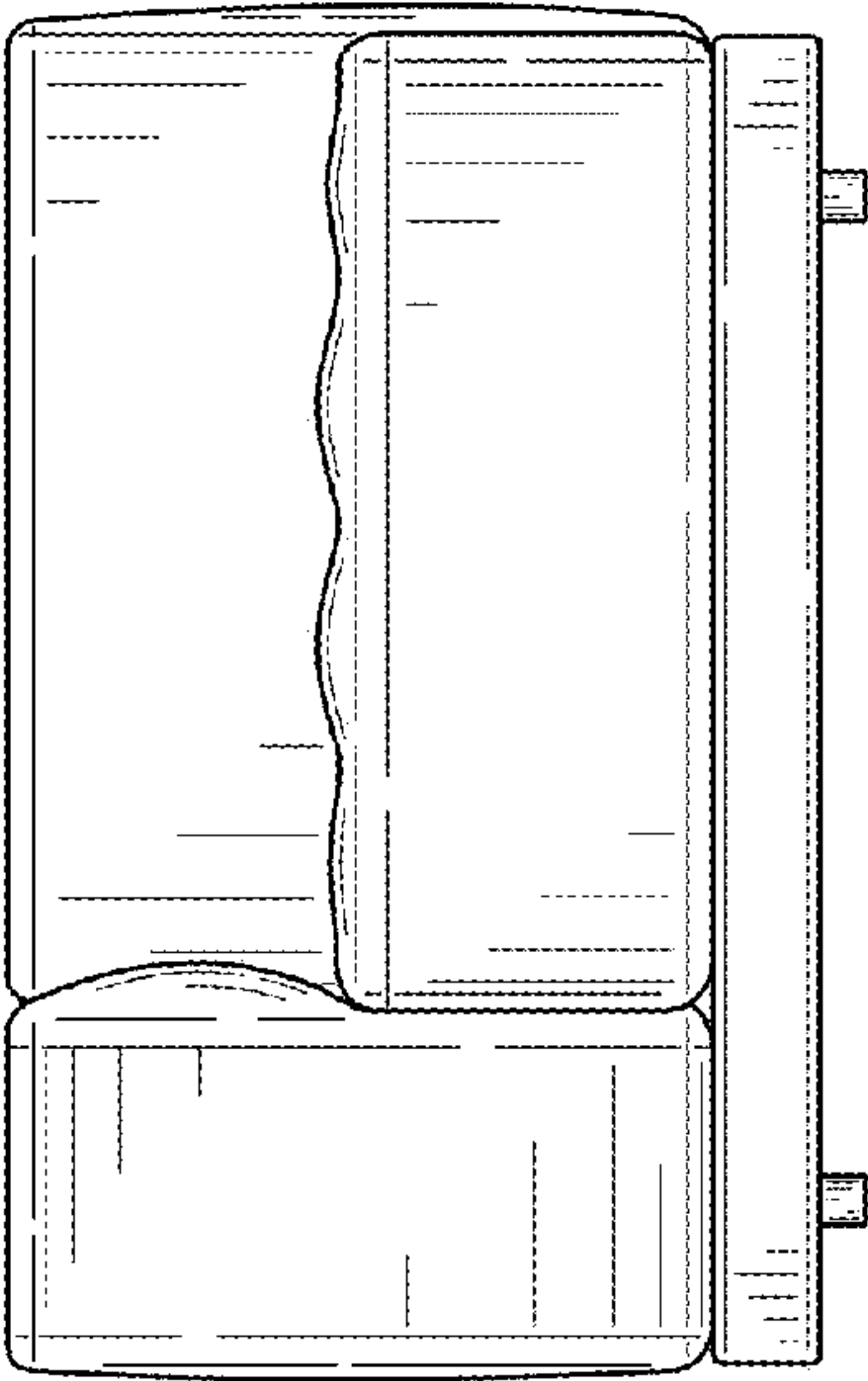

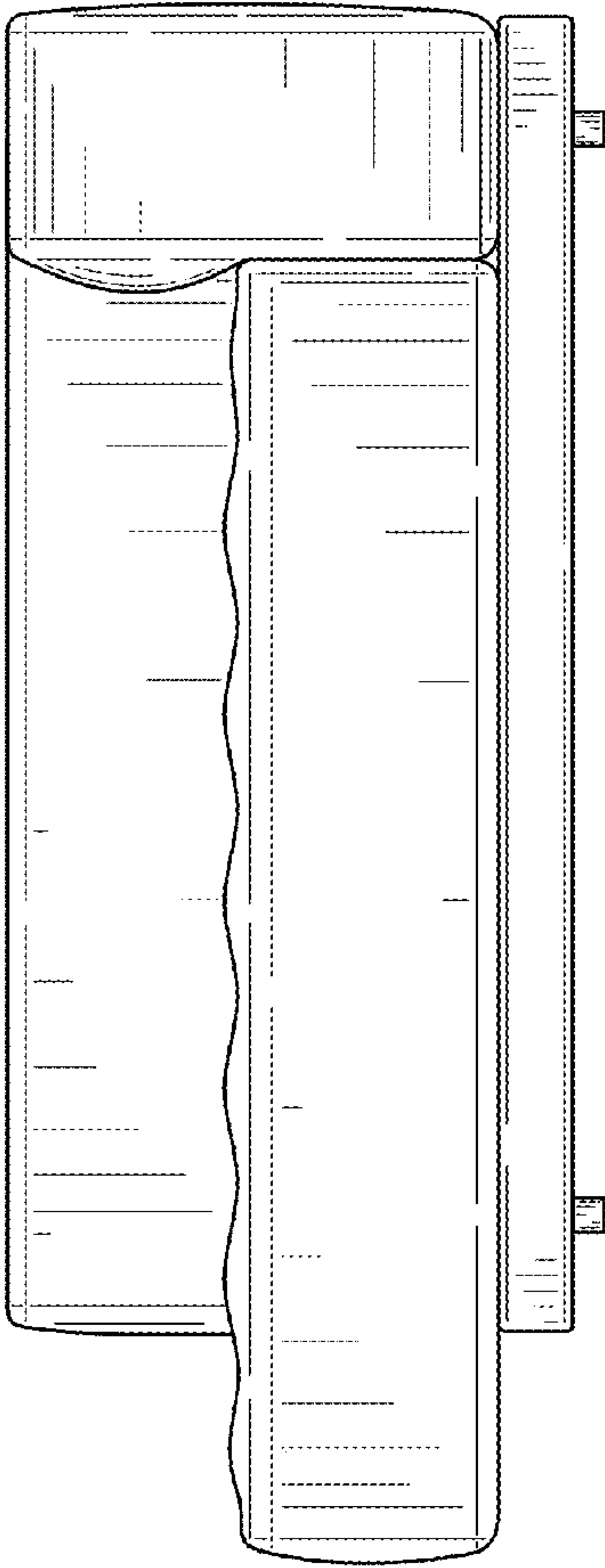

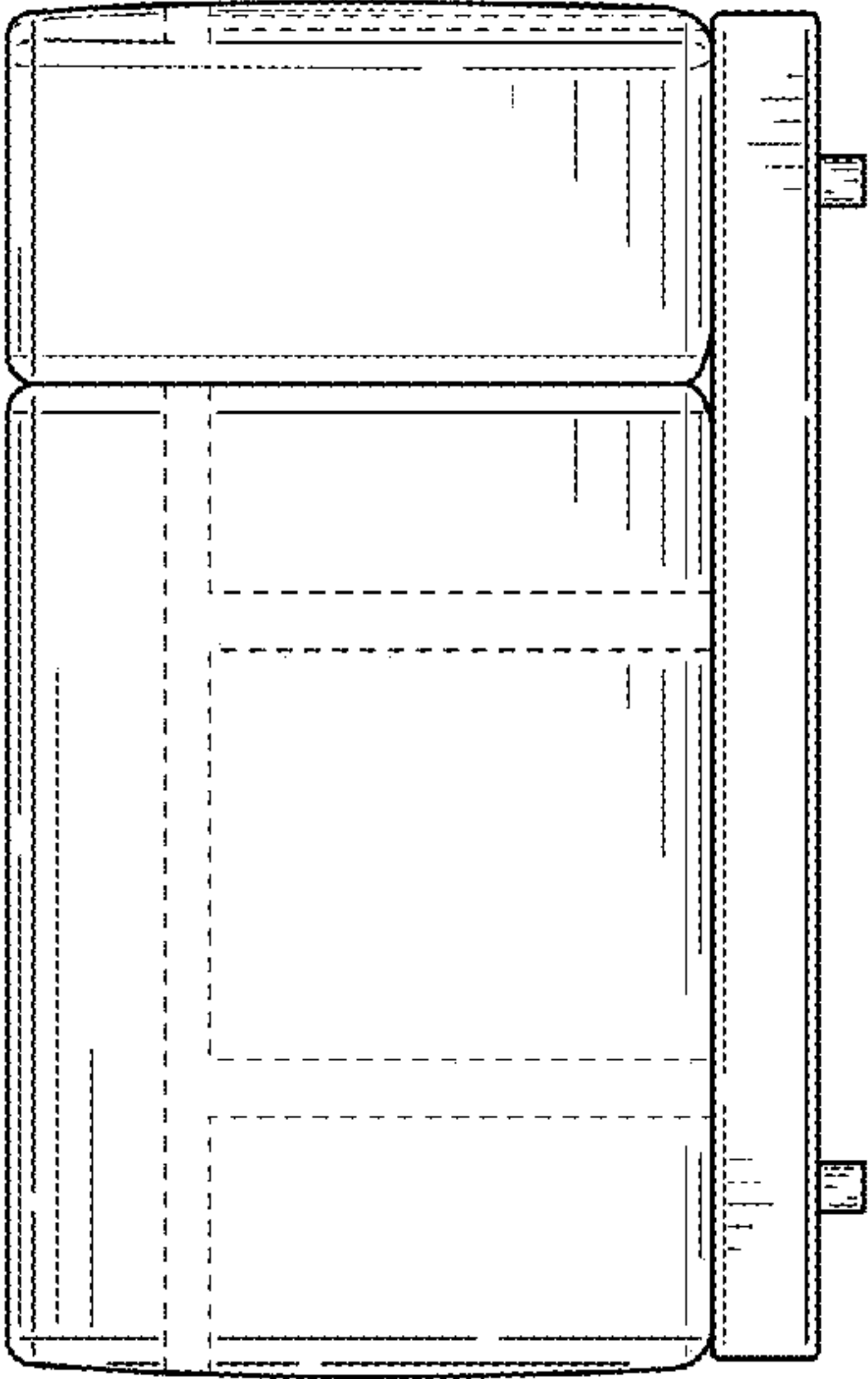
