FIG. 8 is another perspective view of the collectible display stand design.

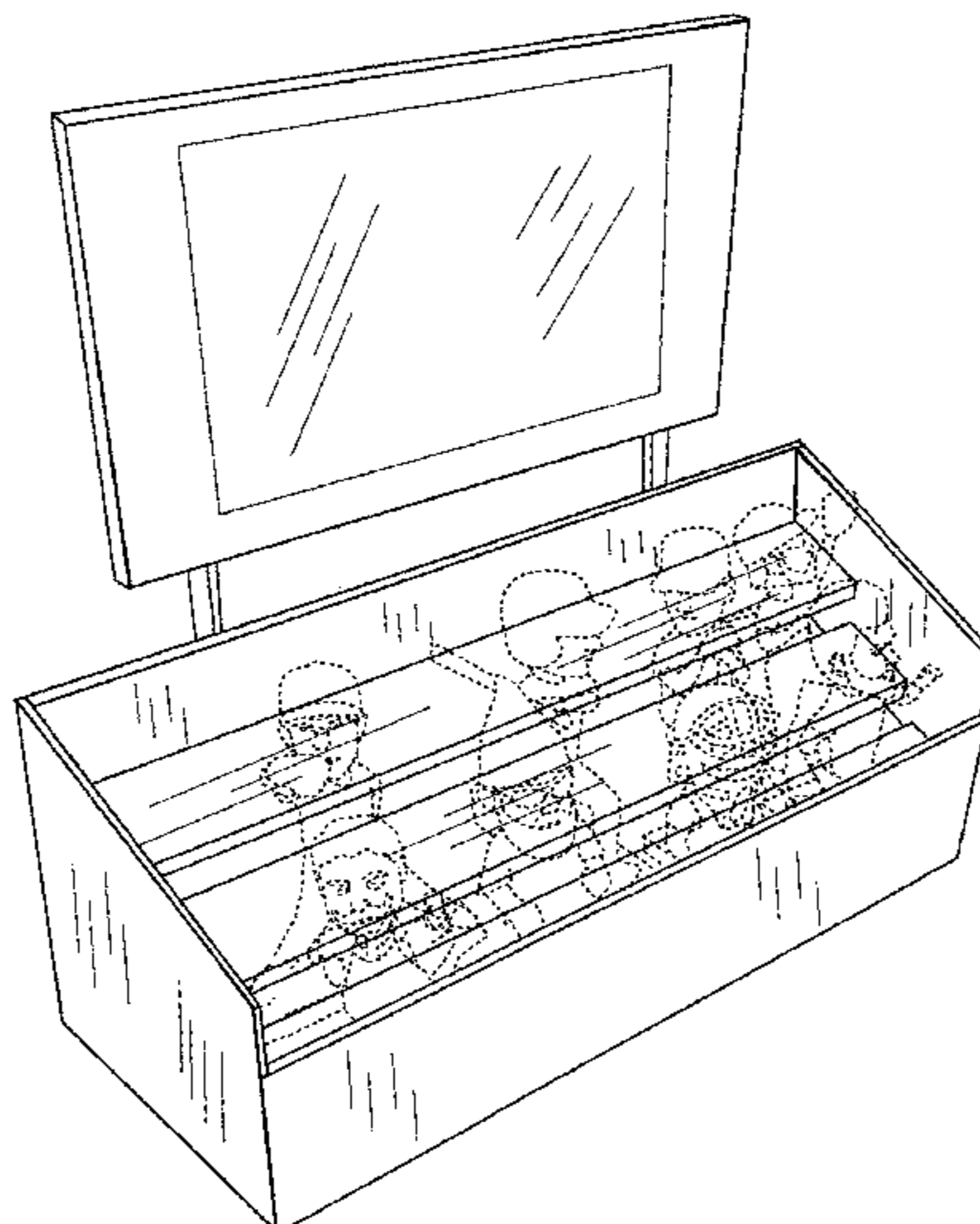

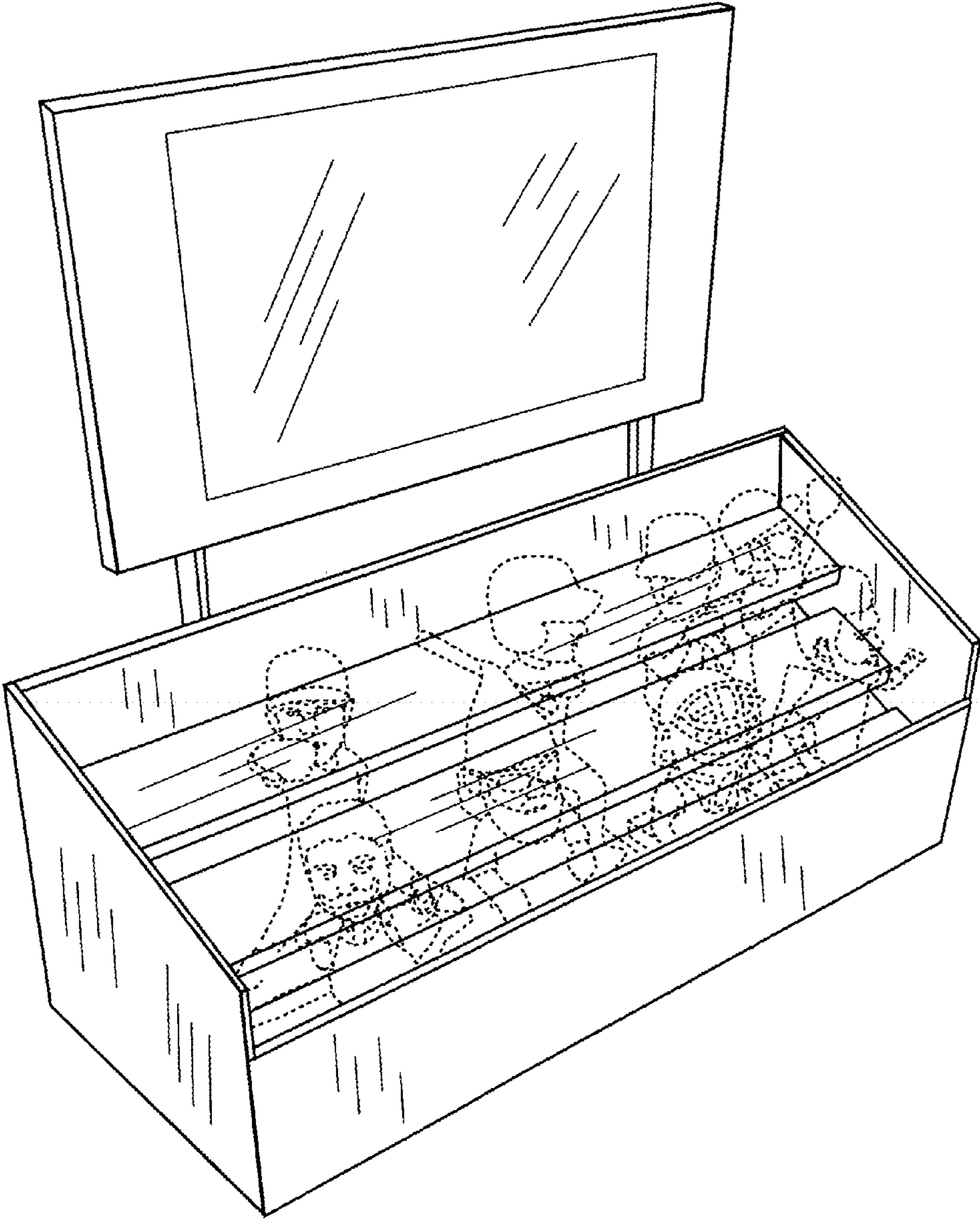

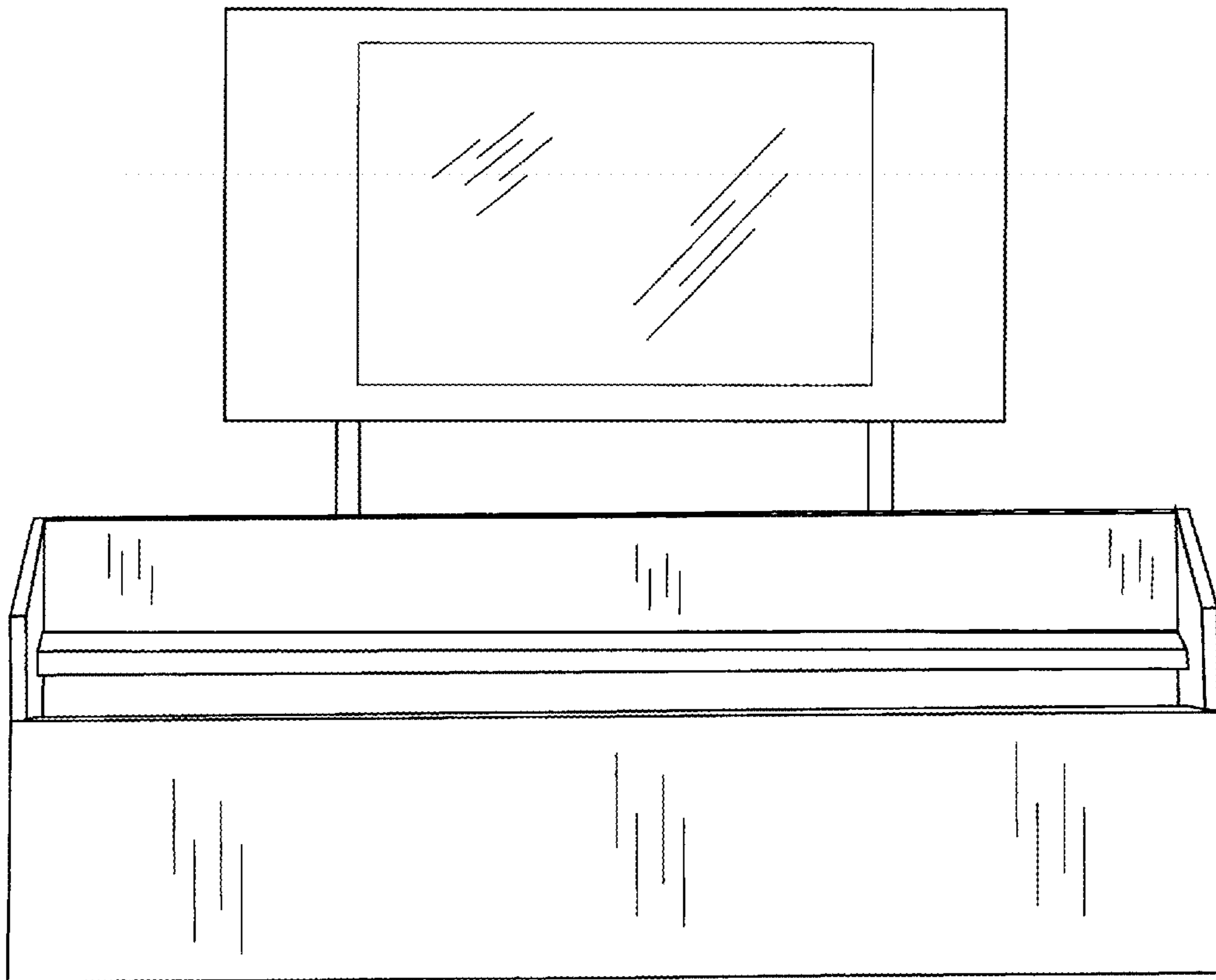

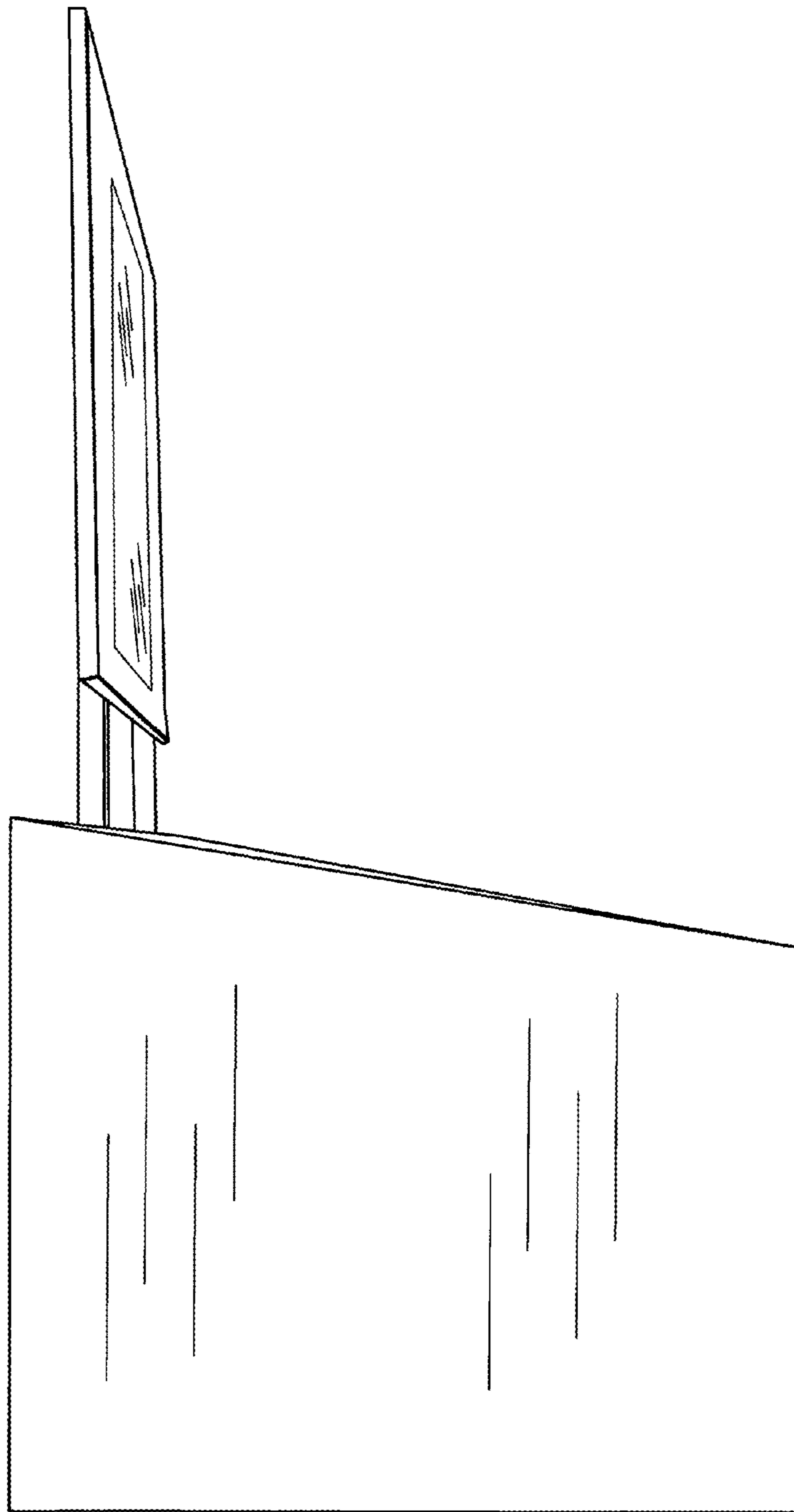

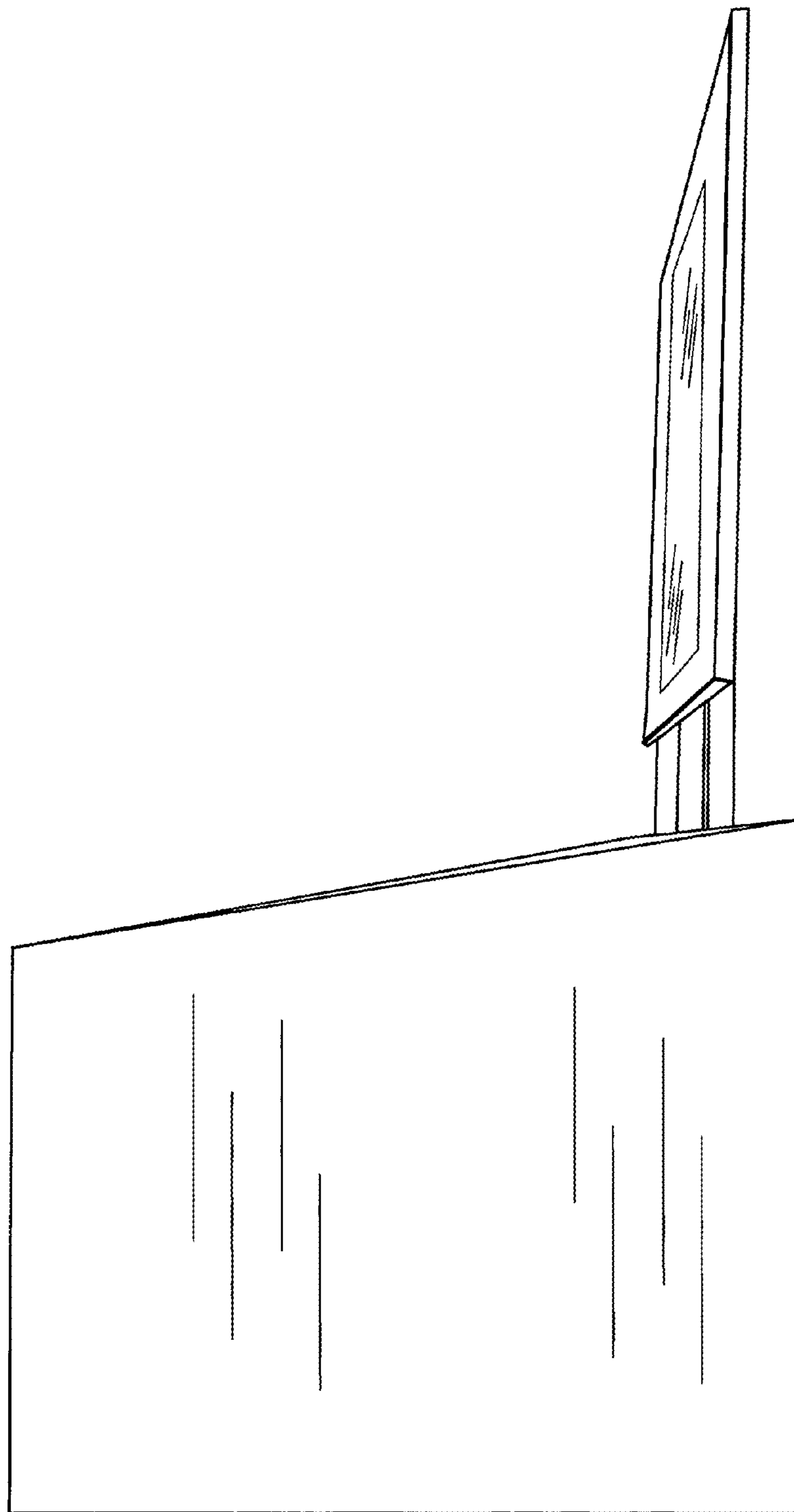

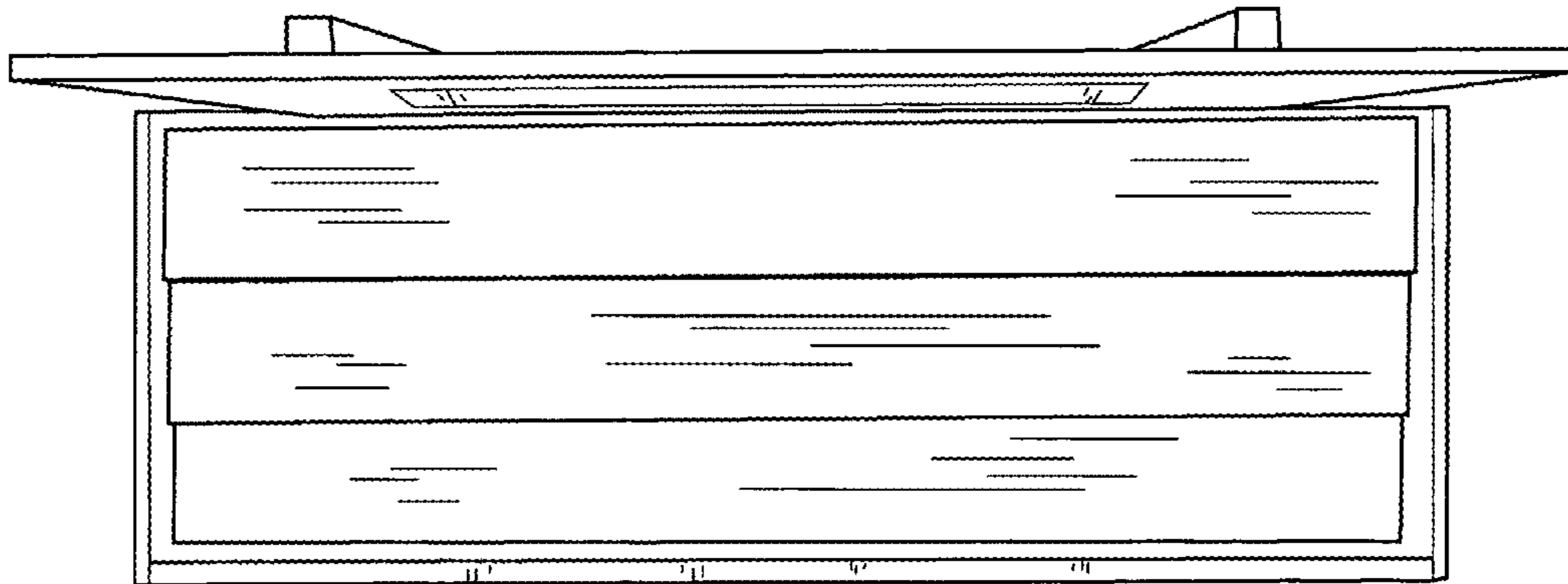

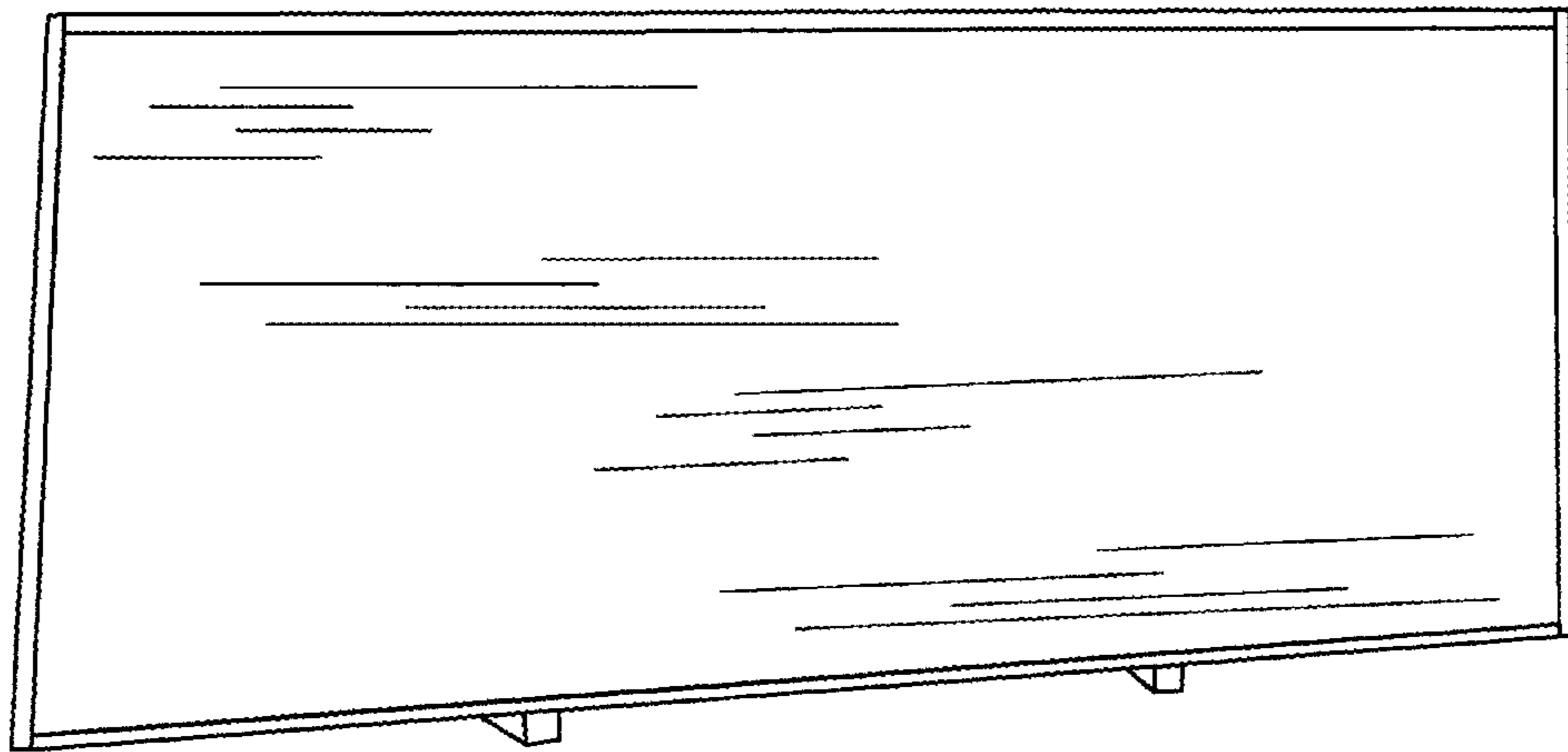

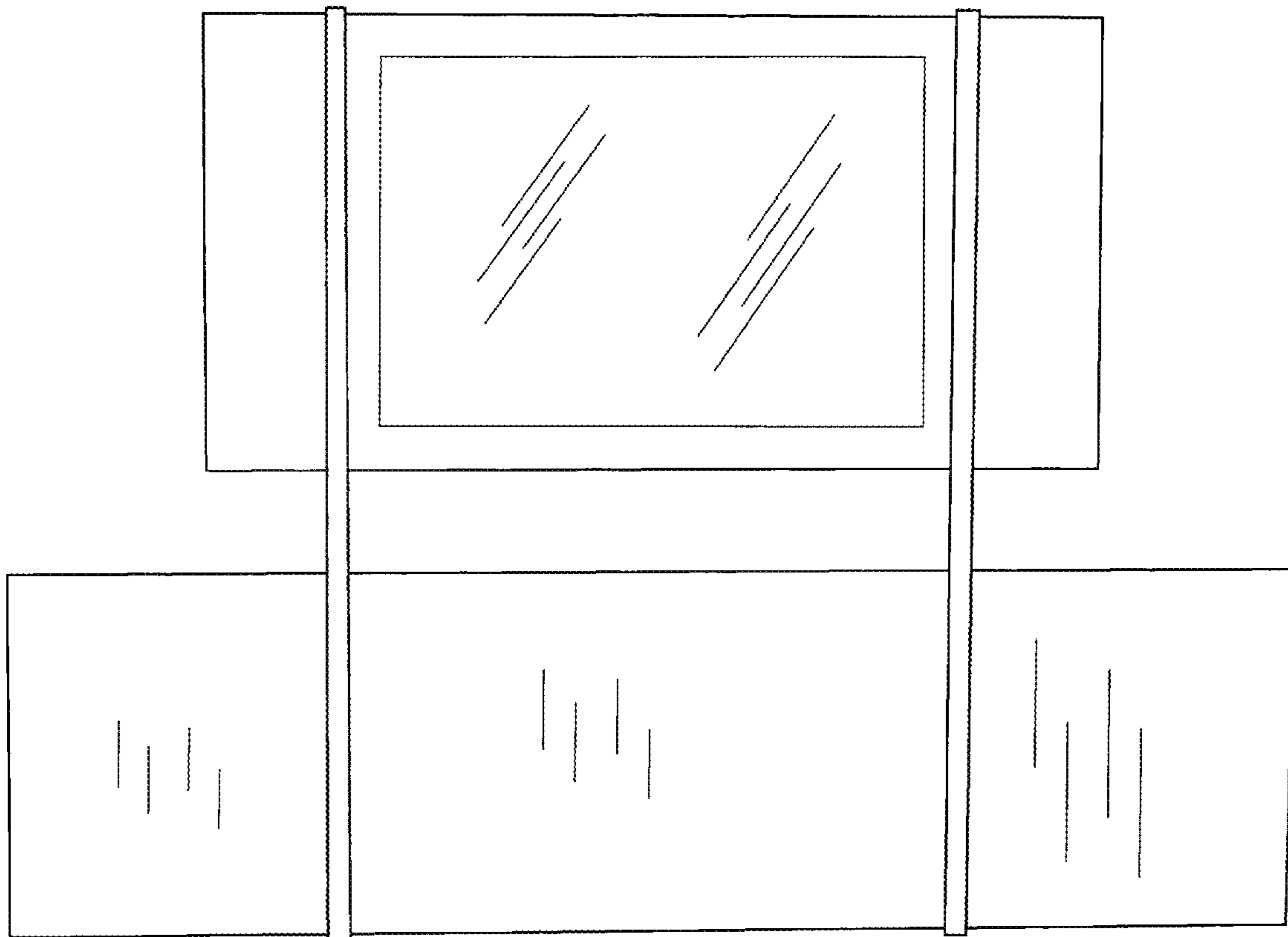

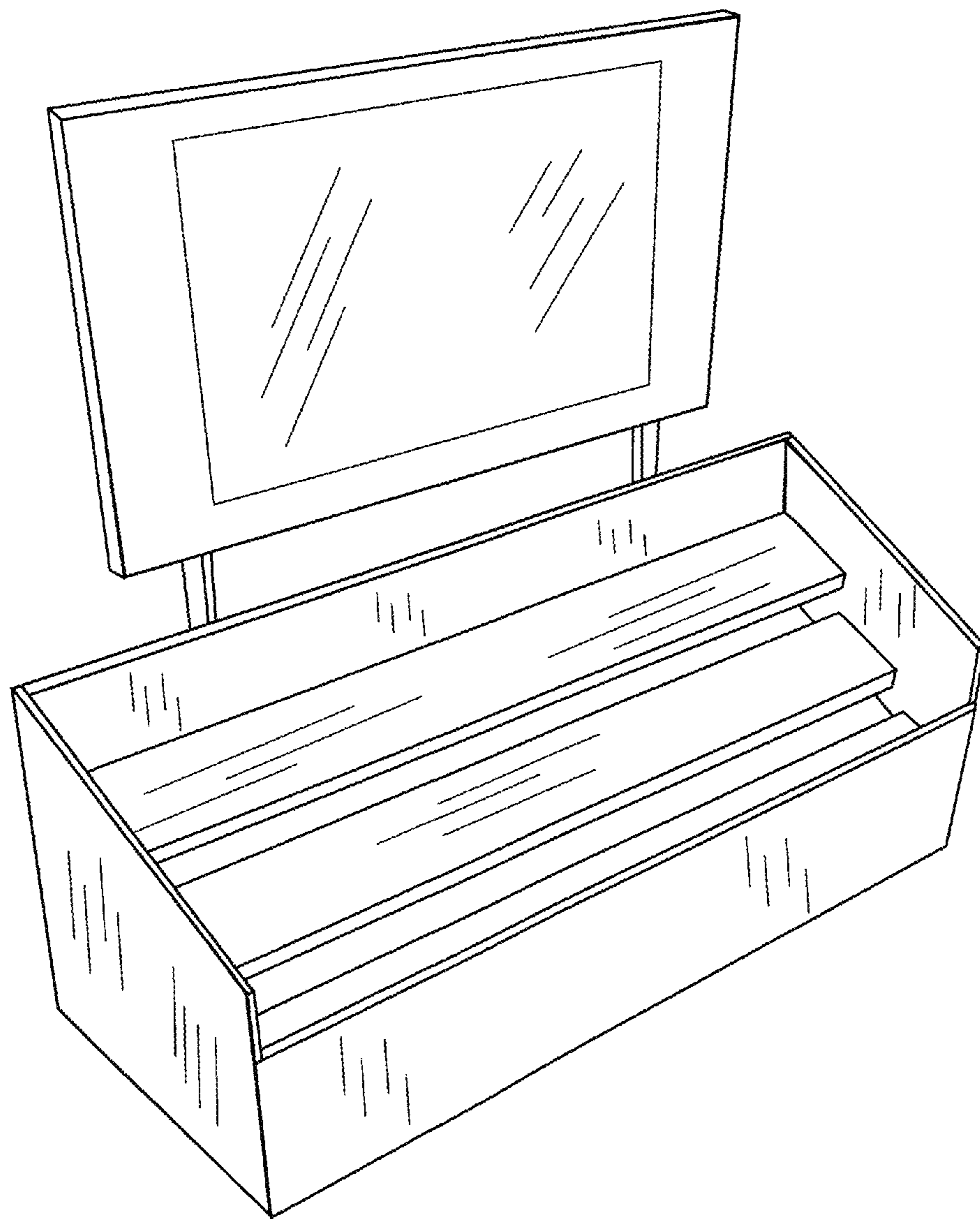
