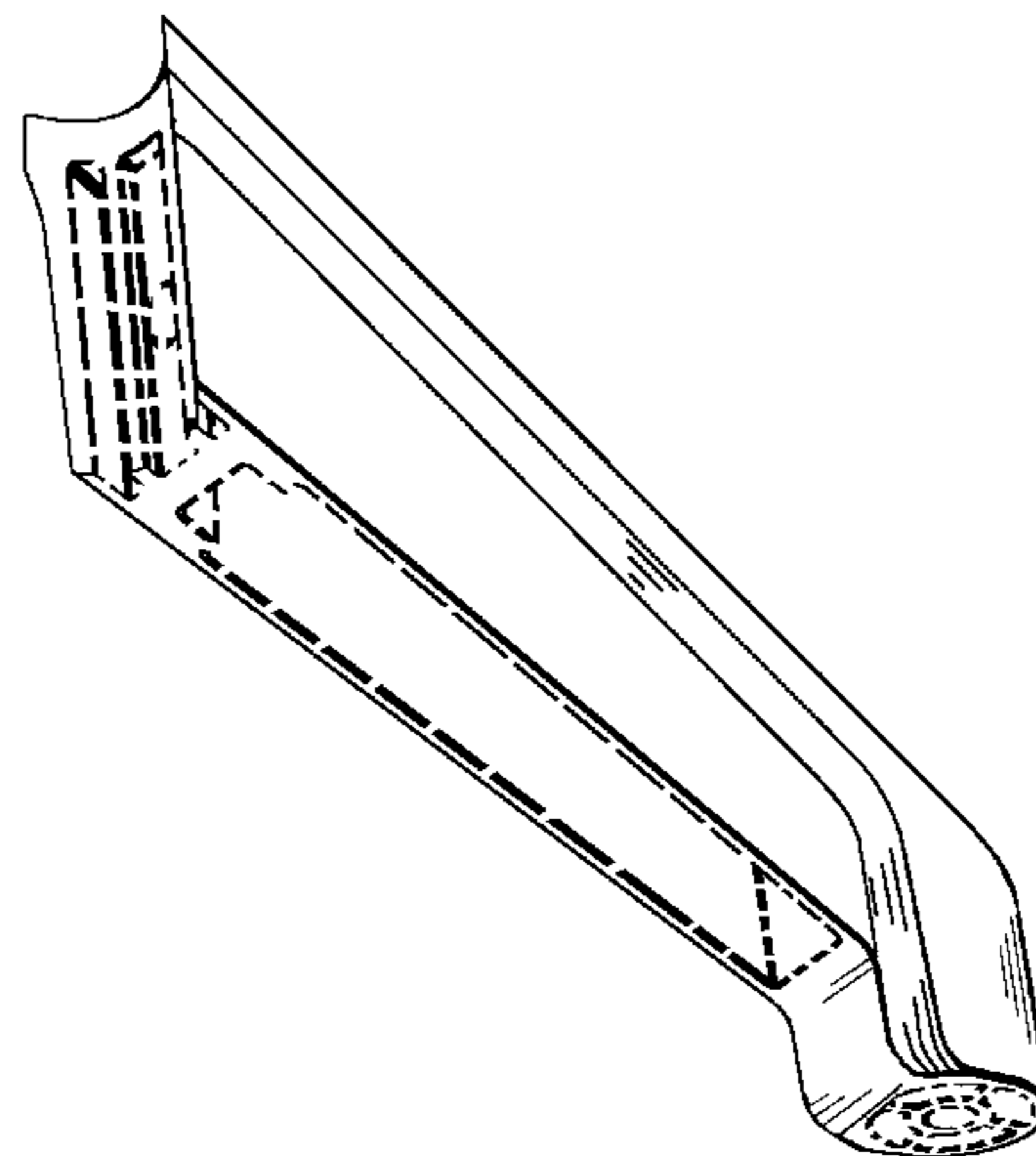
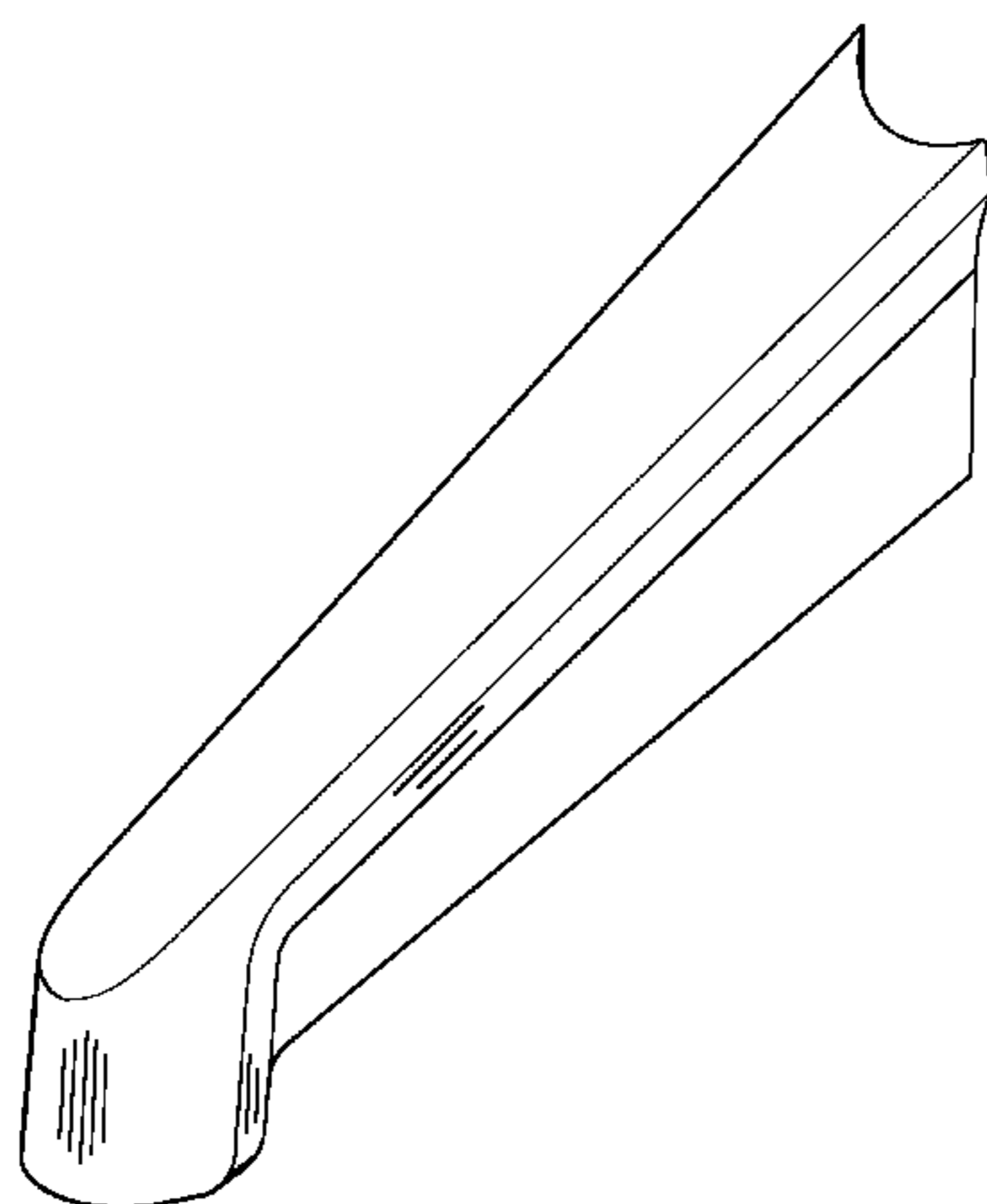


FIG. 25 is a front perspective view of a support leg, showing a fourth embodiment of my new design;

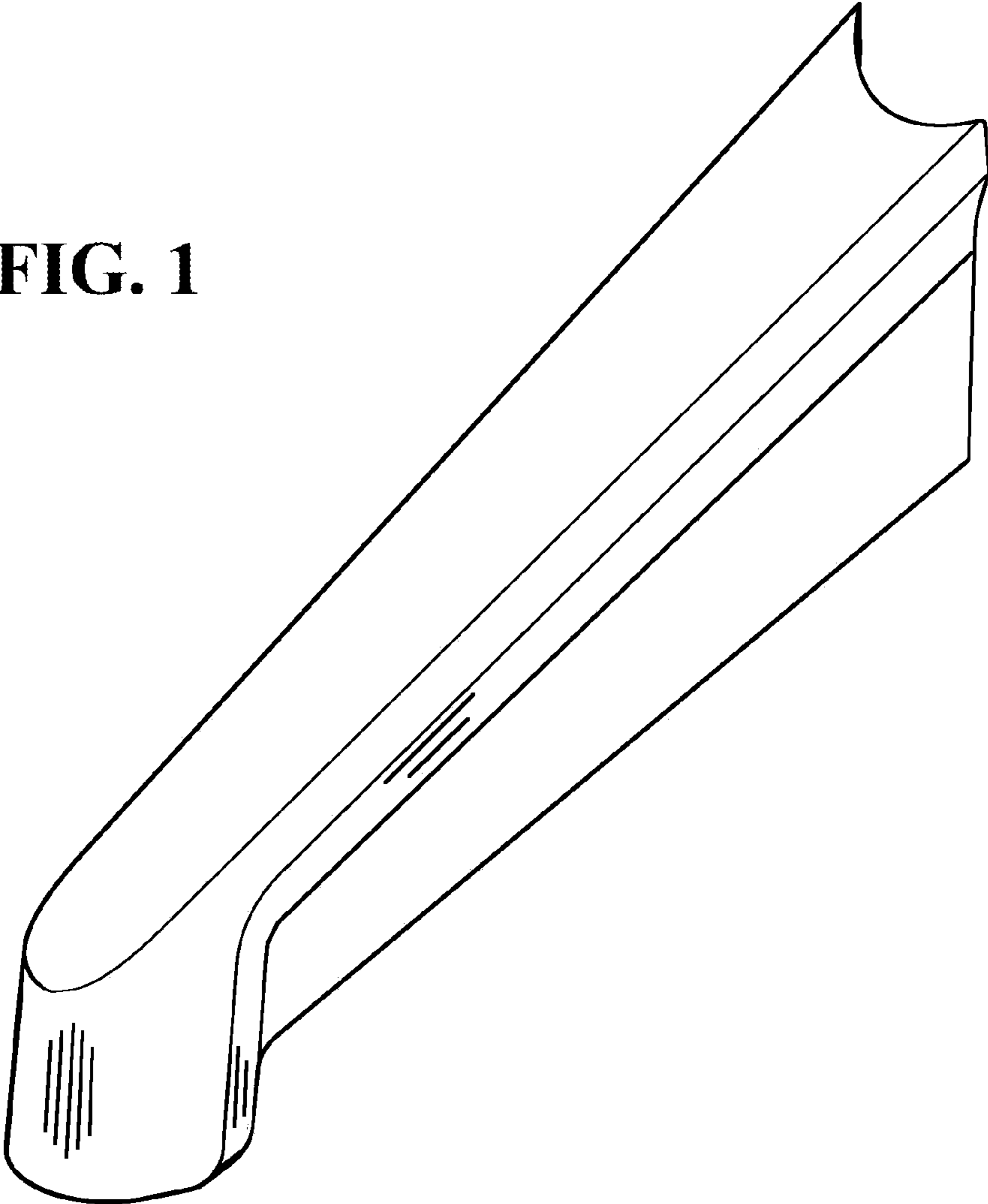
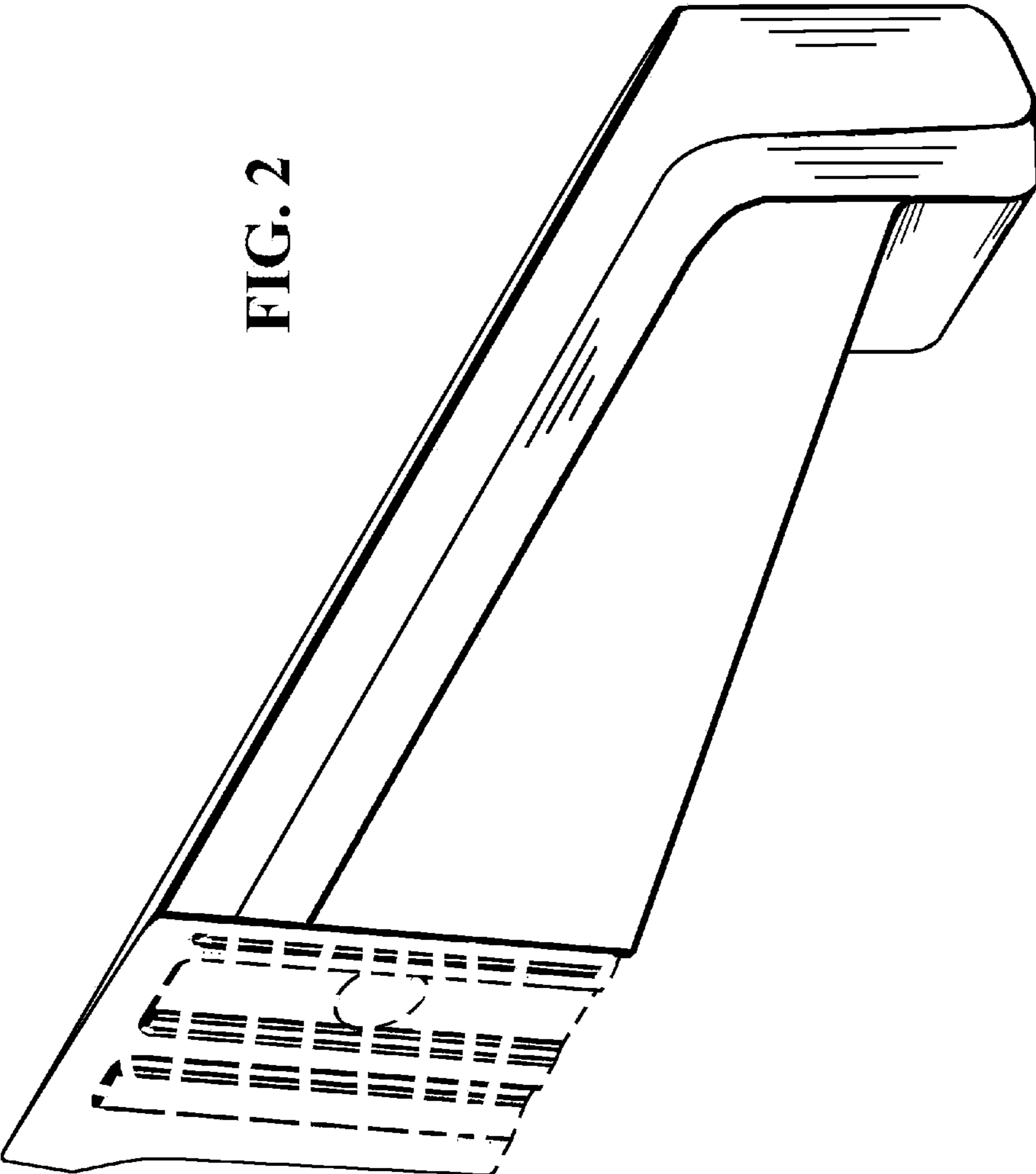

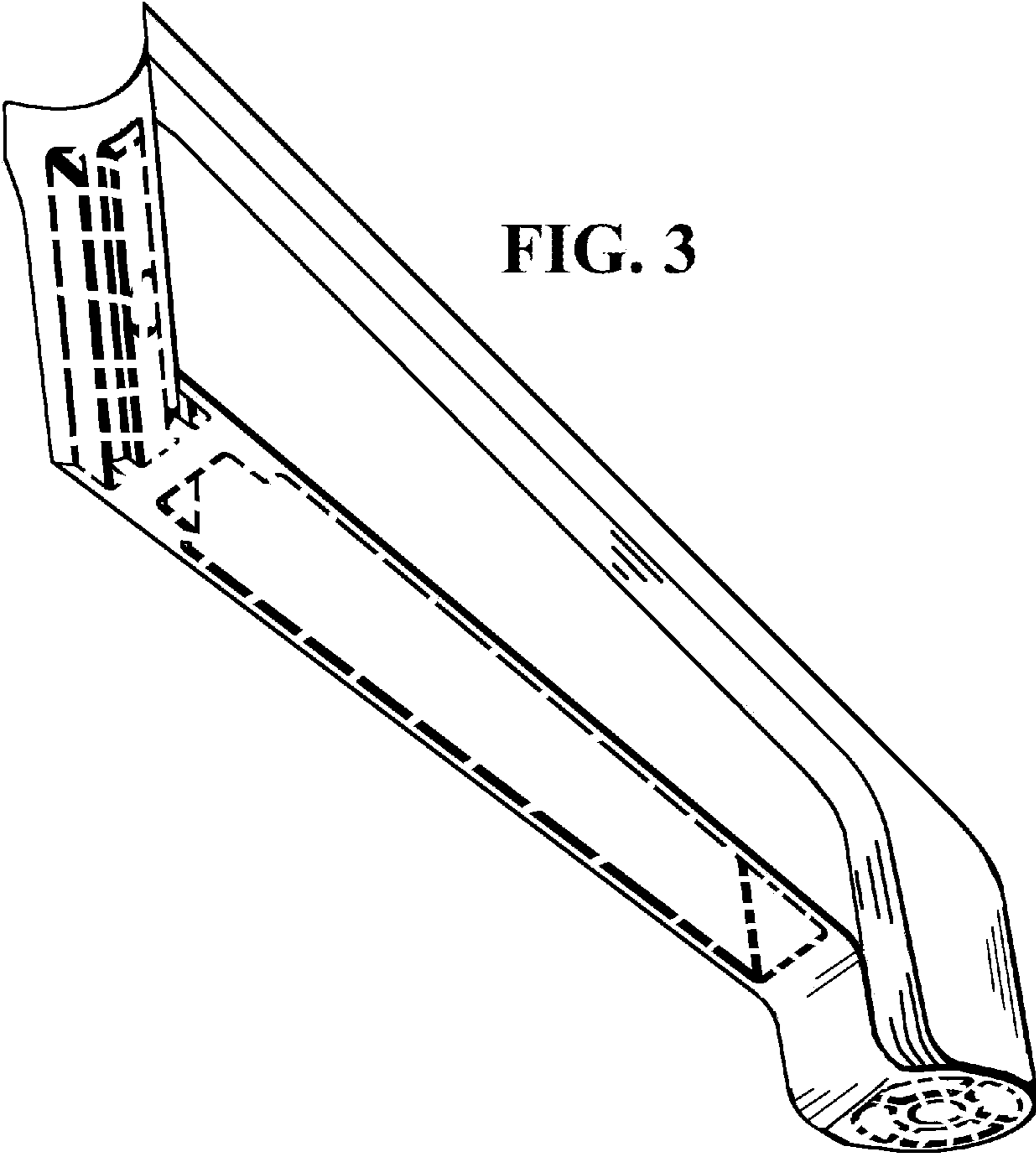

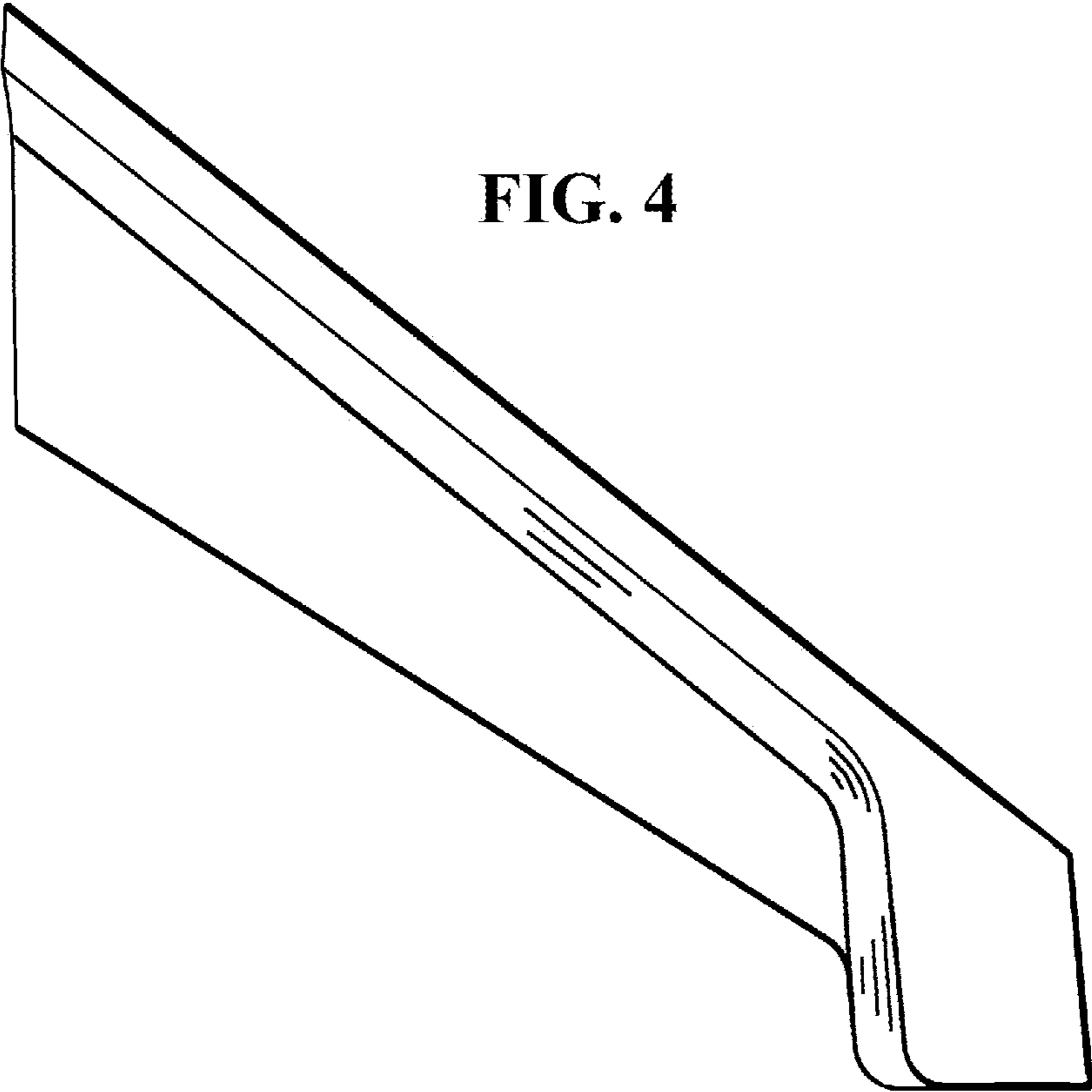

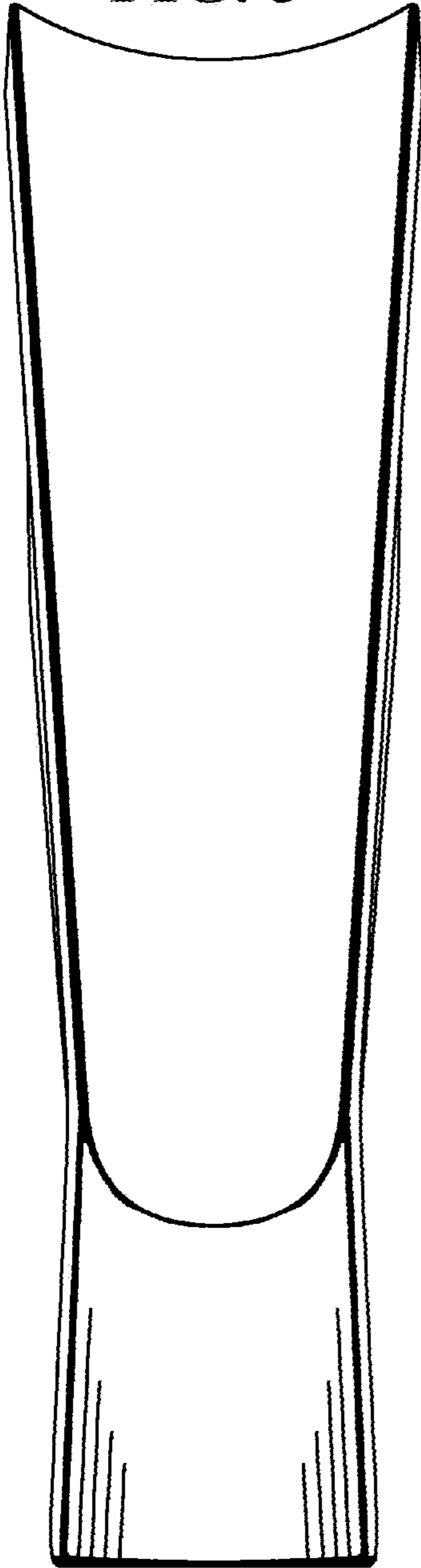

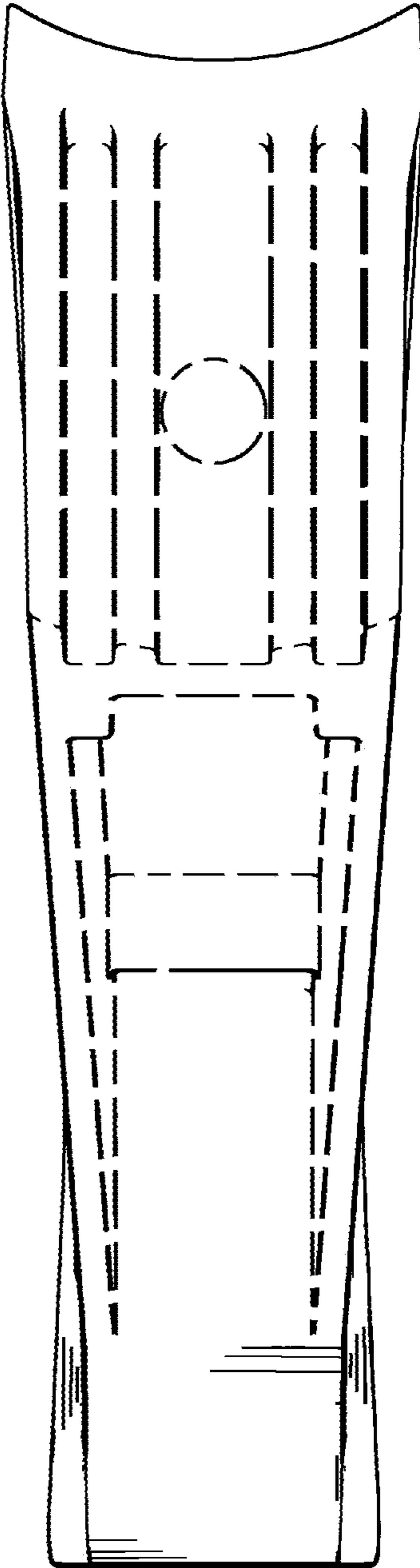

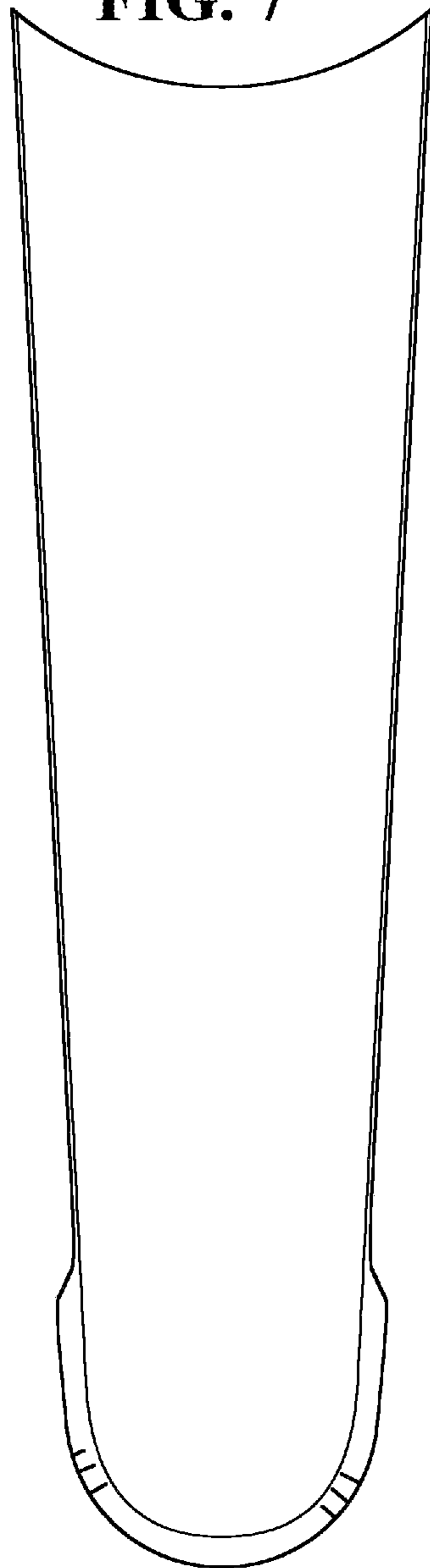
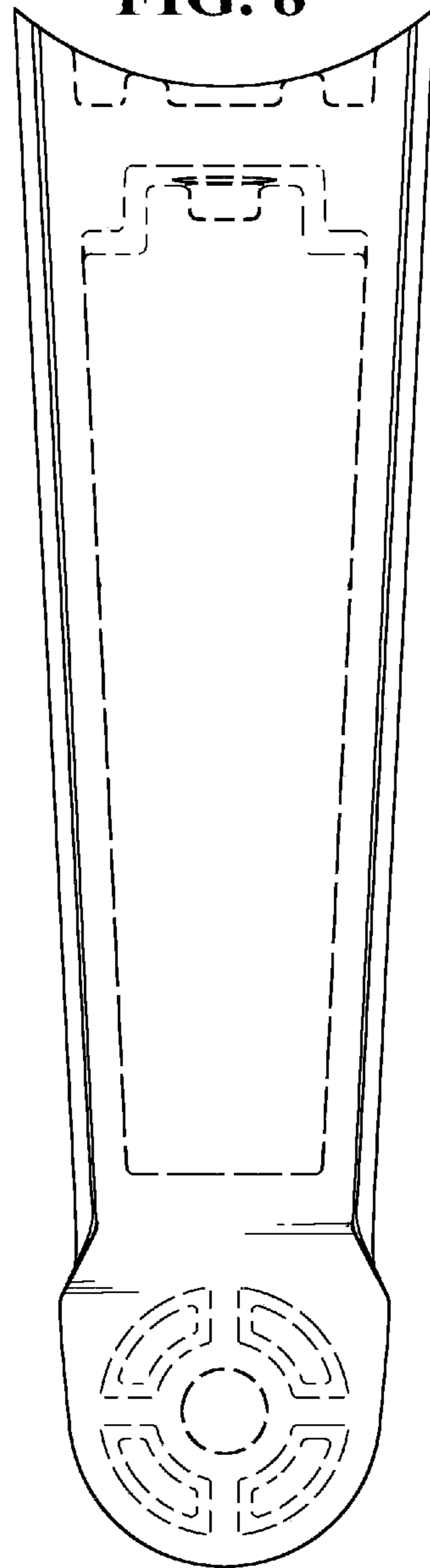

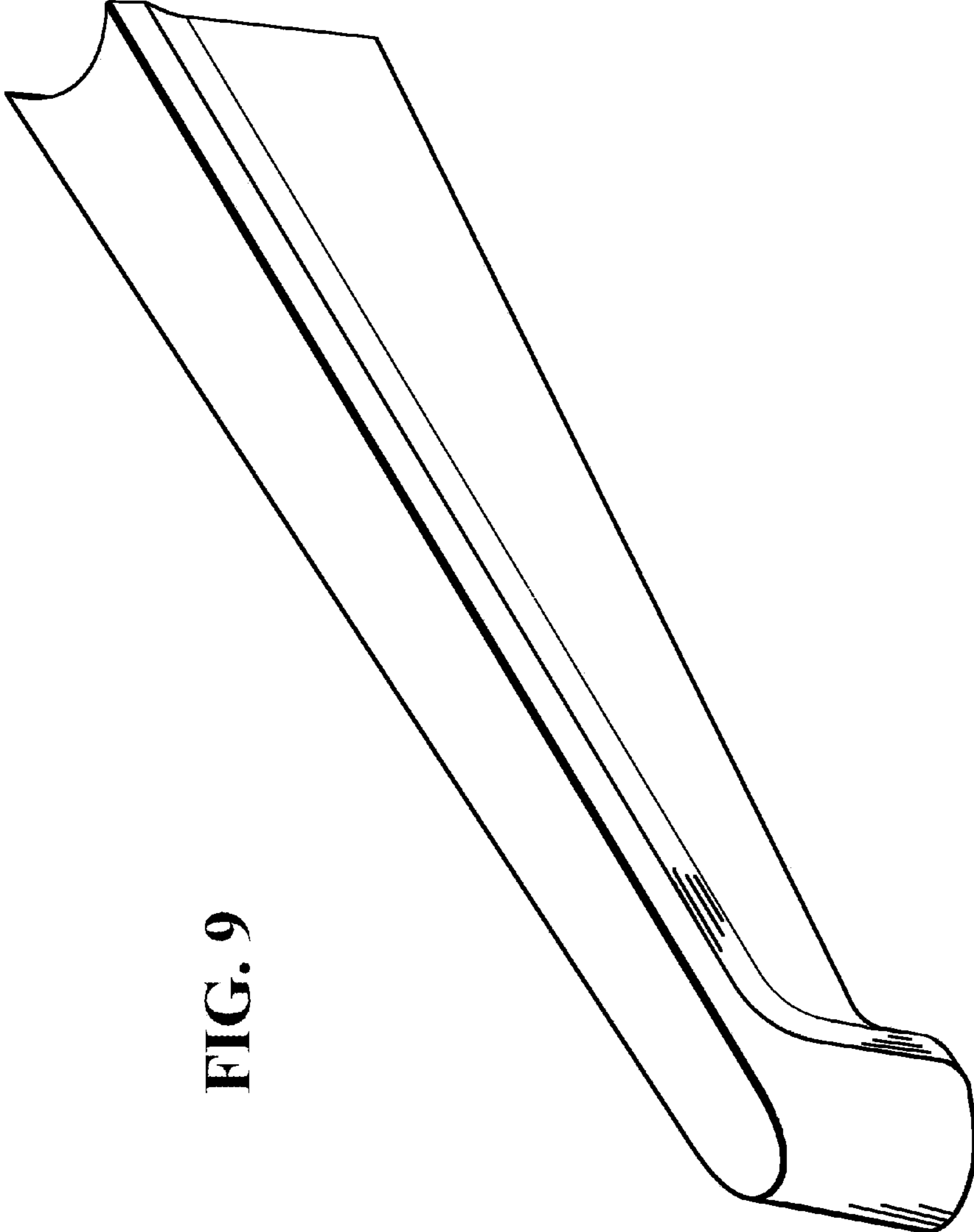

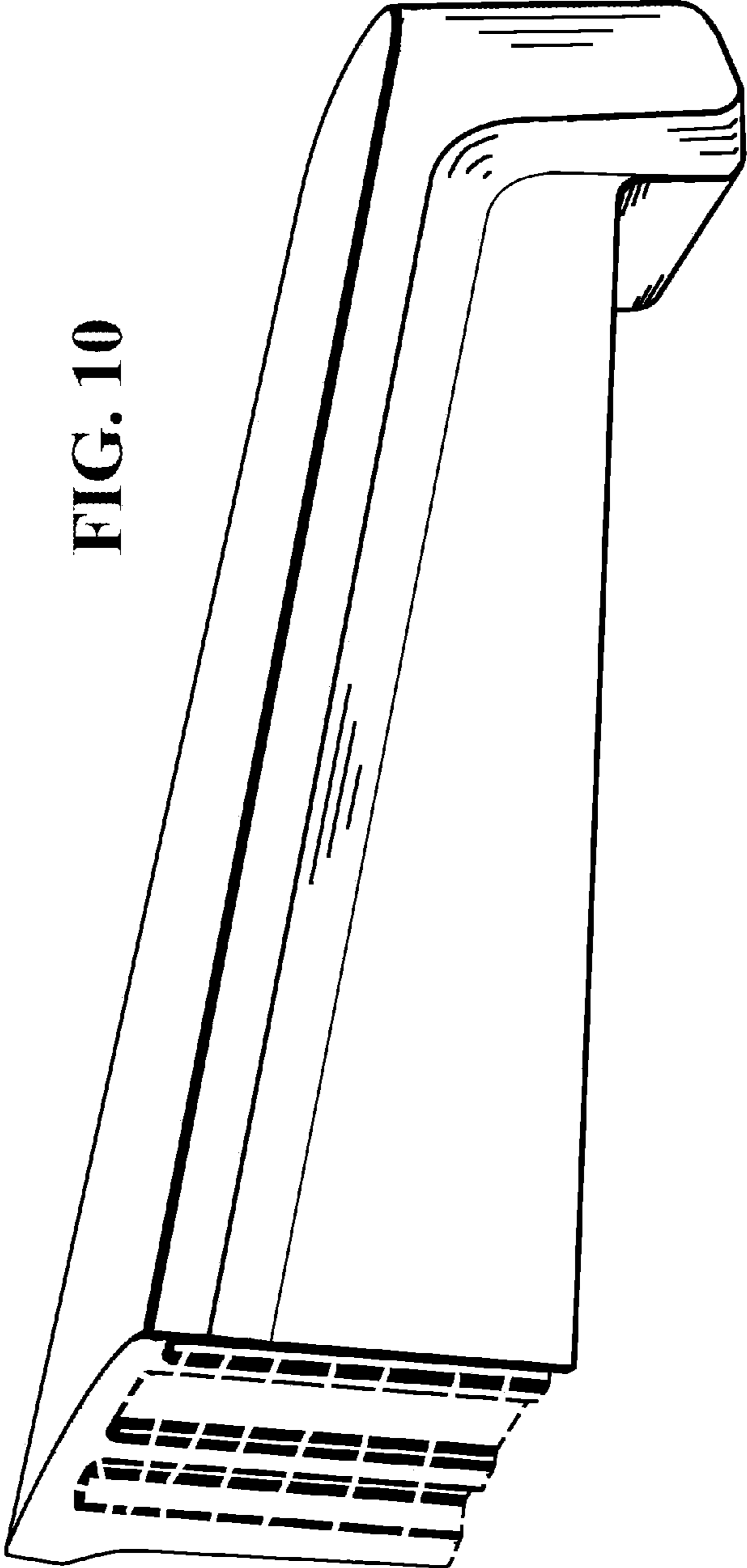

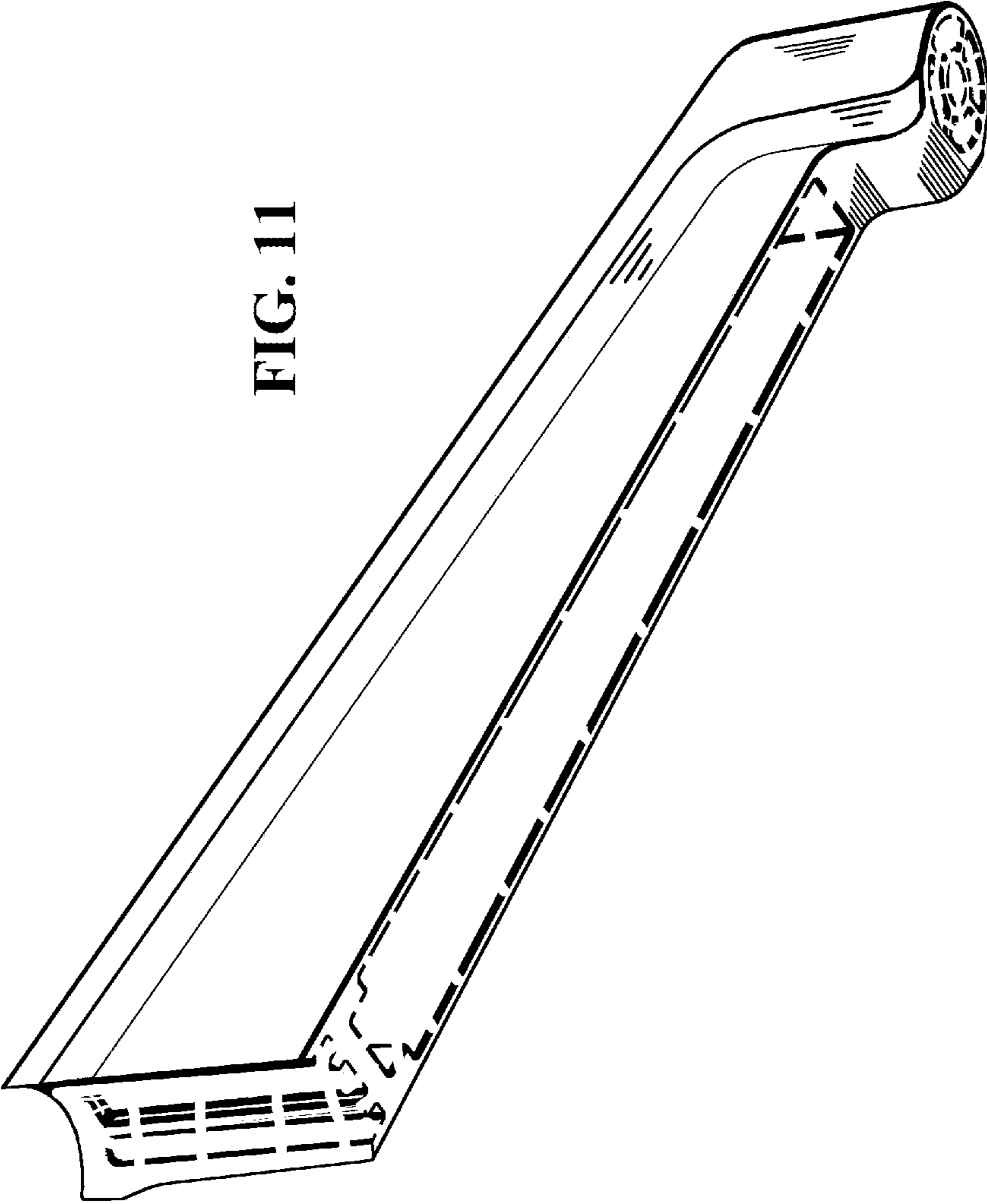

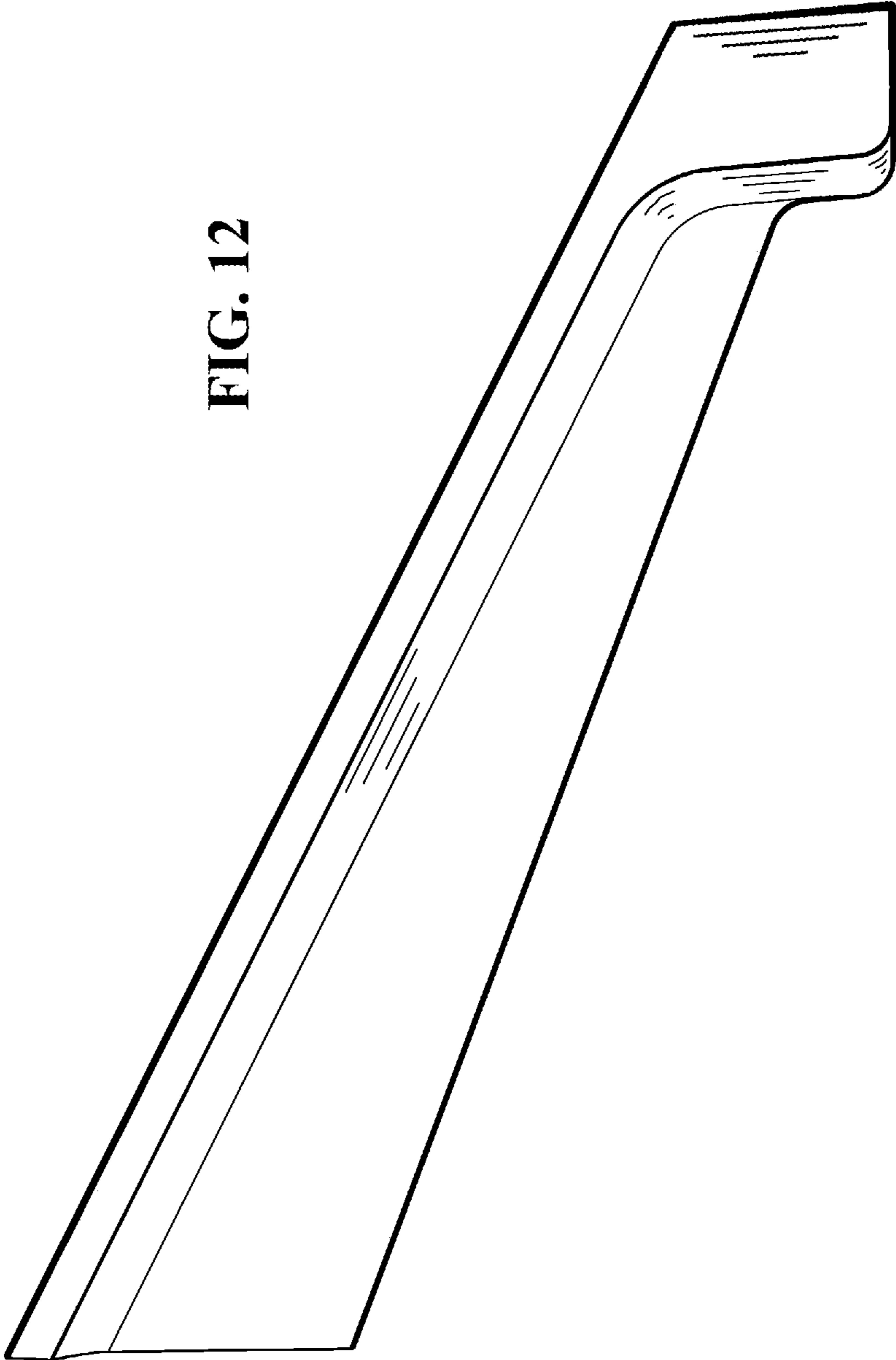

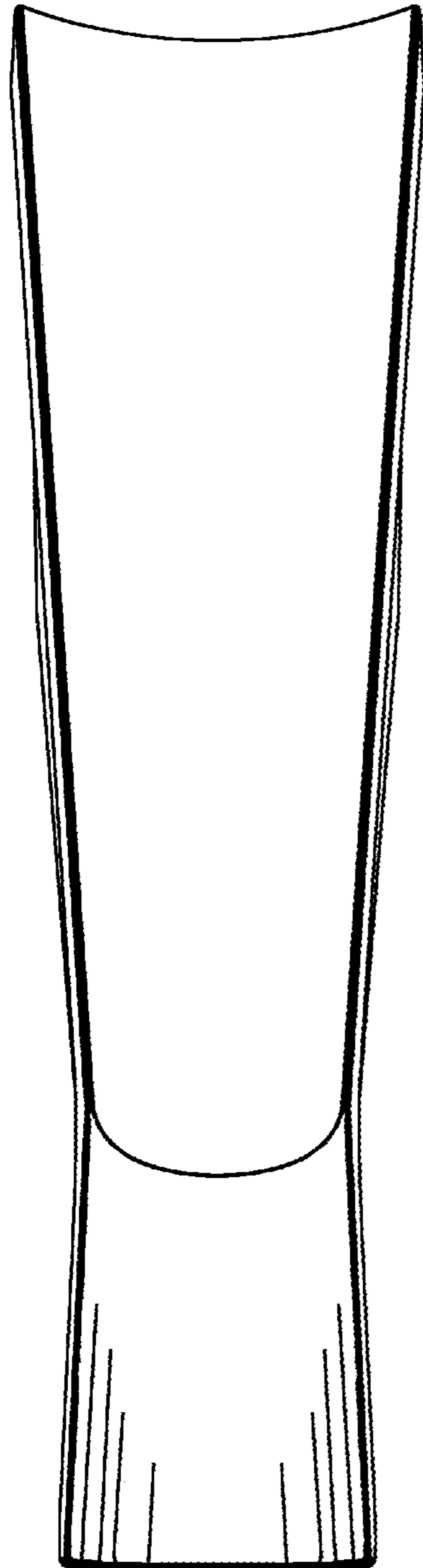

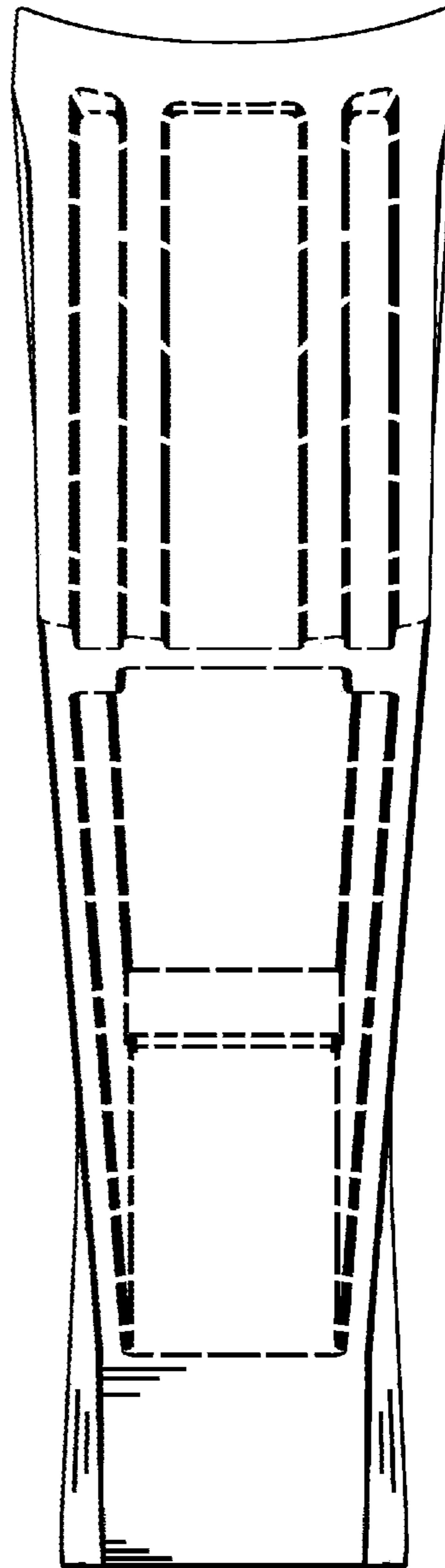

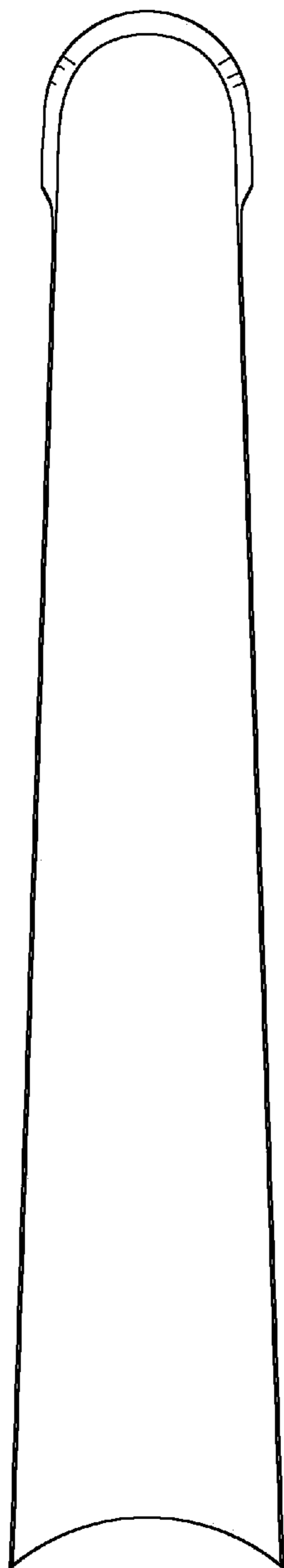
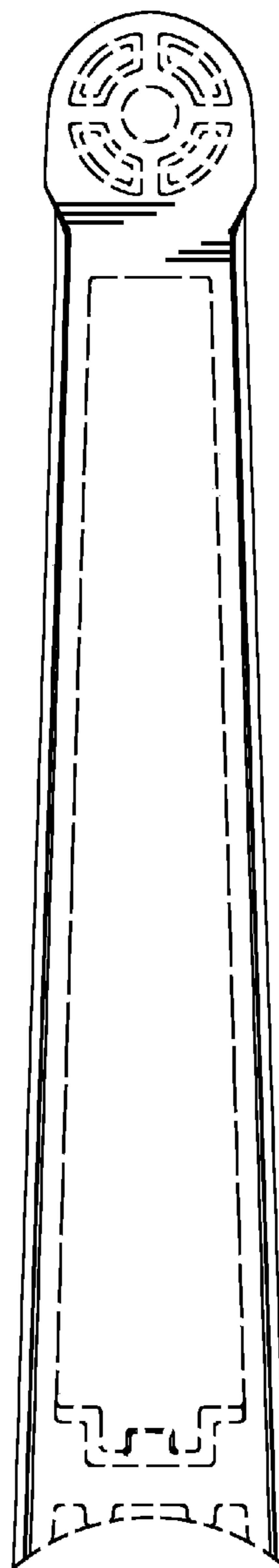

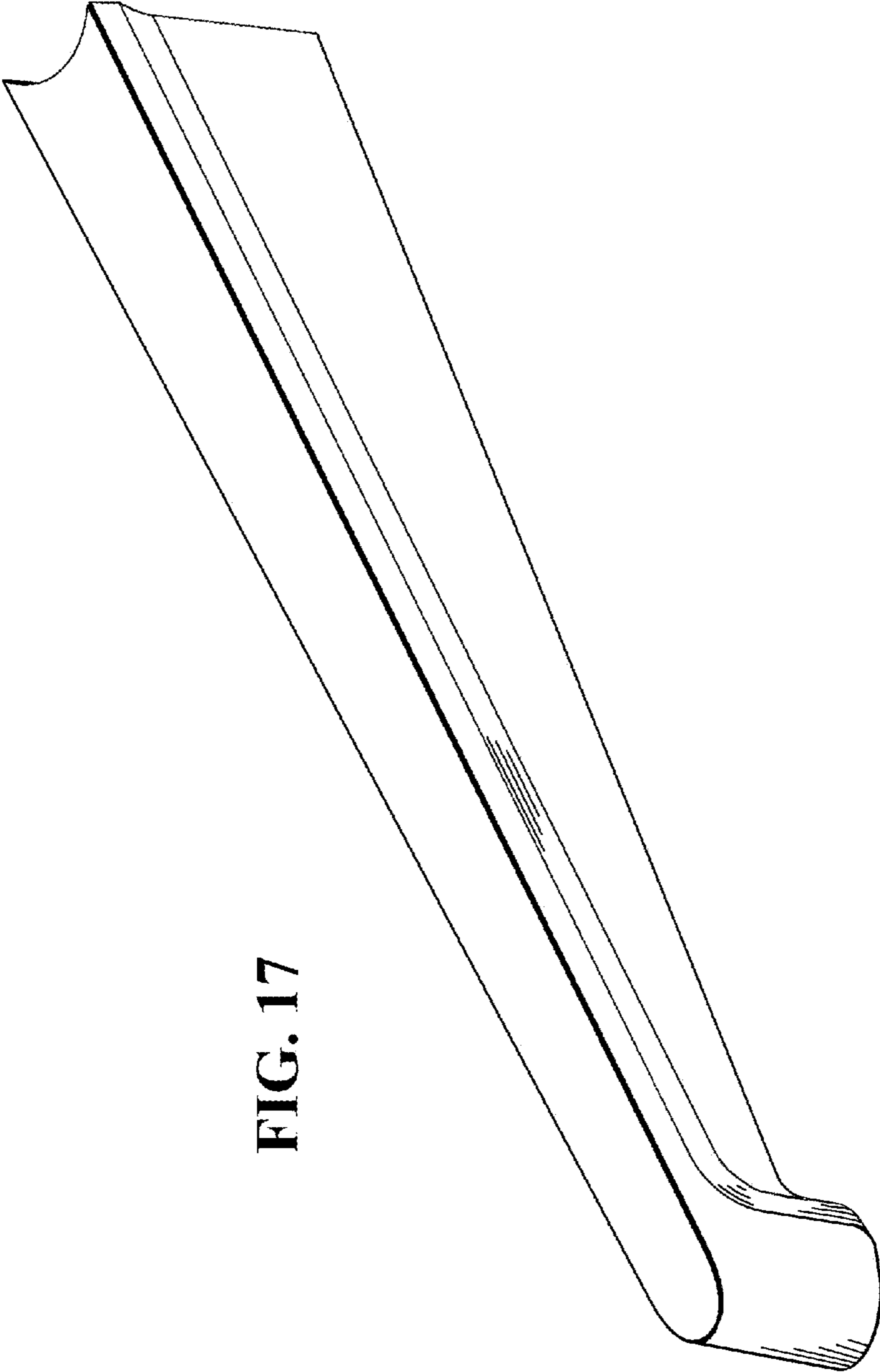

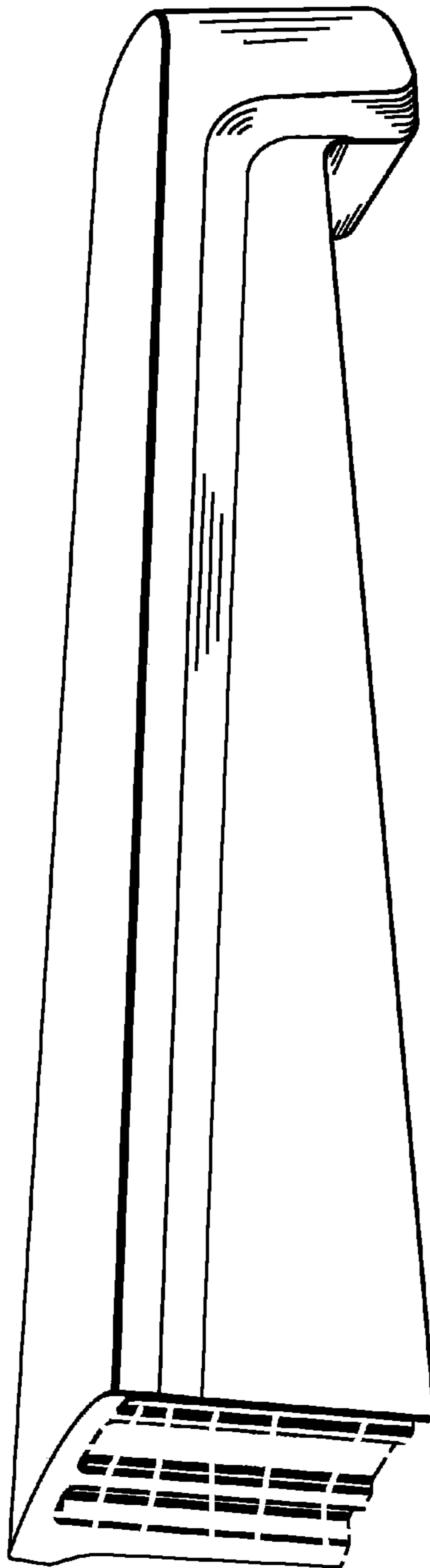

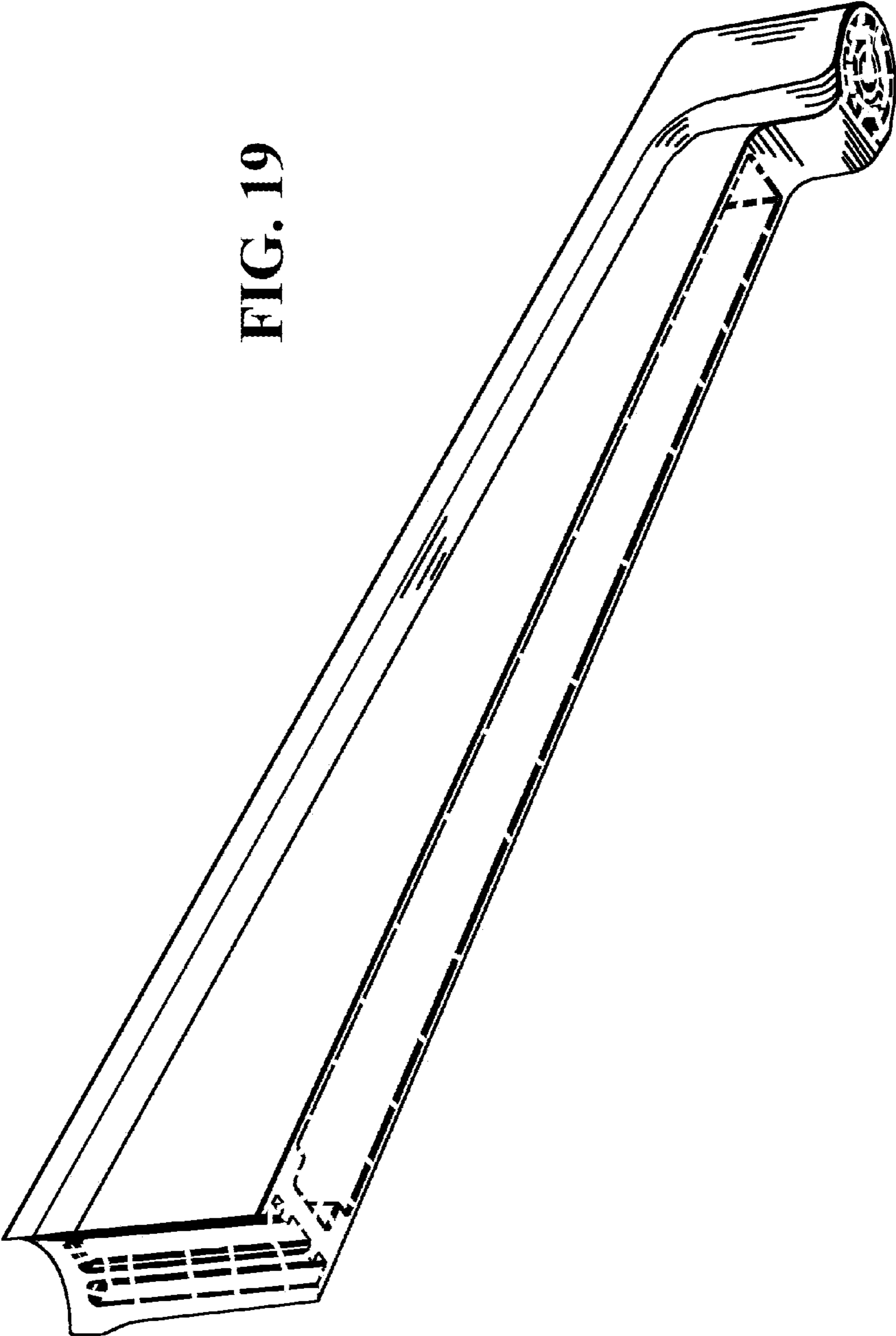

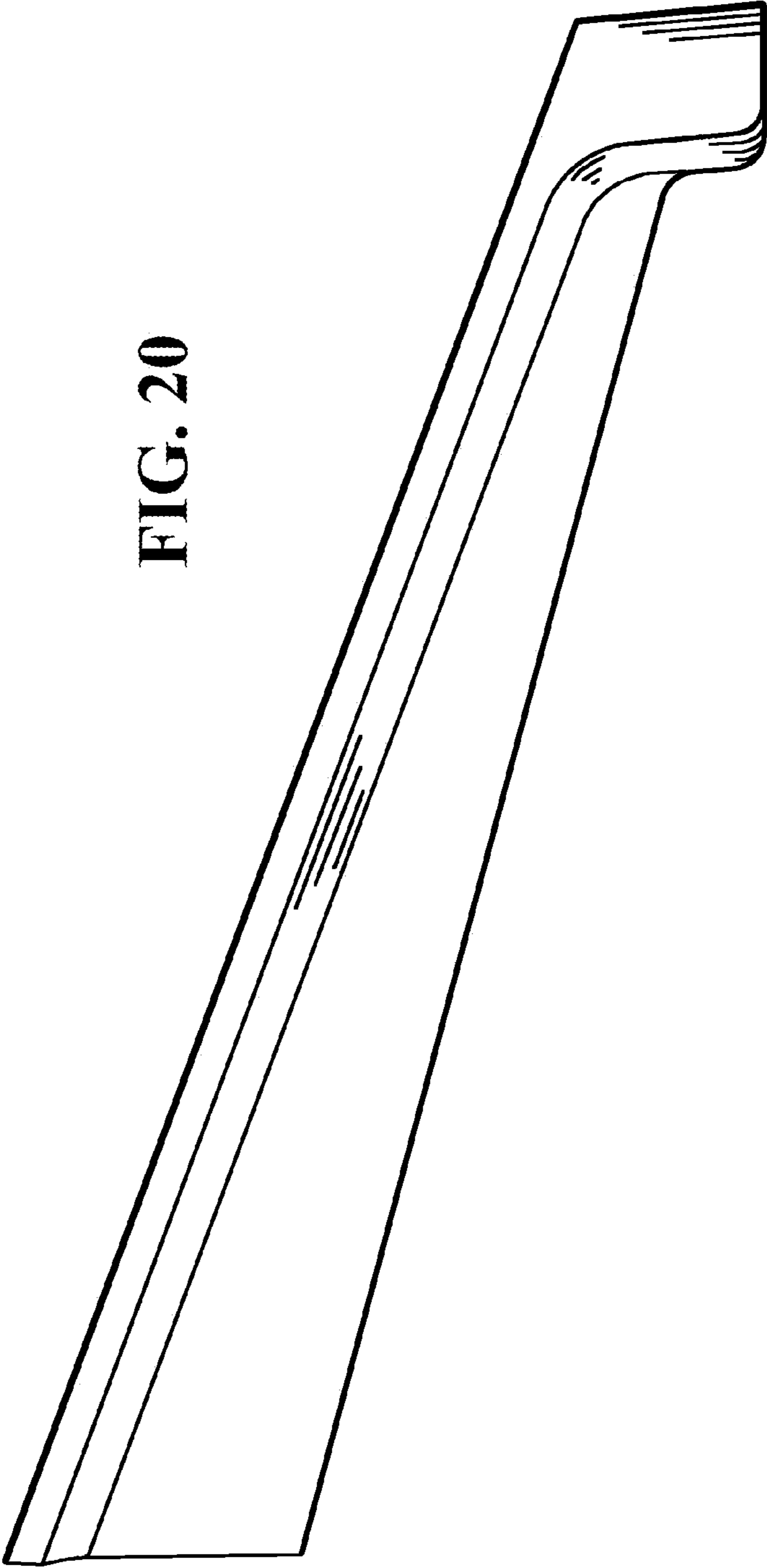

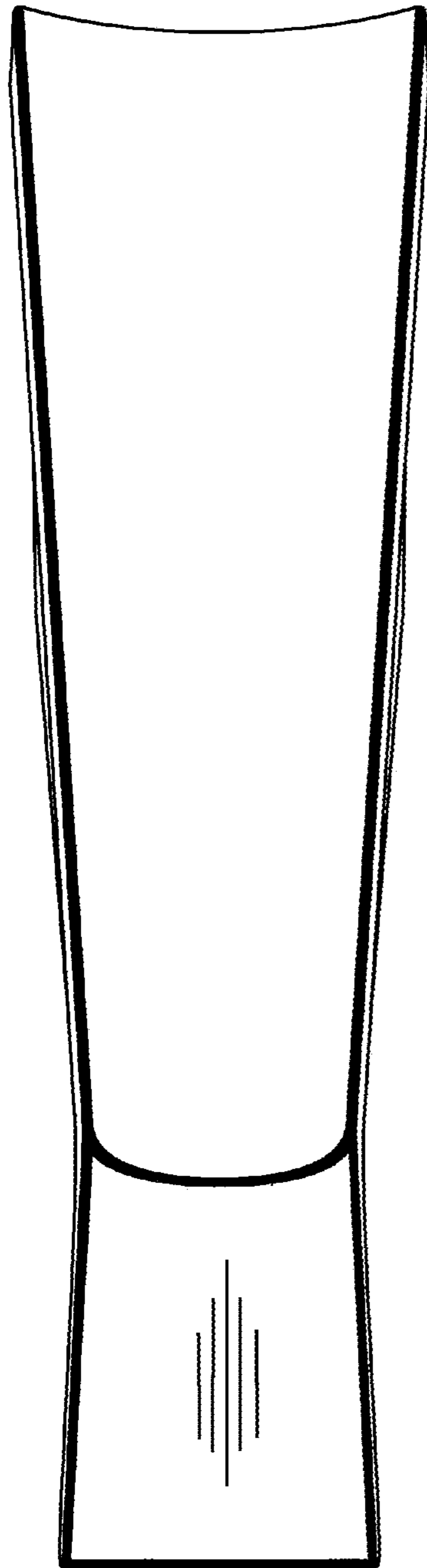

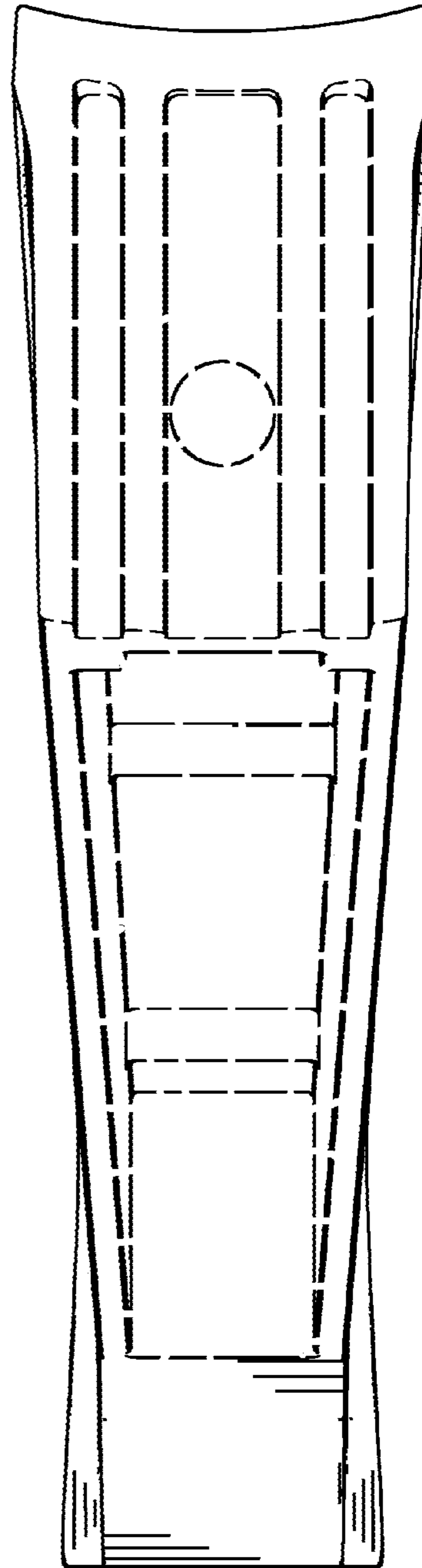

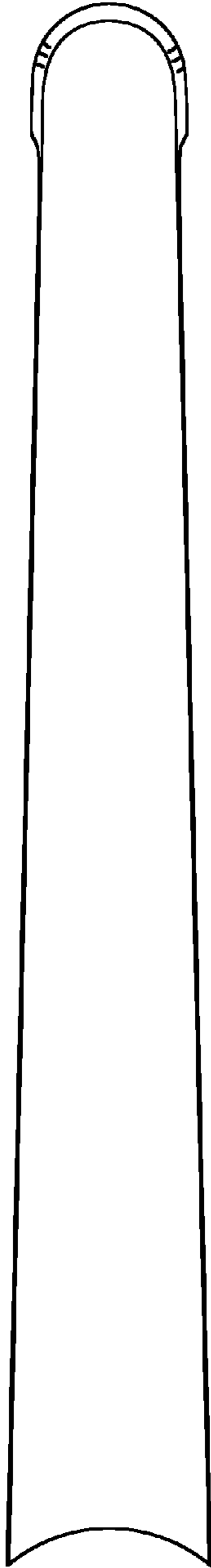
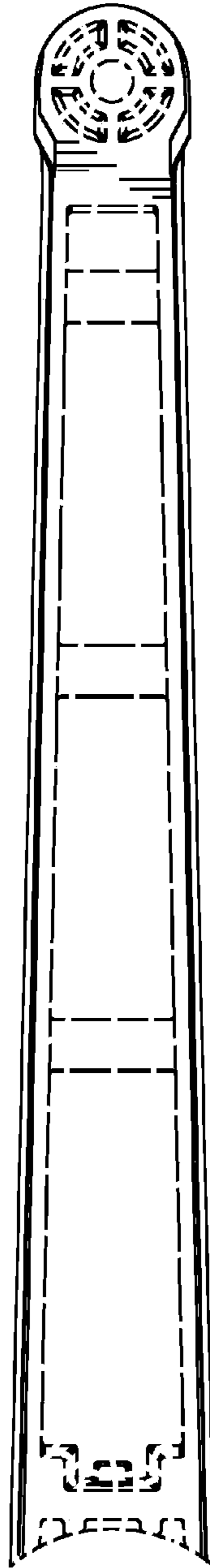

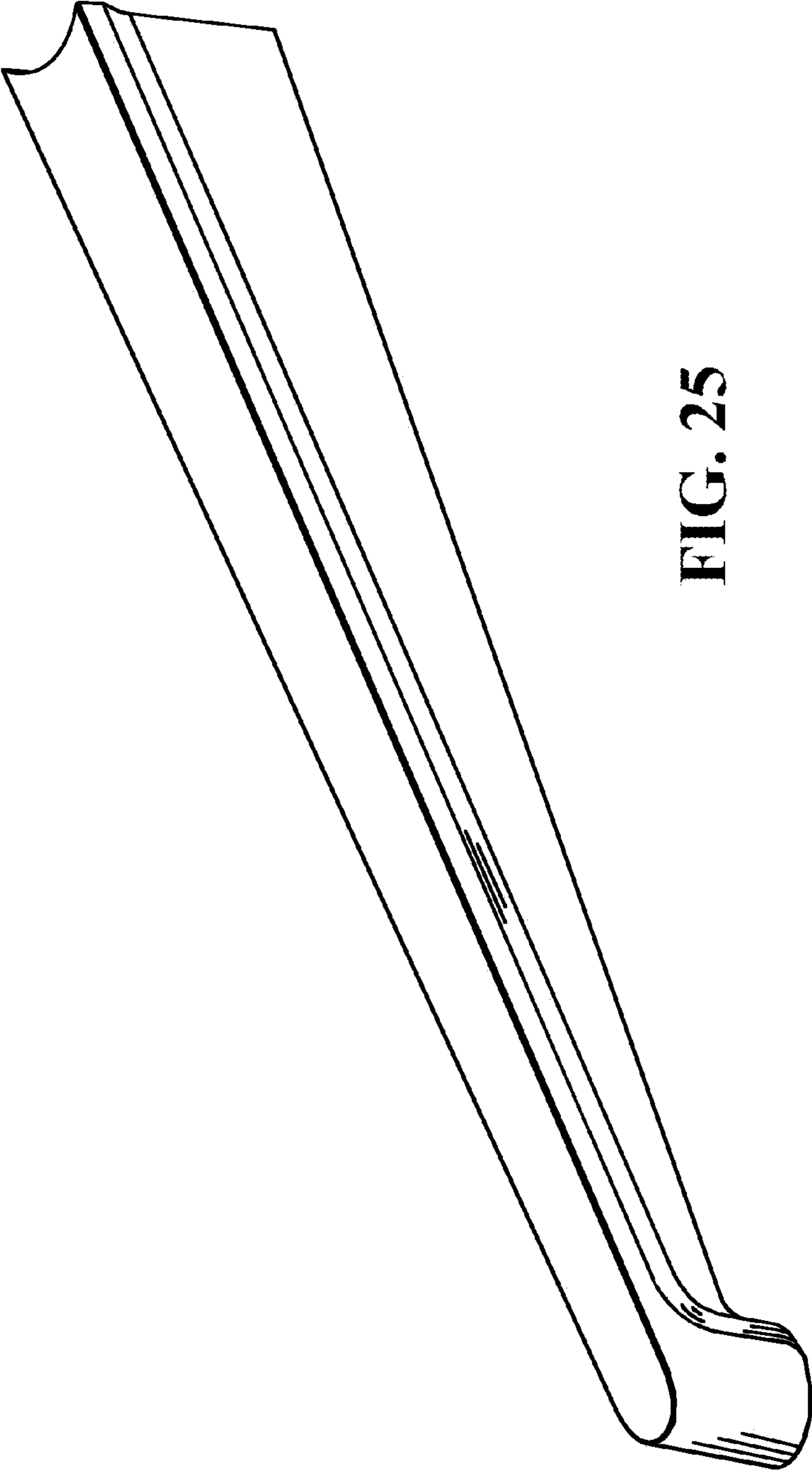

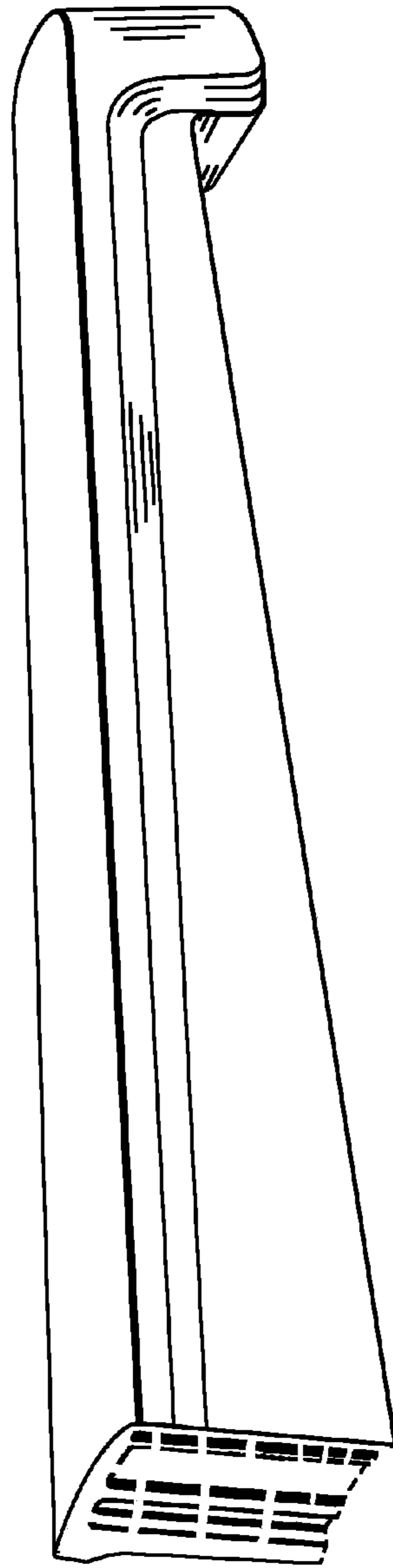

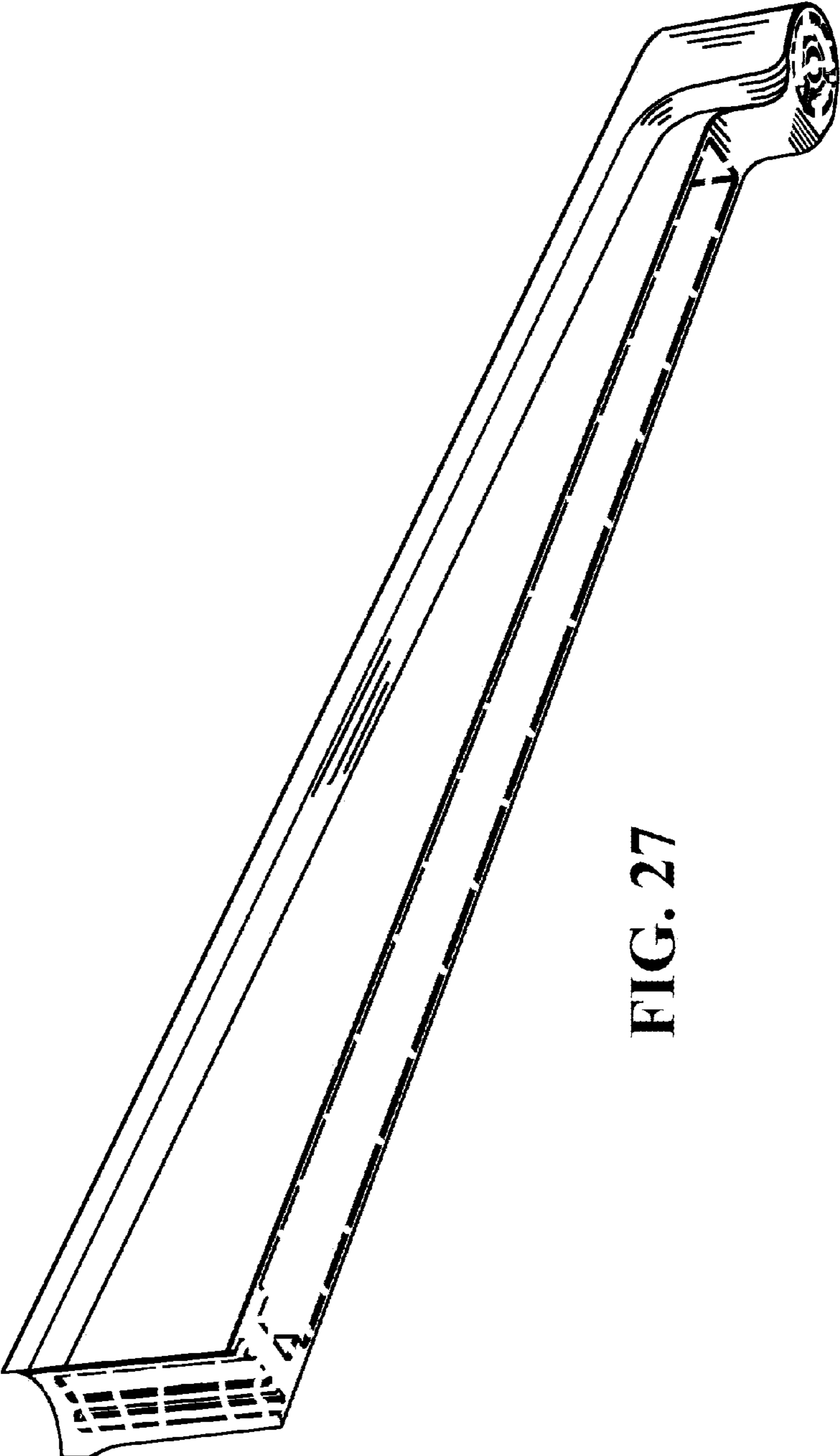

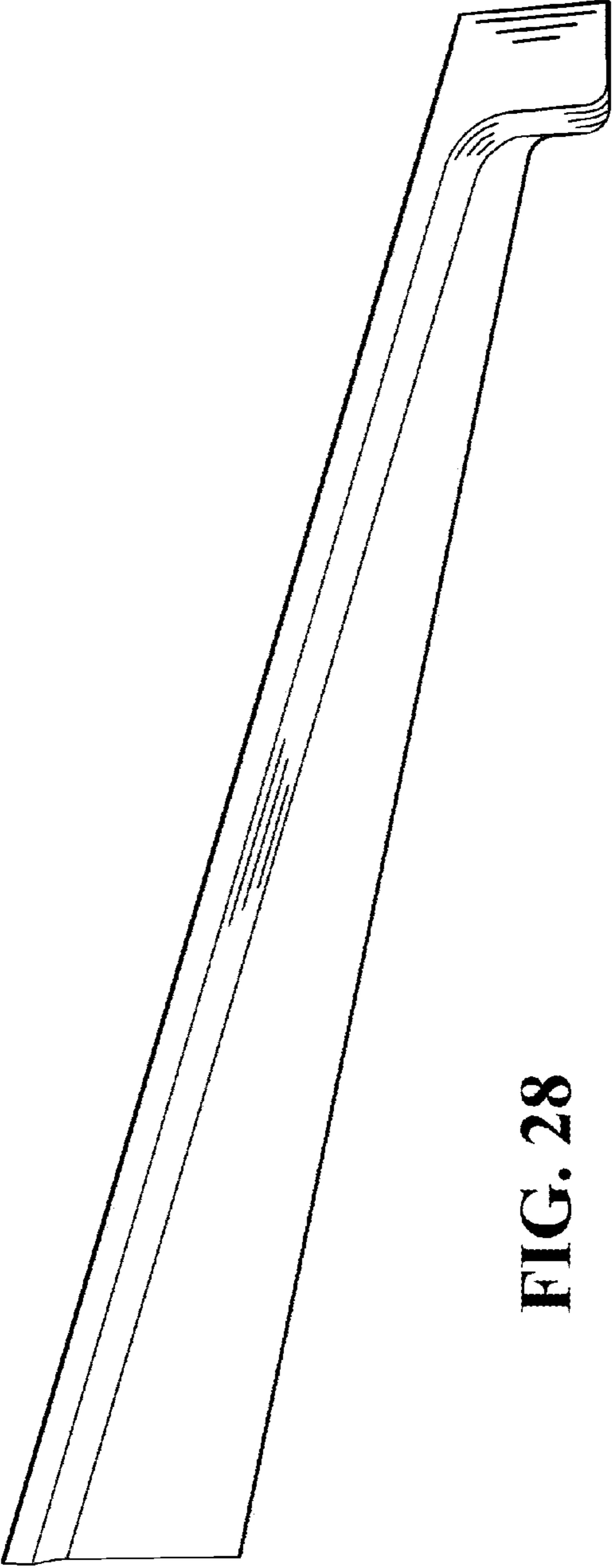

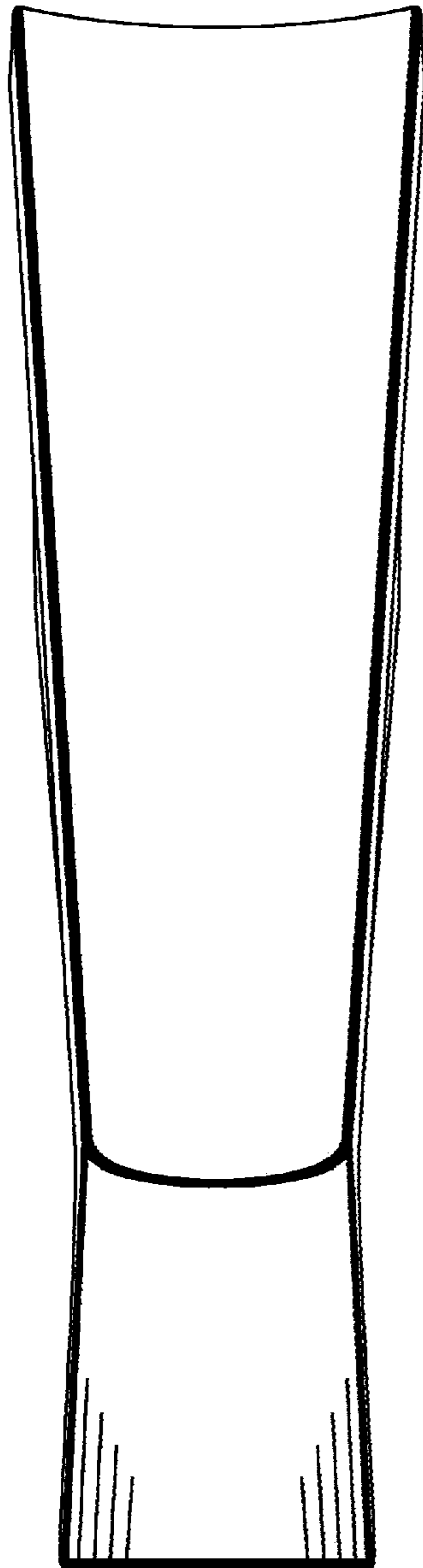

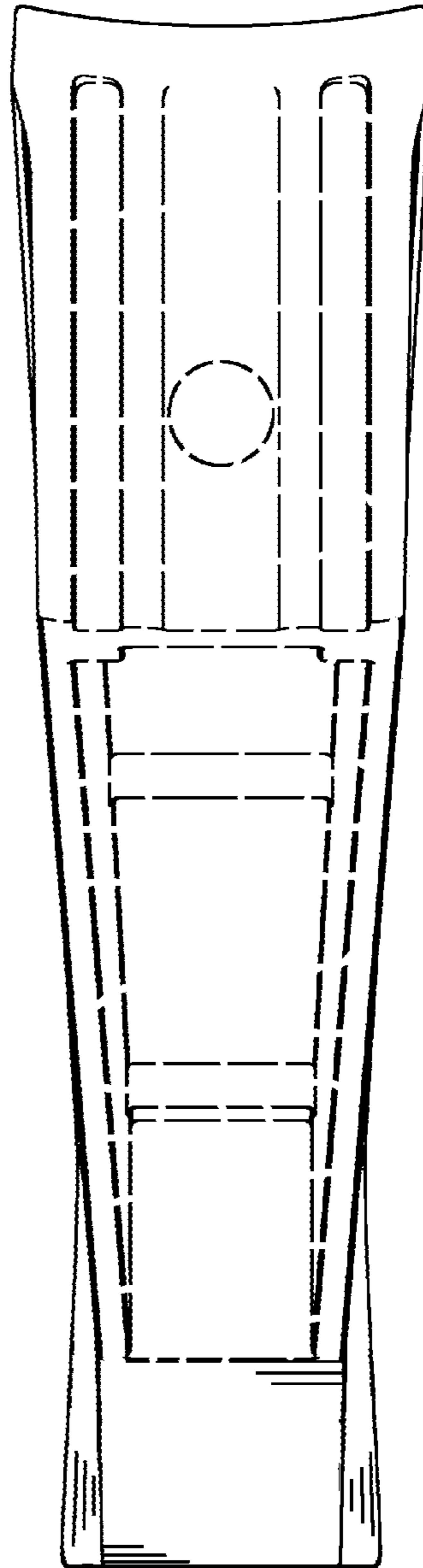

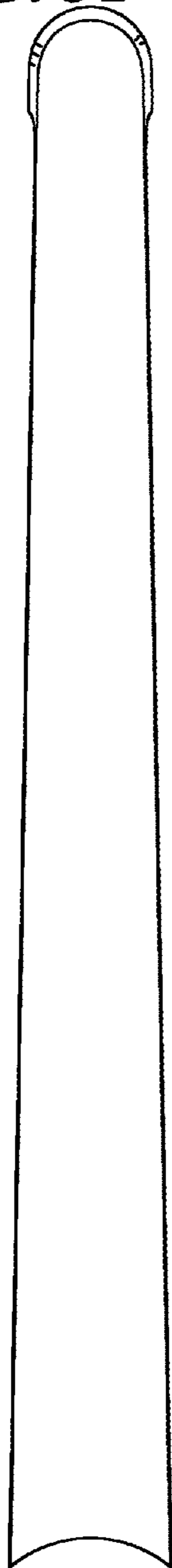
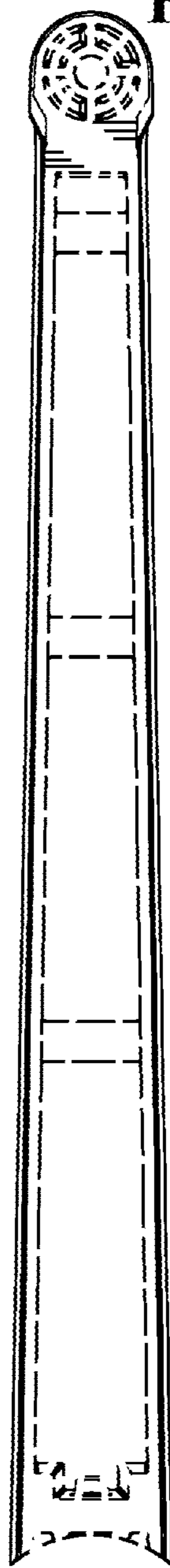

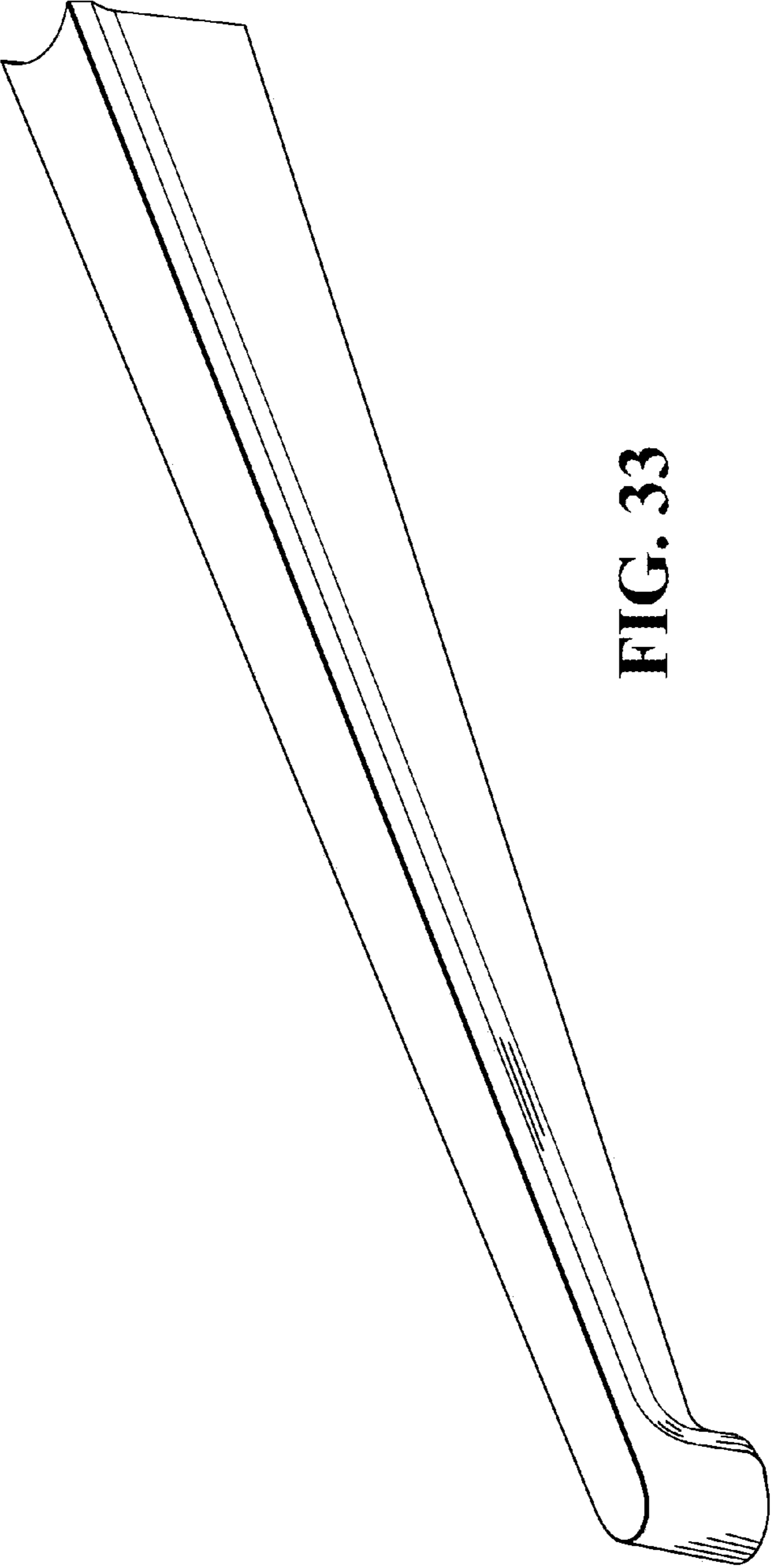

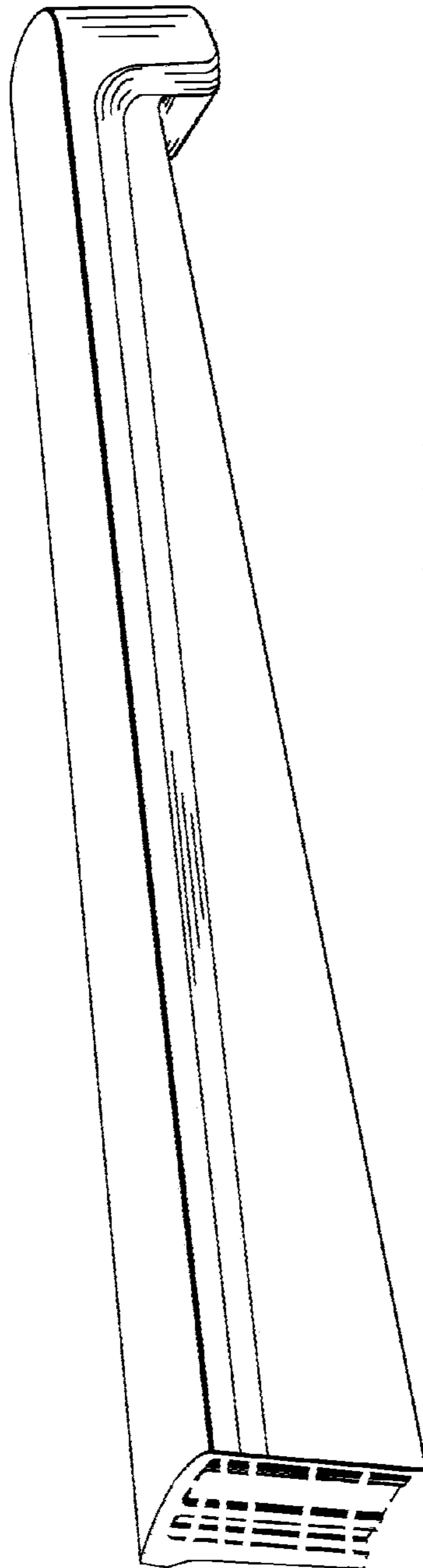

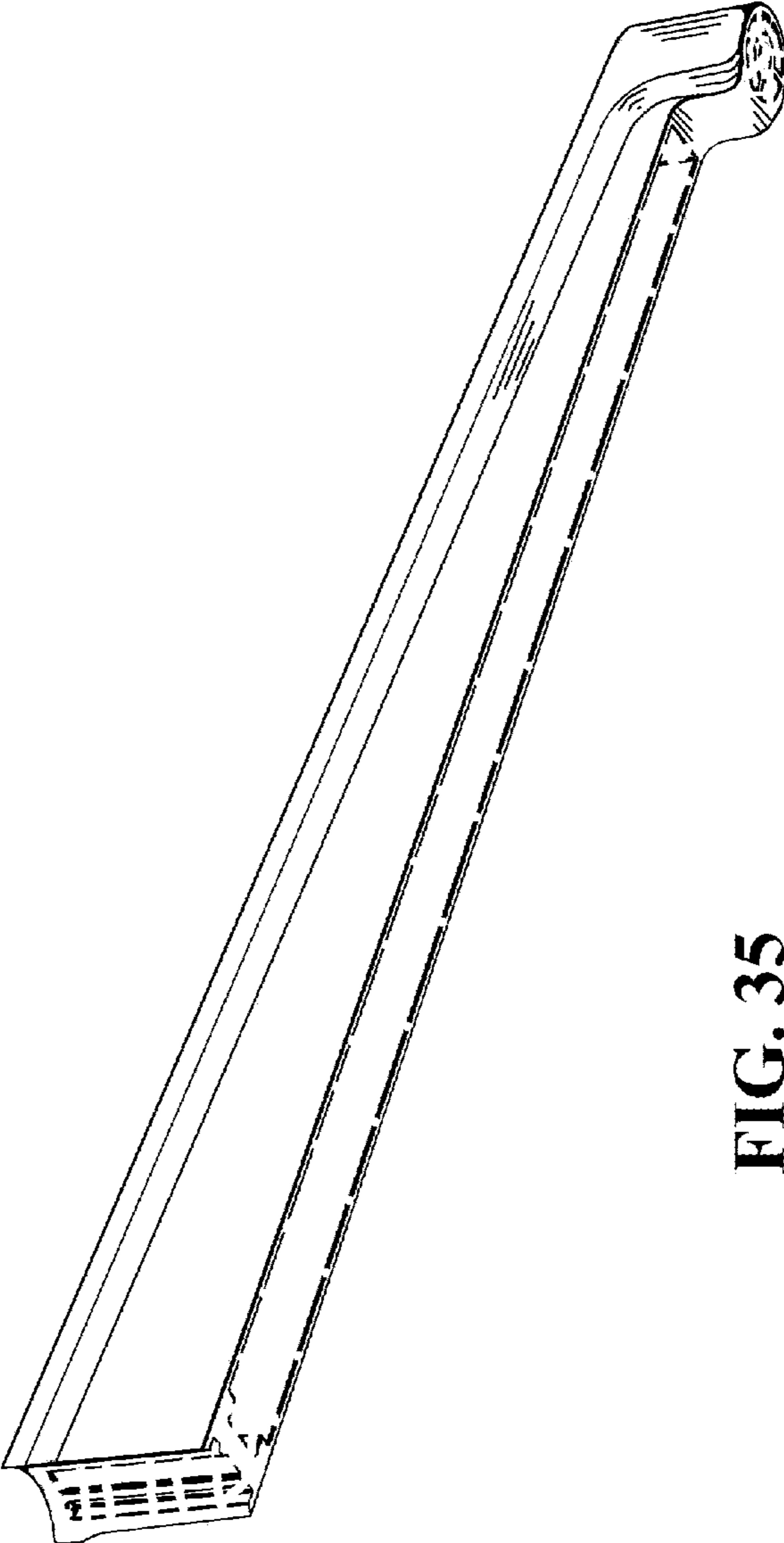

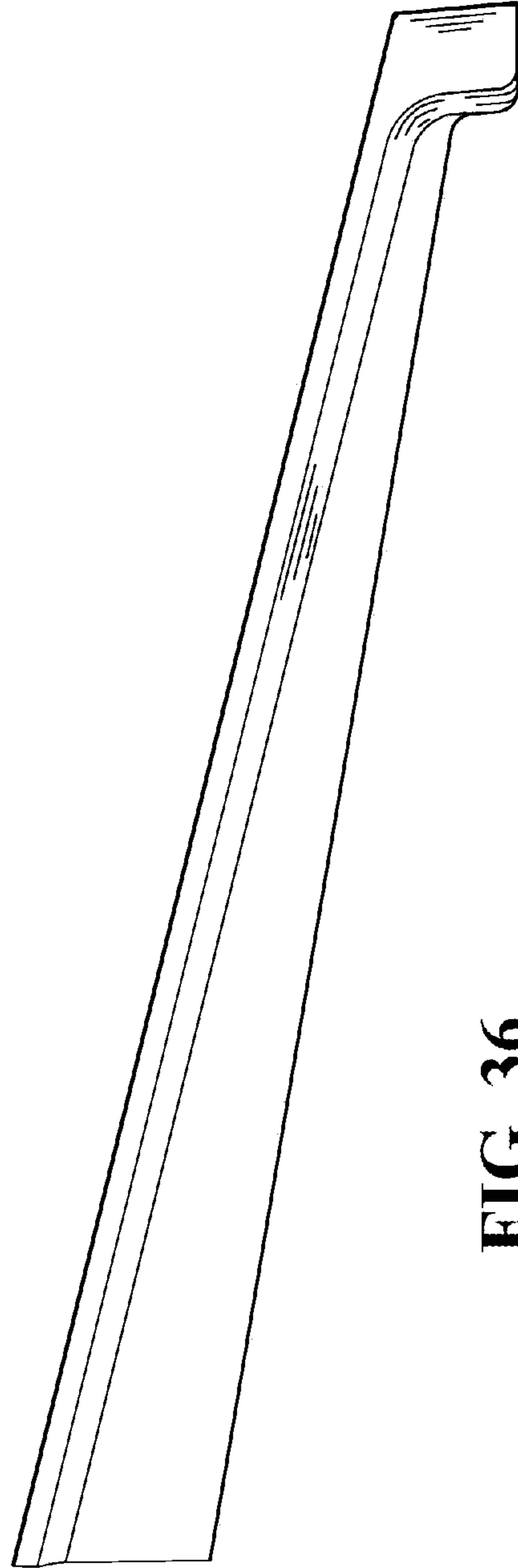

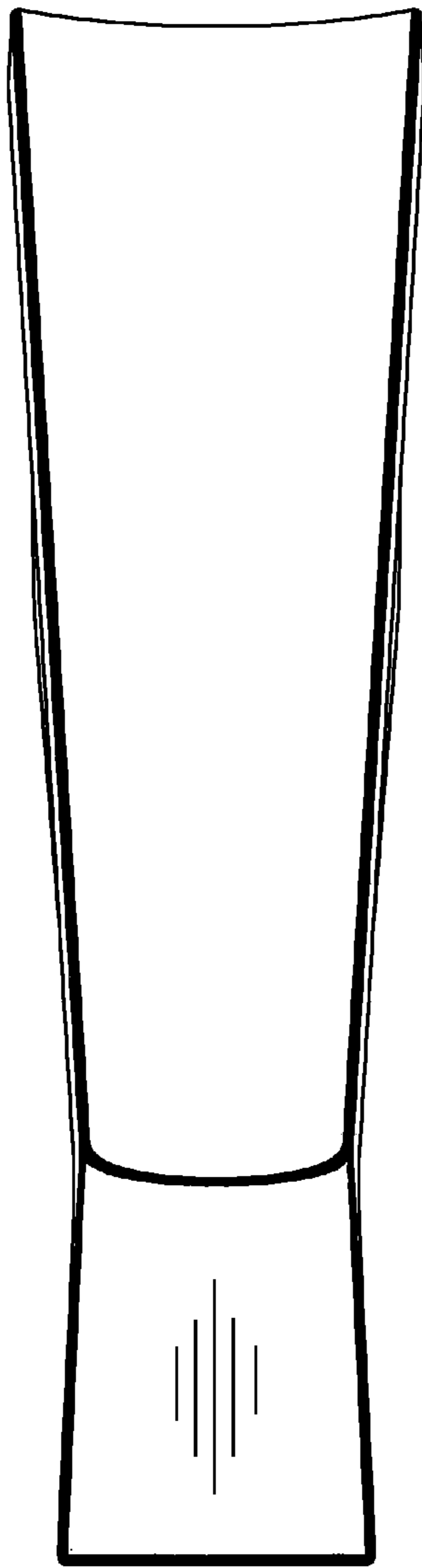

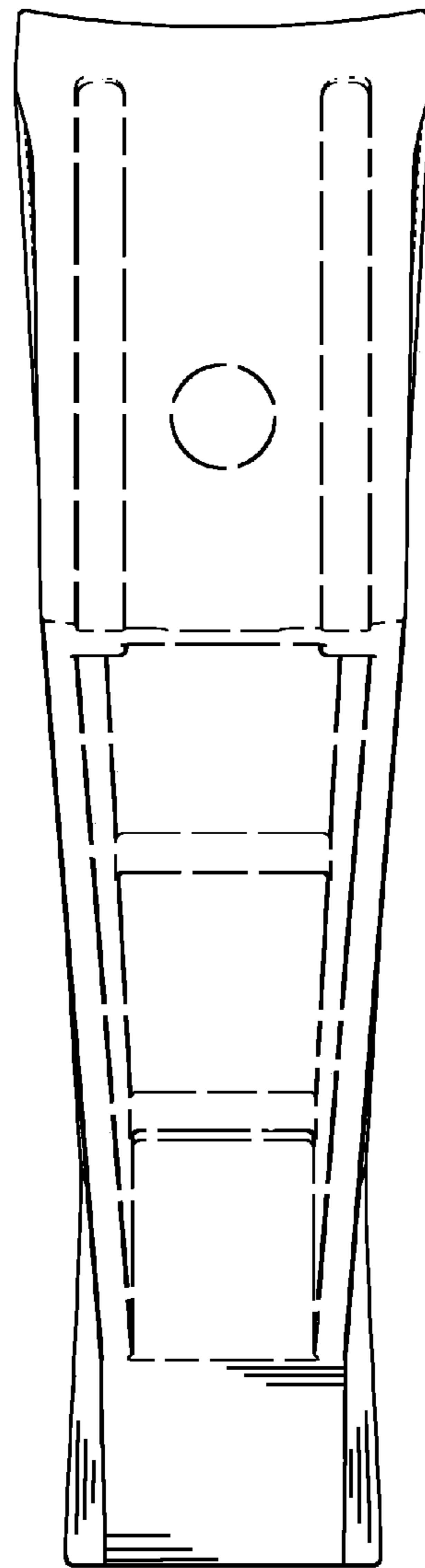

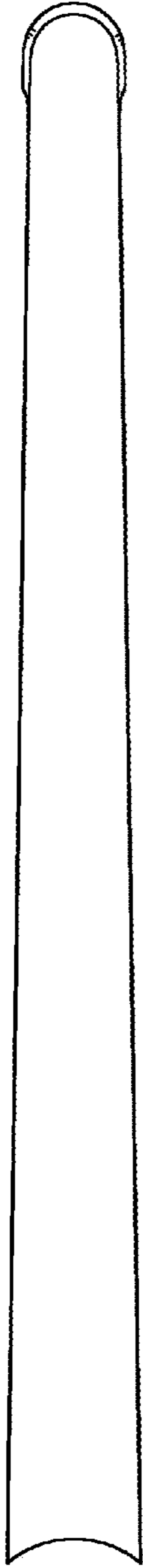
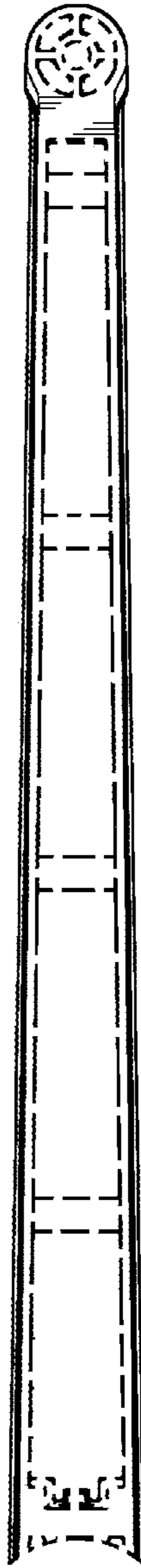

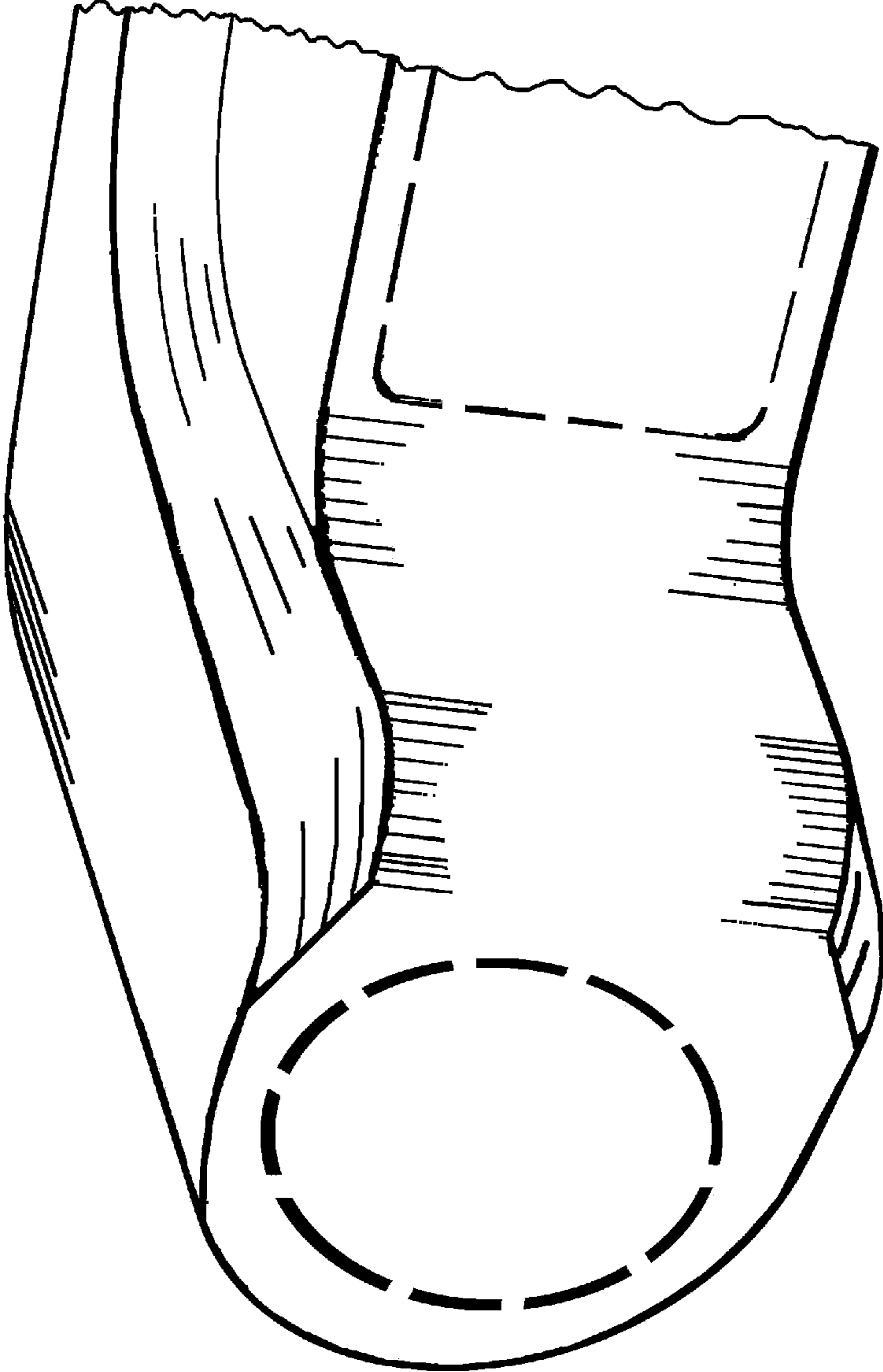
