DESCRIPTION

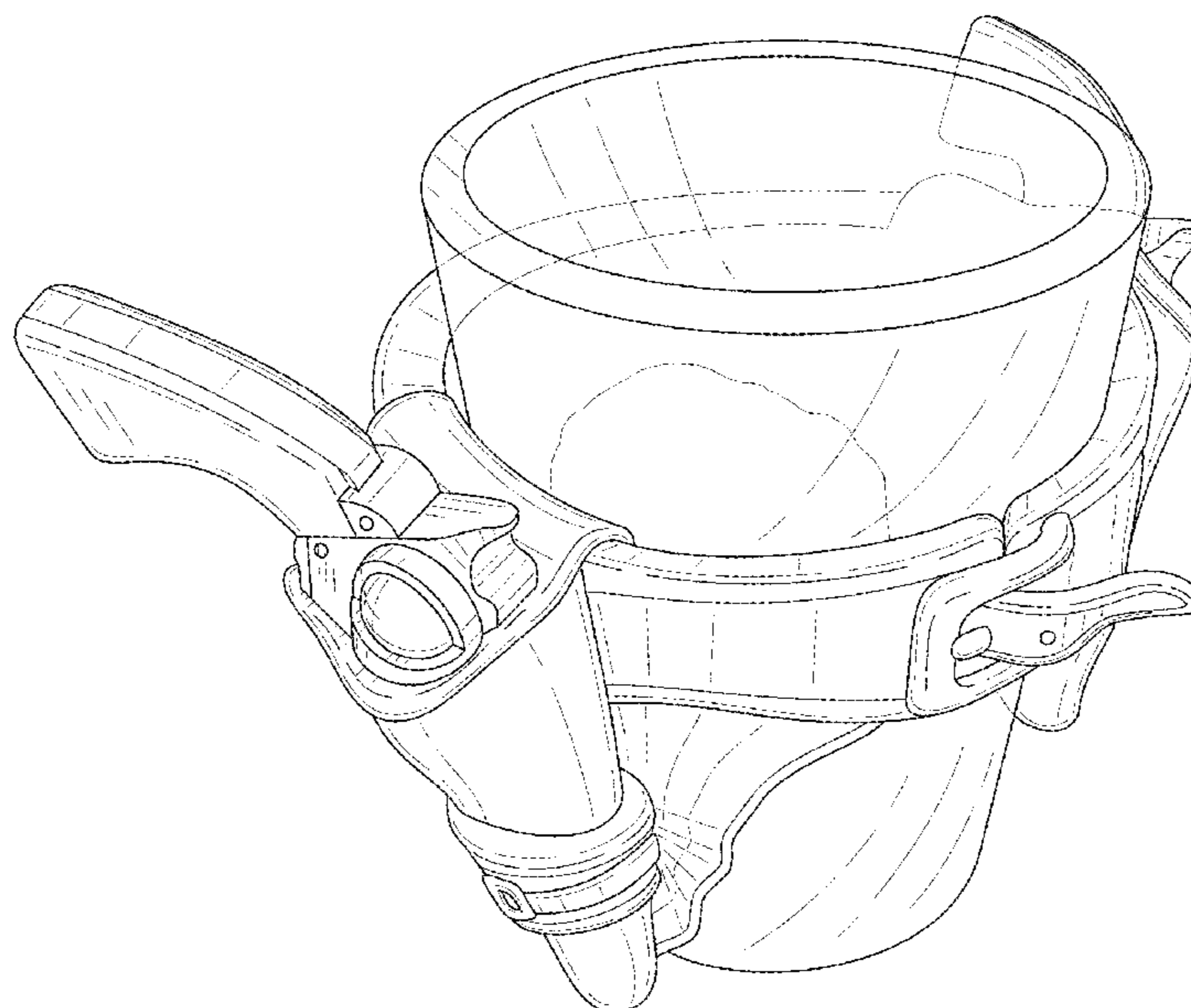
FIG. 1 is a front perspective view of a holster shot glass showing a top, front, and left side thereof;

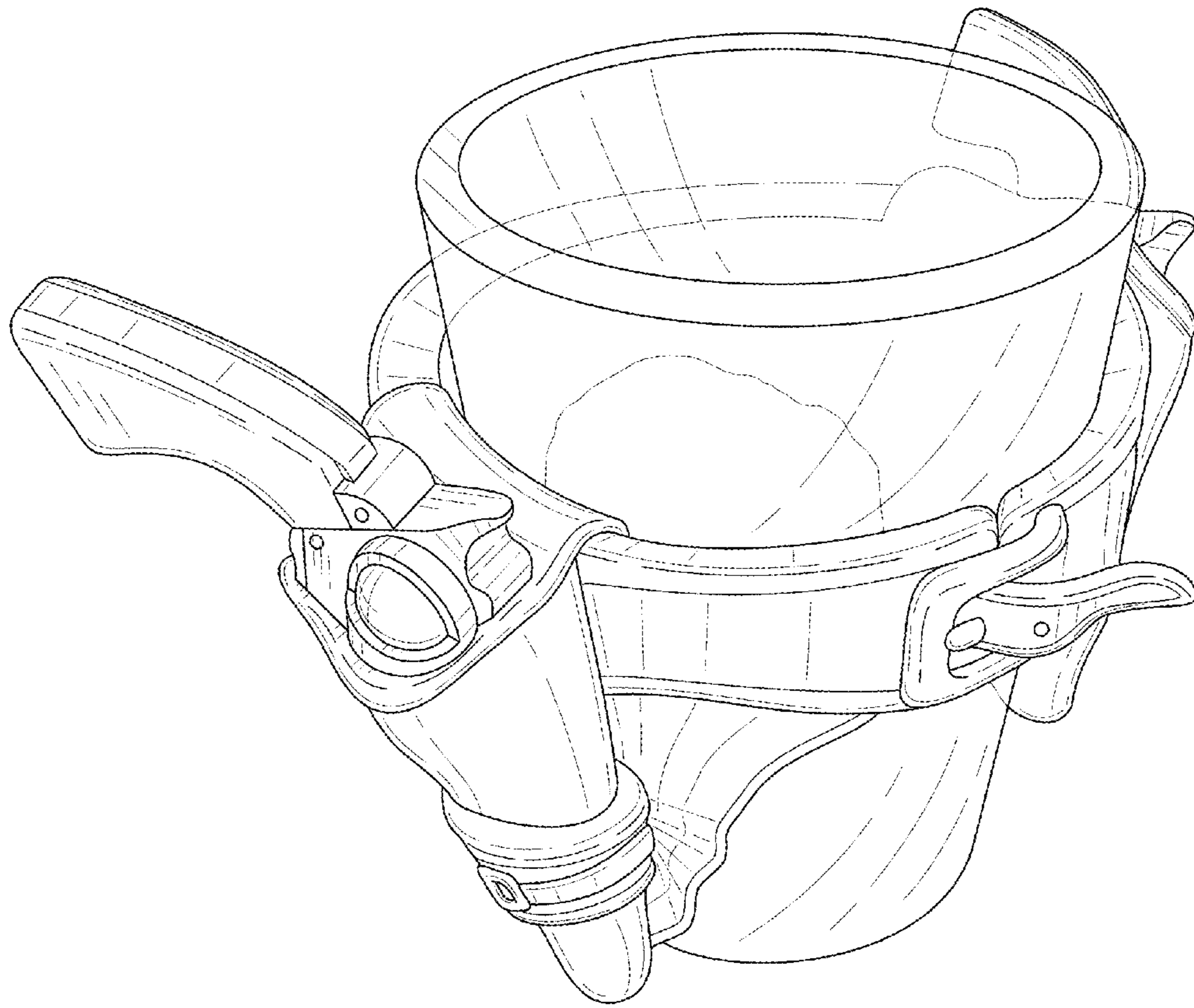

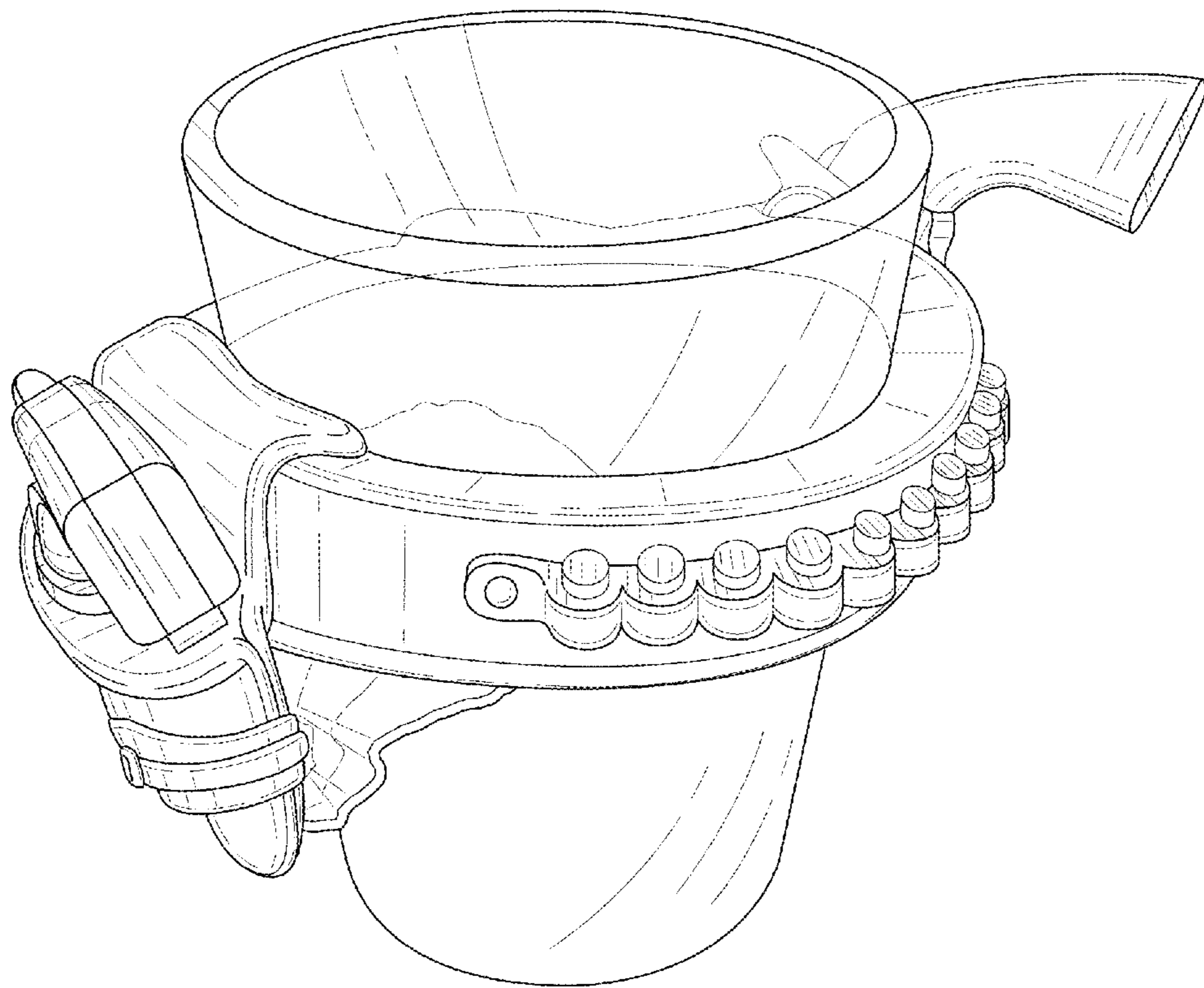

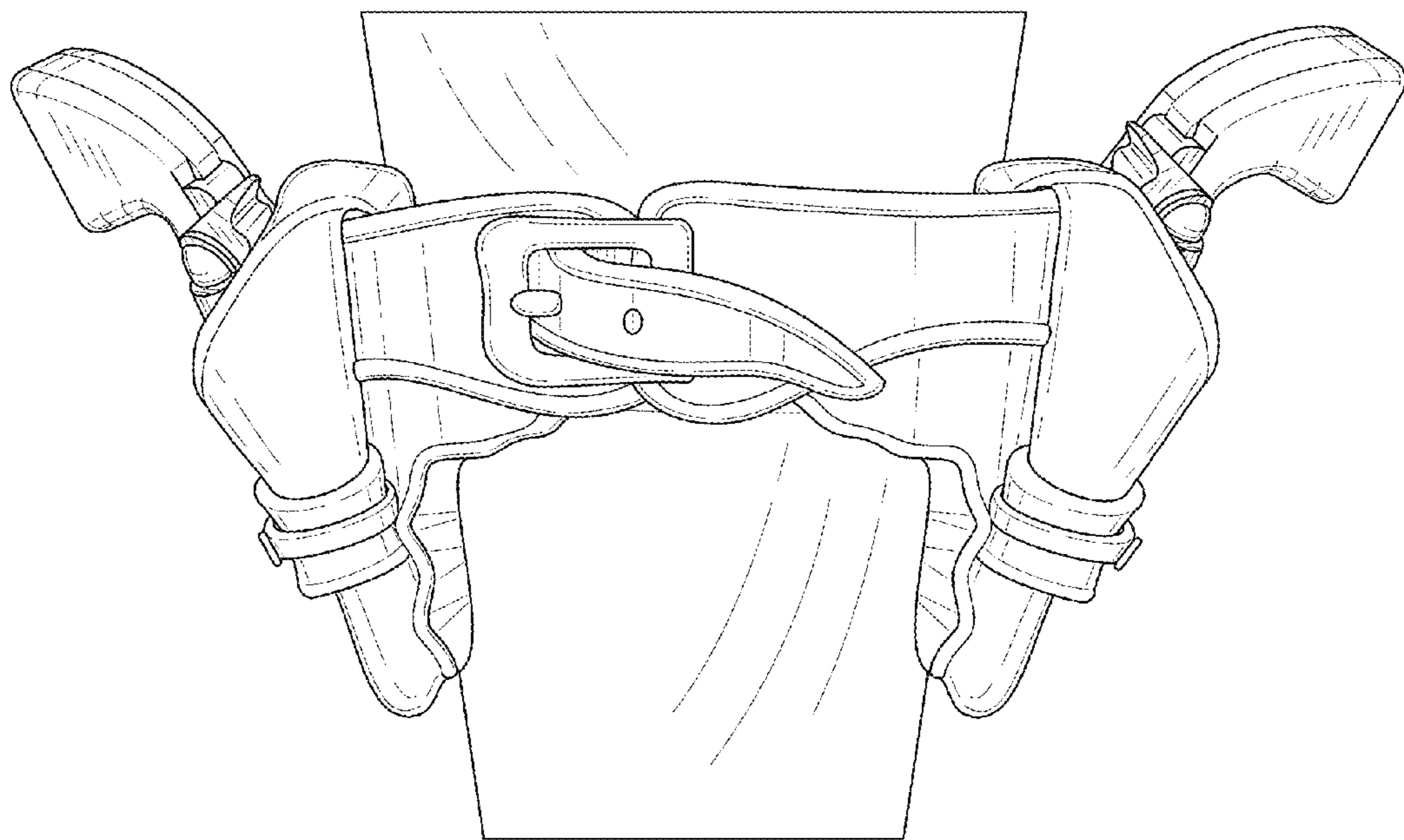

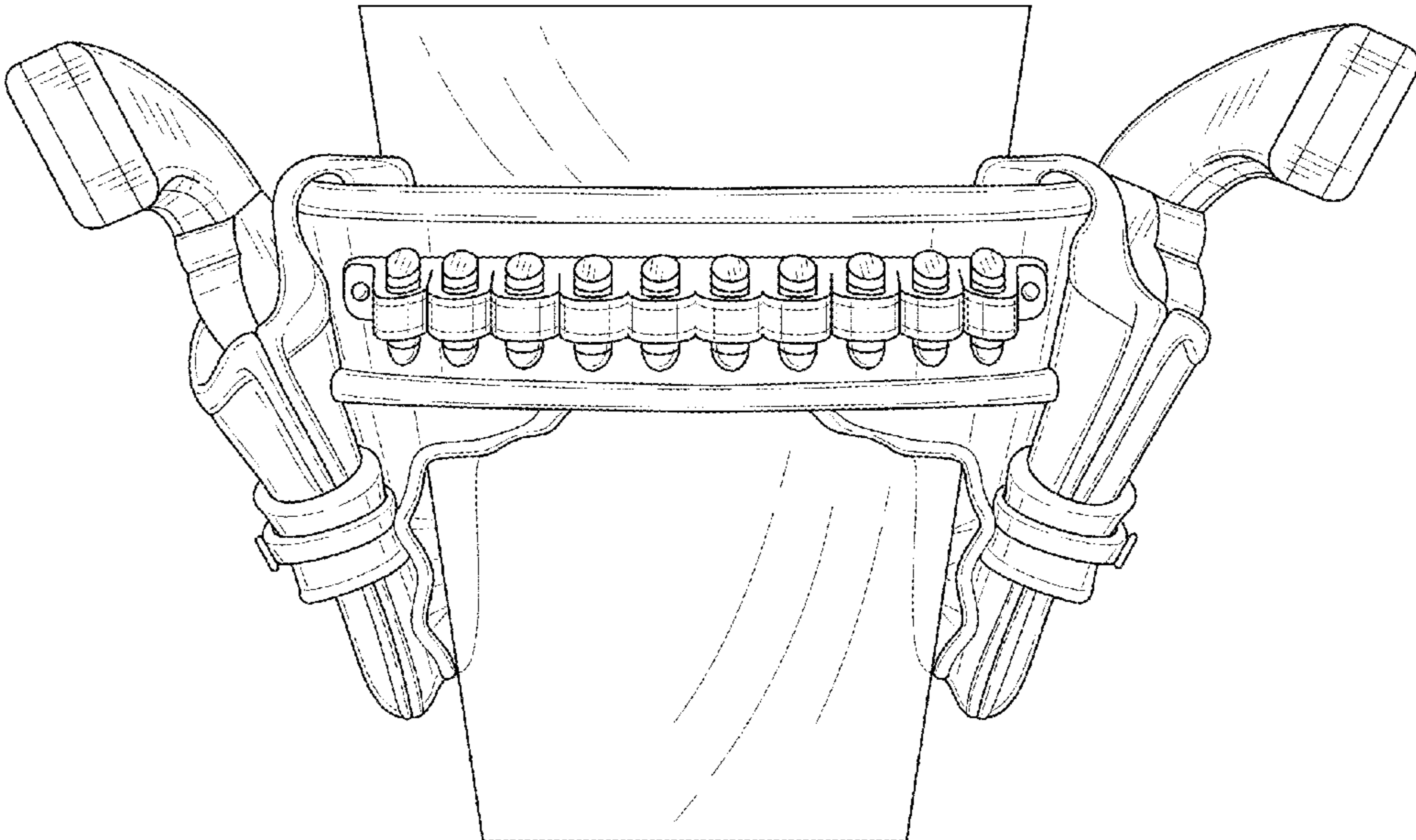

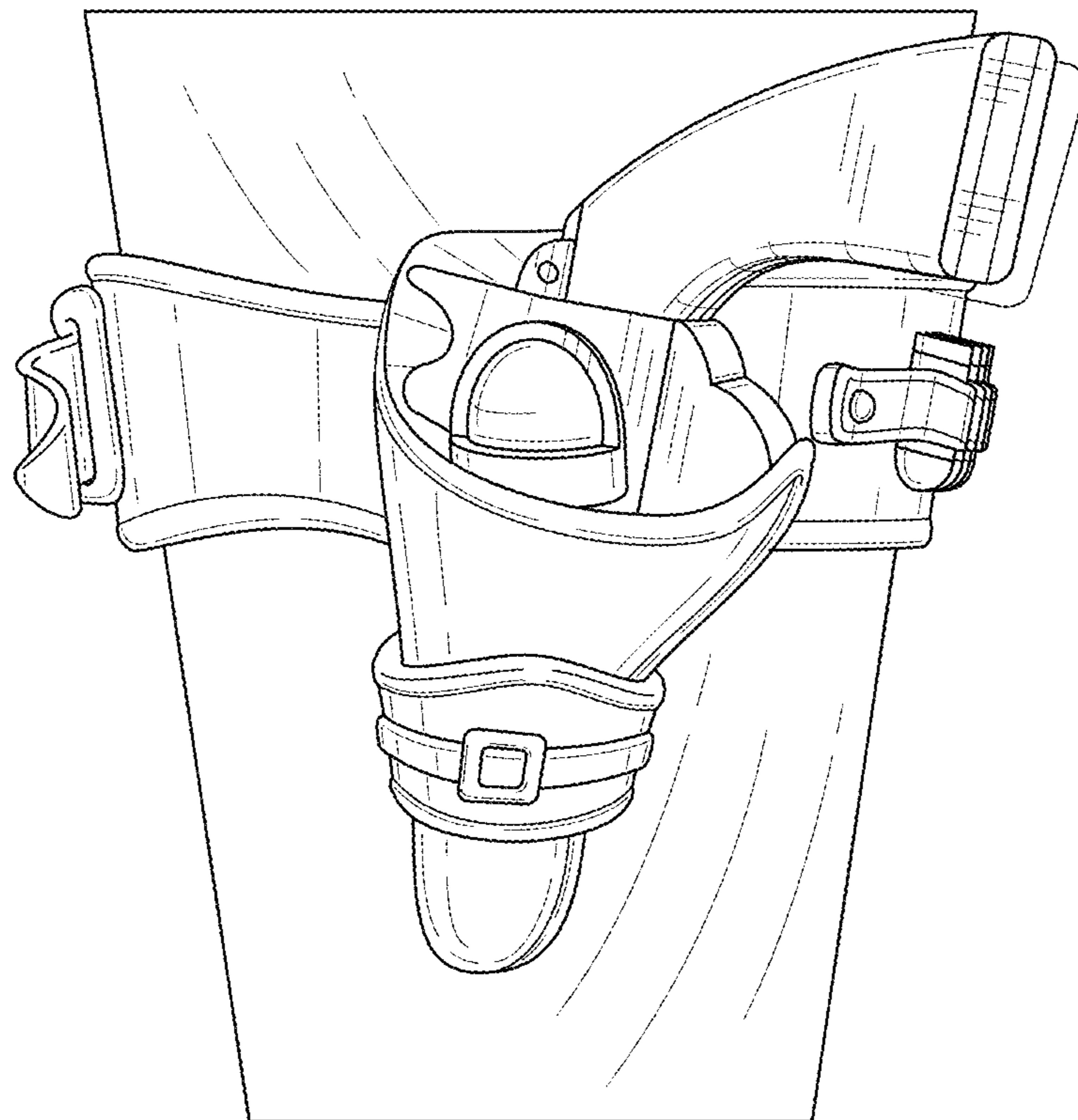

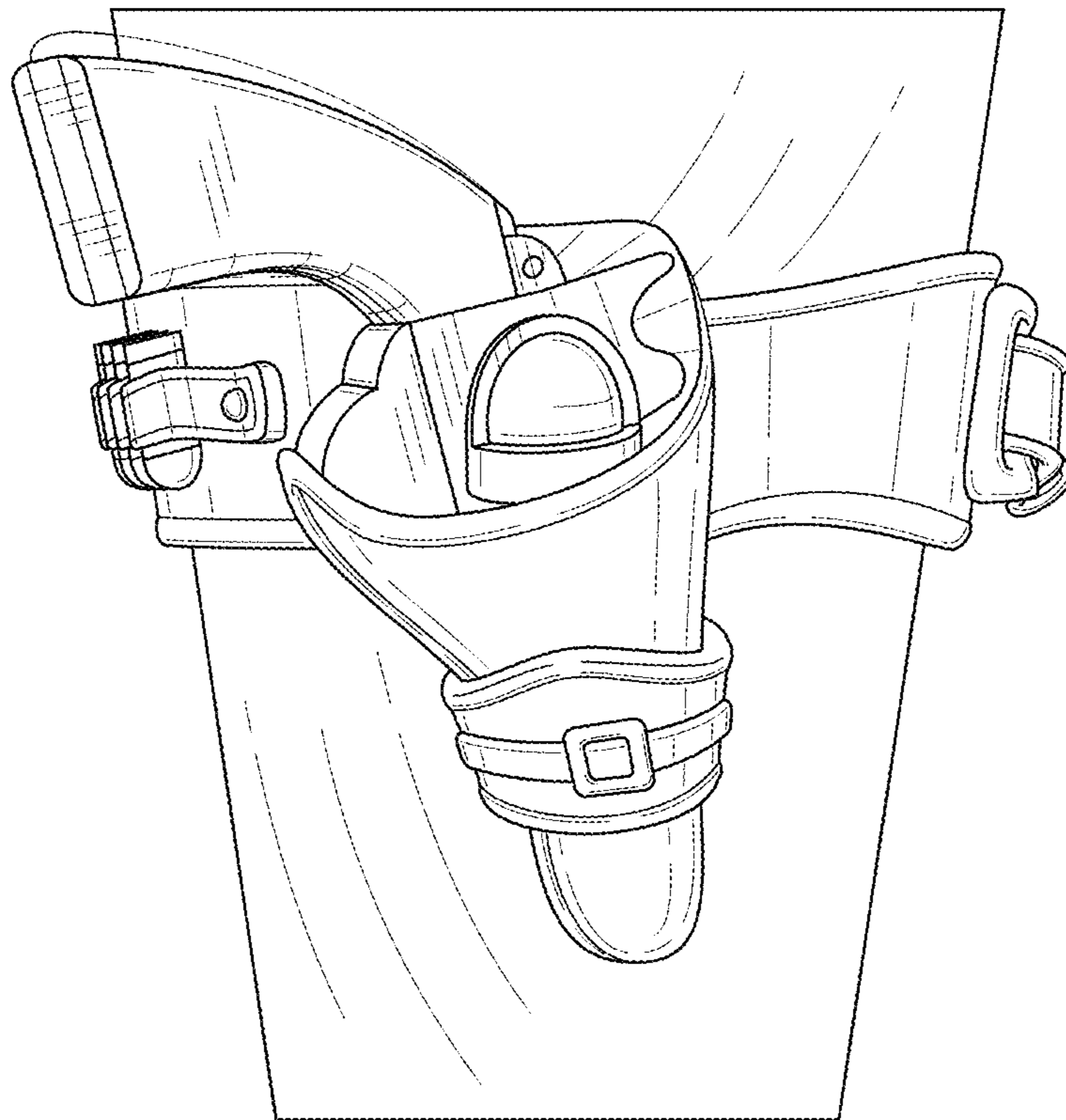

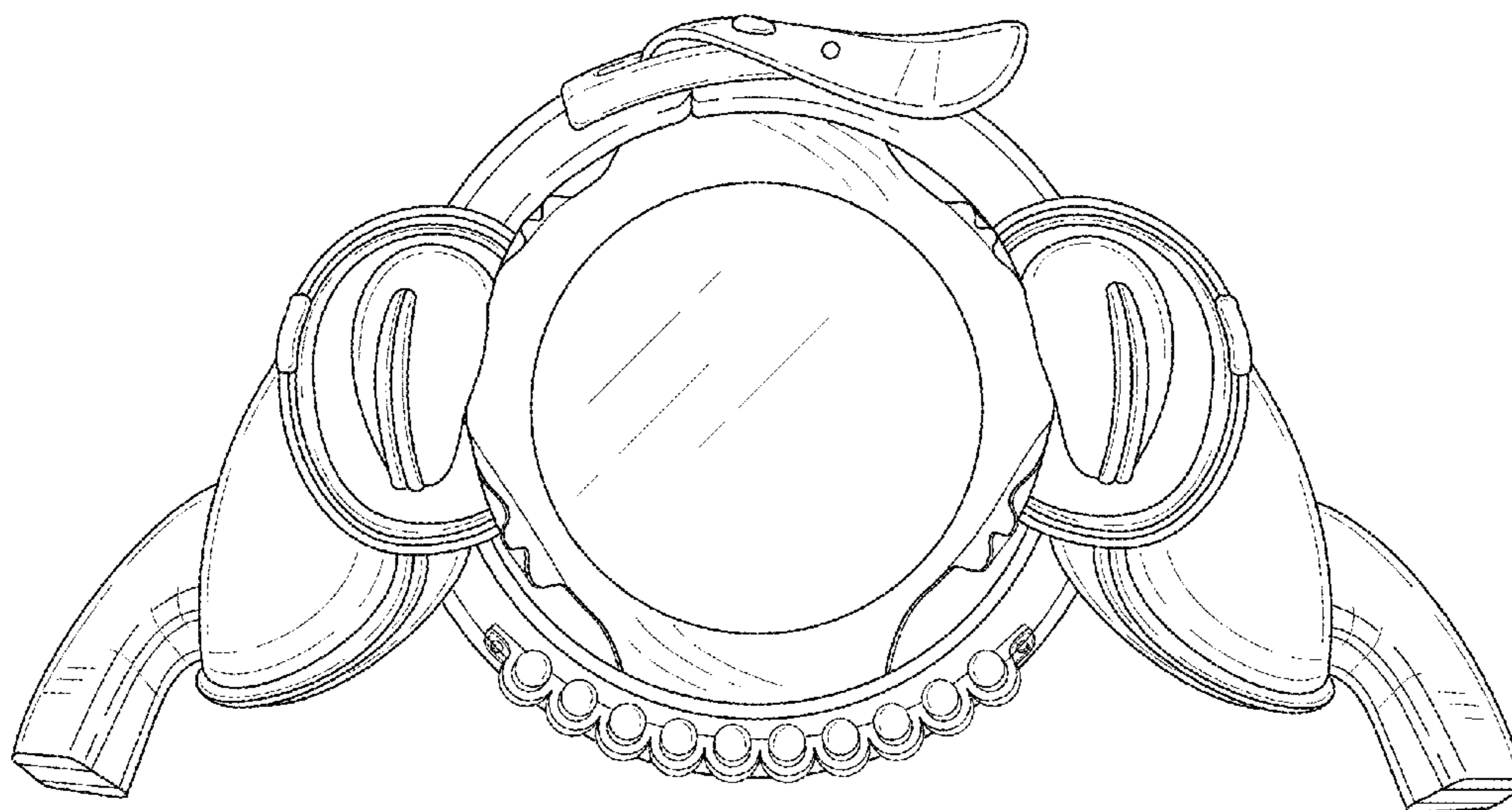

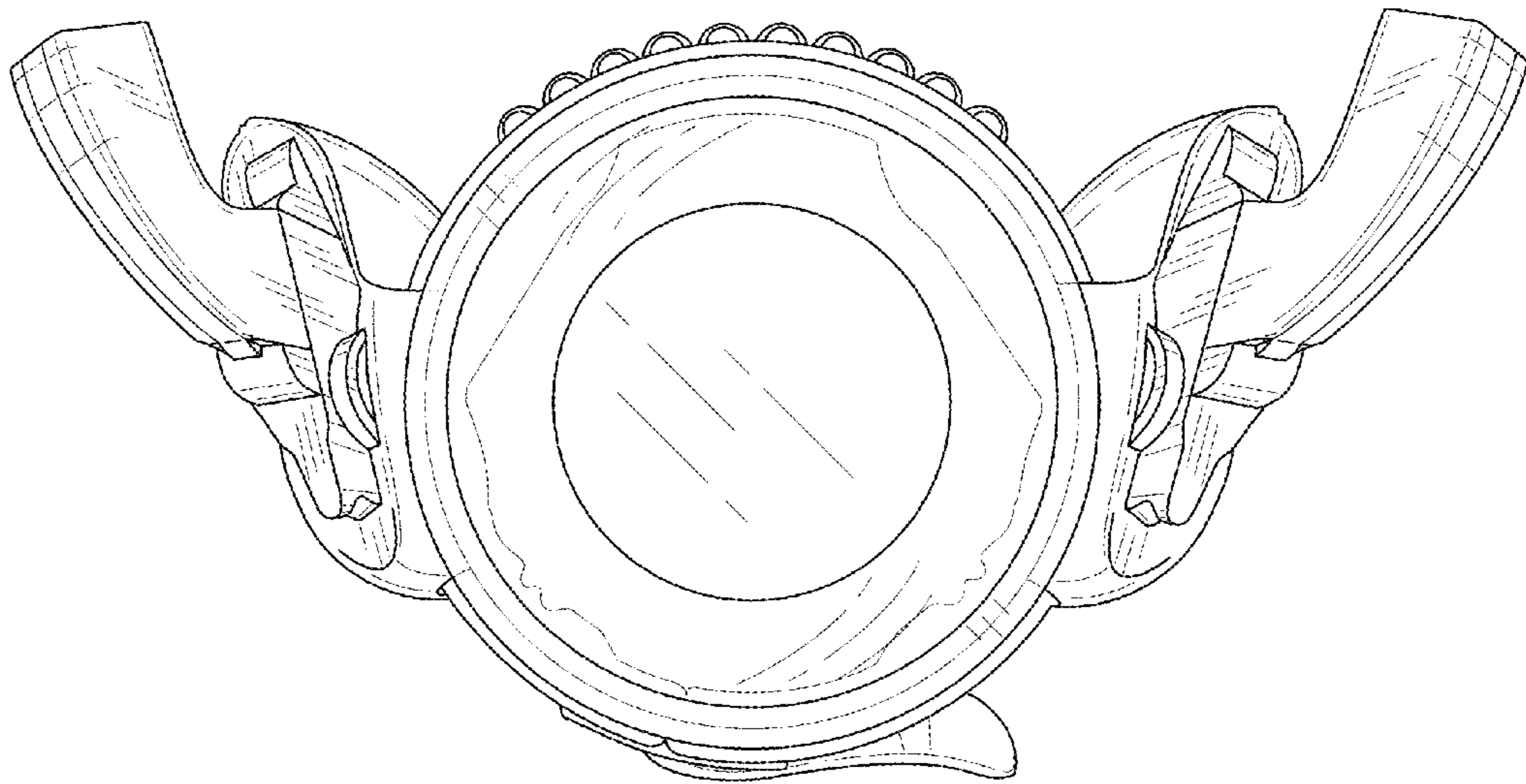
