FIG. 4 is a rear elevational view thereof;

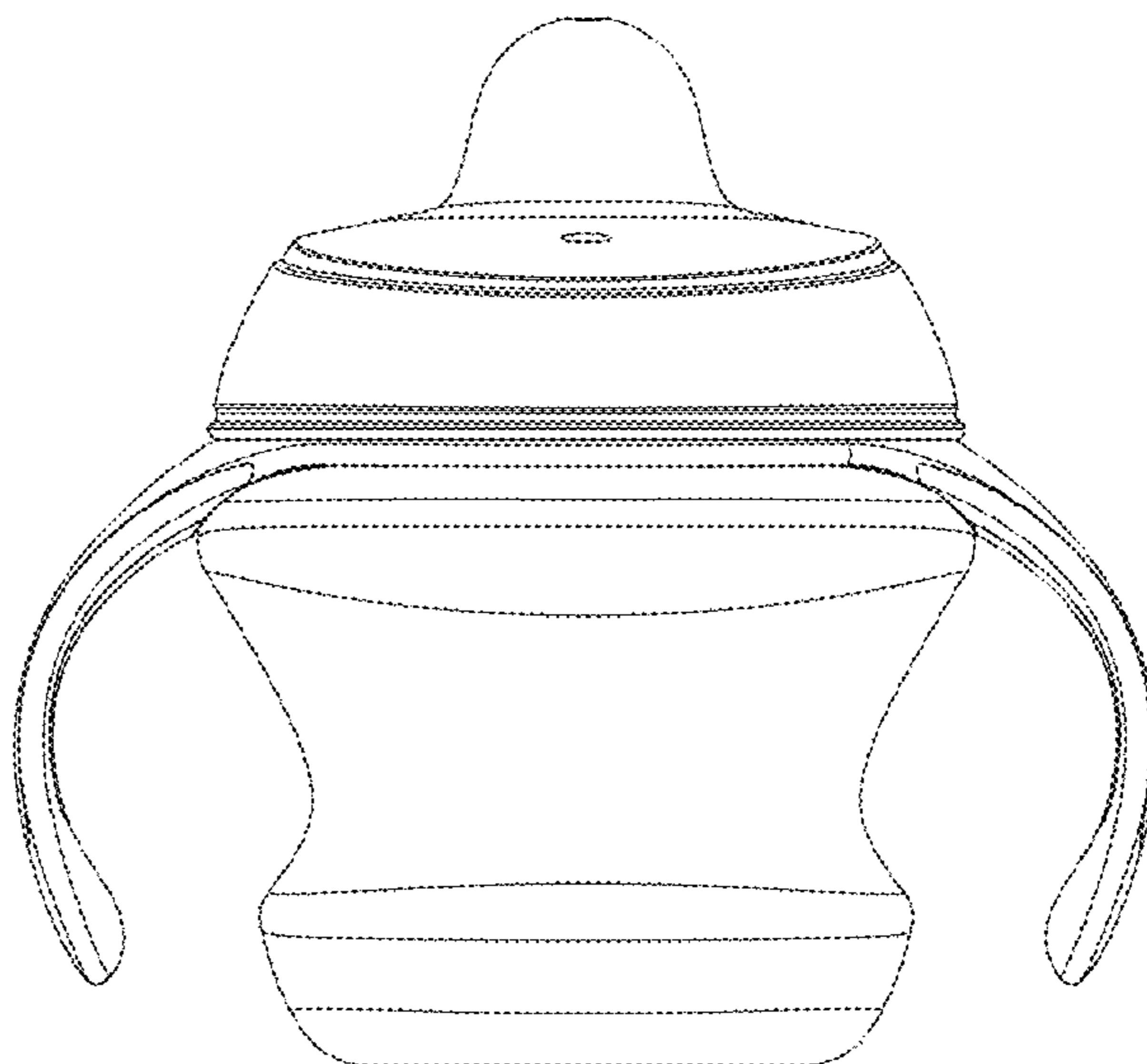
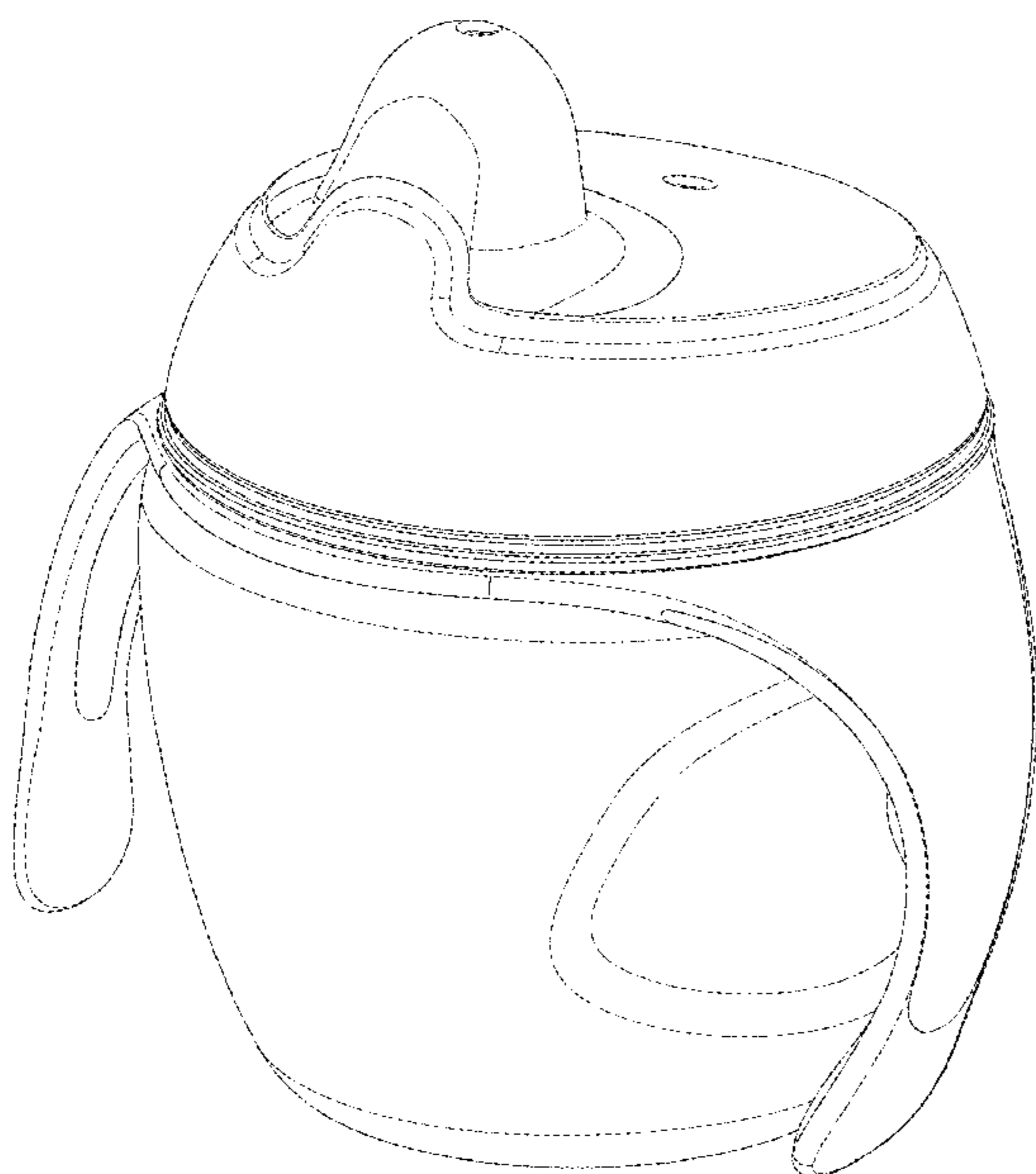
FIG. 5 is a right side elevational view thereof; the left side elevational view being a mirror image thereof;

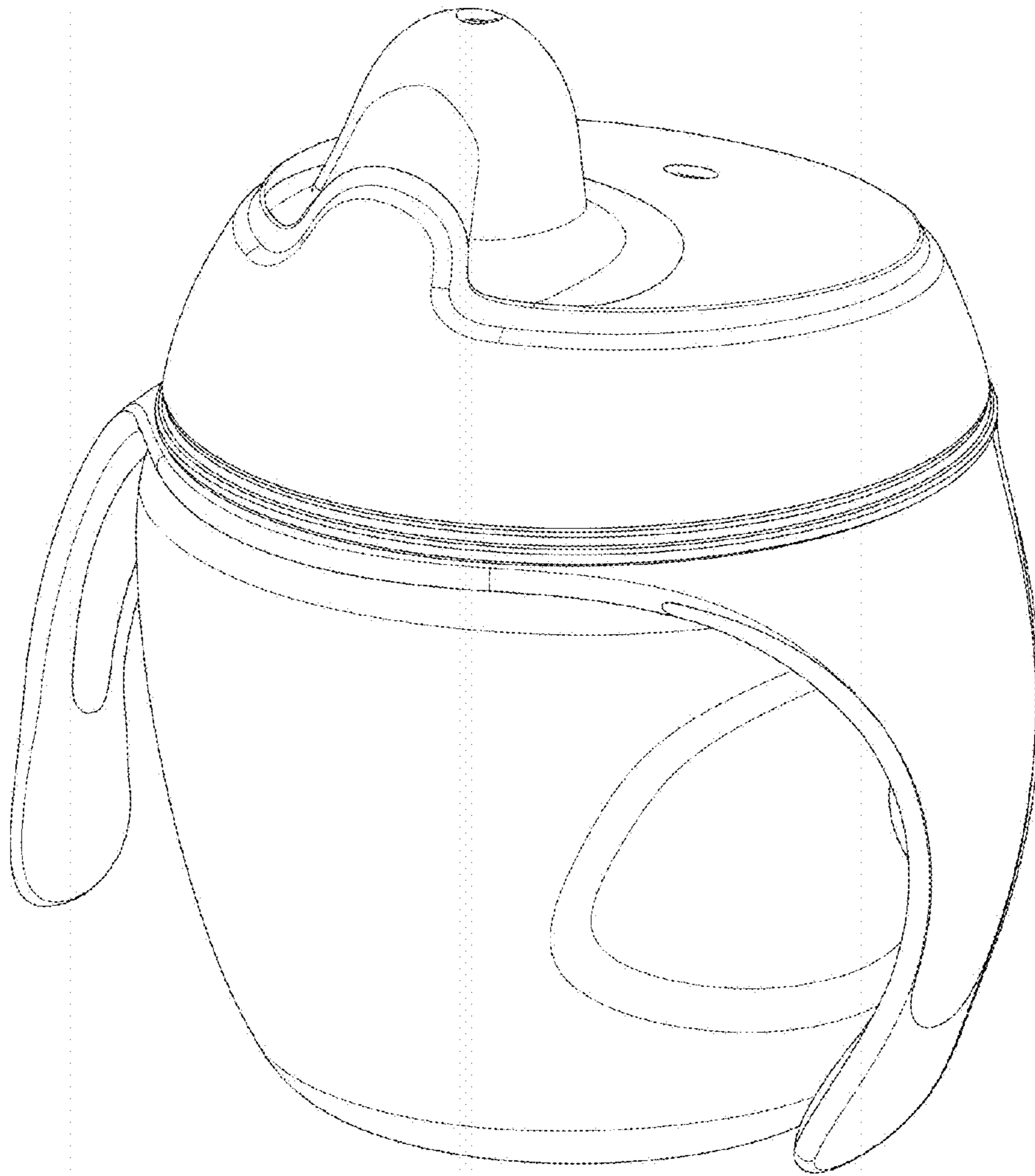

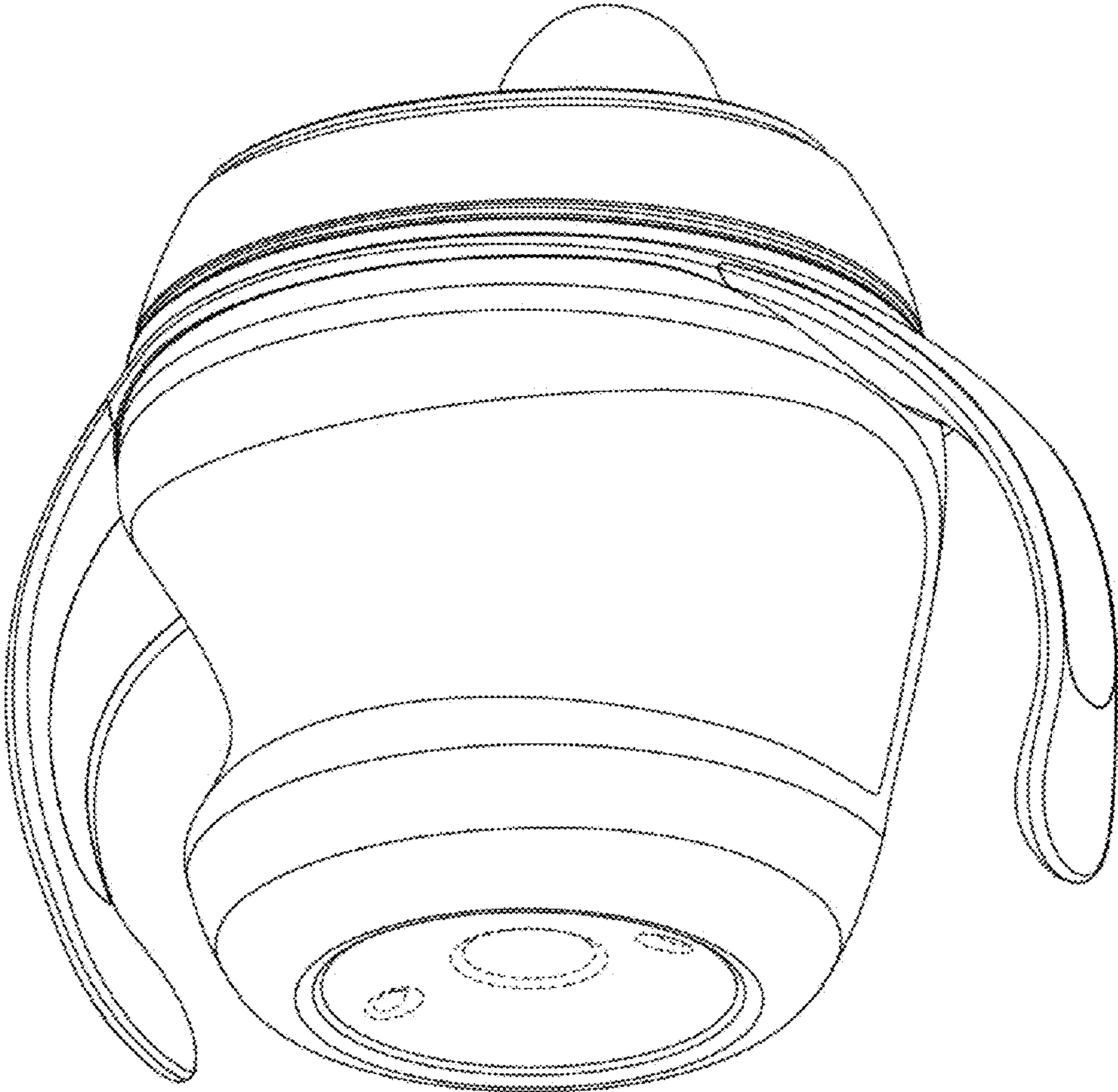

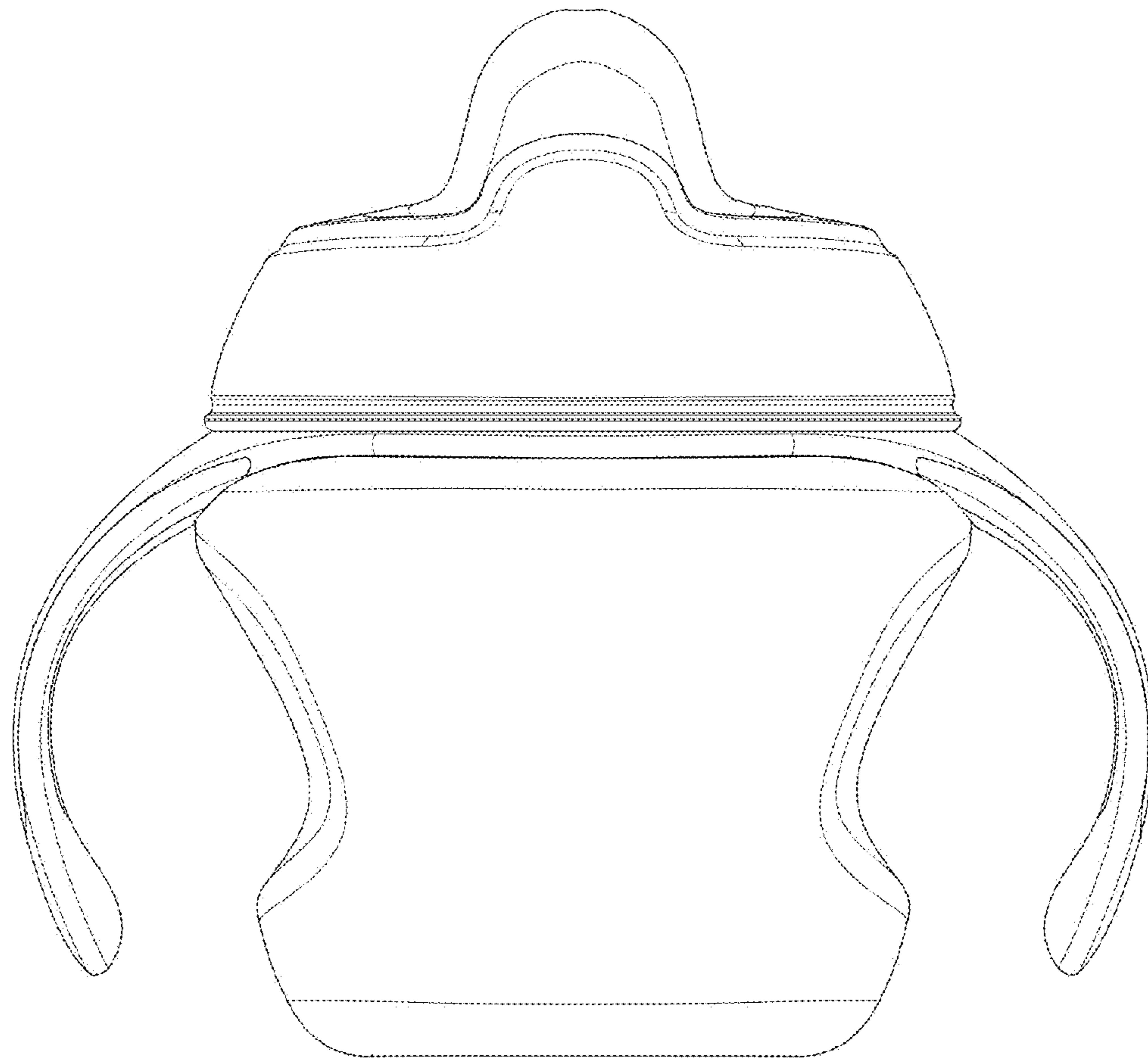

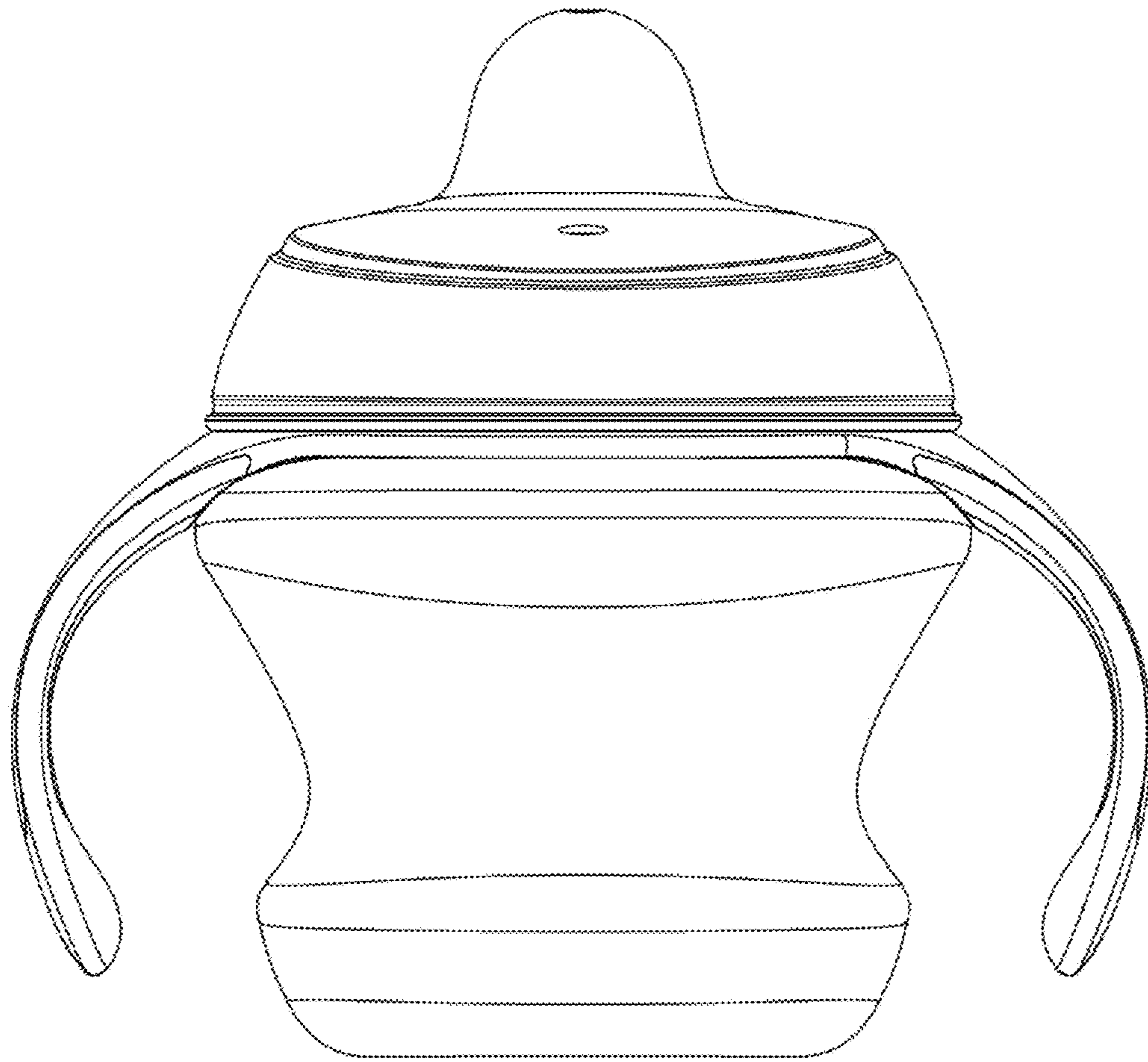

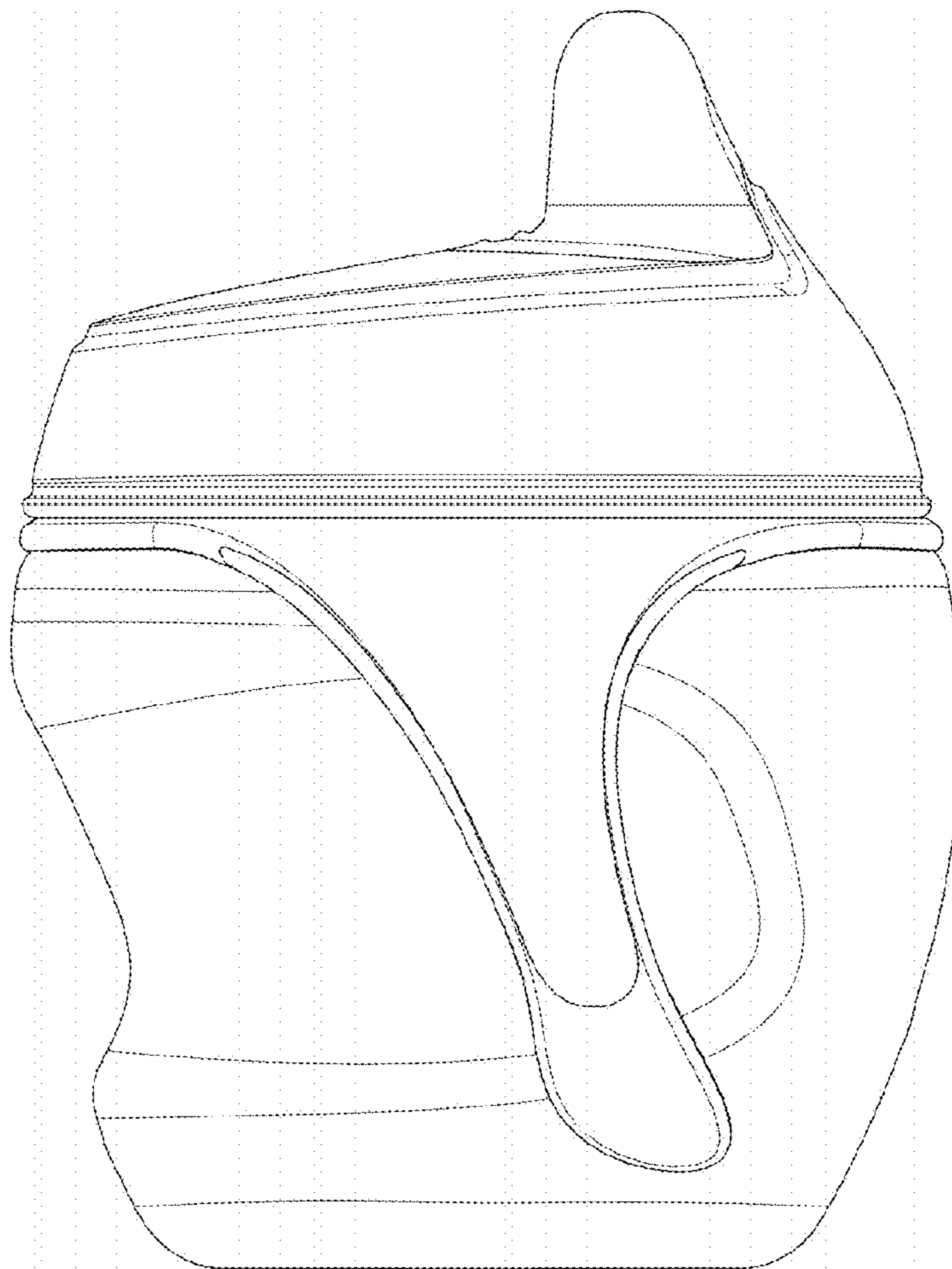

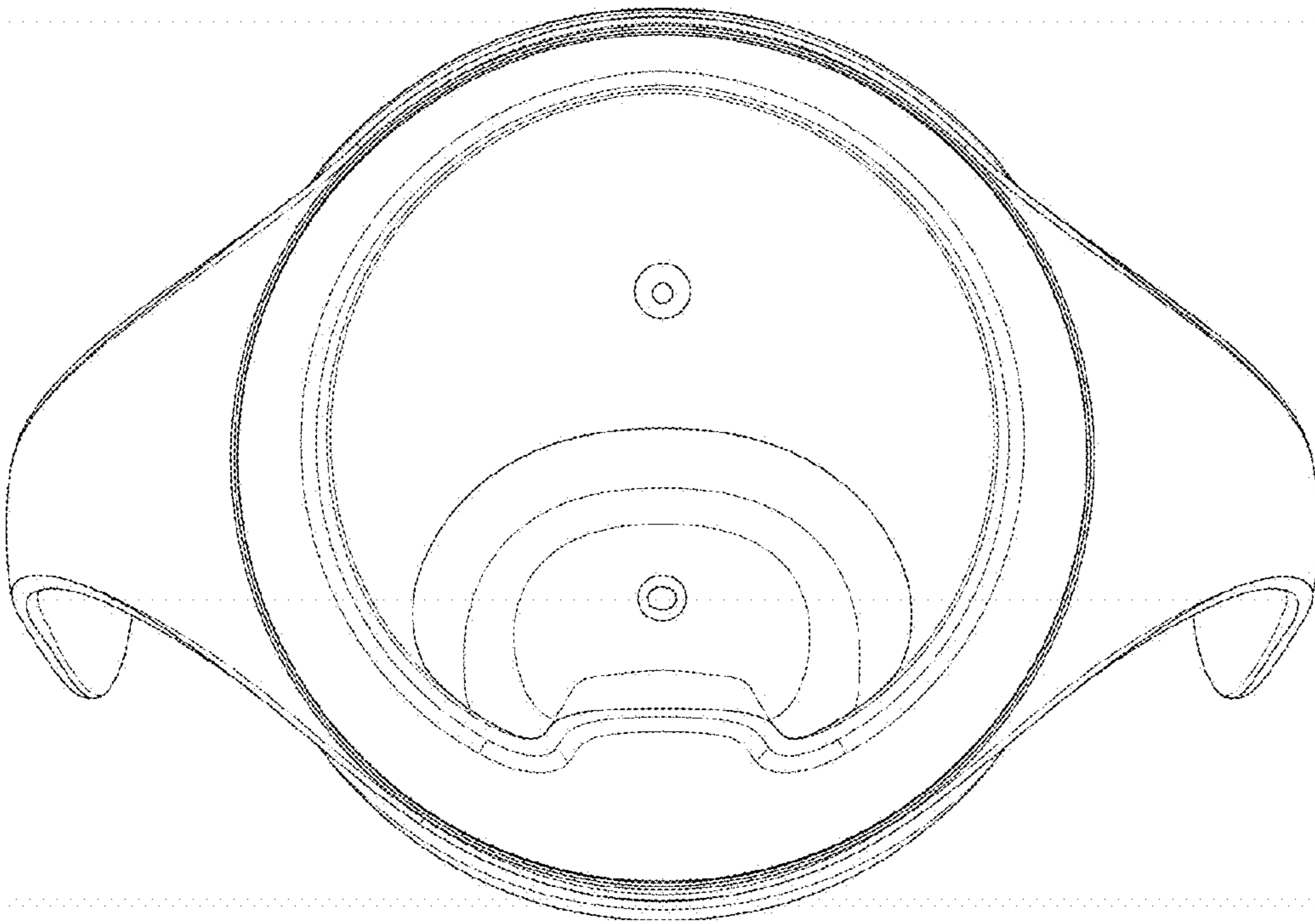

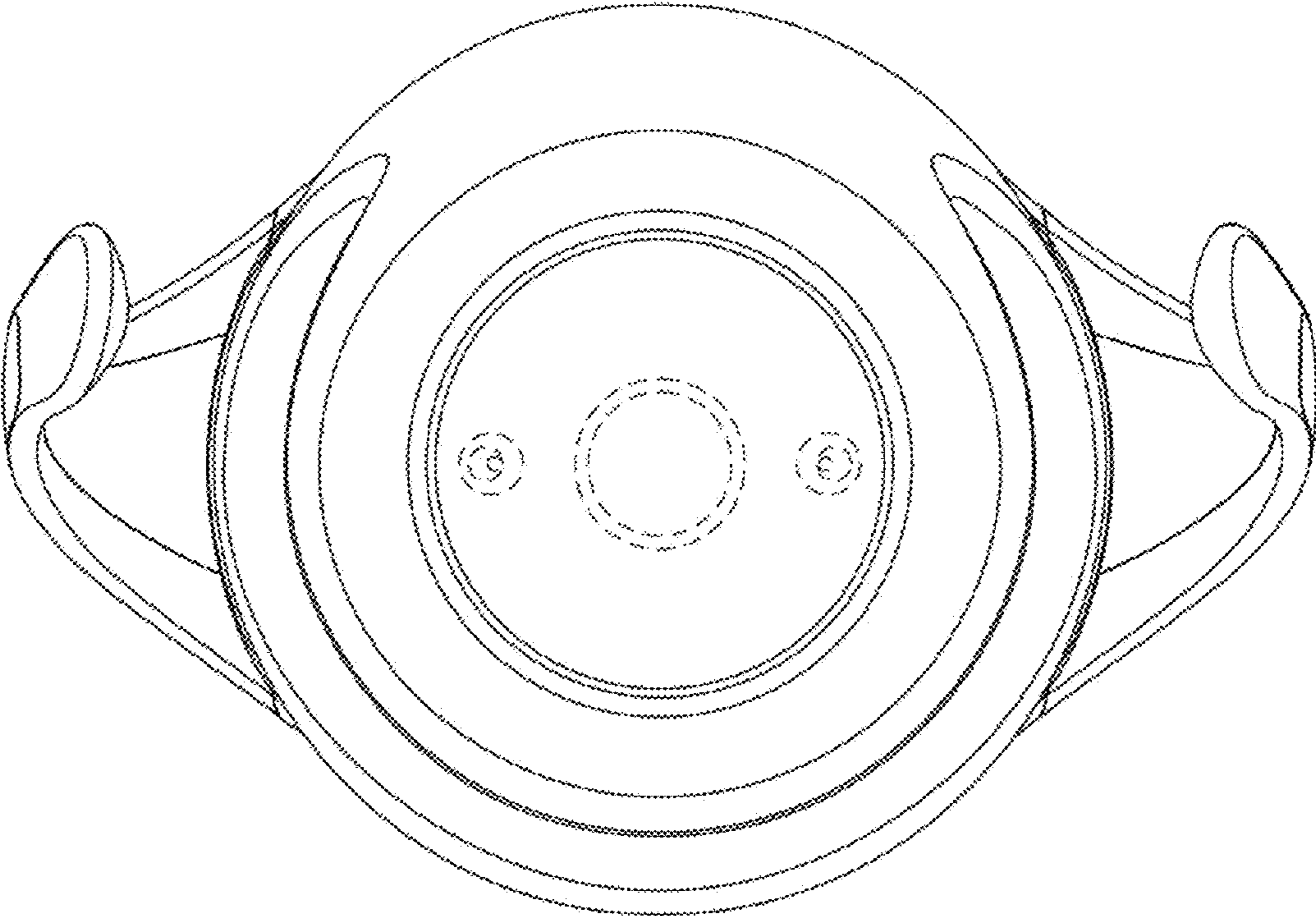
