(57) **CLAIM**

The ornamental design for a sphere ice tongs, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of a sphere ice tongs showing our new design, the opposite side being a mirror image.

FIG. 2 is a side view thereof.

FIG. 3 is a perspective view thereof.

FIG. 4 is a perspective view thereof, the broken line showing of the sphere is for illustrative purposes only and forms no part of the claimed design.

FIG. 5 is a side view of FIG. 4.

FIG. 6 is a front view thereof.

FIG. 7 is a side view thereof, in a closed position.

FIG. 8 is a front view of FIG. 7.

FIG. 9 is a side view of an alternate embodiment of FIG. 1.

FIG. 11 is a side view of FIG. 9.

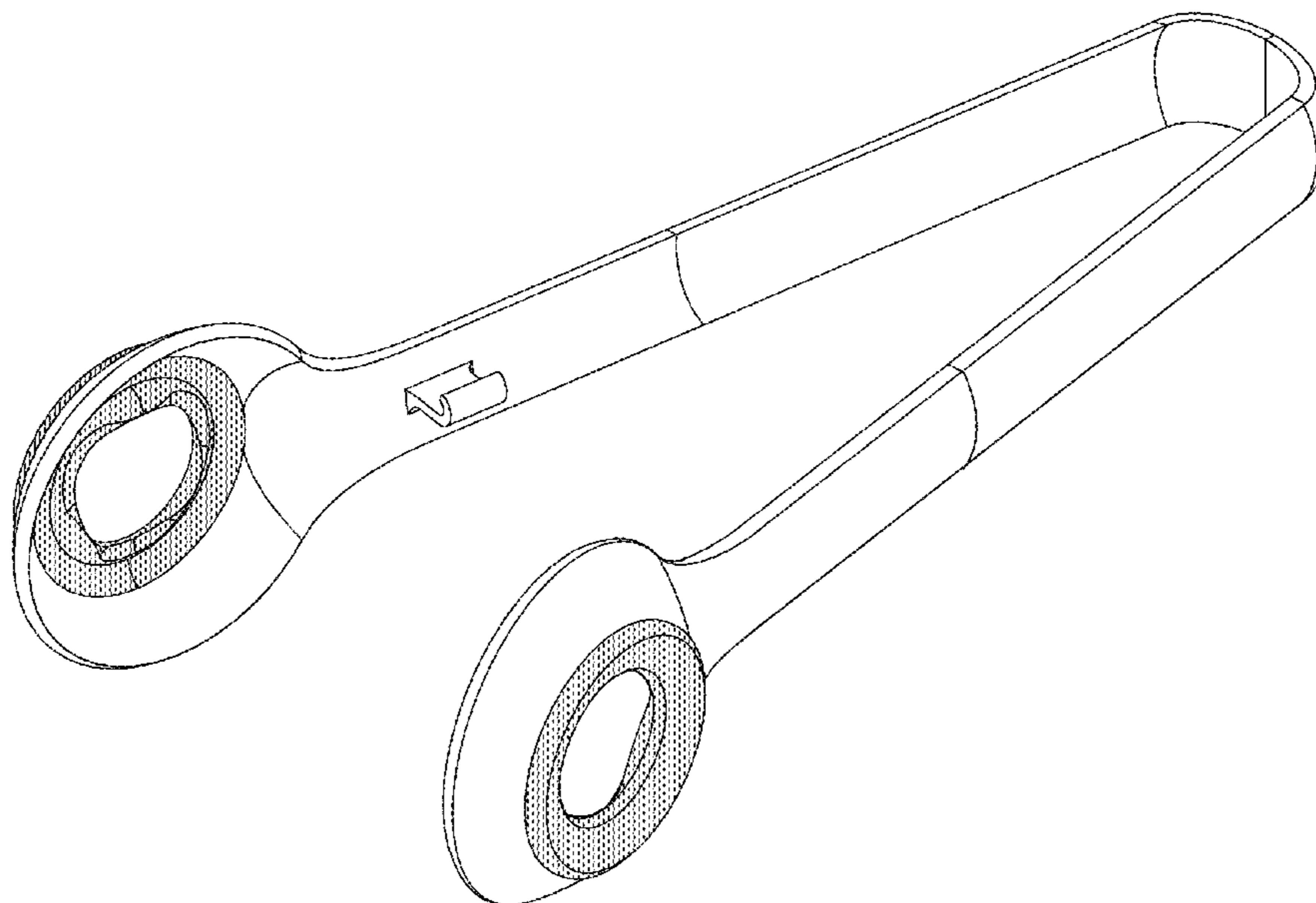
FIG. 12 is a perspective view of FIG. 9.

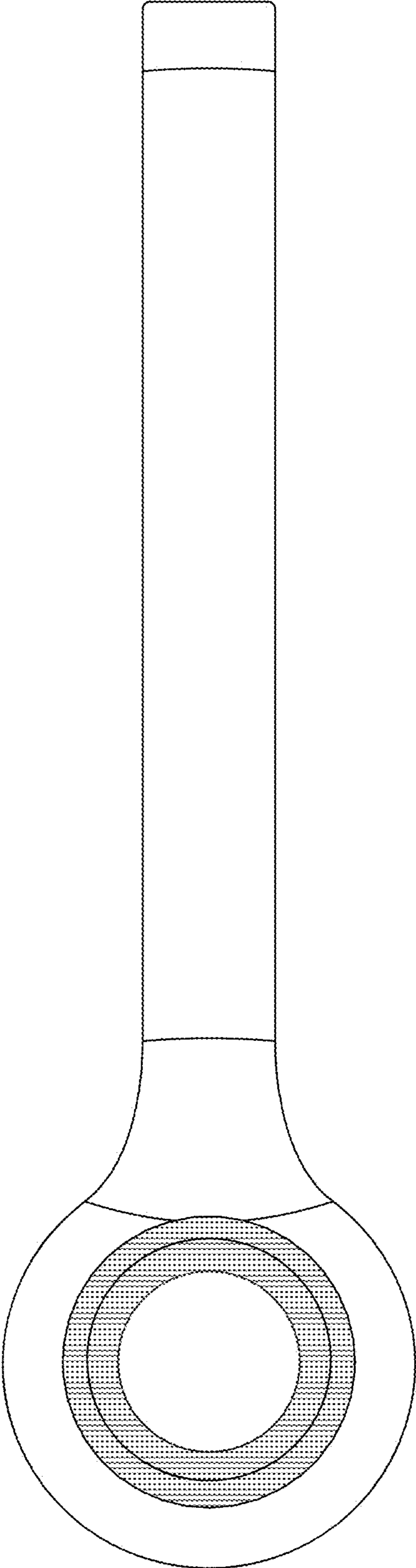

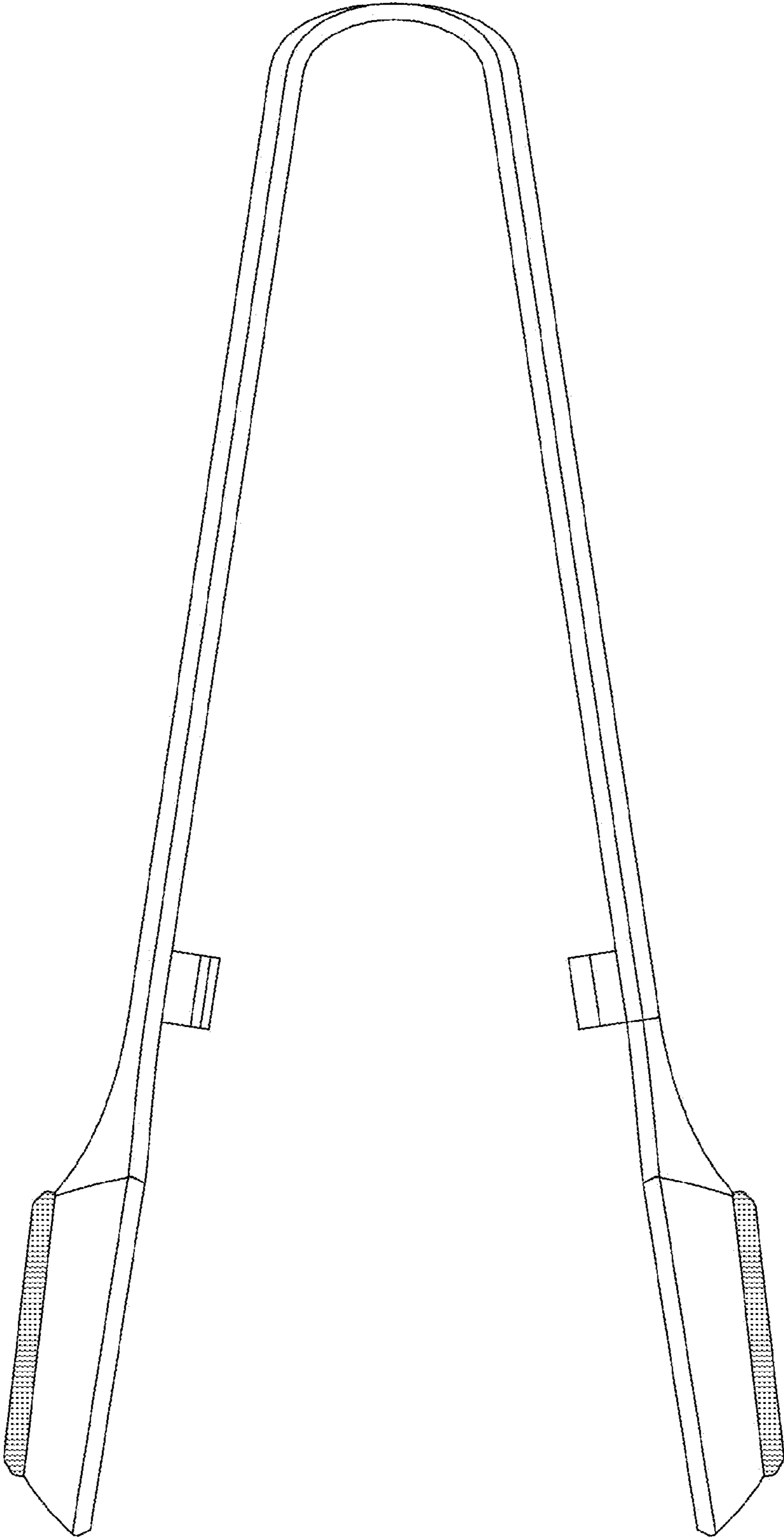

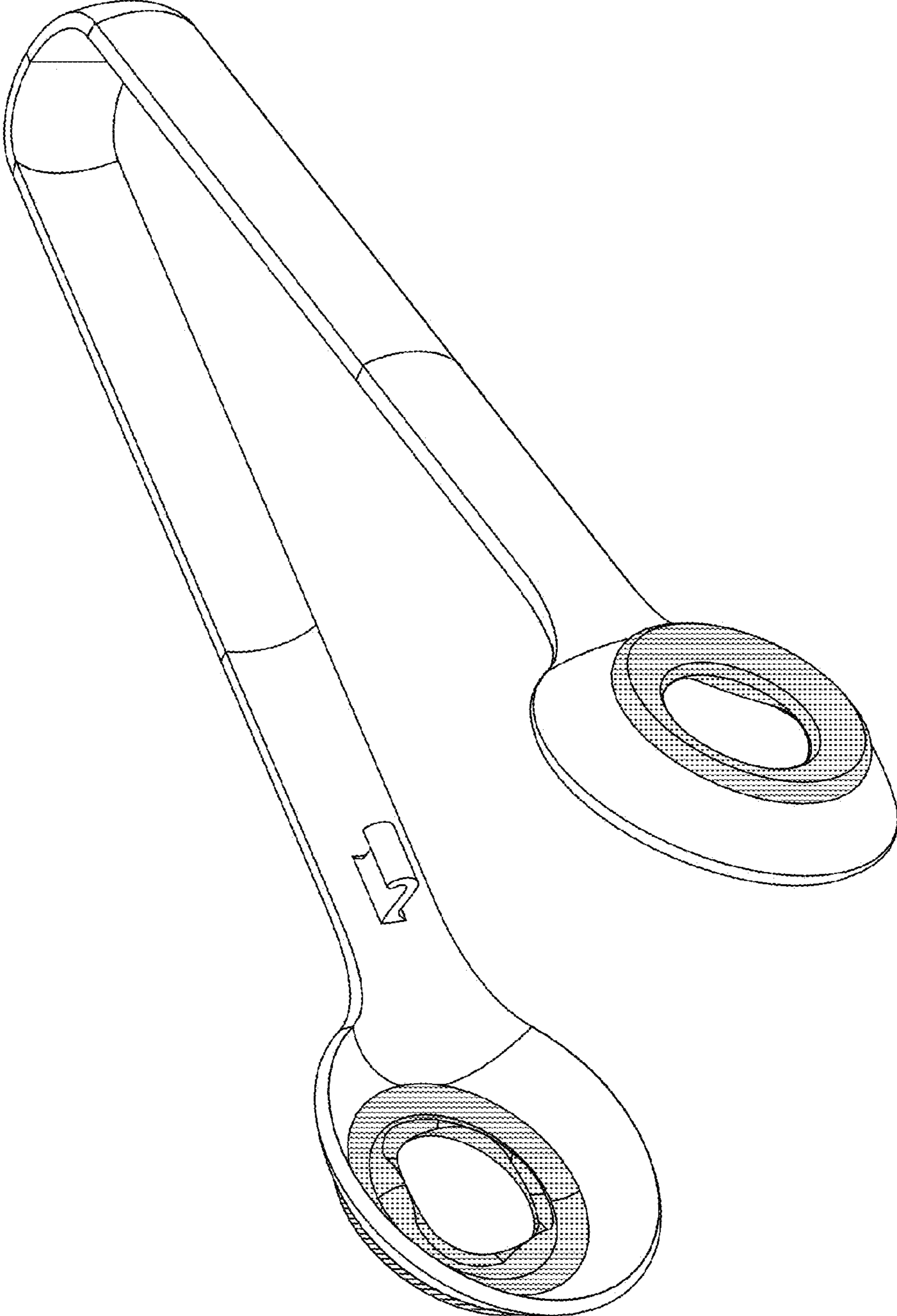

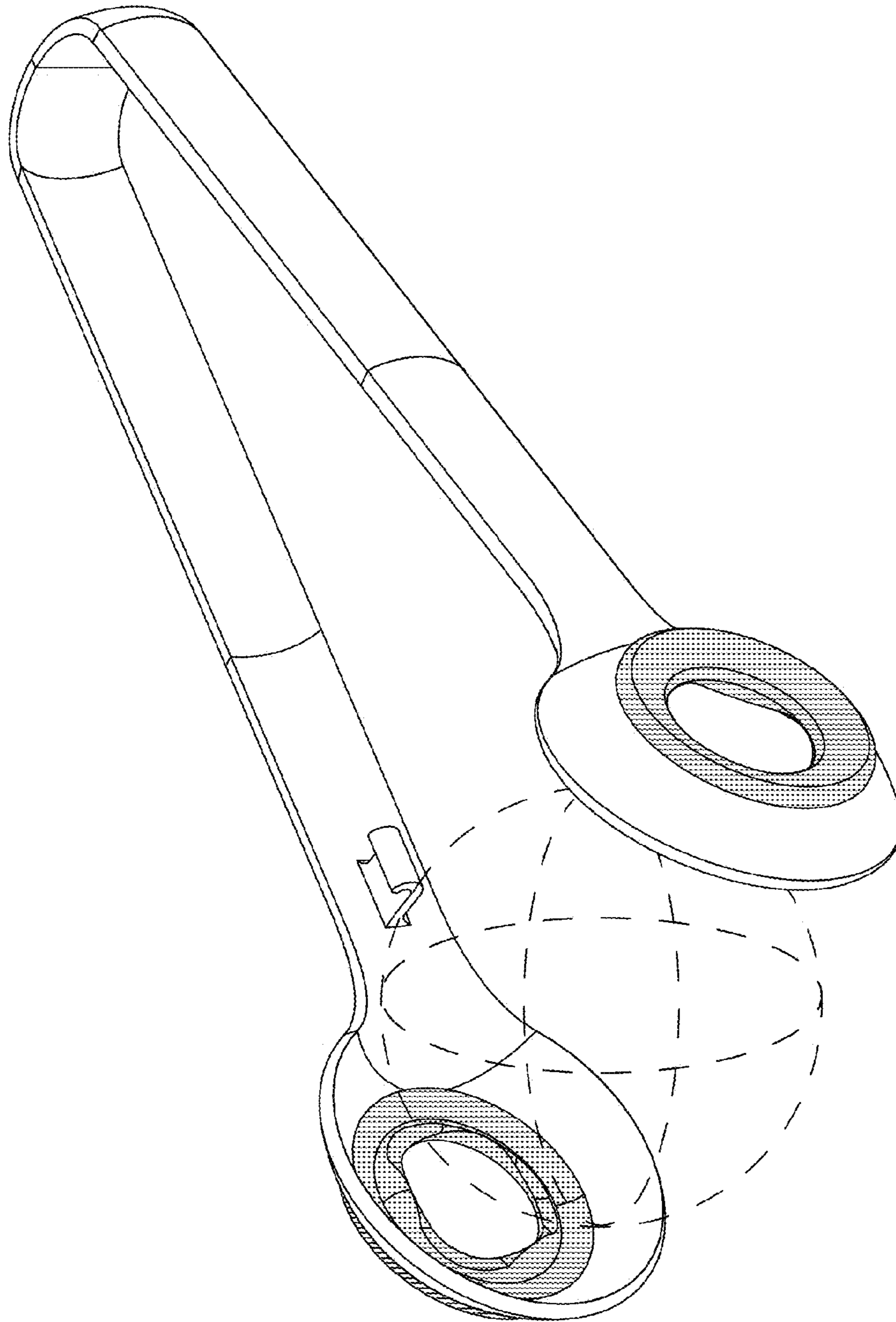

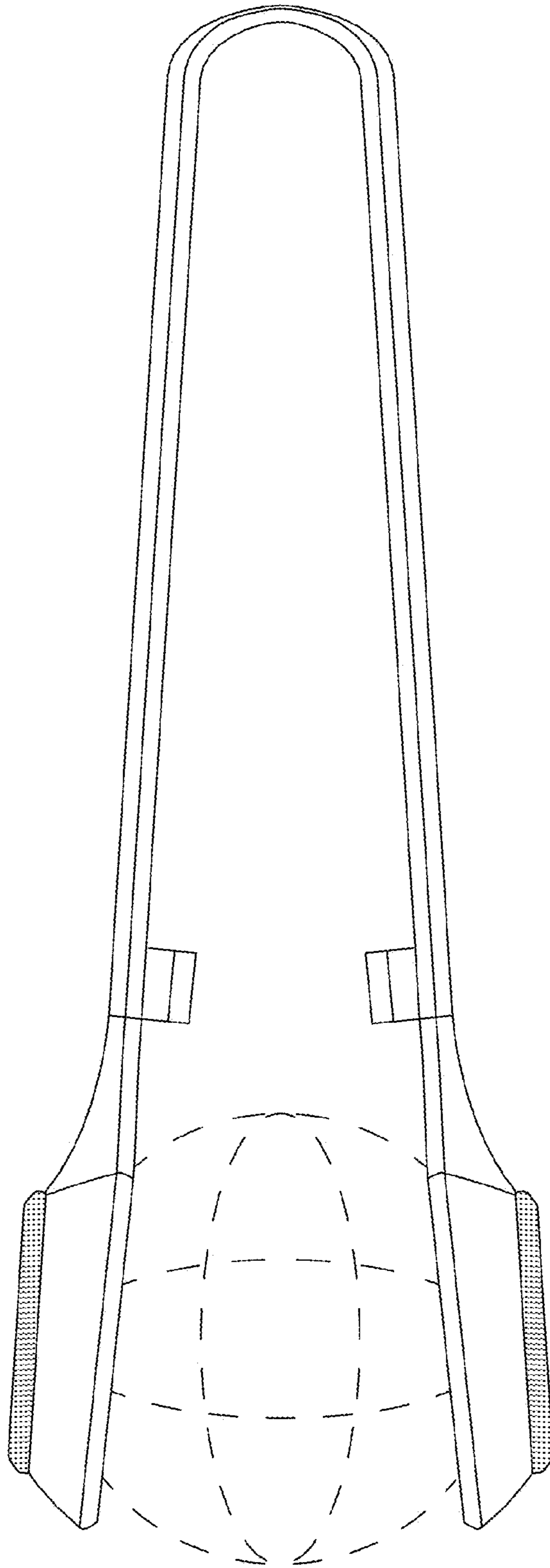

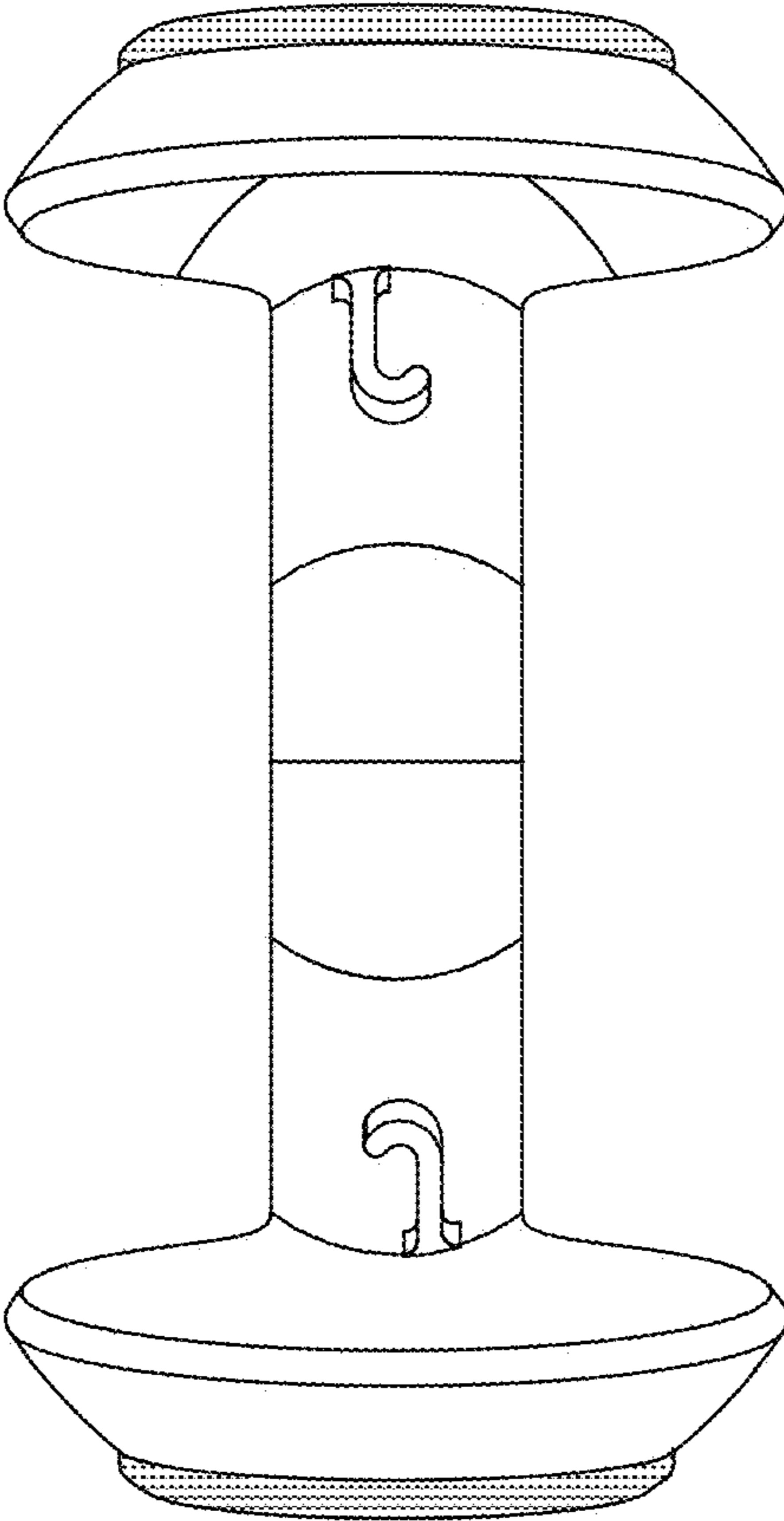

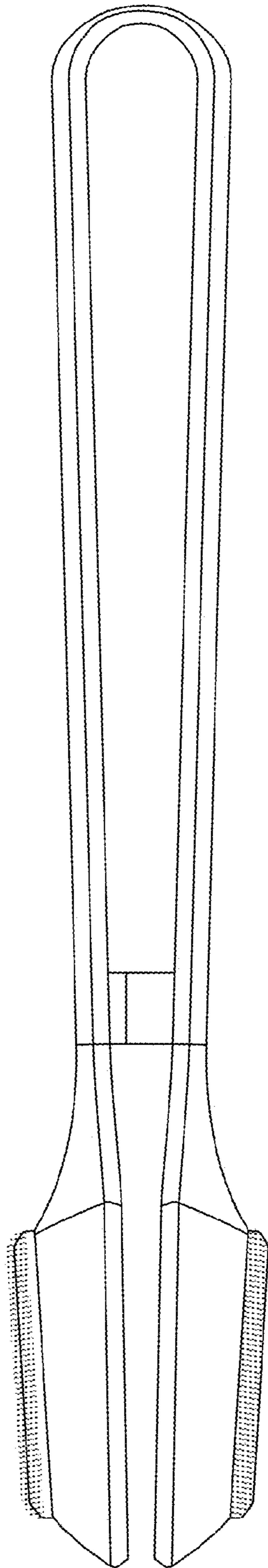

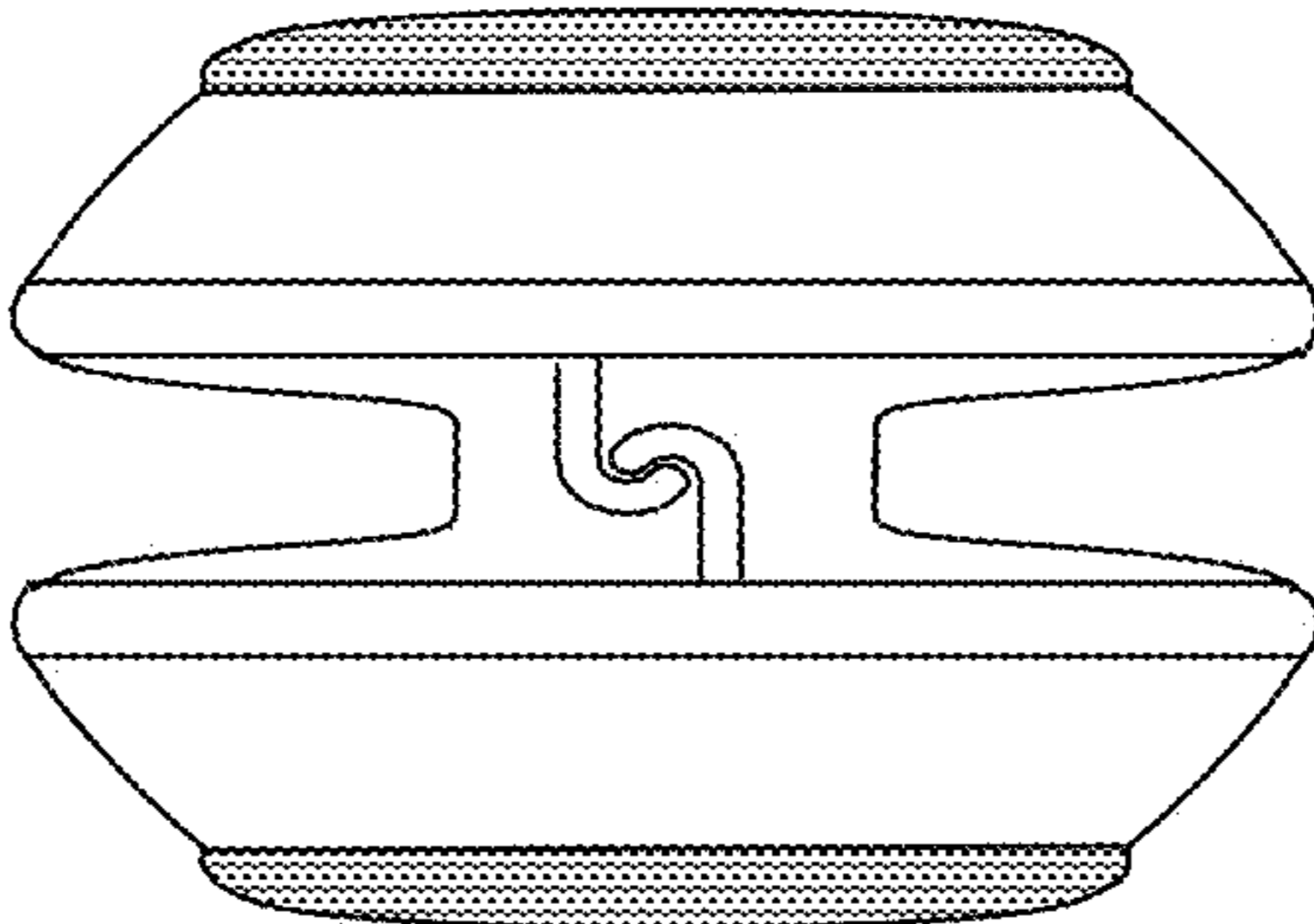

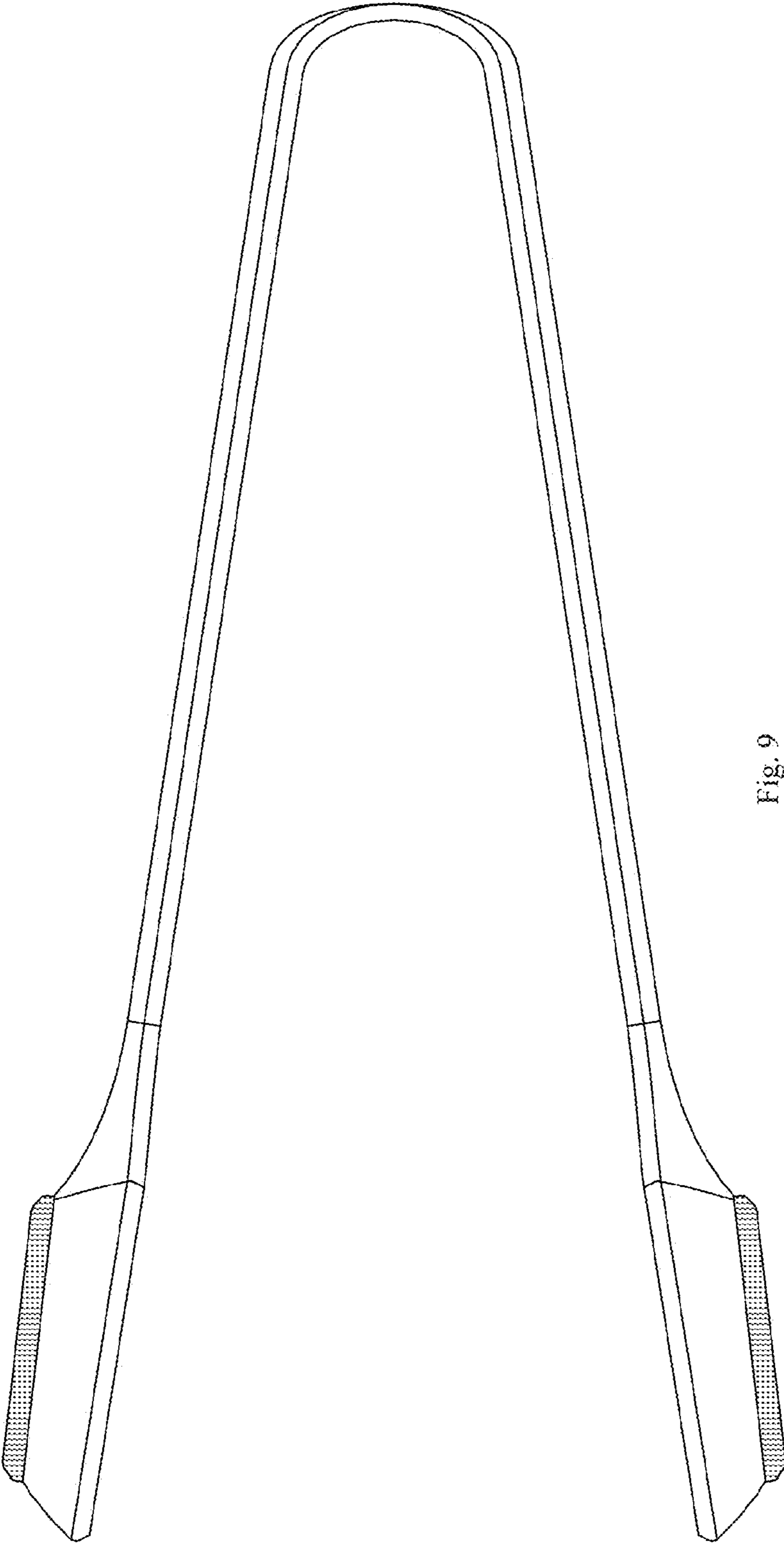

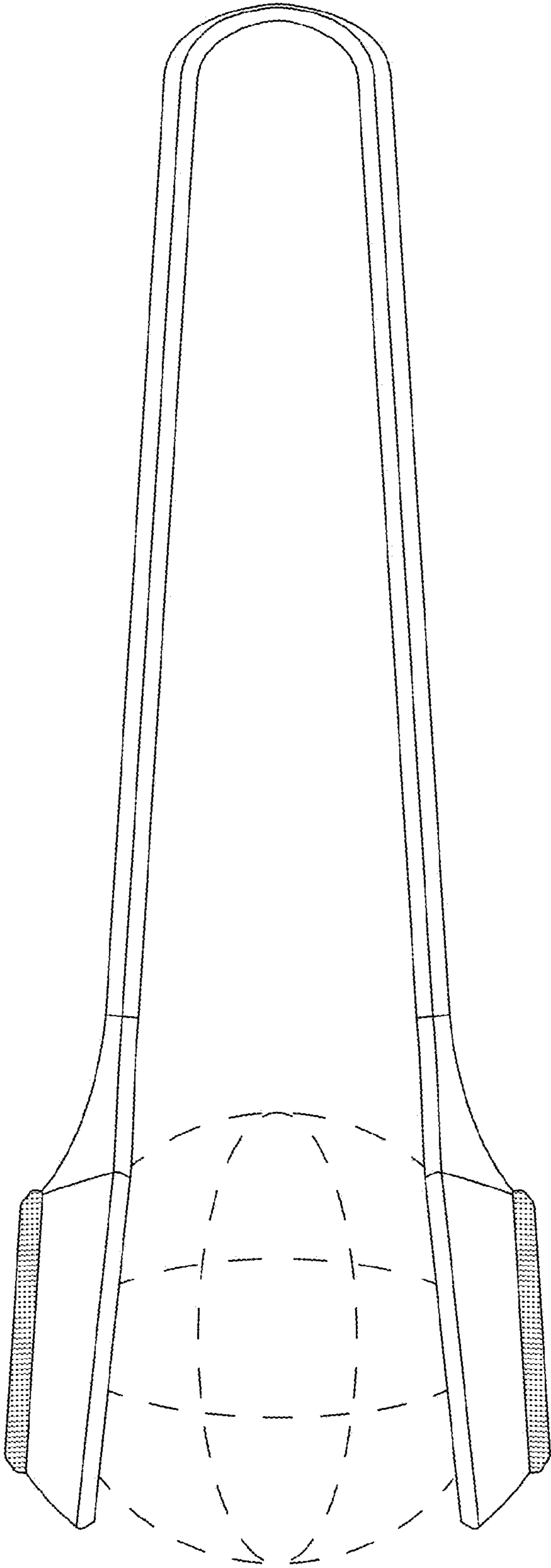

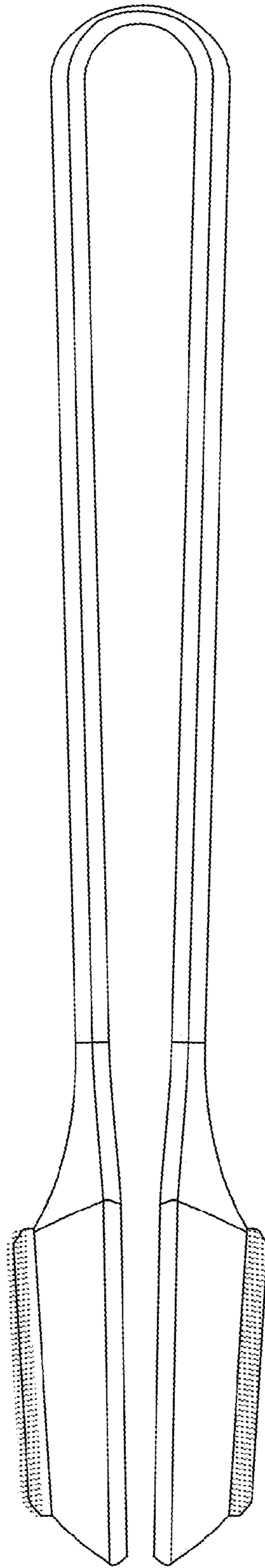

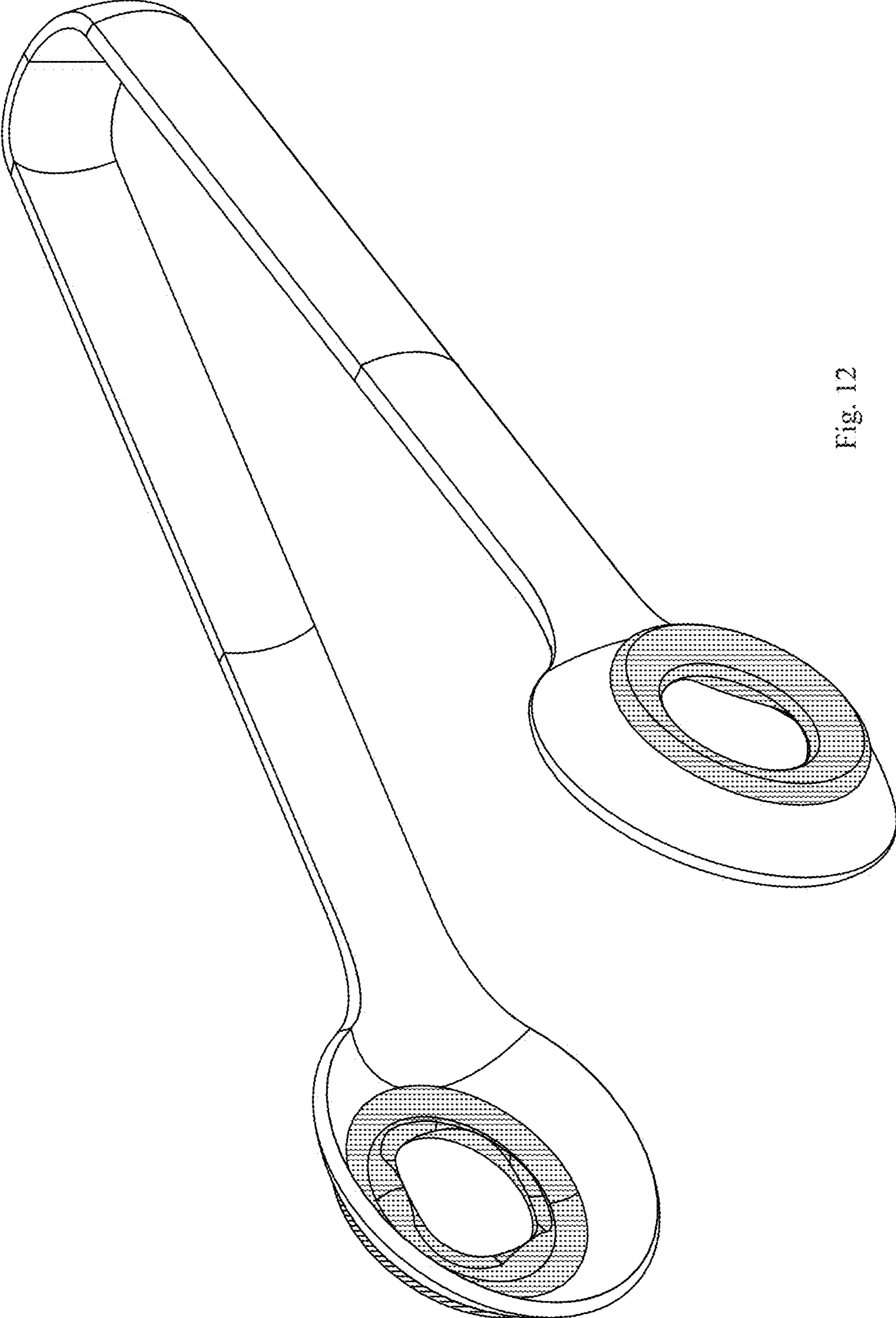

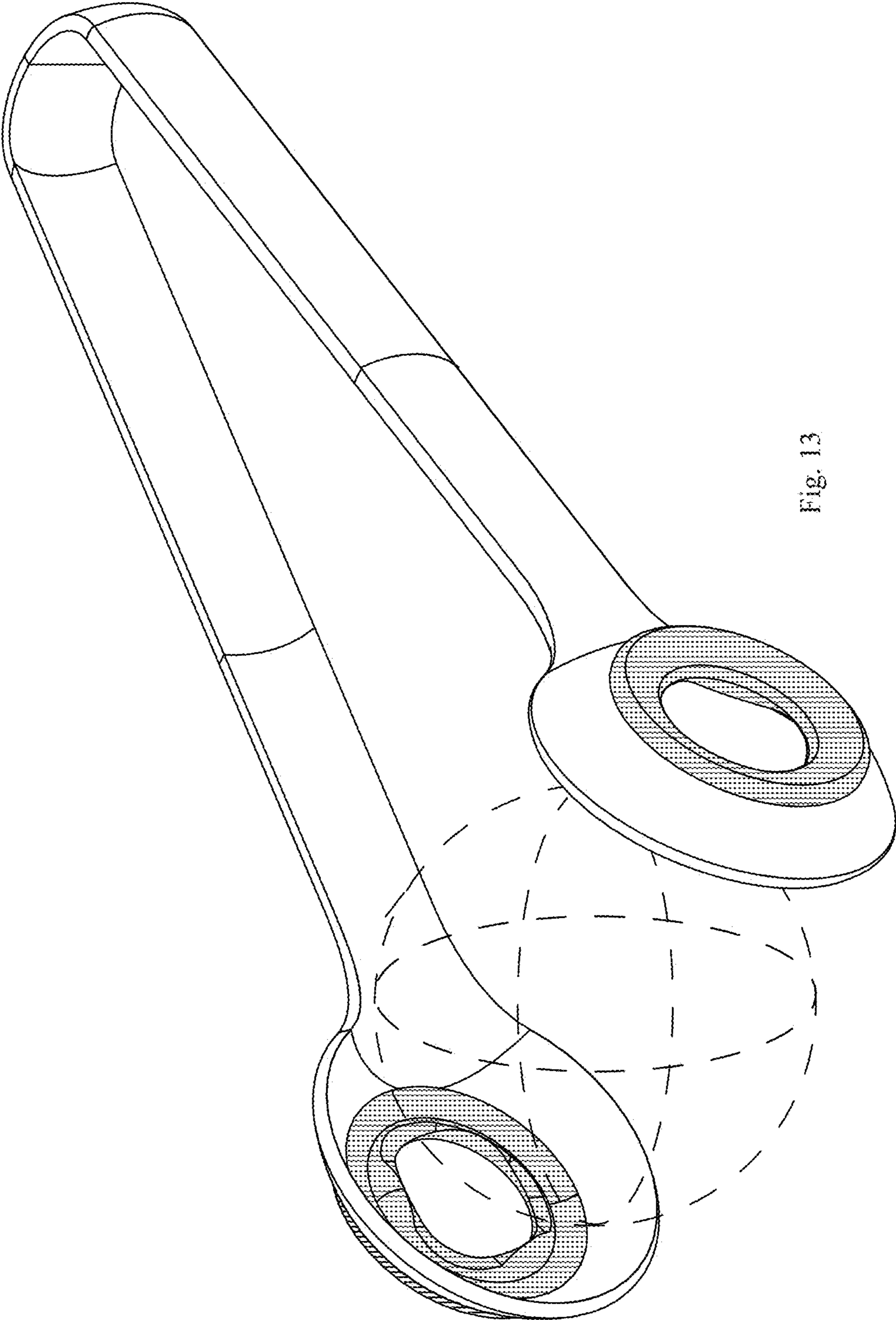

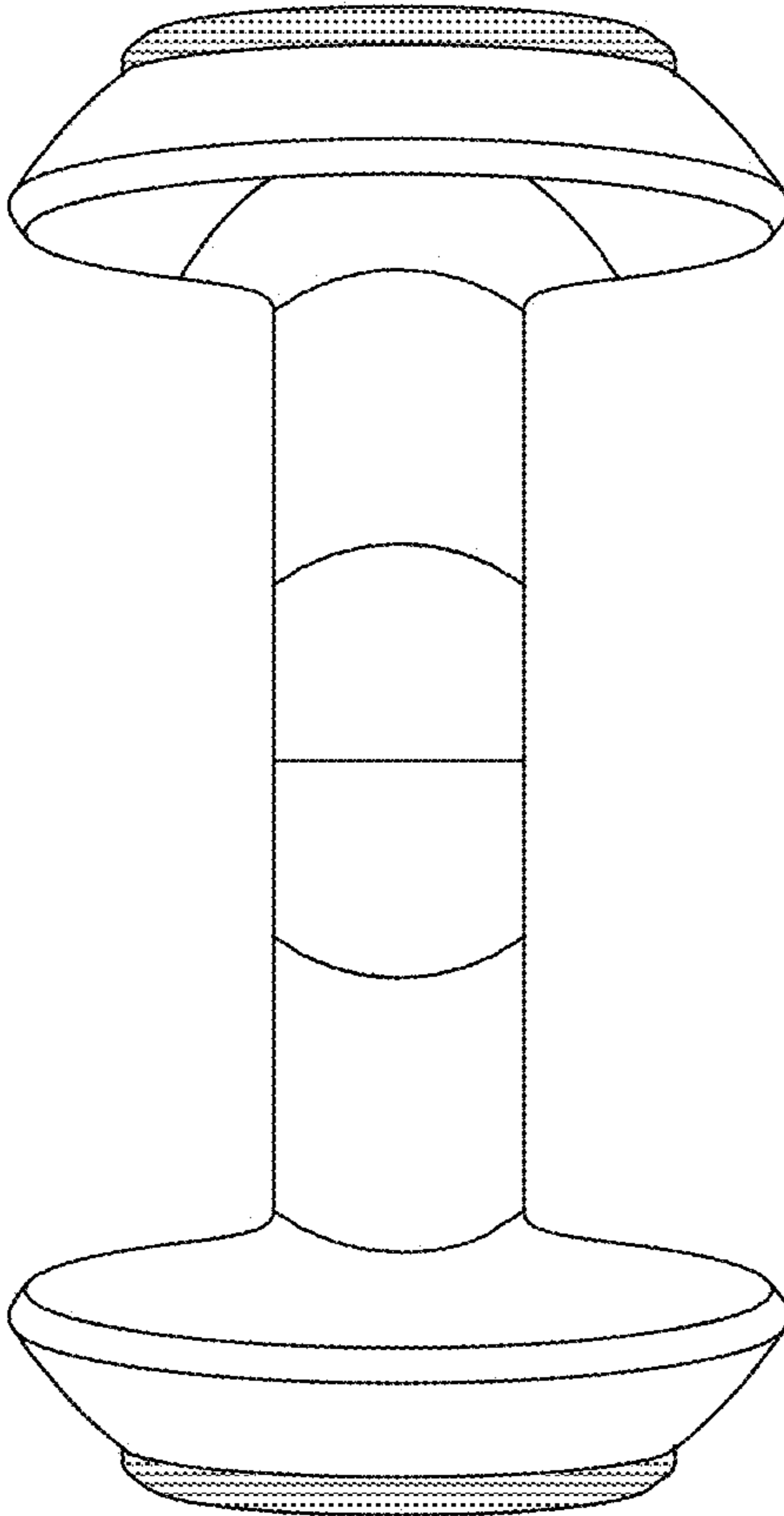

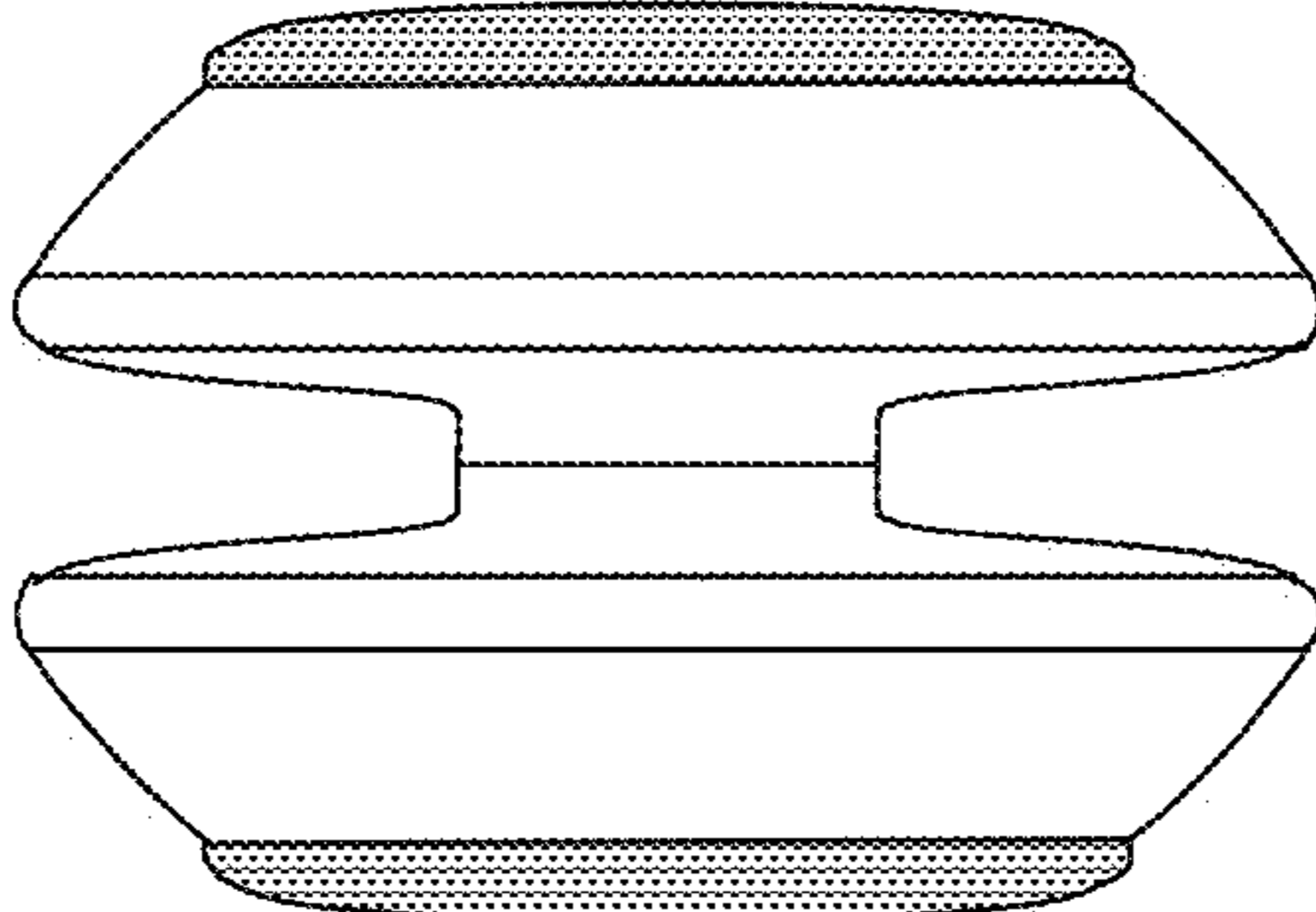
