The ornamental design for a collapsible cutting board with drawer, as shown and described.

DESCRIPTION

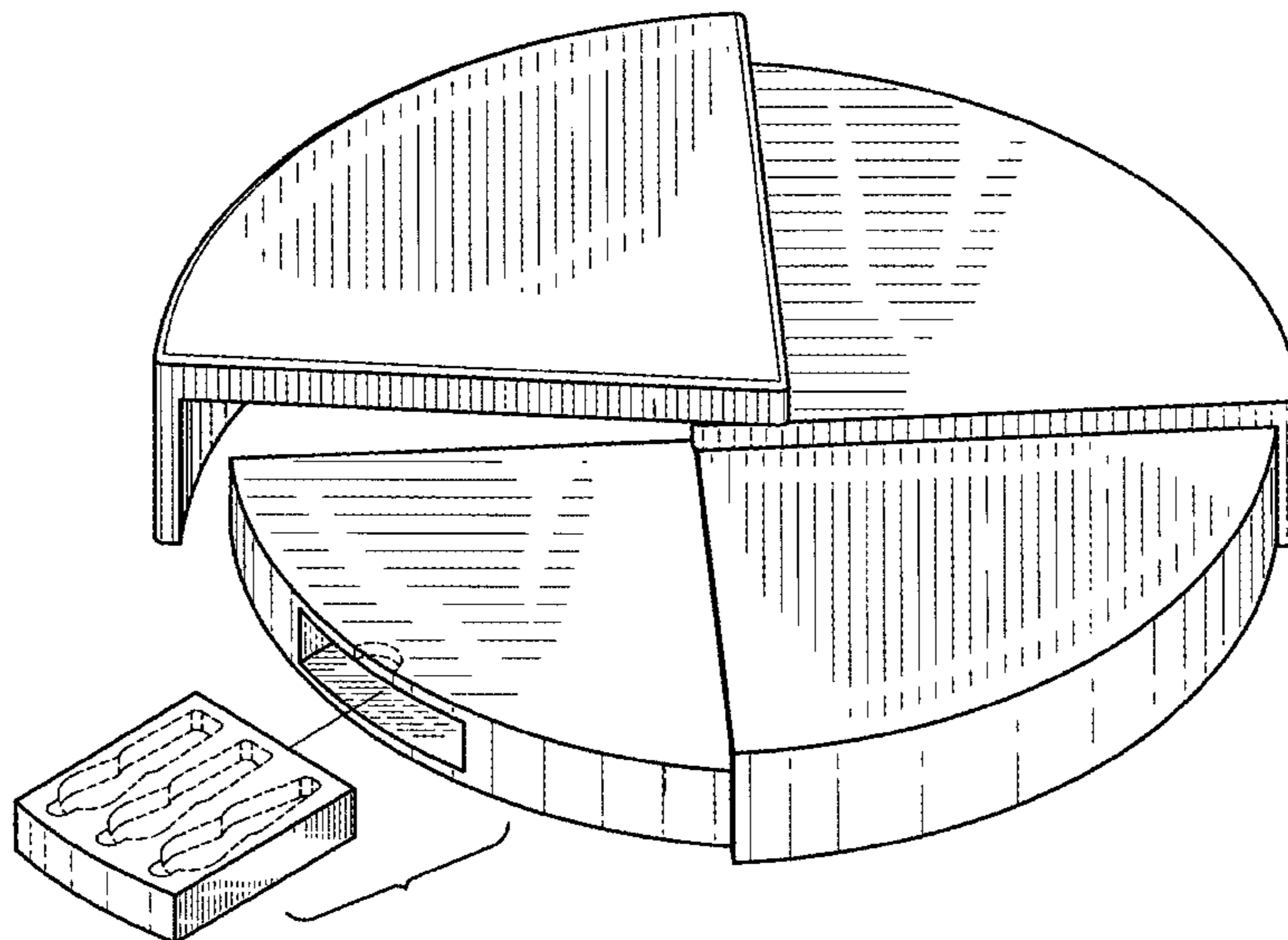

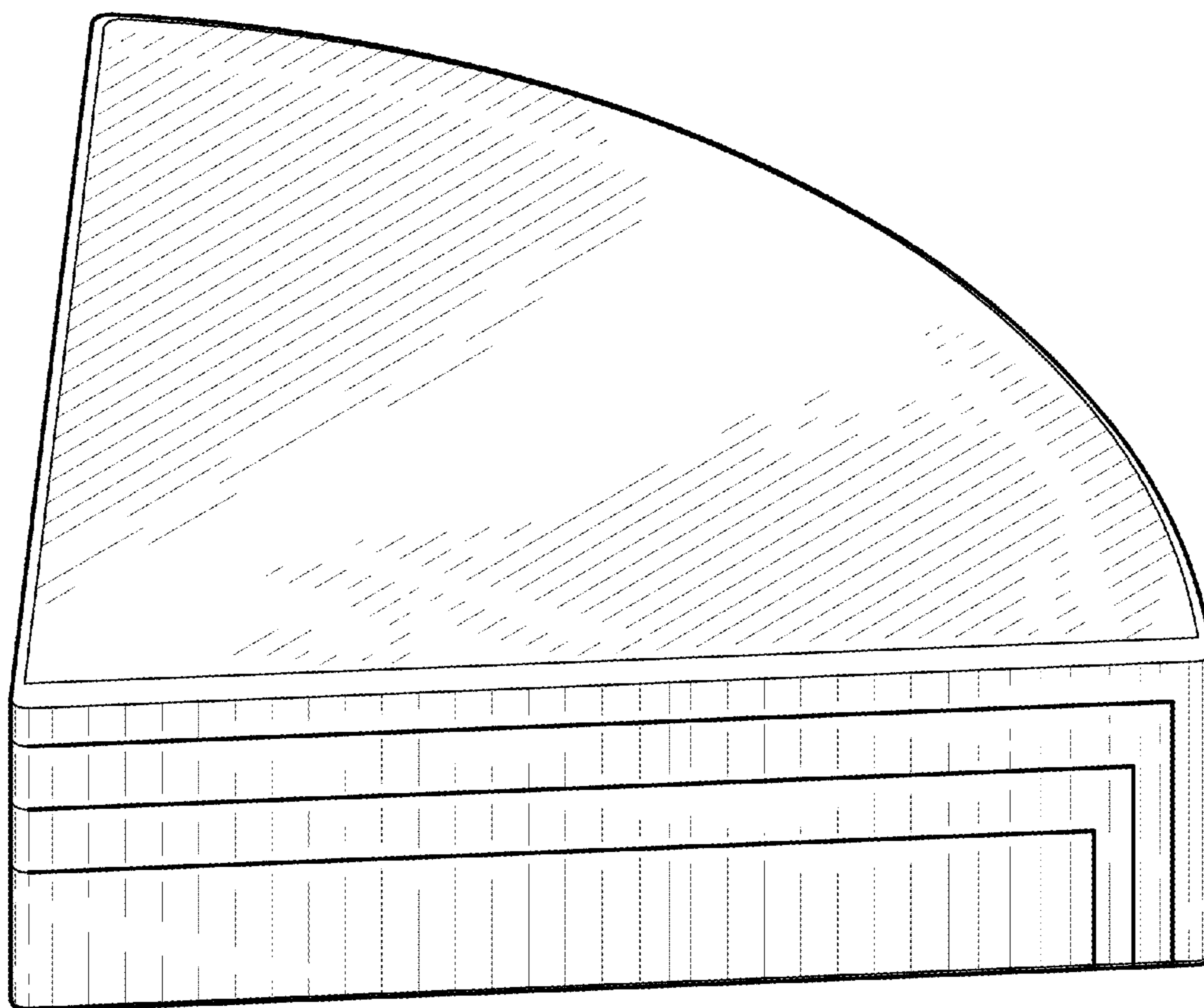

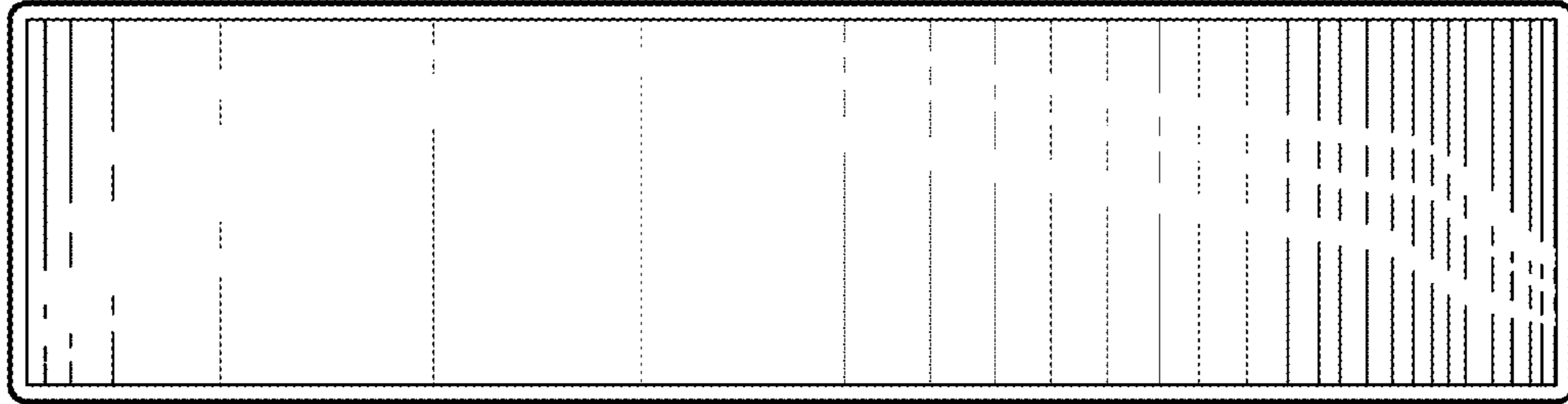

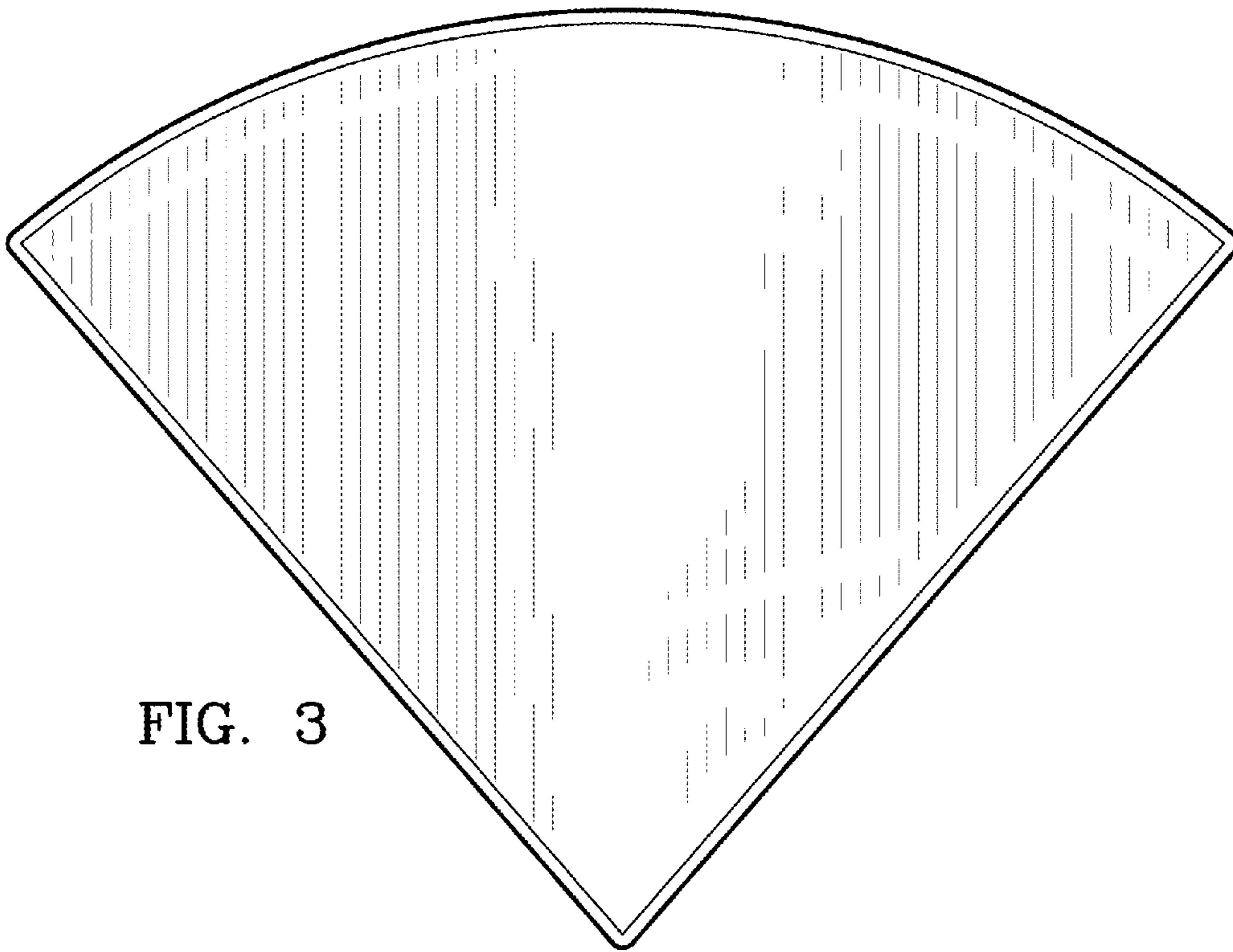

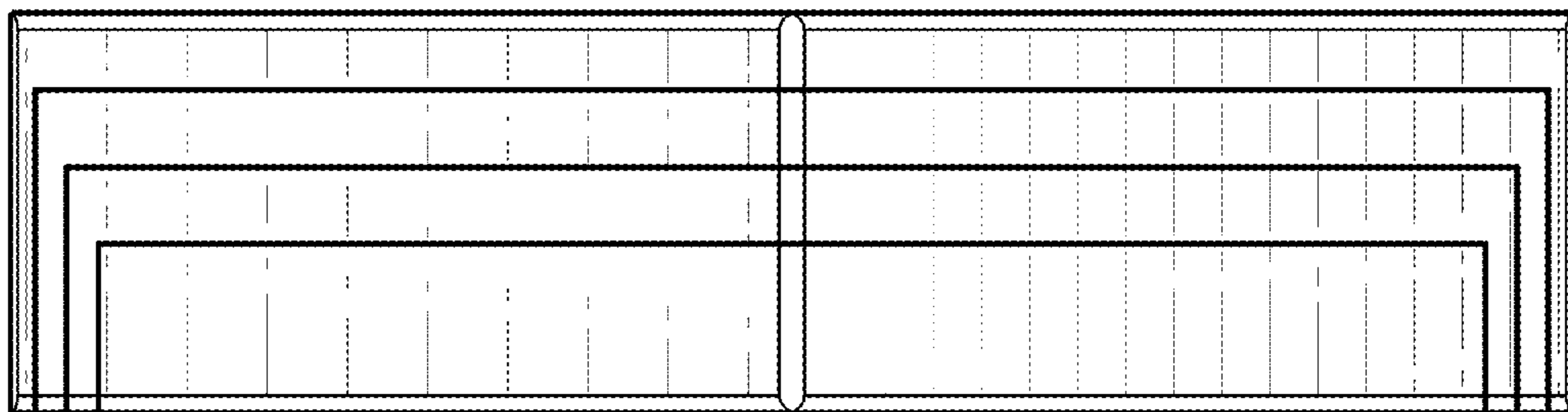

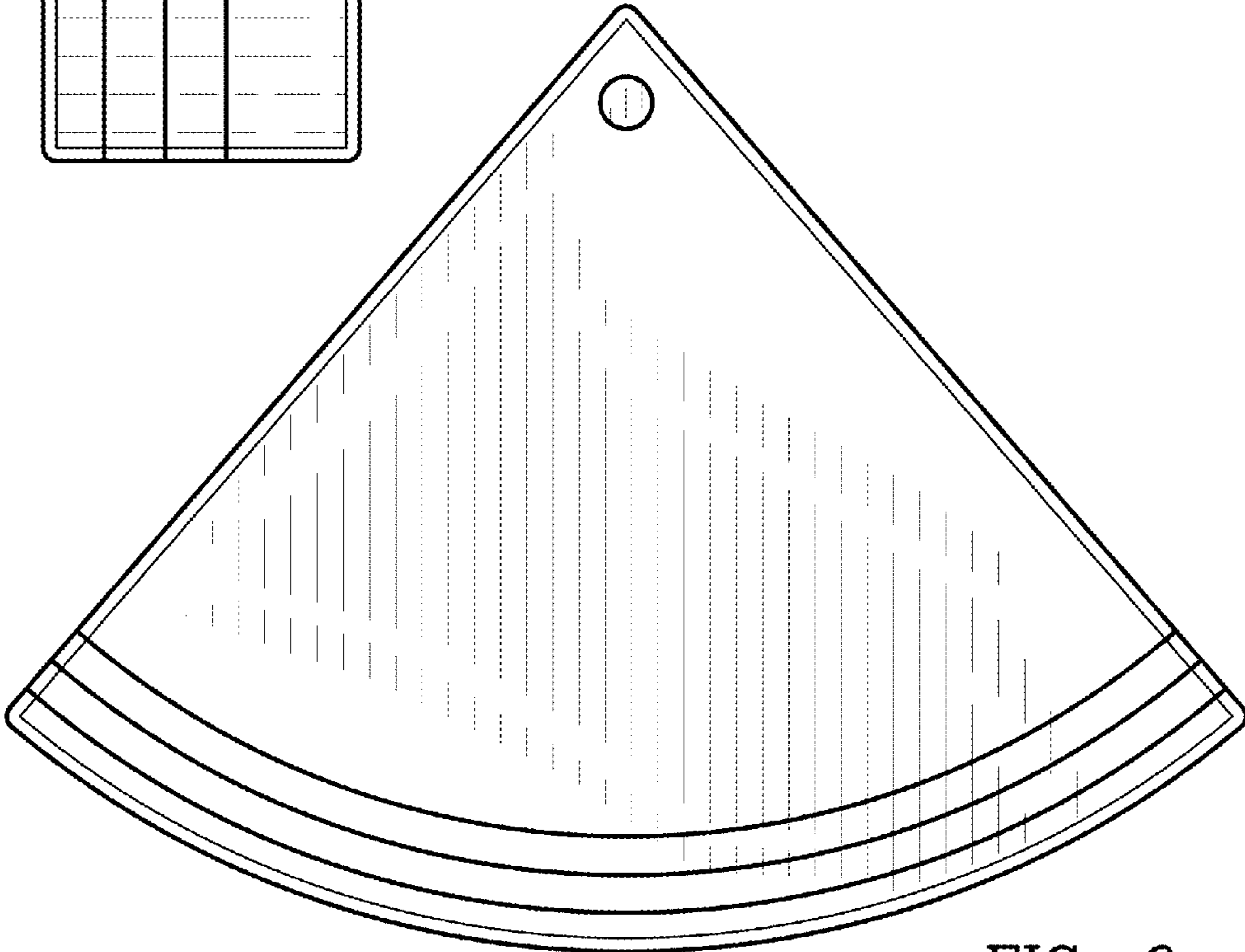
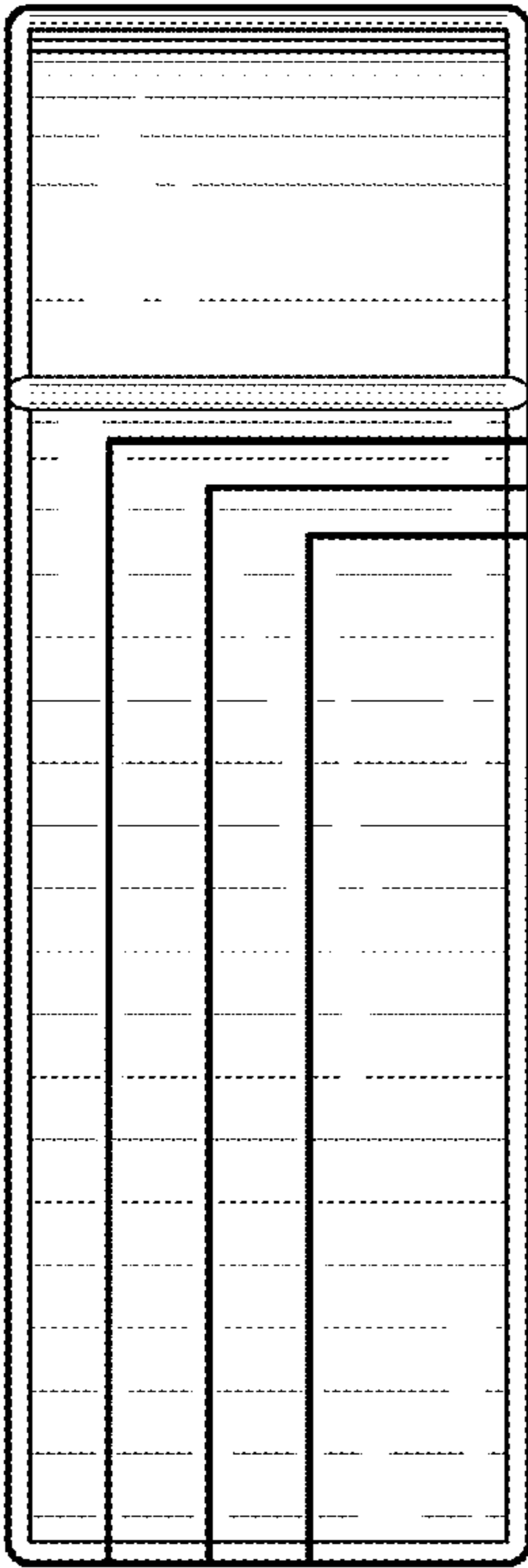
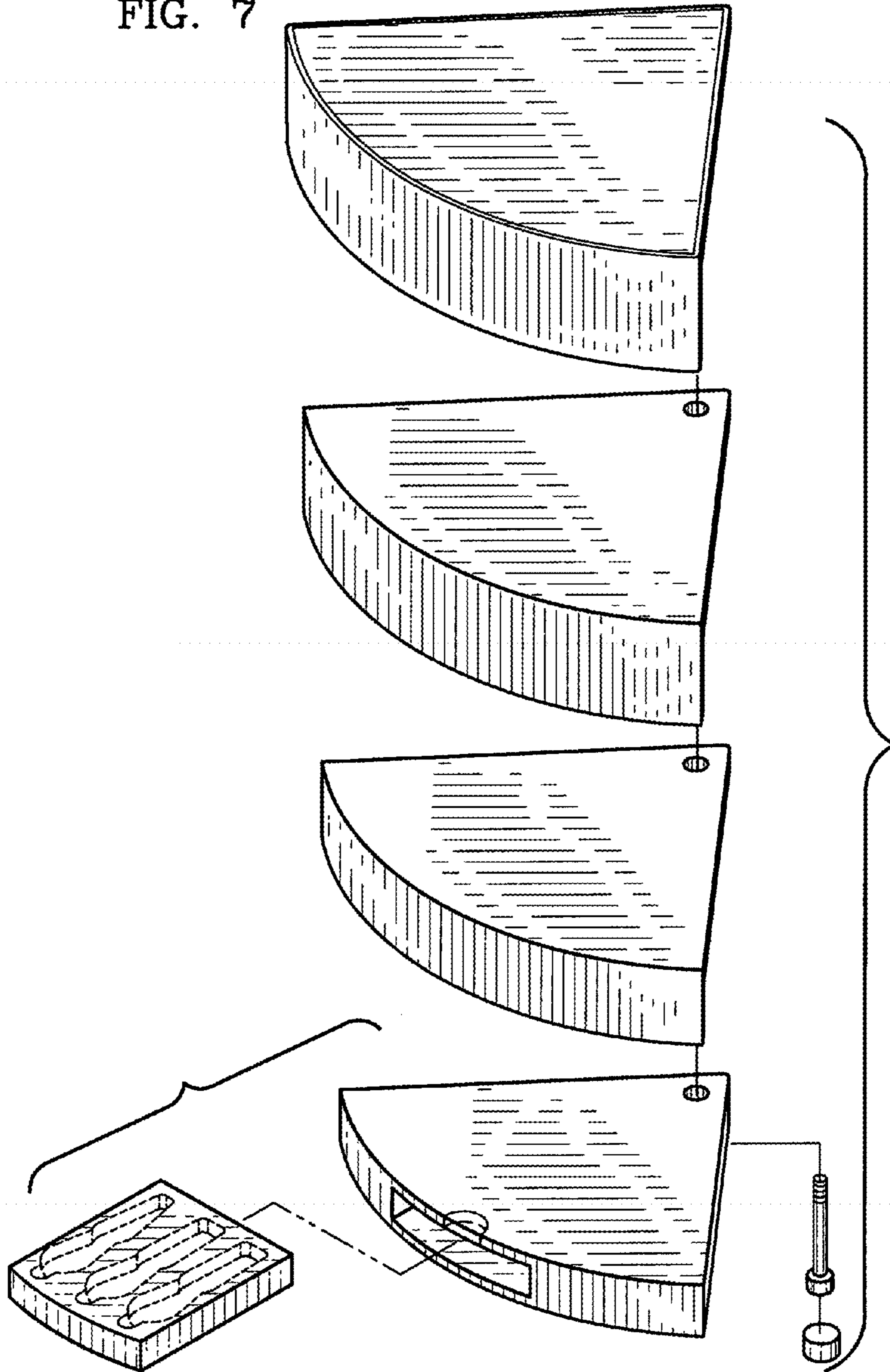

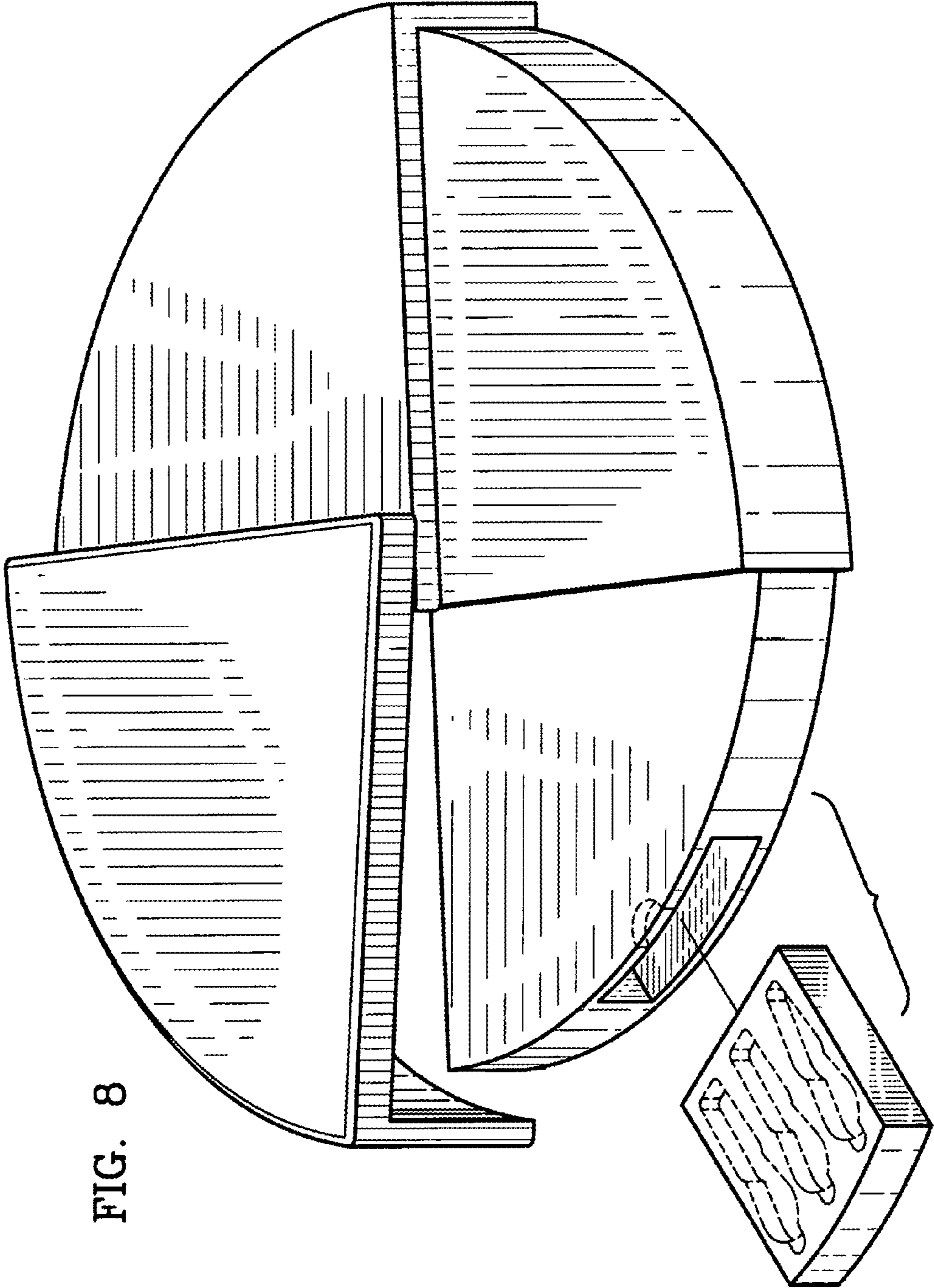

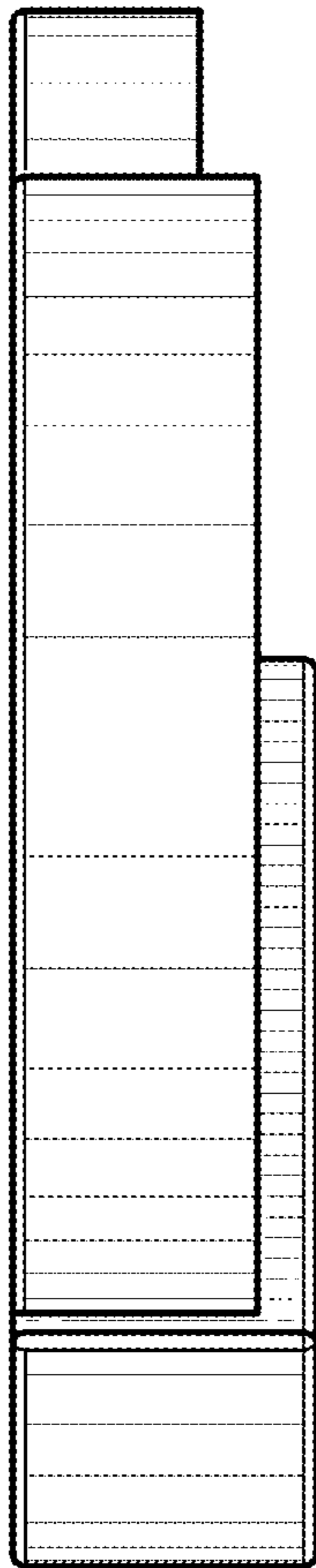

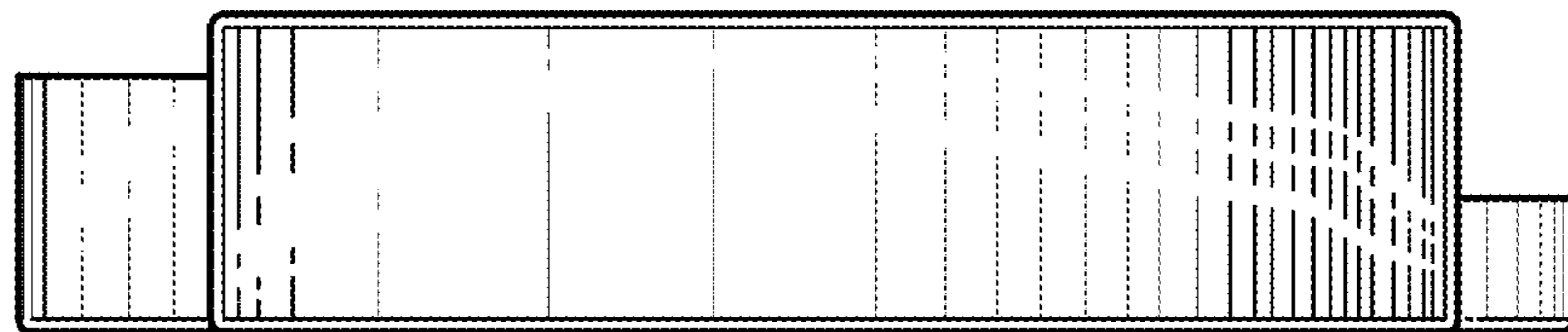
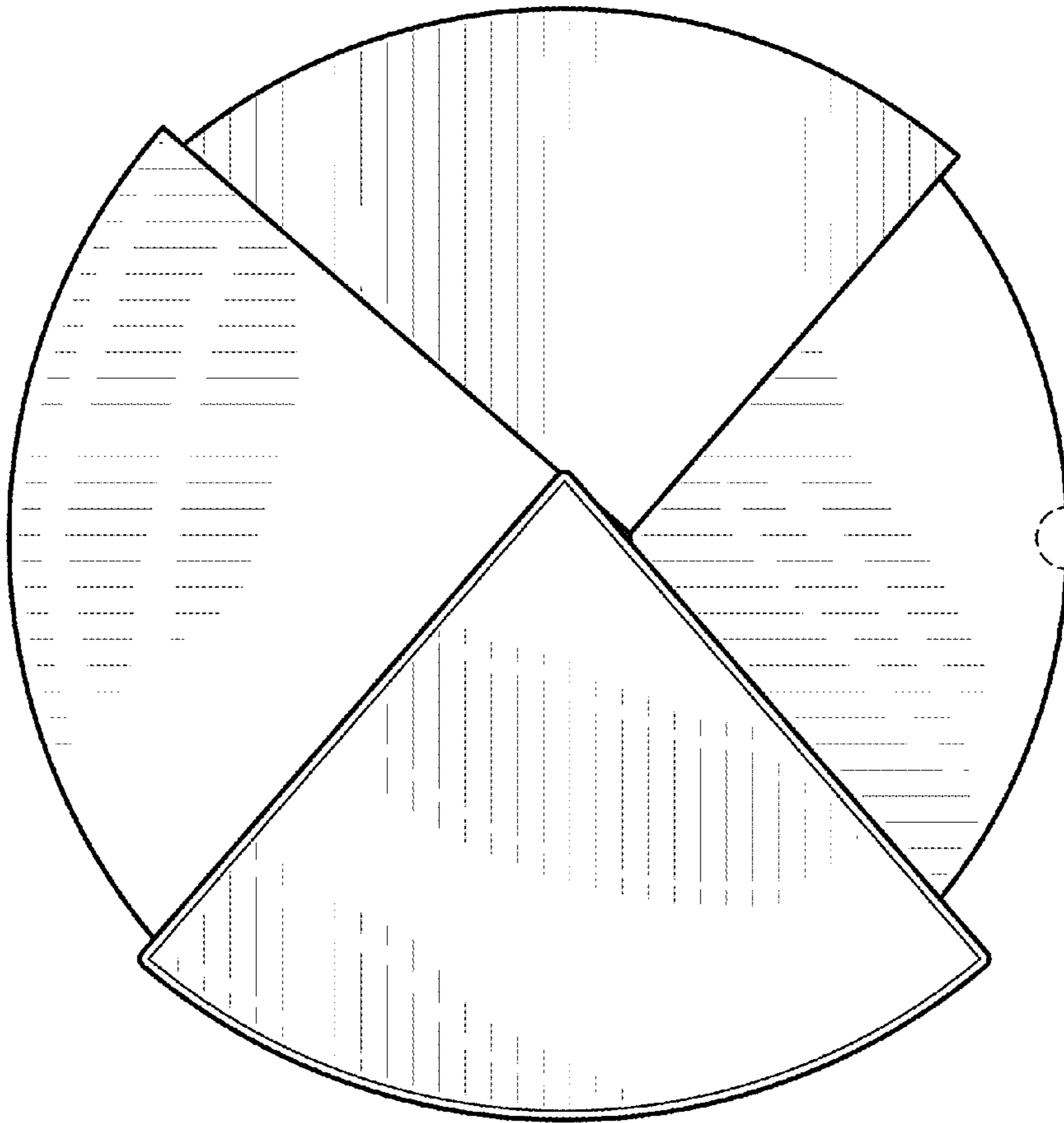

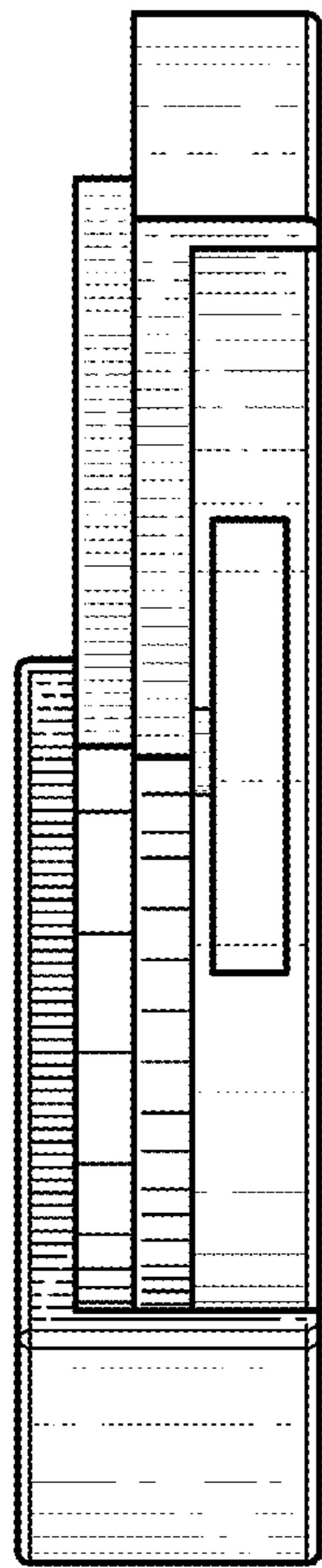

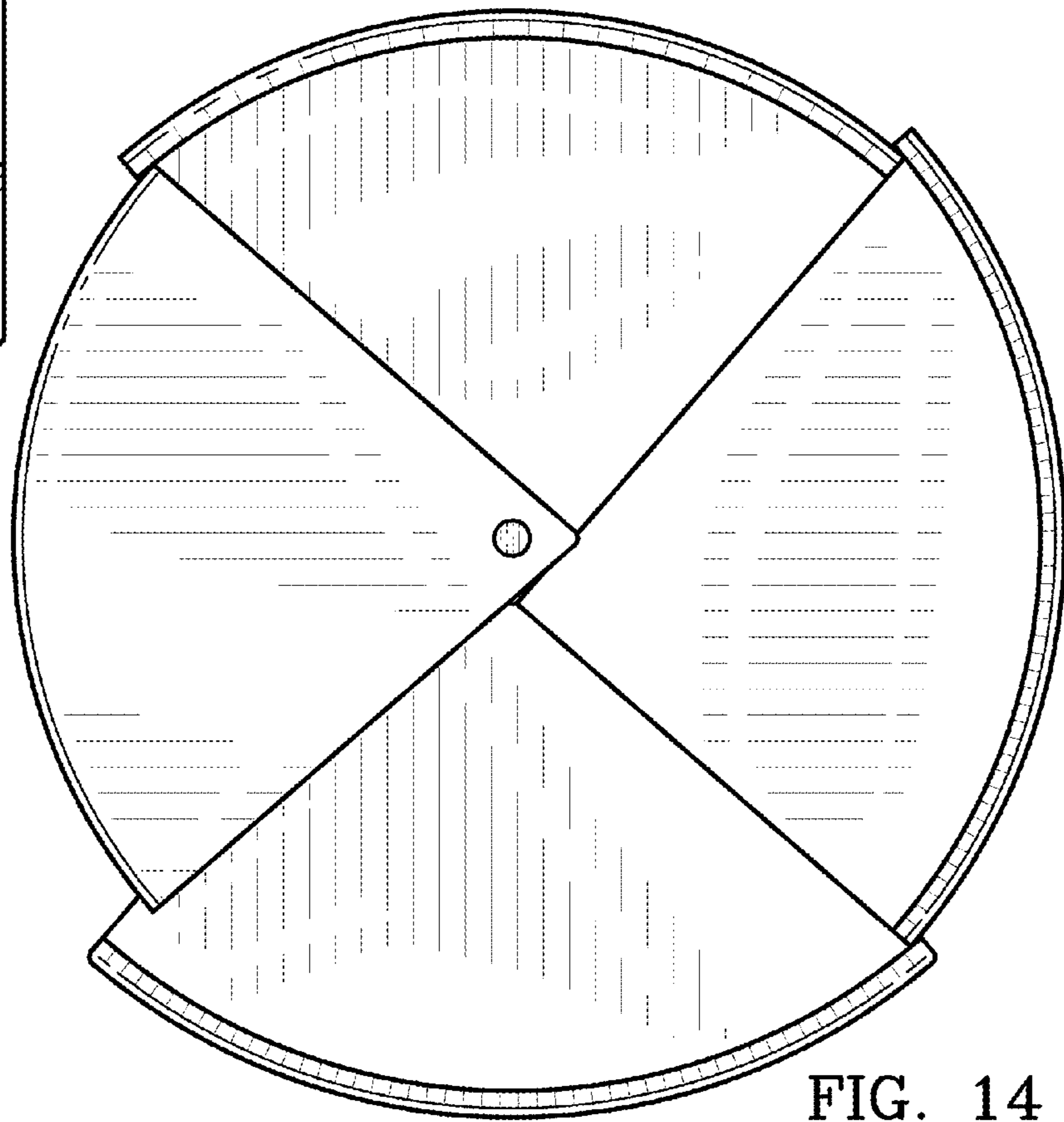
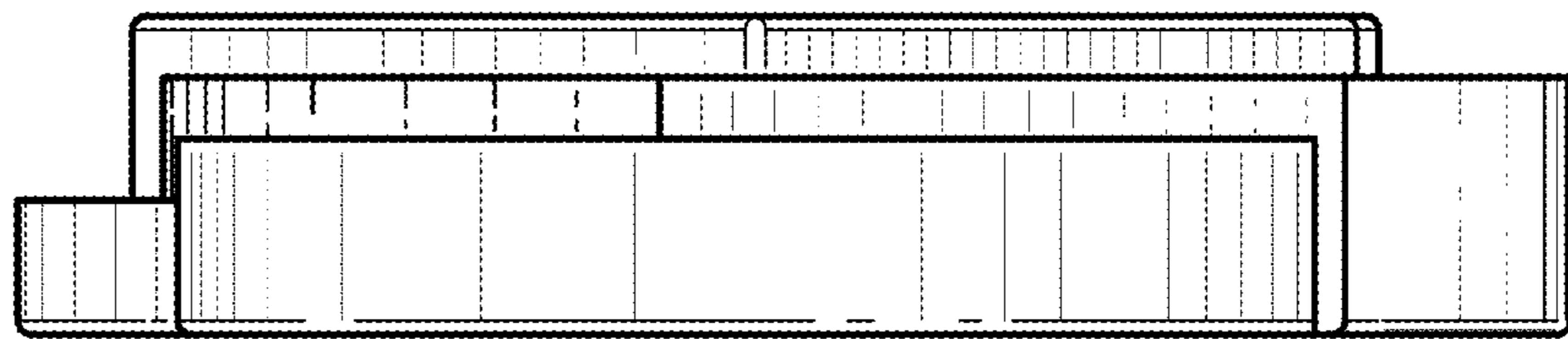

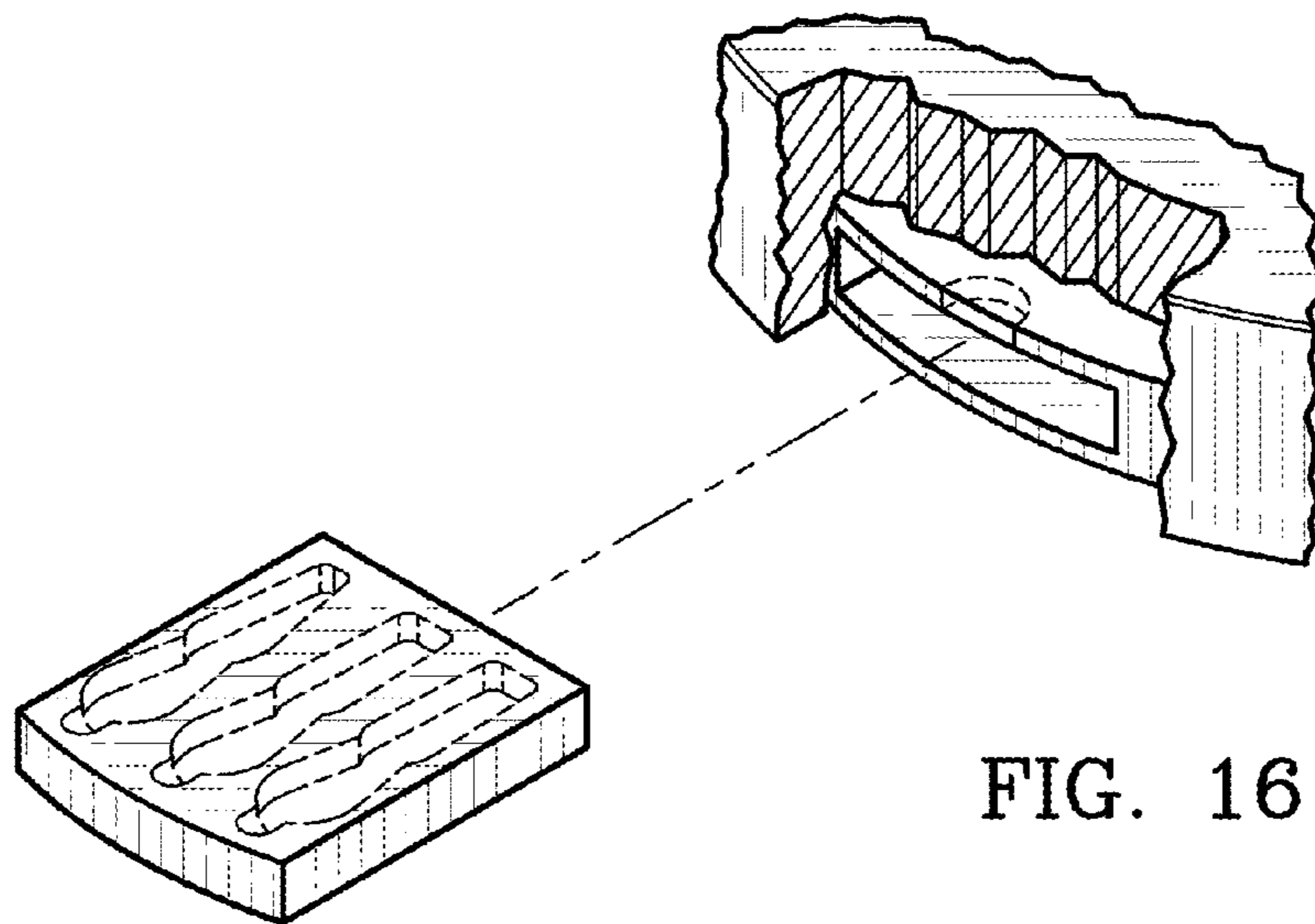
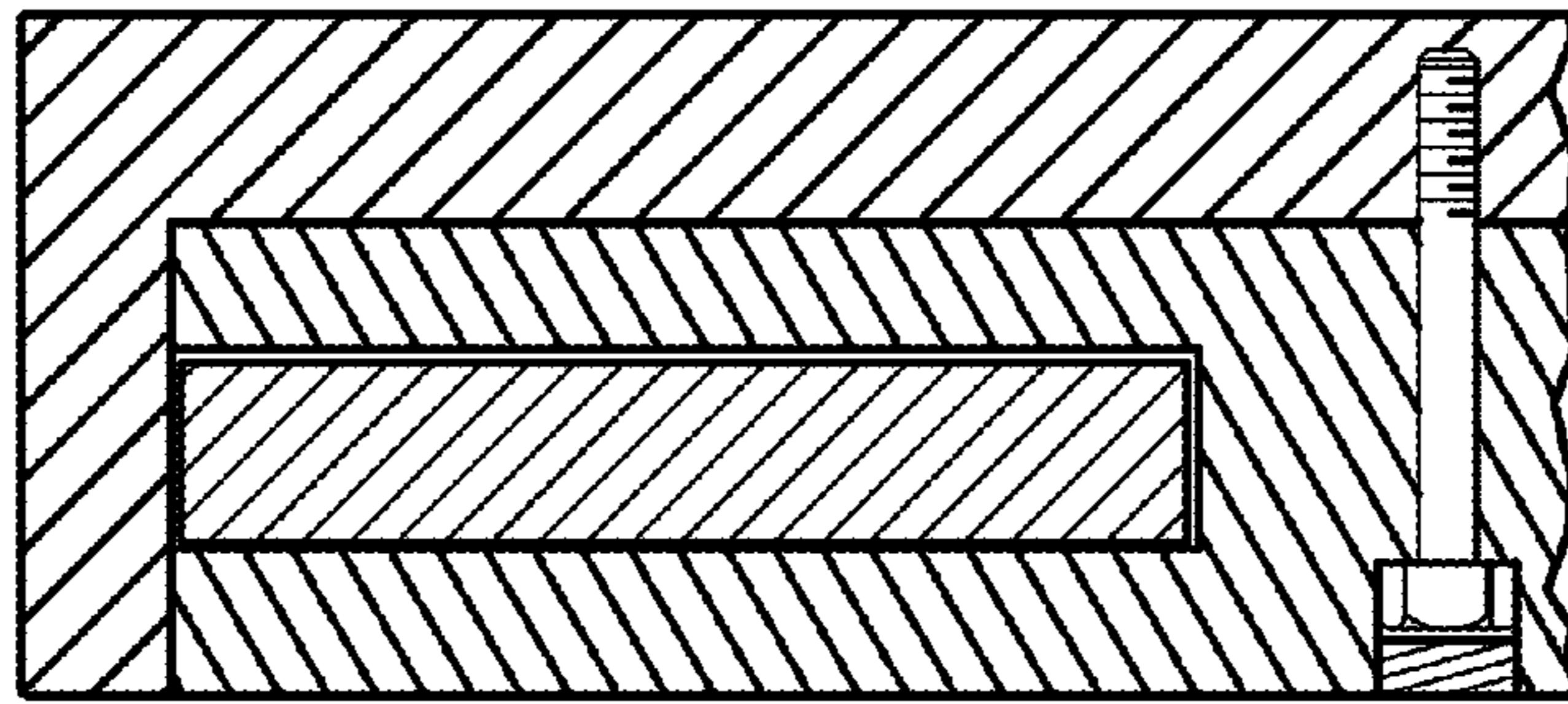
