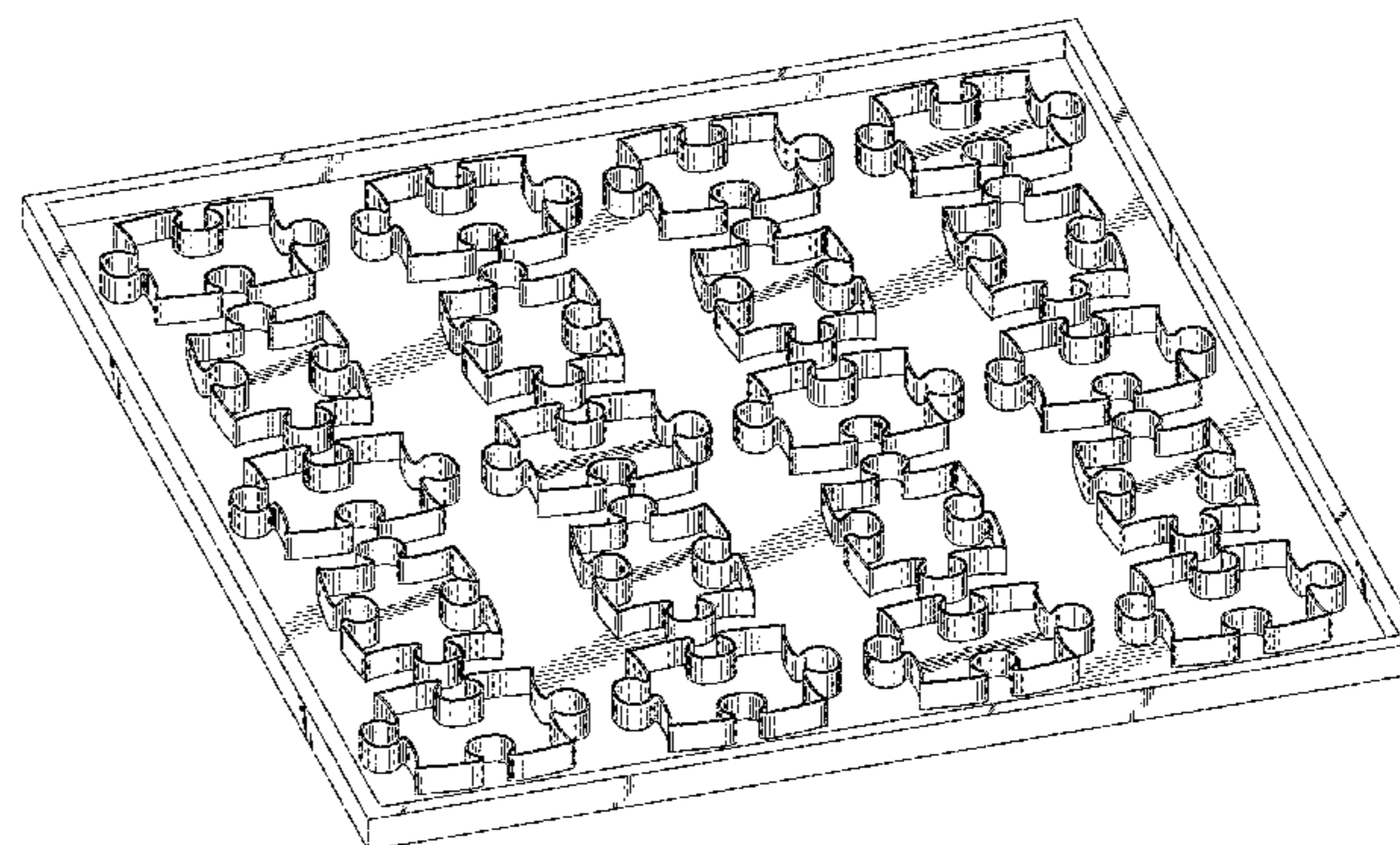
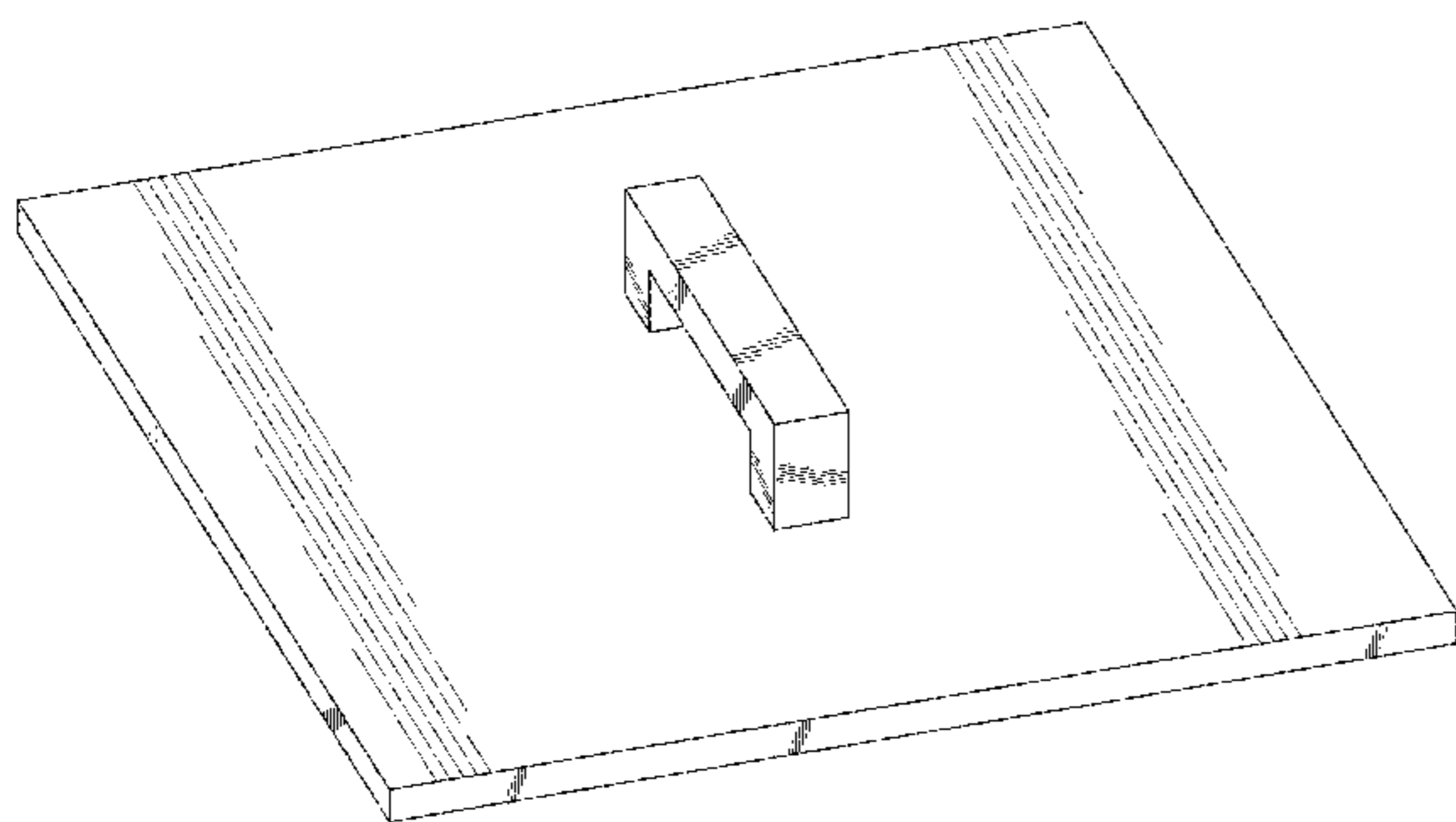
(57) **CLAIM**

The ornamental design for a puzzle shape cutter, as shown and described.

**DESCRIPTION**

FIG. 1 is an isometric top view of the puzzle shape cutter showing my new design;  
FIG. 2 is an isometric bottom view thereof;  
FIG. 3 is a front elevation view thereof, wherein the back side is a mirror image thereof;  
FIG. 4 is a left side elevation view thereof, wherein the right side is a mirror image thereof;  
FIG. 5 is a top plan view thereof; and,  
FIG. 6 is a bottom plan view thereof.

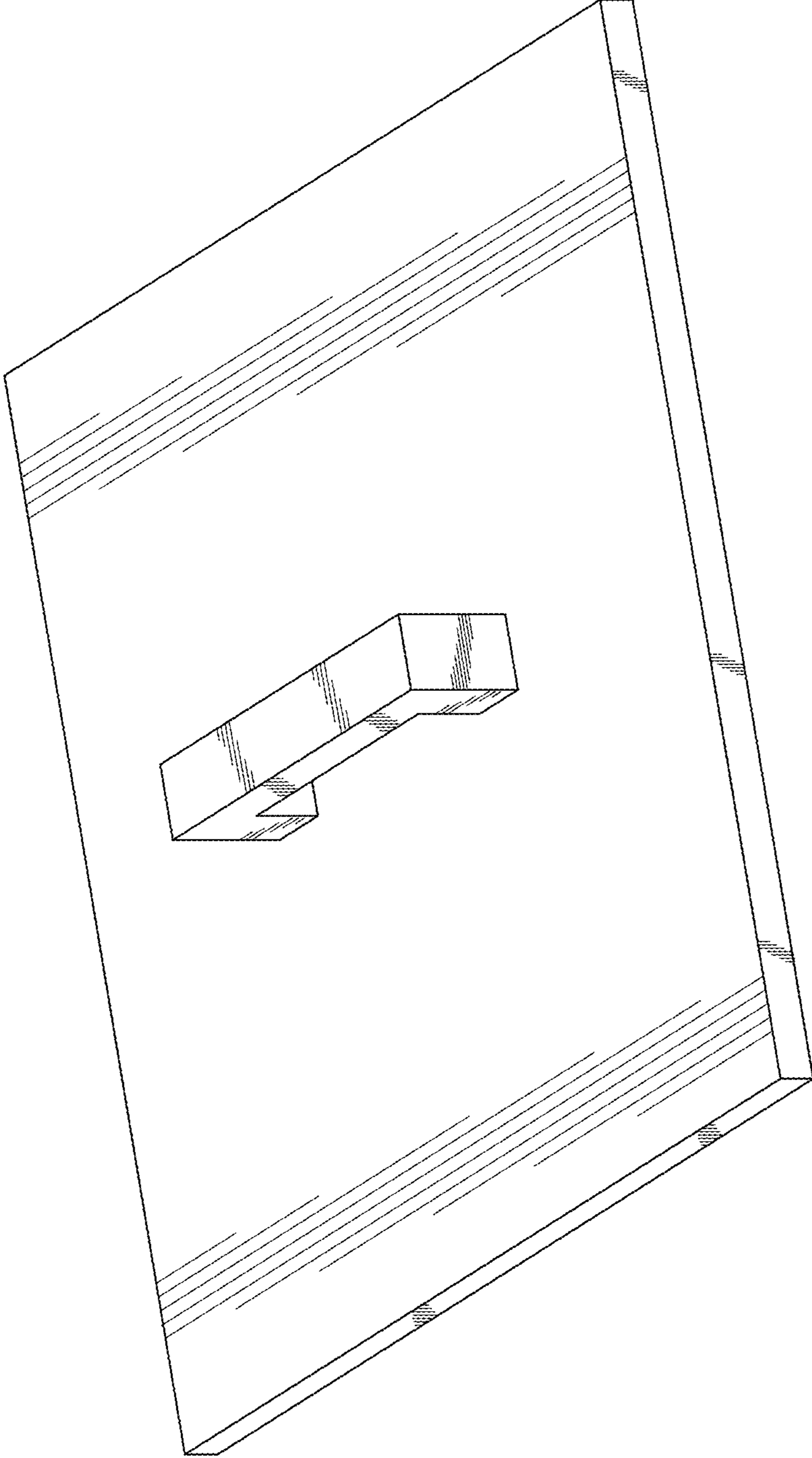

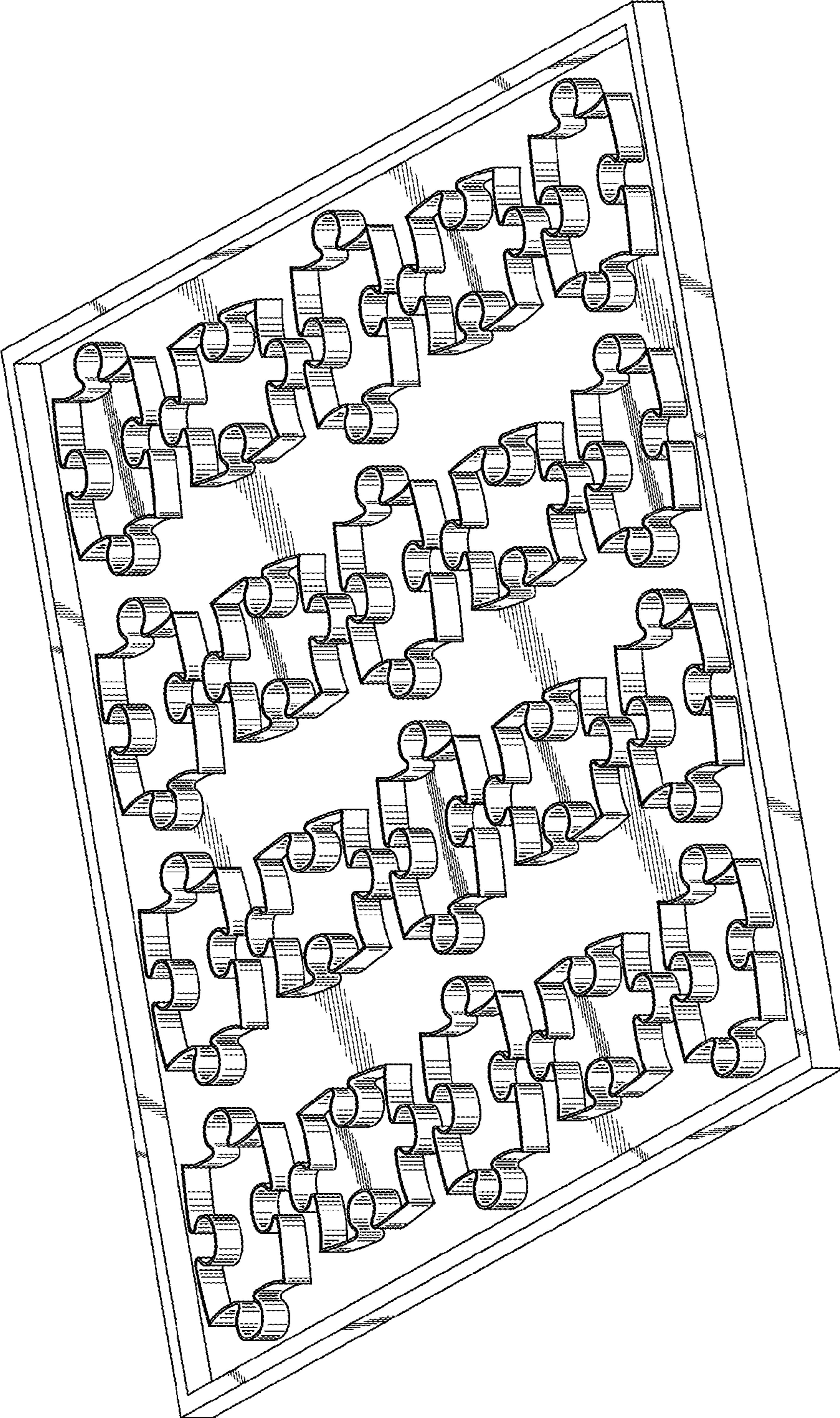

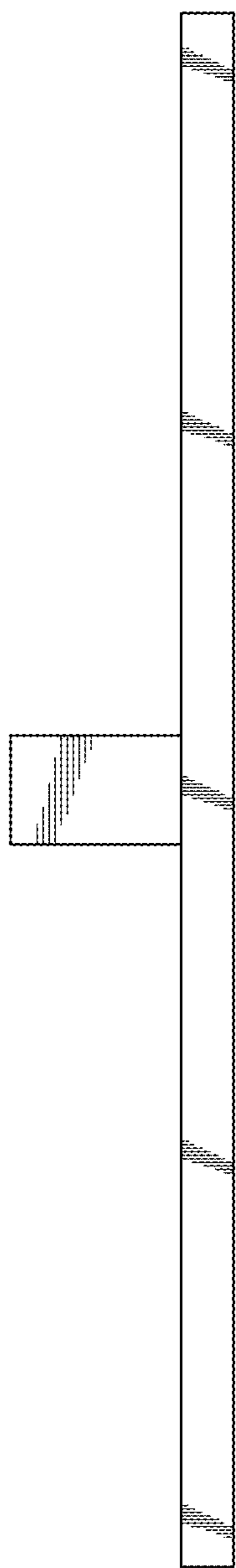

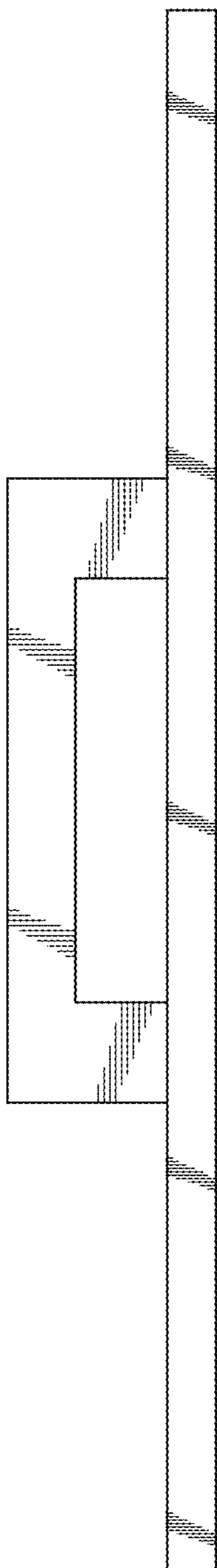

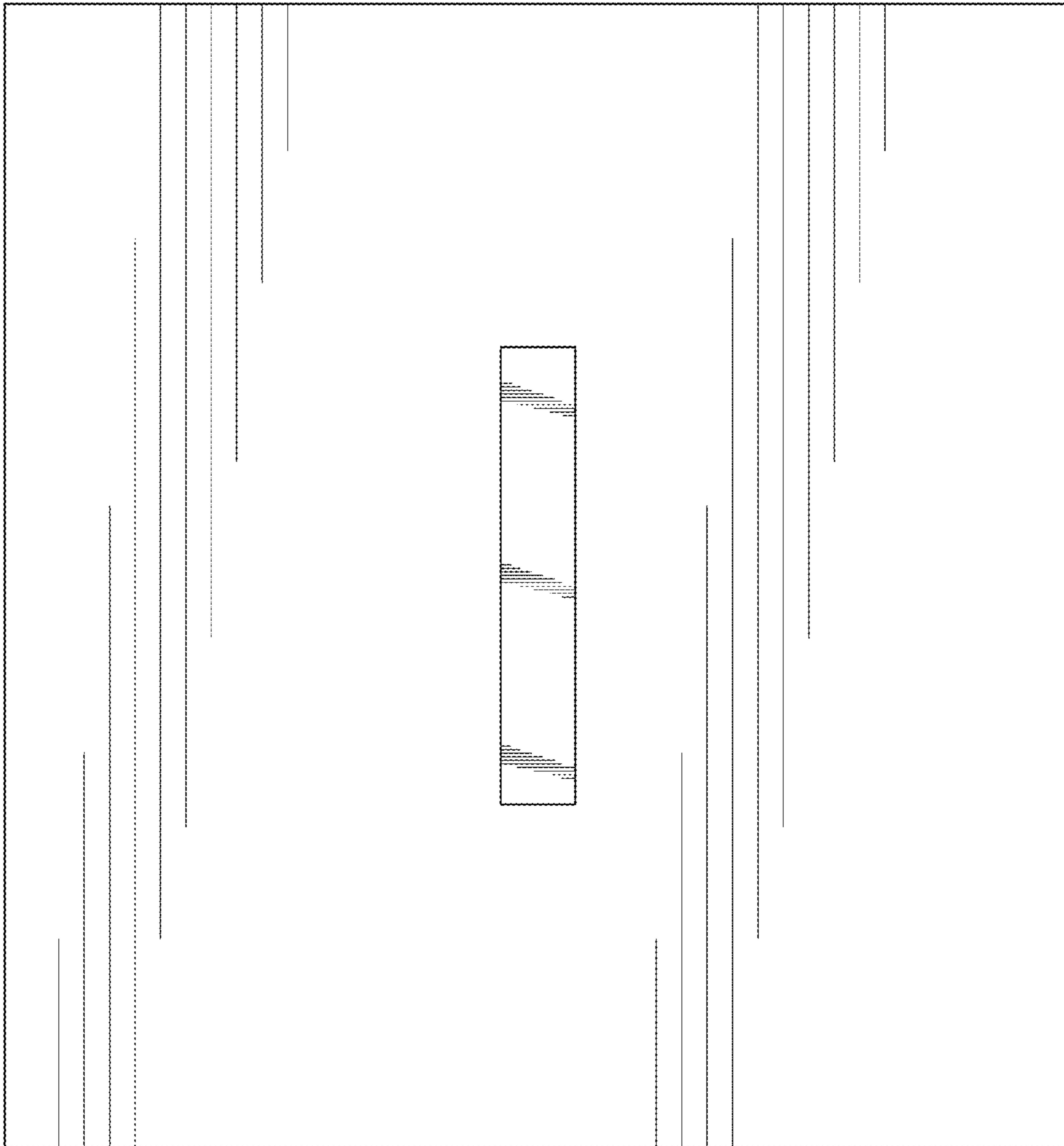

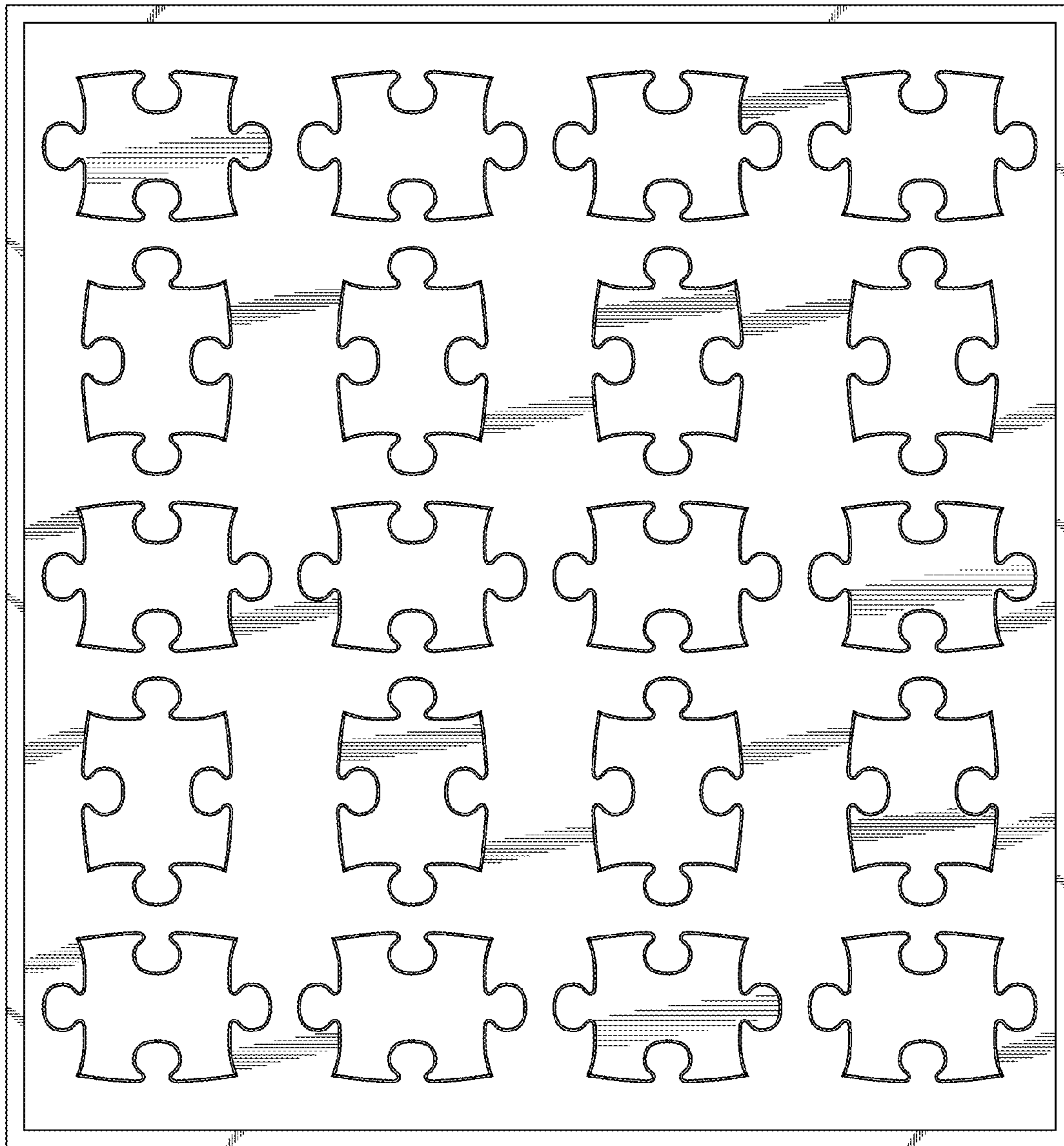
