(57) **CLAIM**

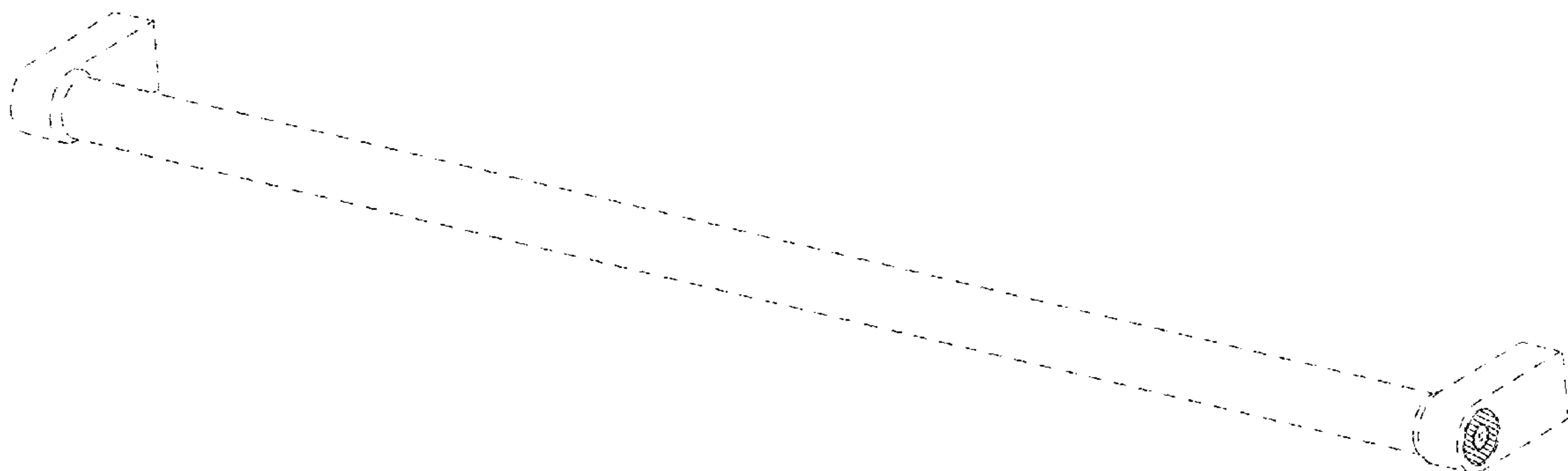
The ornamental design for a colored medallion, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a colored medallion, which is illustrated in an exemplary location of a handle;
 FIG. 2 is a perspective view of the colored medallion, which is illustrated in an exemplary location of a knob;
 FIG. 3 is a front perspective view of the colored medallion;
 FIG. 4 is a front elevational view of the colored medallion of FIG. 3; and,
 FIG. 5 is a side elevational view of the colored medallion of FIG. 3.

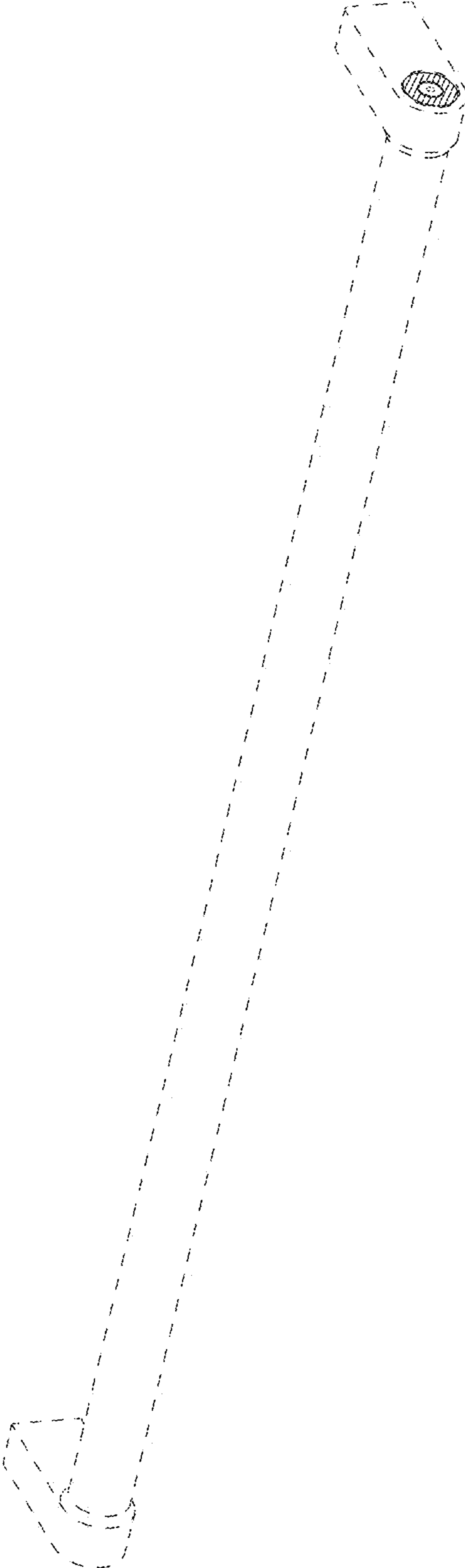

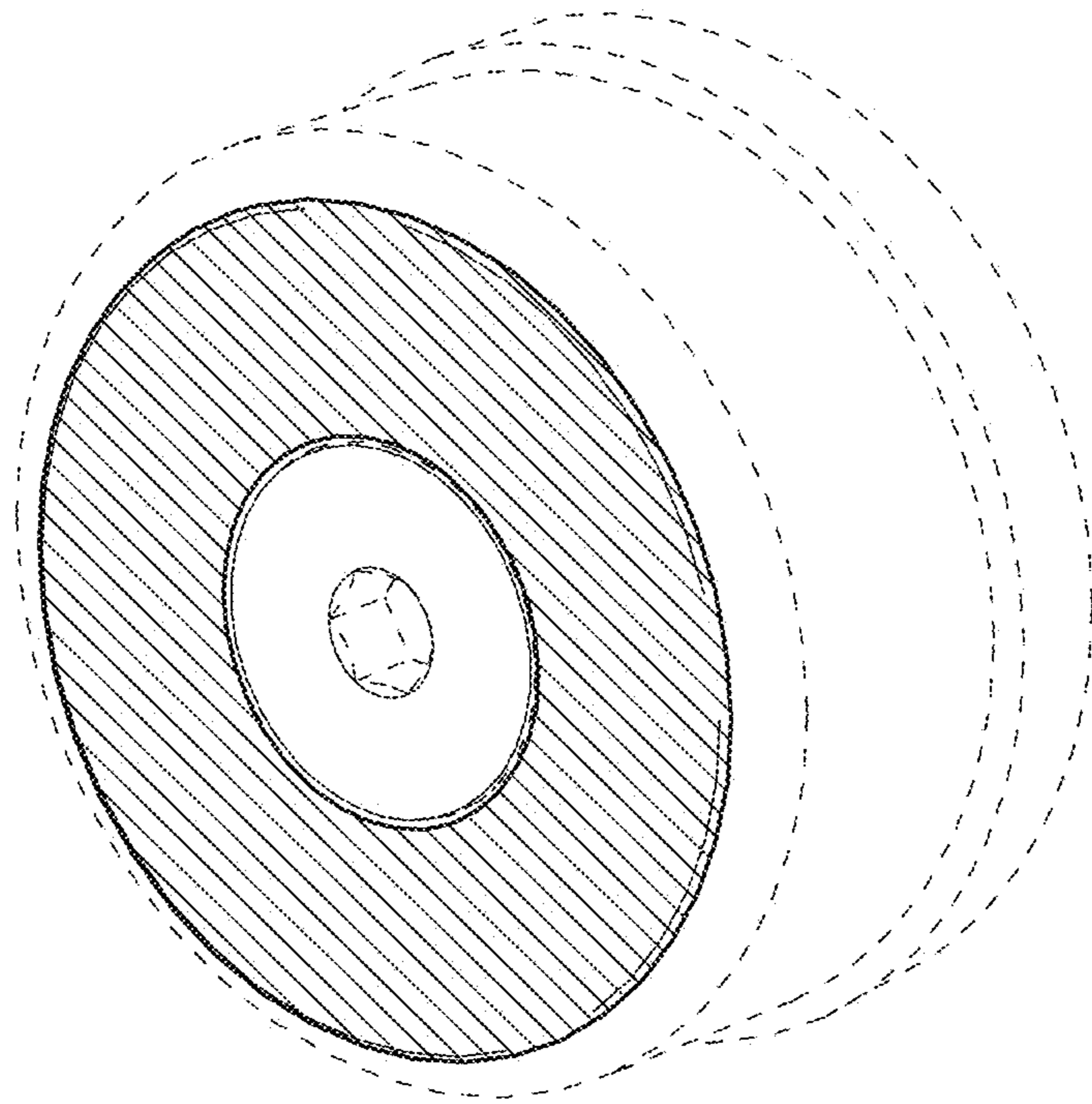

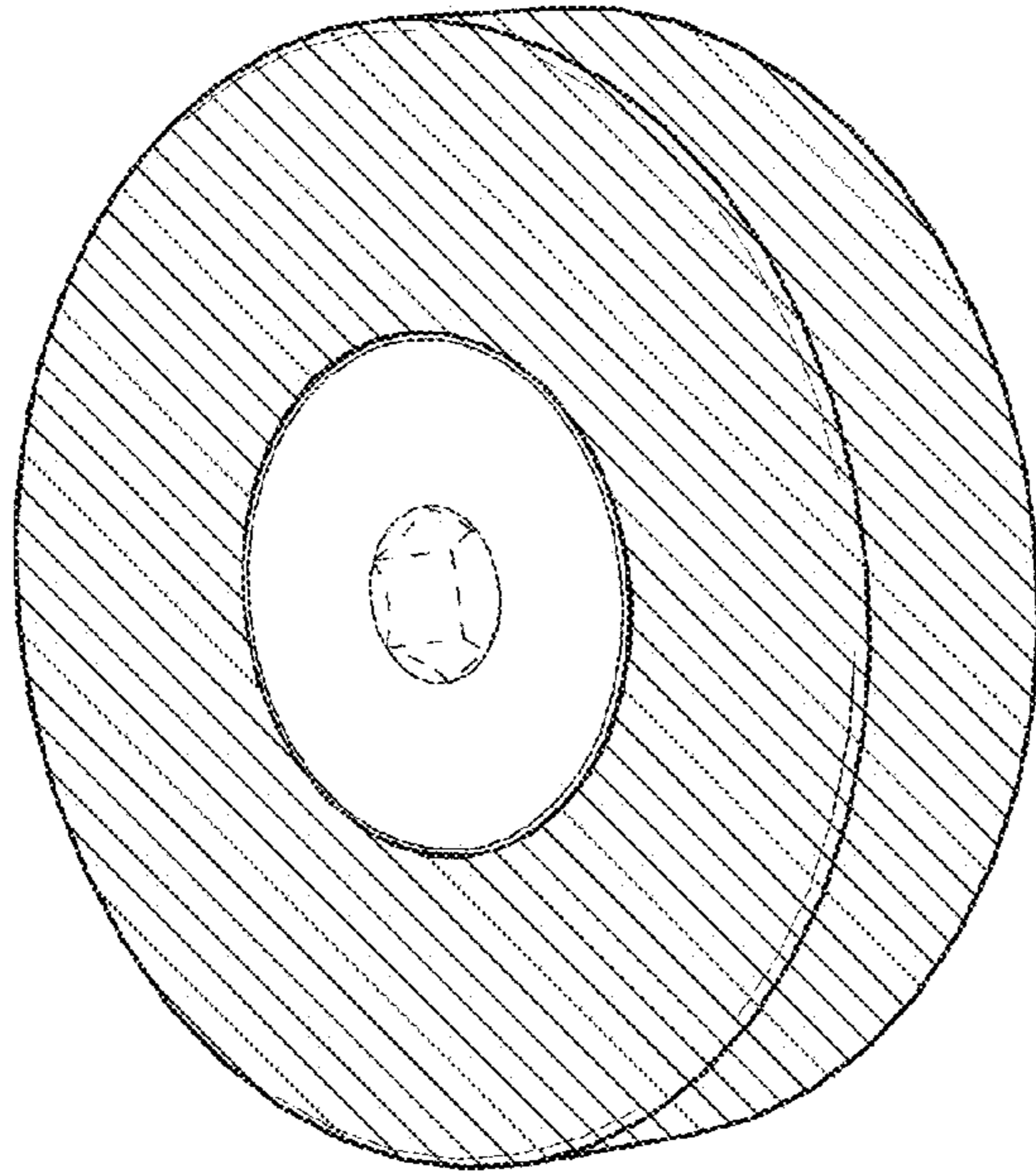

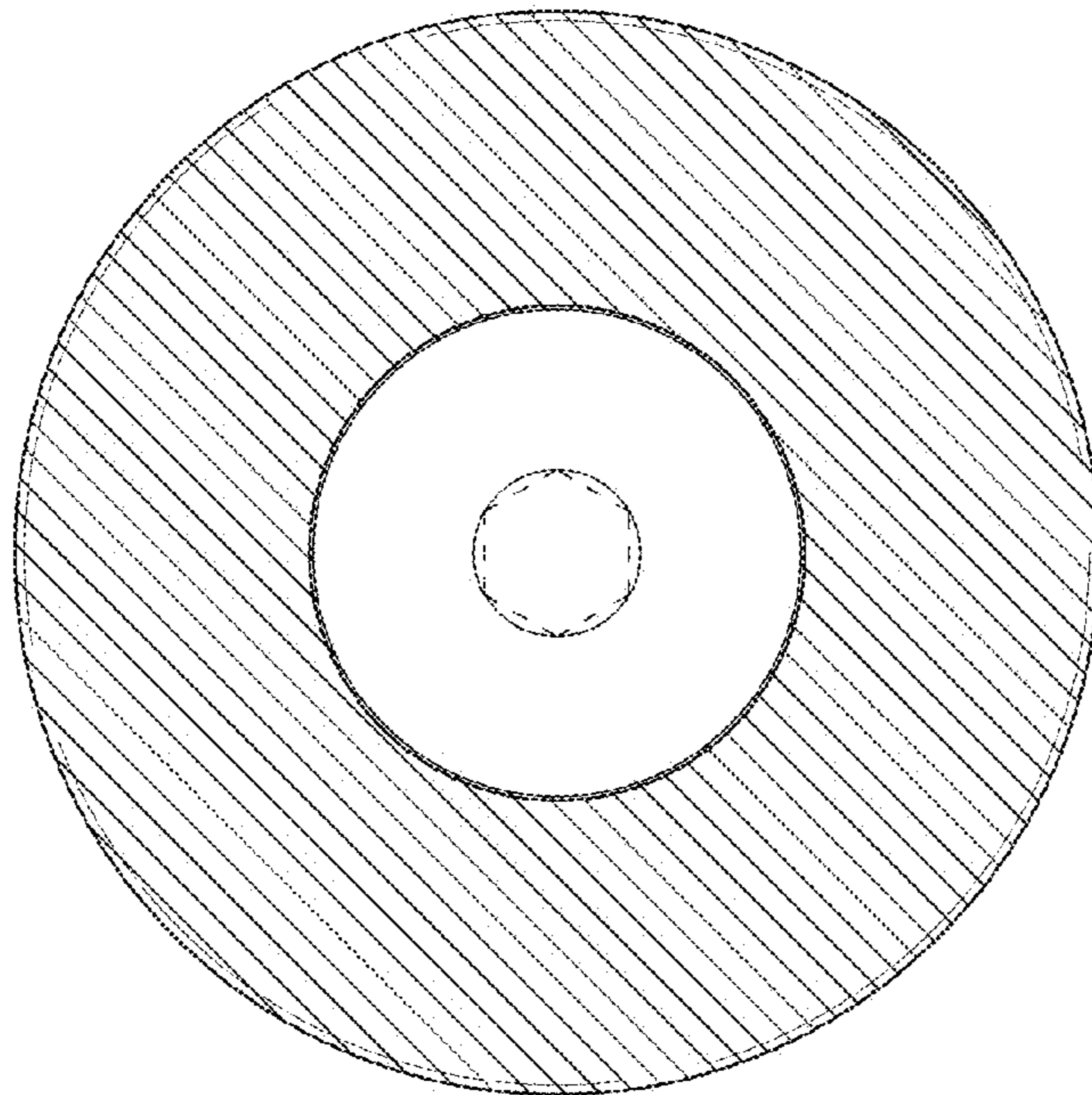

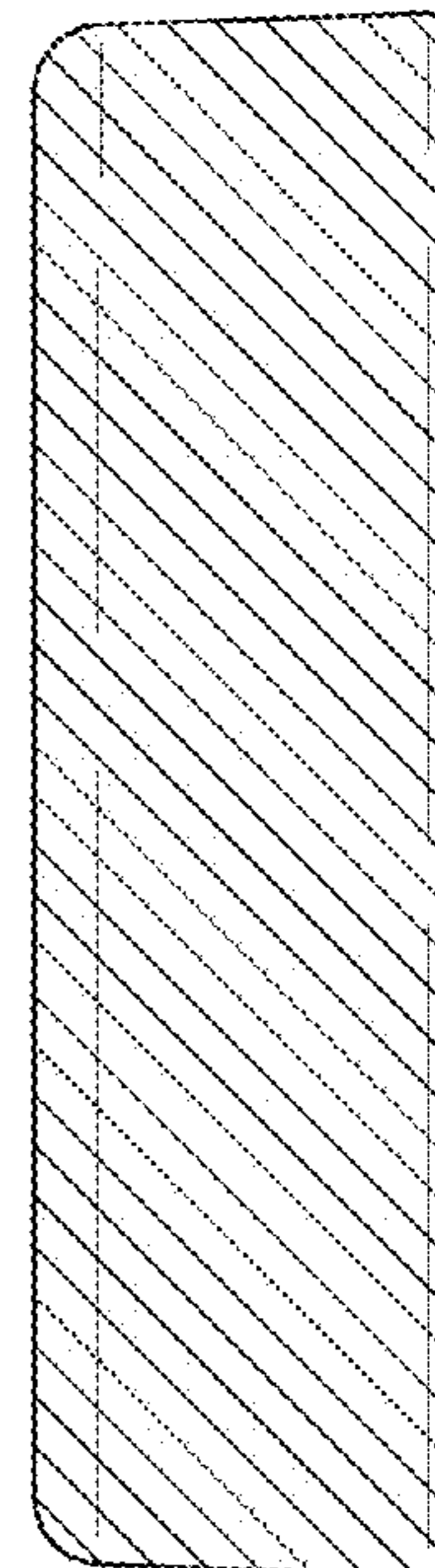
