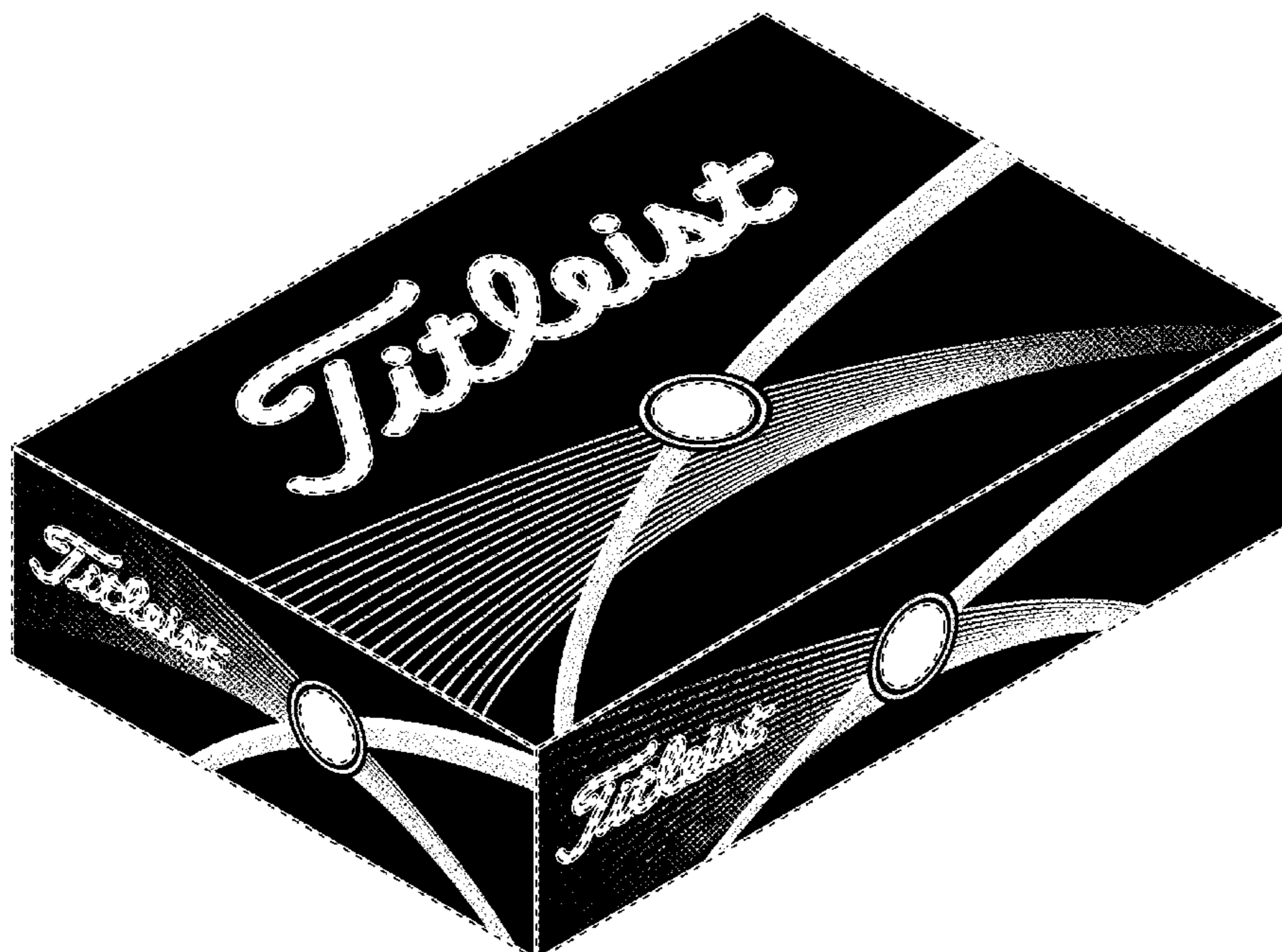
(57) **CLAIM**

The ornamental design for a golf ball package, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a new design for a golf ball package;
FIG. 2 is a left side view thereof;
FIG. 3 is a top view thereof; and,
FIG. 4 is a front side view thereof.
The portion of the golf ball package and text shown in phantom does not form any portion of the present invention. The right-side view of the golf ball package is depicted as shown in FIG. 2 and the back-side view of the golf ball package is depicted as shown in FIG. 4. The black area shown in FIGS. 1-4 depict a contrast in appearance.

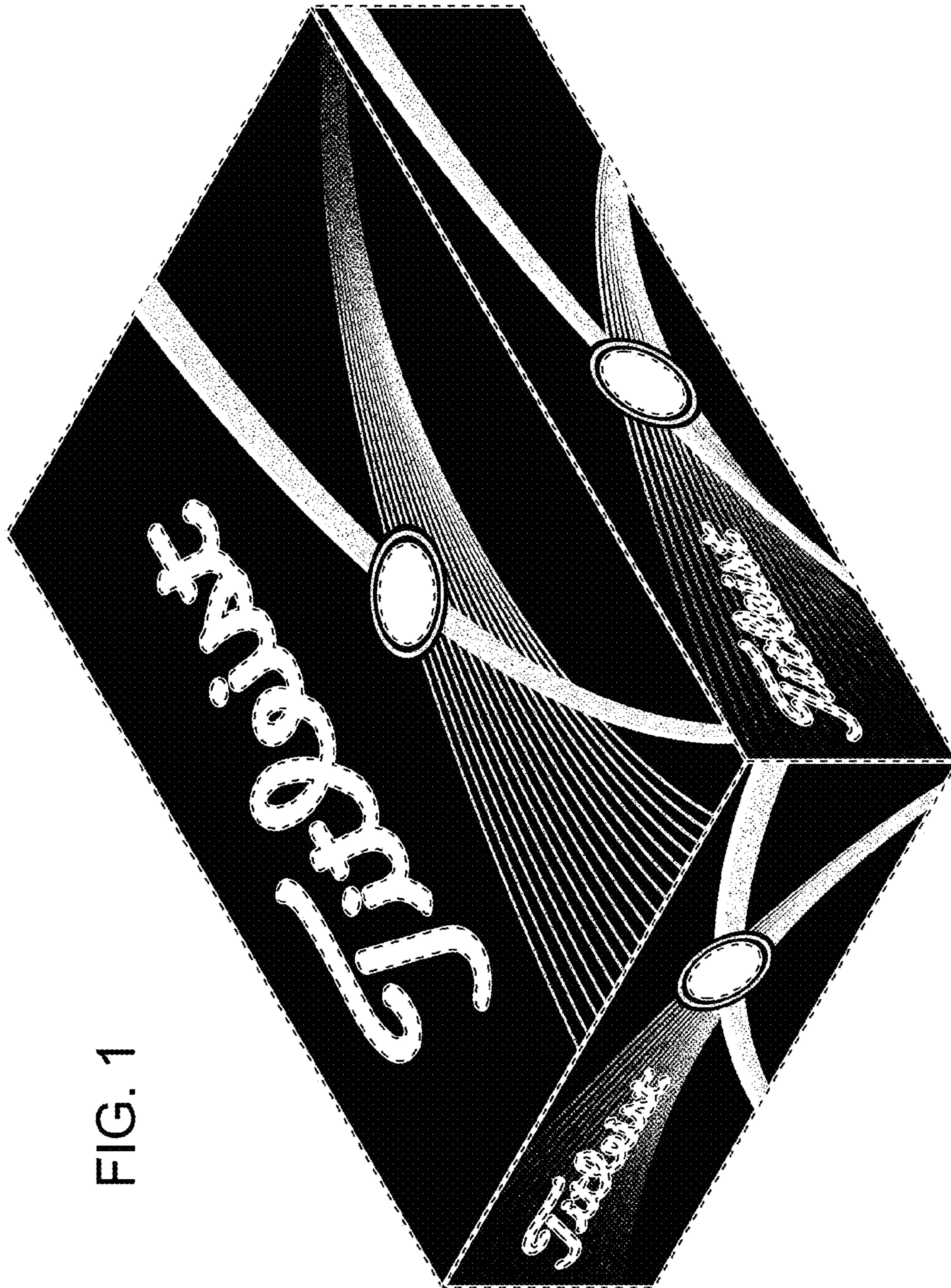

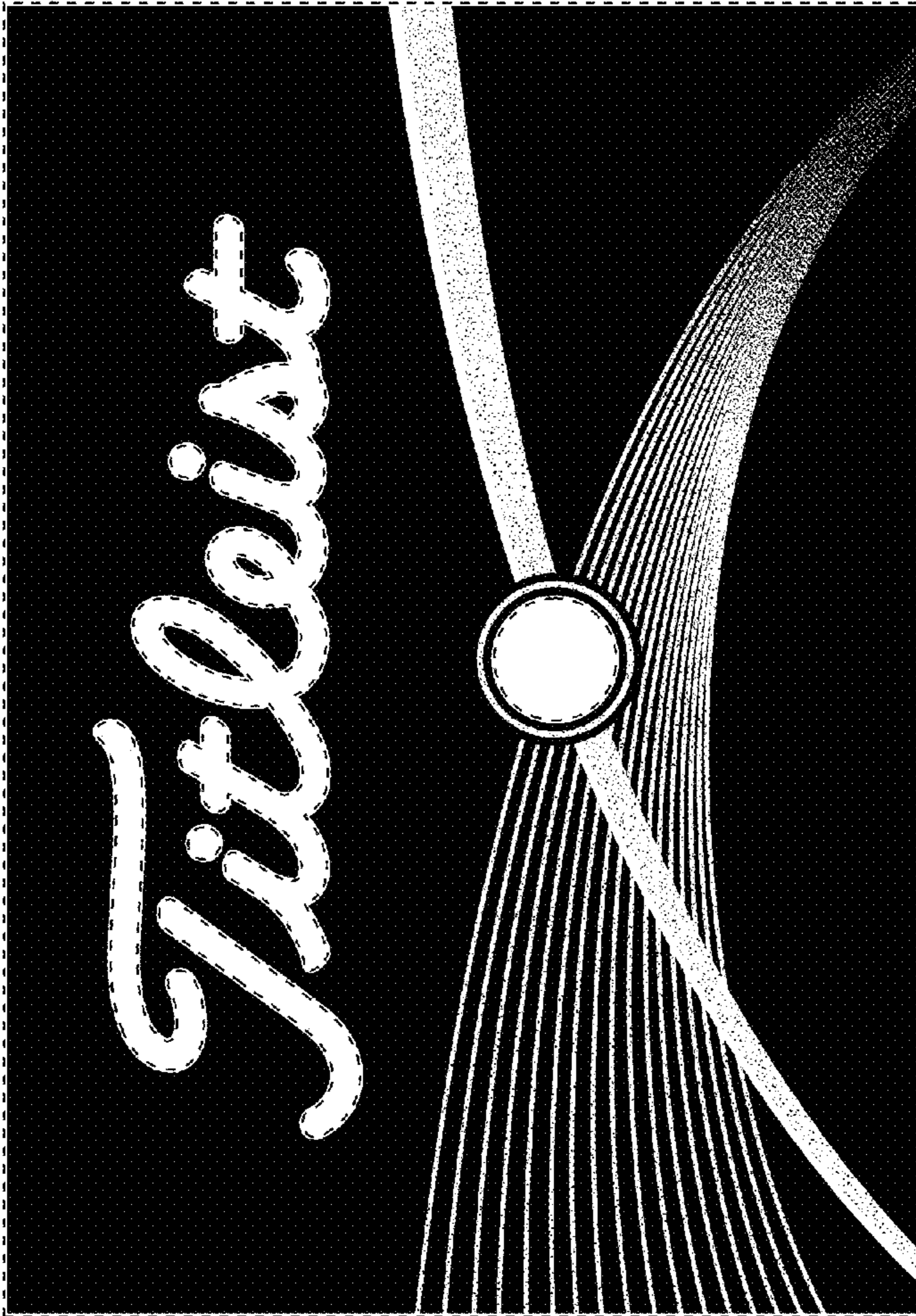

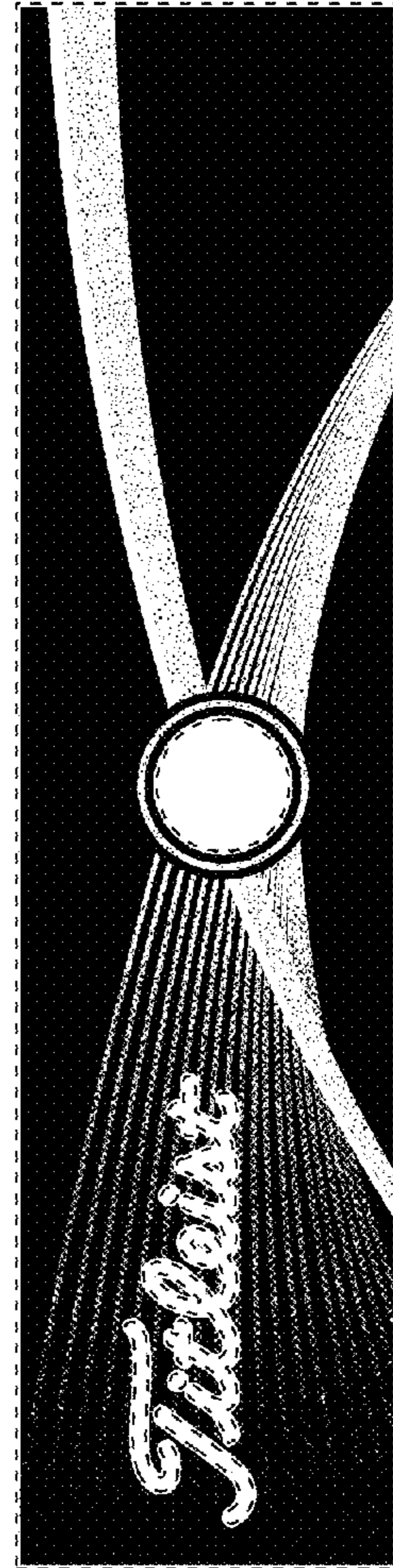

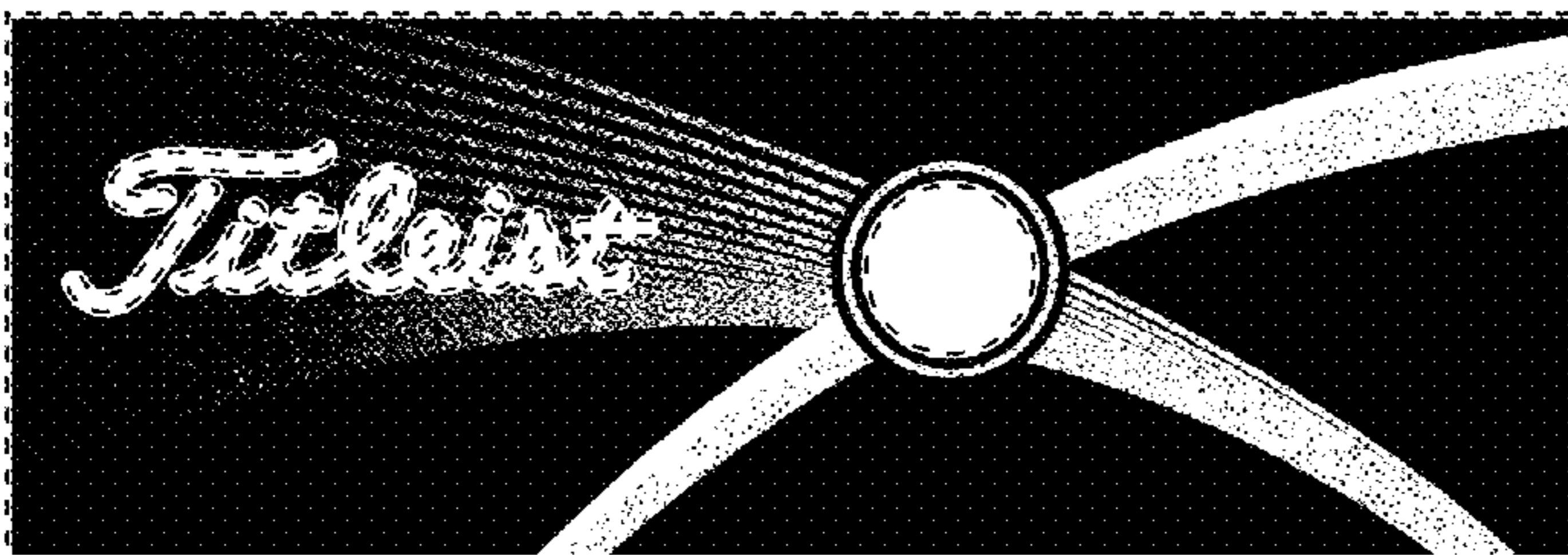
