DESCRIPTION

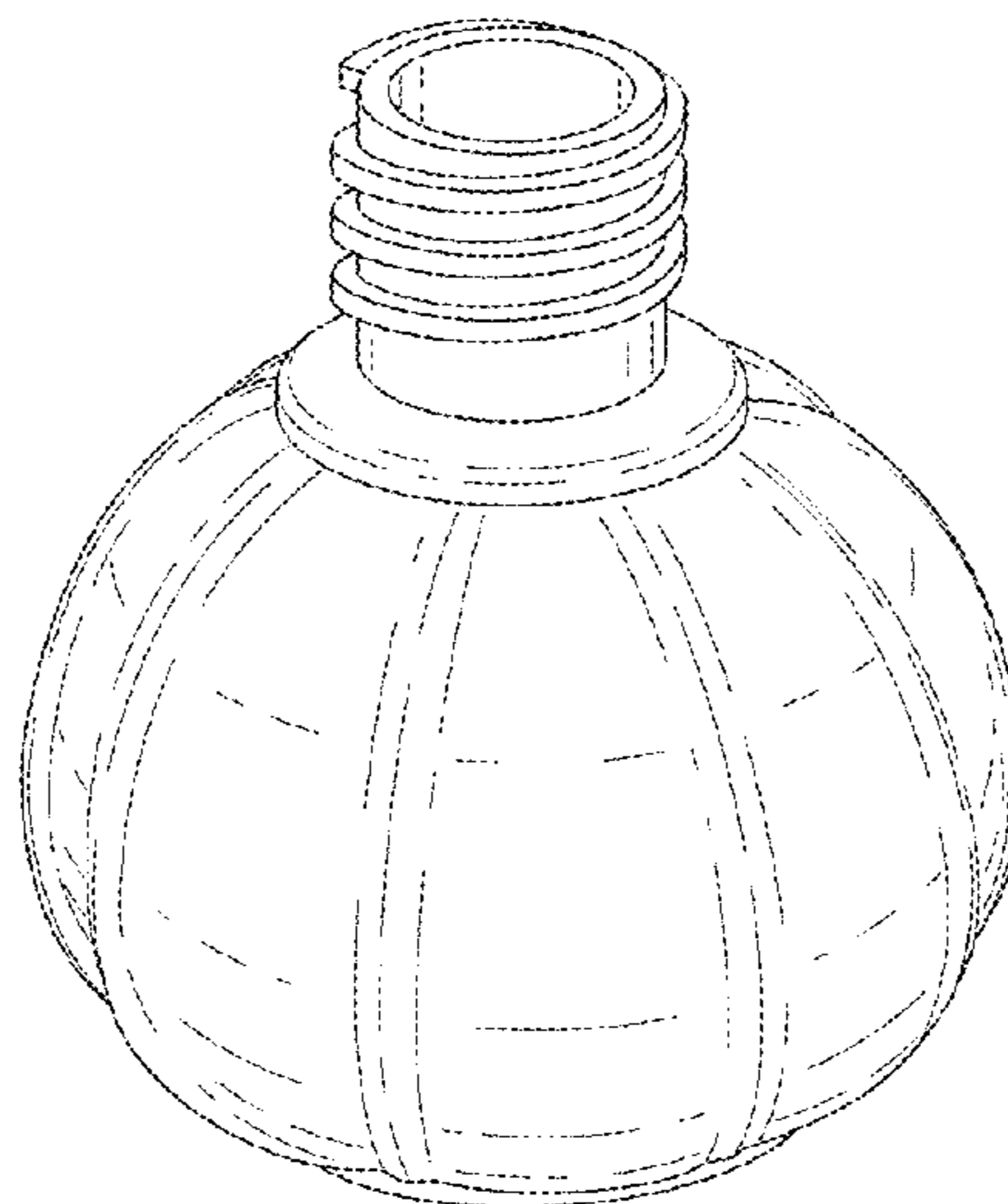
FIG. 1 is a perspective view of a pumpkin-shaped bottle, showing my new design;

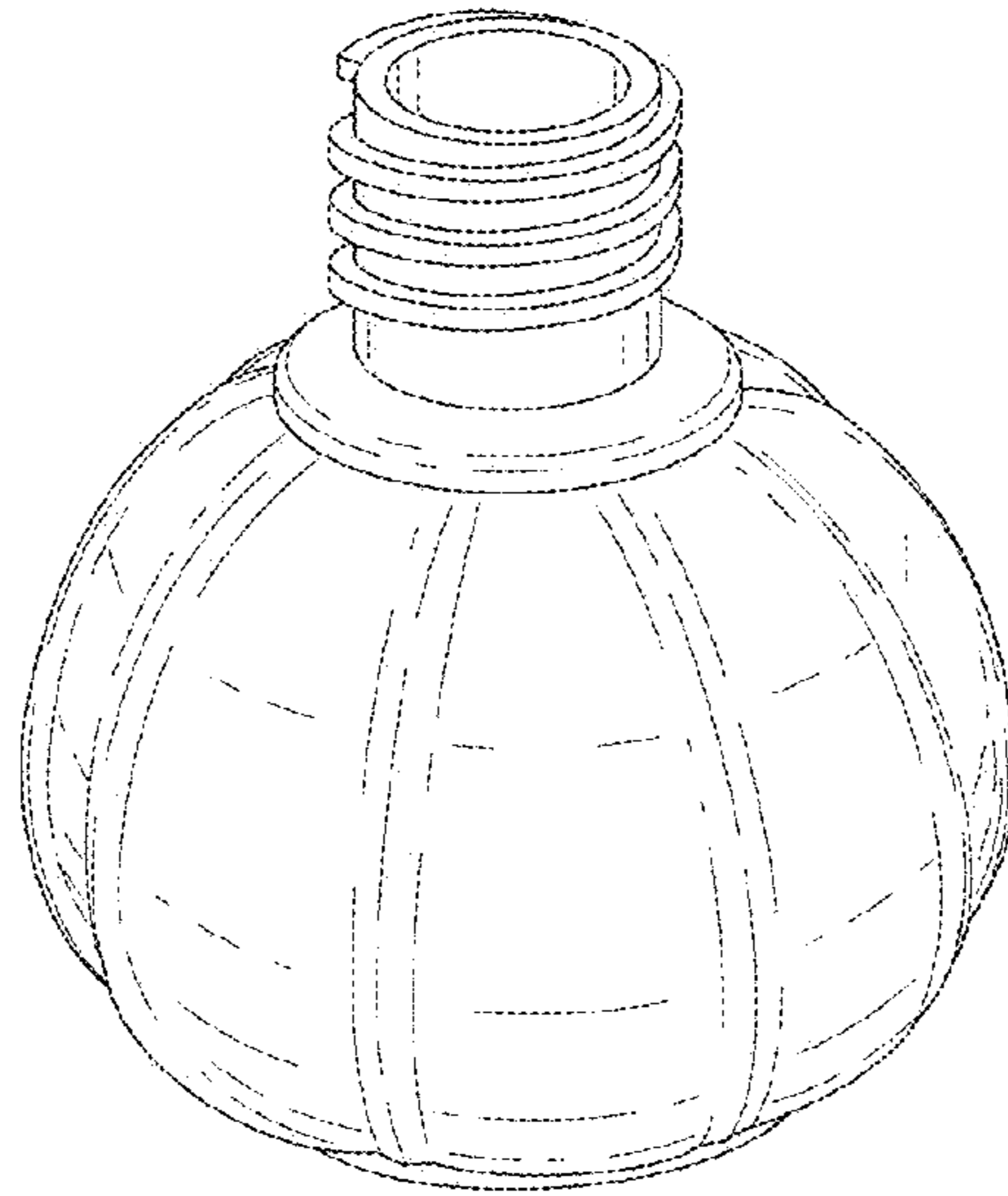

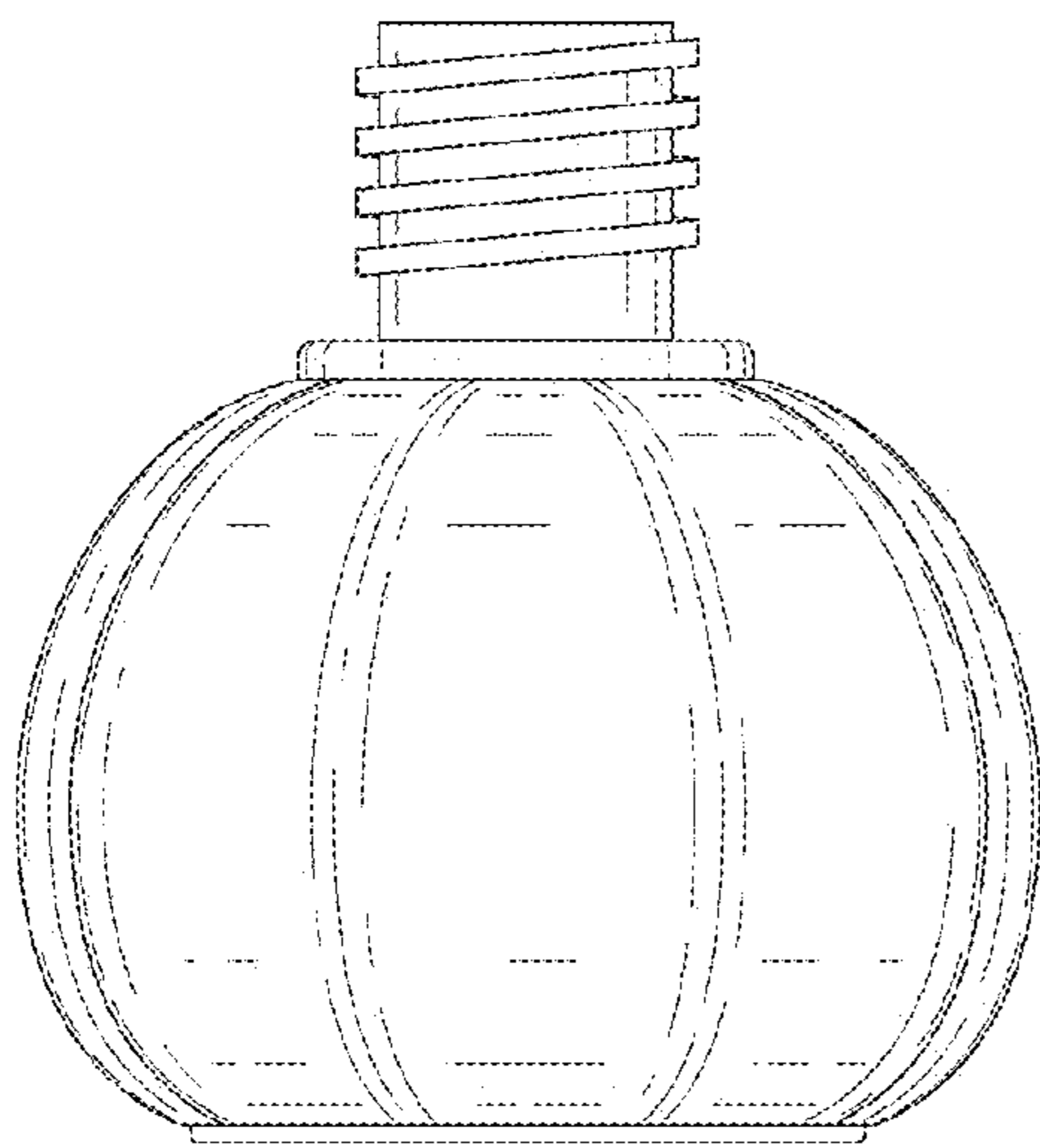

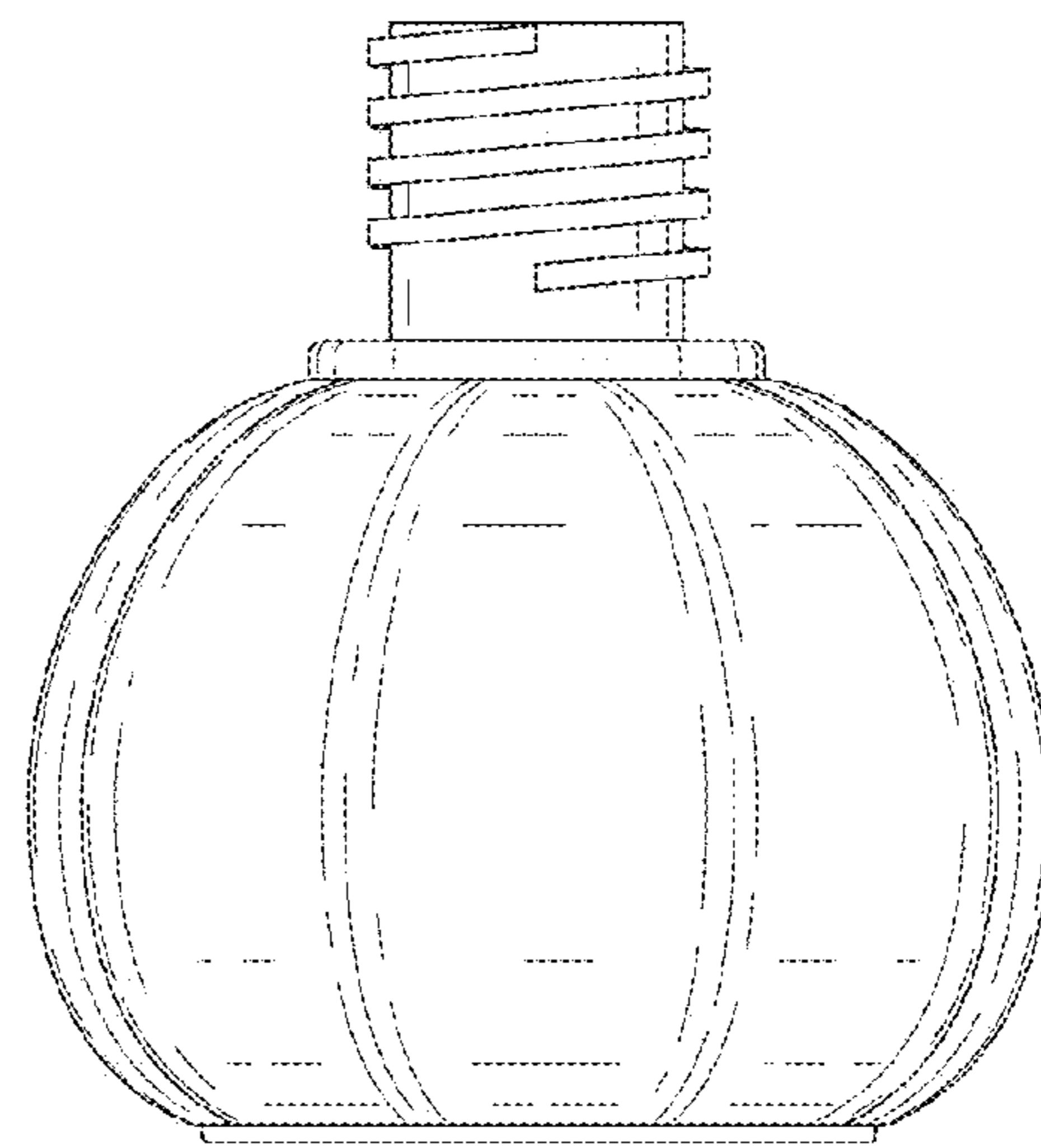

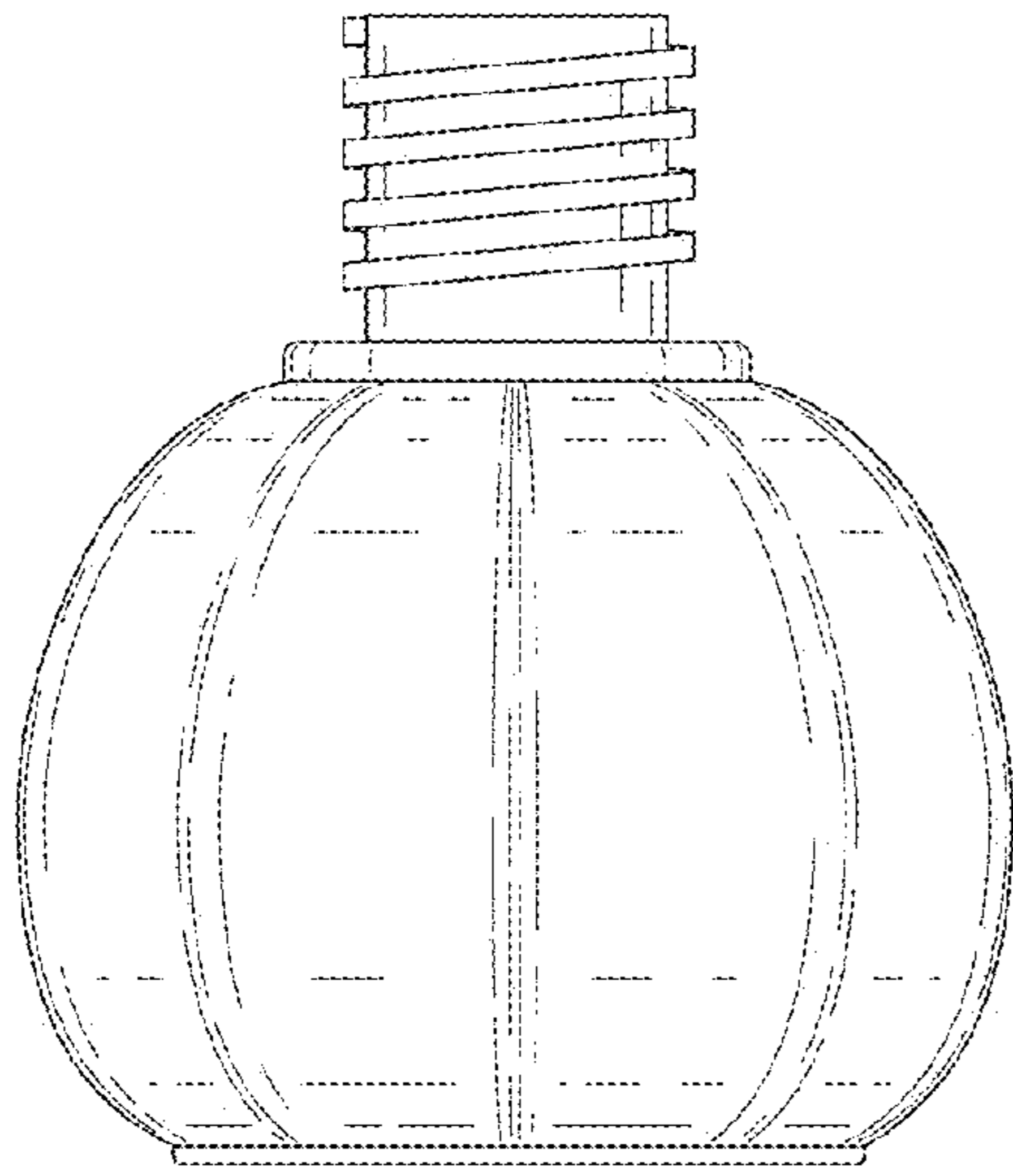

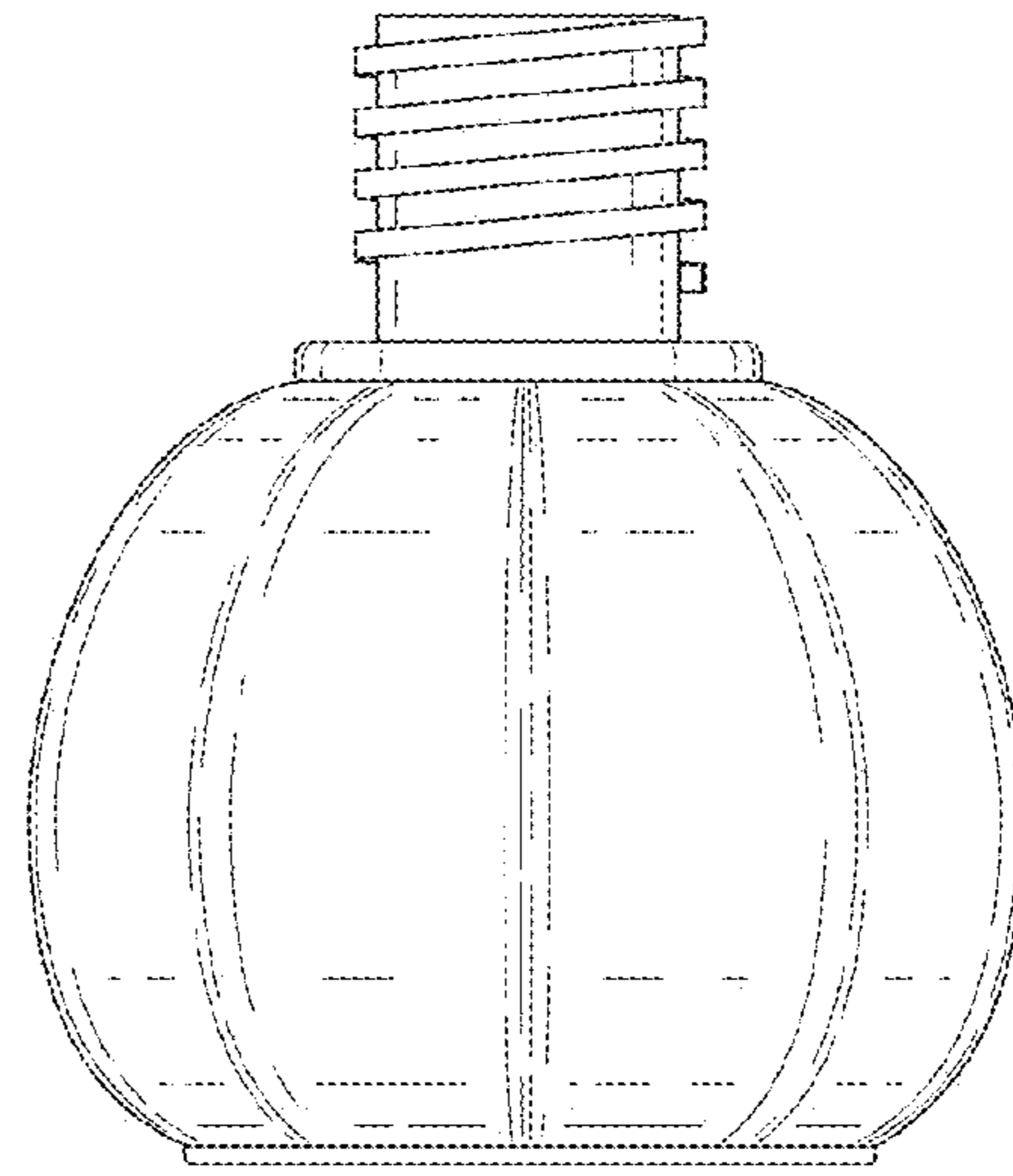

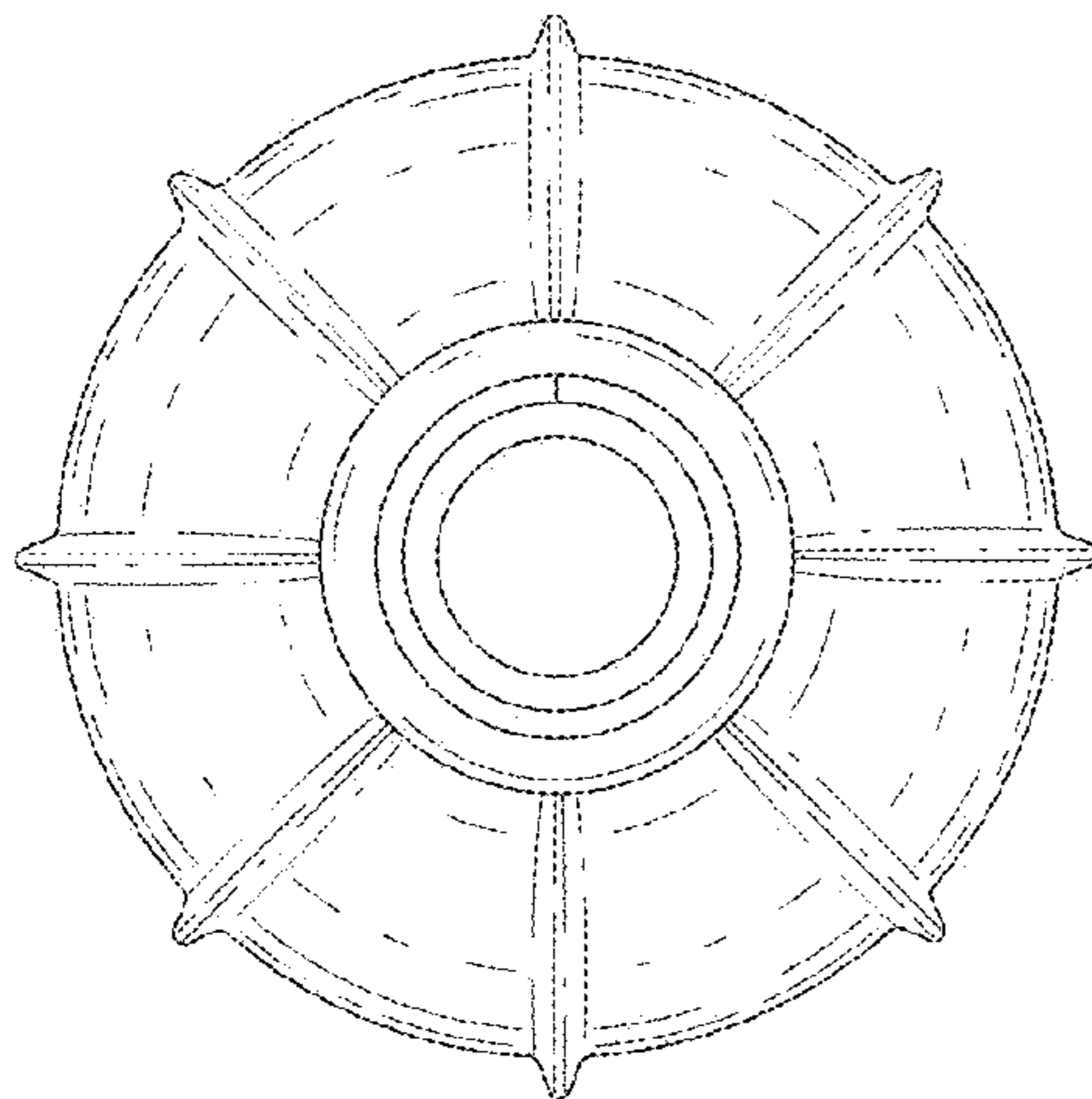

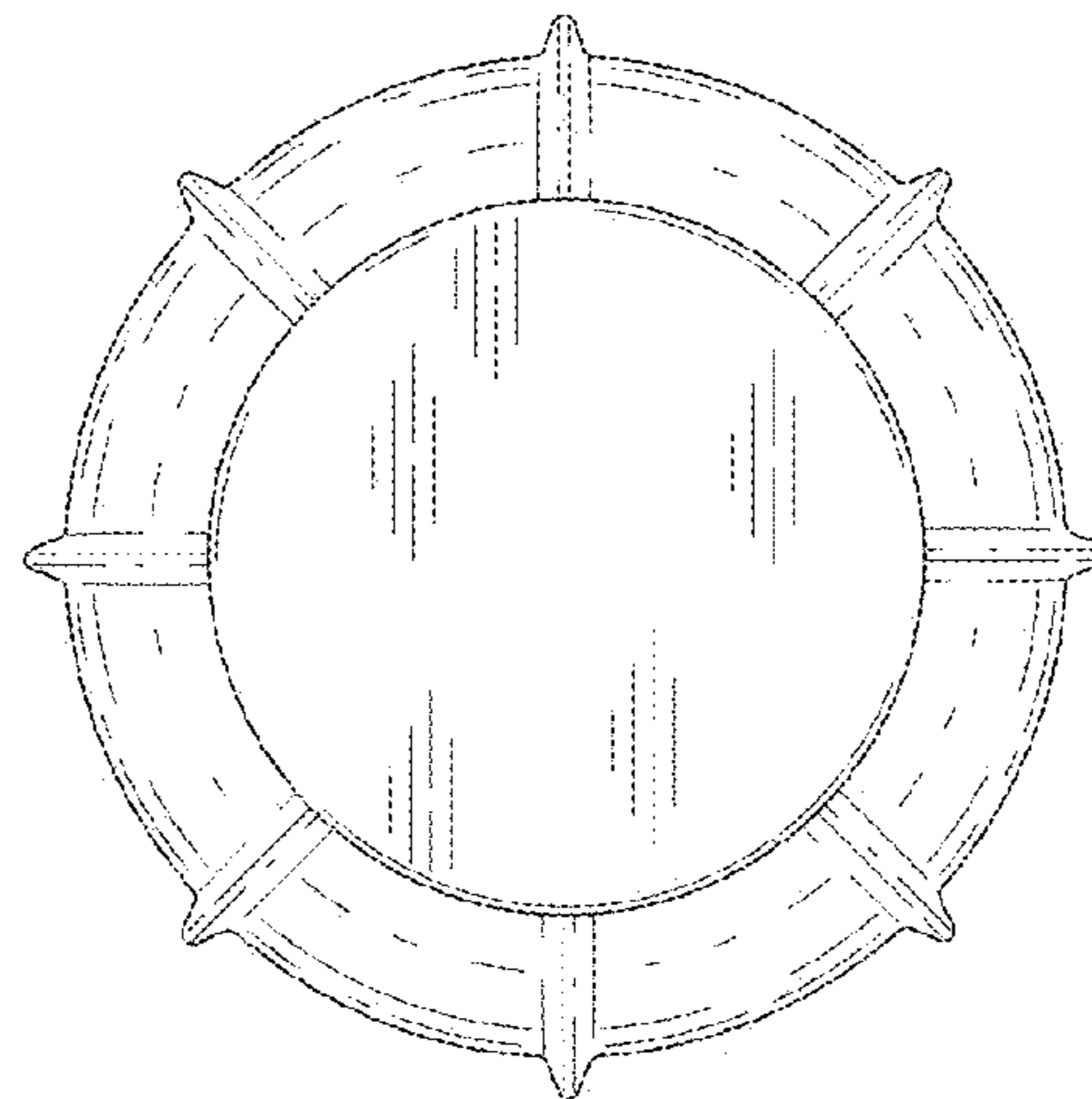
