FIG. 1 is a top plan view of a first embodiment;

 FIG. 6 is a right side view of the third embodiment, which has a textured region, and which is identical to the left side view and to the front and back views of the third embodiment;
 FIG. 7 is a bottom plan view front of the third embodiment;
 FIG. 8 is a right side view of a fourth embodiment, which has identical left, front, and back views, and which top and bottom plan views identical to those of the third embodiment;
 FIG. 9 is a top plan view of a fifth embodiment;
 FIG. 10 is a right side view of the fifth embodiment, which has identical left, front, and back views;
 FIG. 11 is a right side view of a sixth embodiment, which has identical left, front, and back views, and which has top and bottom views identical to those of the fifth embodiment;
 FIG. 12 is a top plan view of a seventh embodiment;
 FIG. 13 is a right side view of the seventh embodiment, which has identical left, front, and back views, and which has a bottom plan view that is flat and without detail;
 FIG. 14 is a top plan view of an eighth embodiment (orange);
 FIG. 15 is a right side view of the eighth embodiment, which has identical left, front, and back views, and which has a bottom plan view that is flat and without detail;
 FIG. 16 is a top plan view of a ninth embodiment (yellow);

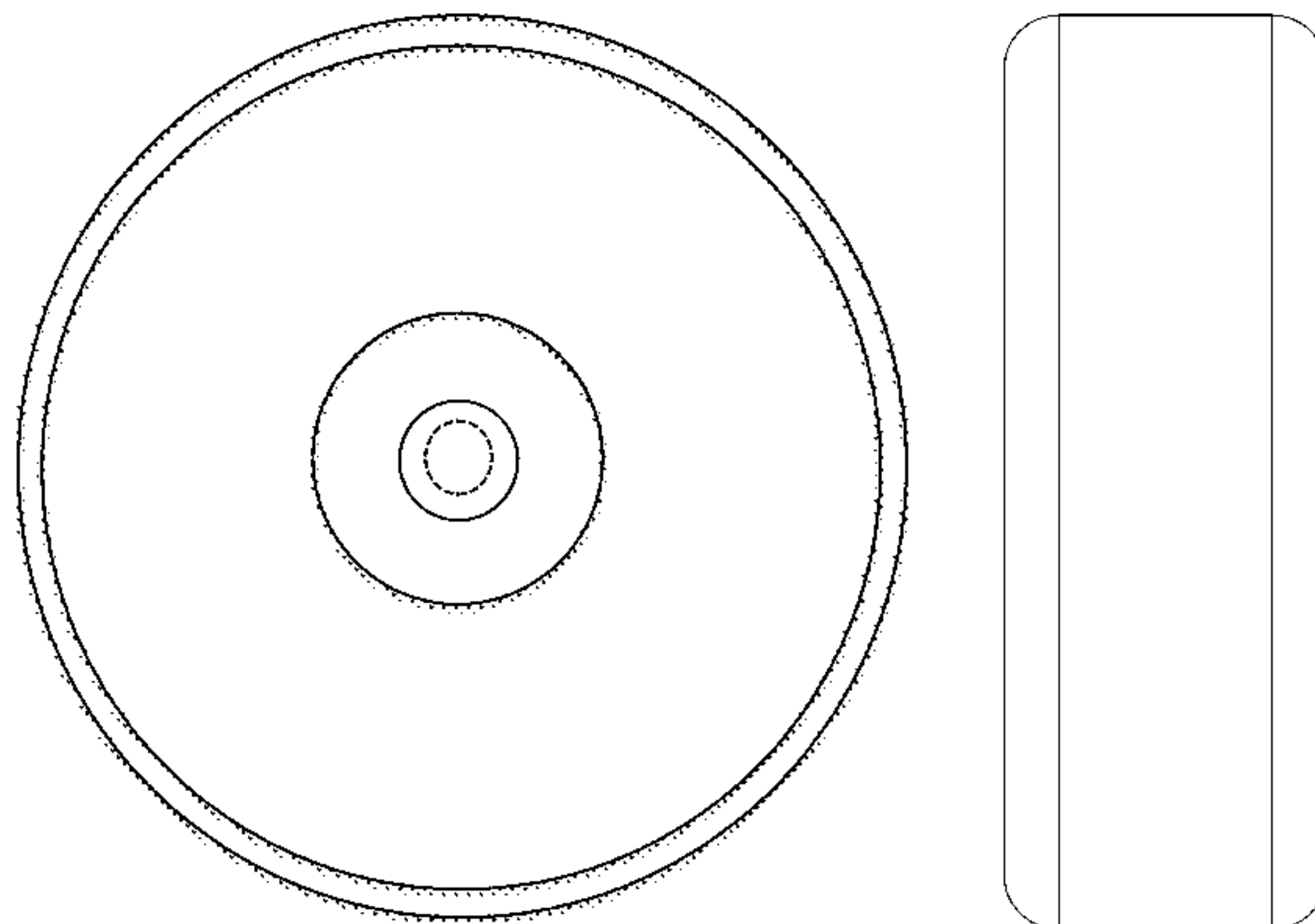


FIG. 17 is a right side view of the ninth embodiment, which has identical left, front, and back views, and which has a bottom plan view that is flat and without detail;

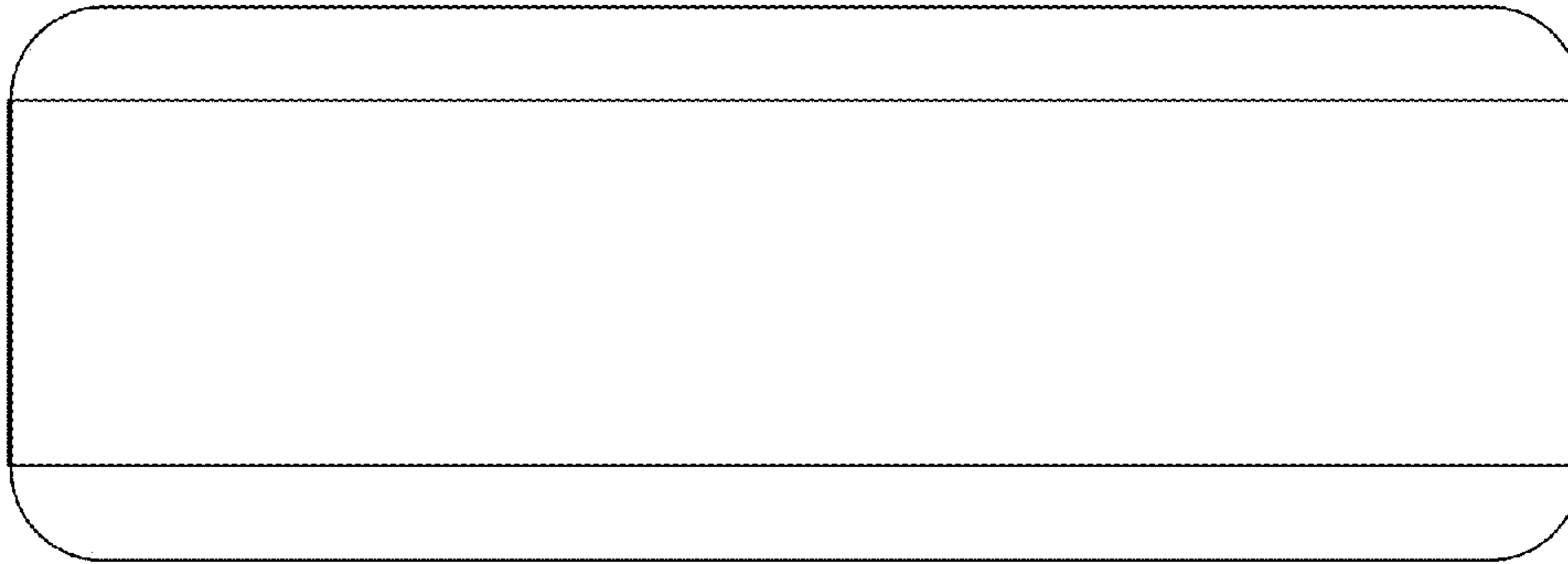

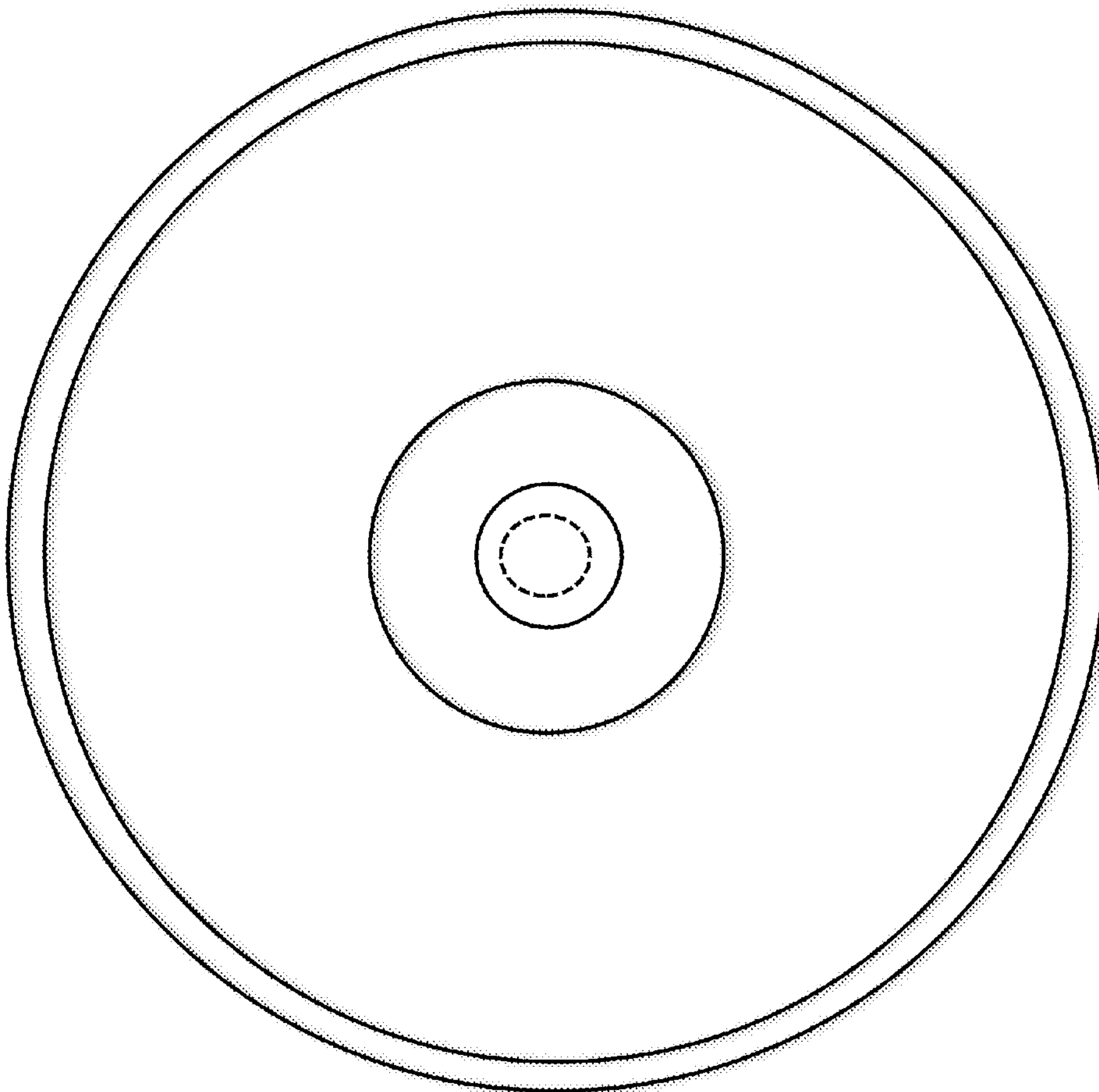

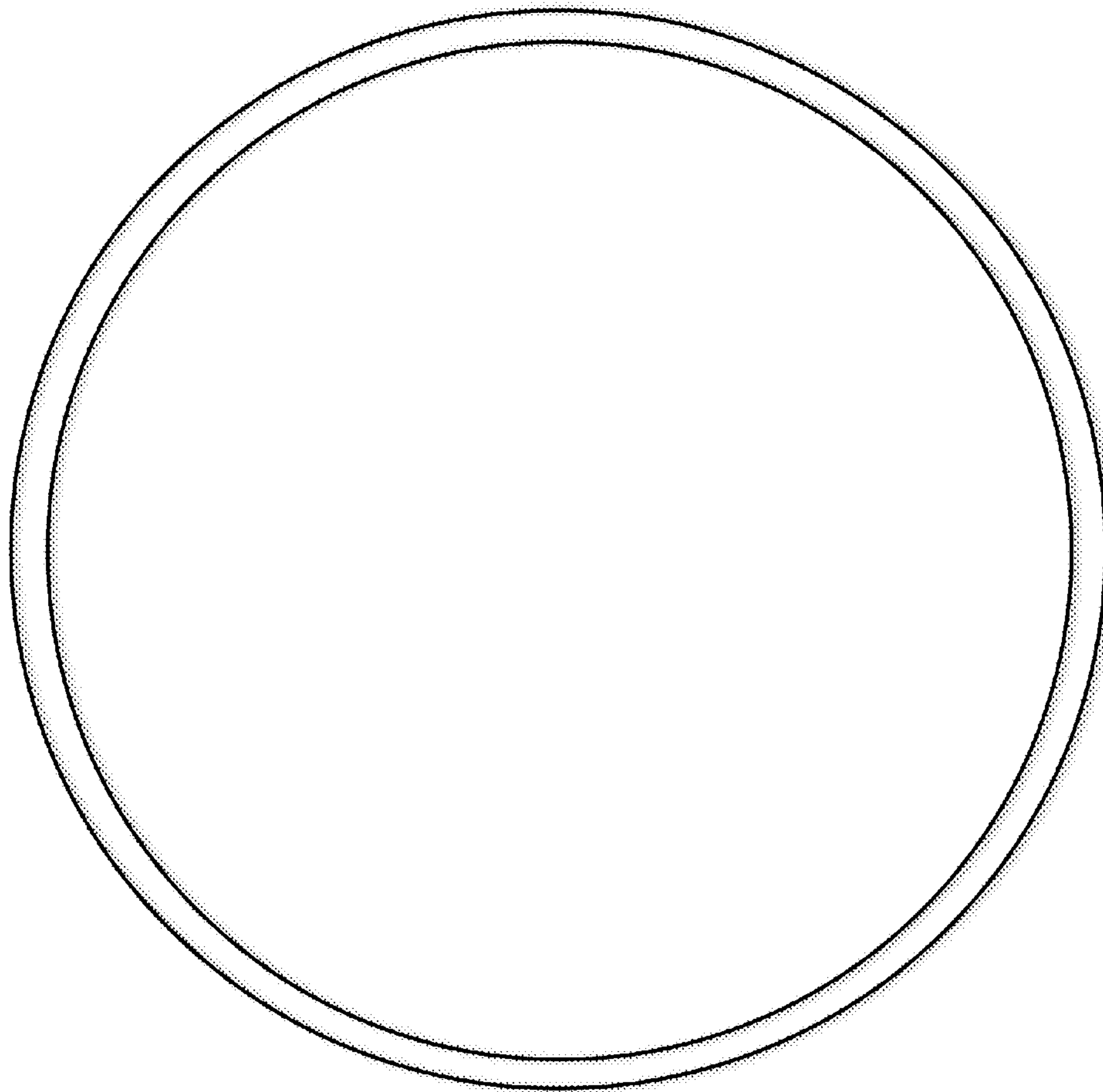

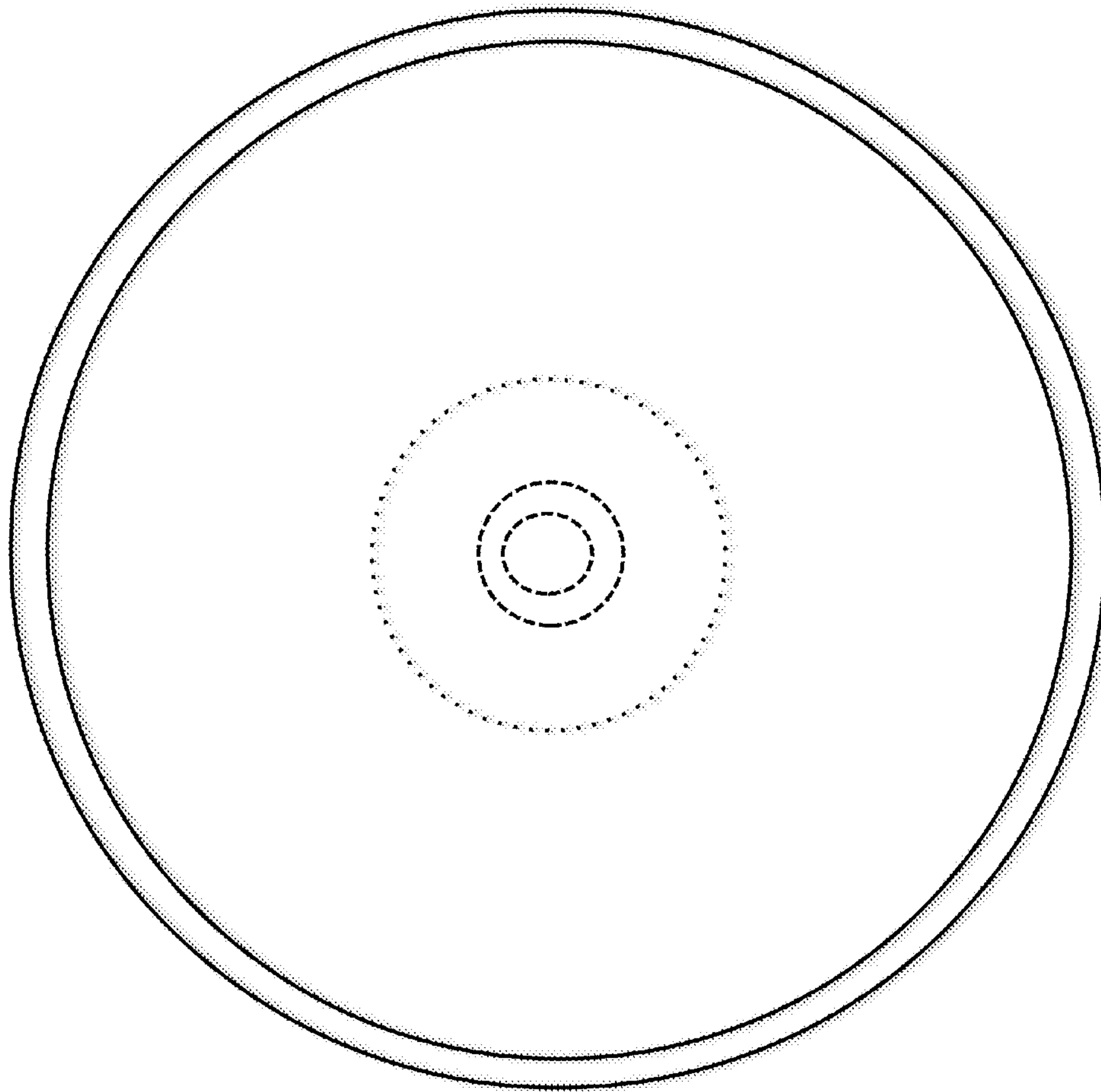

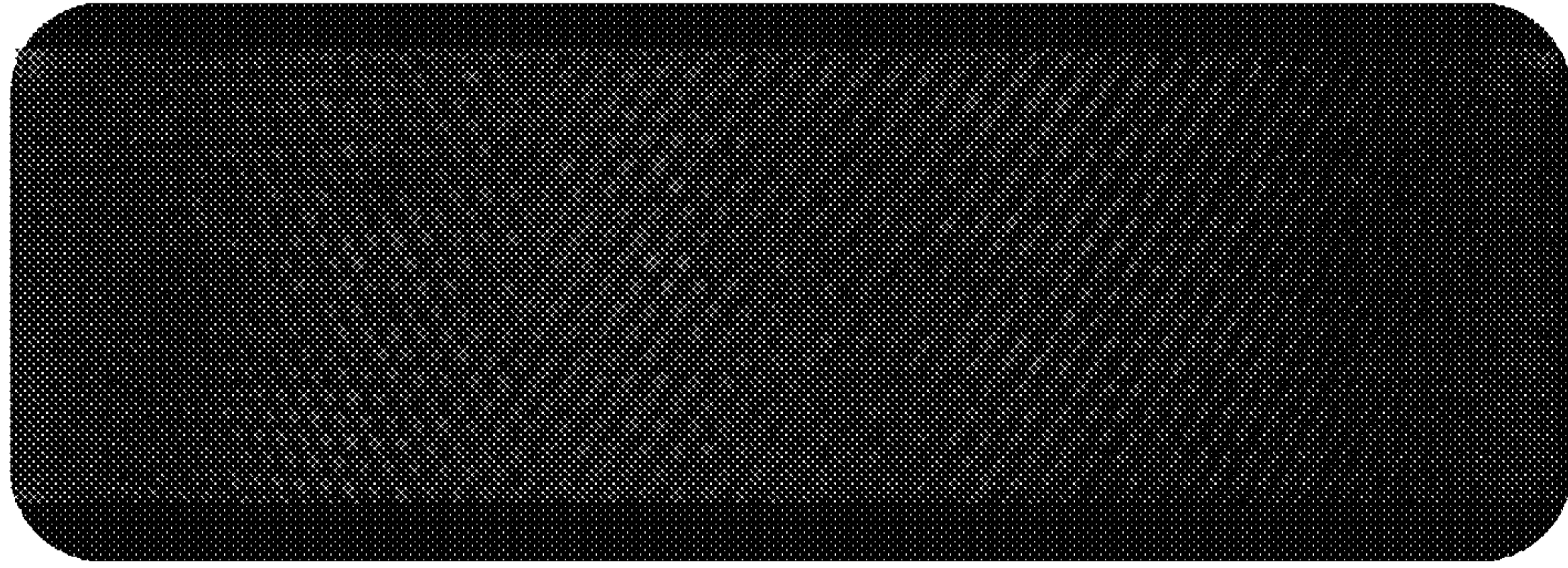

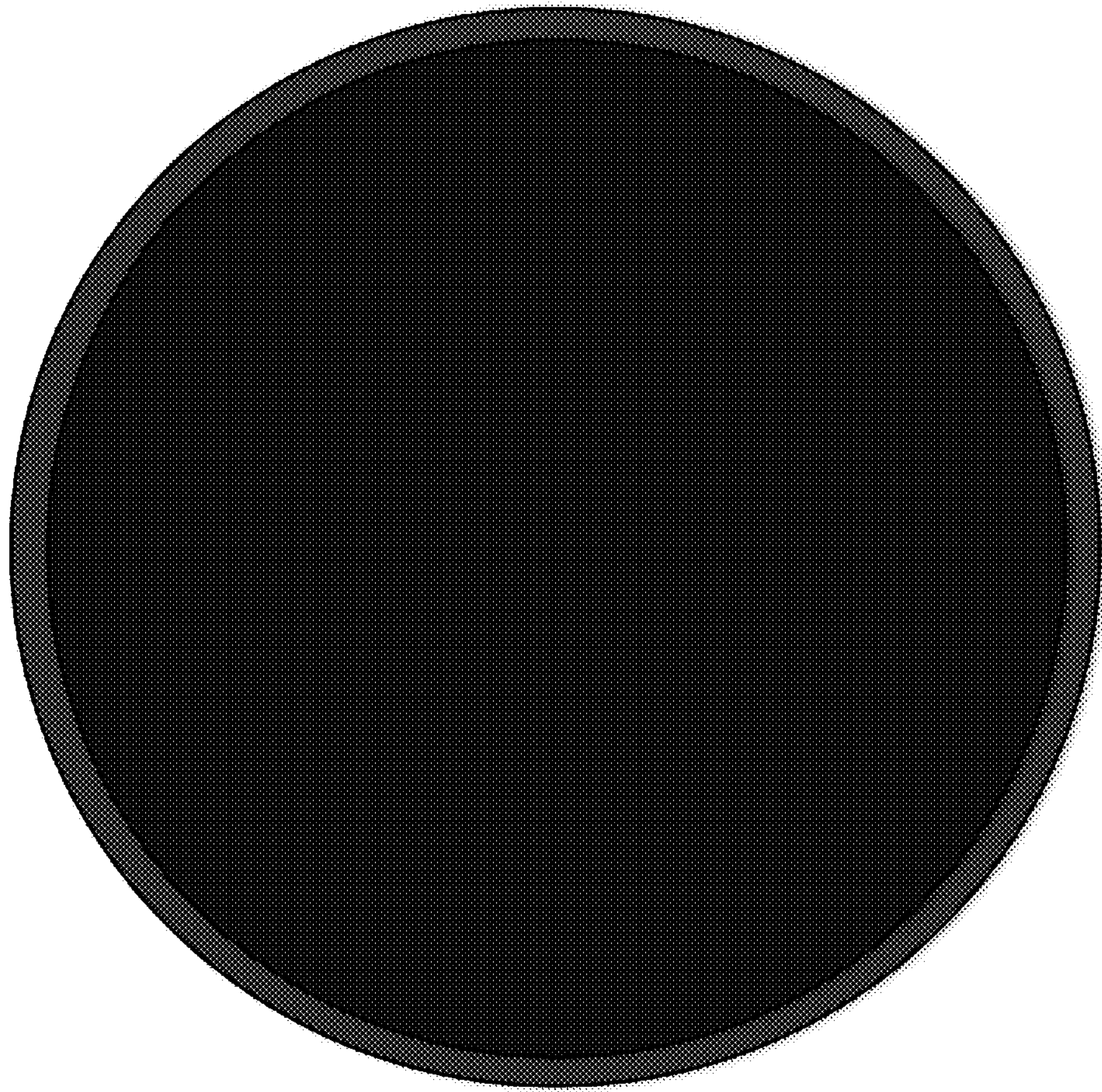

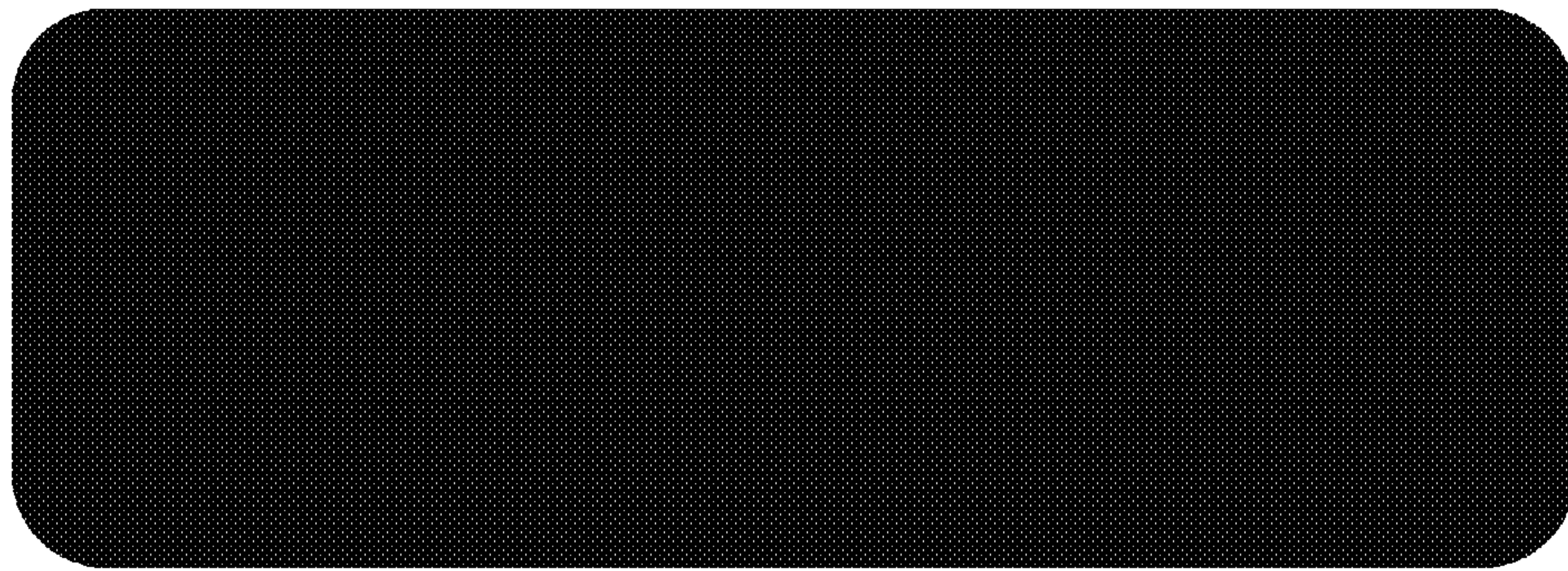

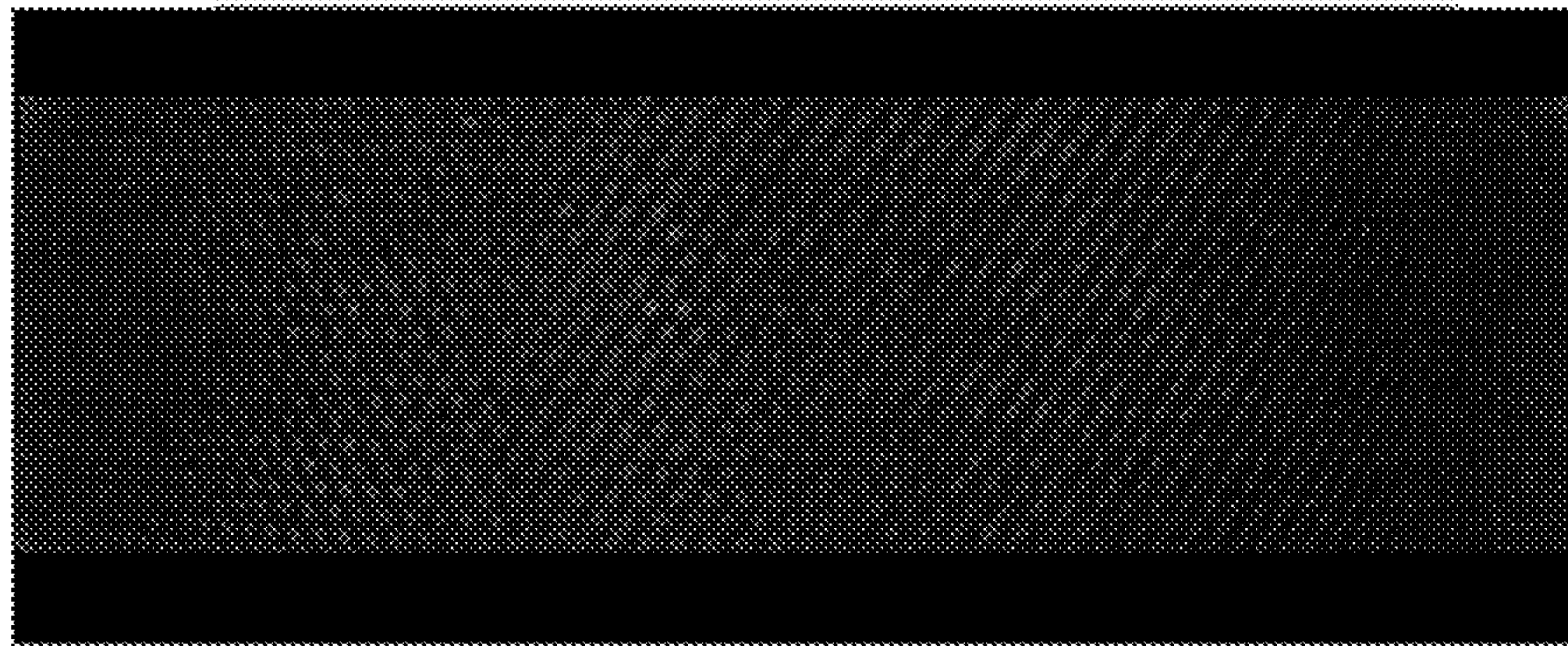

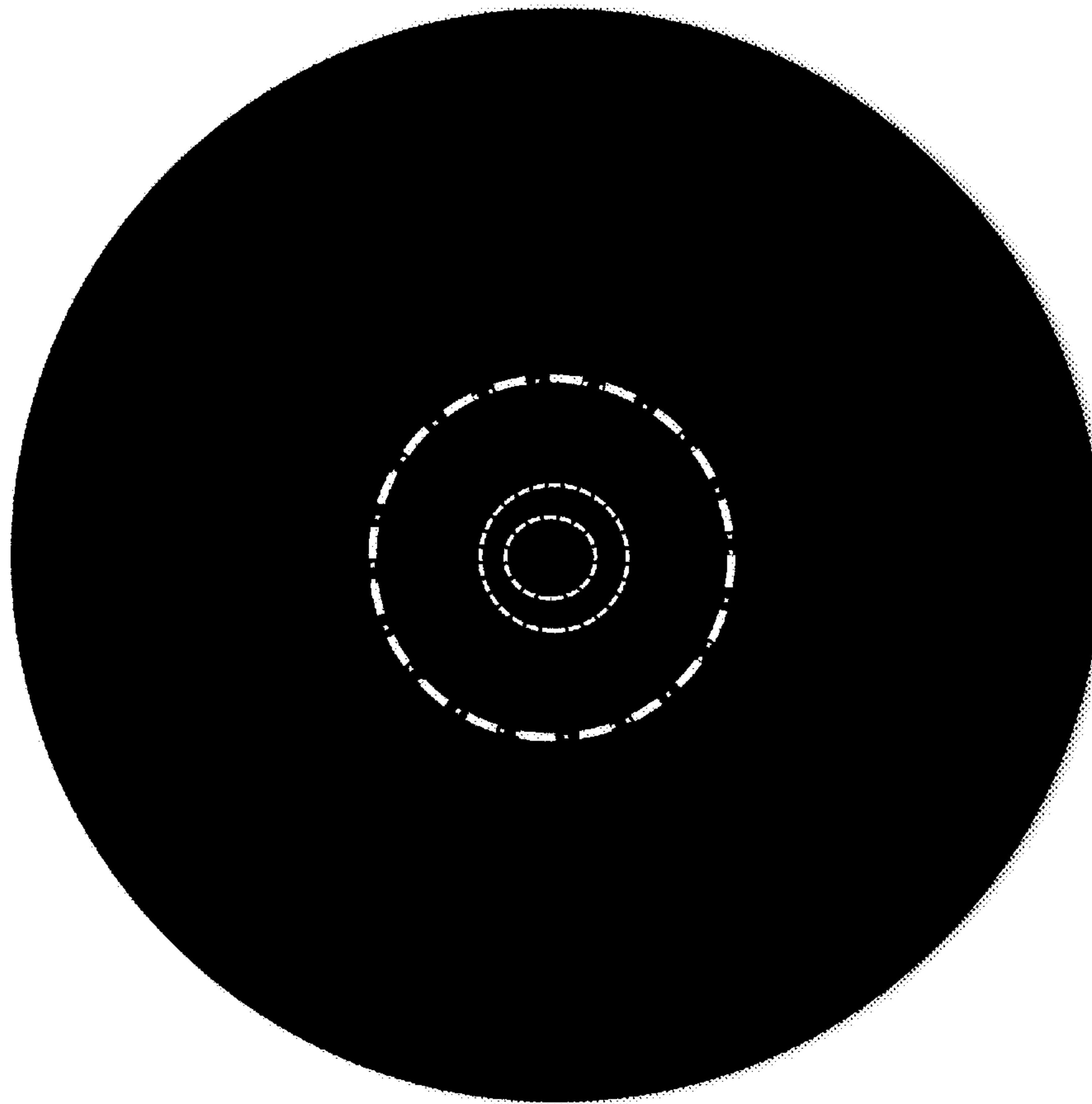

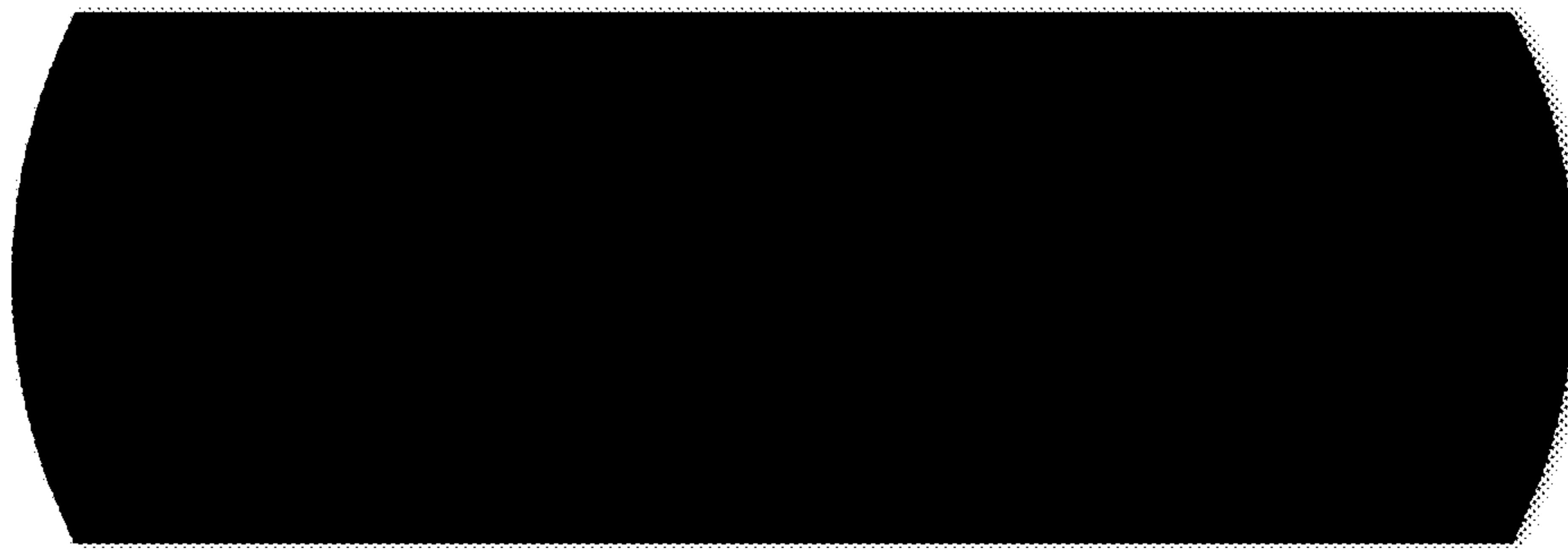

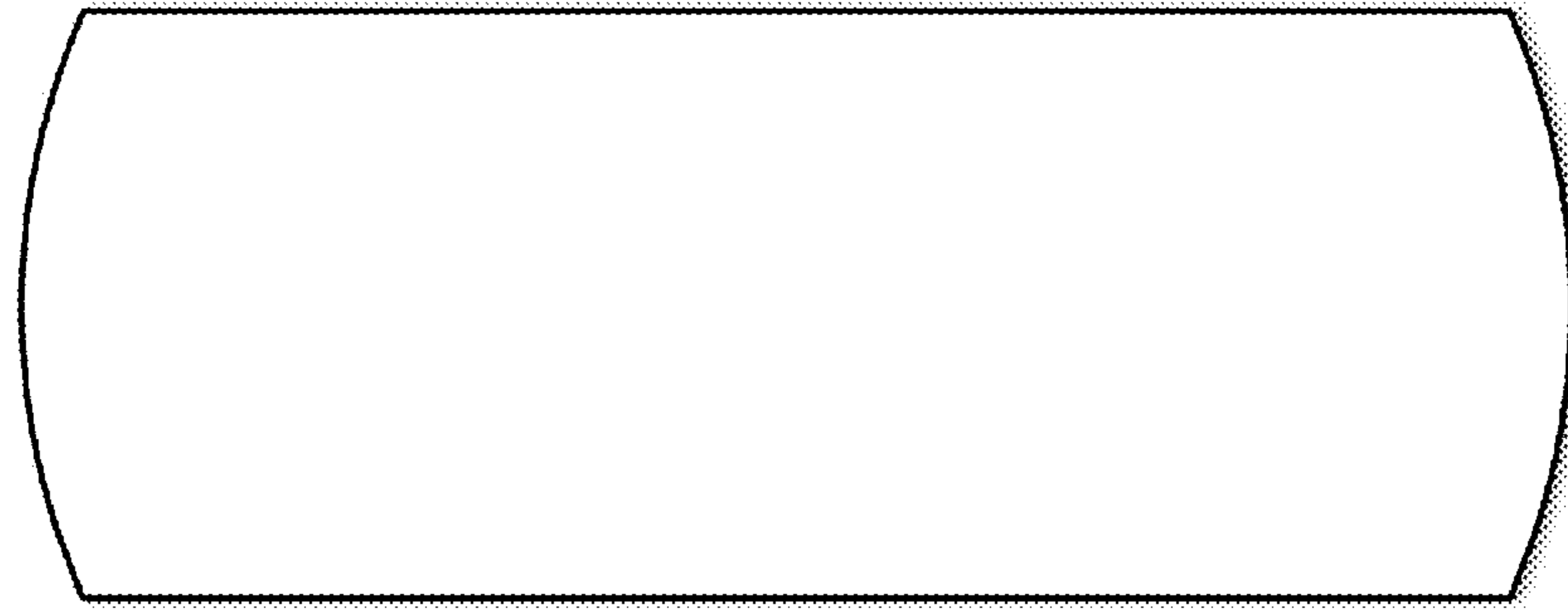

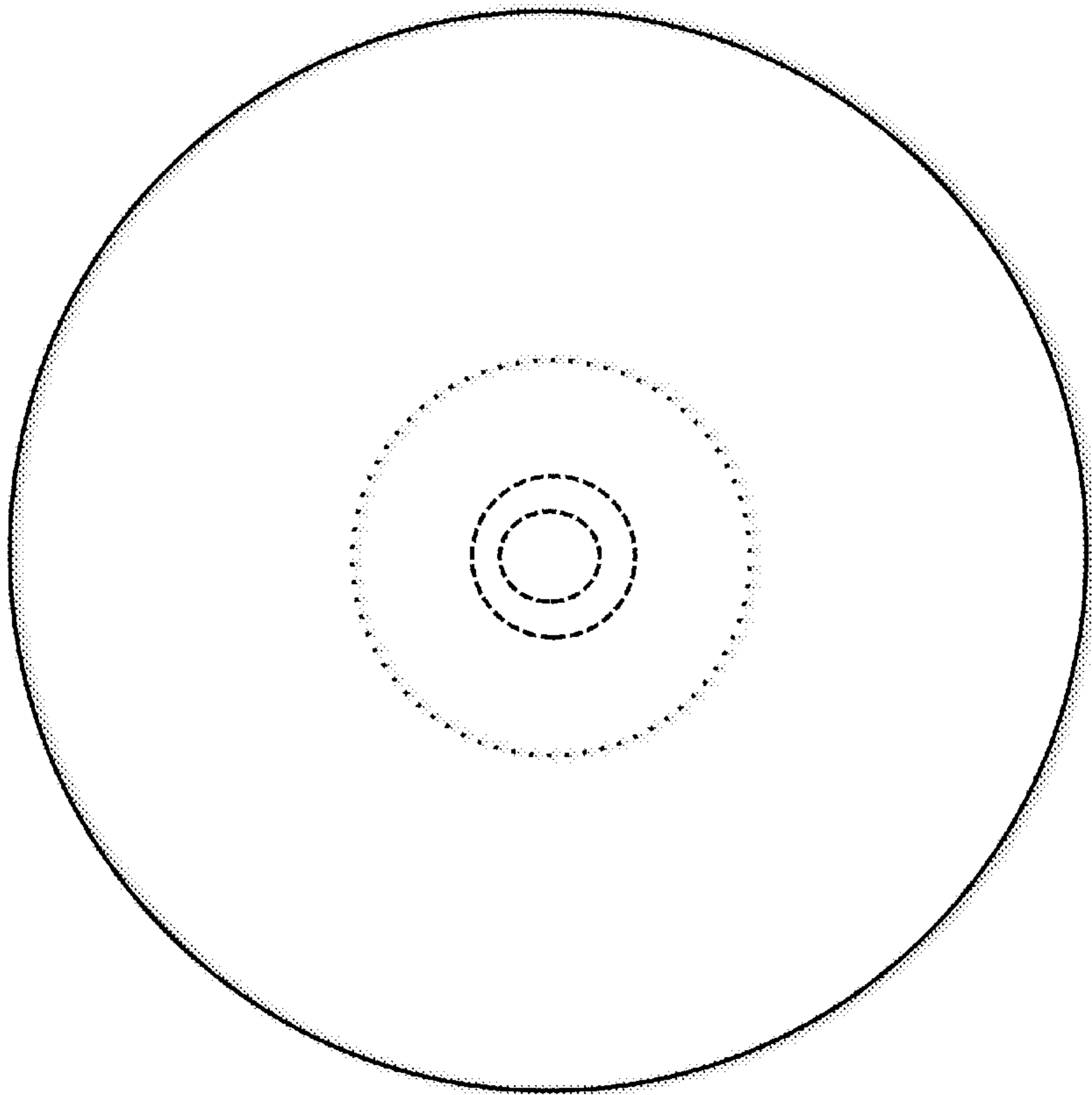

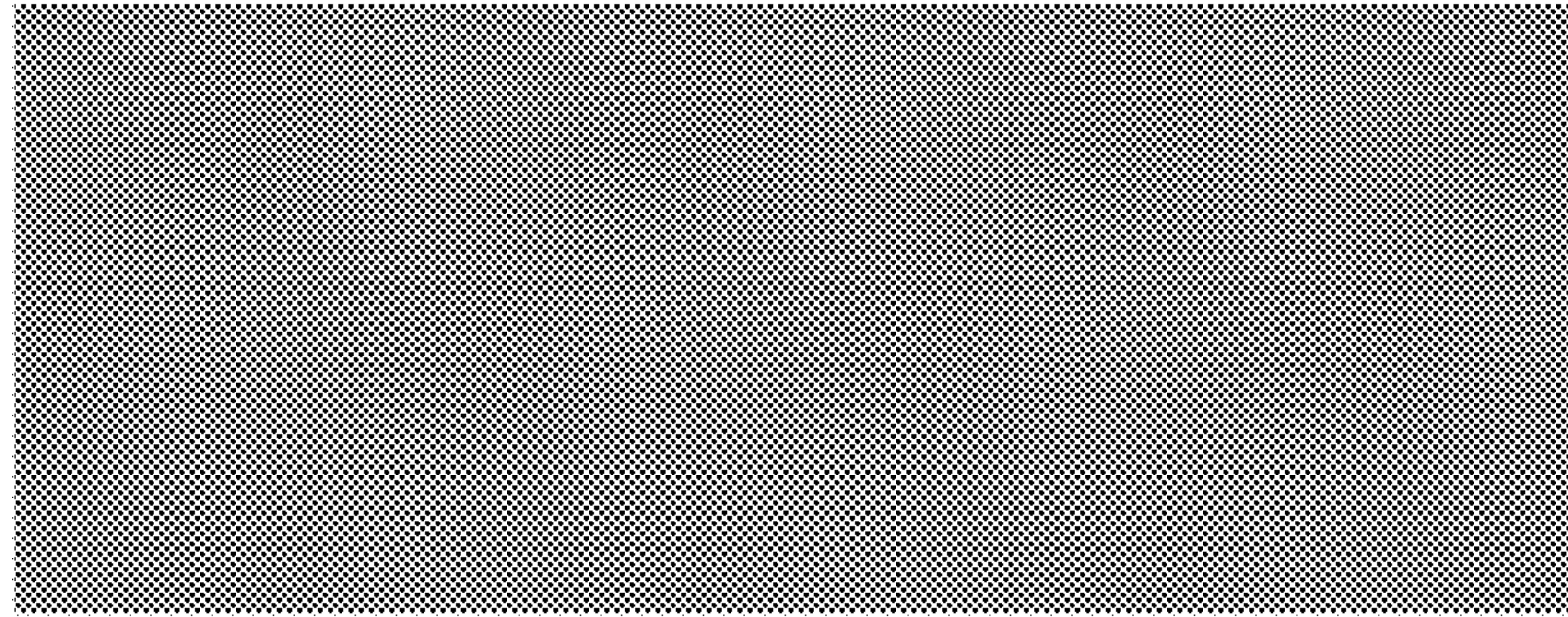

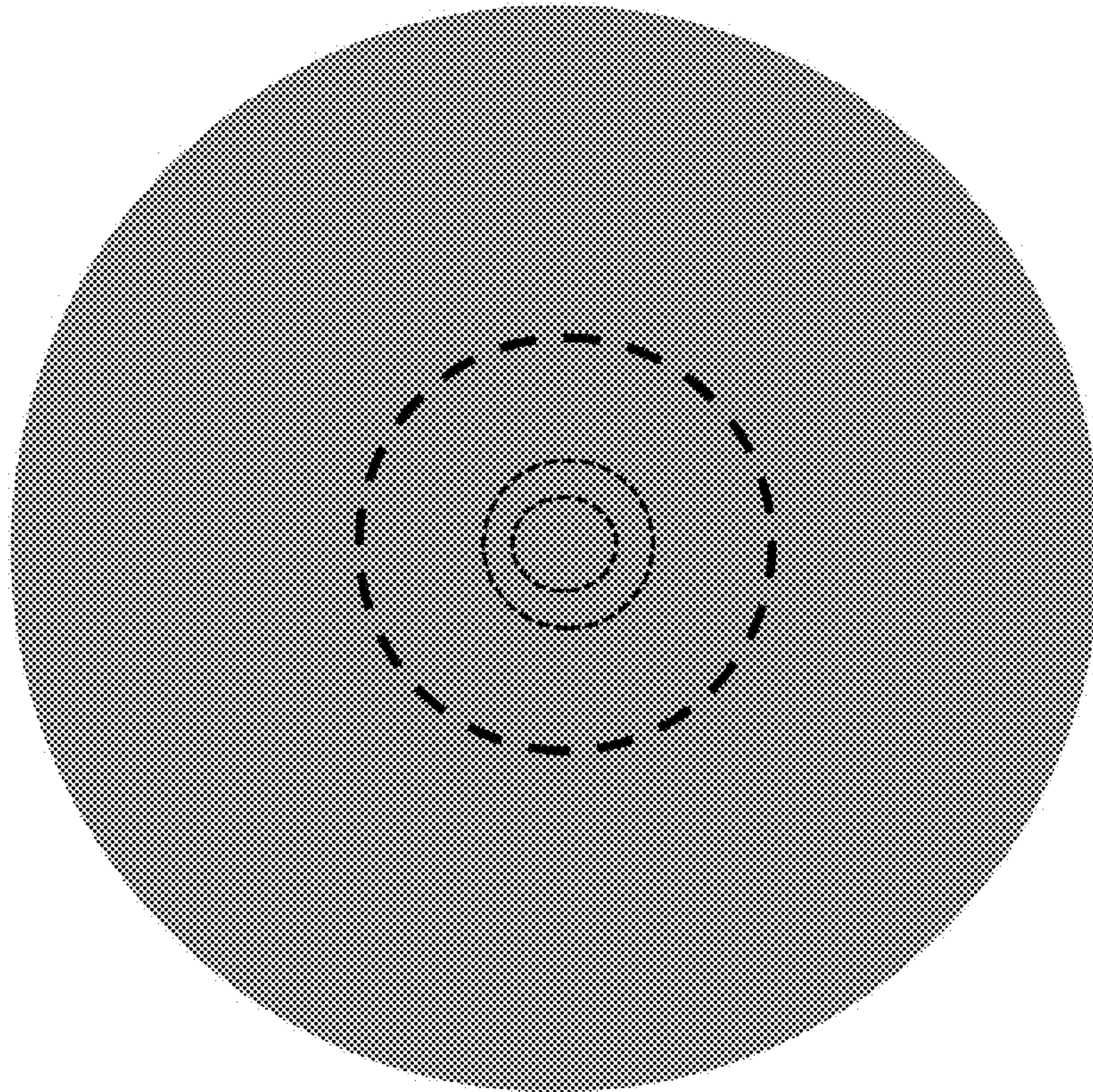

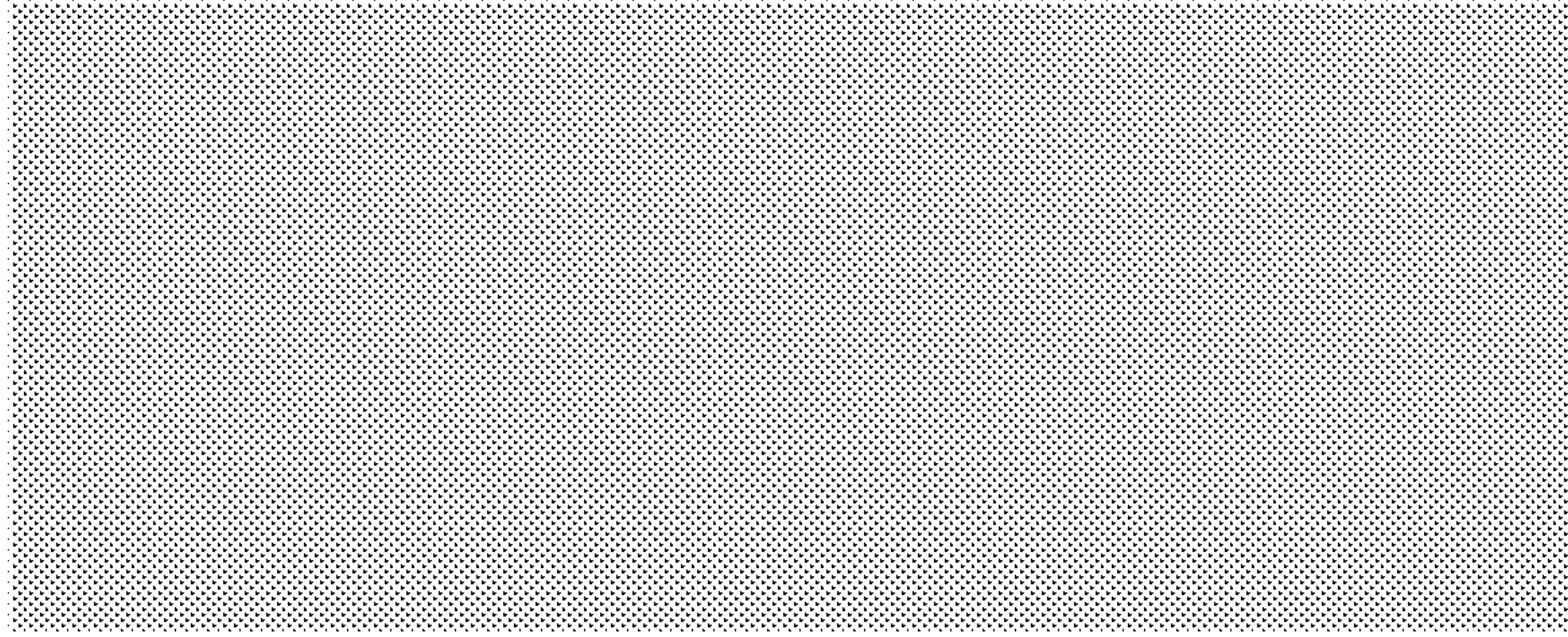

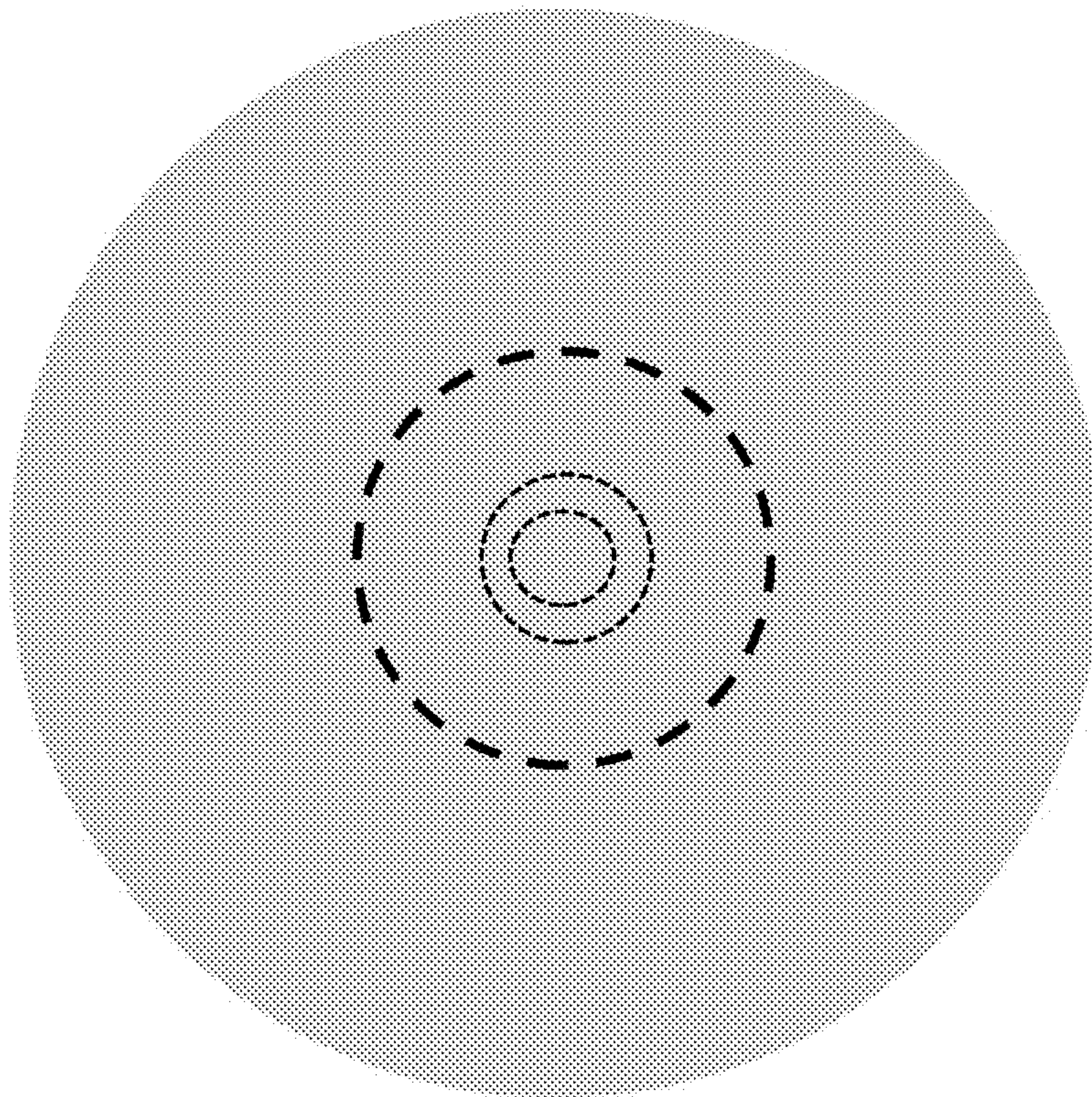

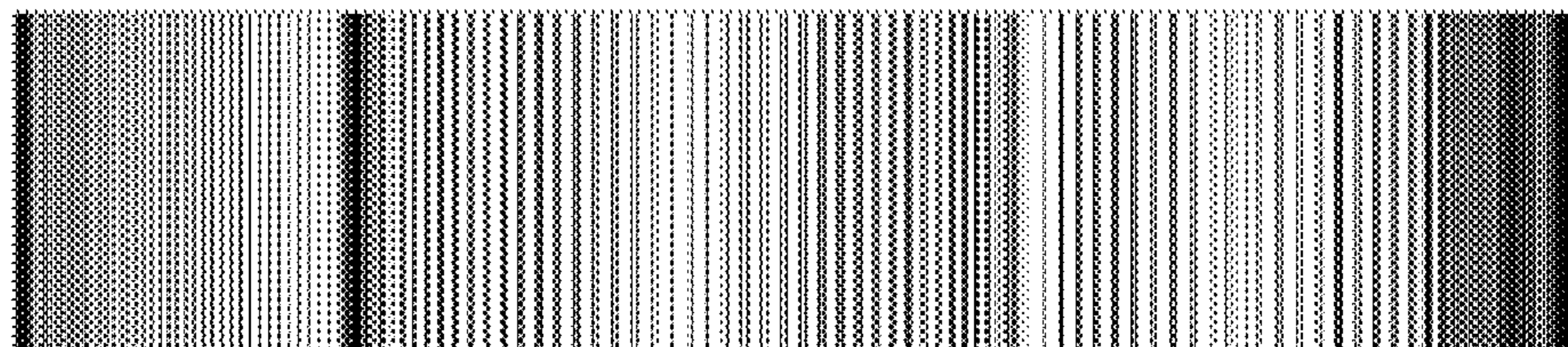

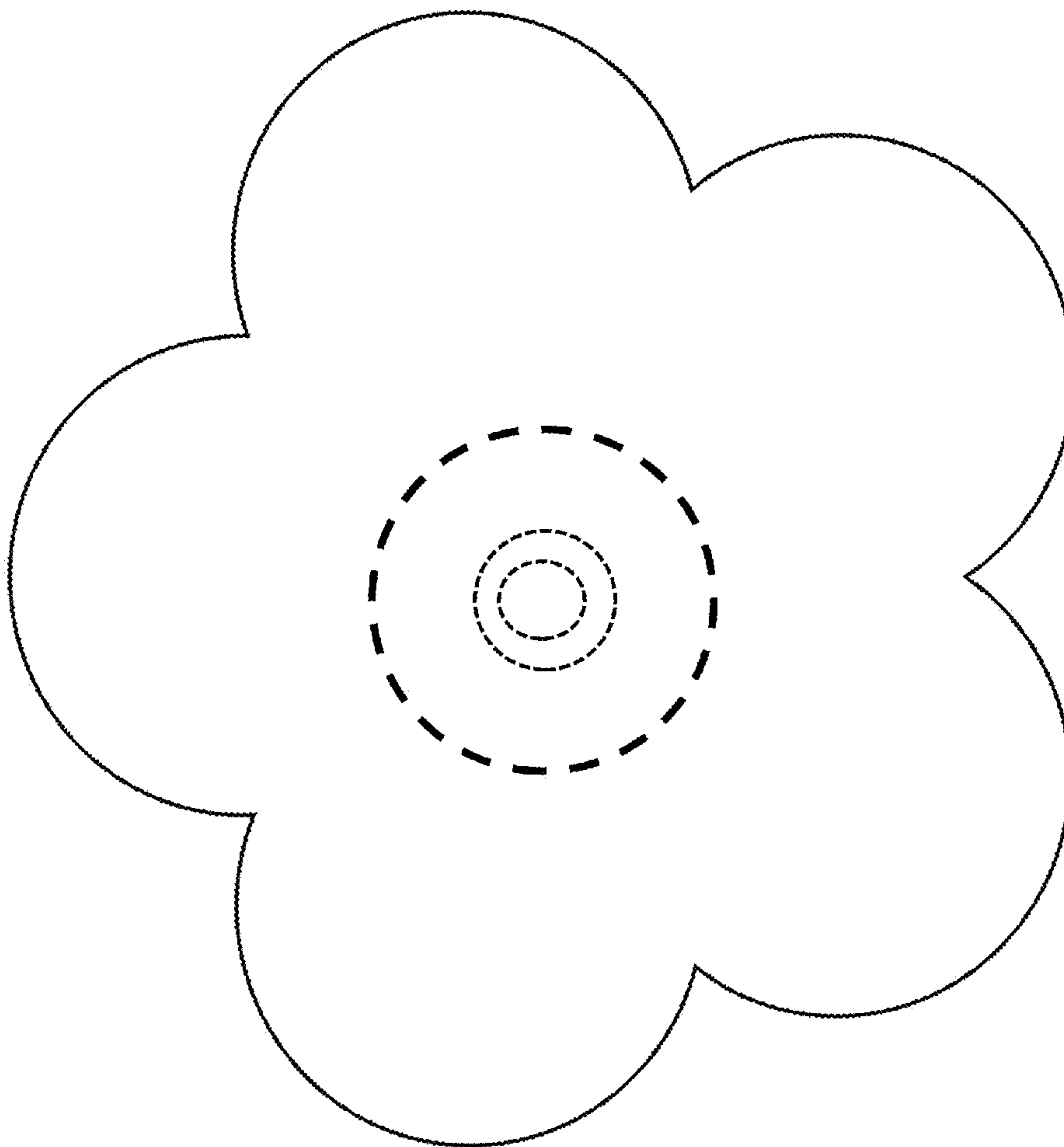
