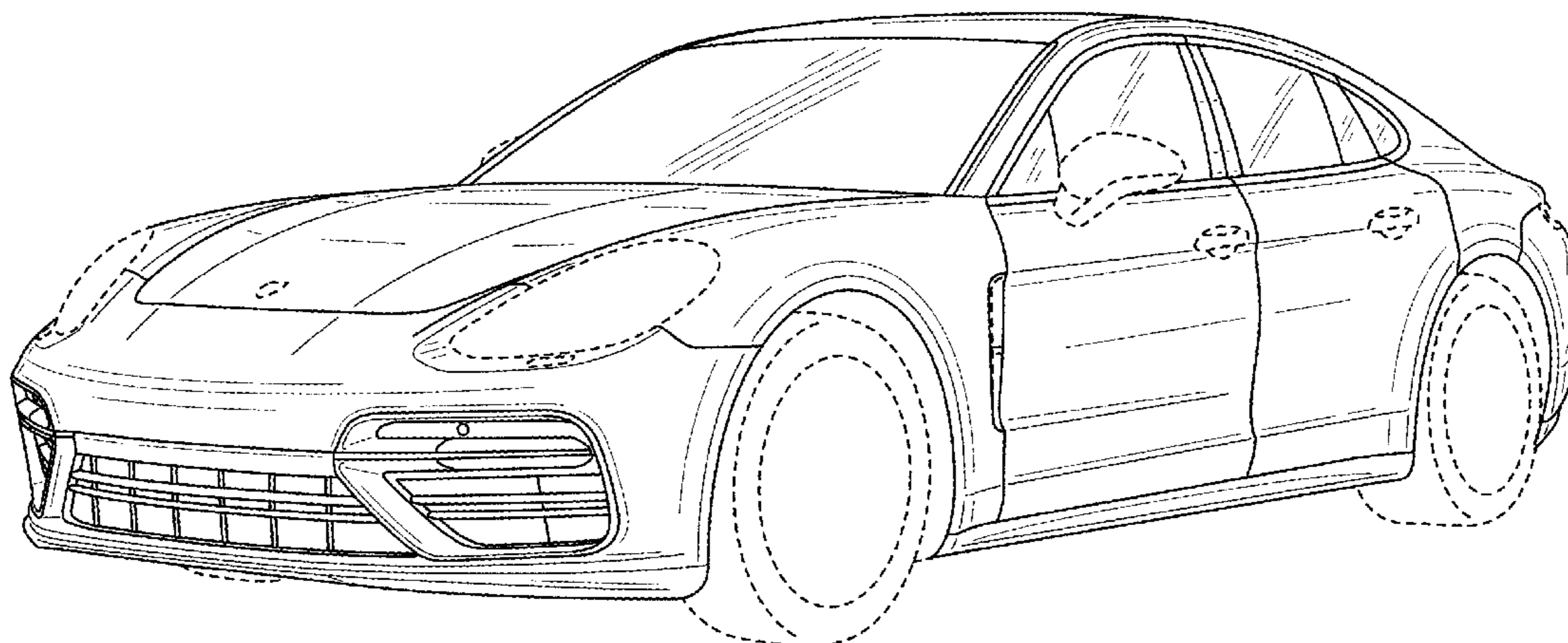
(57) **CLAIM**

The ornamental design for a motor vehicle, toy and/or replica, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a motor vehicle, toy and/or replica;
FIG. 2 is a right side elevation view thereof, the left side being substantially a mirror image;
FIG. 3 is a front elevation view thereof;
FIG. 4 is a rear elevation view thereof; and,
FIG. 5 is a top plan view thereof.

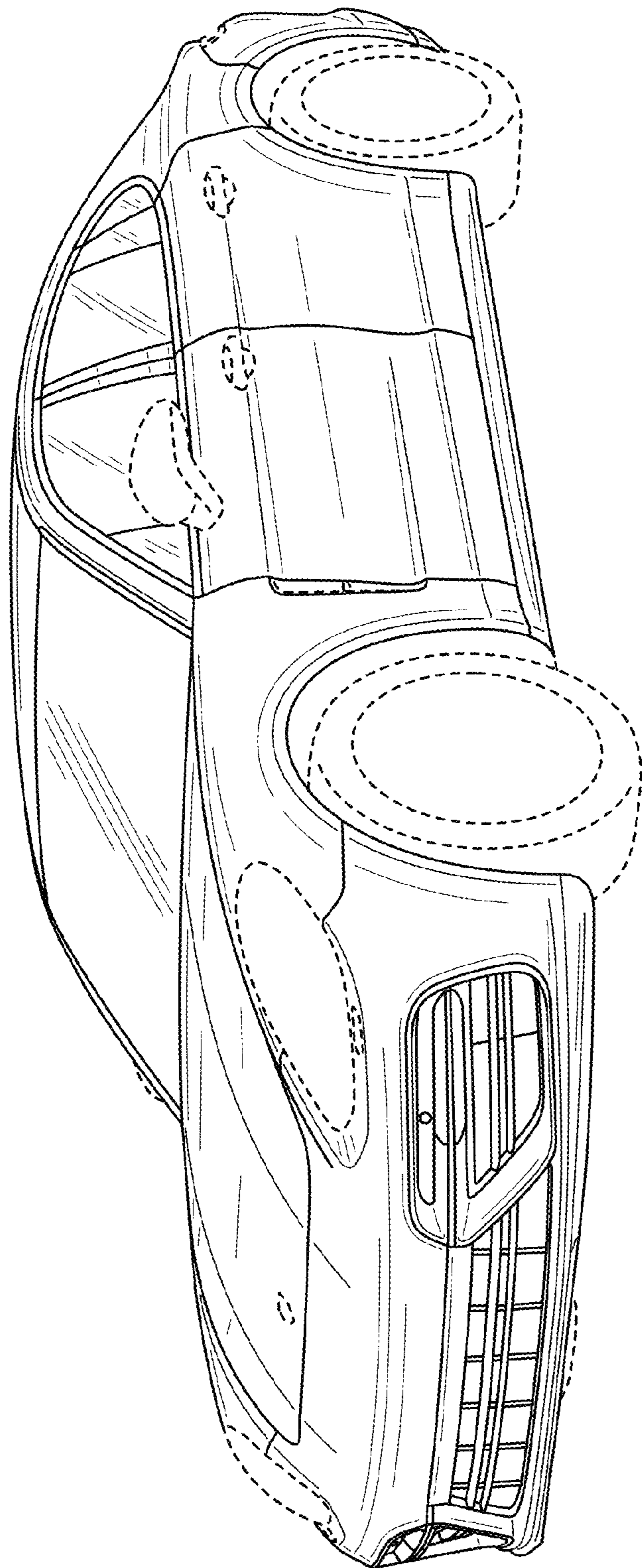

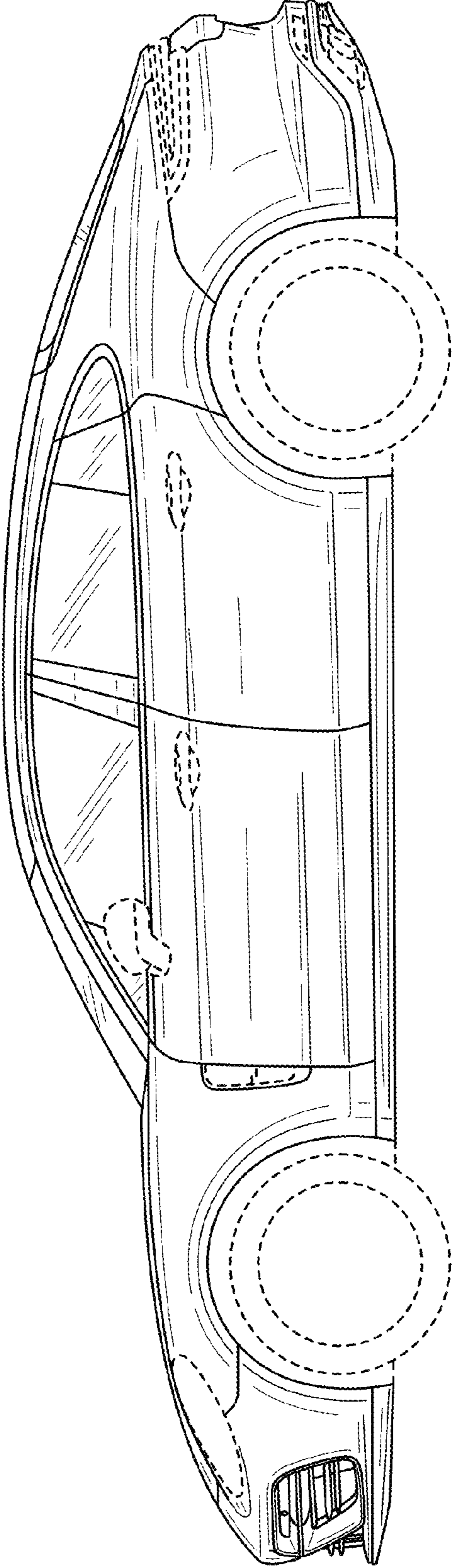

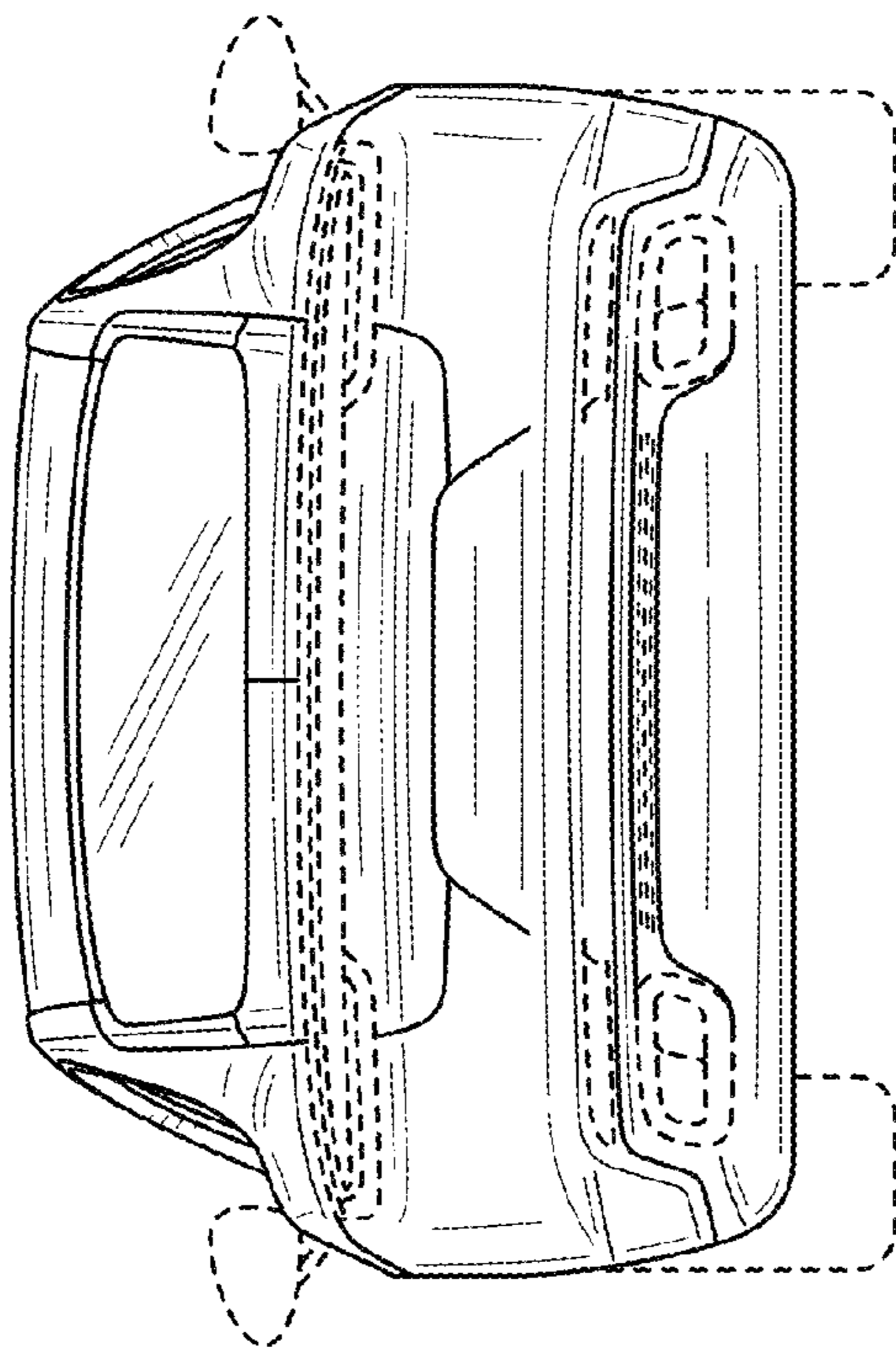

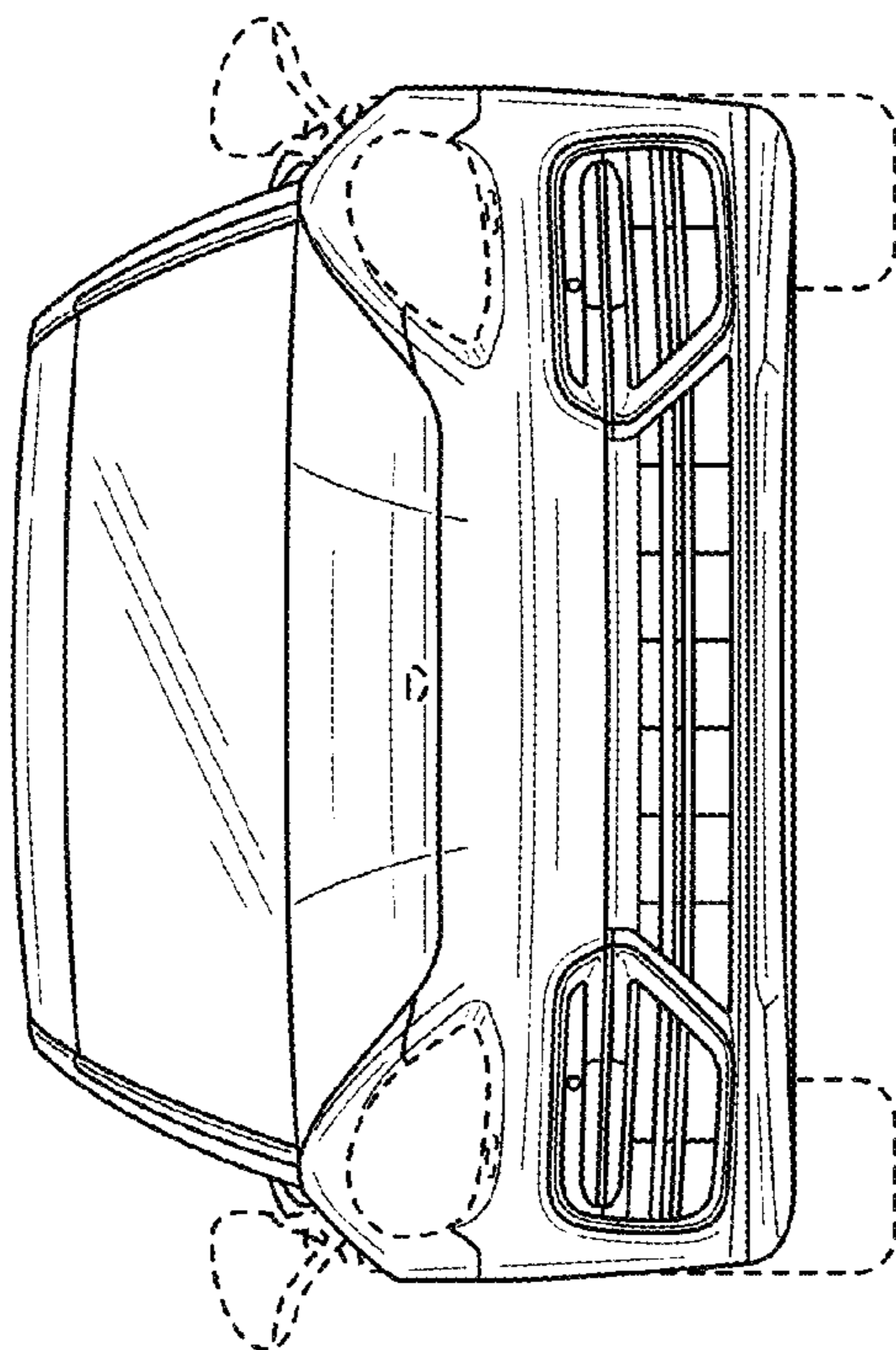

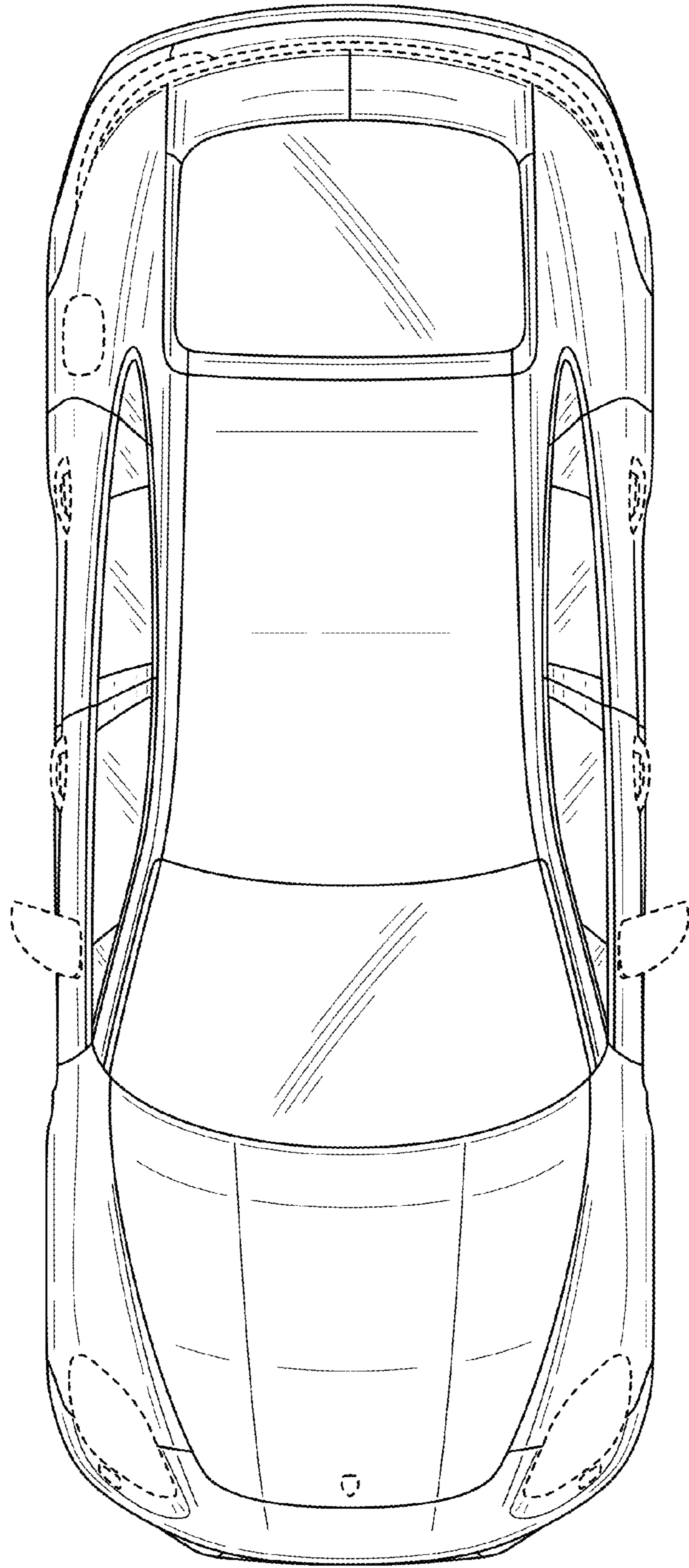
