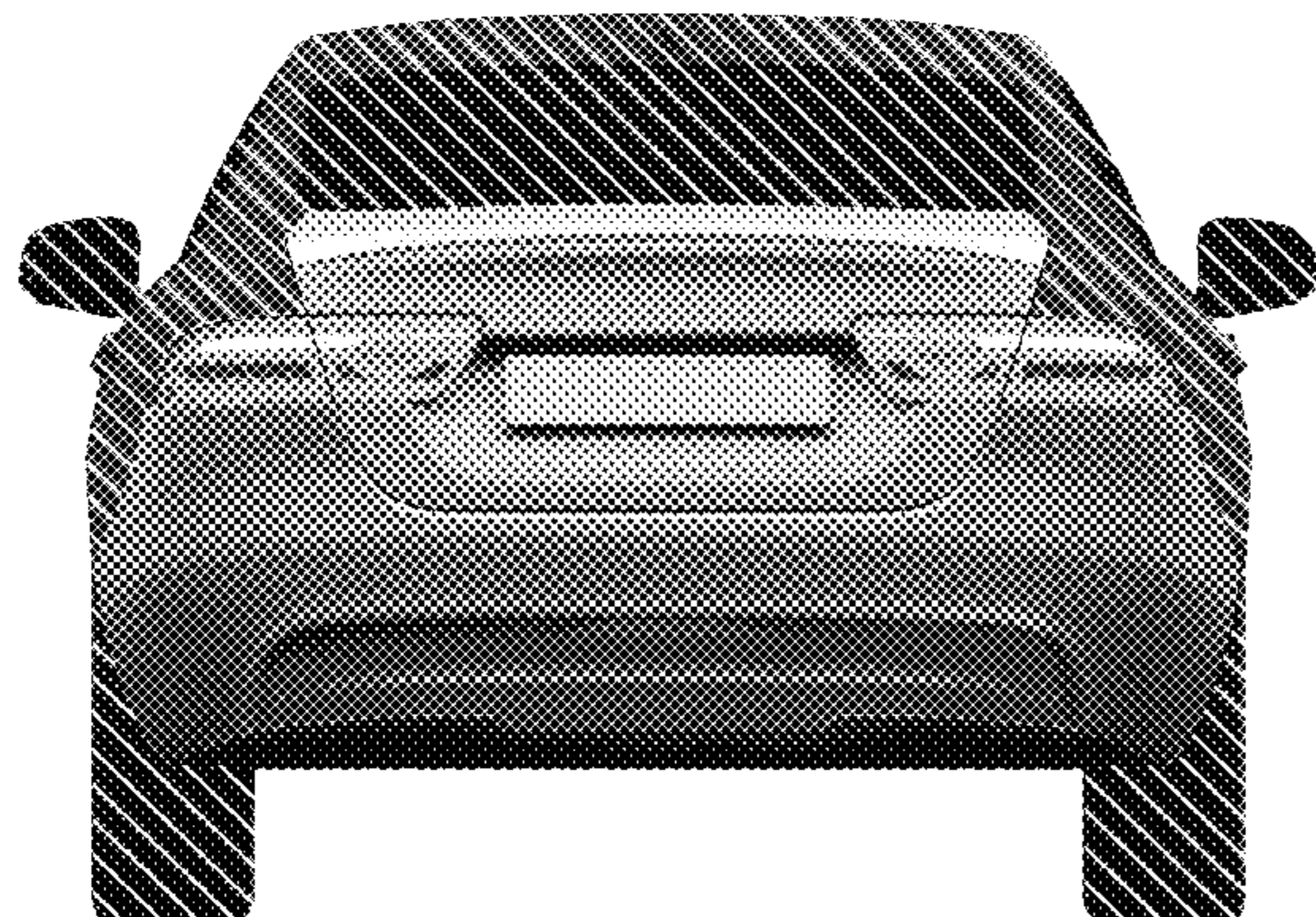

**DESCRIPTION**

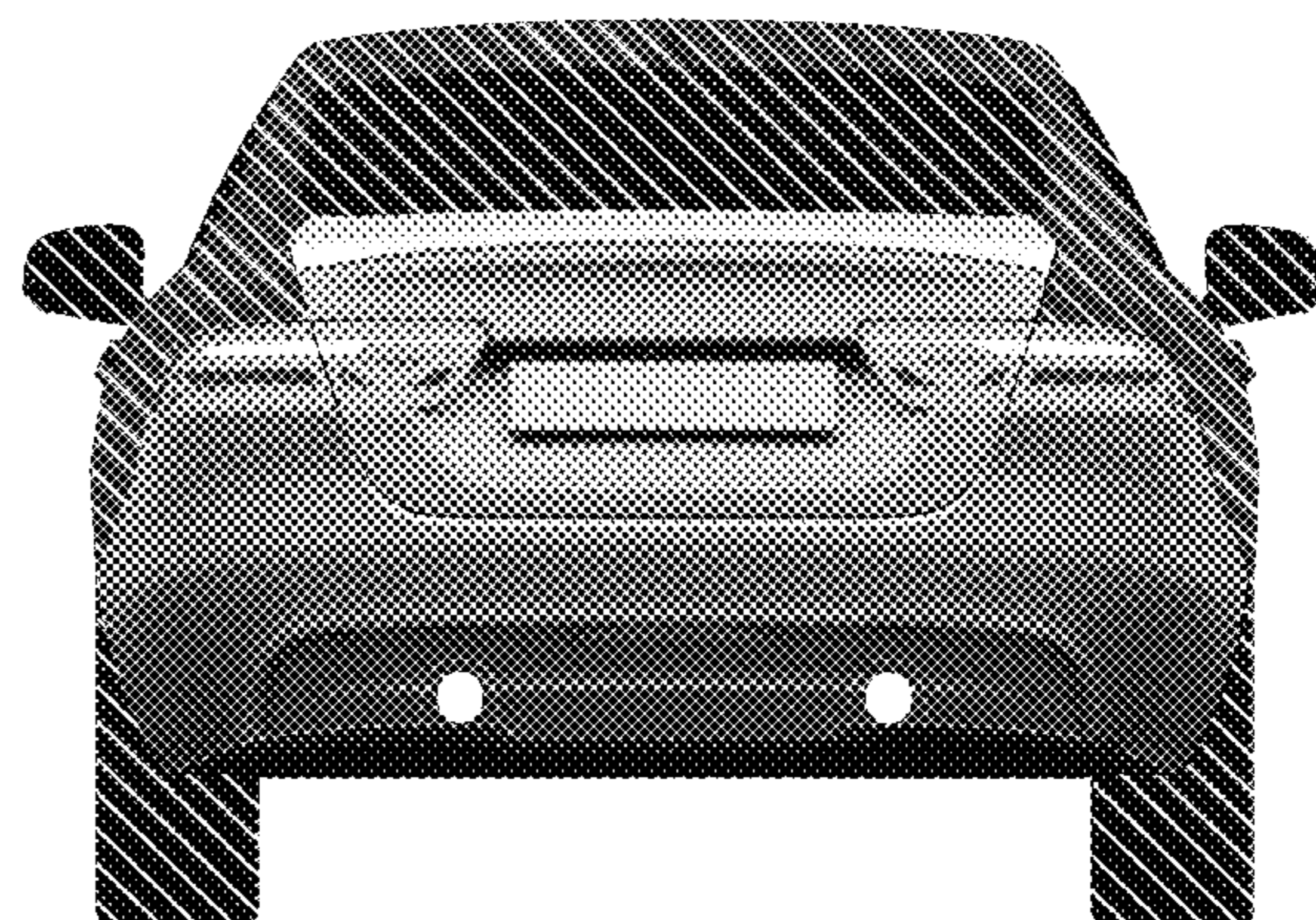
FIG. 1 is a left rear perspective view of a first embodiment of a vehicle rear end unit;

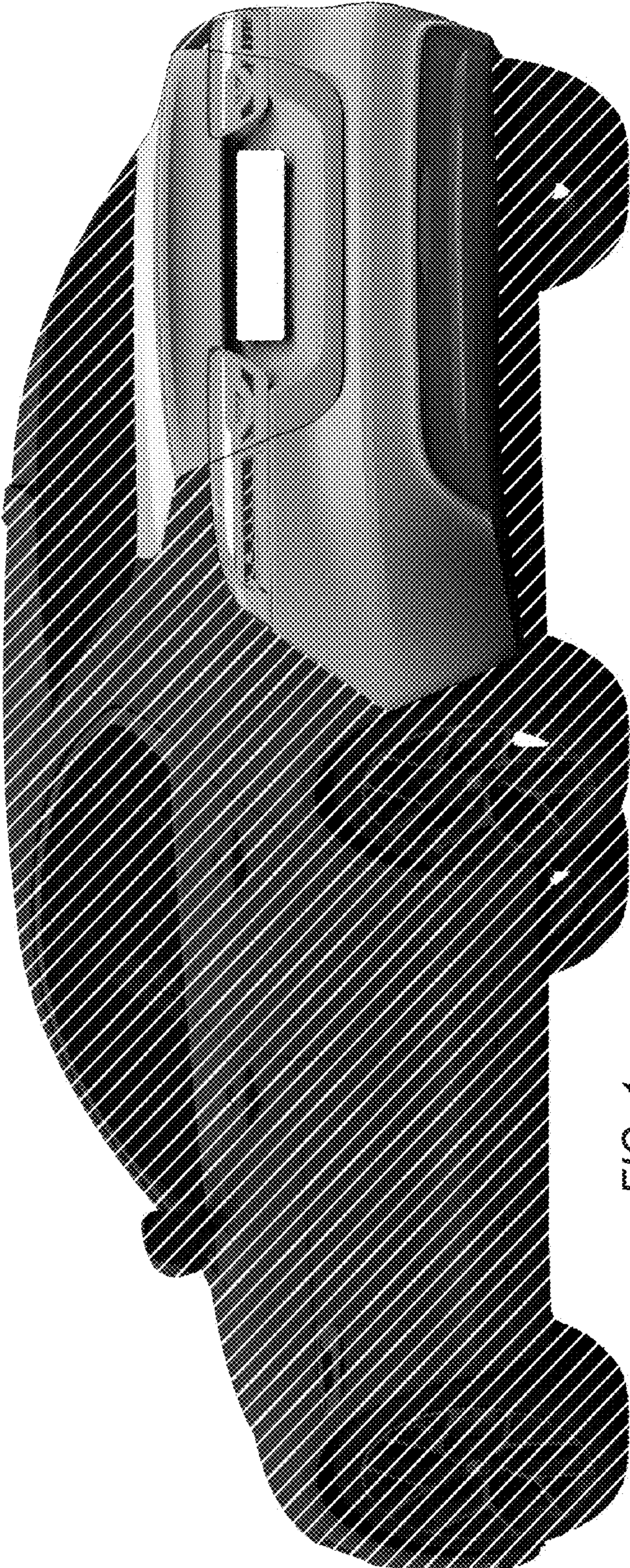

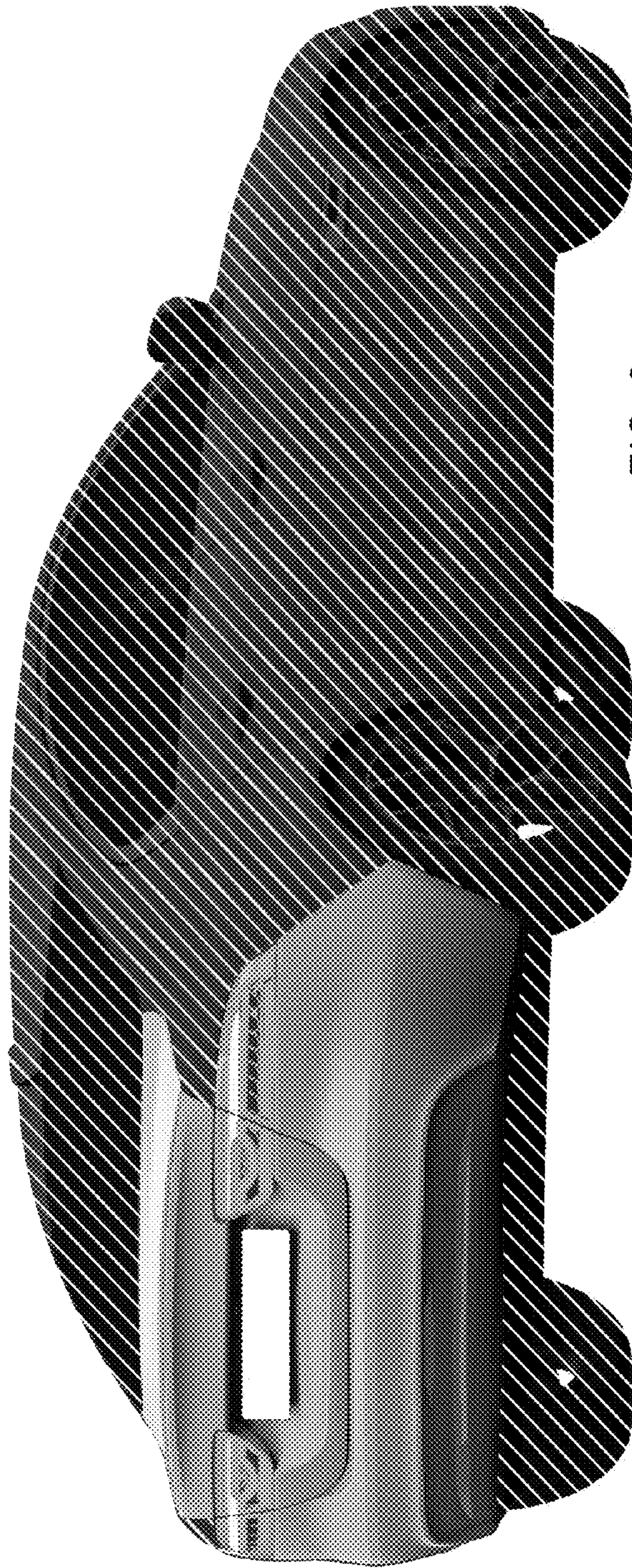

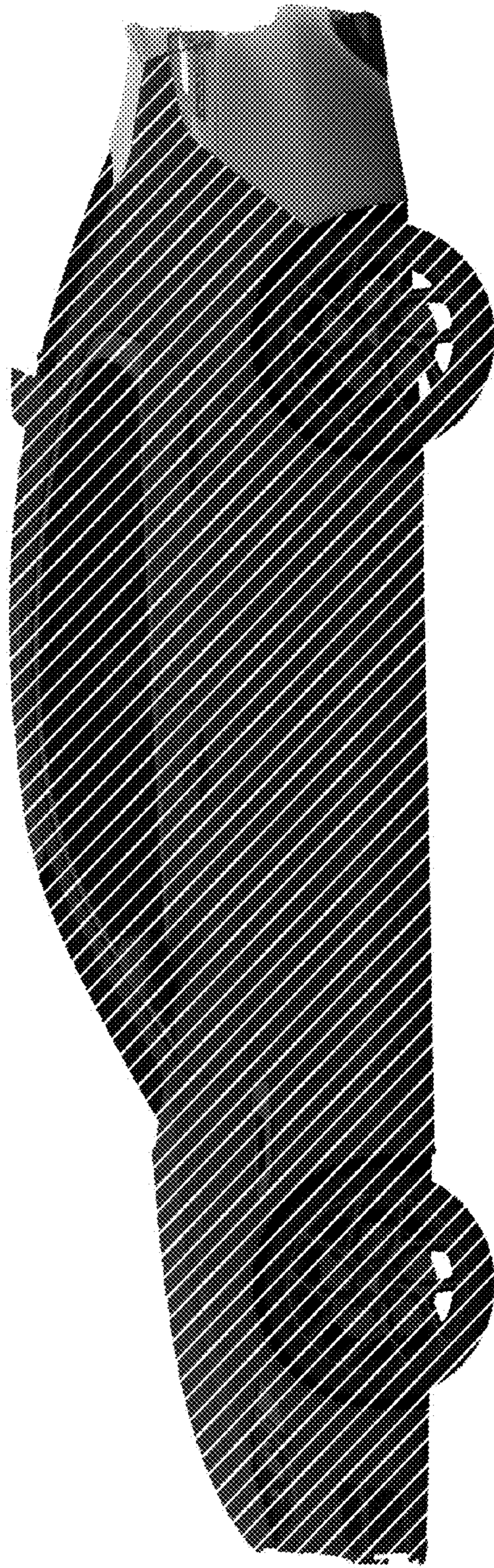

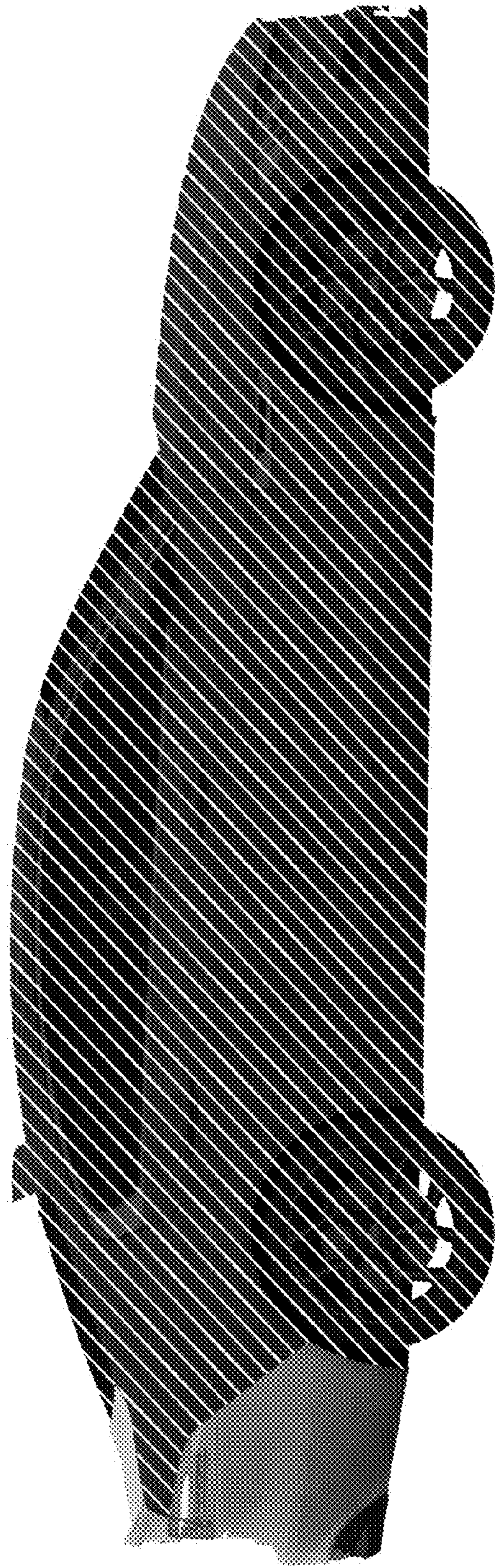

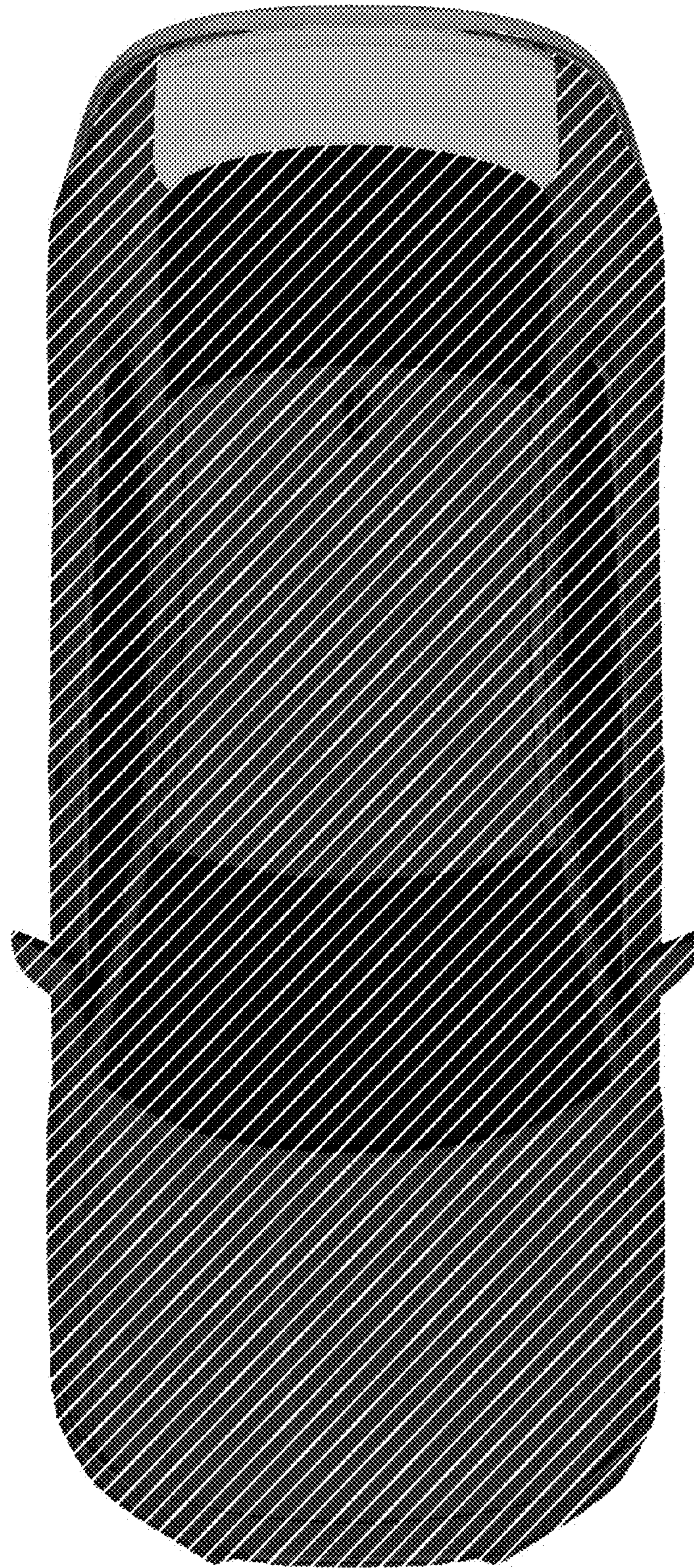

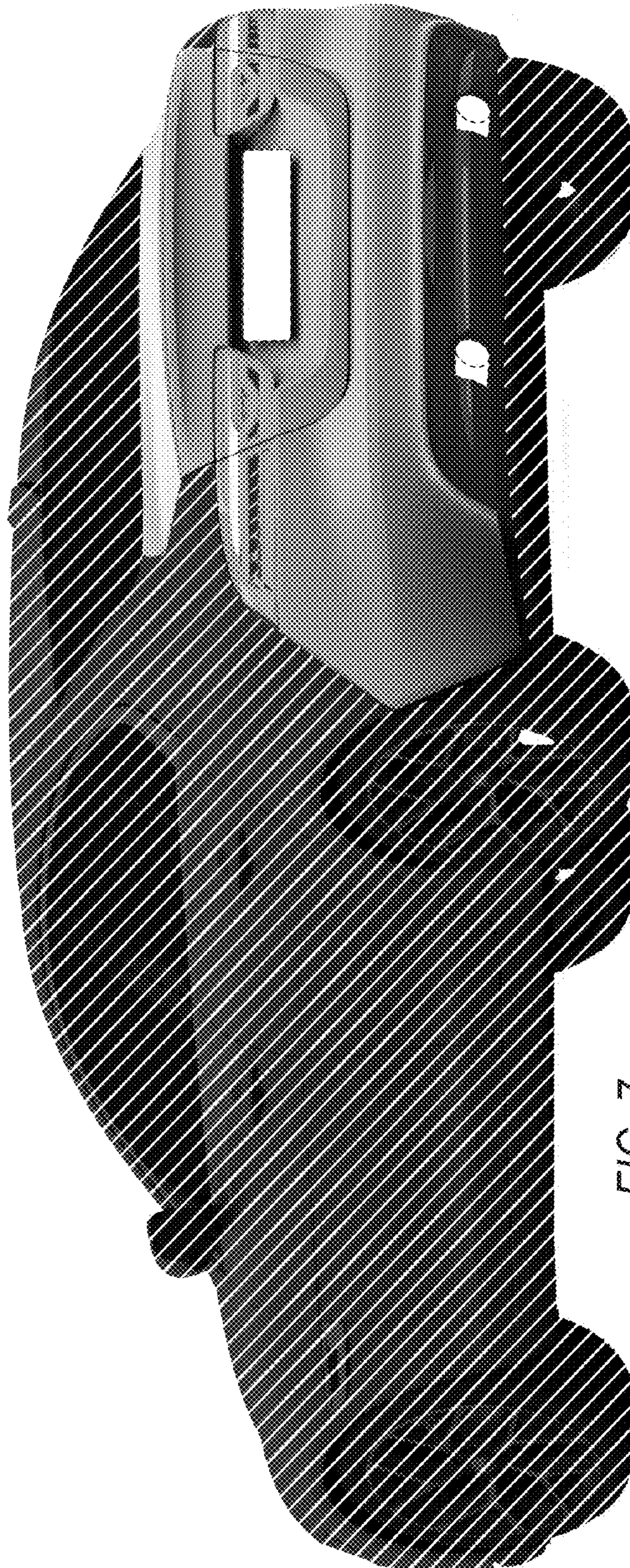

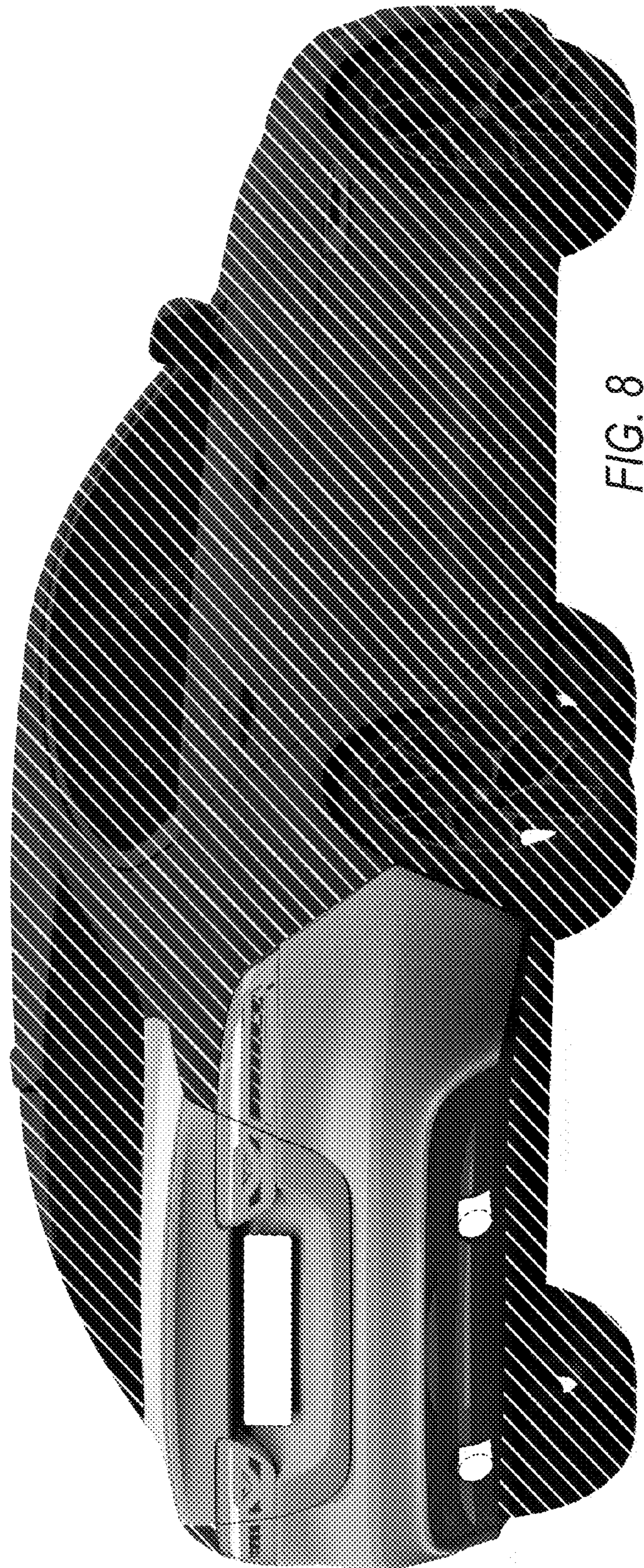

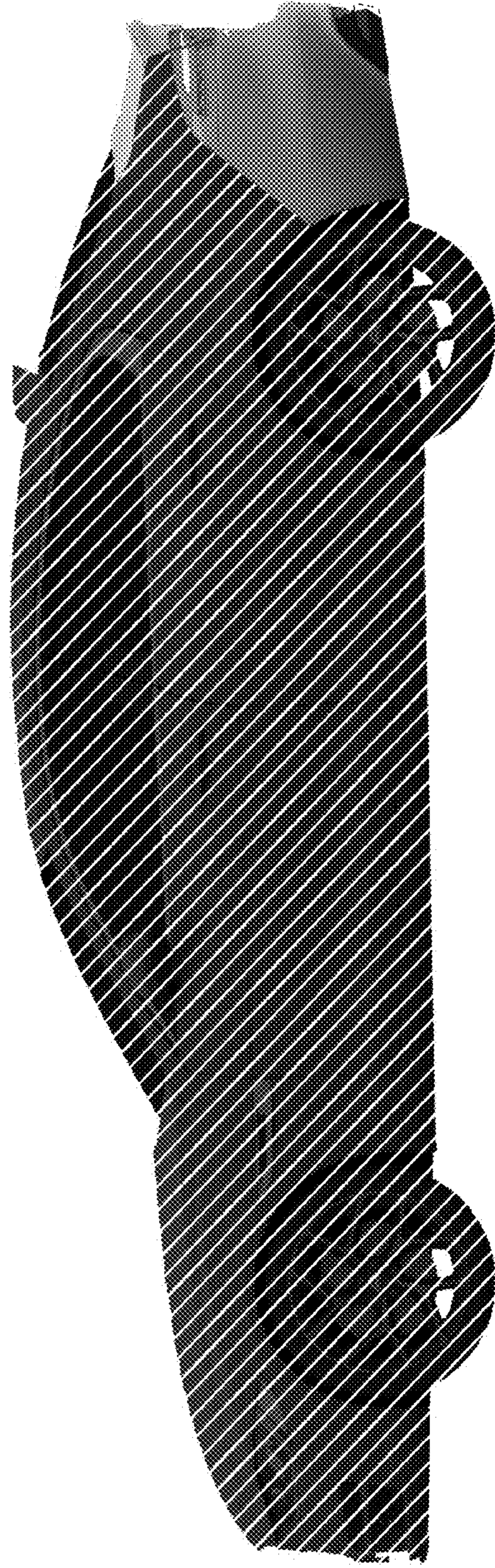

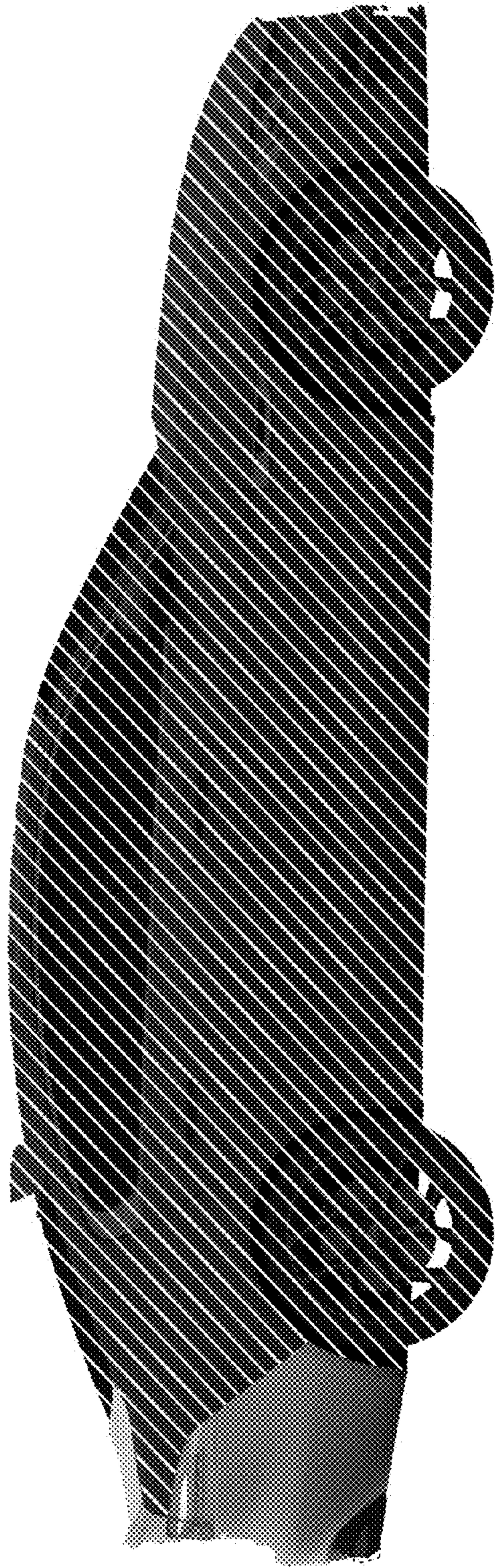

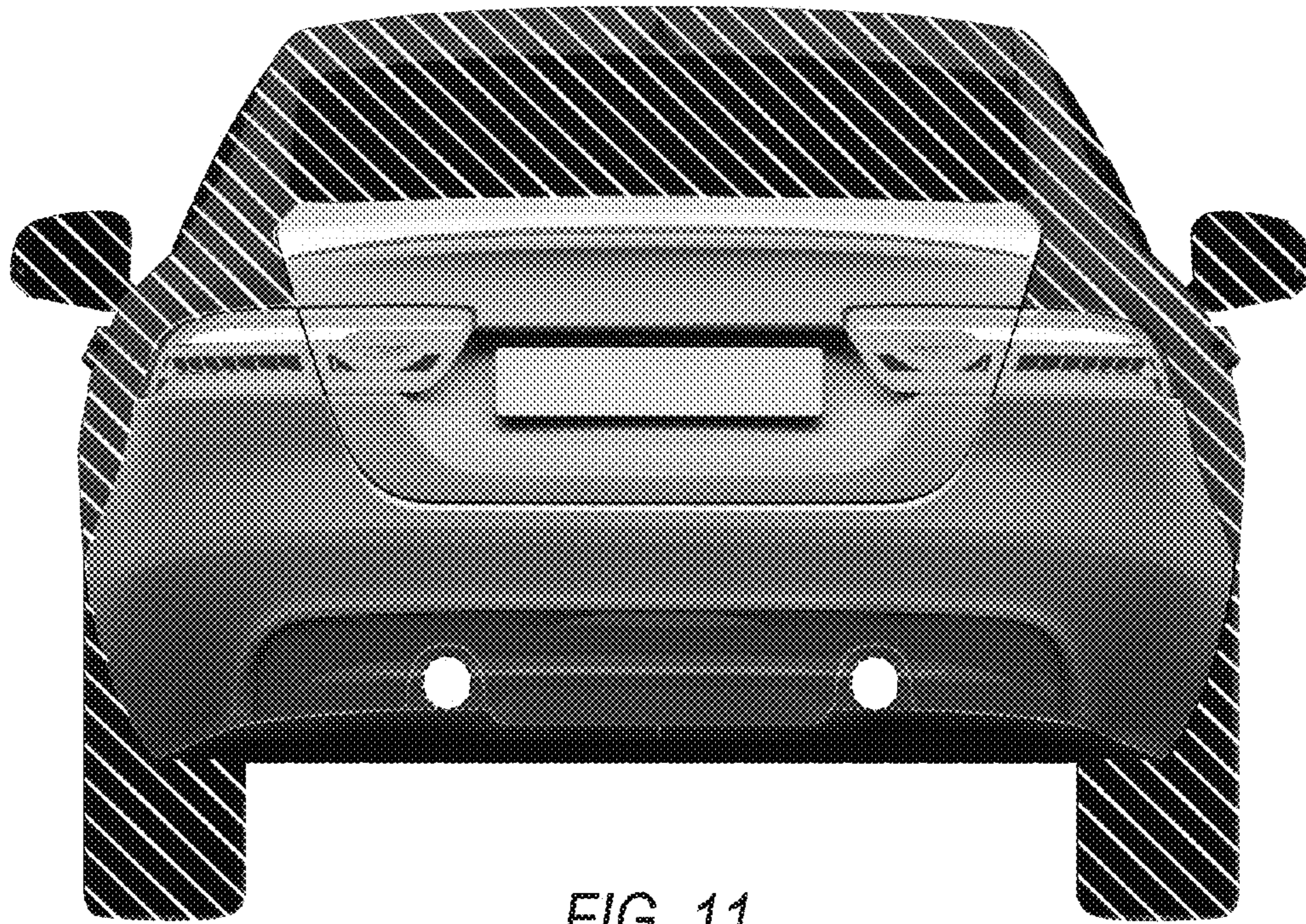

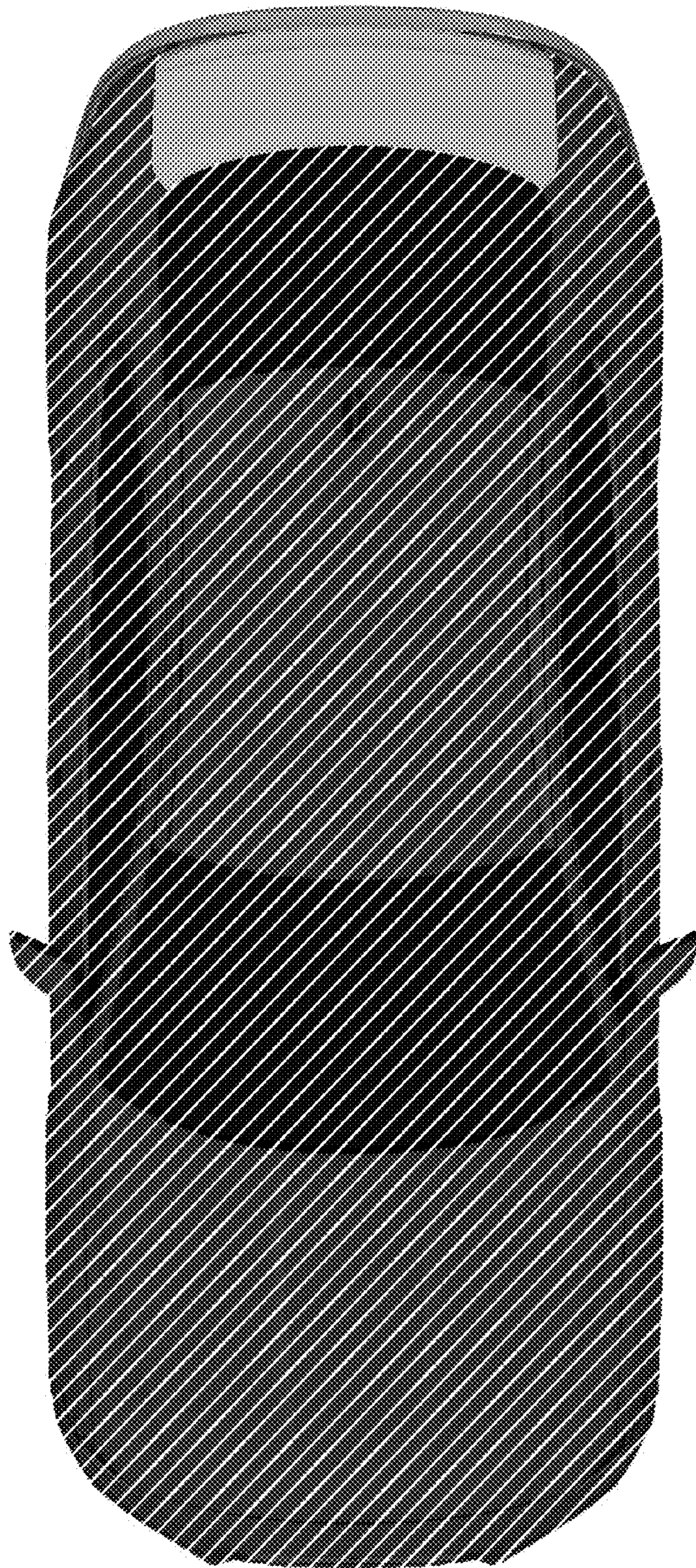

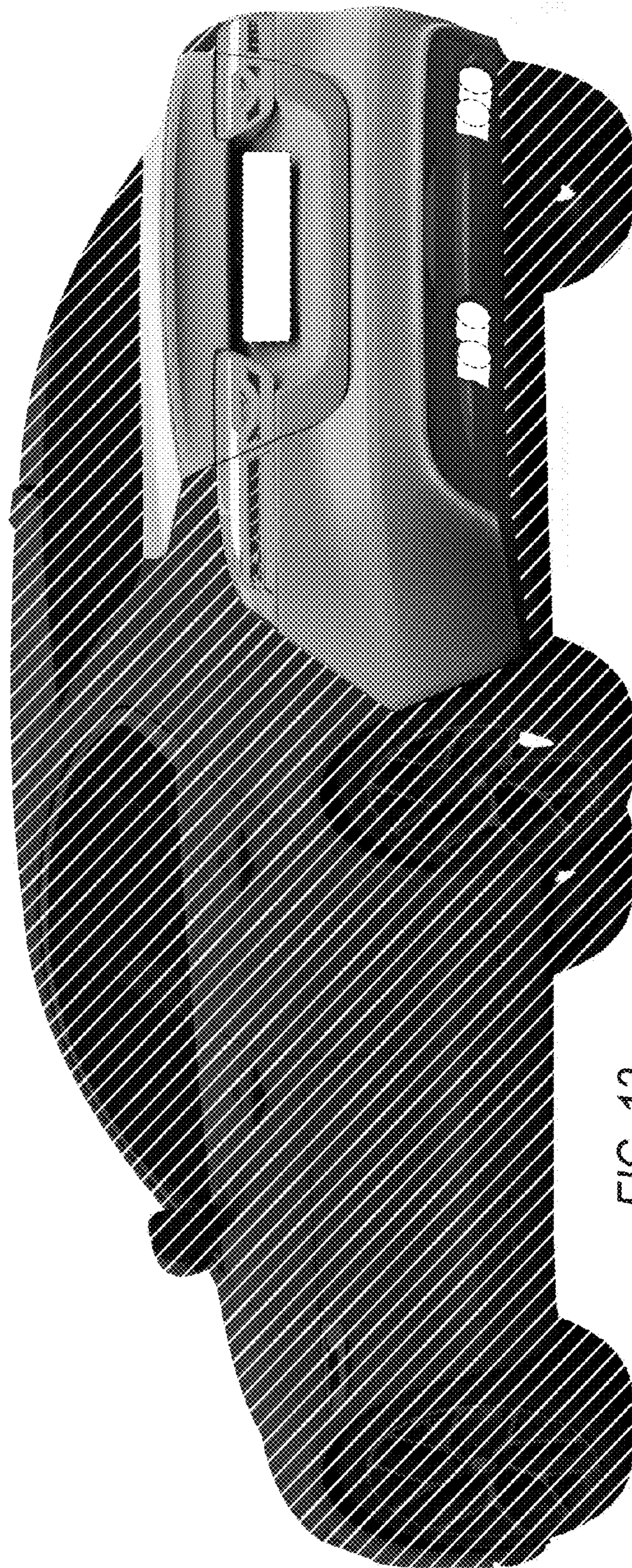

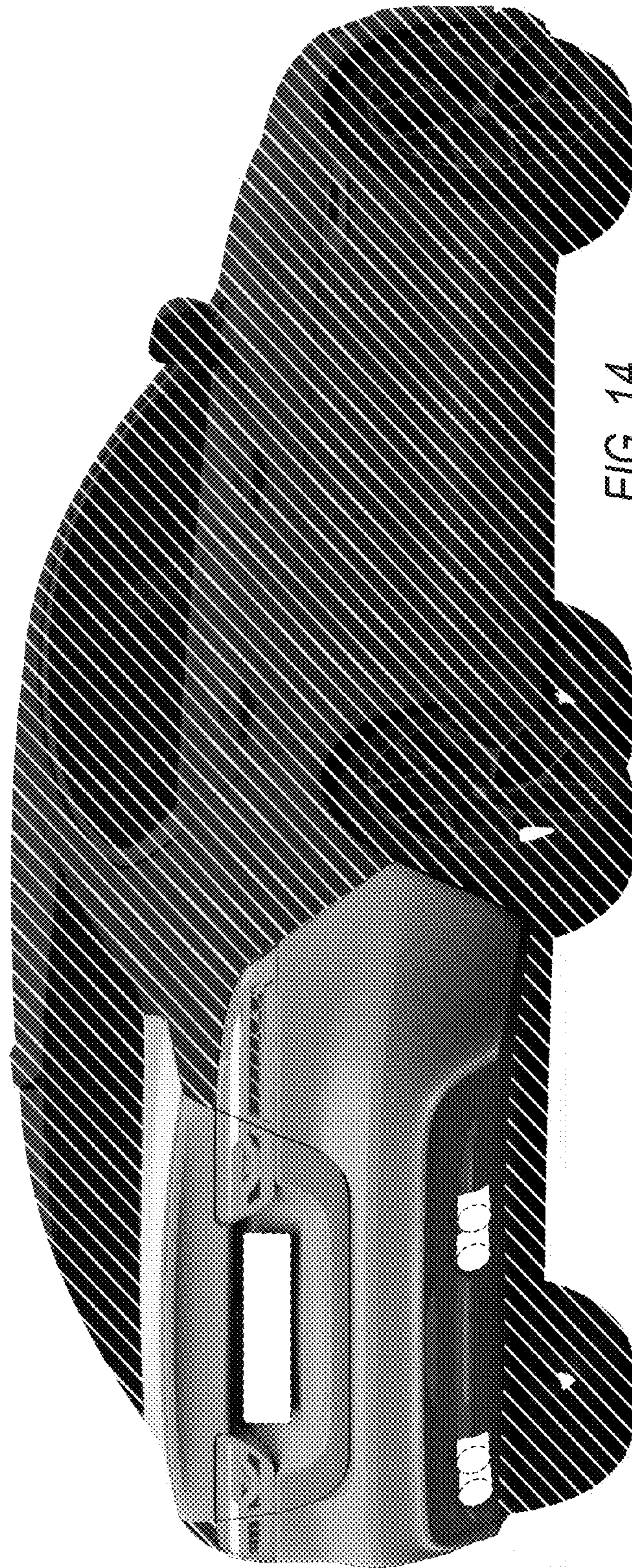

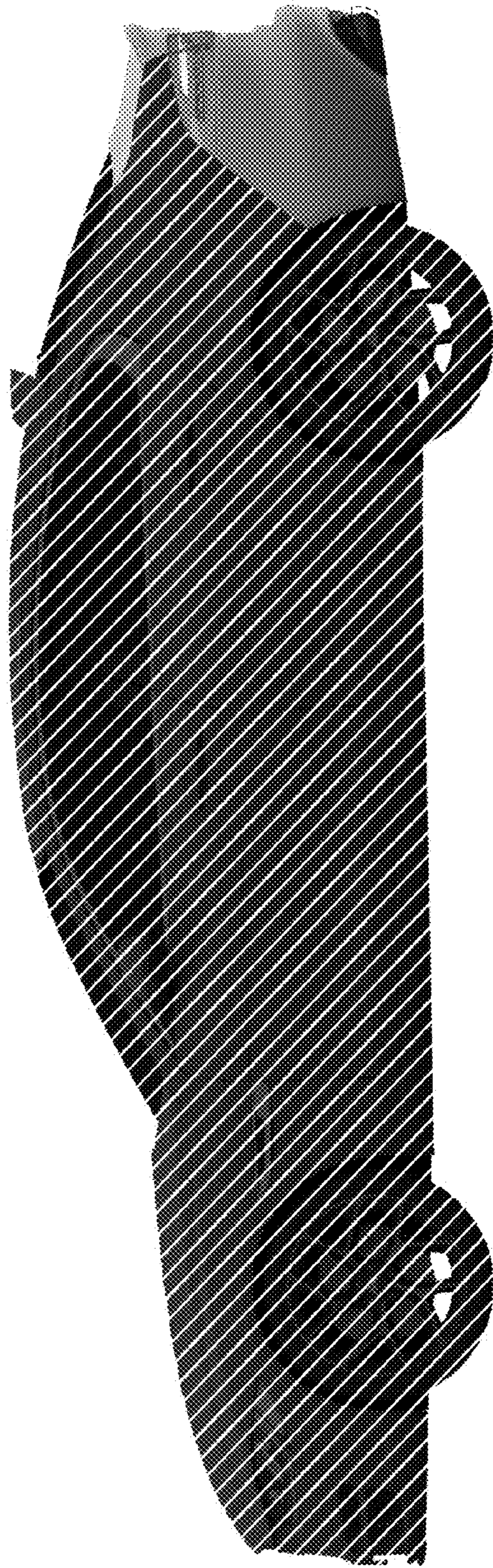

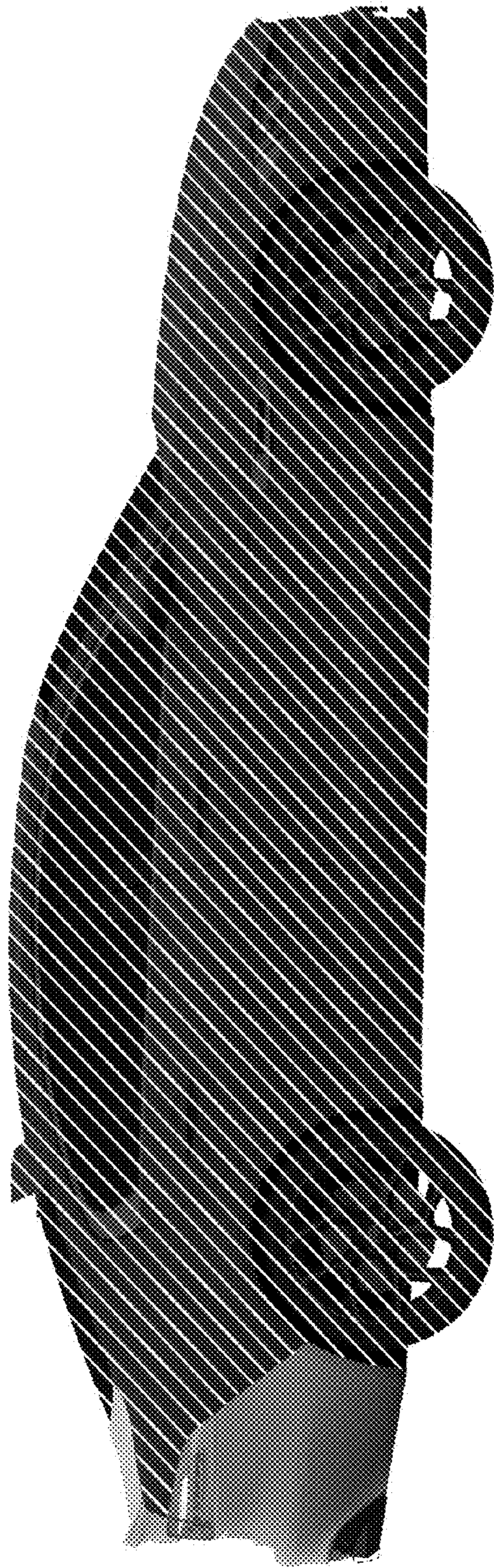

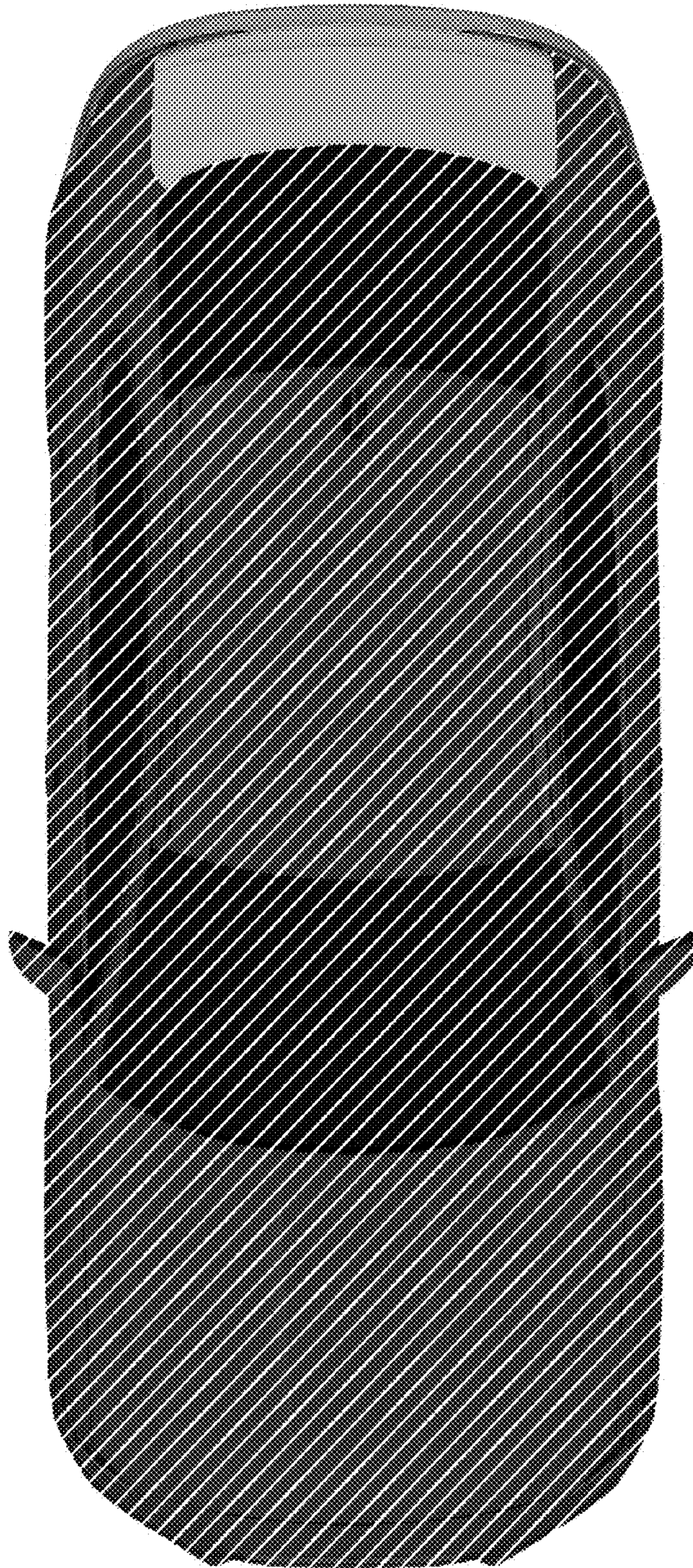
