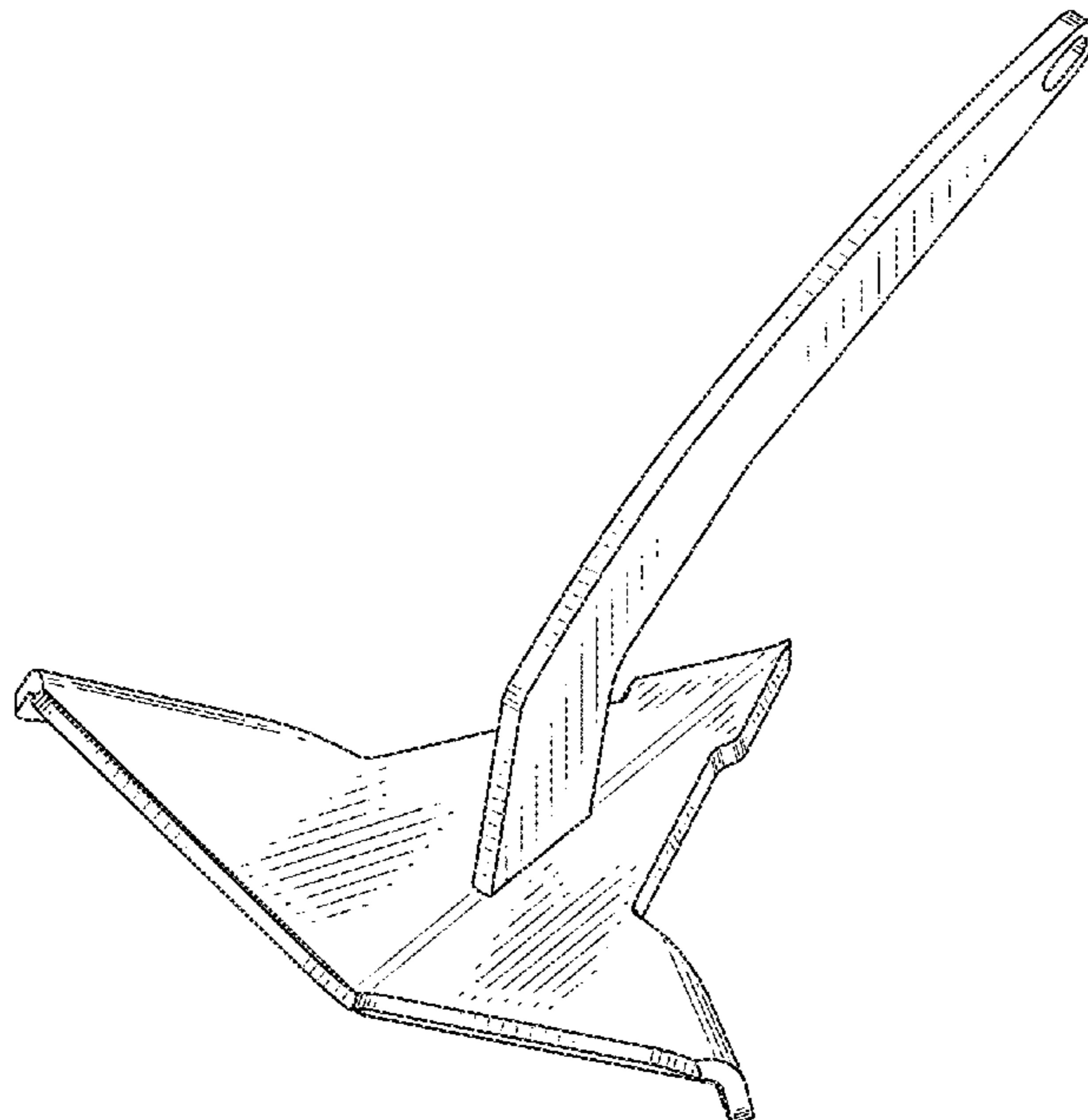

DESCRIPTION

FIG. 1 is a high angle isometric view of an anchor showing our new design;

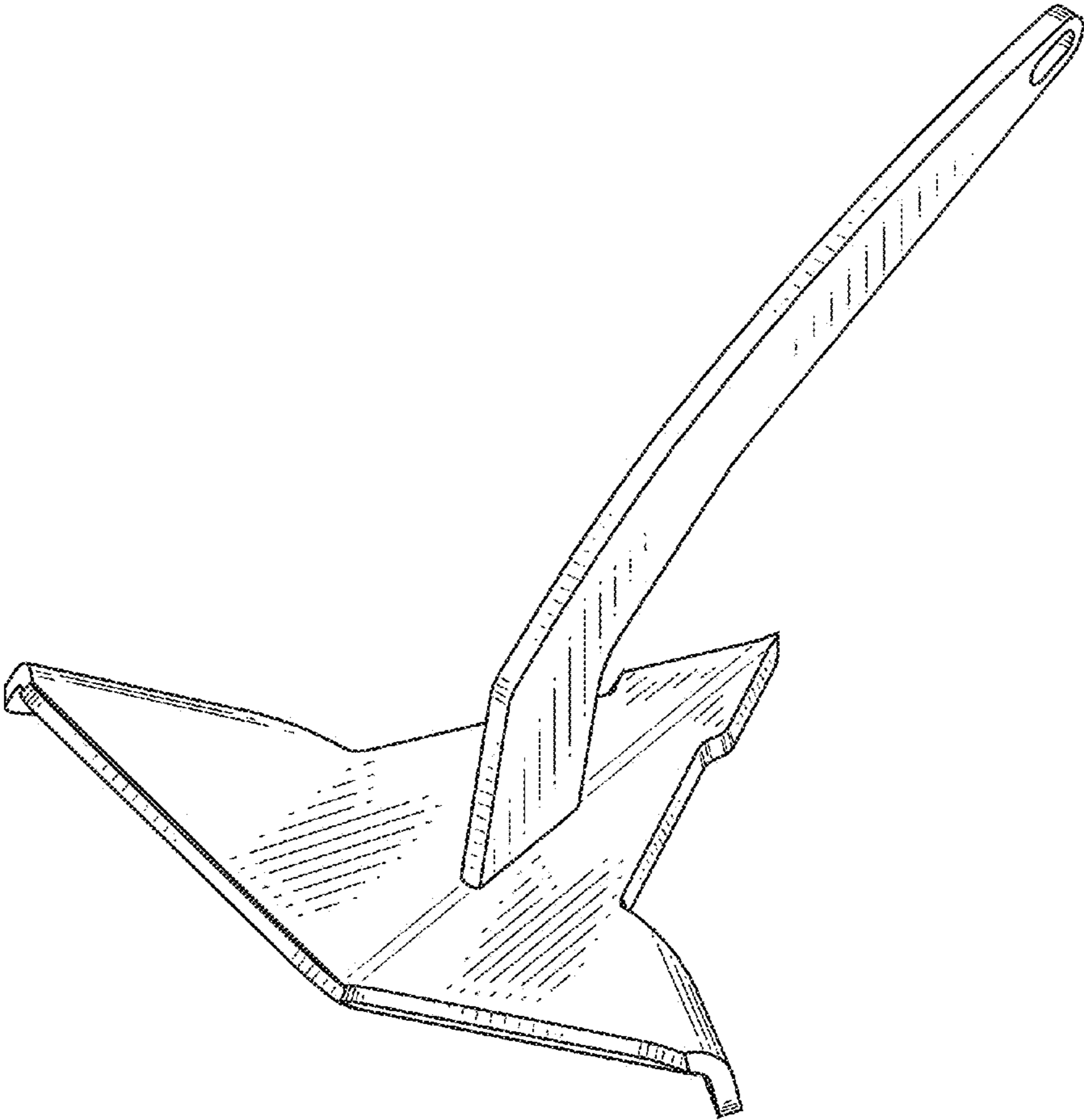

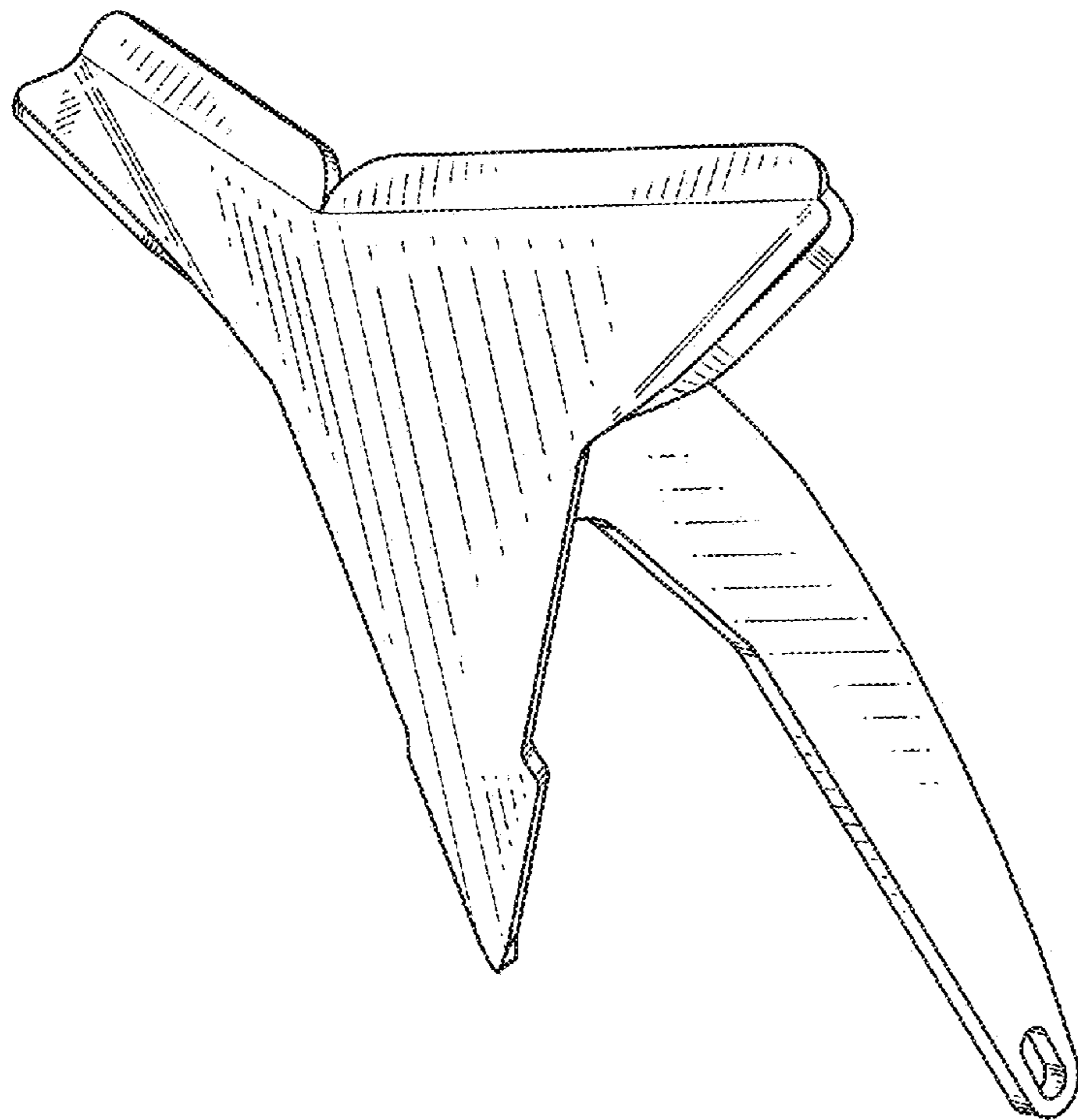

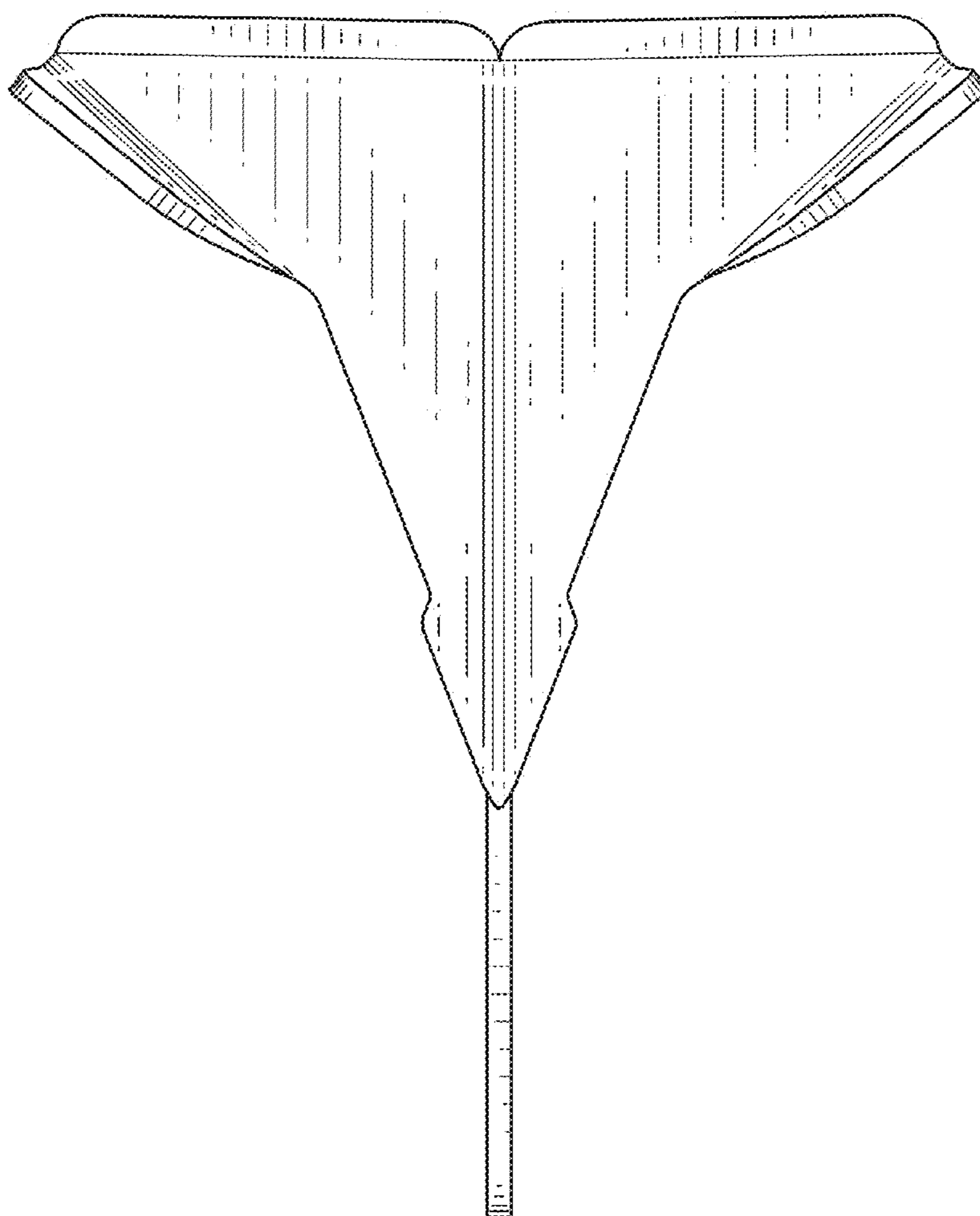

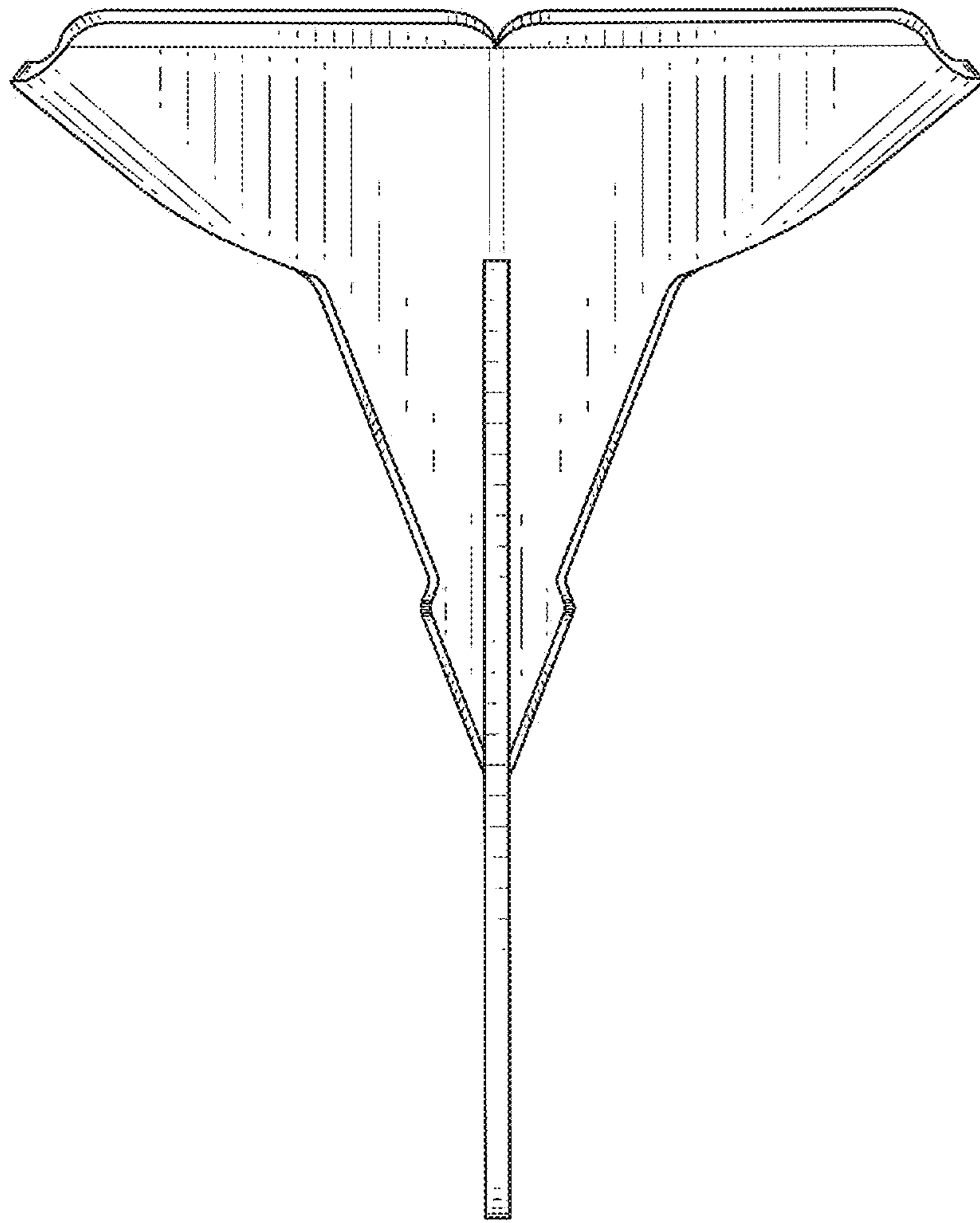

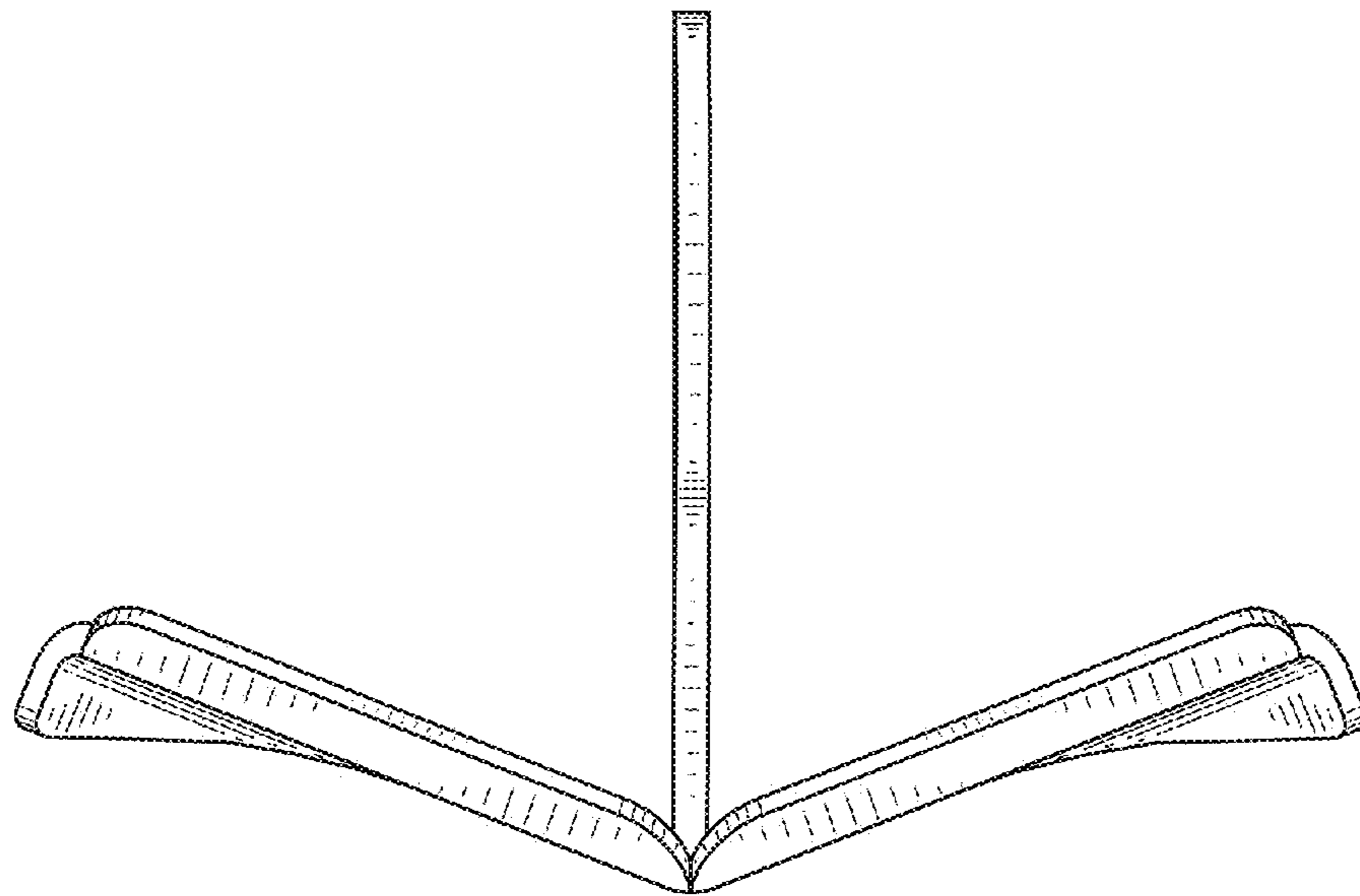

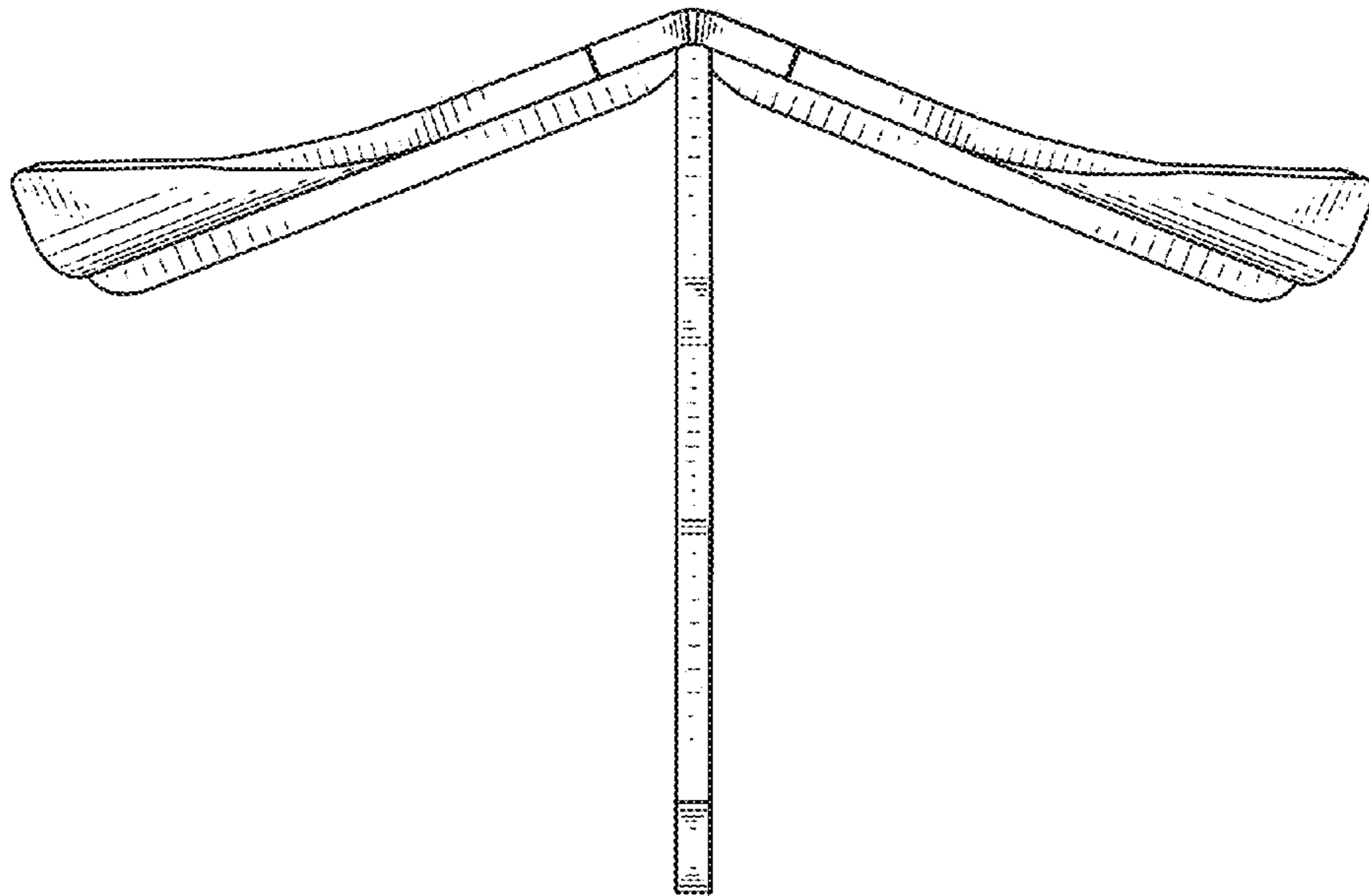

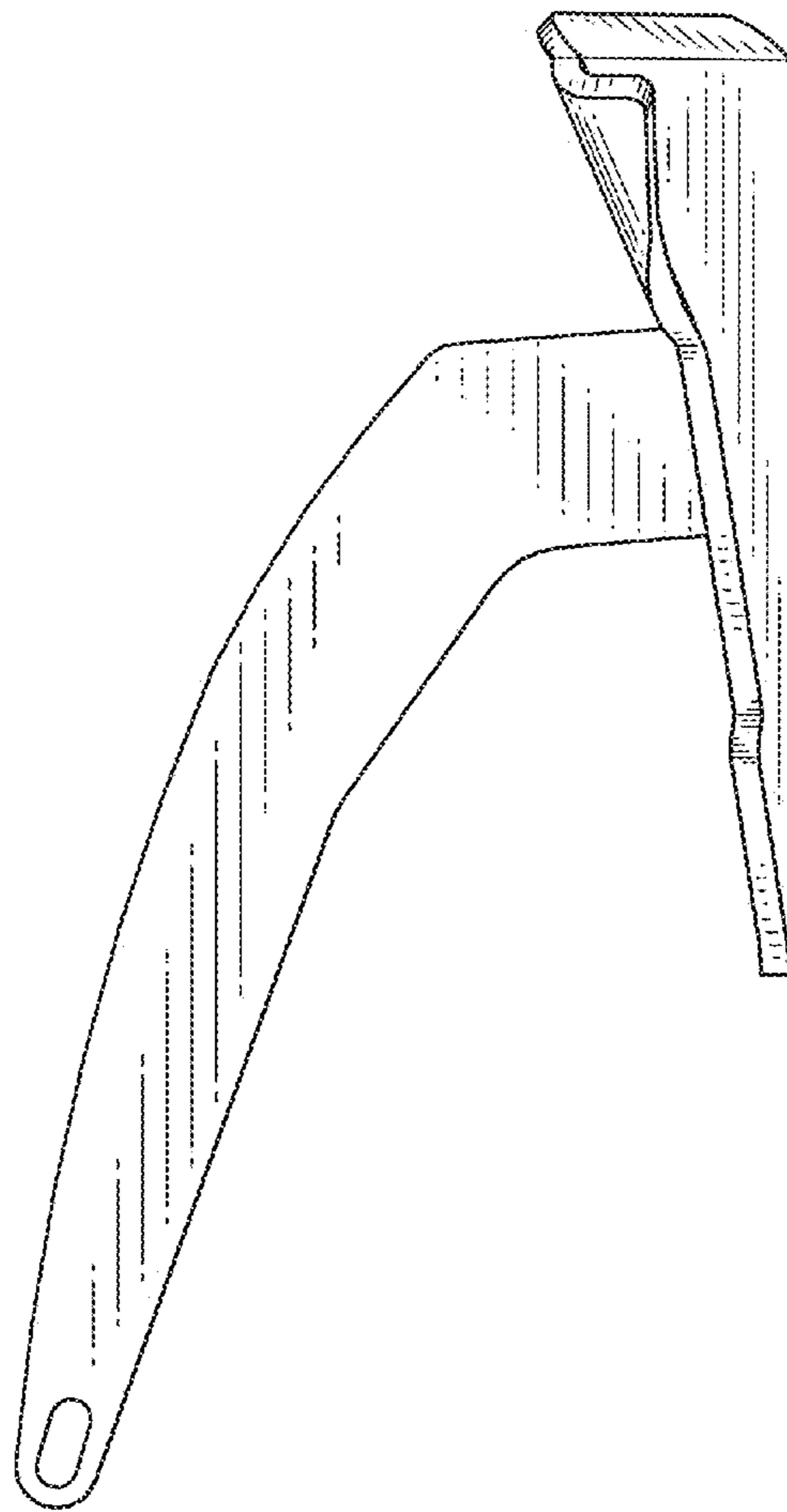

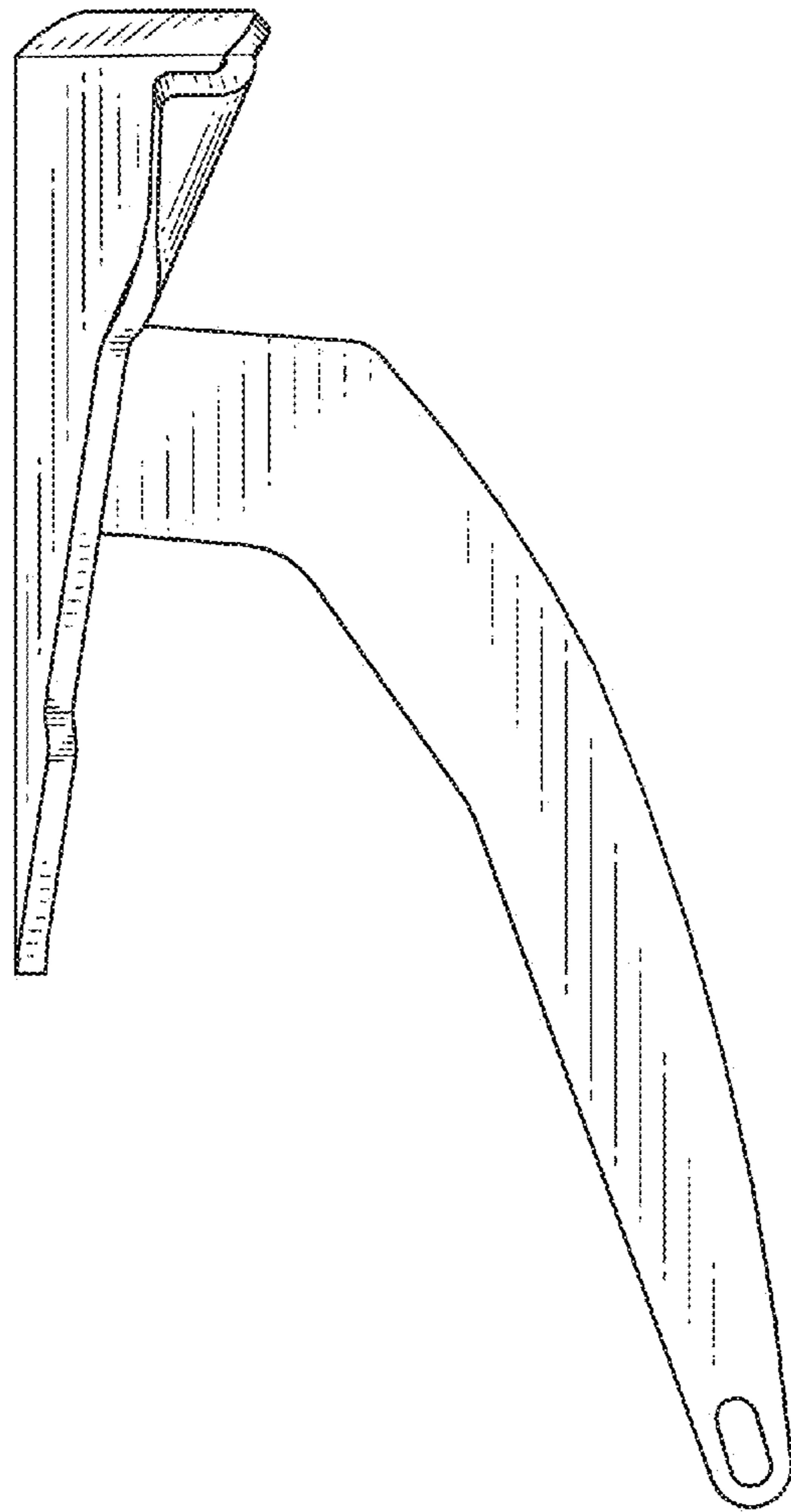
