(57) **CLAIM**

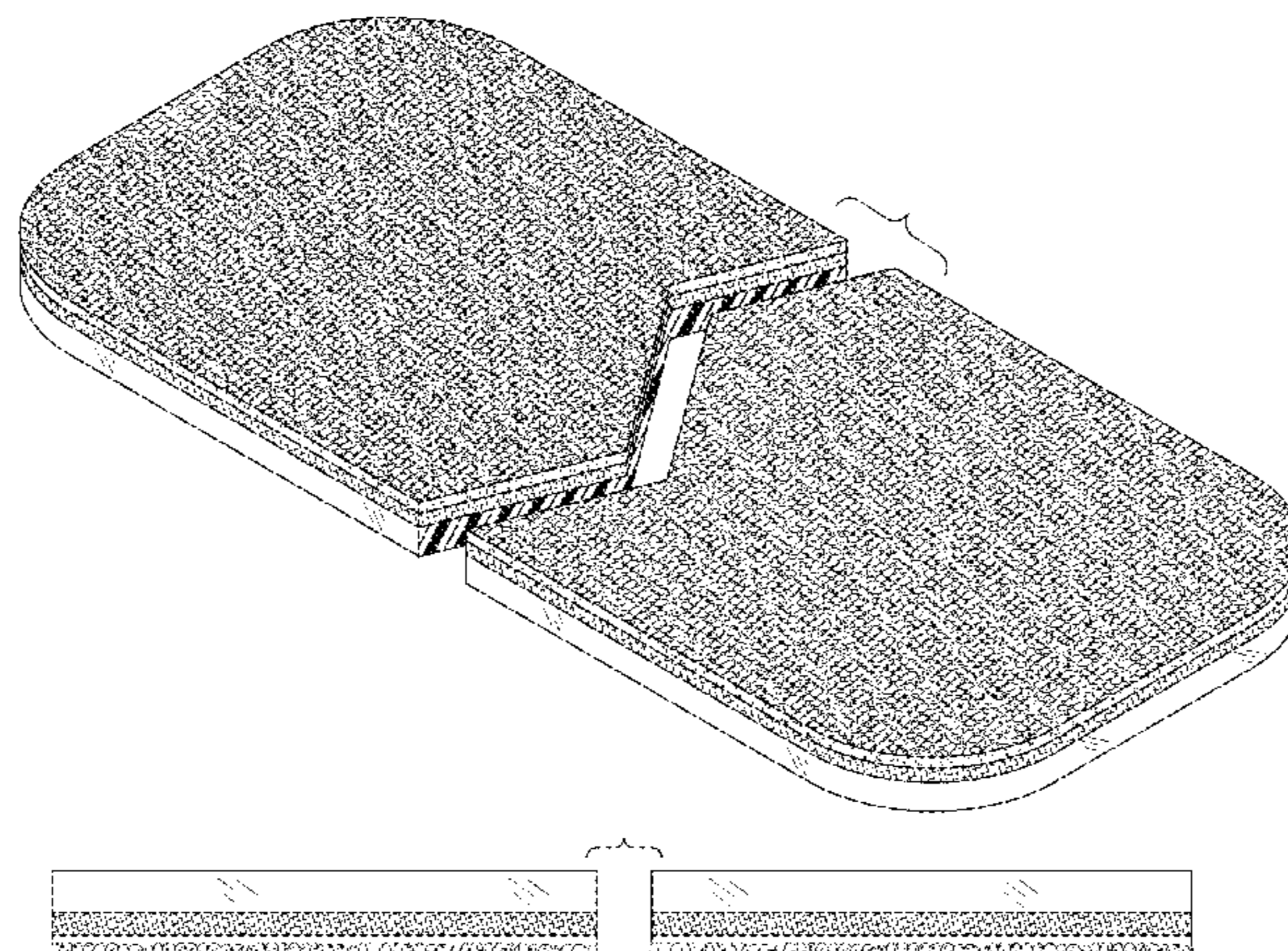
The ornamental design for a webcam cover, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a first embodiment of a webcam cover shown in a position of use, covering a webcam on an electronic device;  
FIG. 2 is a perspective view thereof as used to clean a screen on an electronic device;  
FIG. 3 is a front perspective view thereof;  
FIG. 4 is a front elevational view thereof;  
FIG. 5 is a right elevational view thereof;  
FIG. 6 is a left elevational view thereof;  
FIG. 7 is a top plan view thereof;  
FIG. 8 is a bottom plan view thereof;  
FIG. 9 is a rear elevational view thereof;  
FIG. 10 is a front perspective view of a second embodiment of a webcam cover;  
FIG. 11 is a front elevational view thereof;  
FIG. 12 is a right elevational view thereof;  
FIG. 13 is a left elevational view thereof;  
FIG. 14 is a top plan view thereof;  
FIG. 15 is a bottom plan view thereof; and,  
FIG. 16 is a rear elevational view thereof.

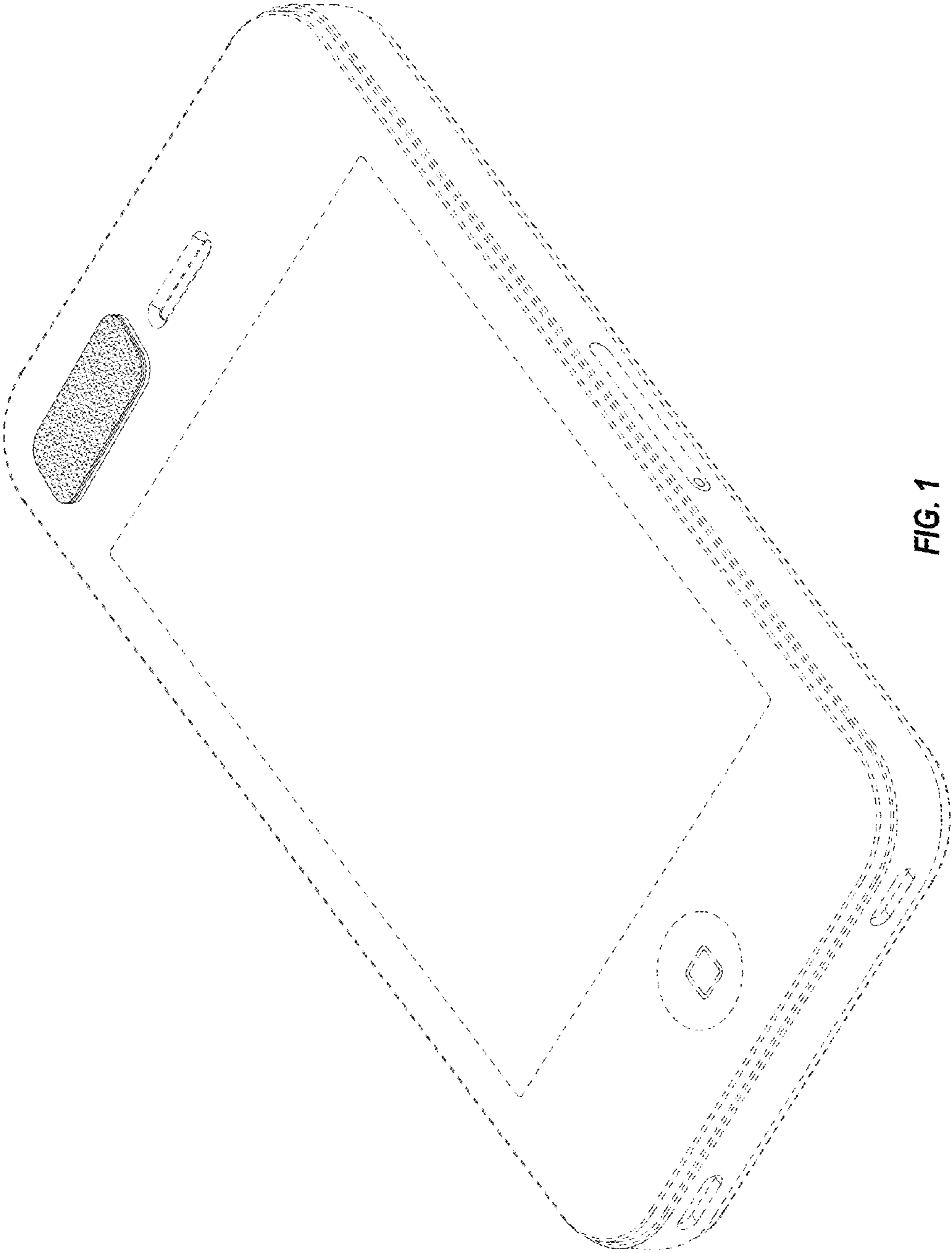

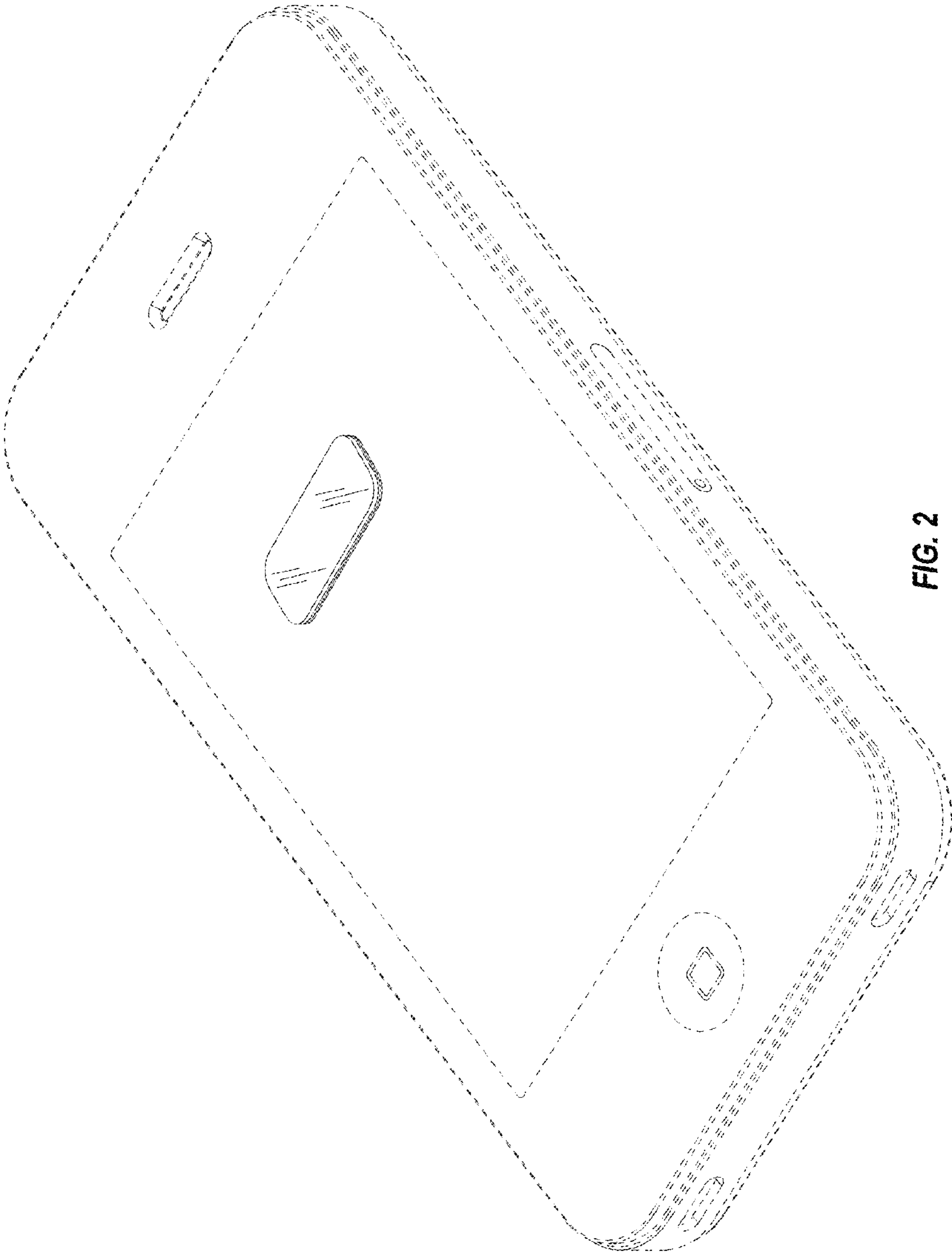

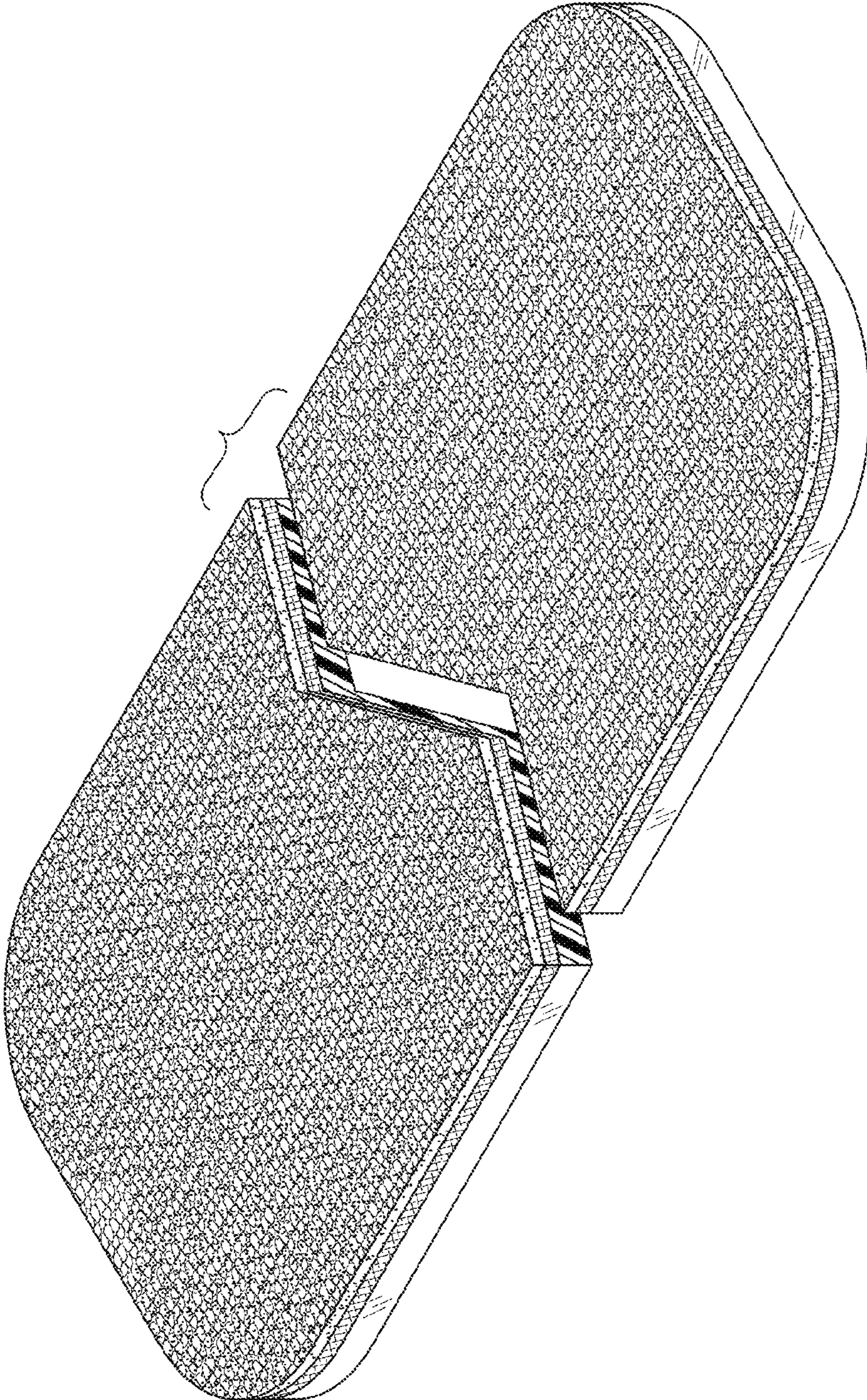

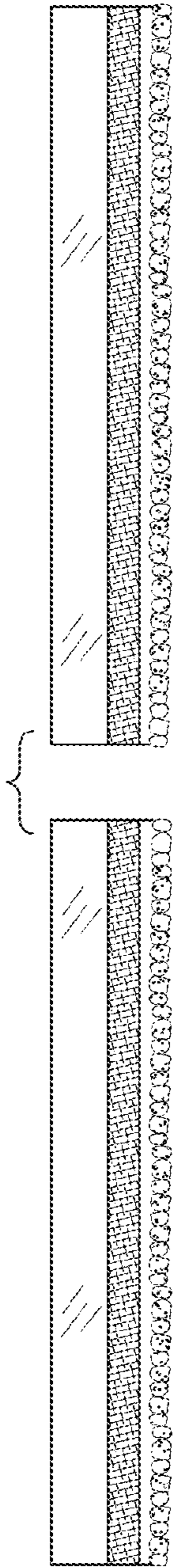

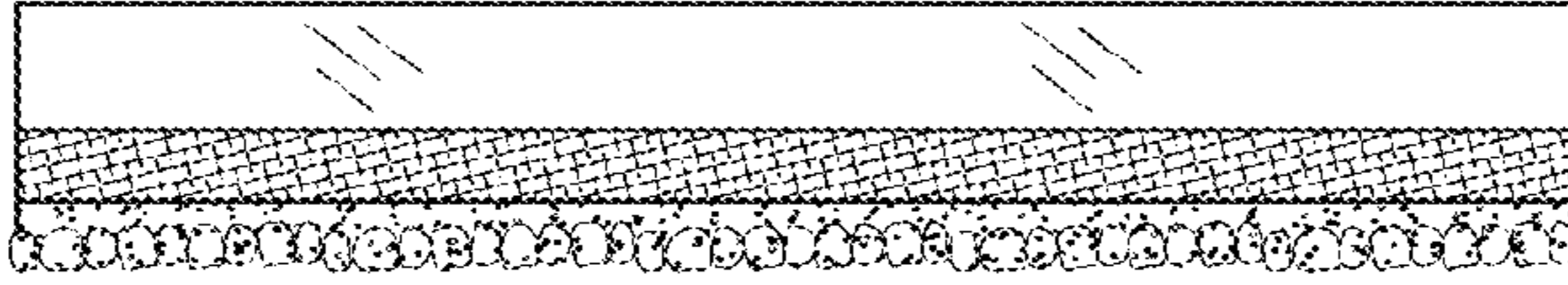

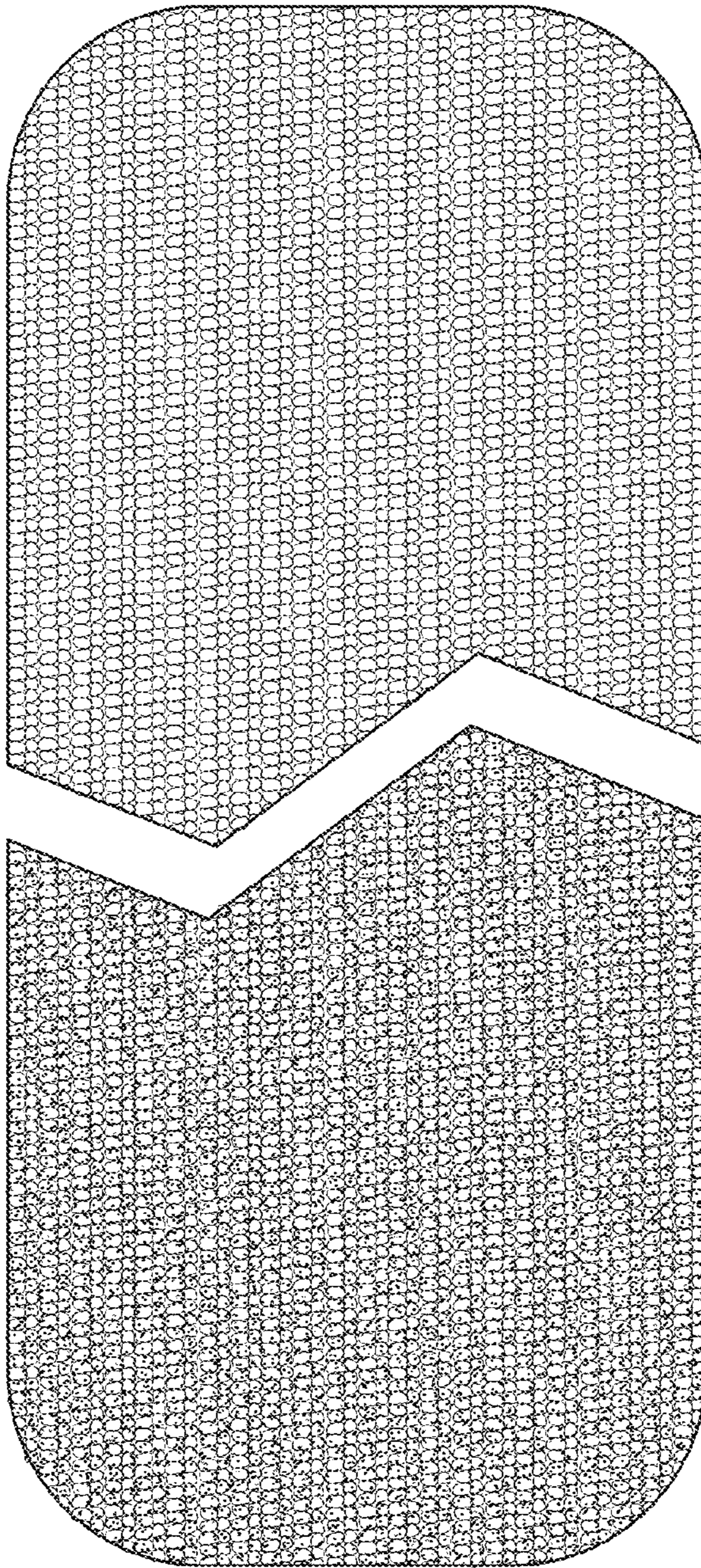

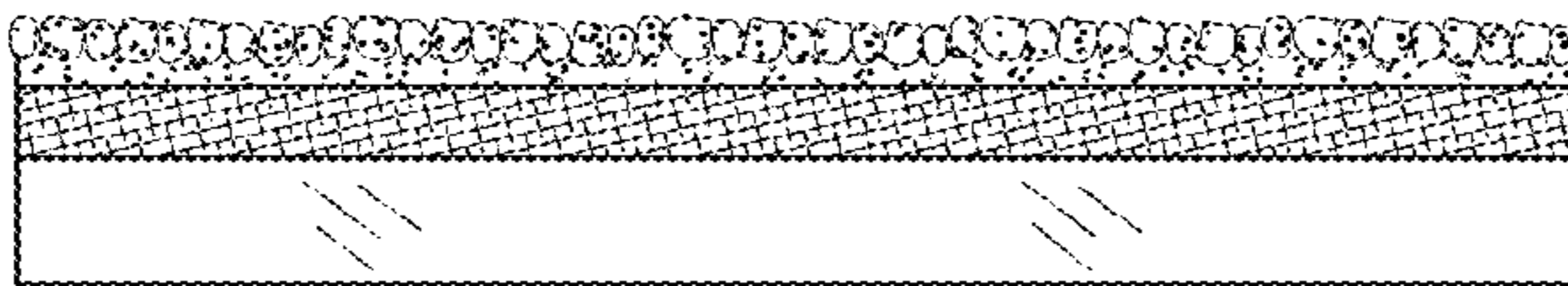

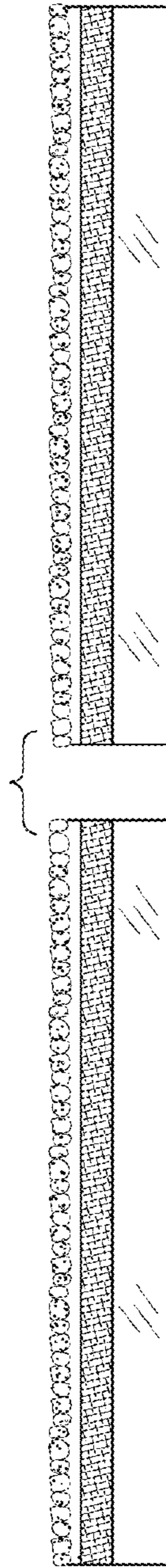

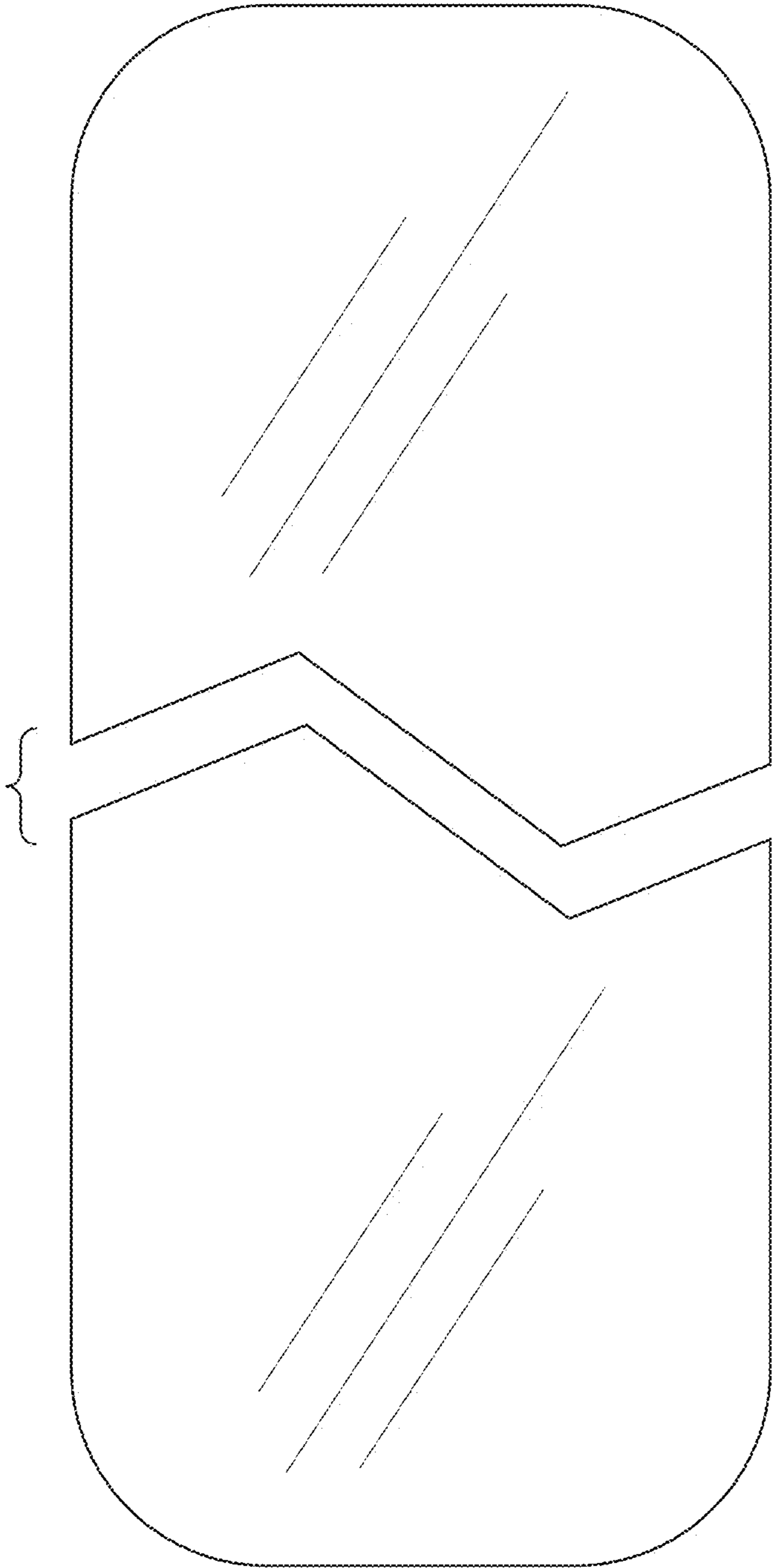

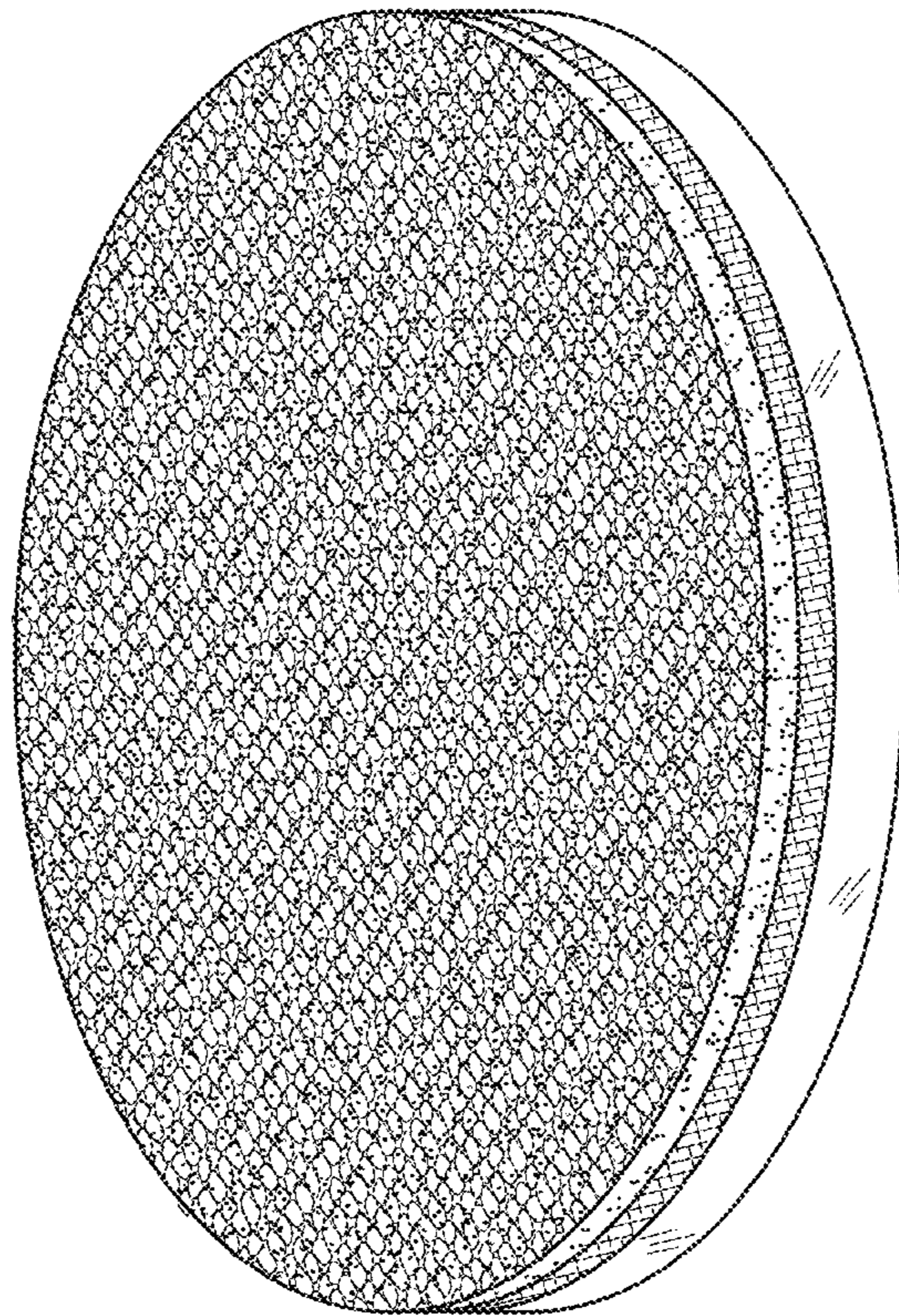

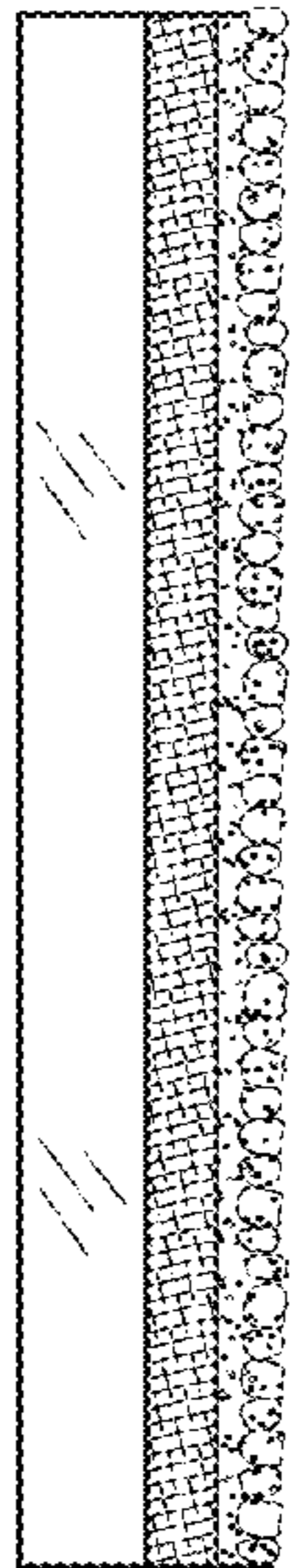

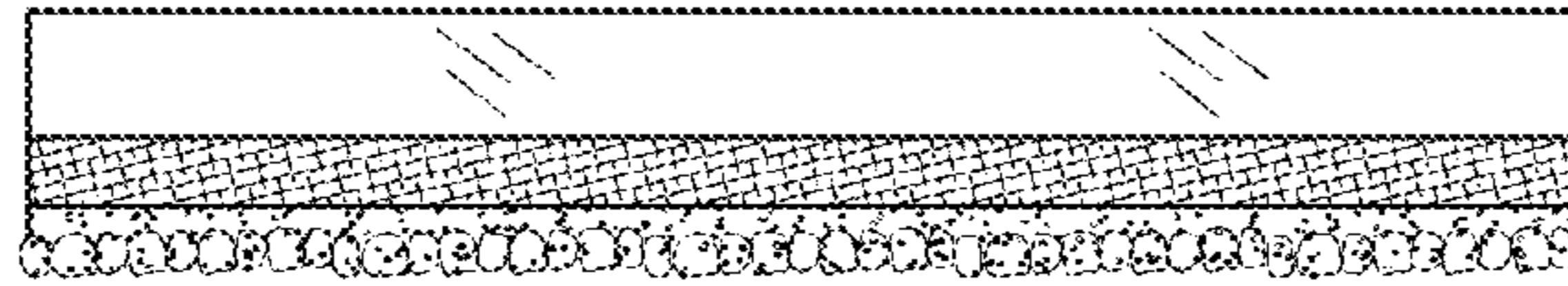

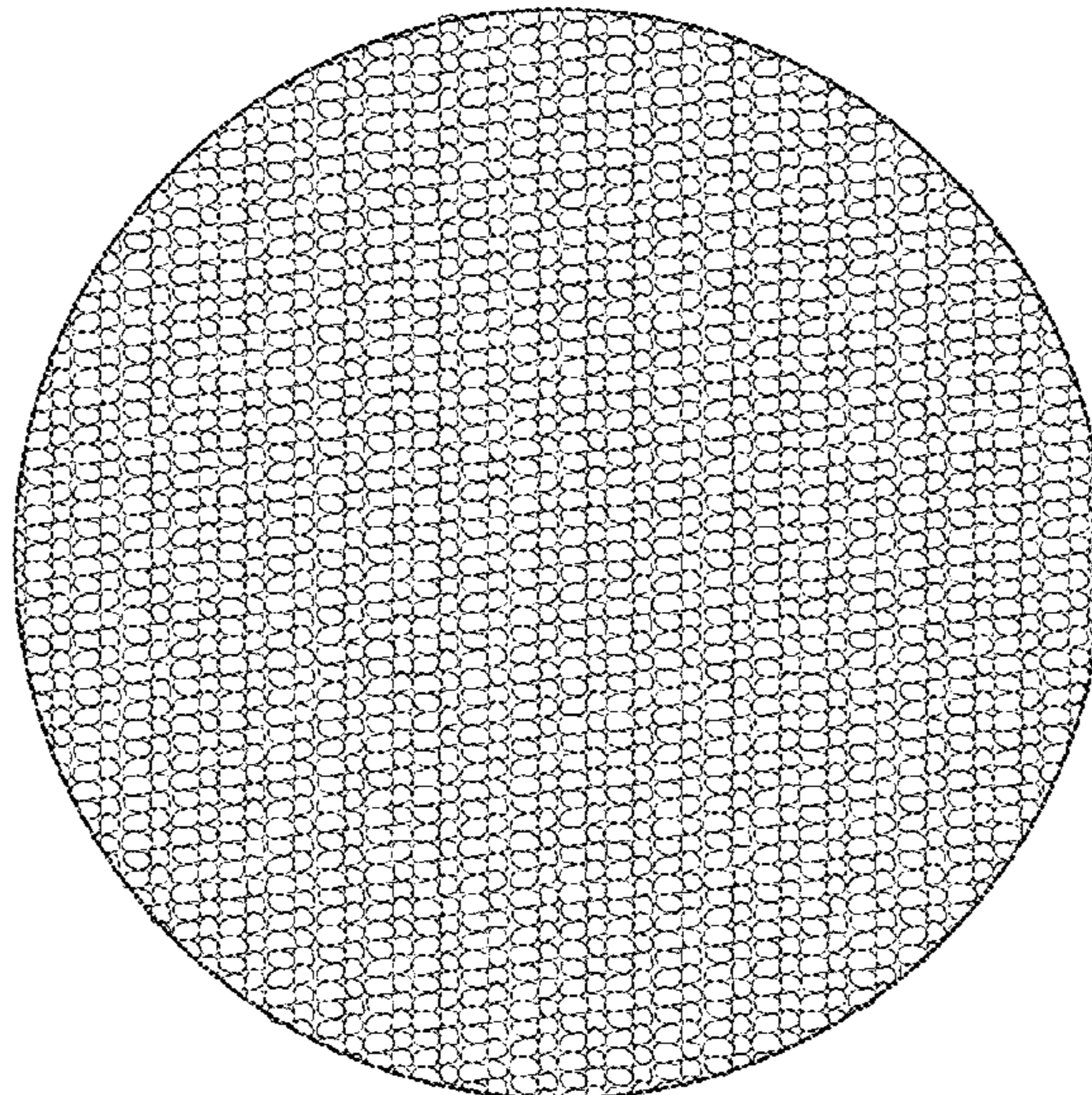

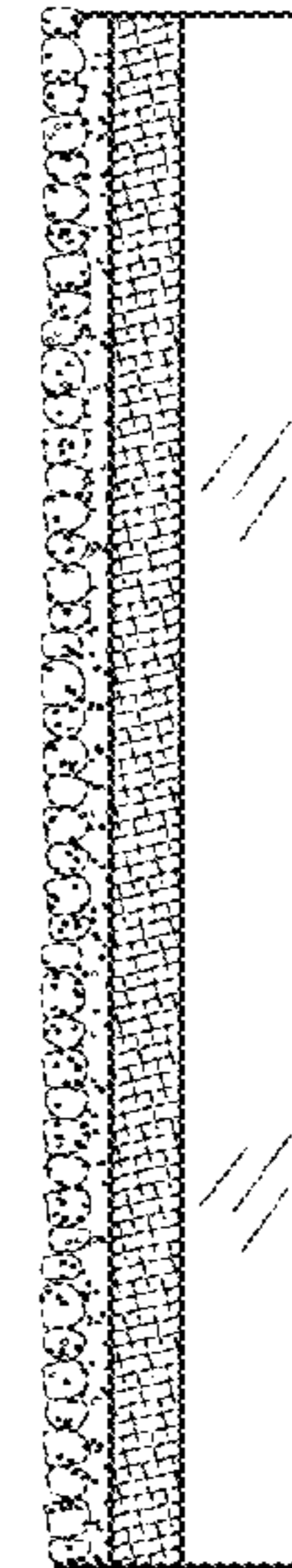

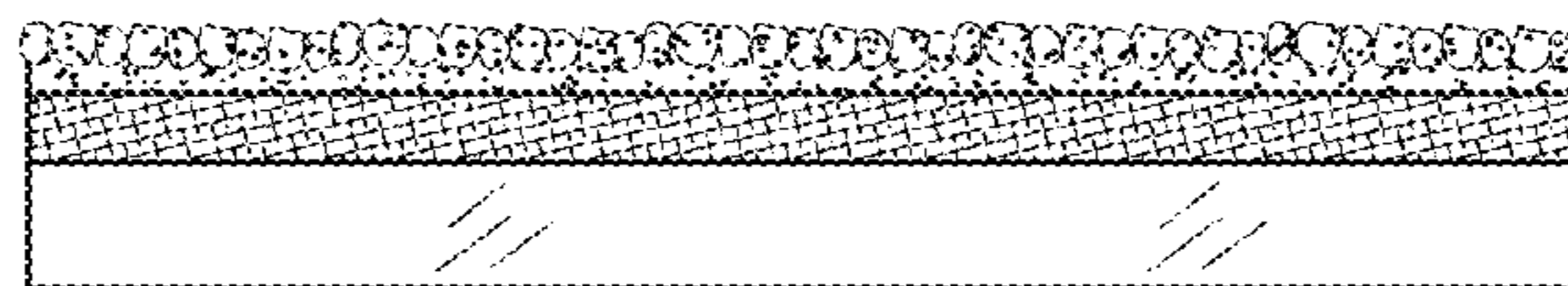

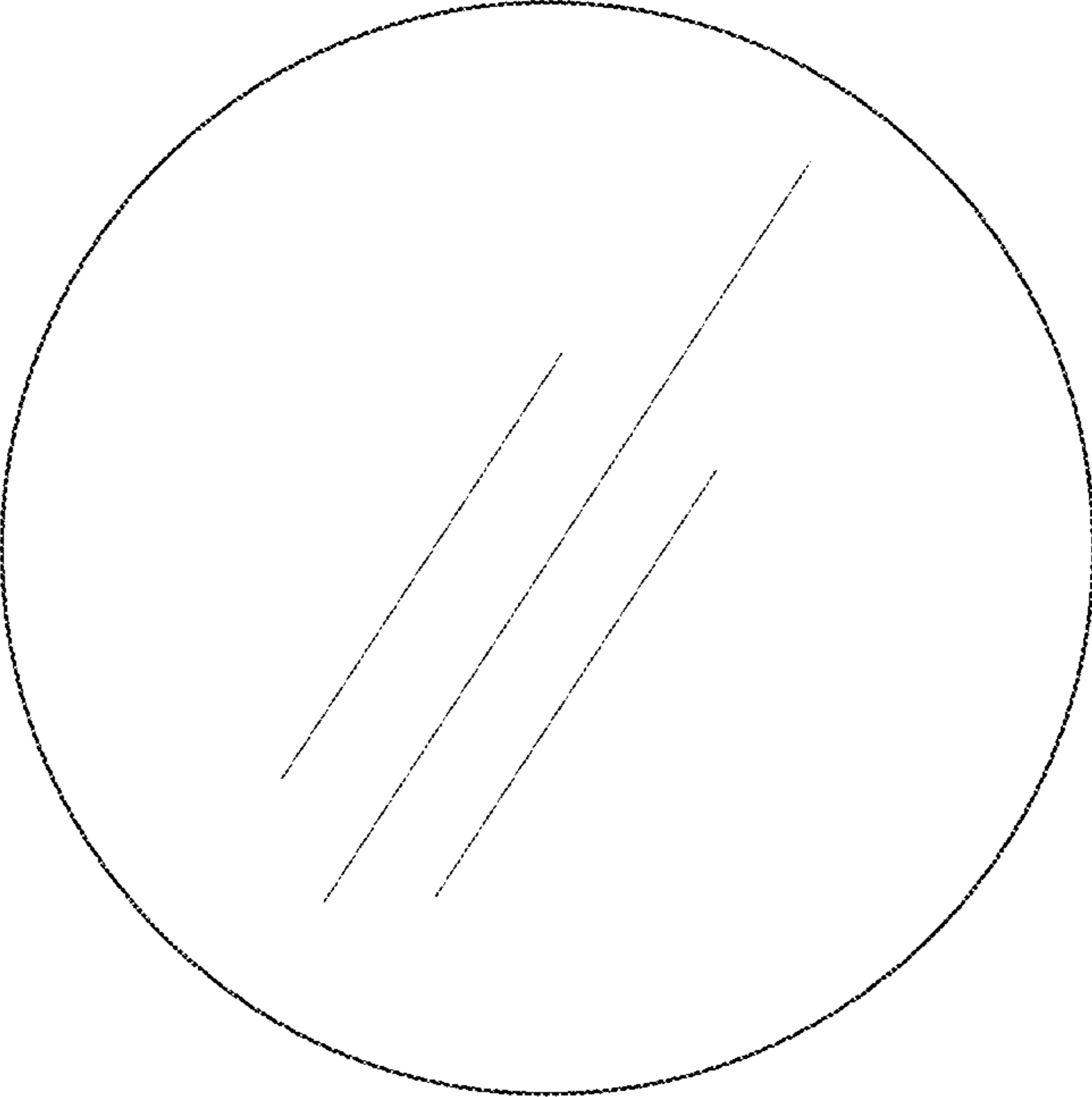
