(57) **CLAIM**

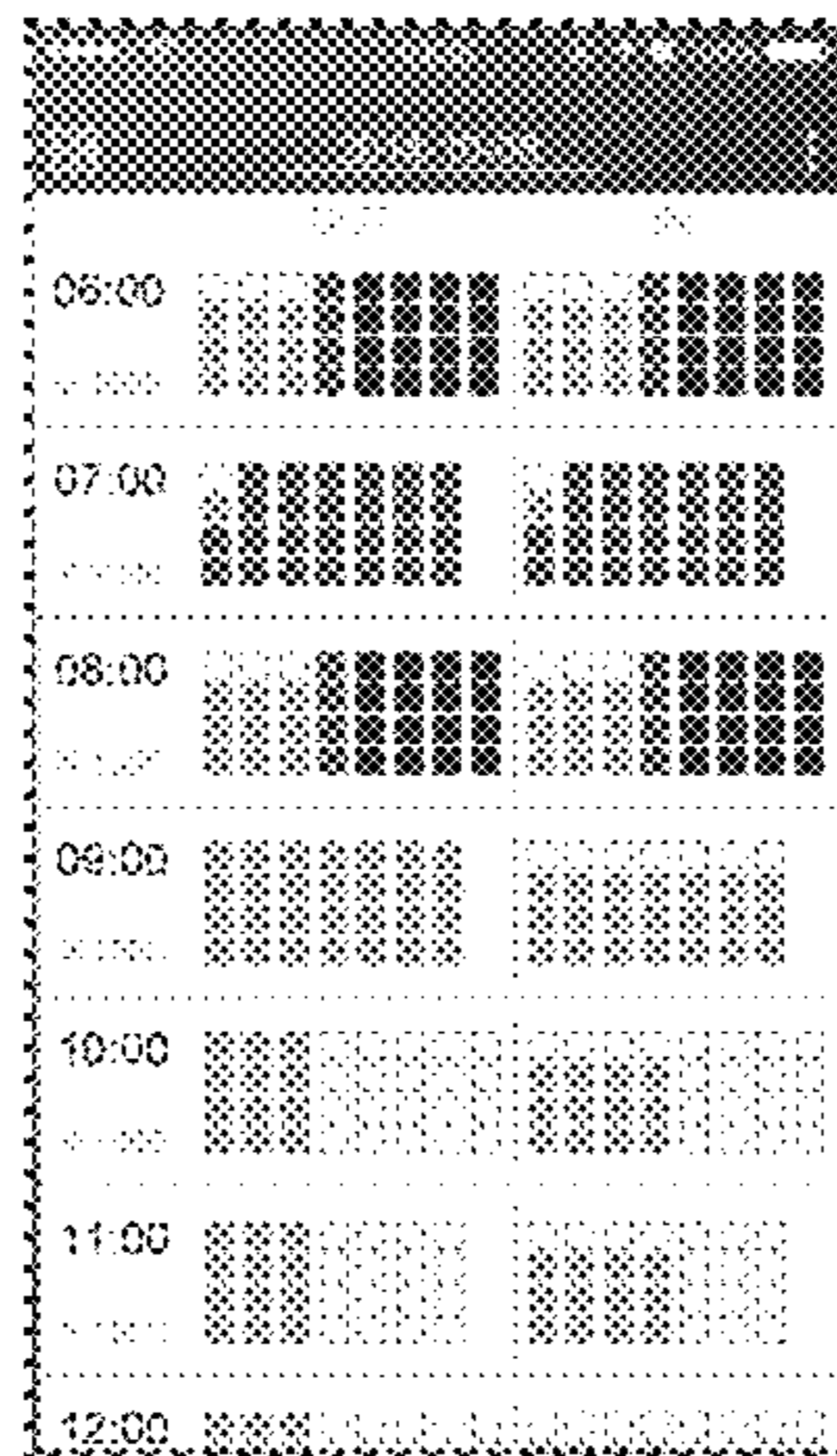
I claim, the ornamental design for display screen or portion thereof with graphical user interface, as shown and described.

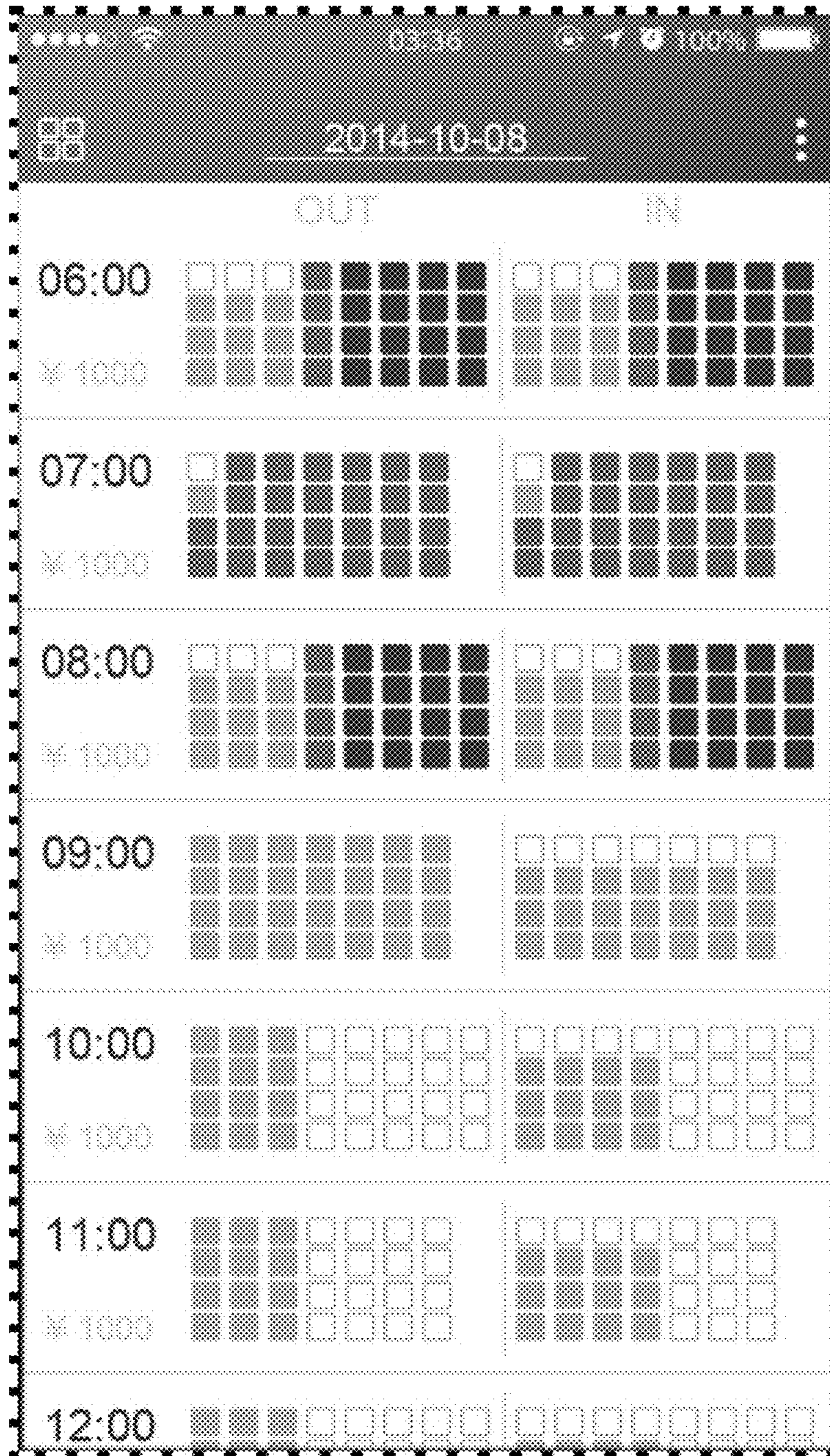

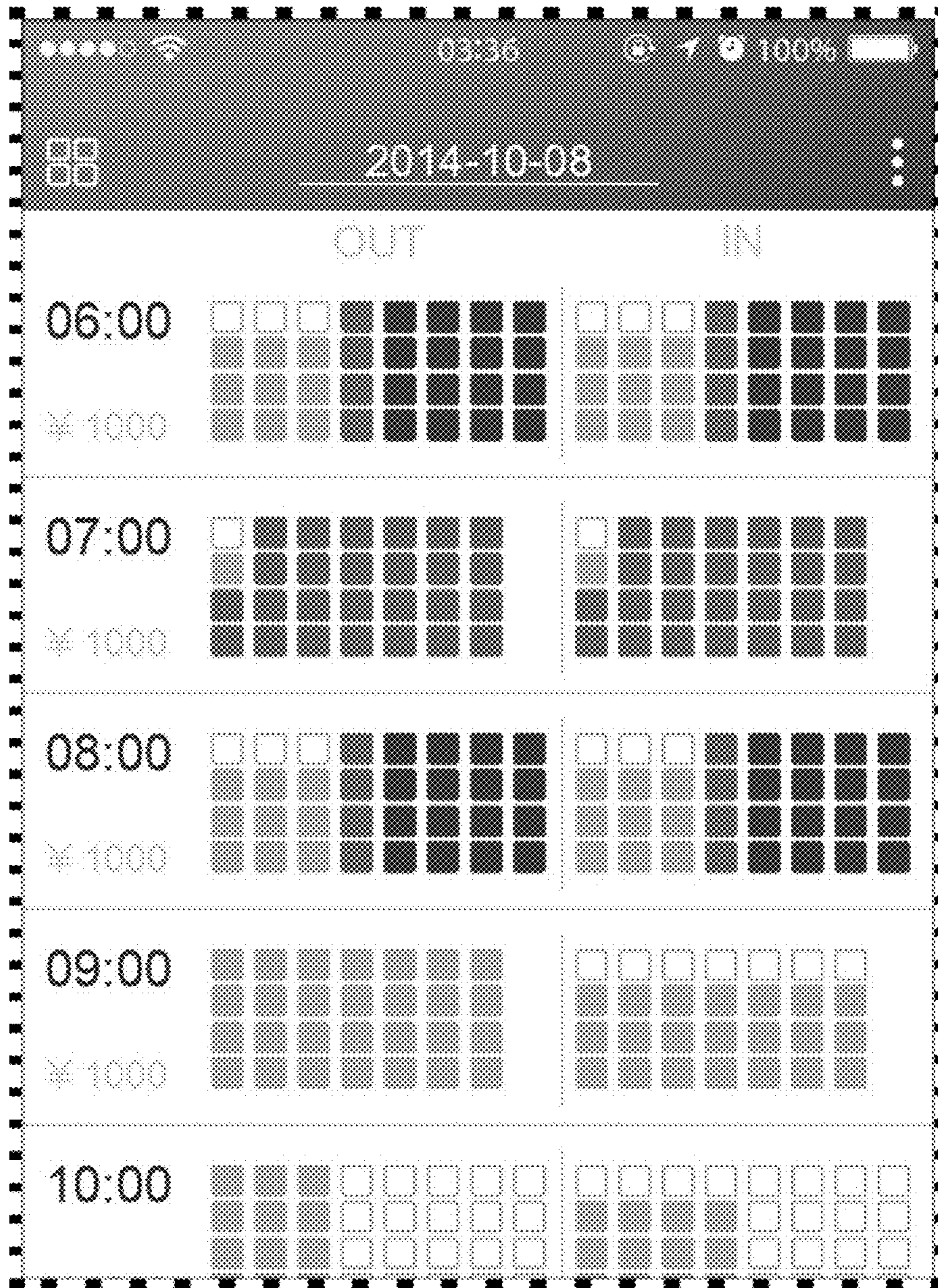
