ing my new design.

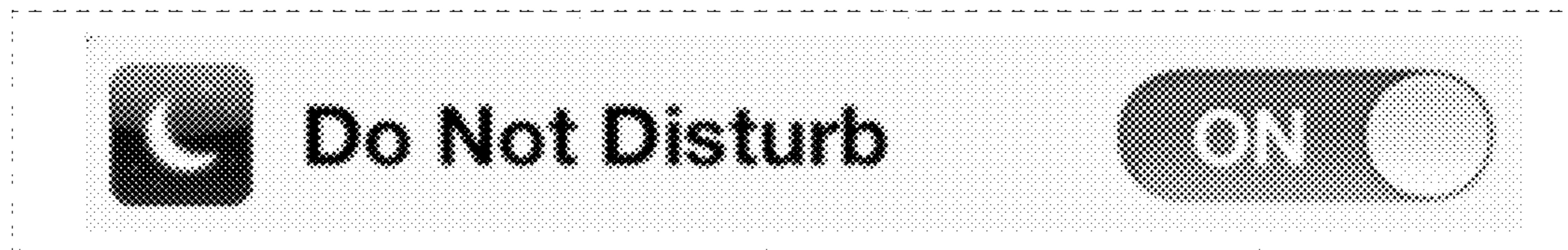

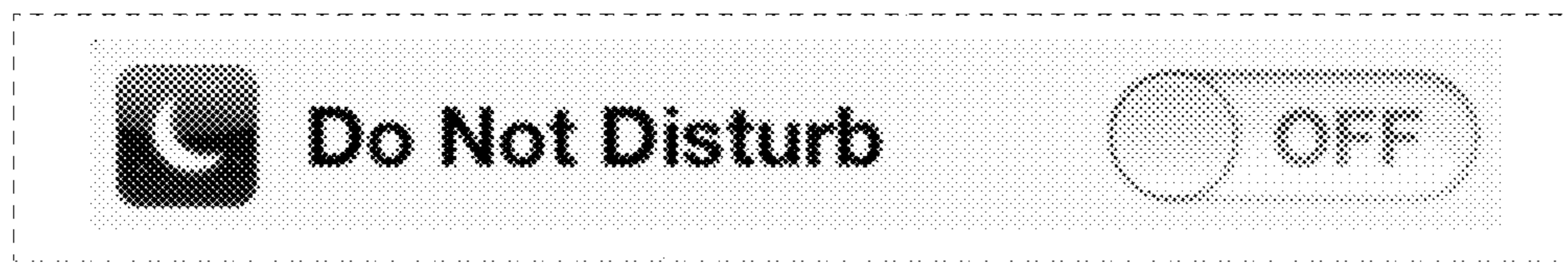

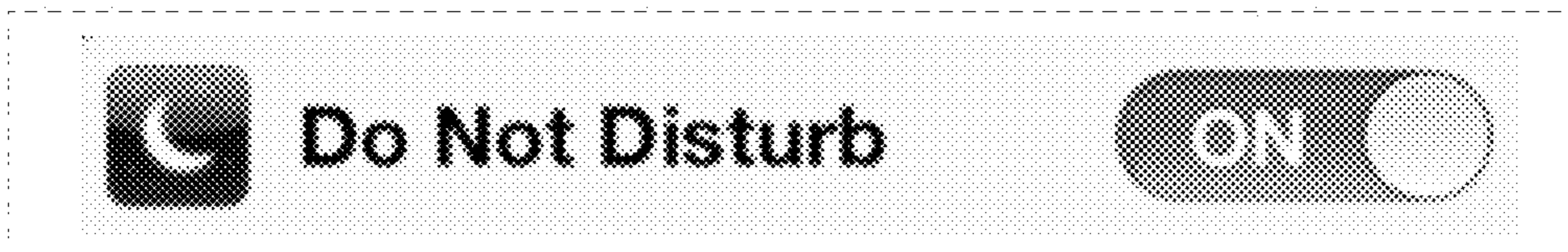

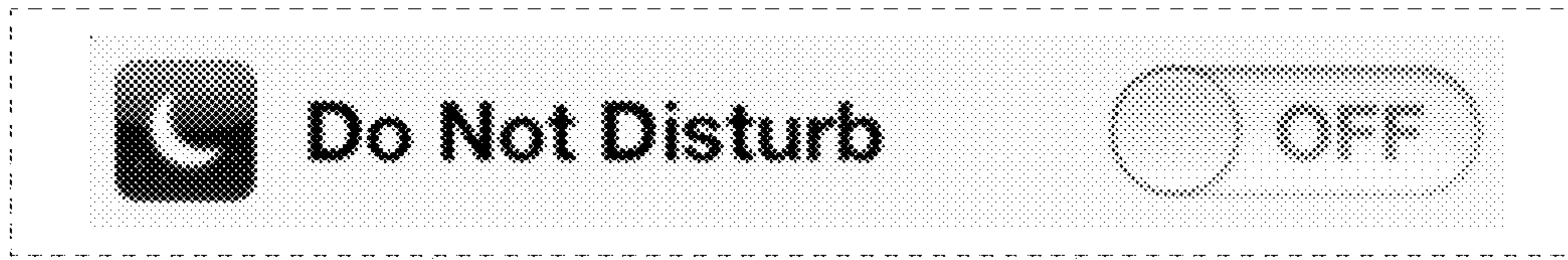

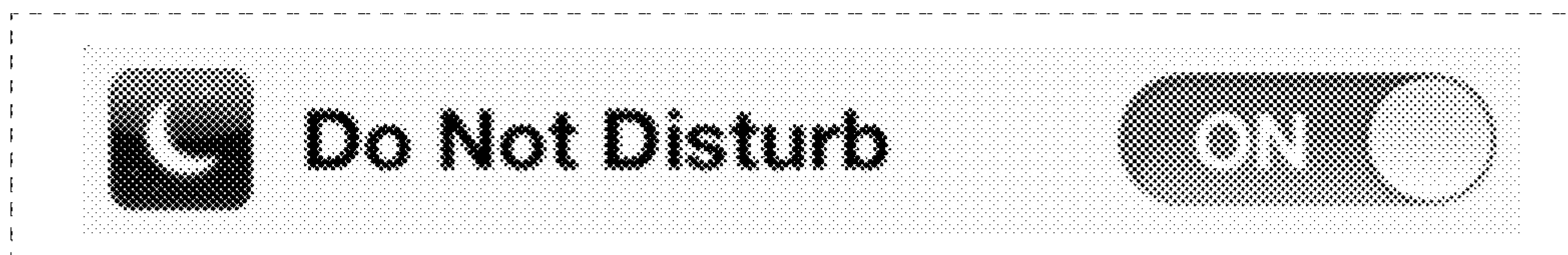
