(57) **CLAIM**

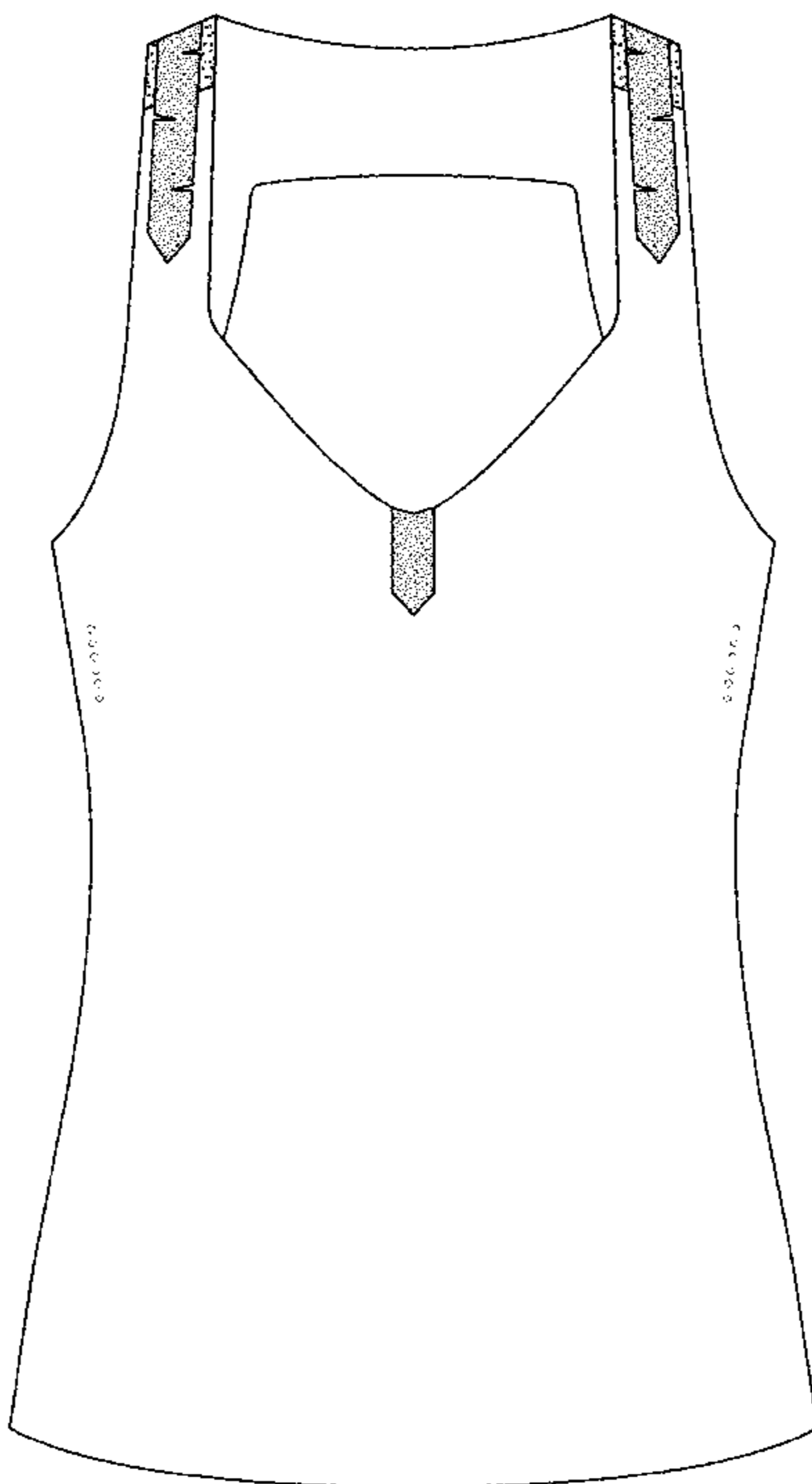
The ornamental design for a shirt, as shown and described.

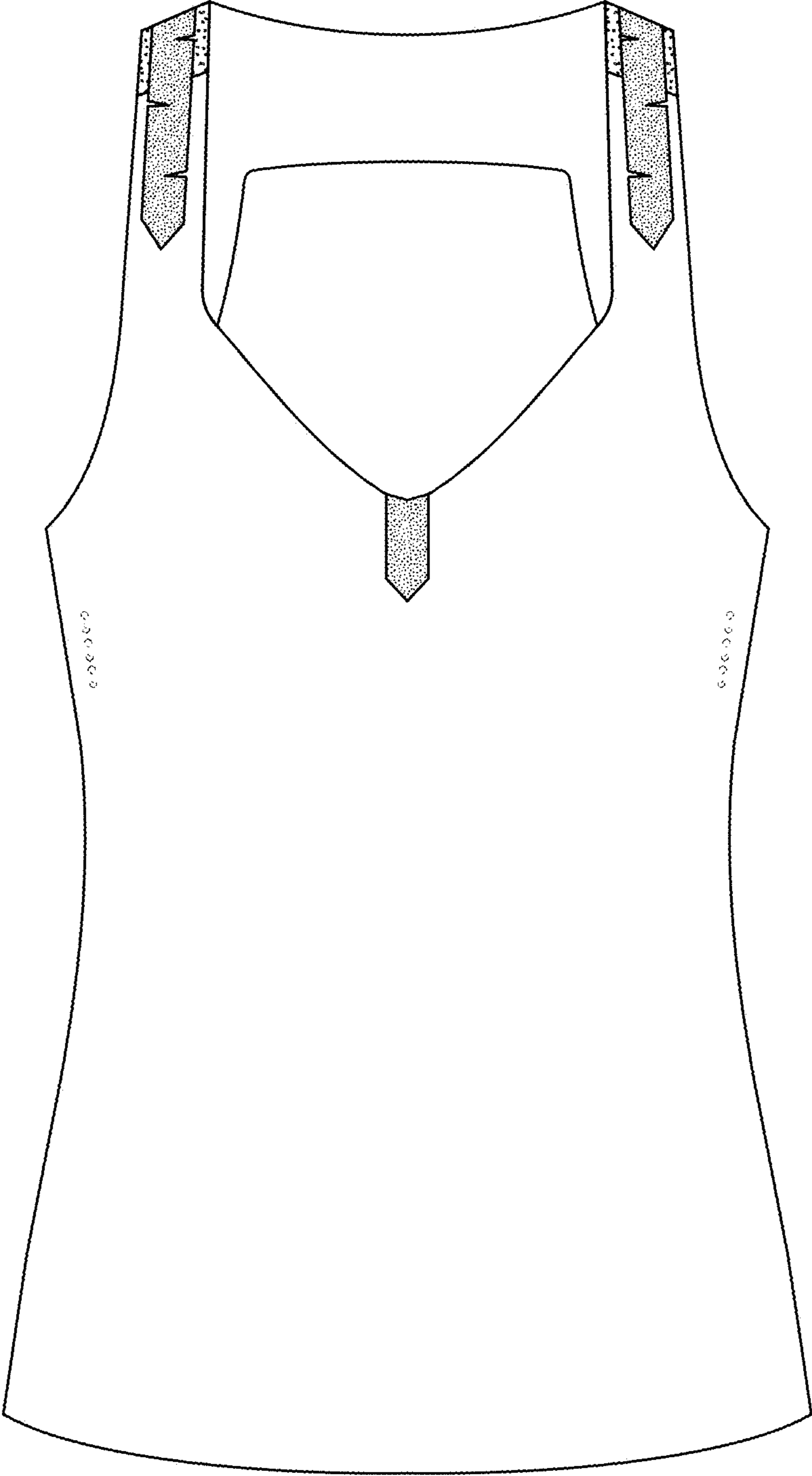

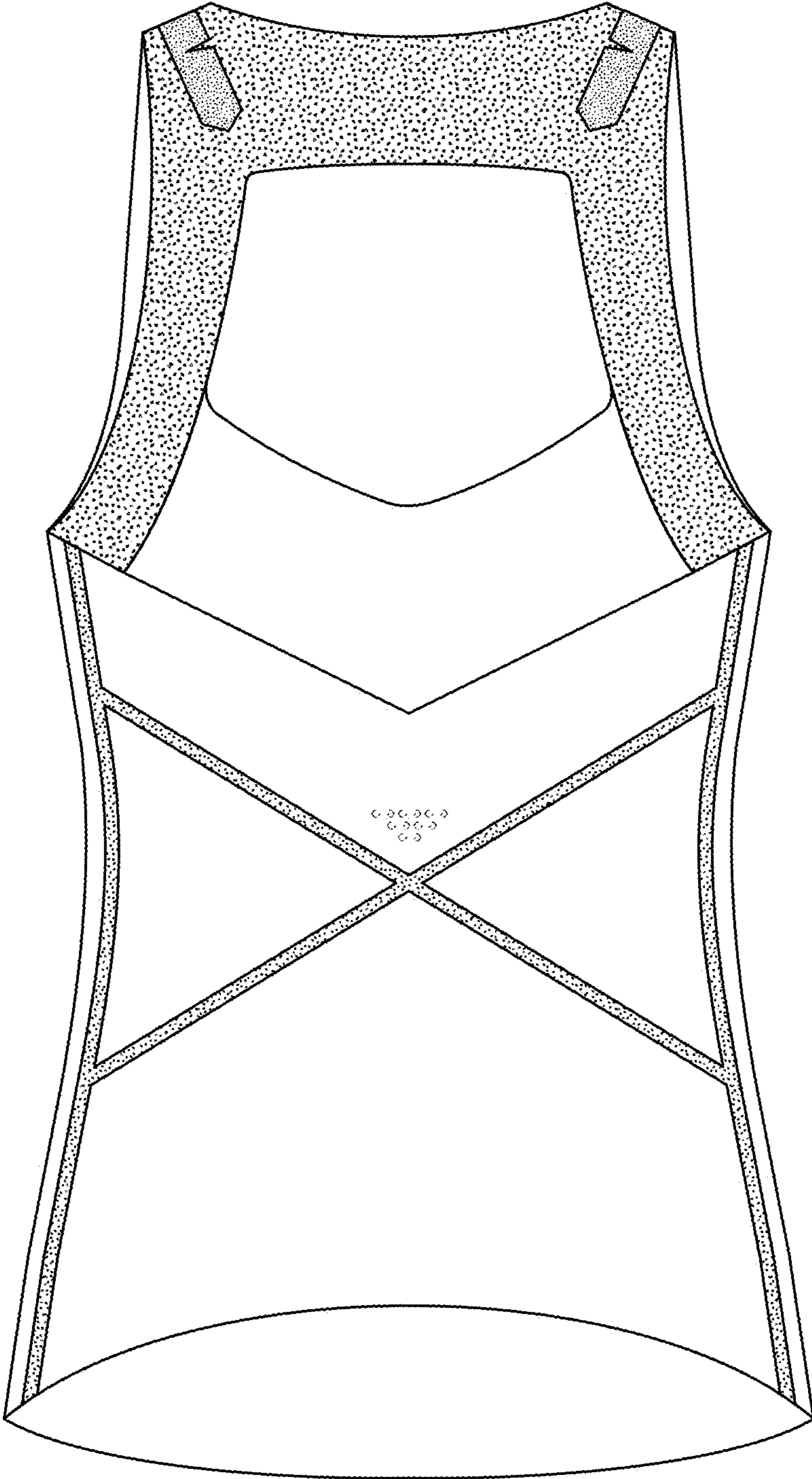

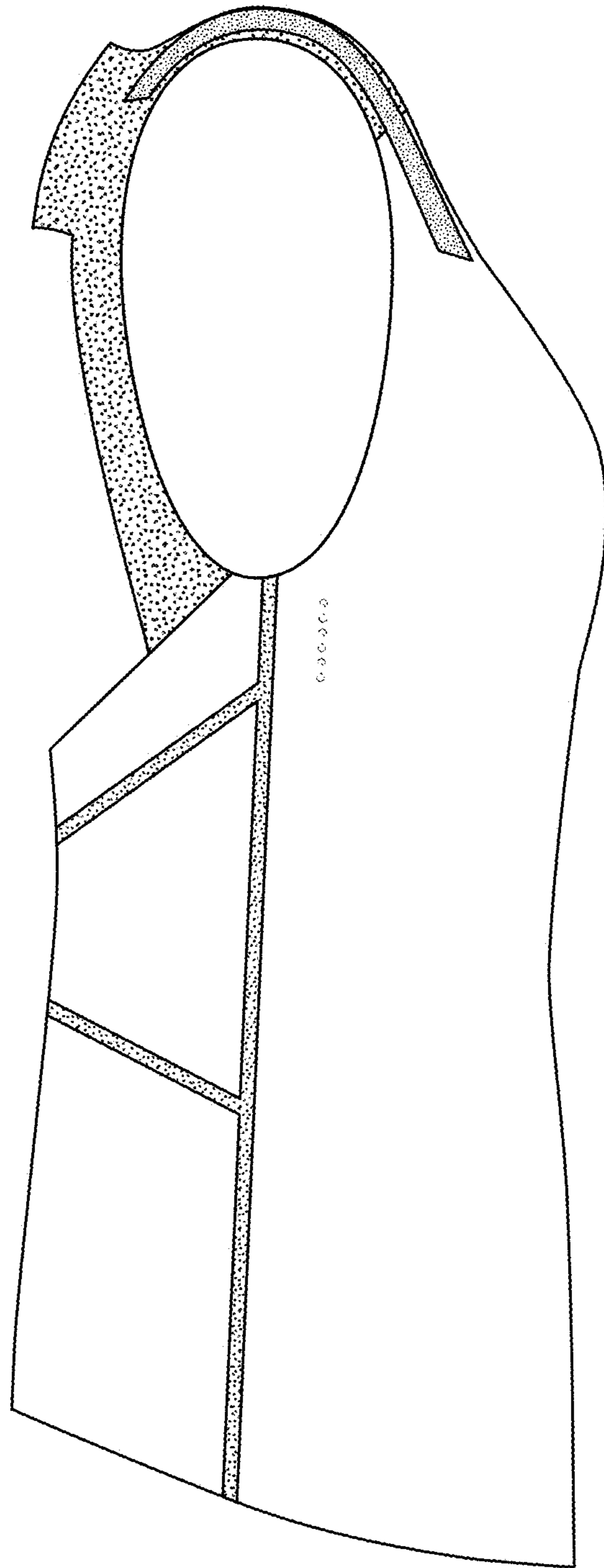
