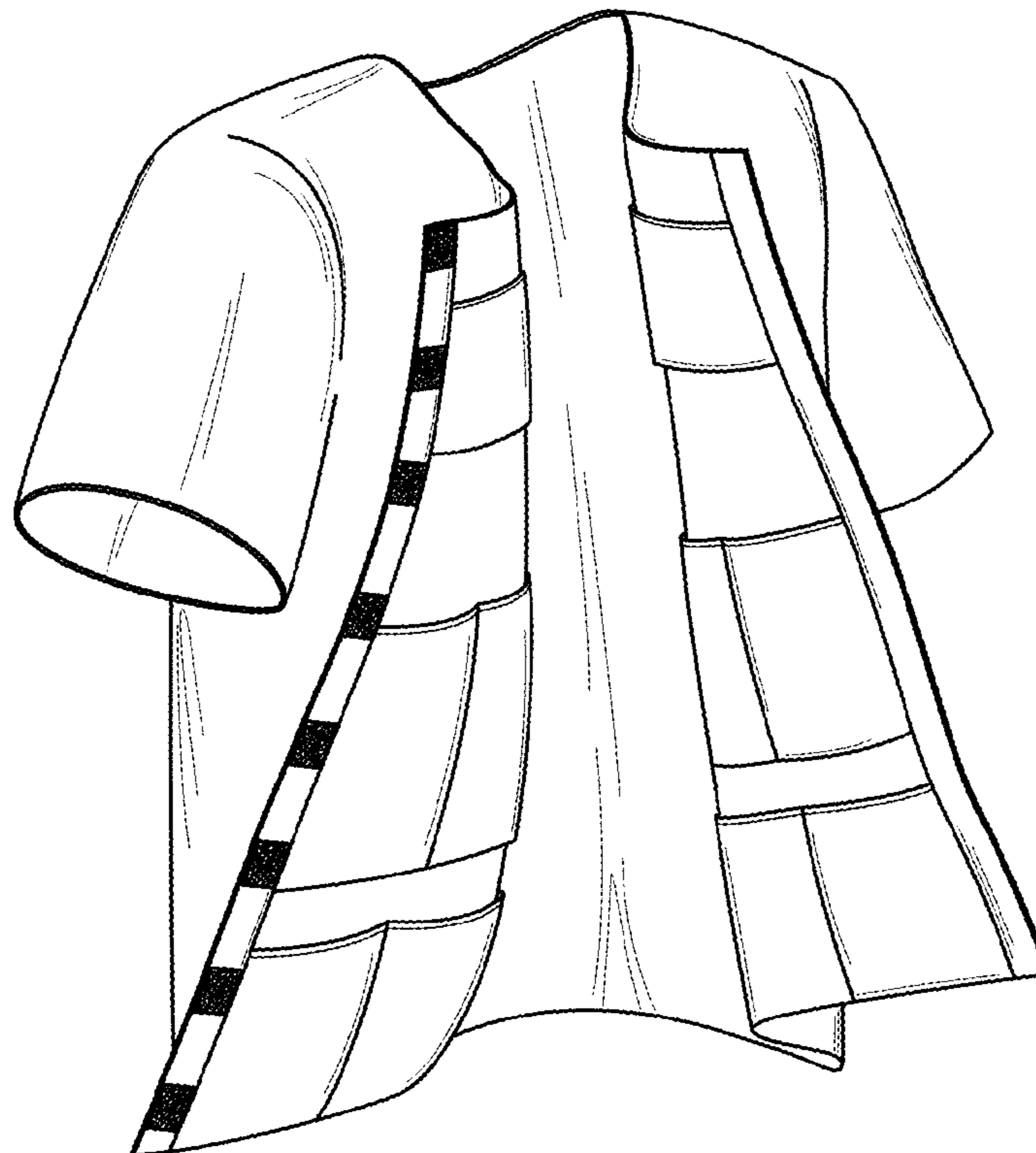
(57) **CLAIM**

I claim the ornamental design for a garment with internal pockets, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a garment with internal pockets, showing my new design in an open position; FIG. 2 is a perspective view thereof, illustrated in a closed position; FIG. 3 is a front elevational view of FIG. 2; FIG. 4 is a rear elevational view of FIG. 2; FIG. 5 is a right-side elevational view of FIG. 2; FIG. 6 is a left-side elevational view of FIG. 2; FIG. 7 is a top plan view of FIG. 2; FIG. 8 is a bottom plan view of FIG. 2; and, FIG. 9 is a front elevational view of FIG. 1.

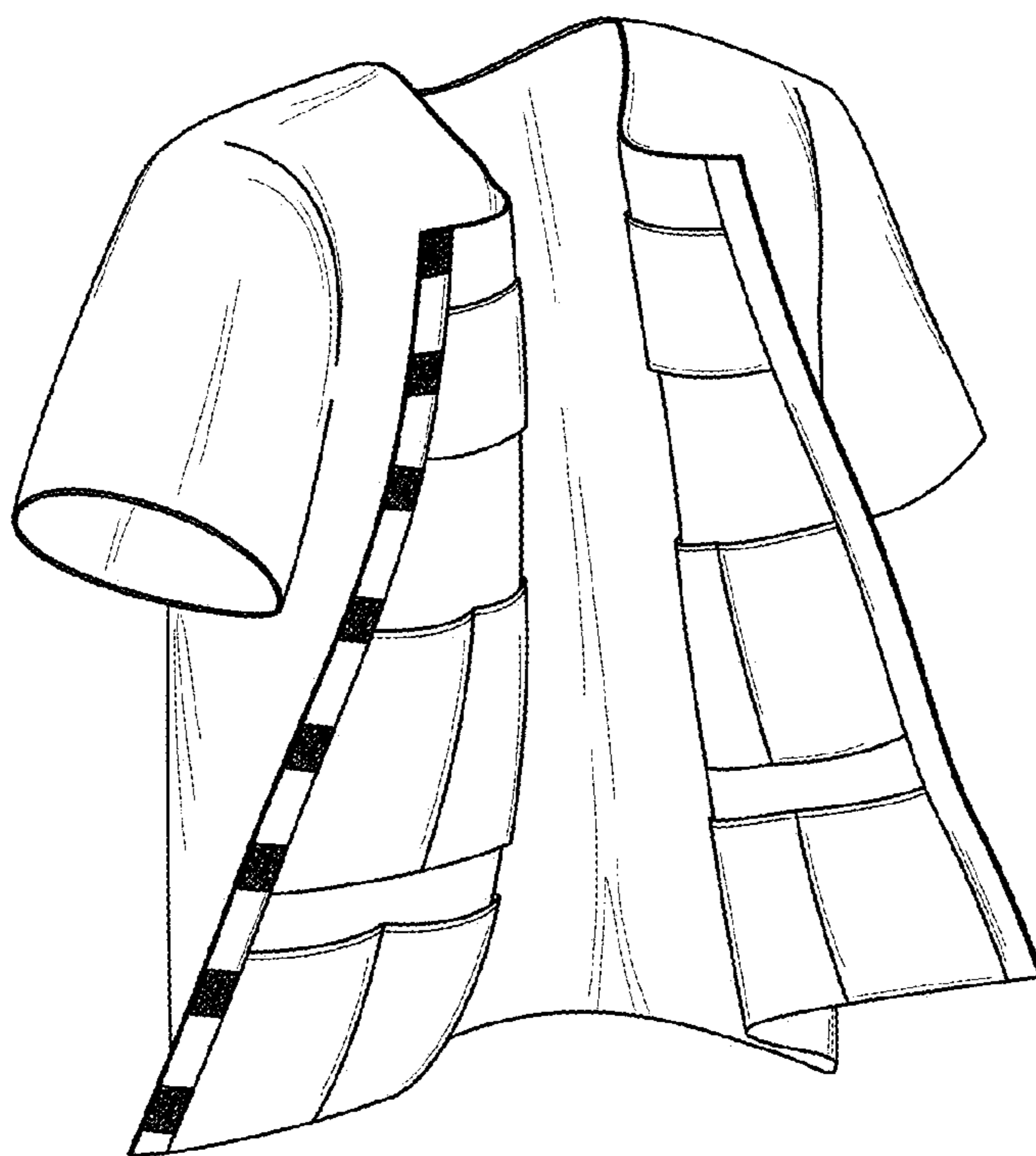

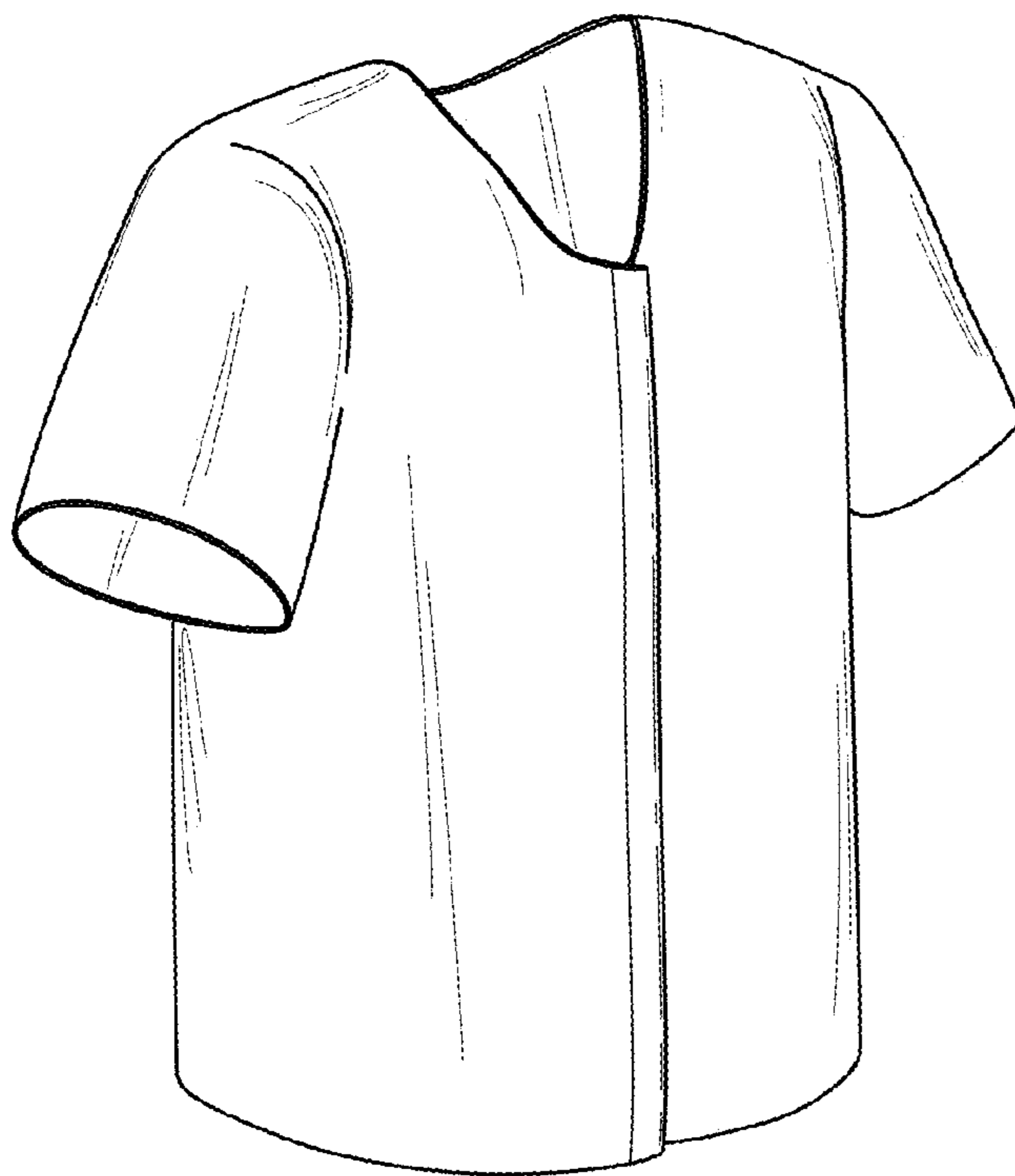

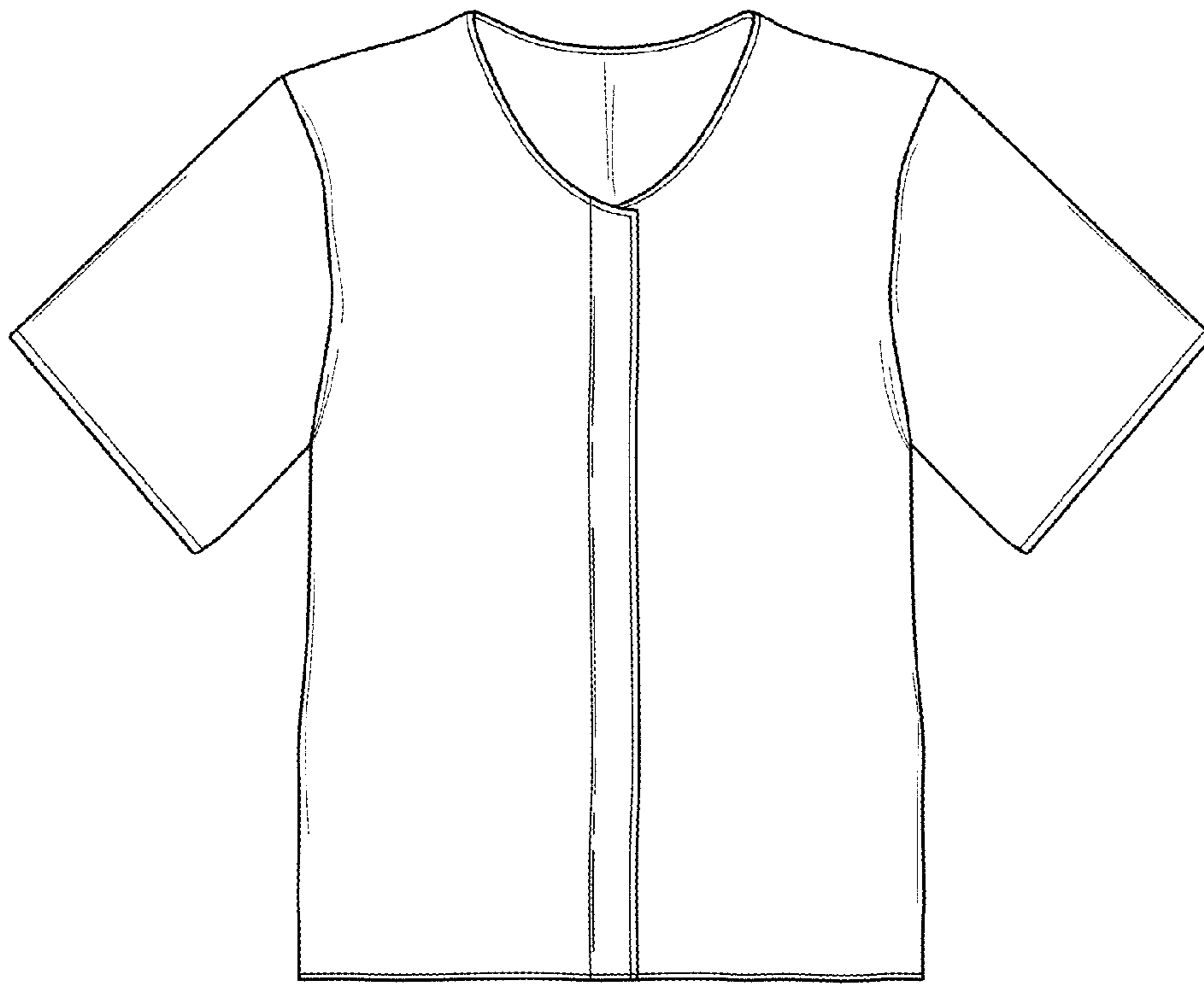

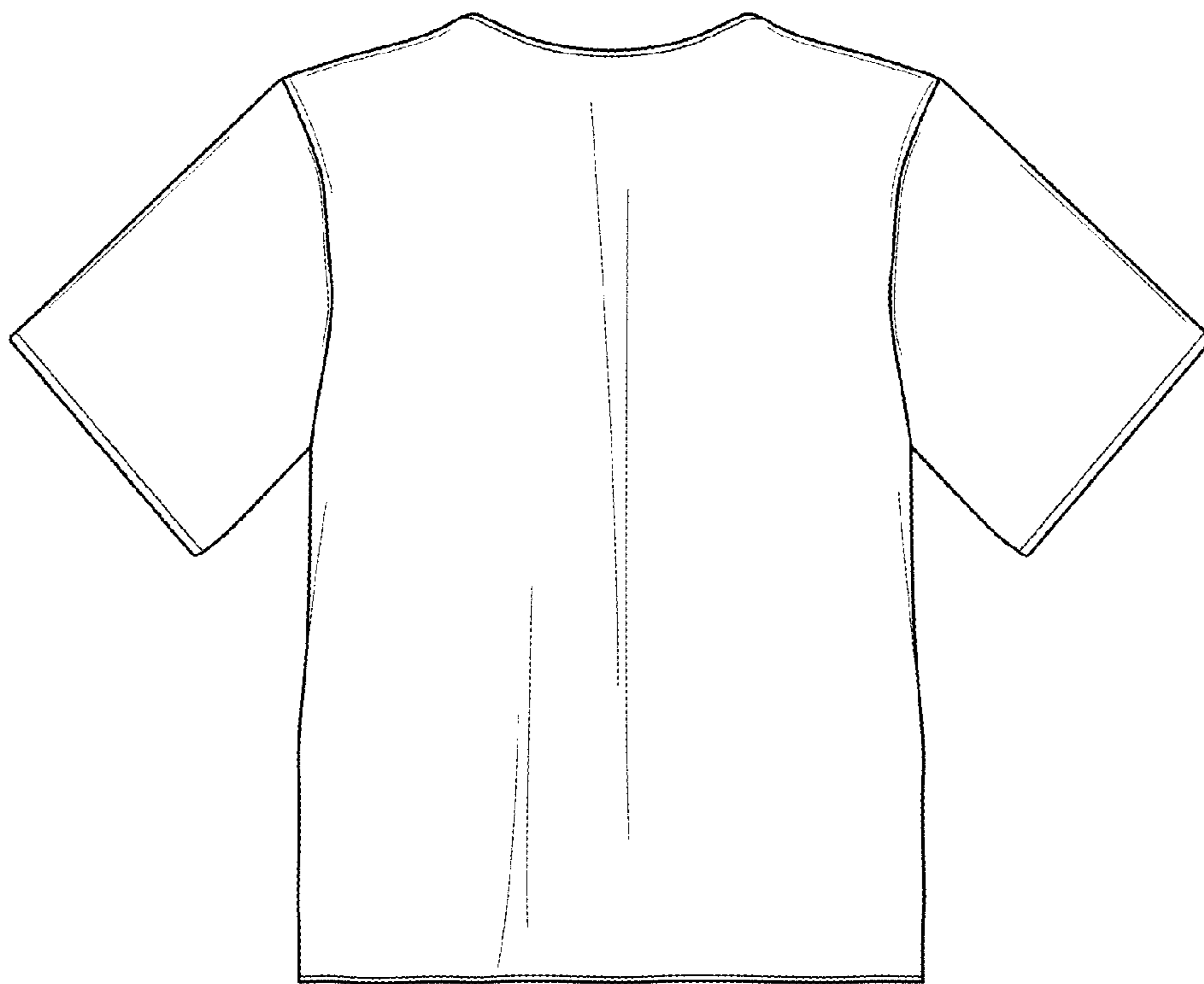

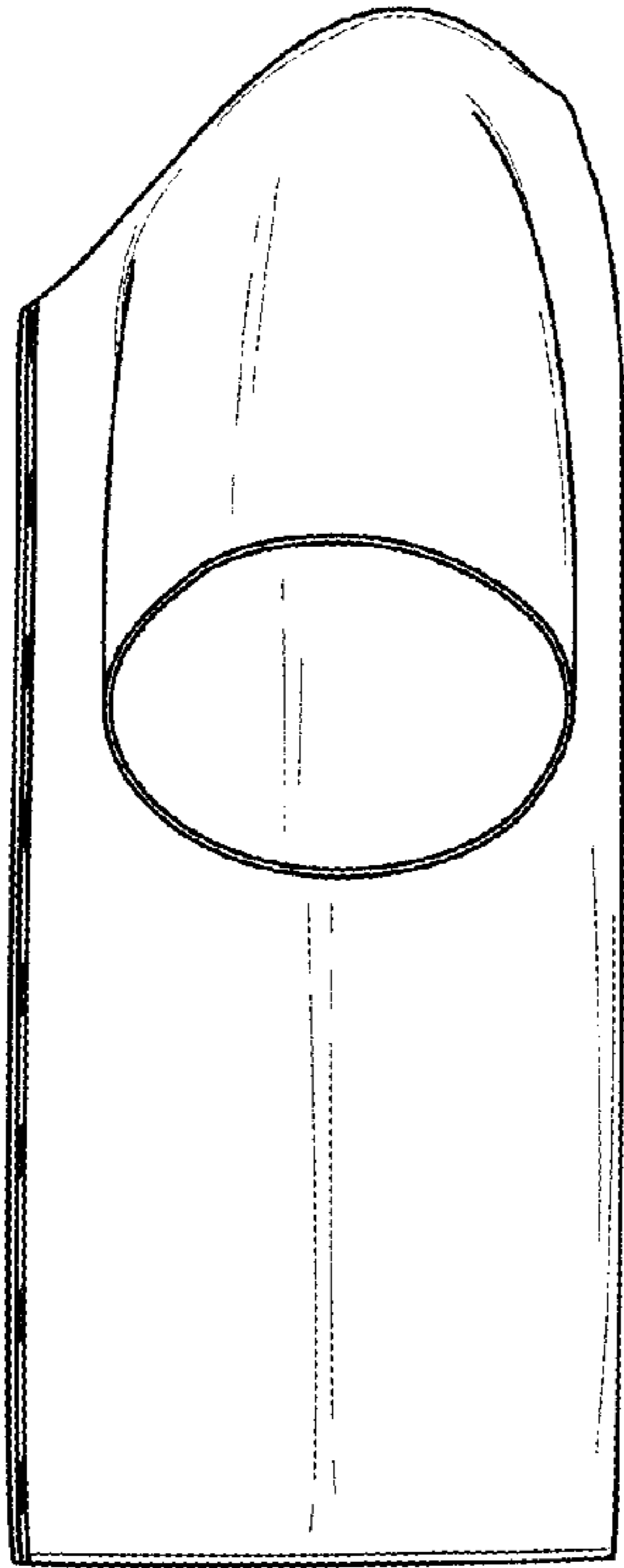

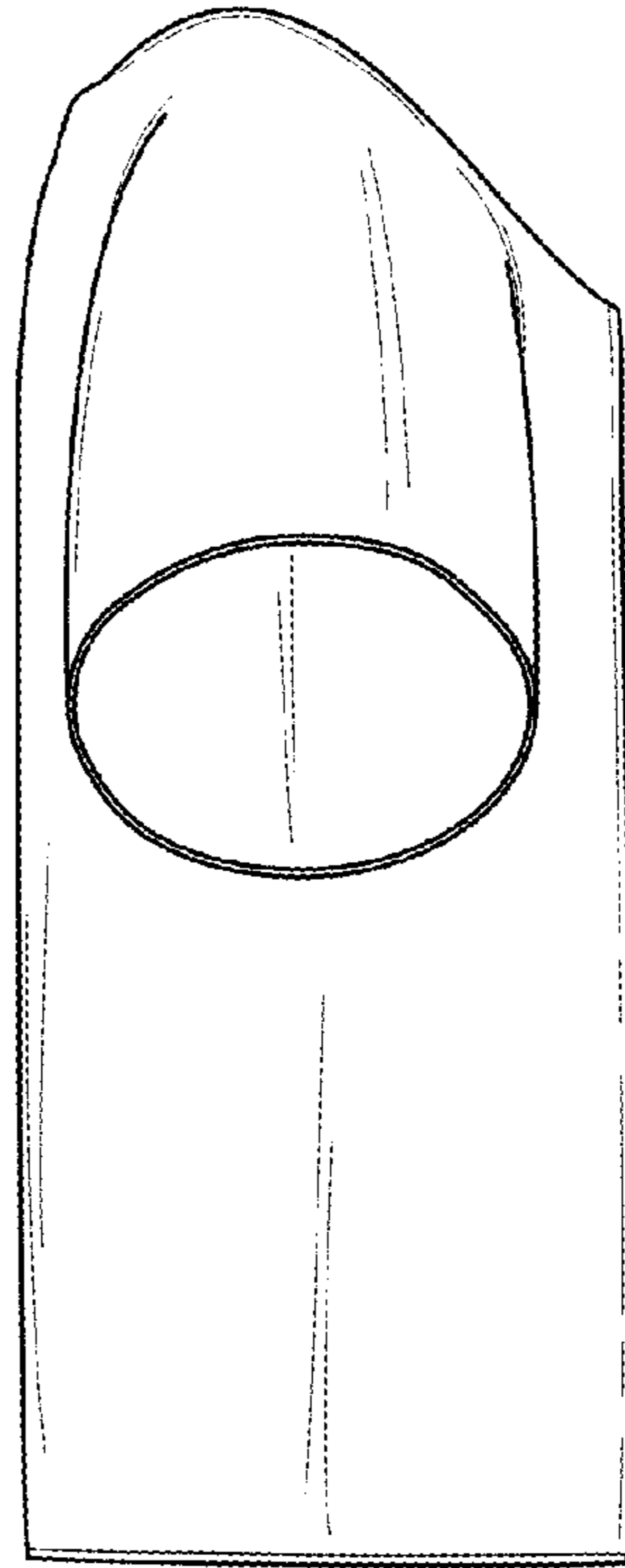

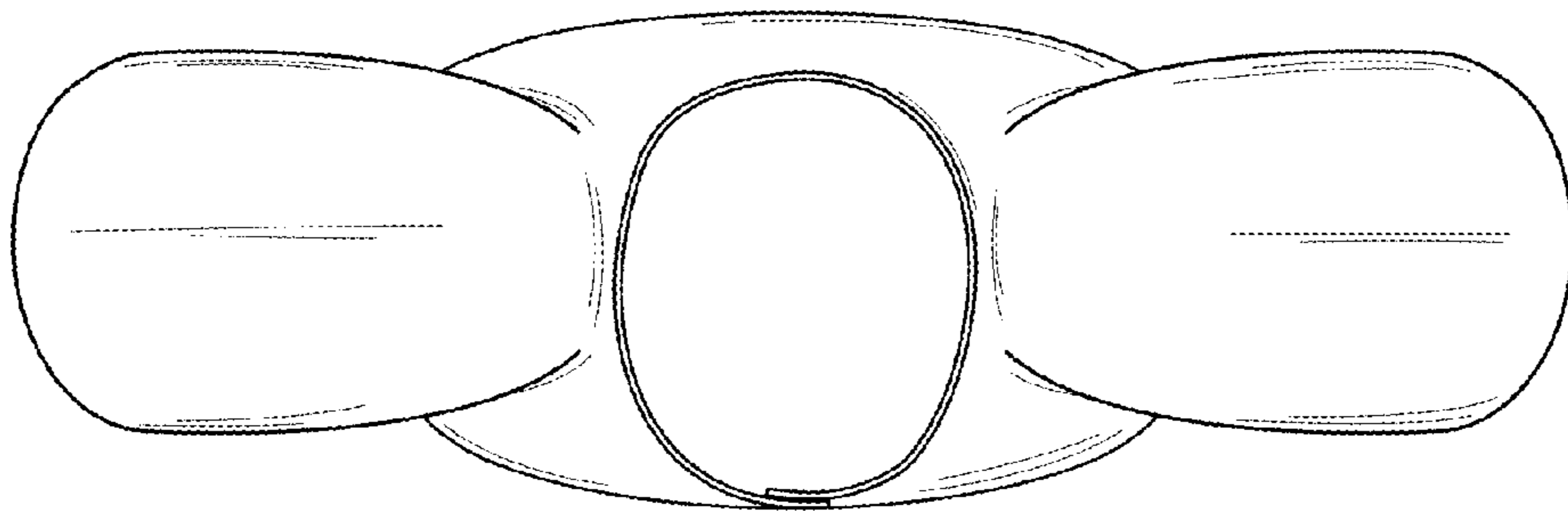

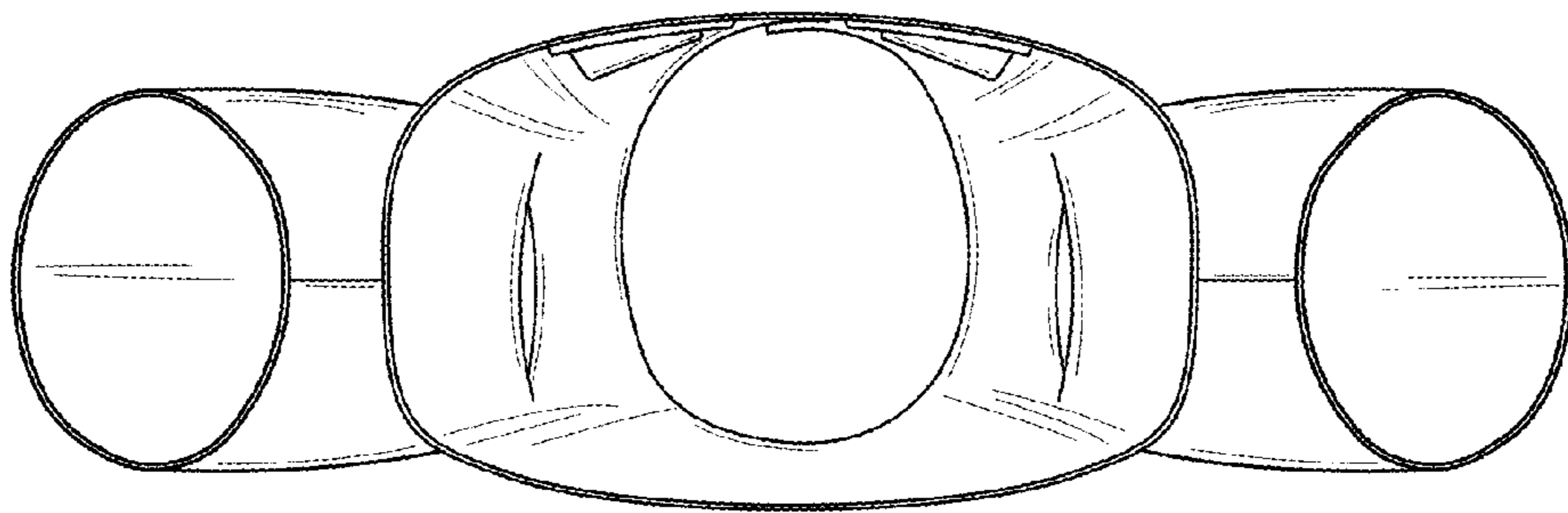

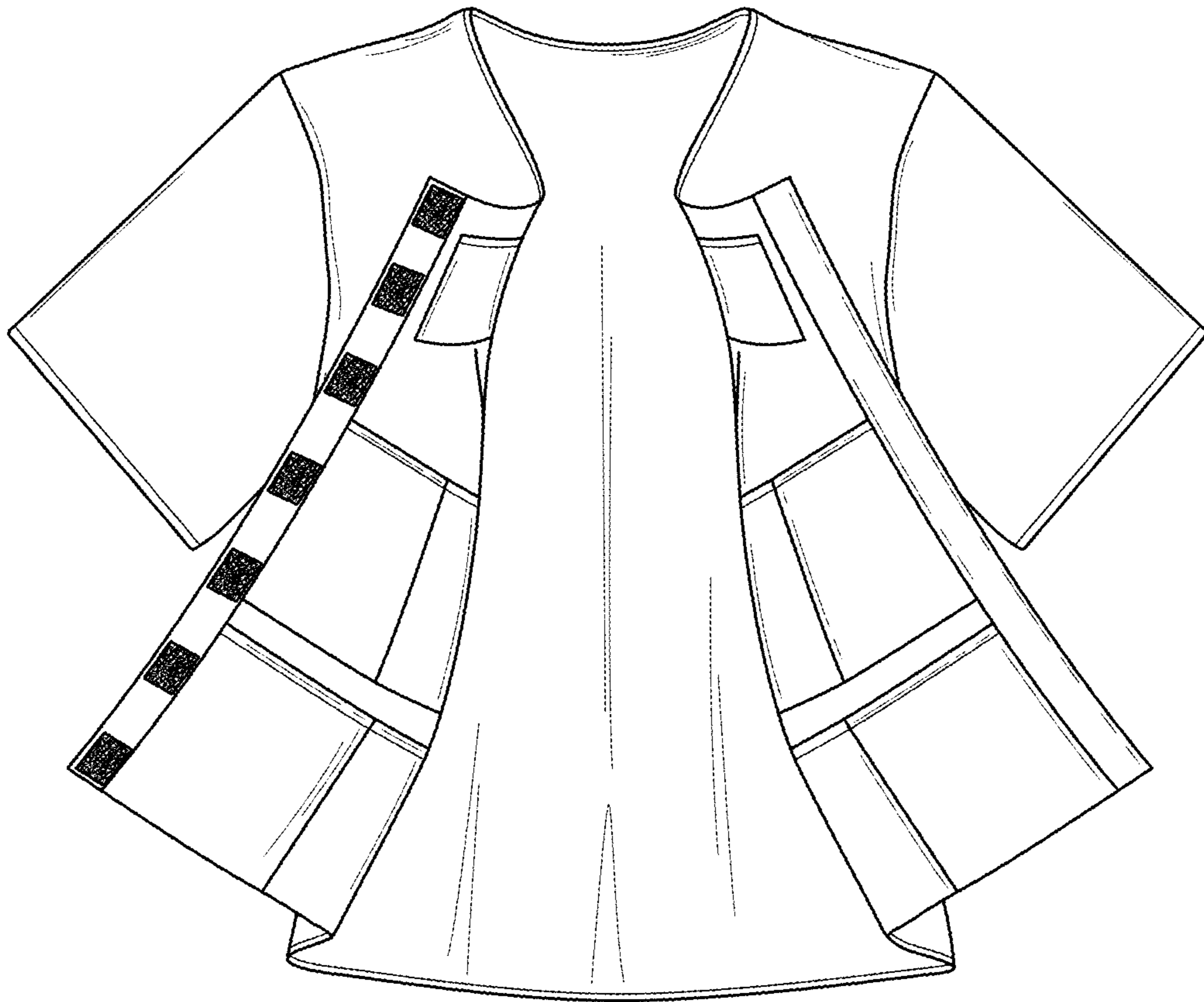
