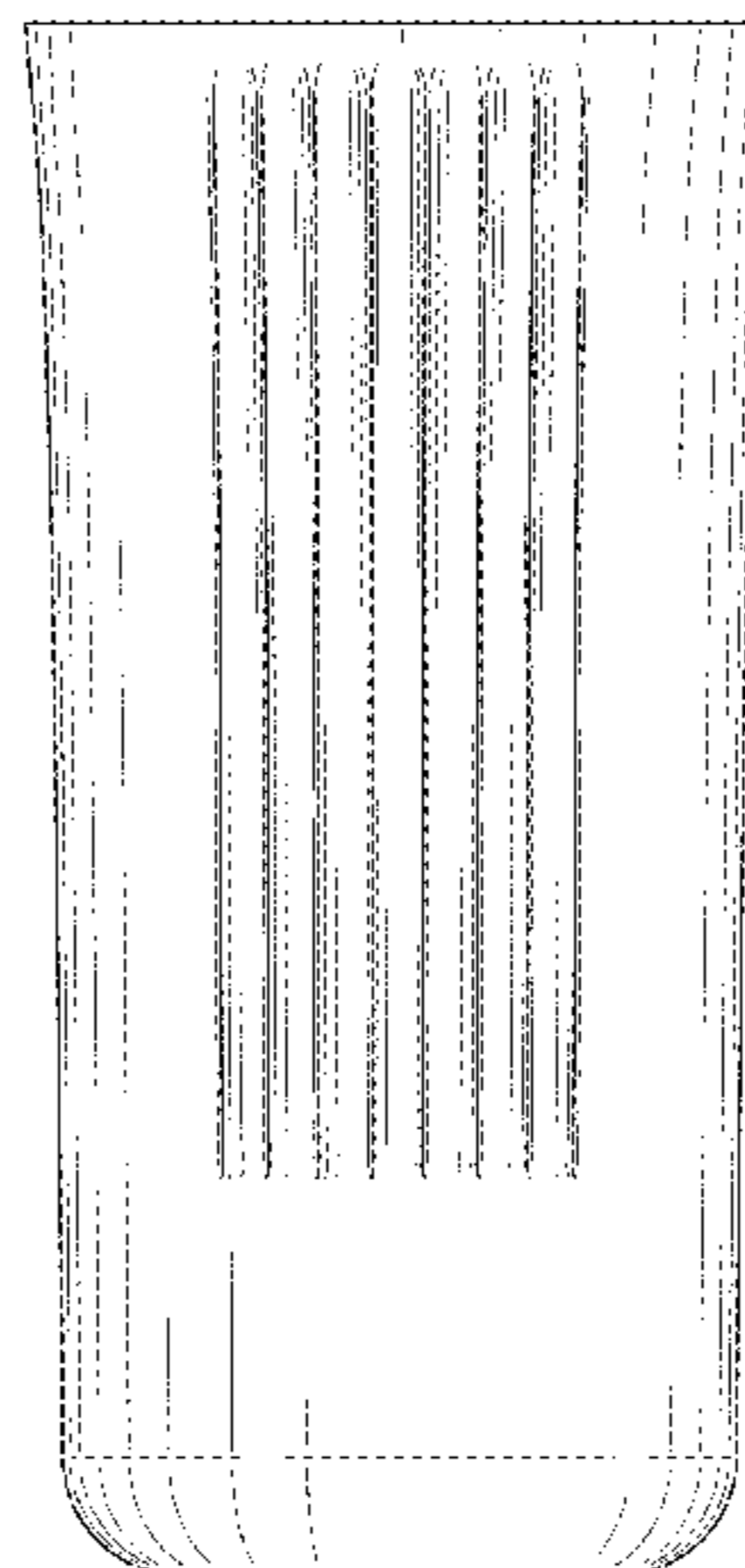
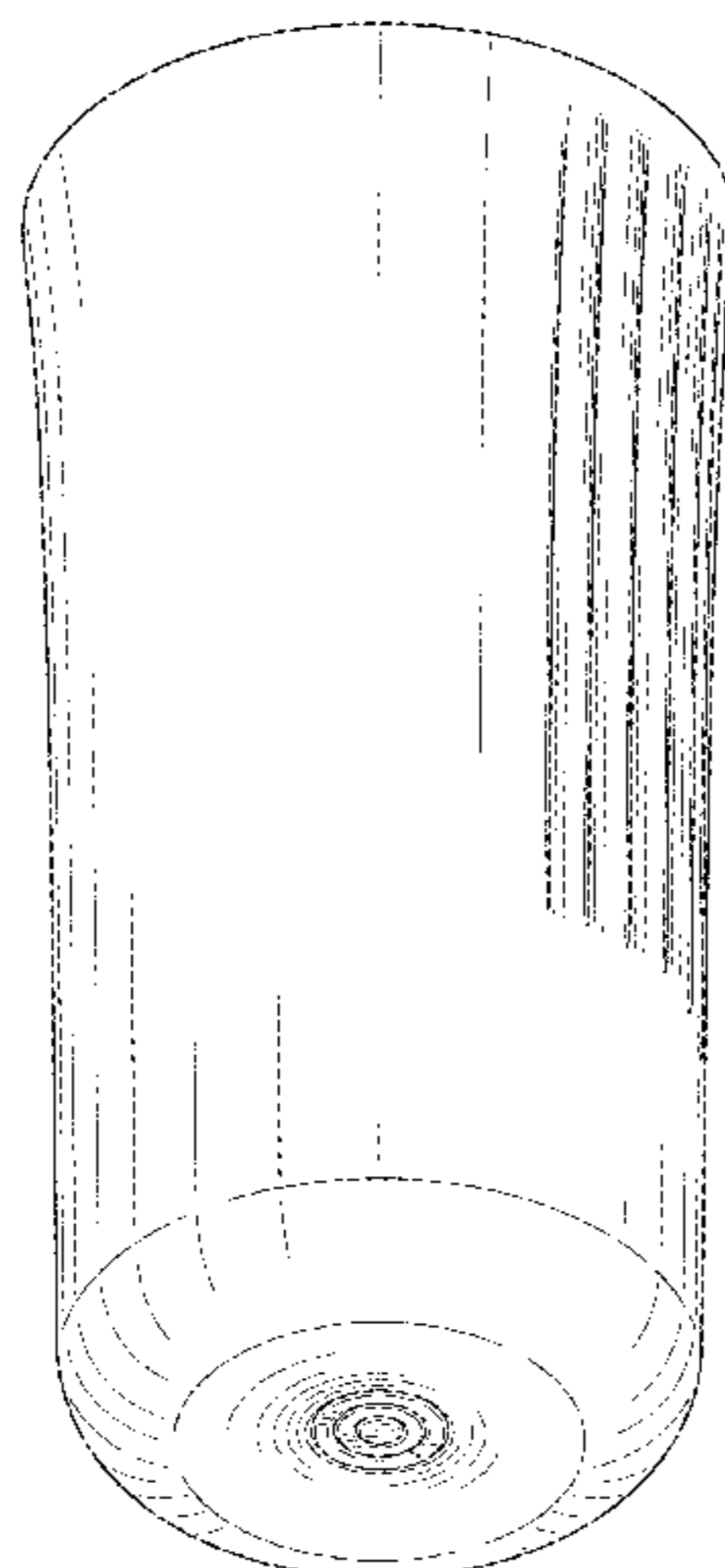
(57) **CLAIM**

The ornamental design for a beverage vessel, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a first embodiment of a beverage vessel showing our new design; FIG. 2 is a bottom perspective view thereof; FIG. 3 is a front view thereof; FIG. 4 is a rear view thereof; FIG. 5 is a right side view thereof; FIG. 6 is a left side view thereof; FIG. 7 is a top view thereof; FIG. 8 is a bottom view thereof; FIG. 9 is a cross-sectional view thereof taken along line 9-9 of FIG. 7; FIG. 10 is a top perspective view of a second embodiment of a beverage vessel; and, FIG. 11 is a front view thereof. 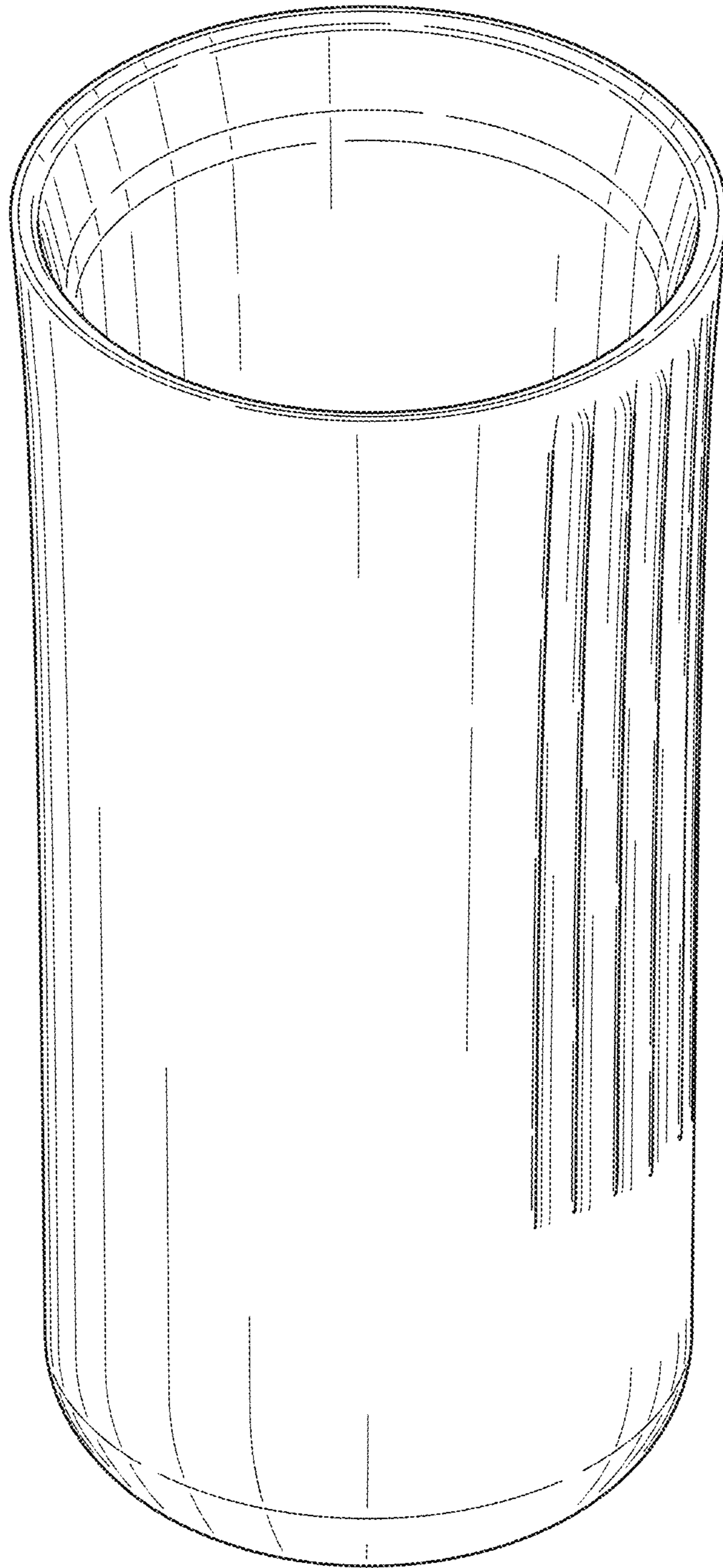

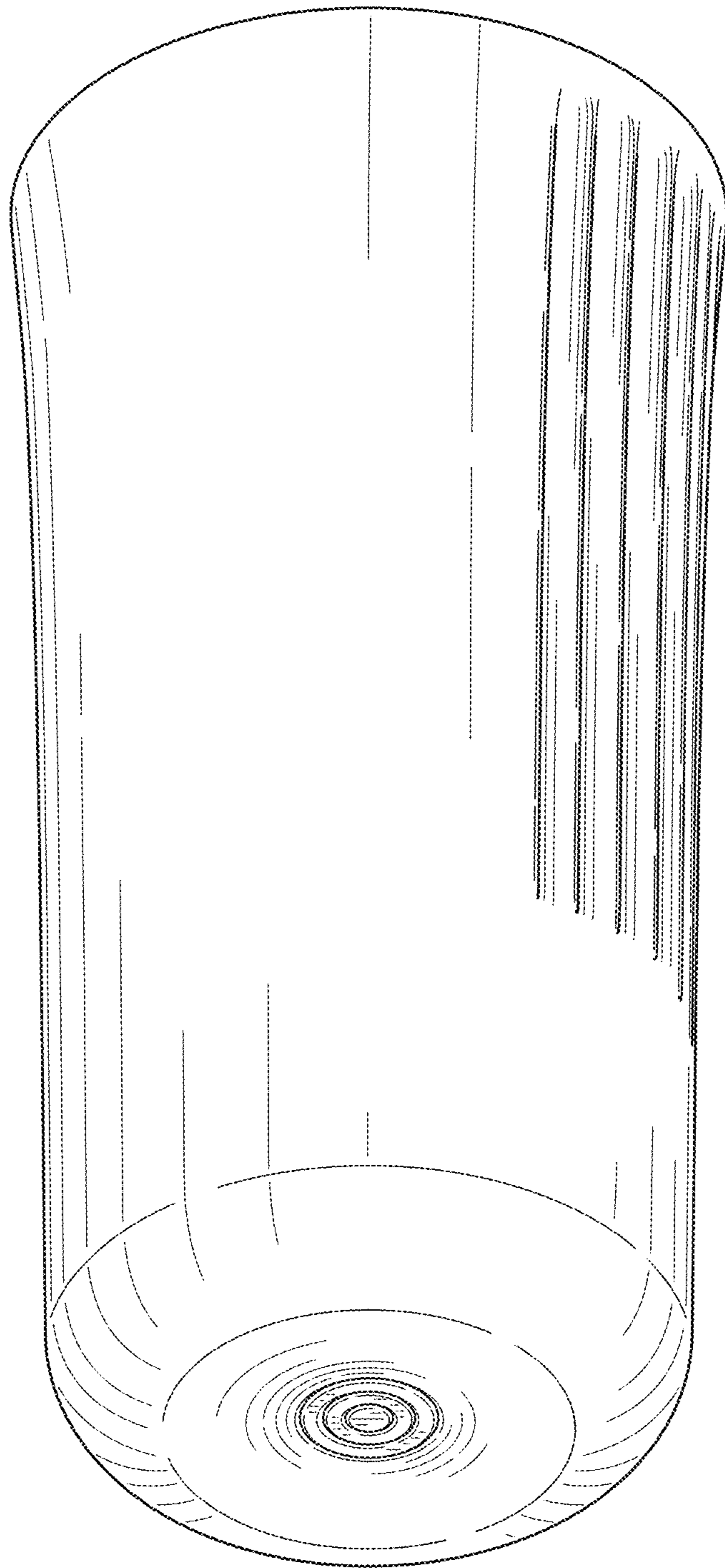

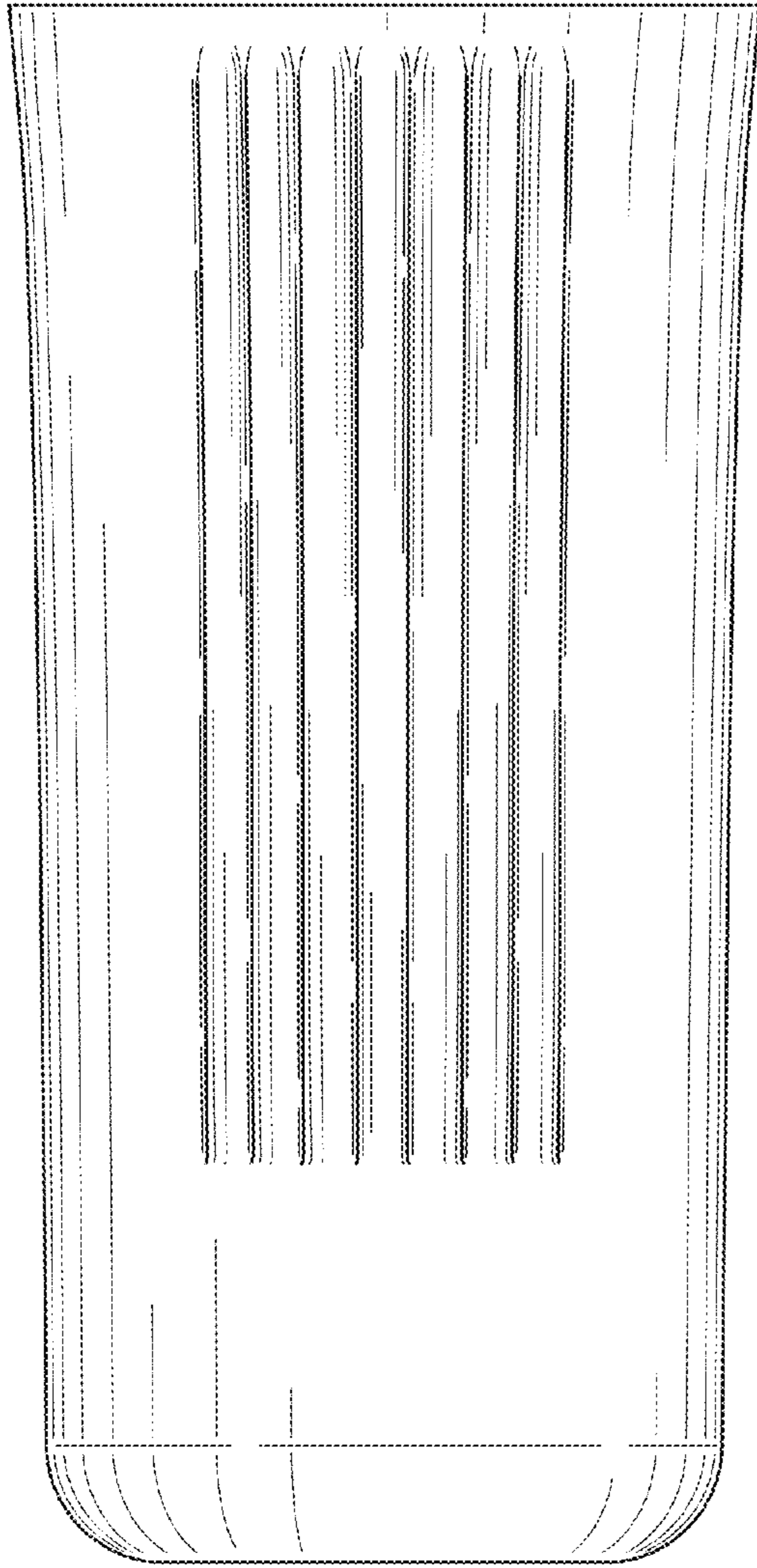

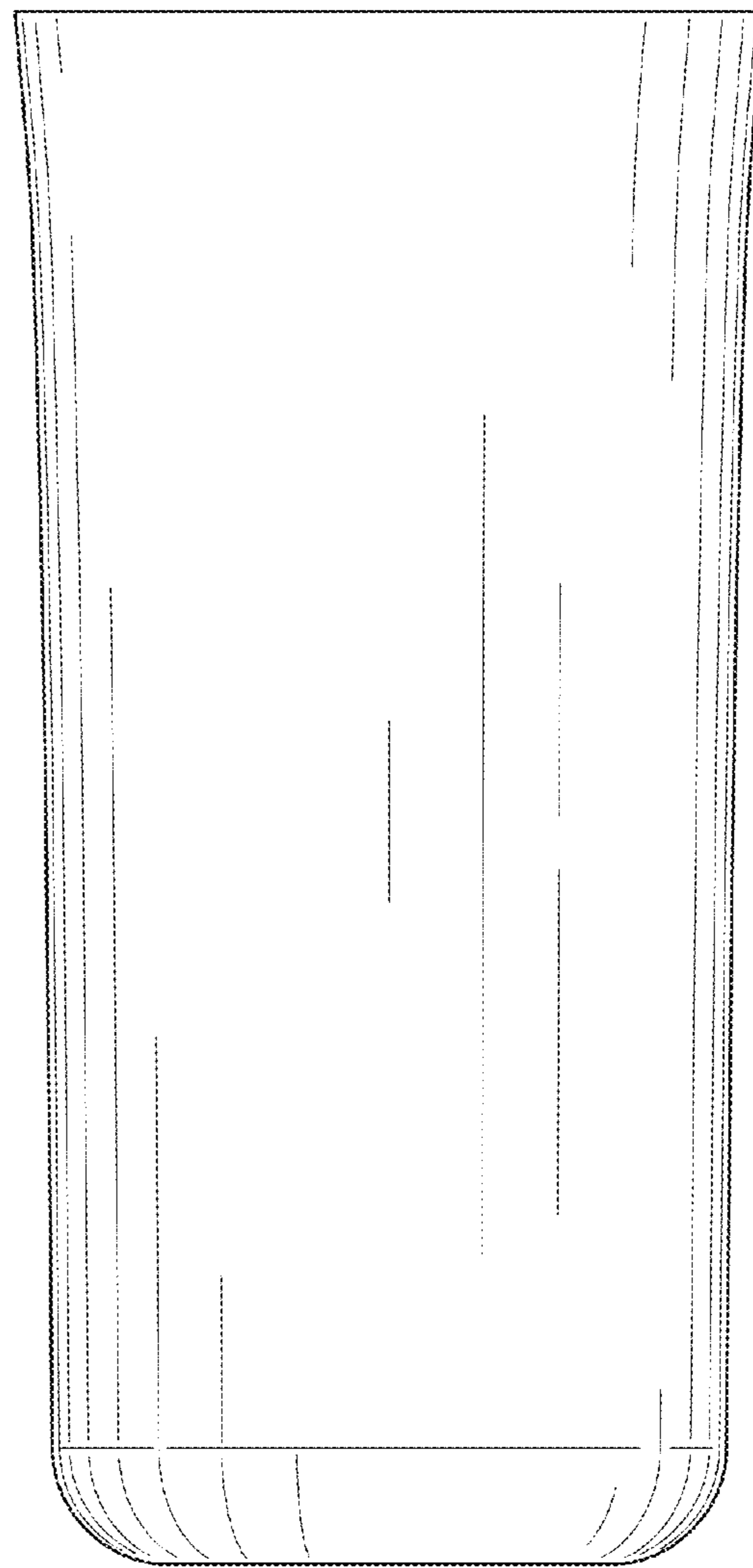

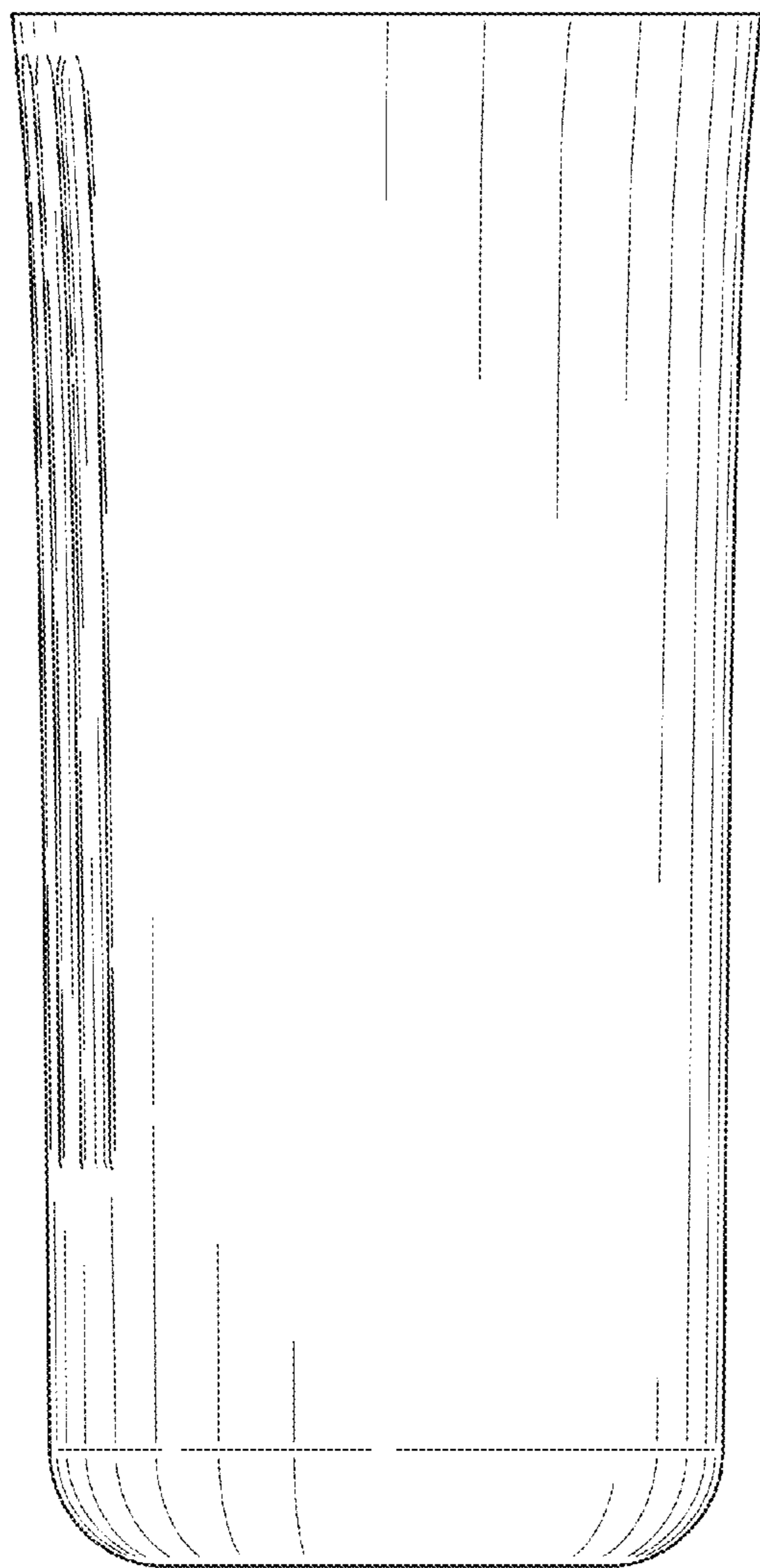

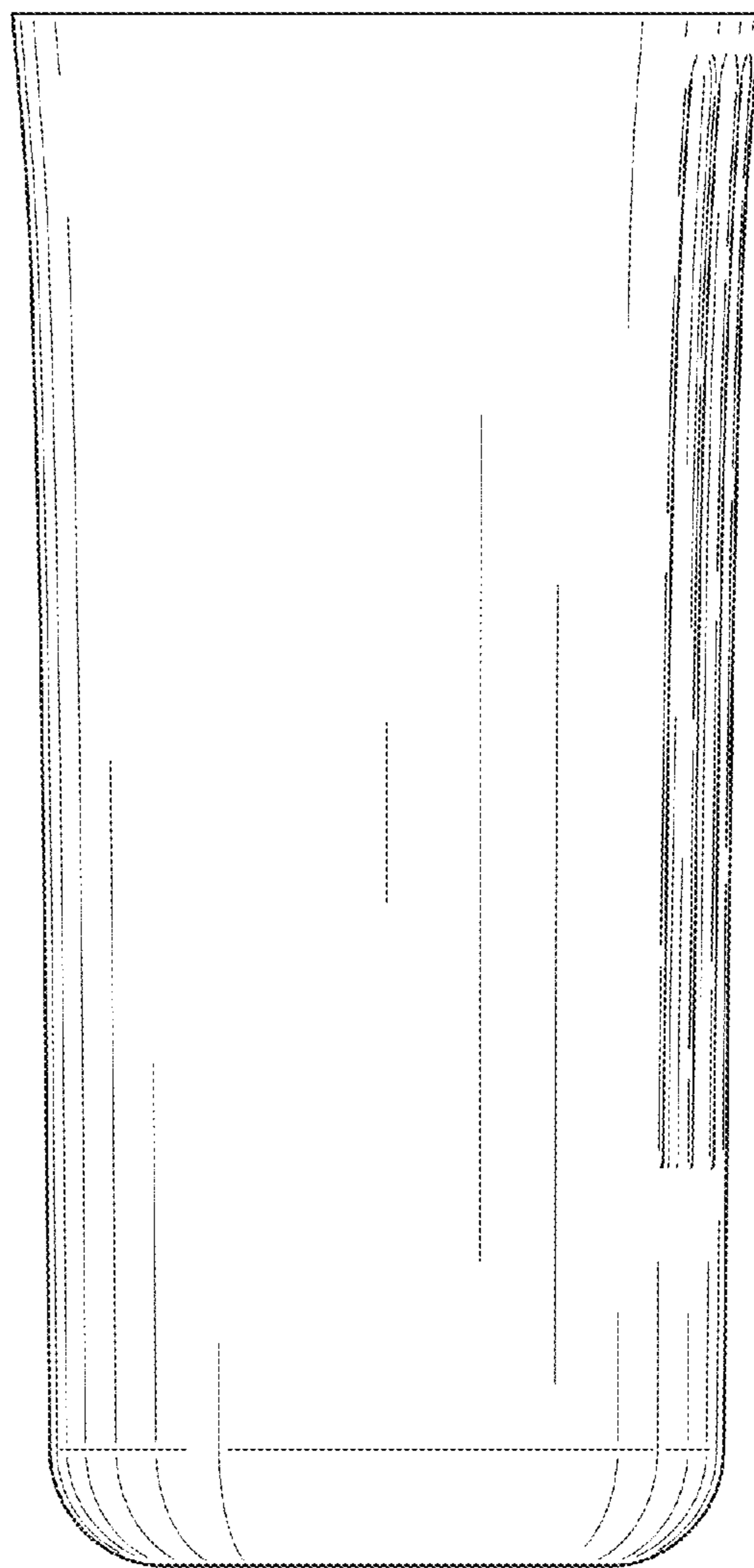

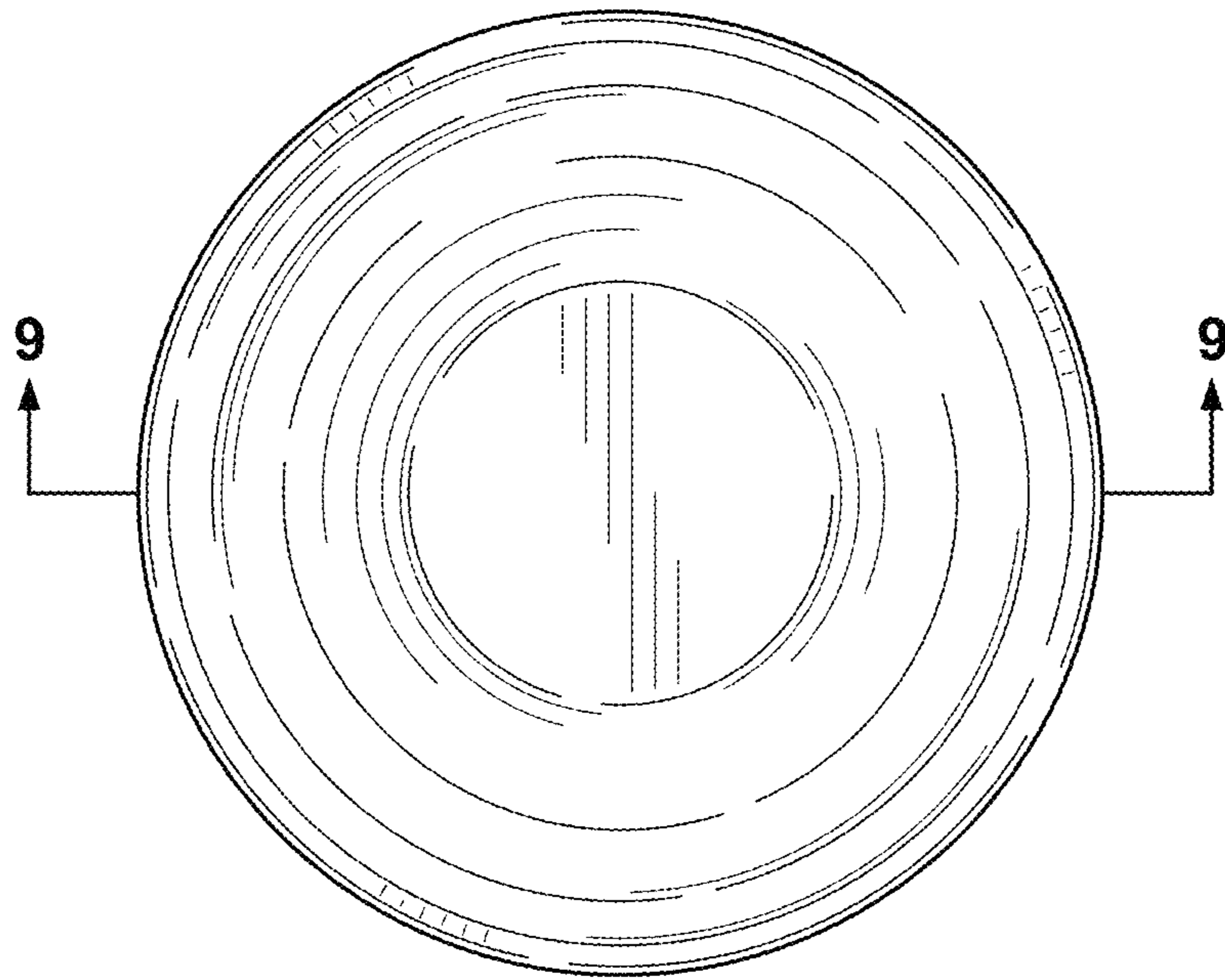

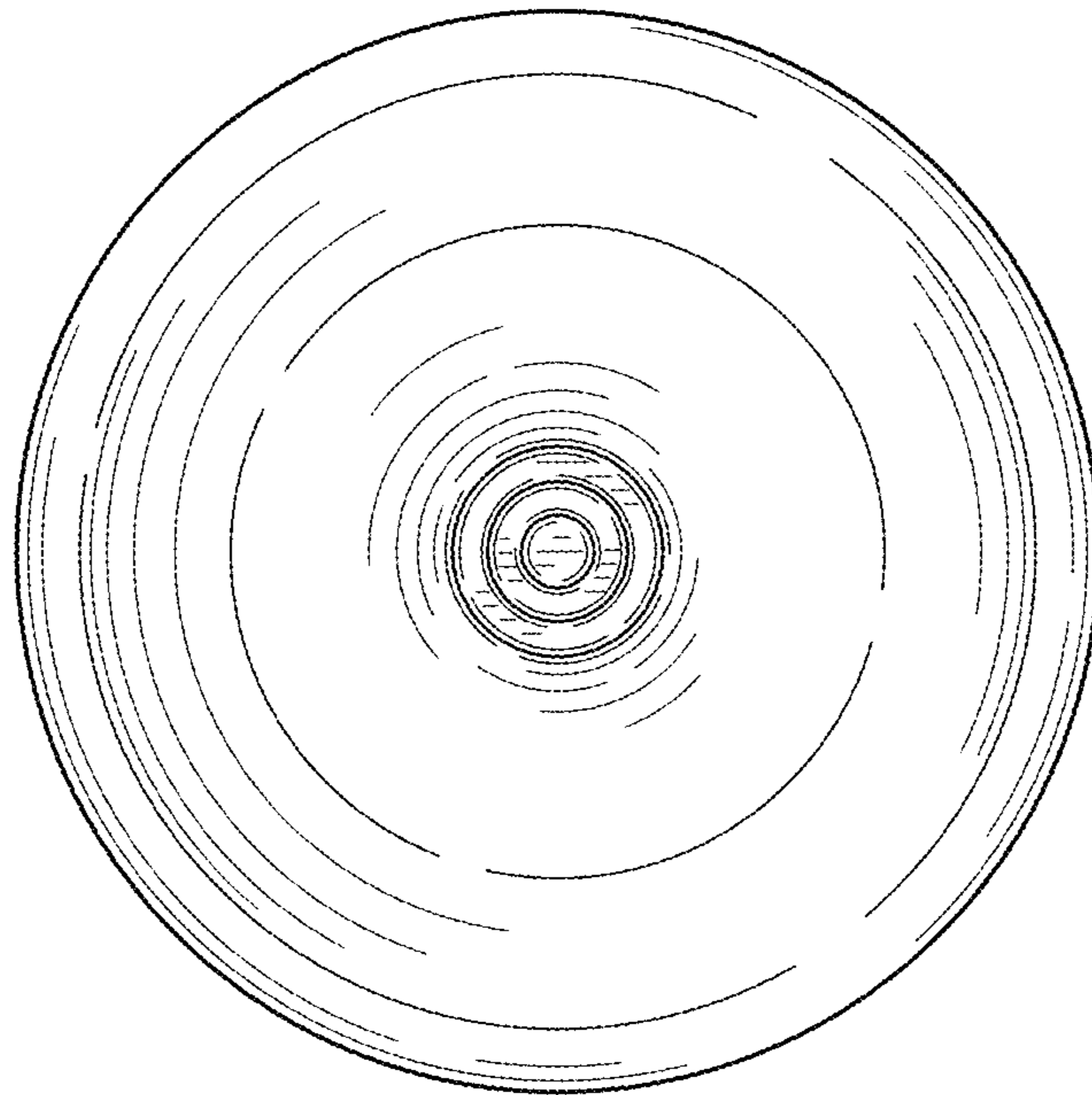

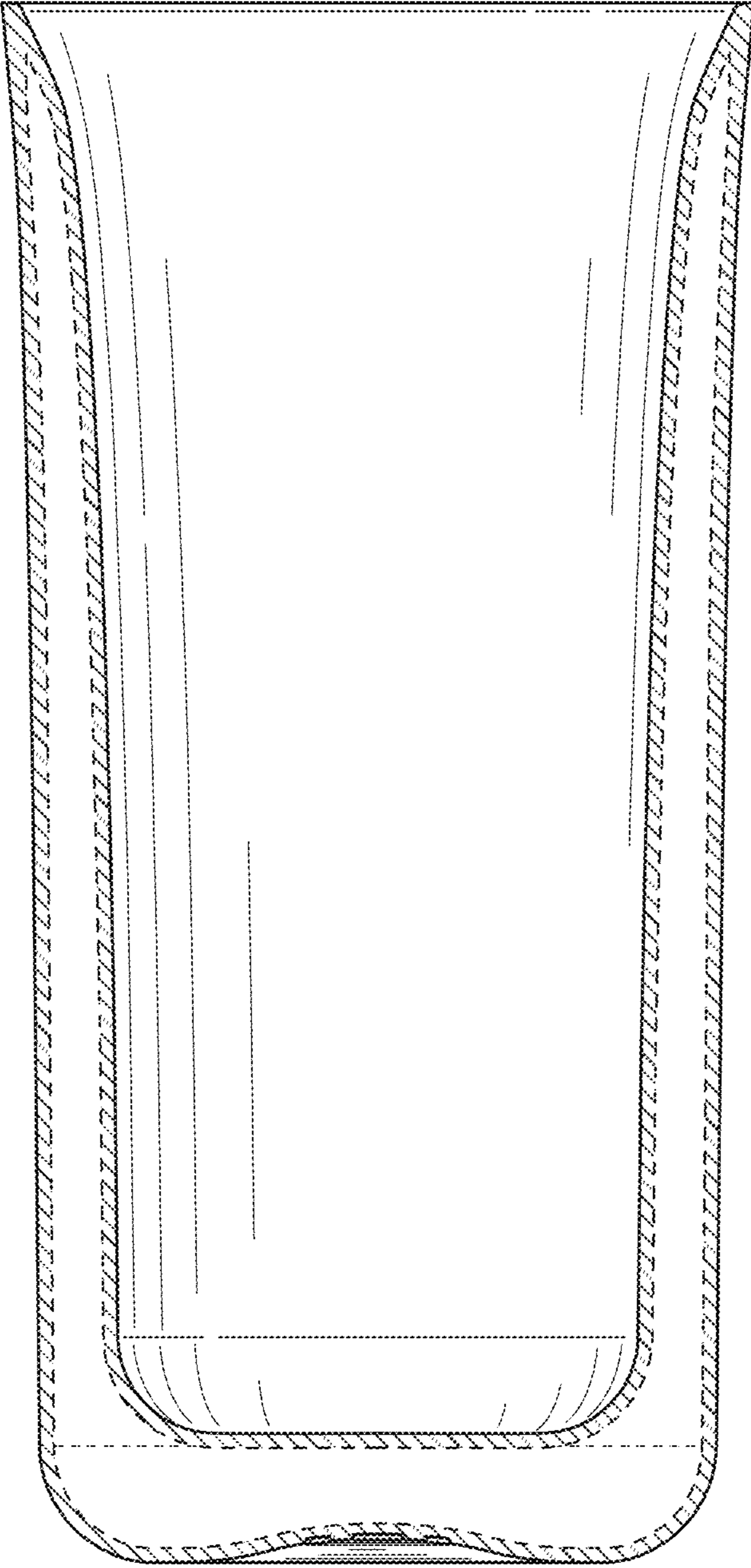

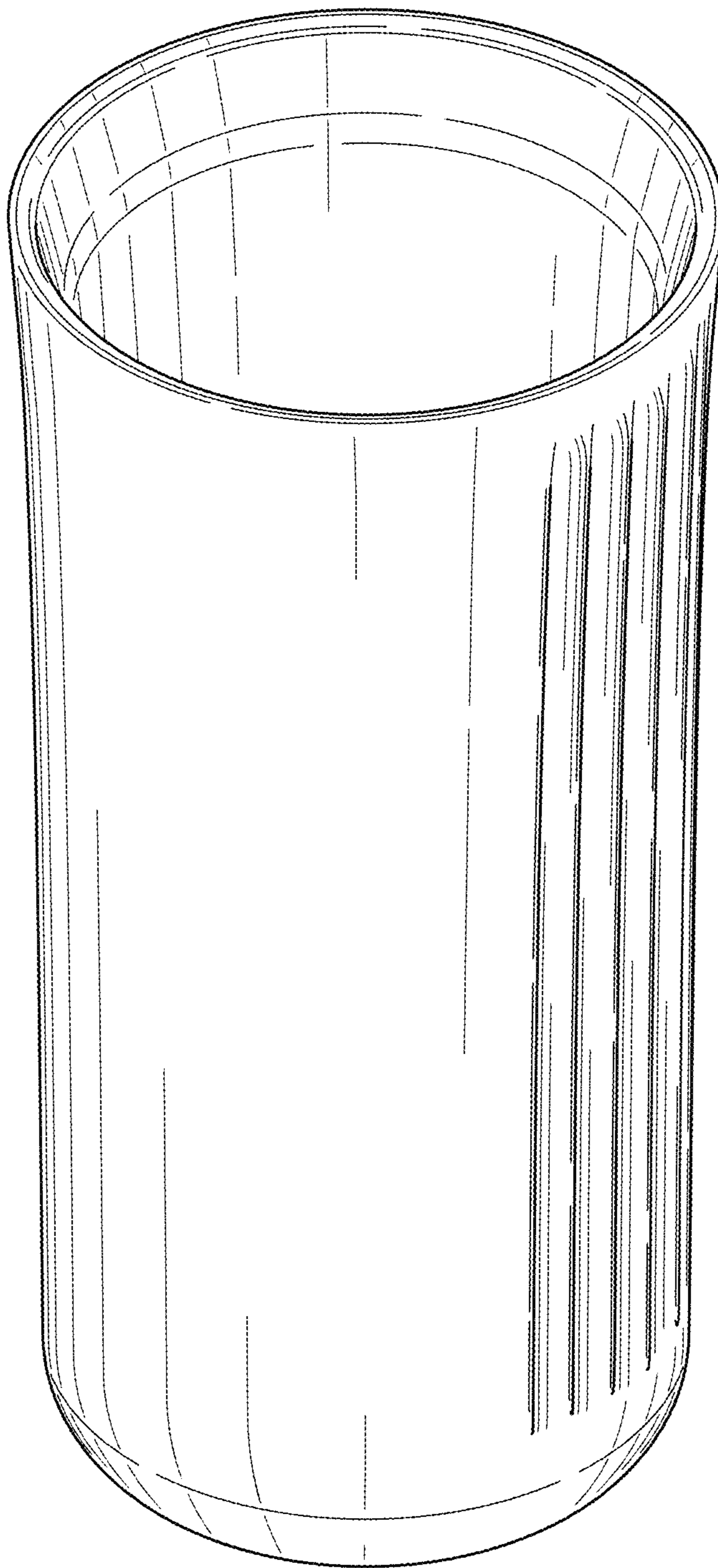

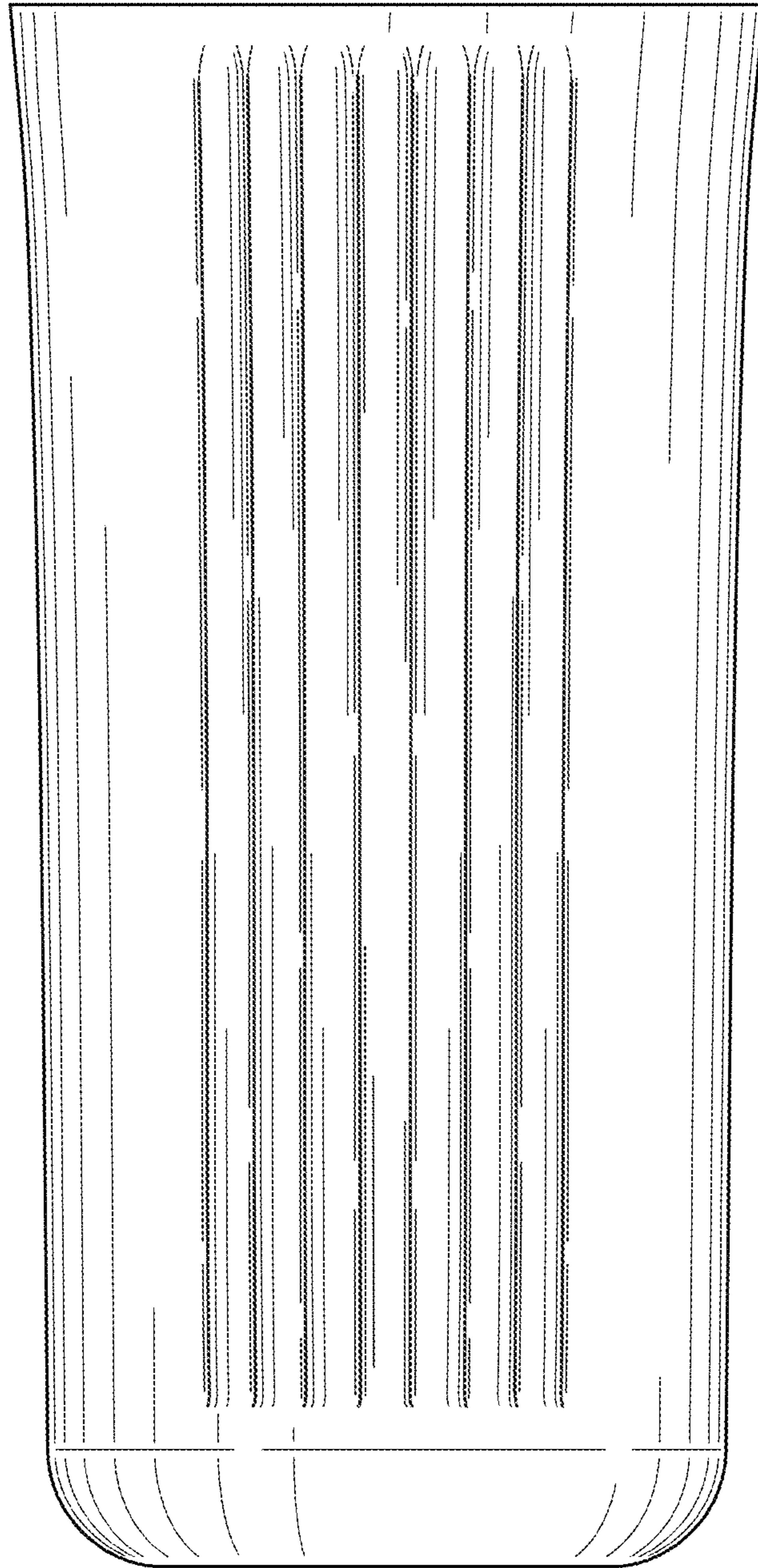
