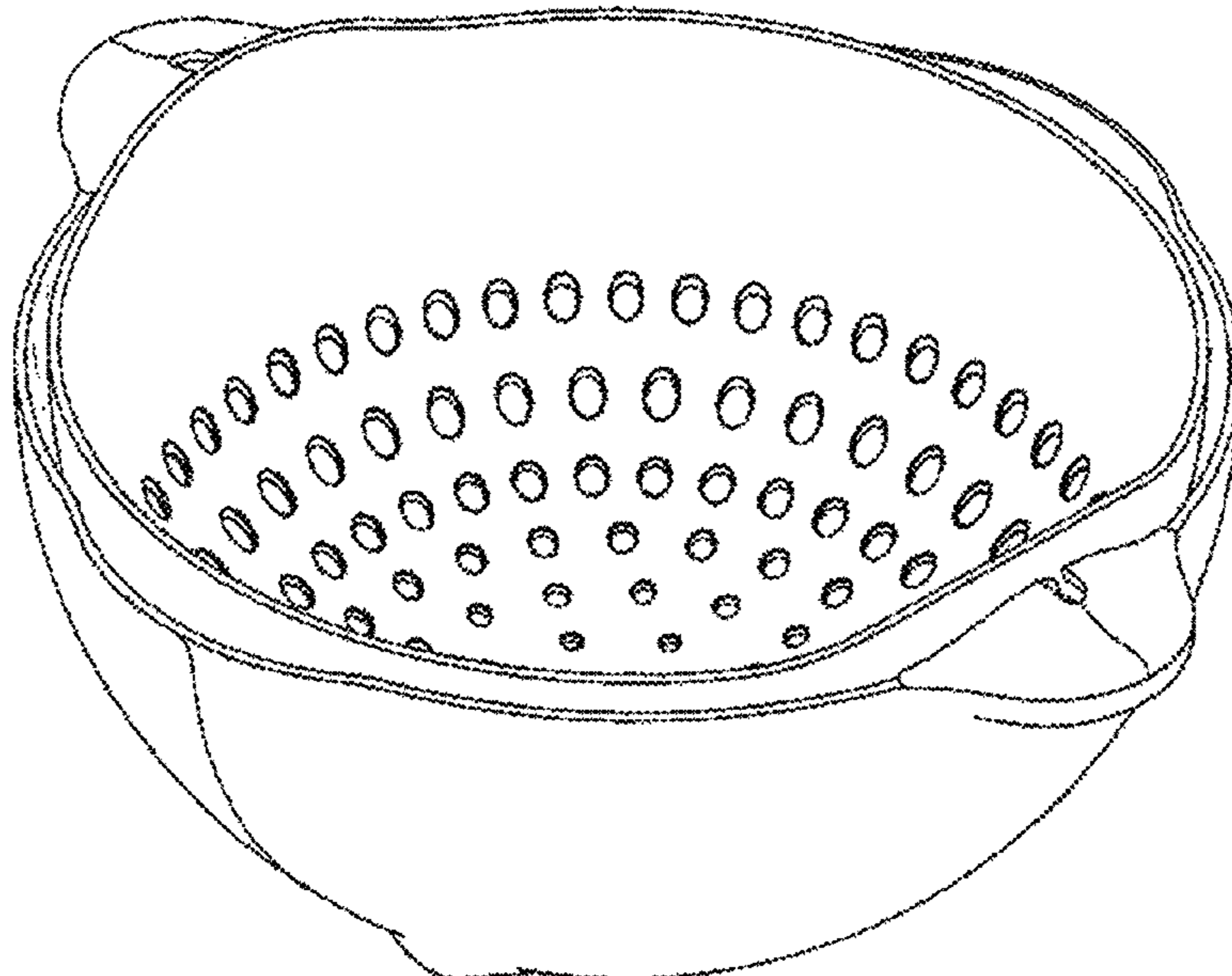

DESCRIPTION

FIG. 1 is a perspective view of a colander showing our new design.
FIG. 2 is a top plan view thereof.
FIG. 3 is a side view thereof.
FIG. 4 is a perspective view thereof, the bowl portion shown separately for clarity of illustration.
FIG. 5 is a top plan view of FIG. 4.
FIG. 6 is a side view of FIG. 4.
FIG. 7 is a perspective view thereof, the colander portion shown separately for clarity of illustration.
FIG. 8 is a top plan view of FIG. 7.
FIG. 9 is a side view of FIG. 7.
FIG. 10 is a front view of the colander.
FIG. 11 is a bottom view of FIG. 4.
FIG. 12 is a front view of FIG. 4.
FIG. 13 is a front view of FIG. 7.
FIG. 14 is a bottom plan view of FIG. 7.
FIG. 15 is a perspective view thereof, in an alternate position.
FIG. 16 is a top plan view of FIG. 15.
FIG. 17 is a side view of FIG. 15; and,
FIG. 18 is a front view of FIG. 15.
The colander consists of a bowl portion and a colander portion. The bowl and colander are shown separately for clarity of illustration.

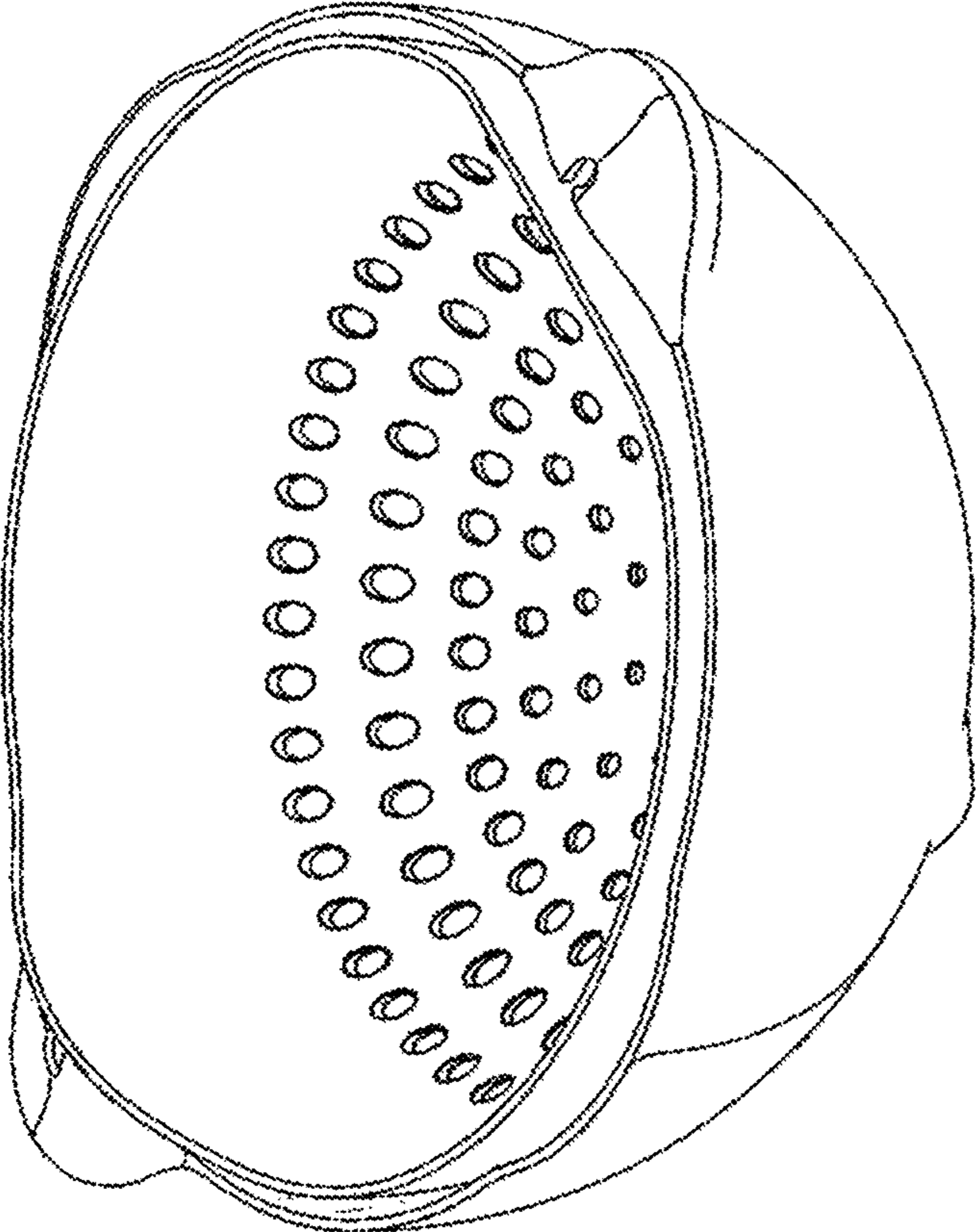

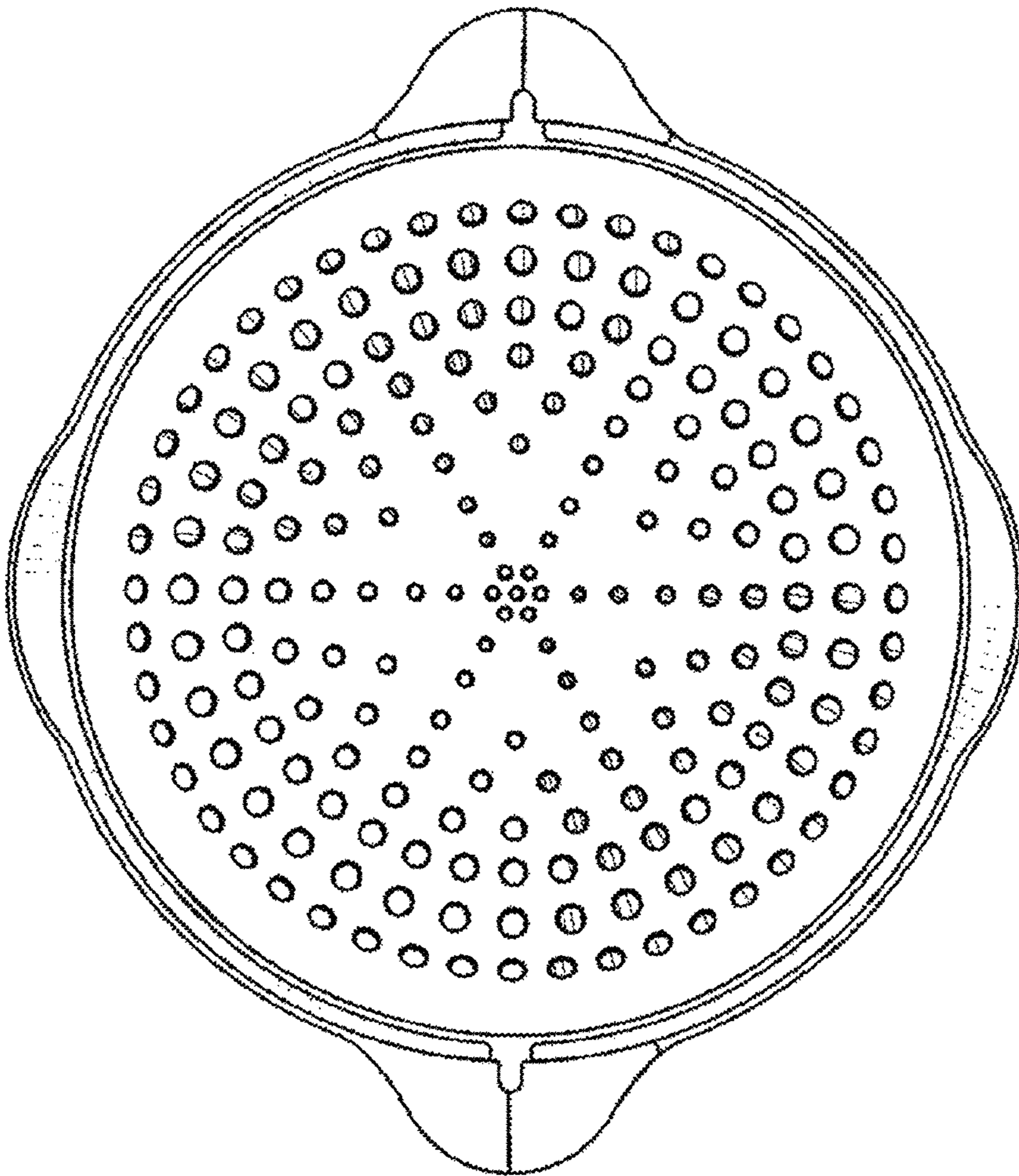

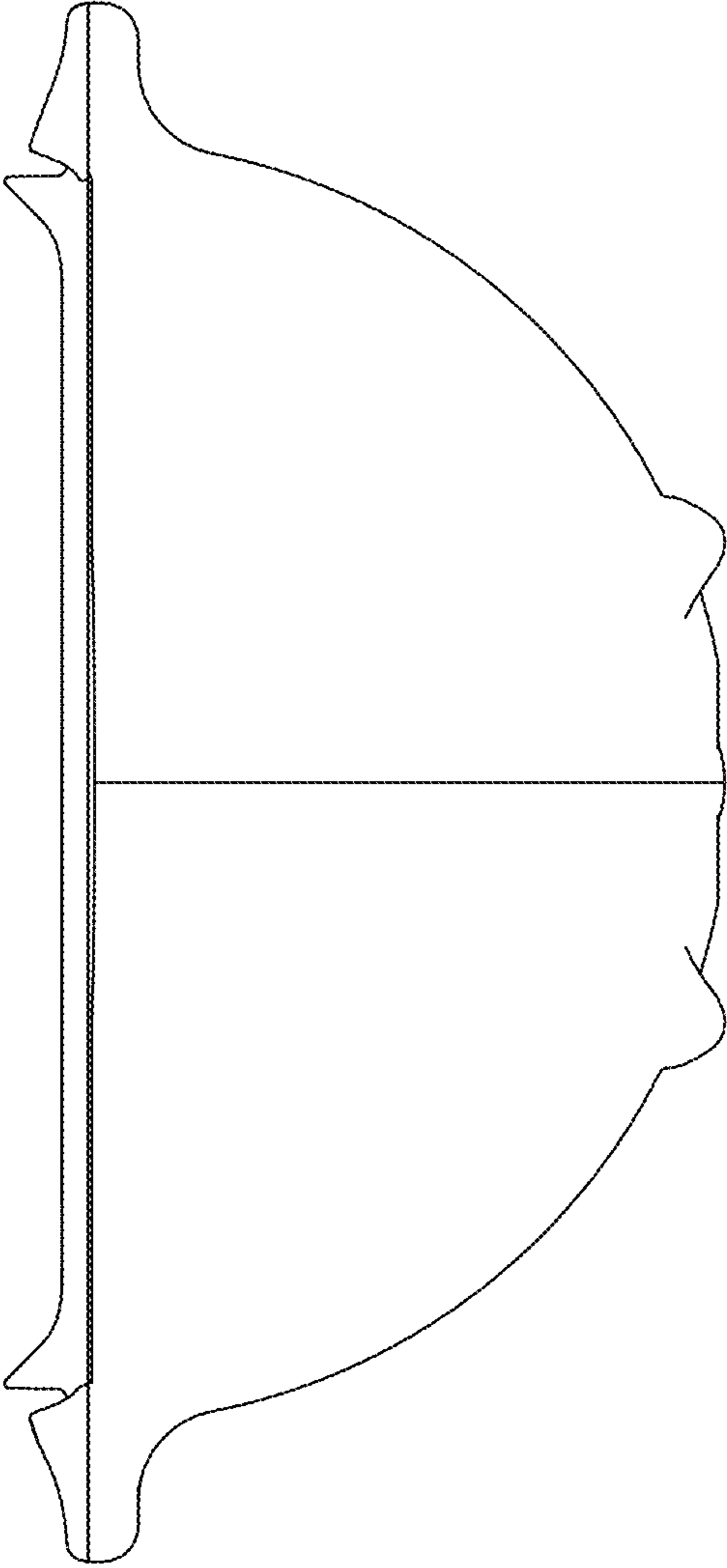

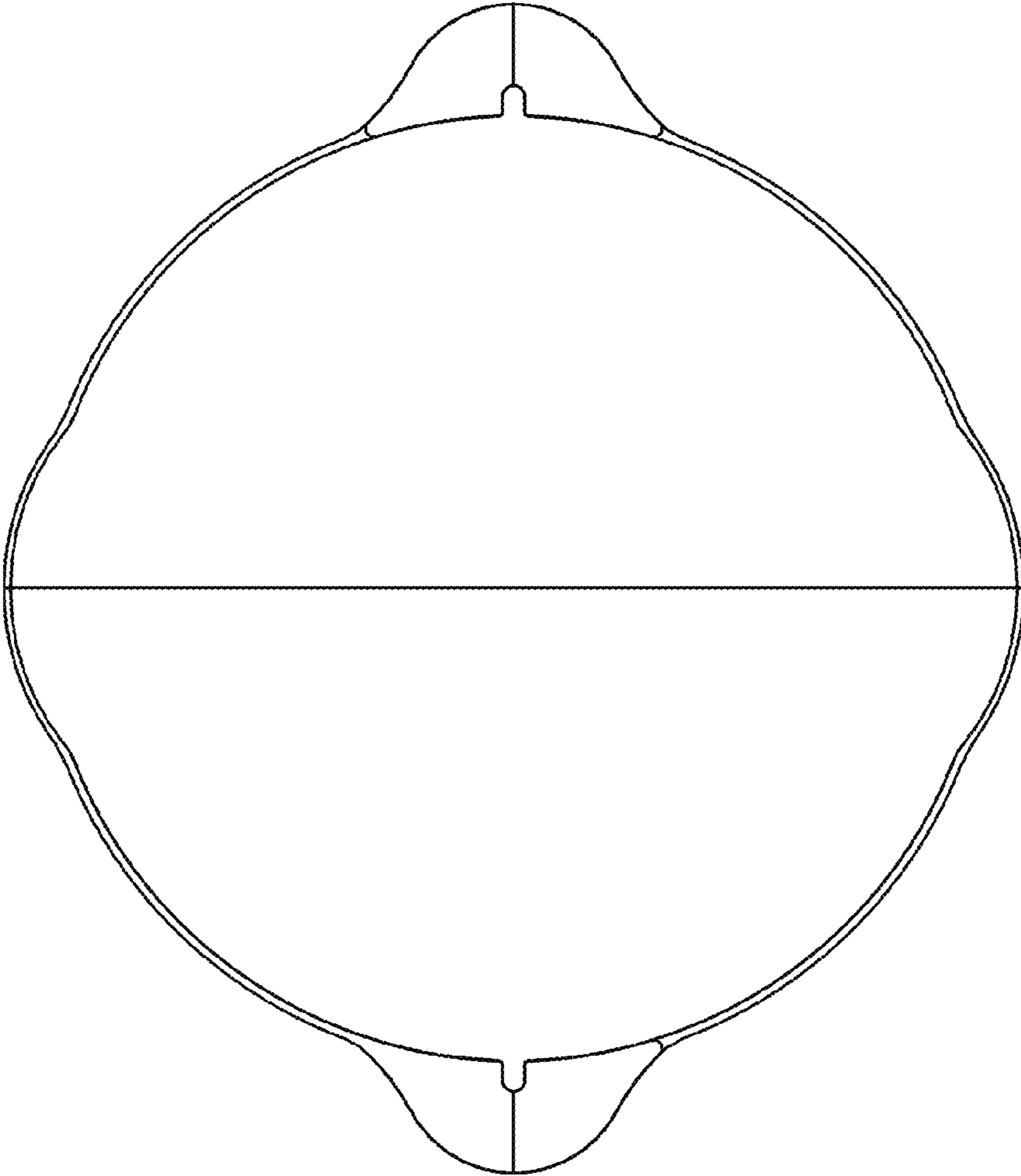

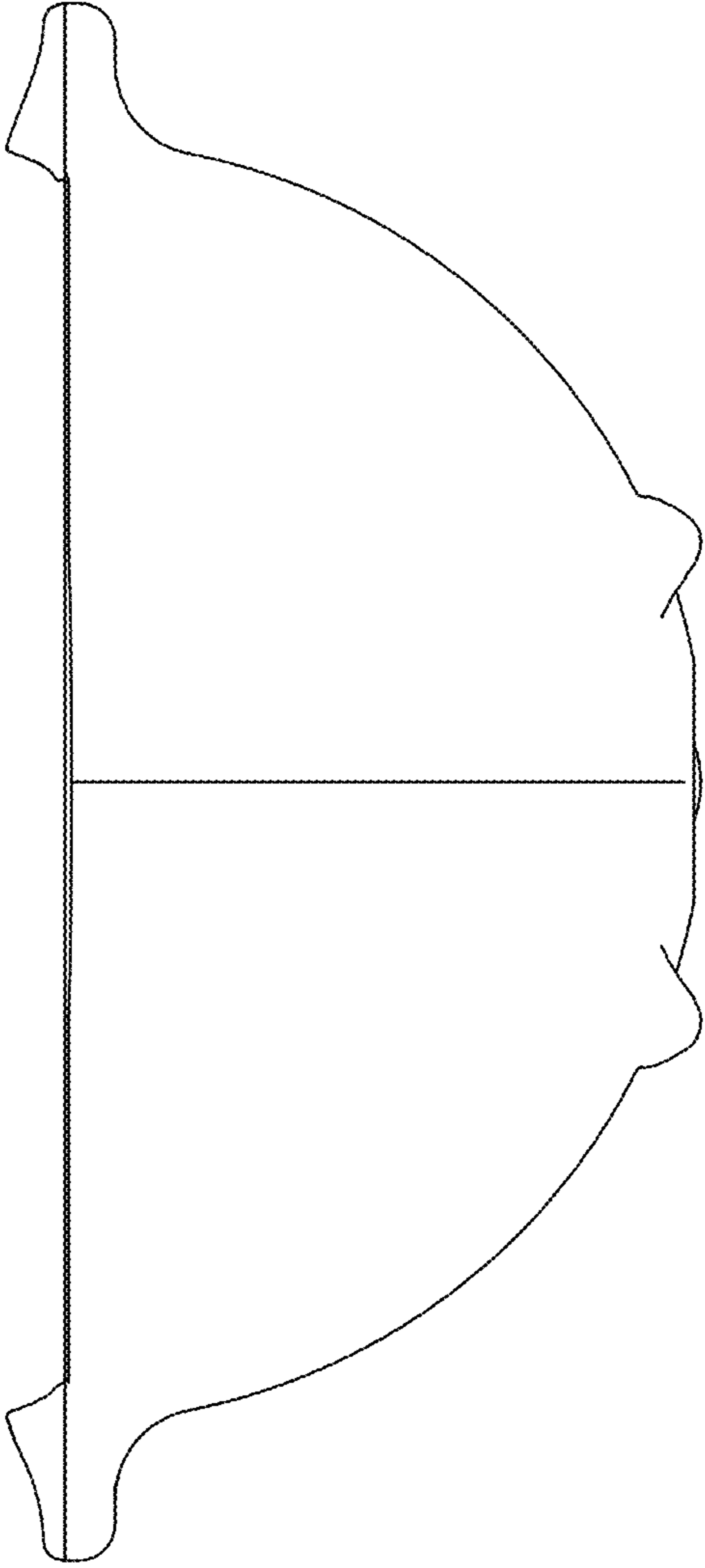

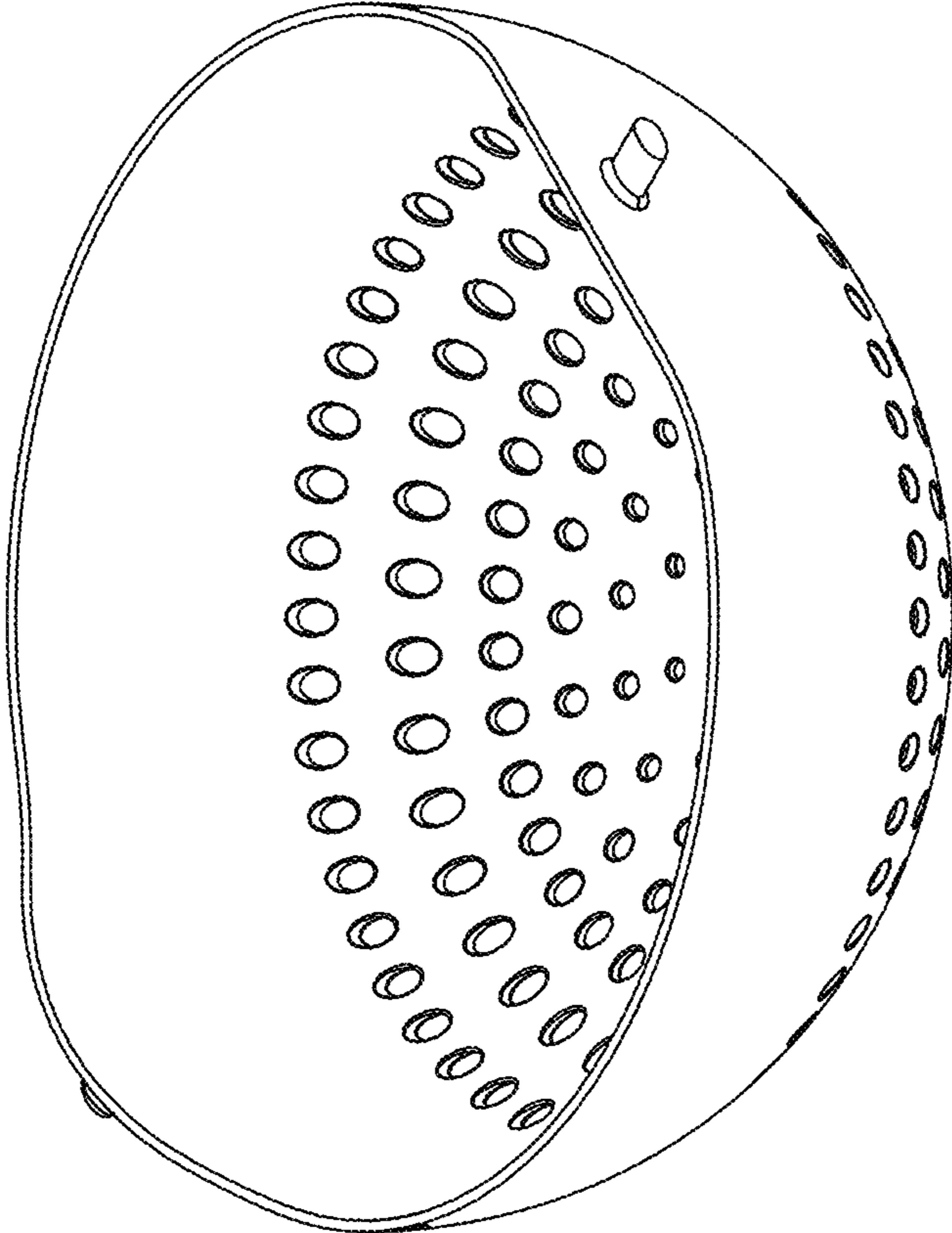

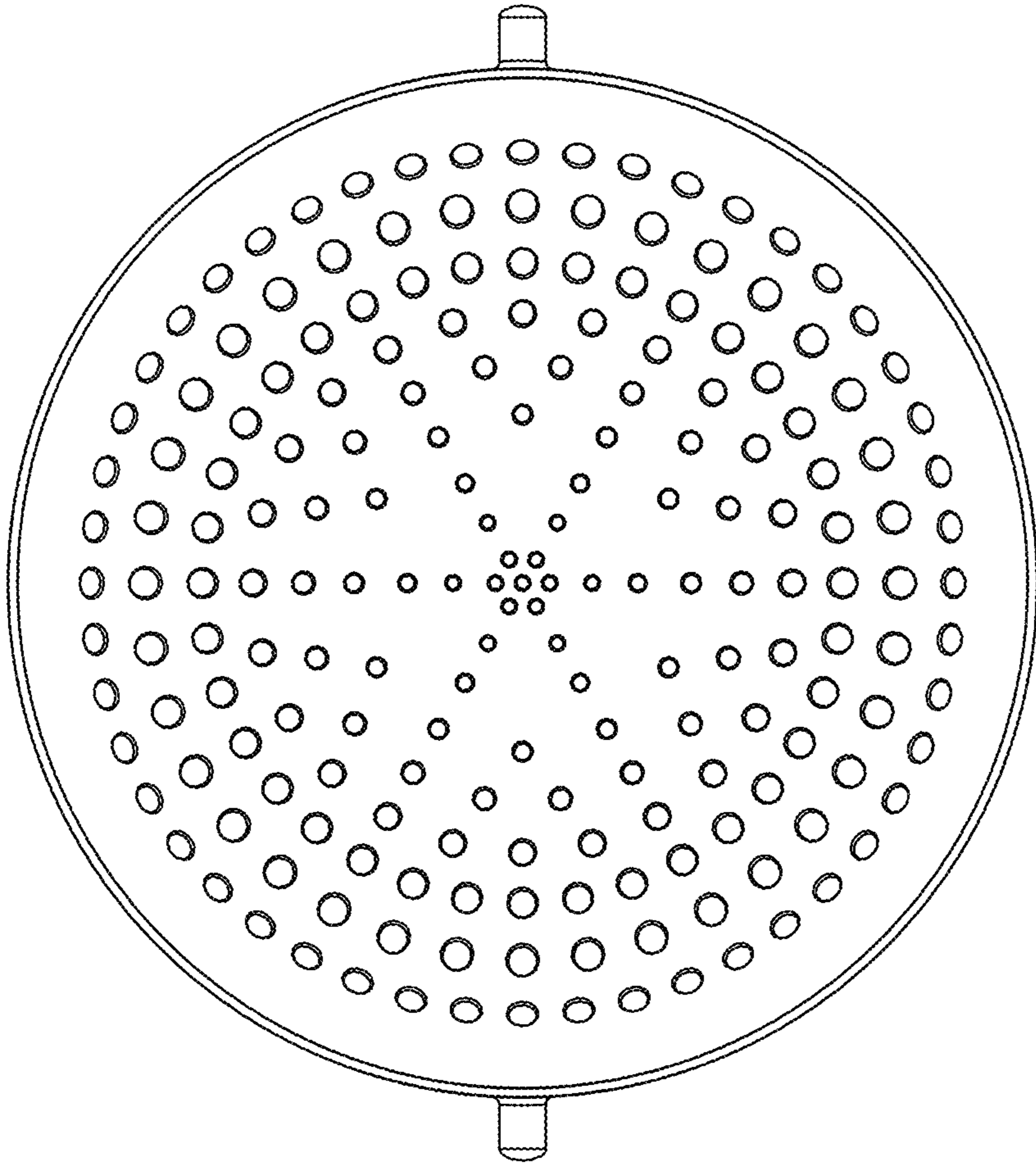

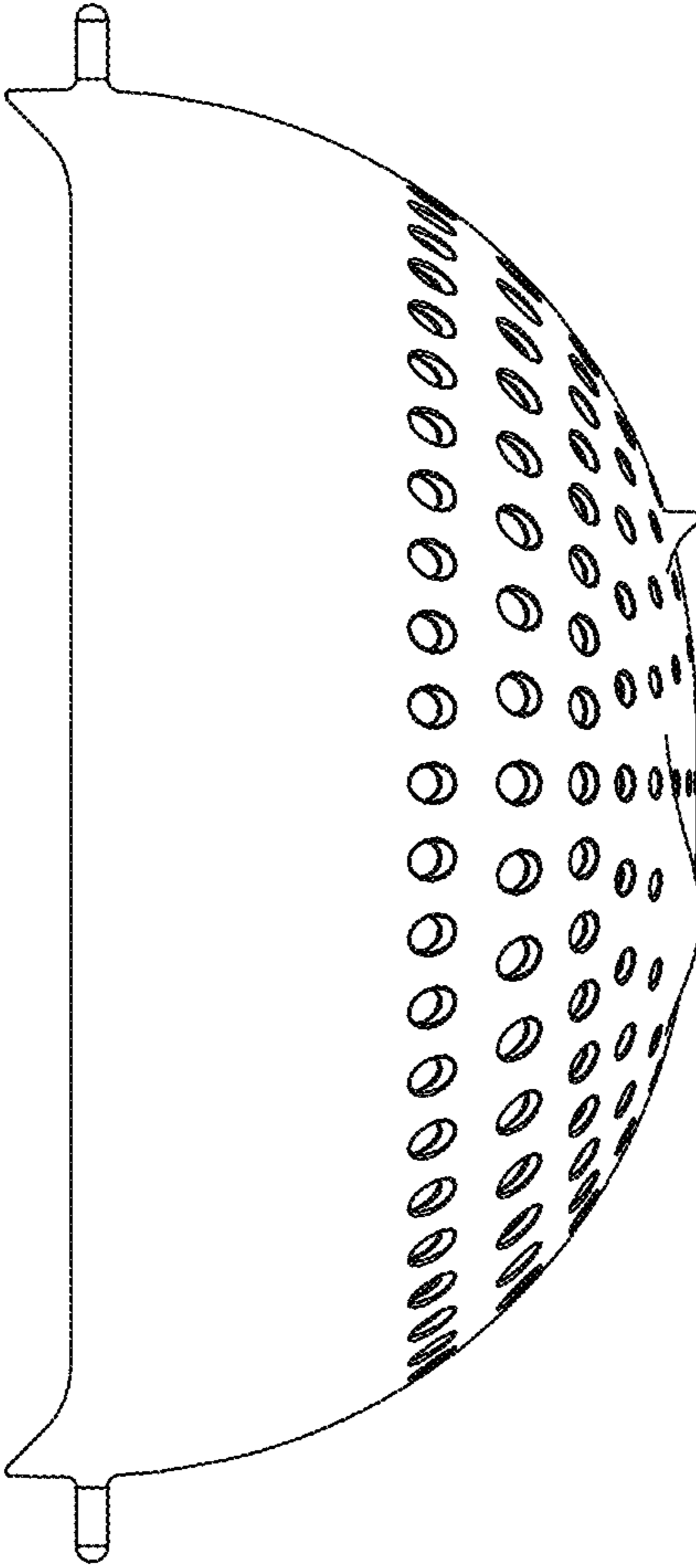

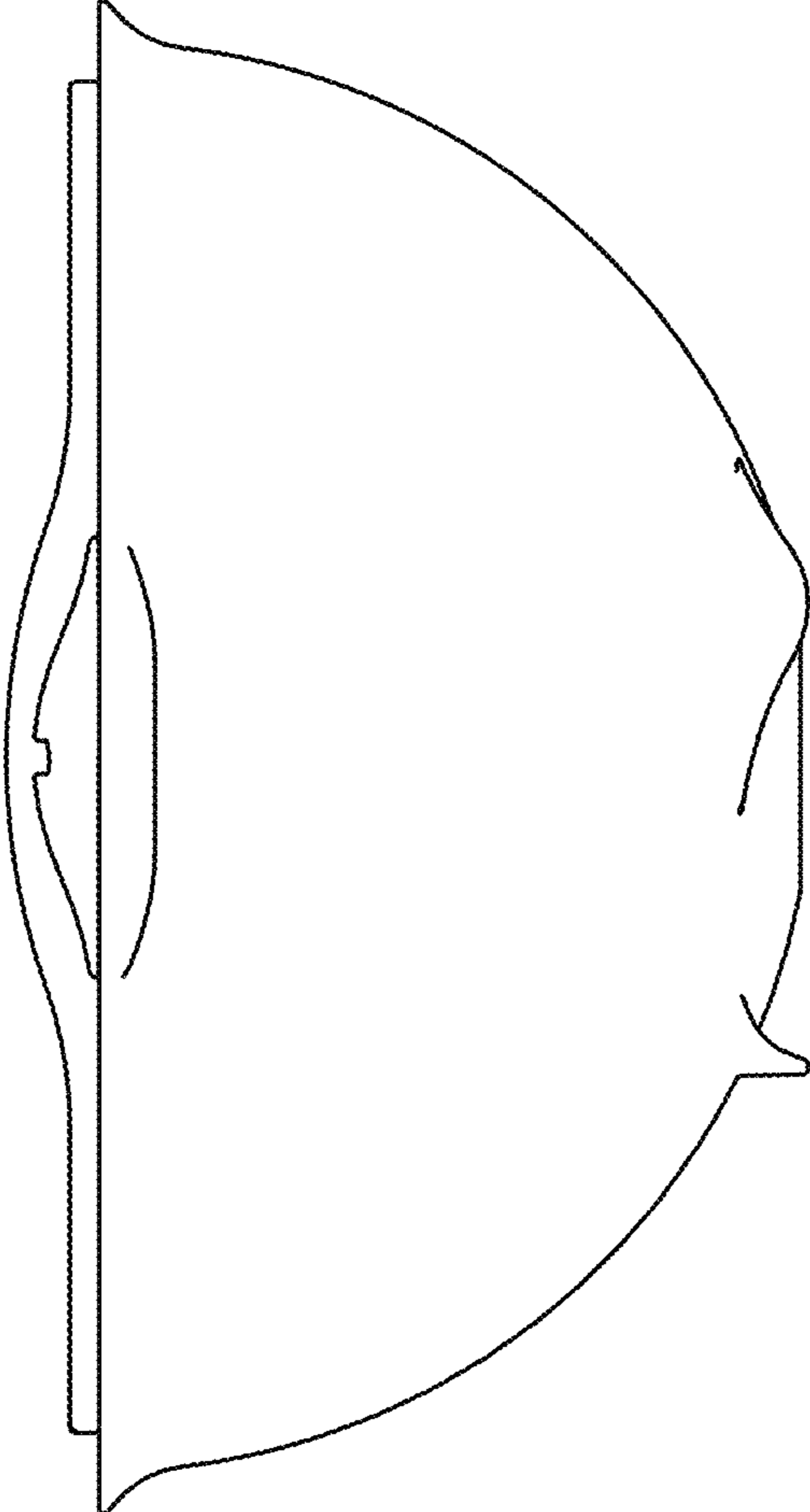

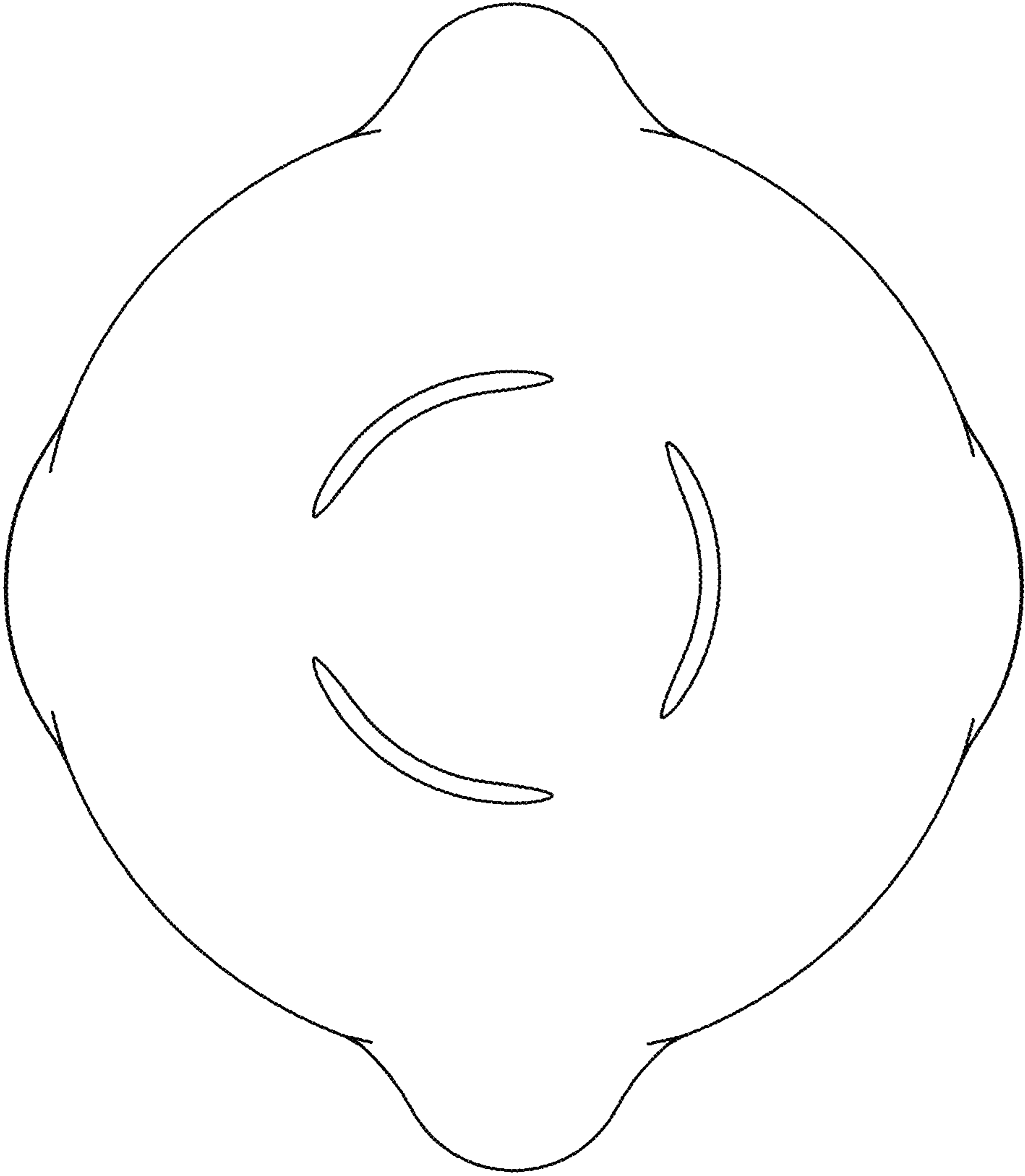

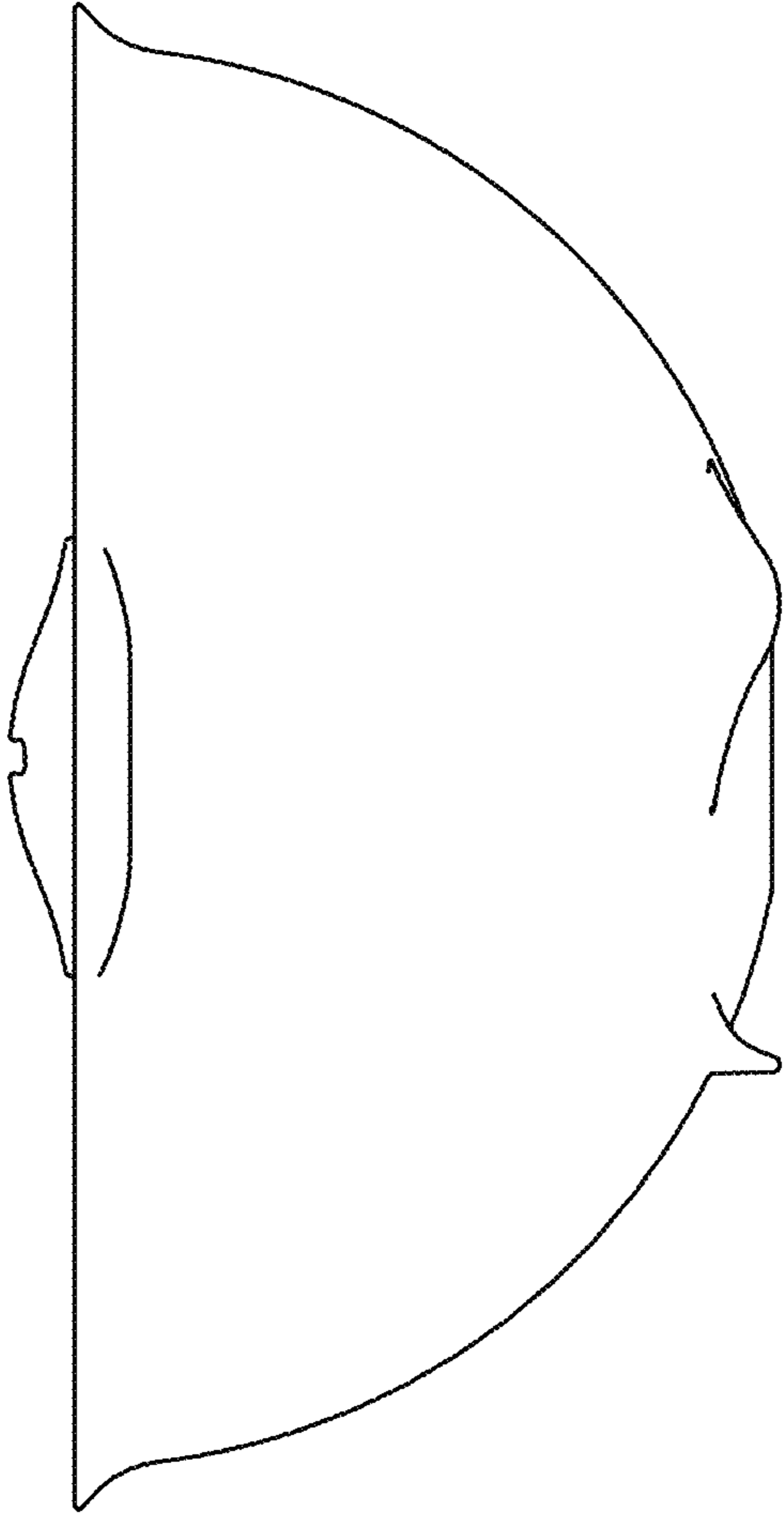

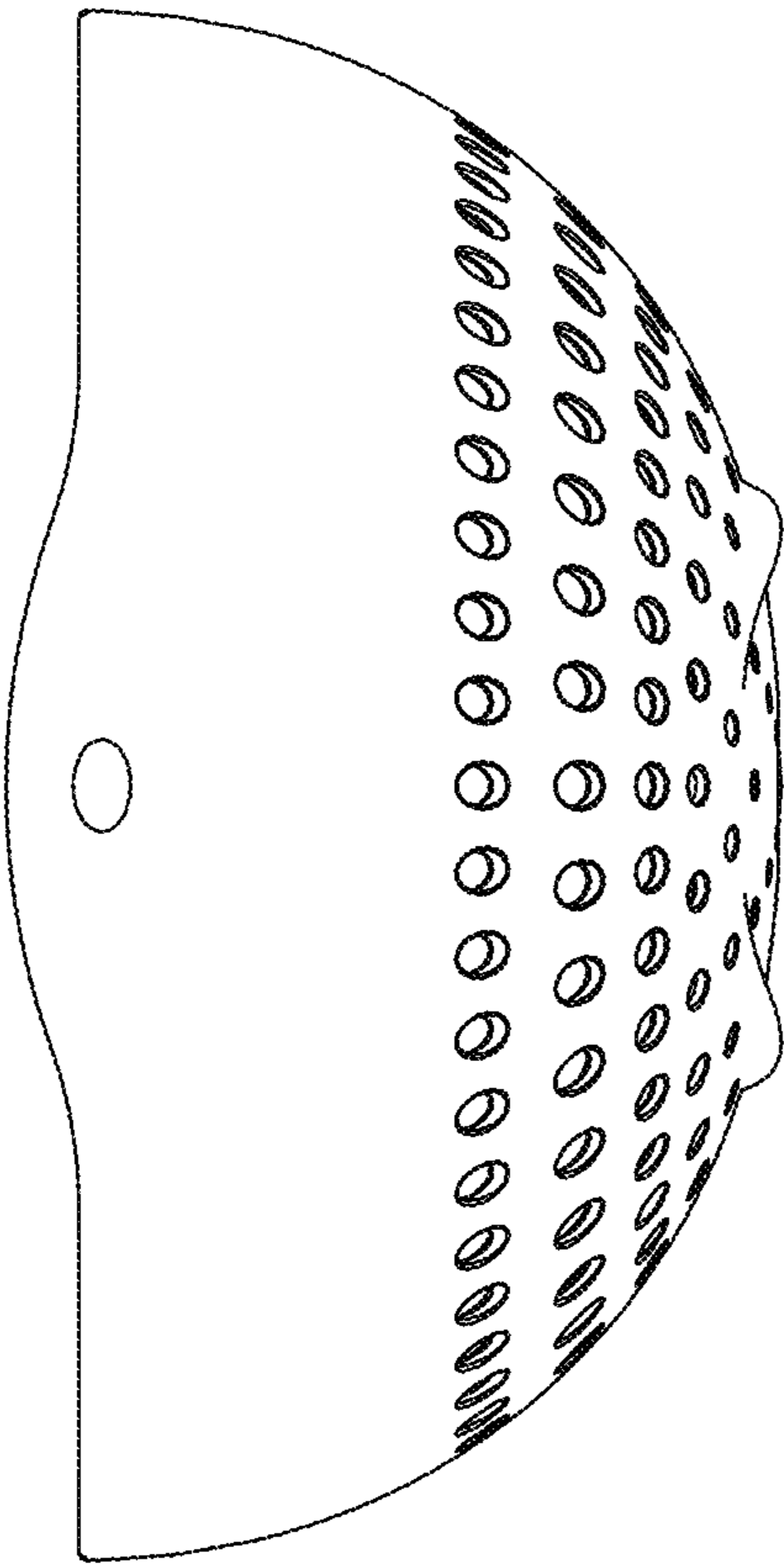

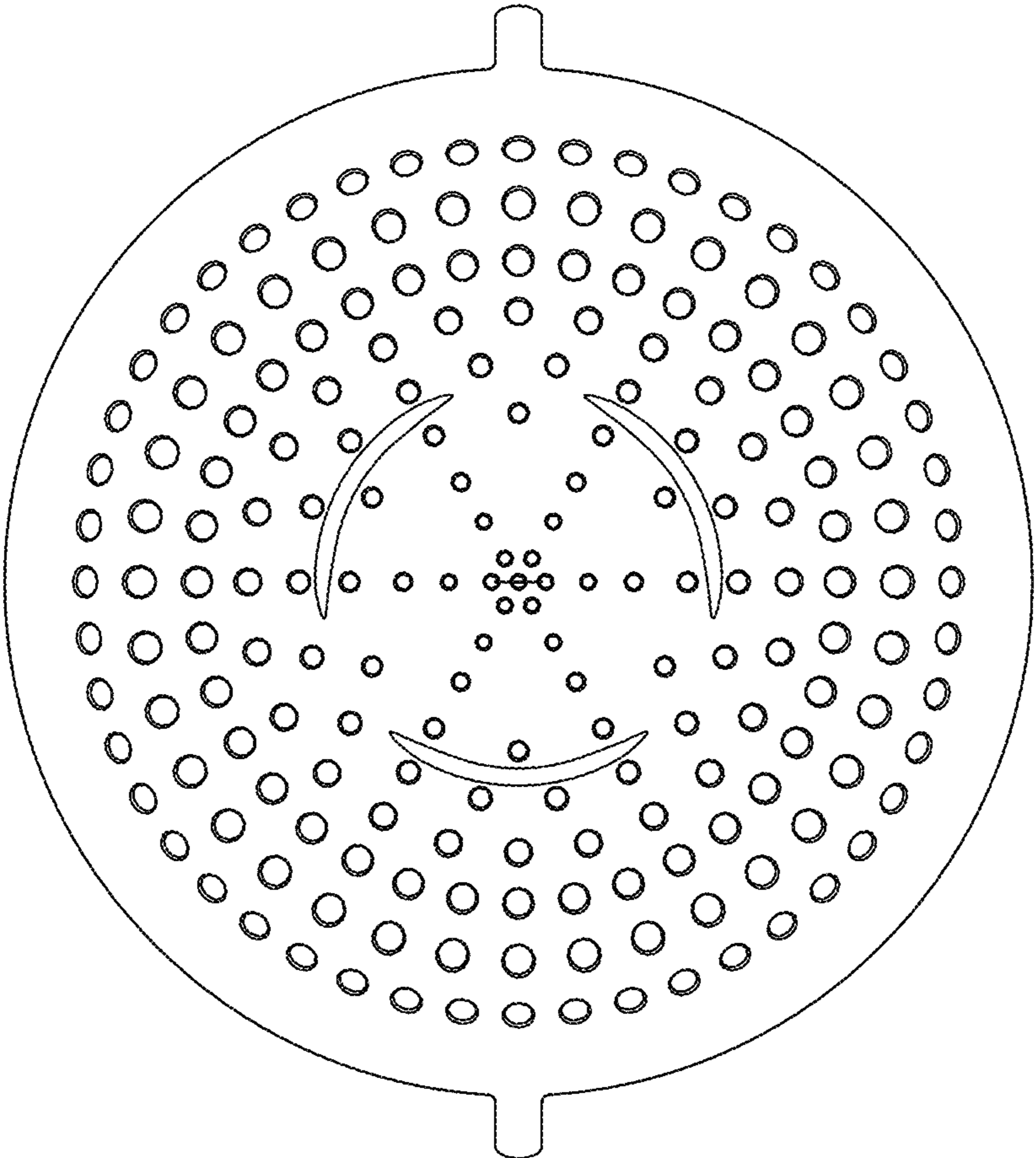

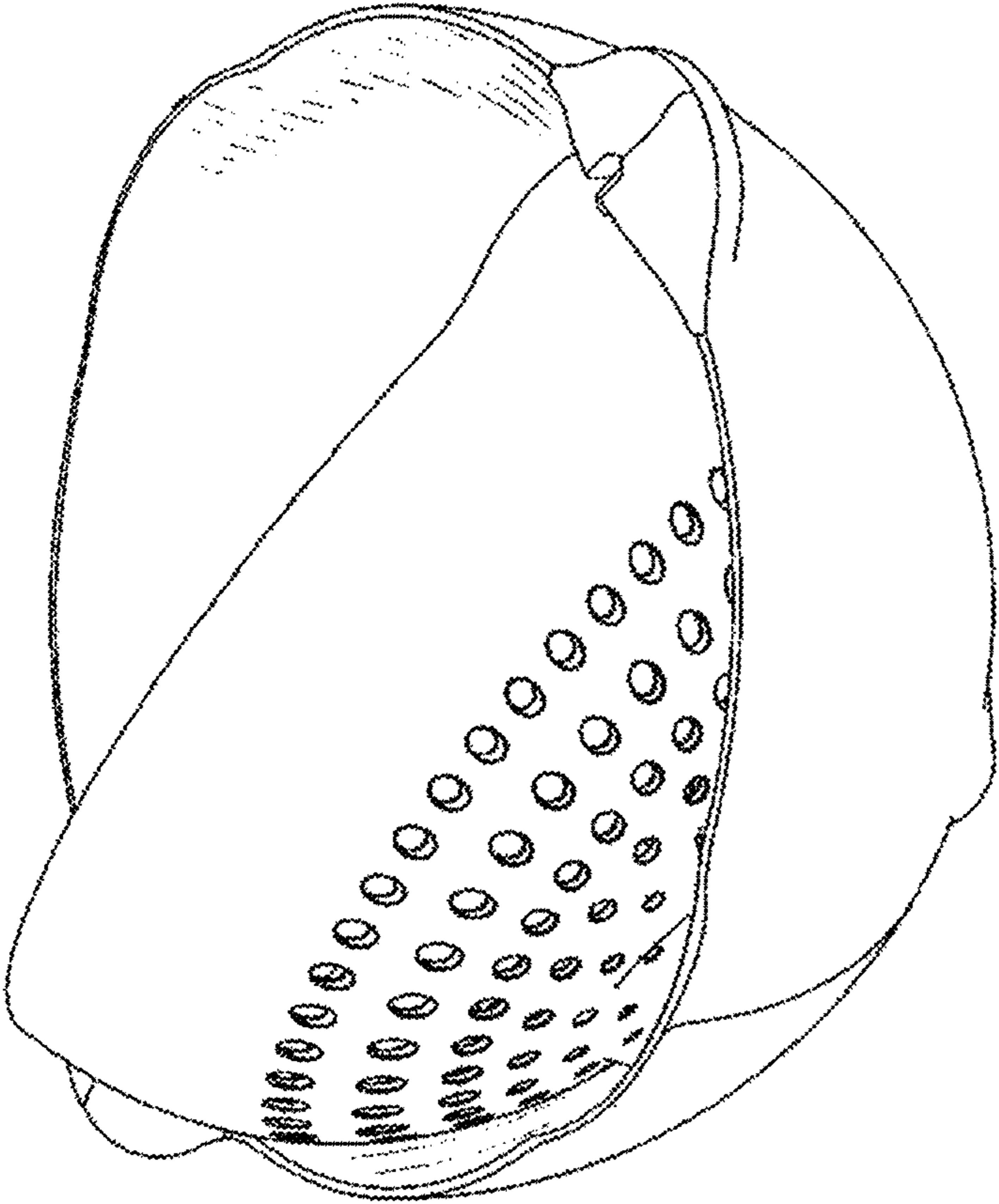

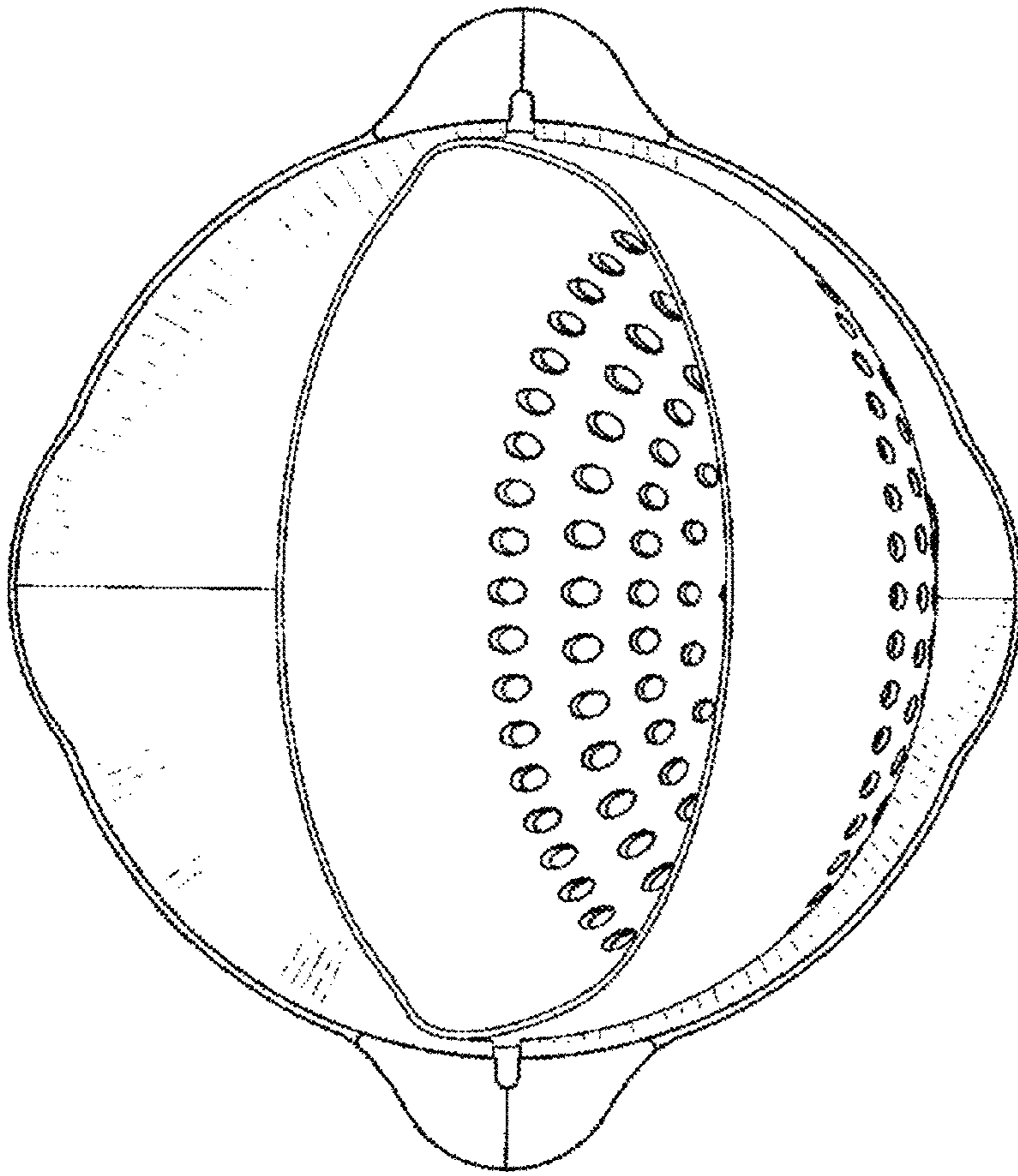

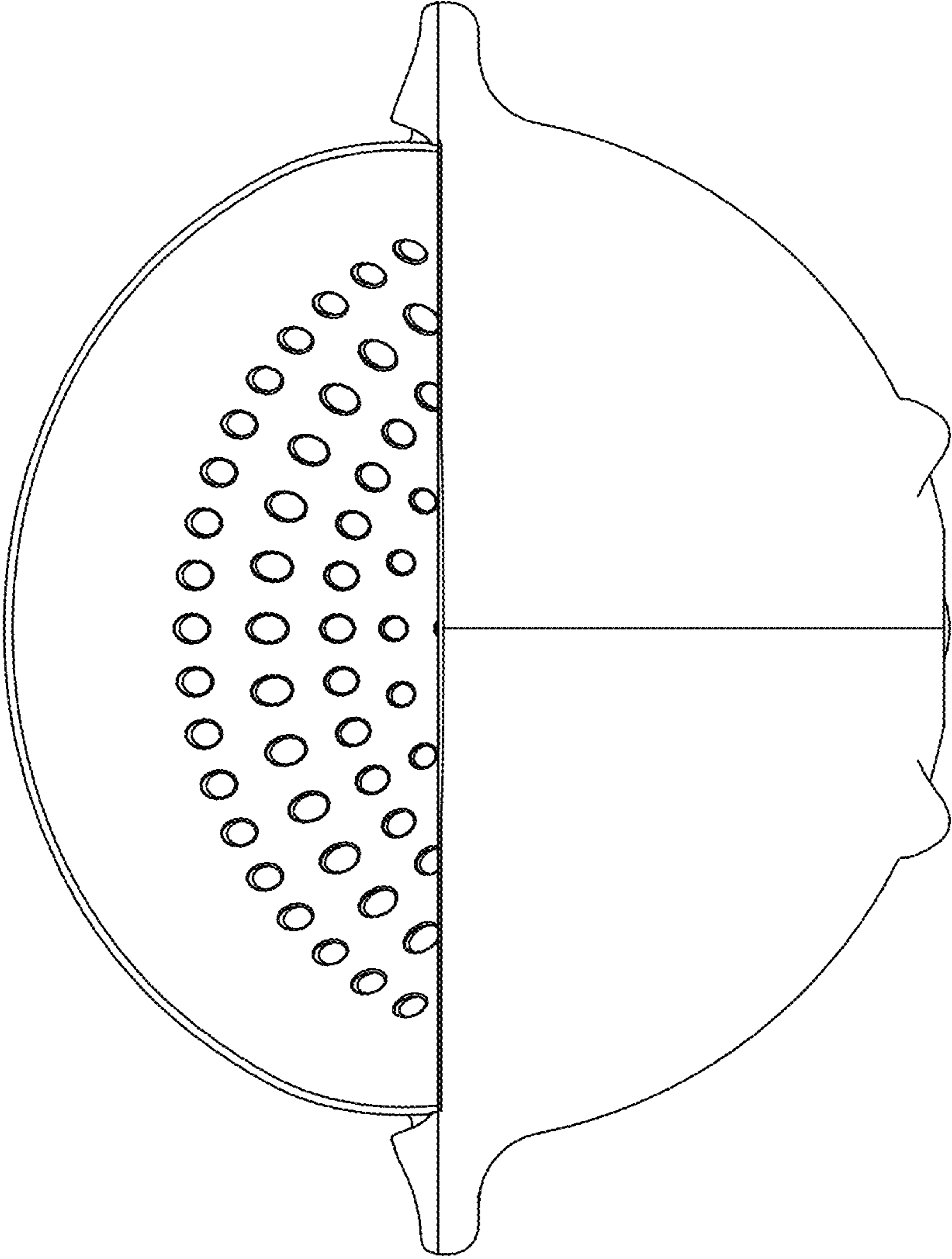

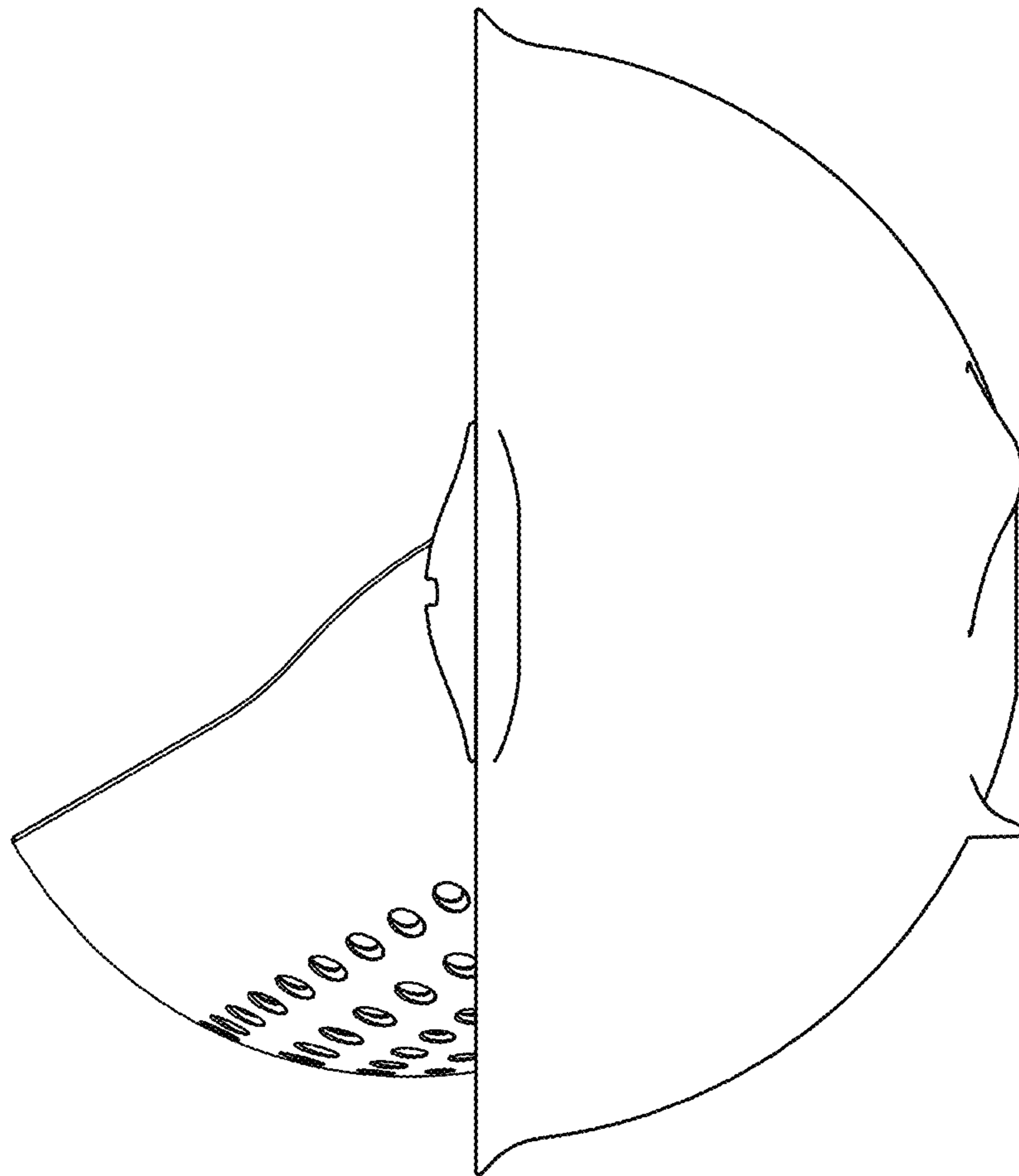
