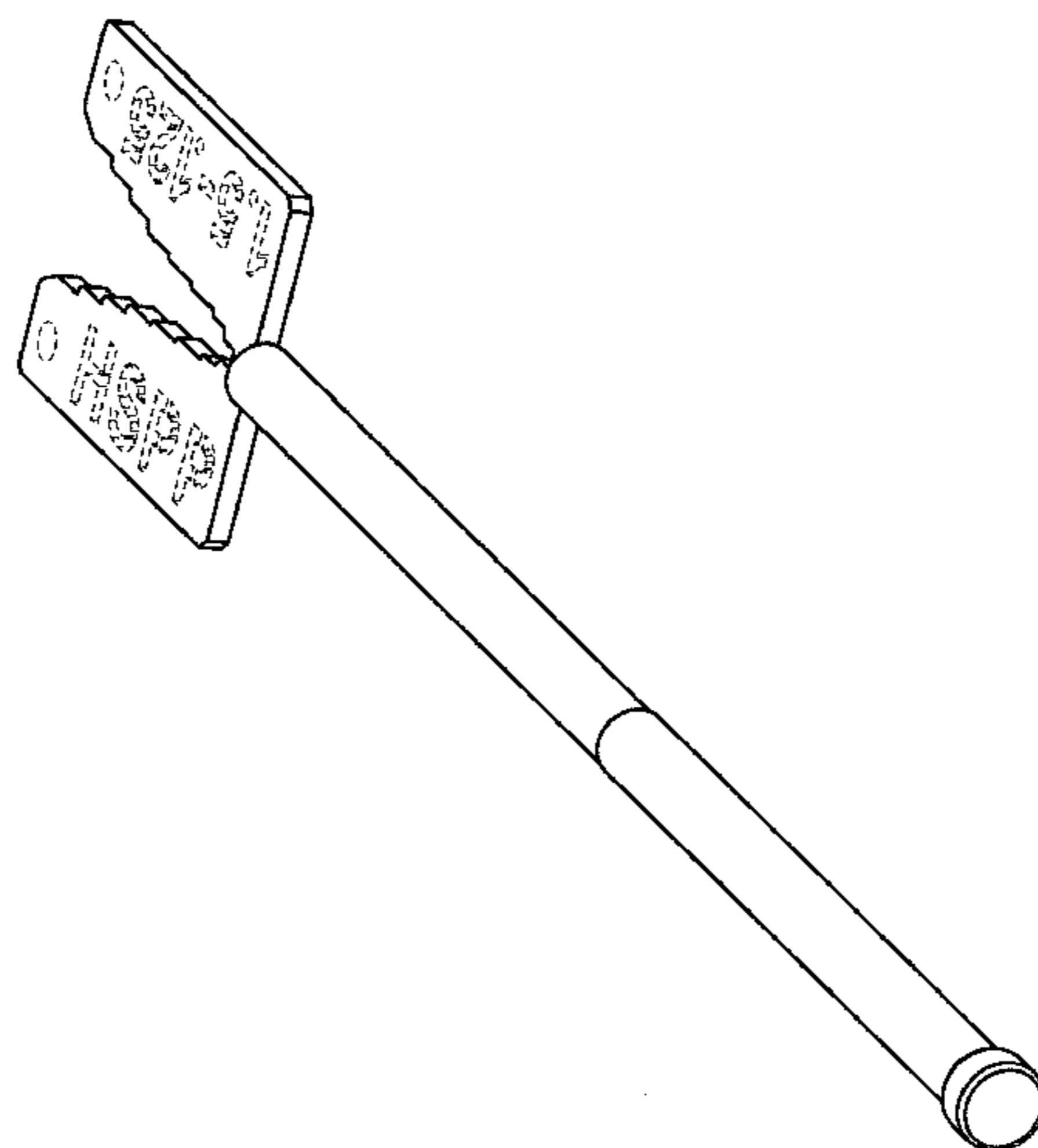
(57) **CLAIM**

The ornamental design for a plate handling tool, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a plate handling tool, illustrating the design;
 FIG. 2 is a right side view thereof, with the left side view being a mirror image;
 FIG. 3 is a bottom view thereof, with the top view being identical;
 FIG. 4 is a front view thereof; and,
 FIG. 5 is a rear view thereof.
 The broken lines depict portions of the plate handling tool in which the design is embodied that are not considered part of the claimed design.

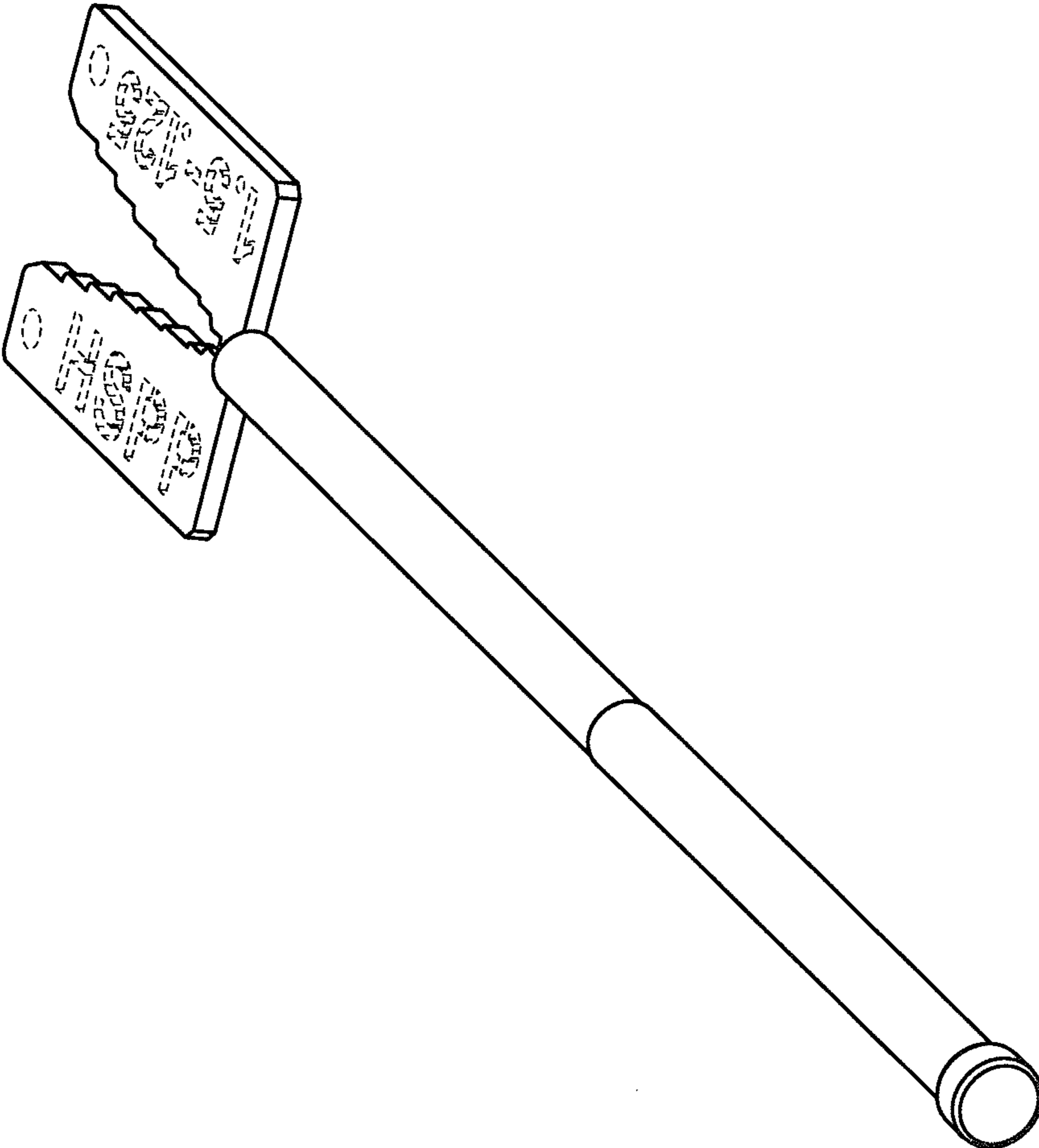

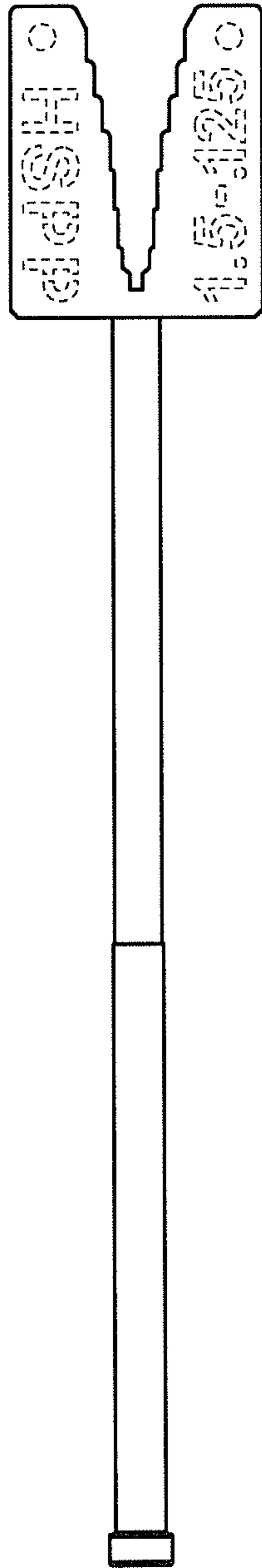
