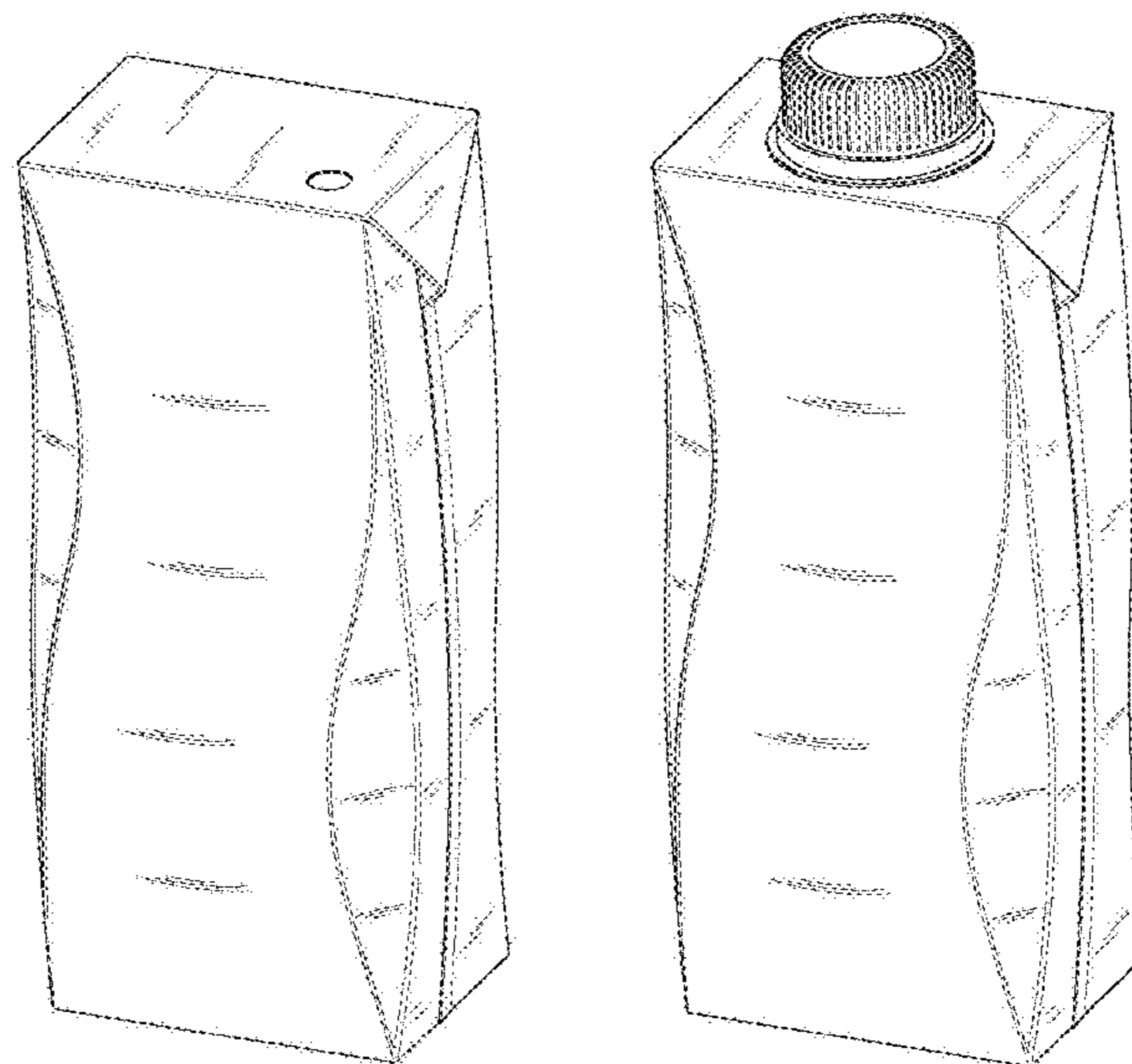
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front-left perspective view of a first embodiment of a packaging, showing our new design;

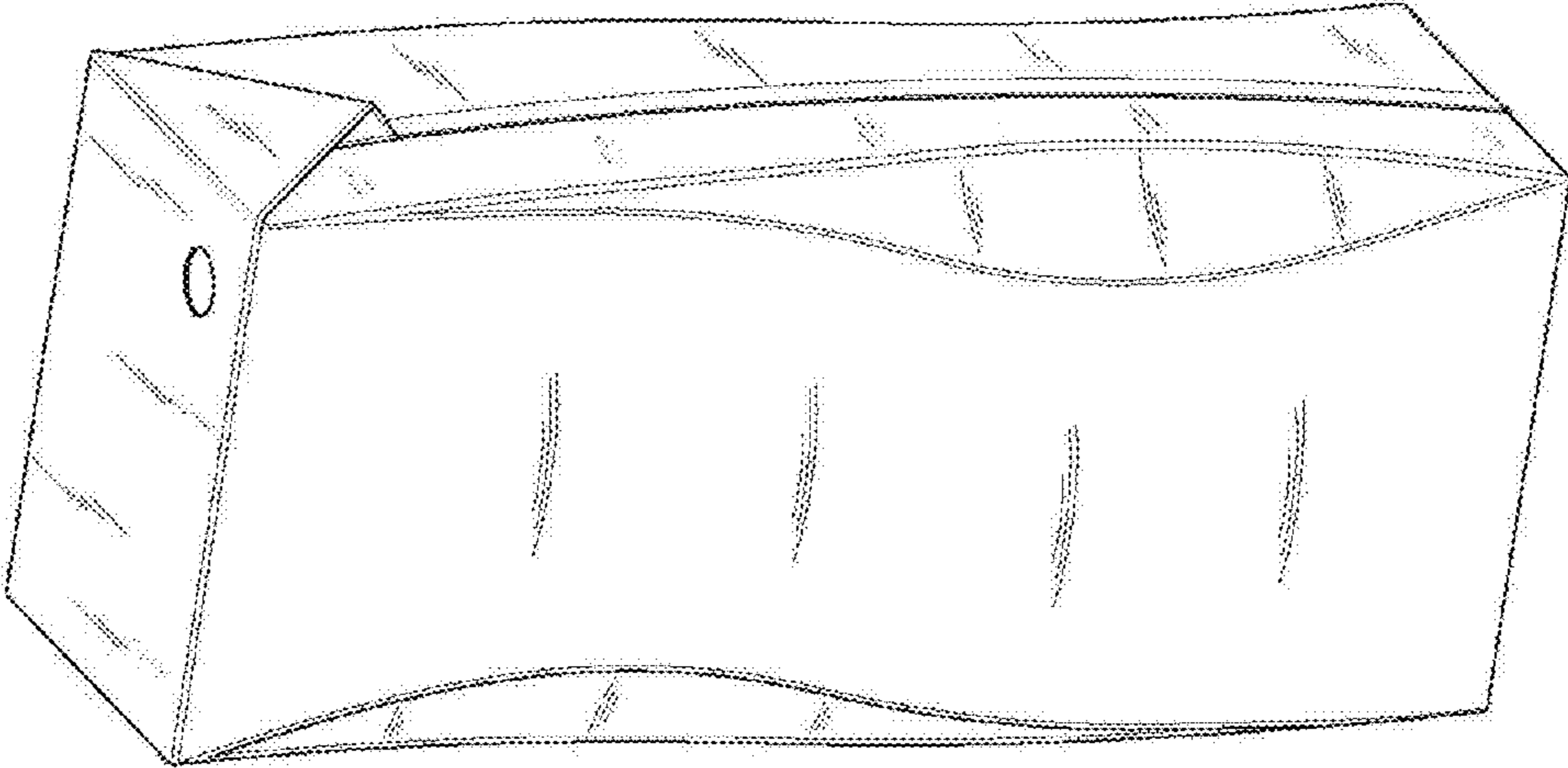

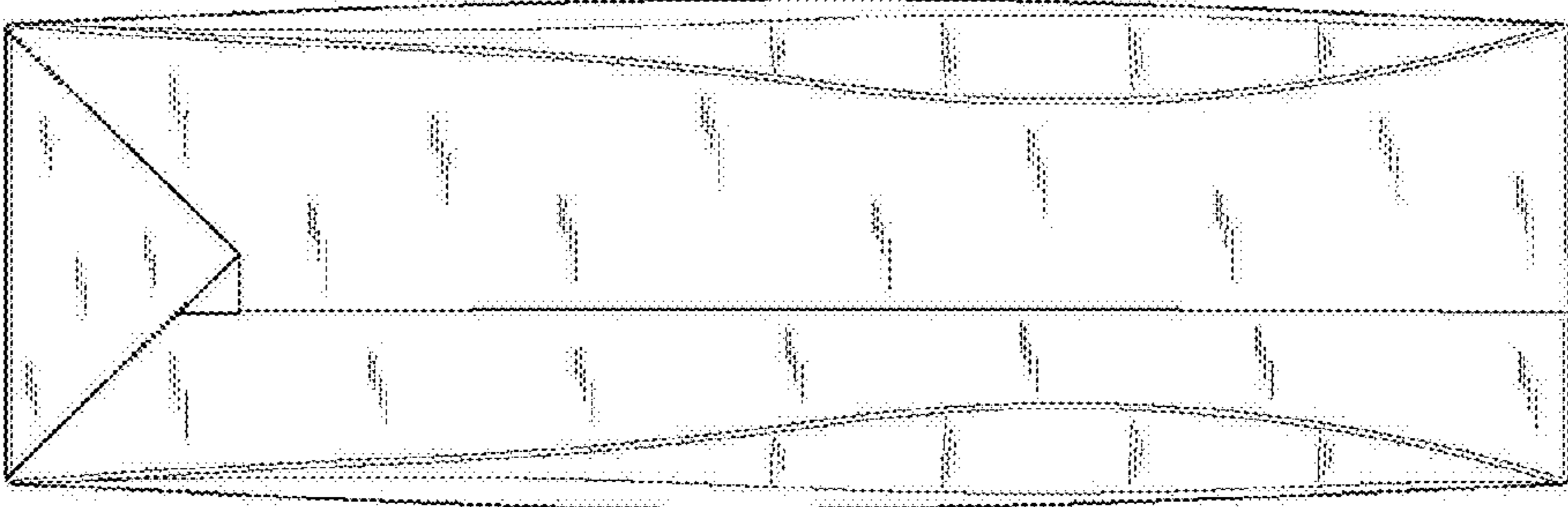

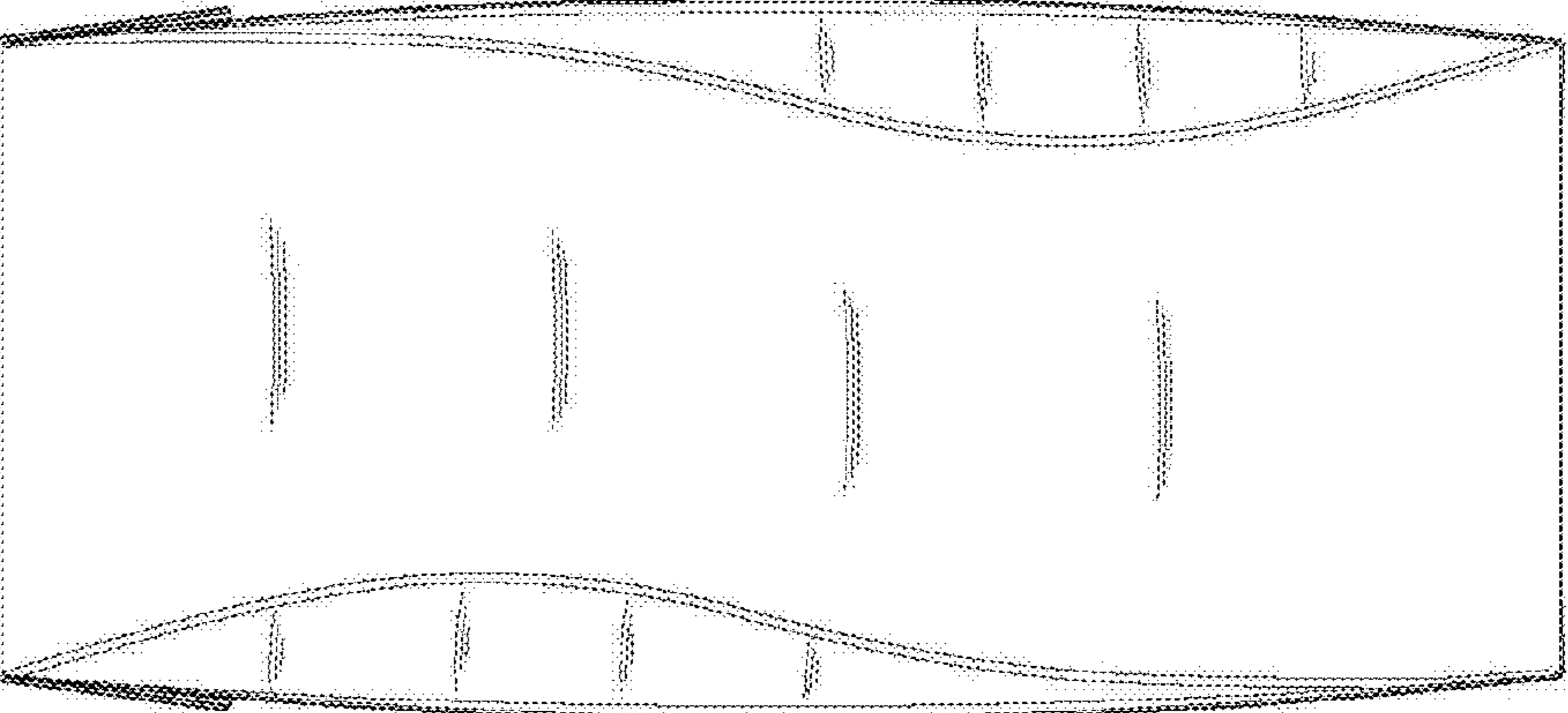

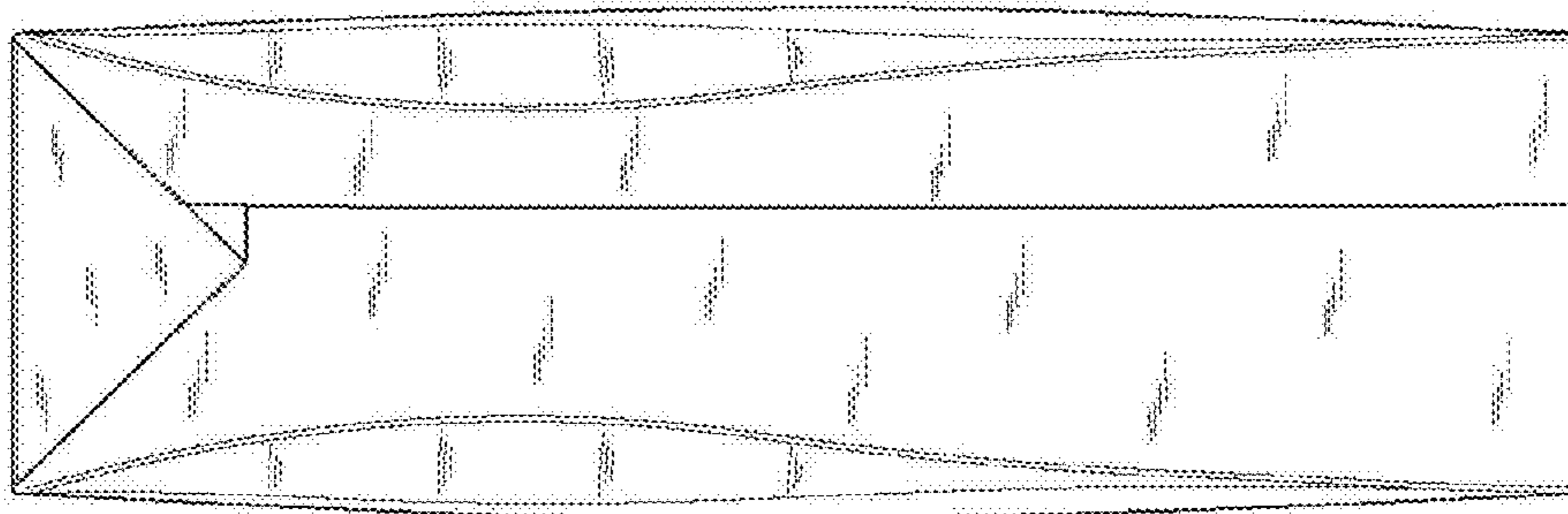

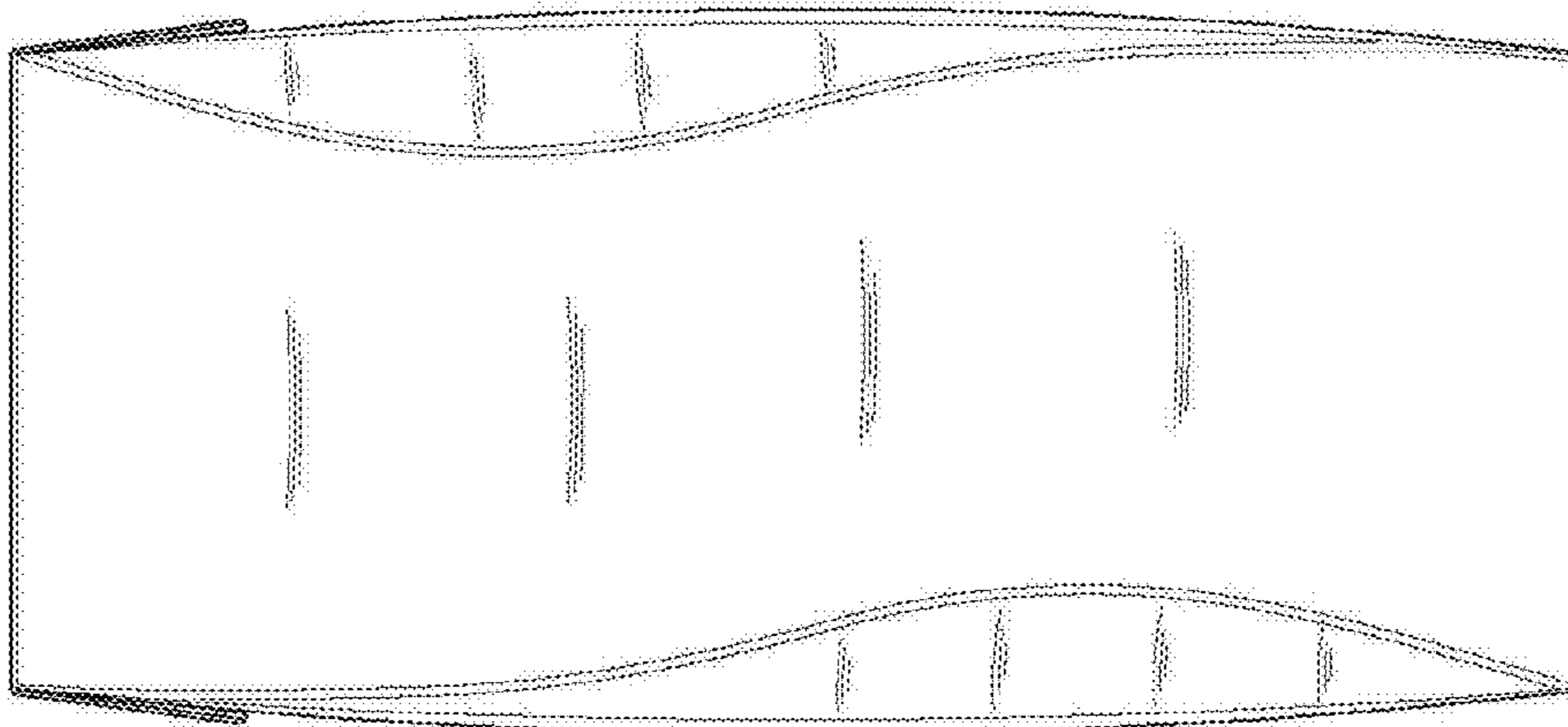

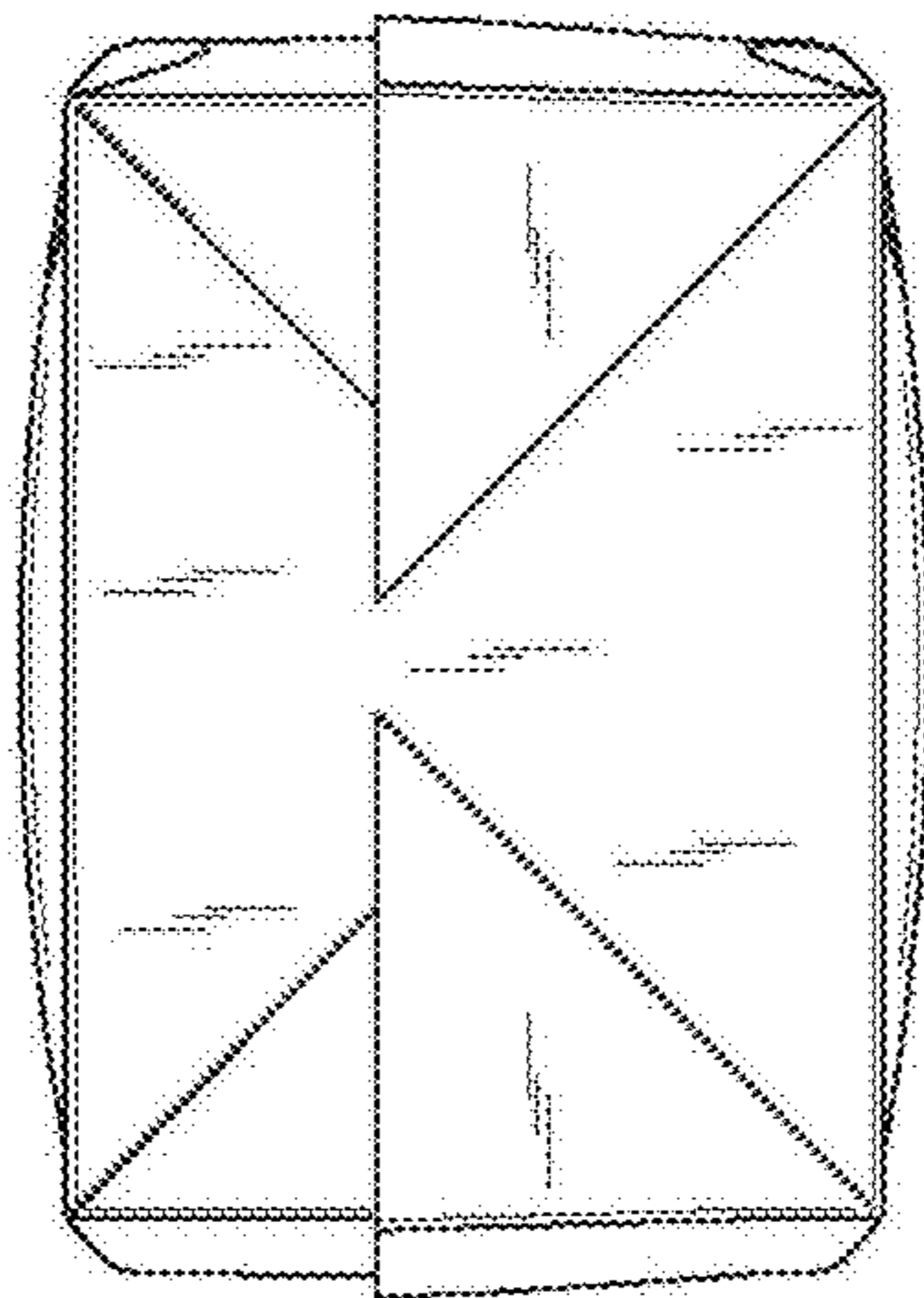

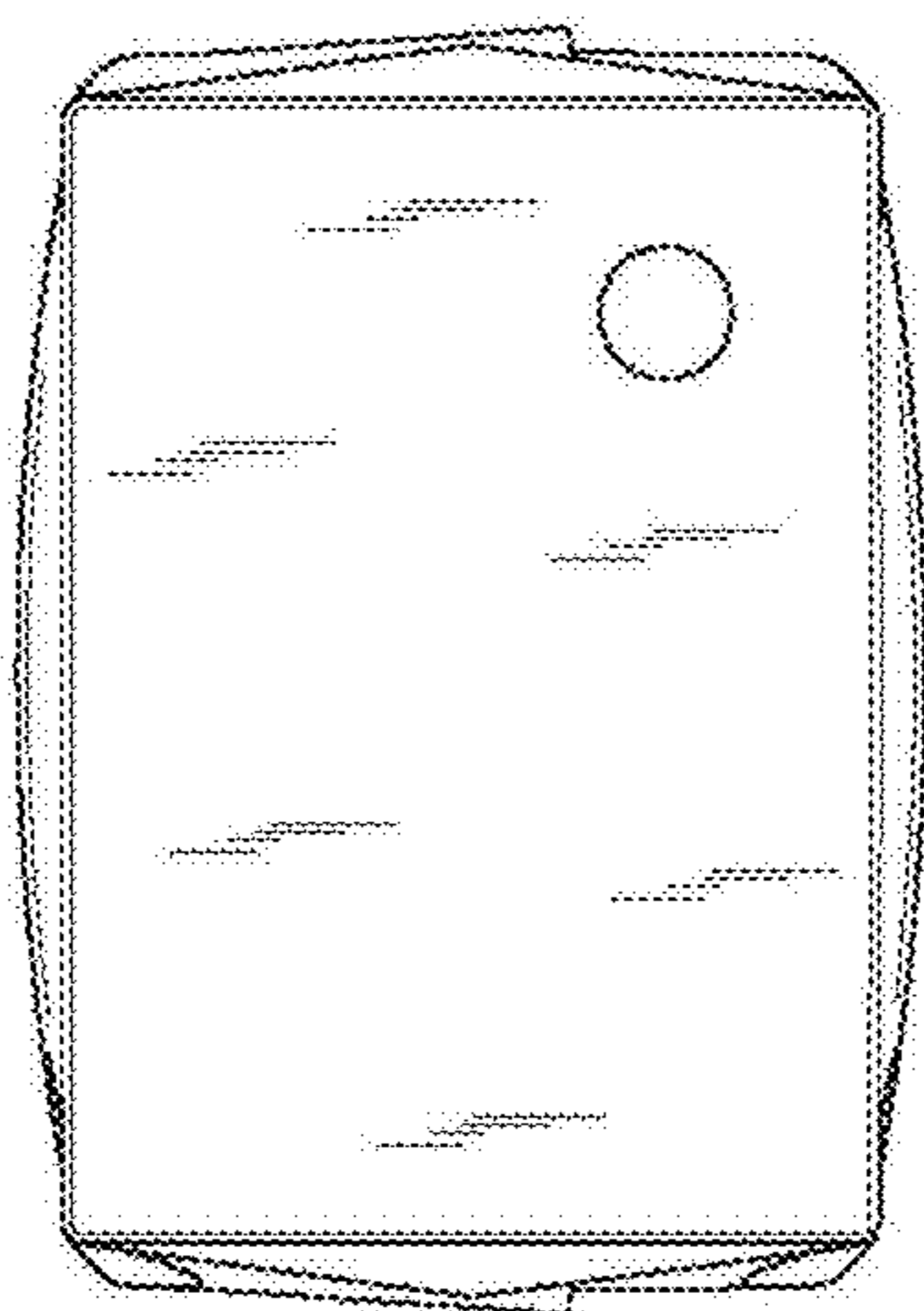

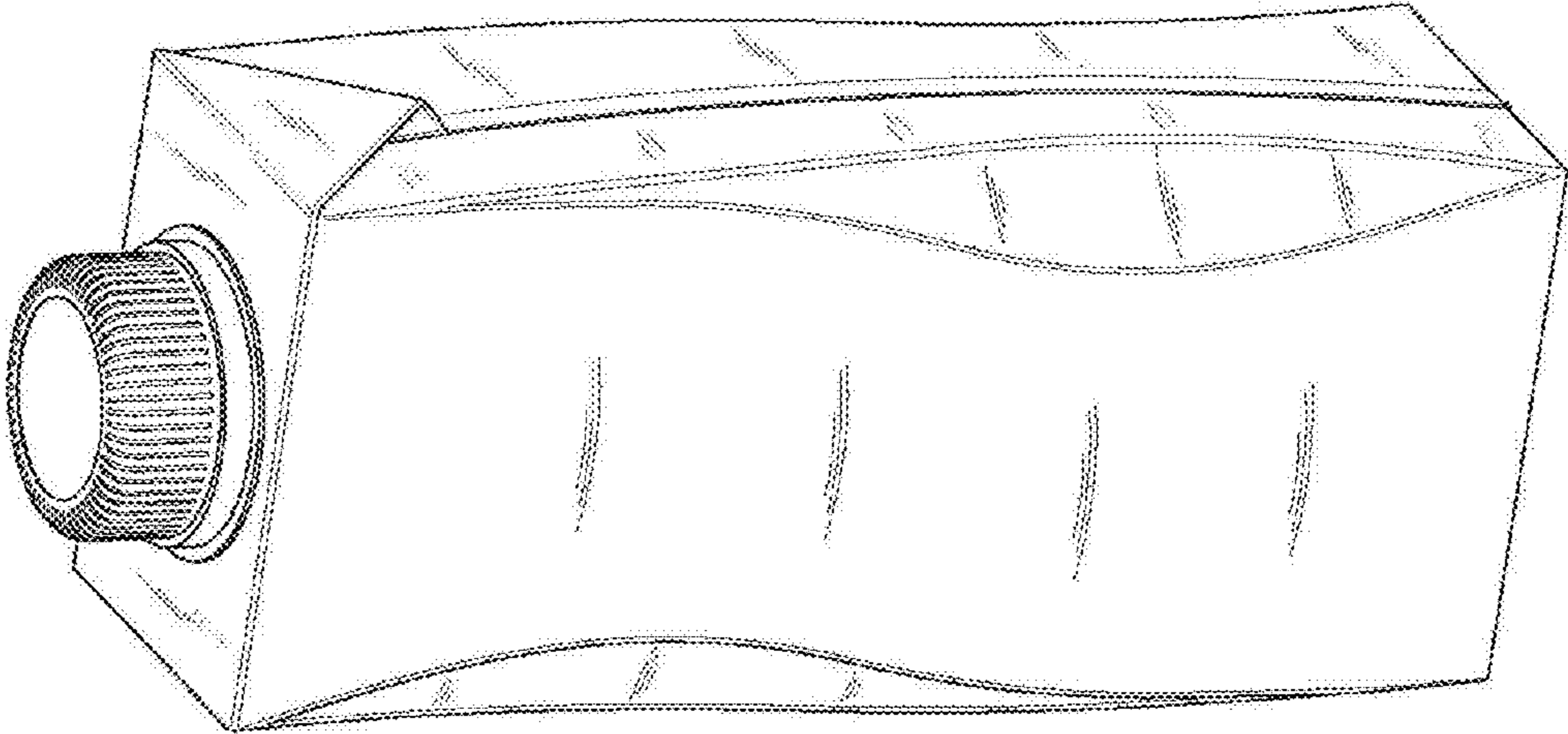

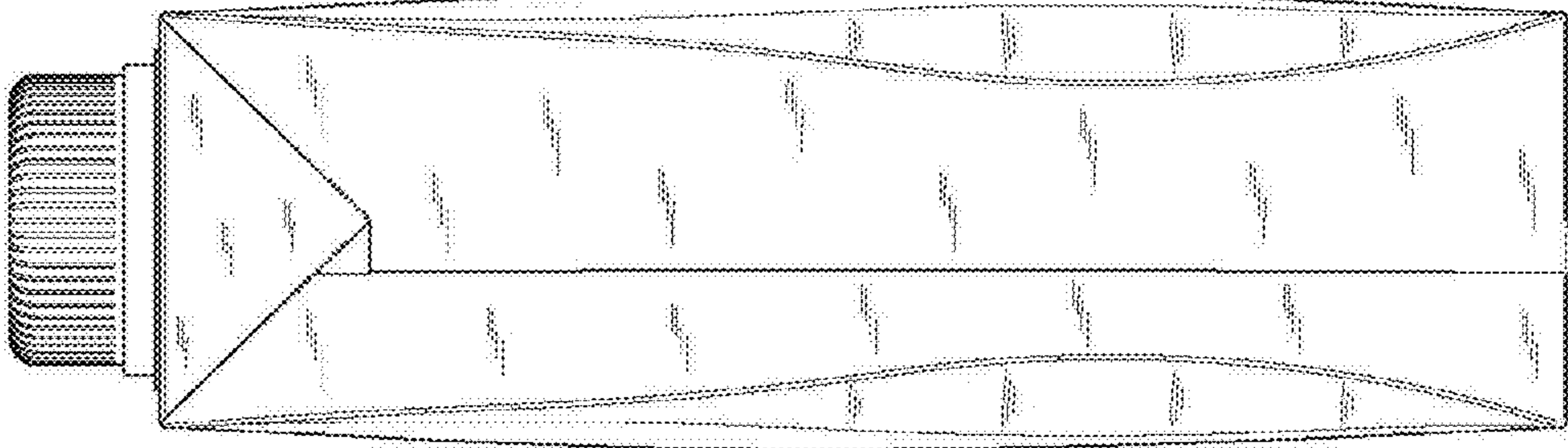

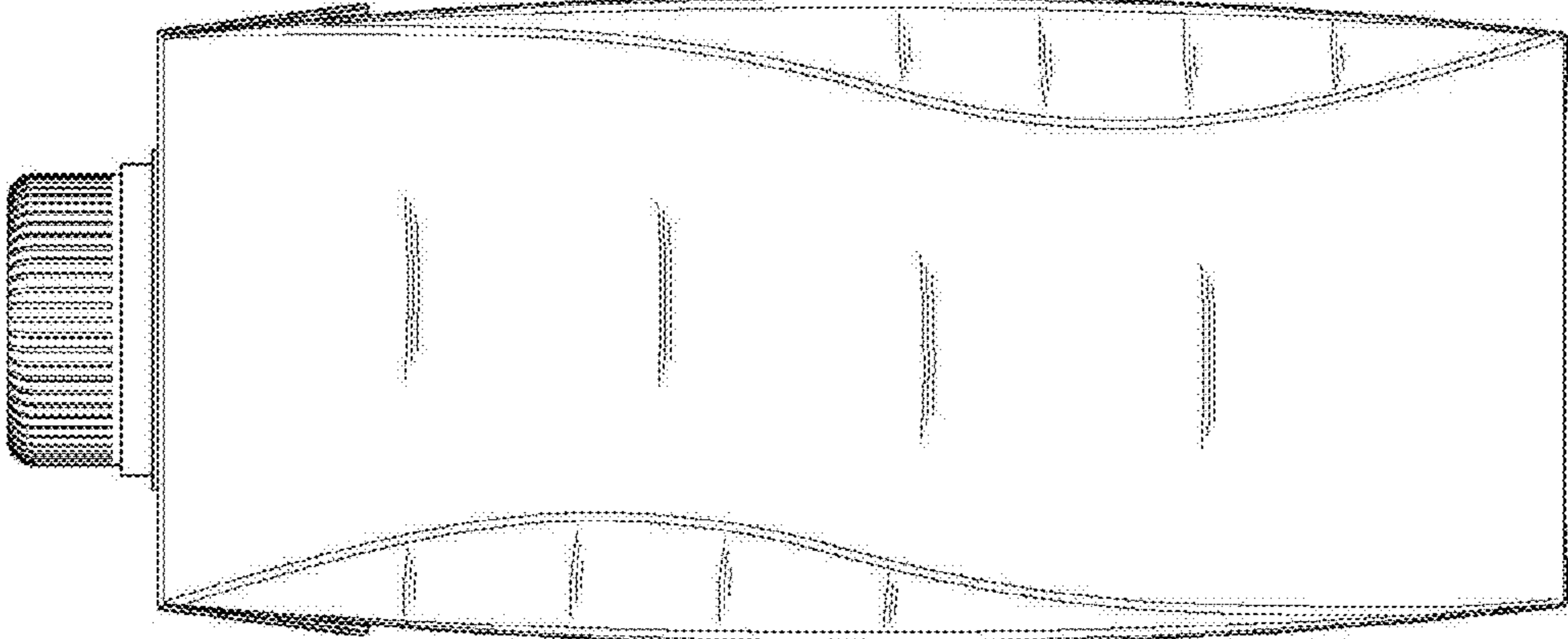

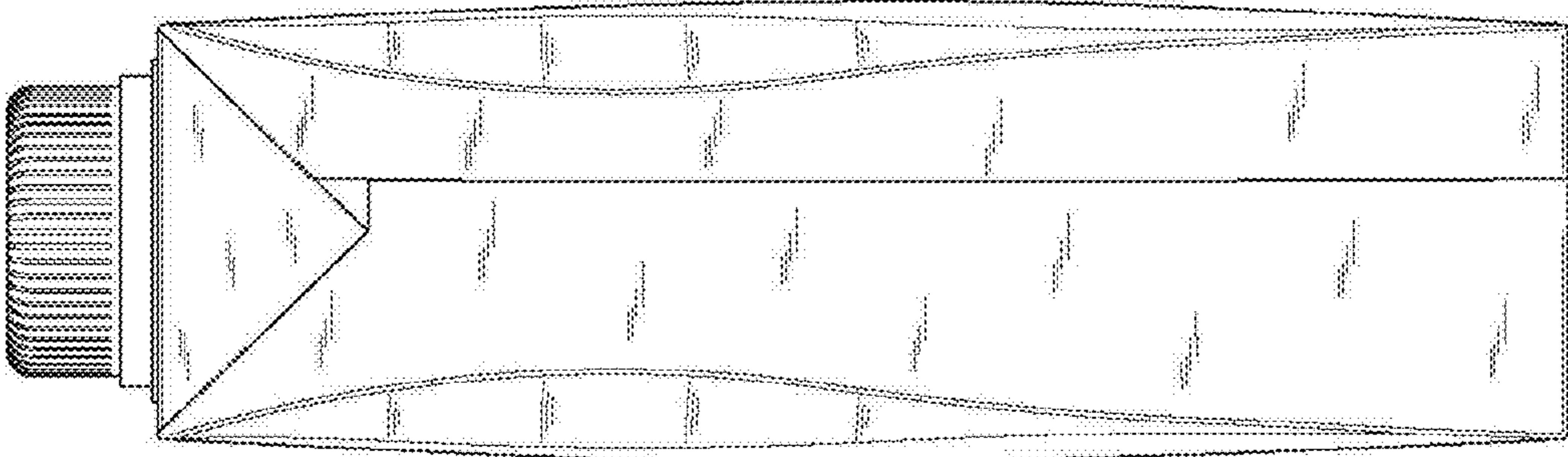

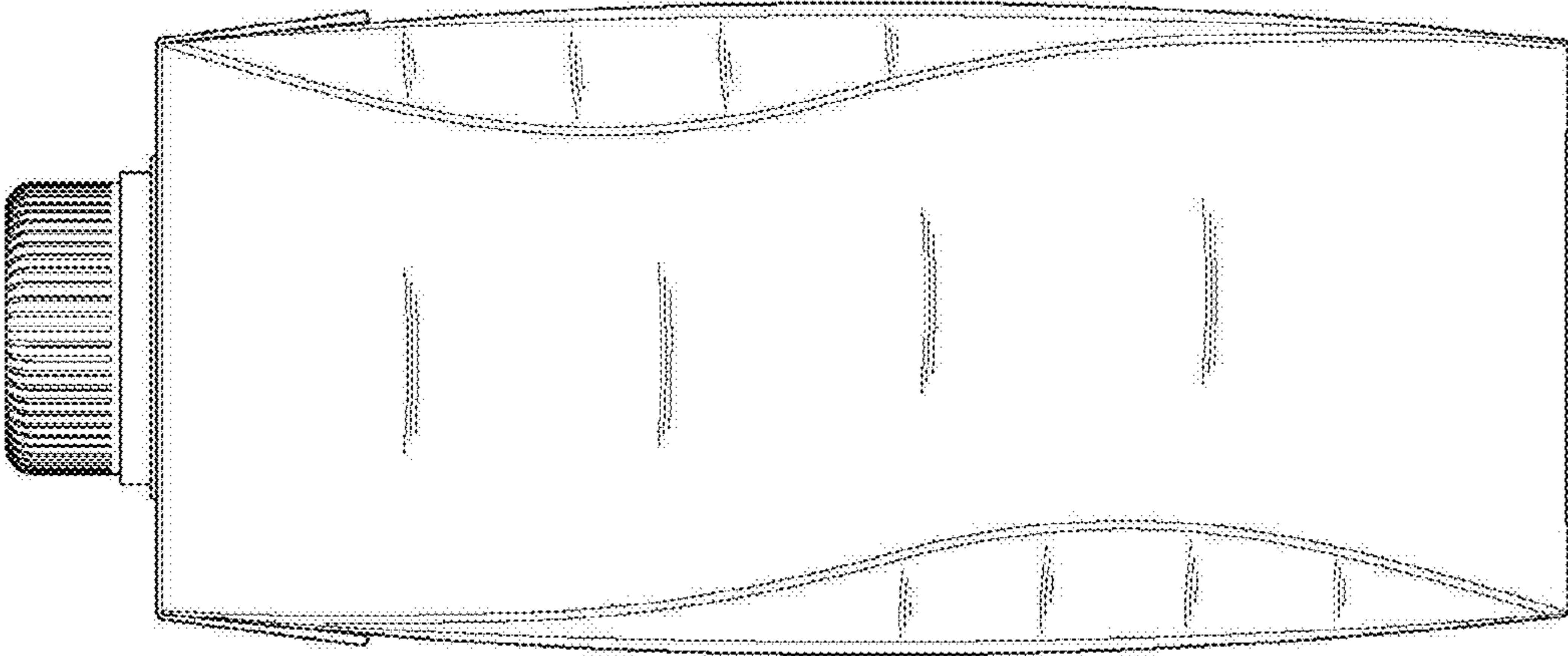

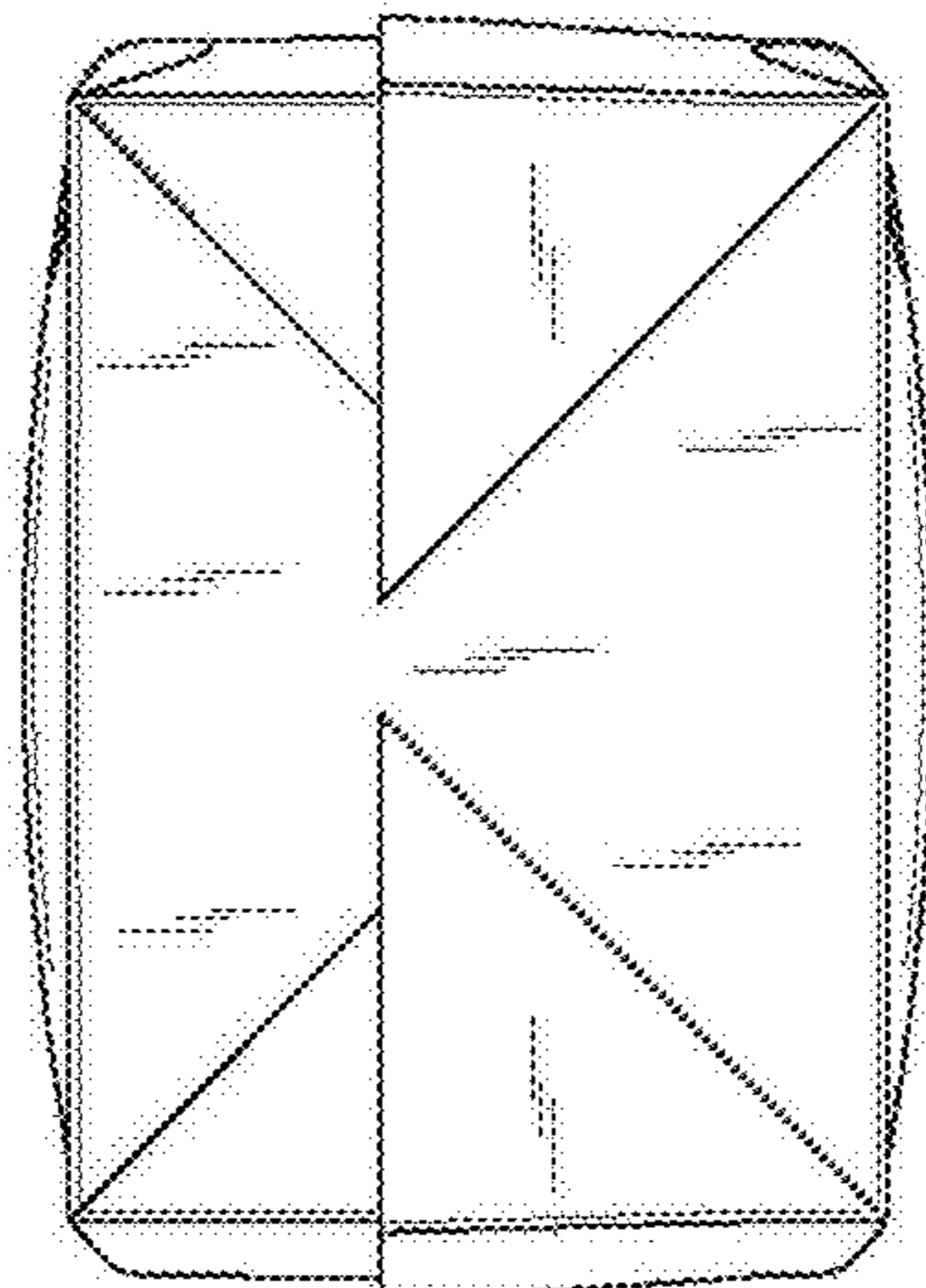
