DESCRIPTION

FIG. 1 is a perspective view of a package showing my new
design;

FIG. 2 is a front view thereof;

FIG. 3 is a rear view thereof;

FIG. 4 is a left side view thereof, the right side view being
identical;

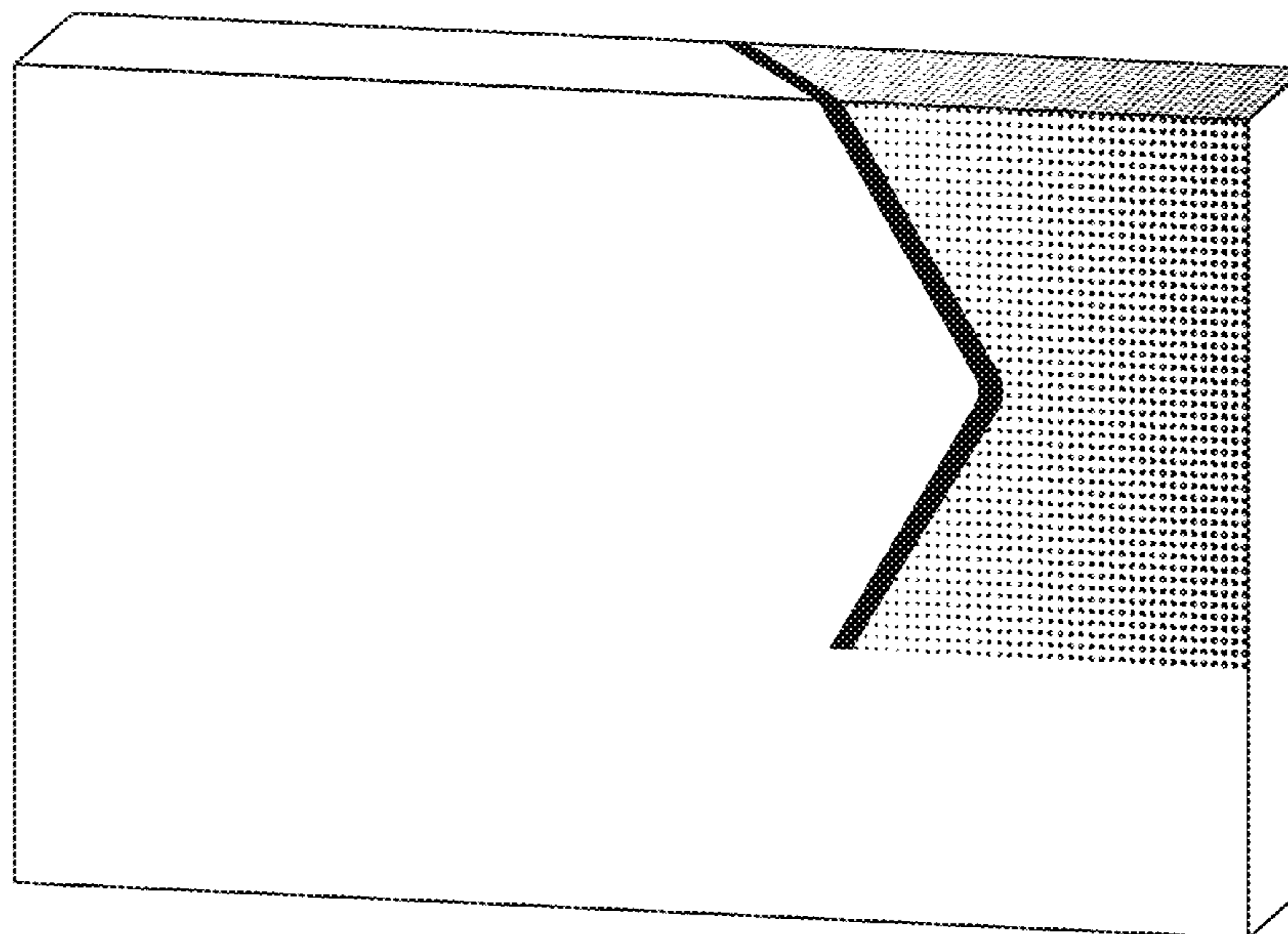
FIG. 5 is a top view thereof; and,

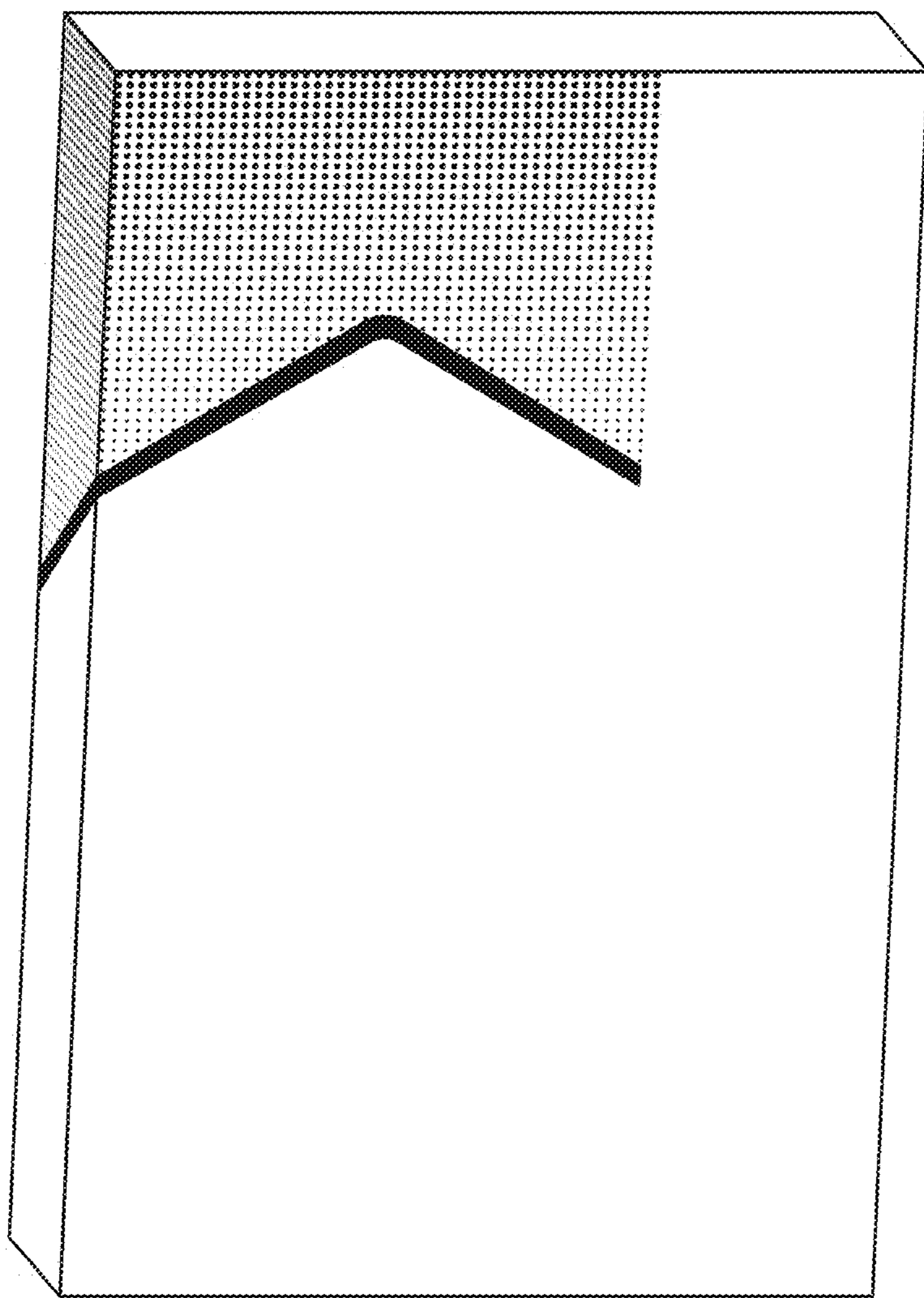

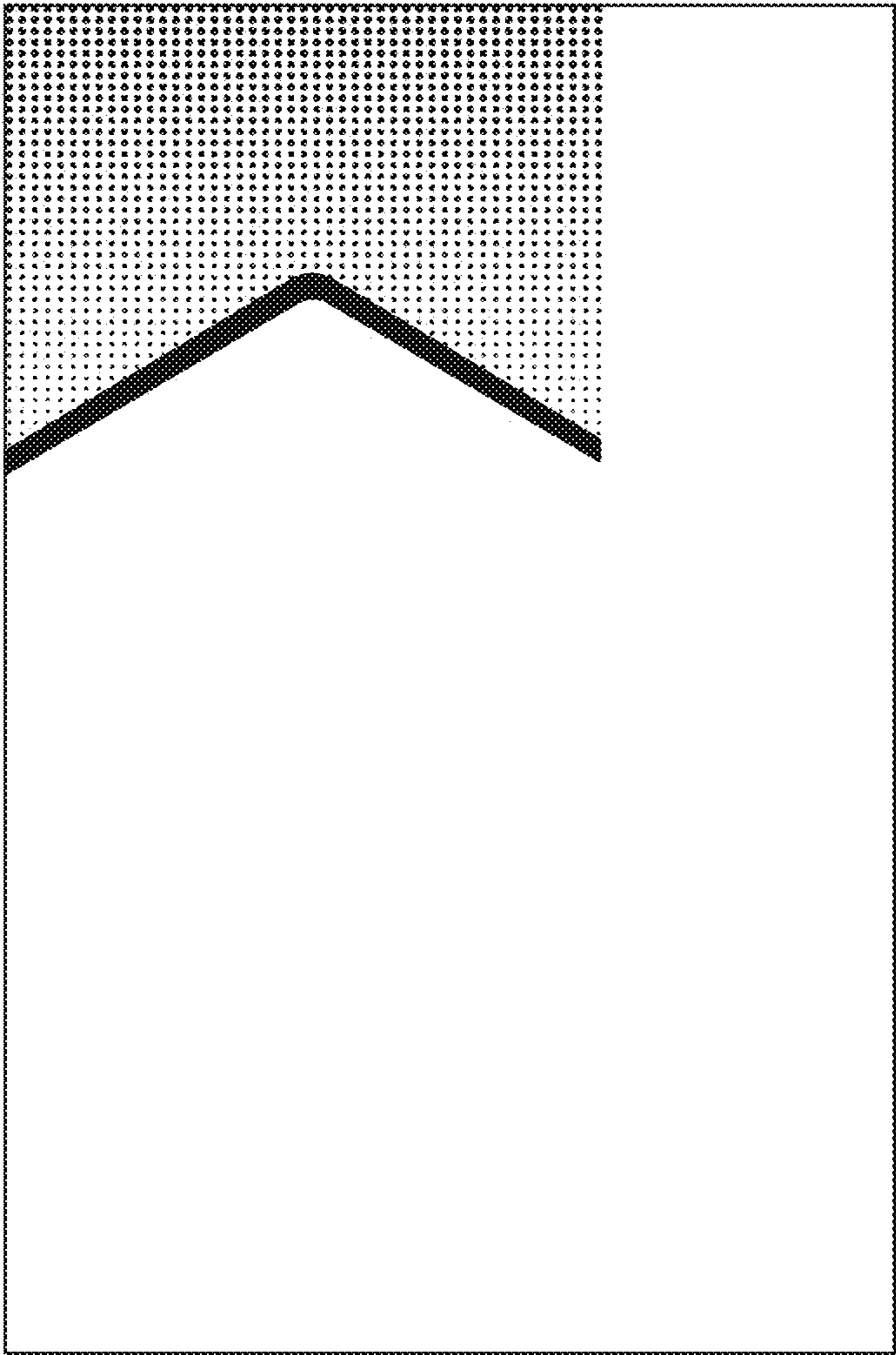

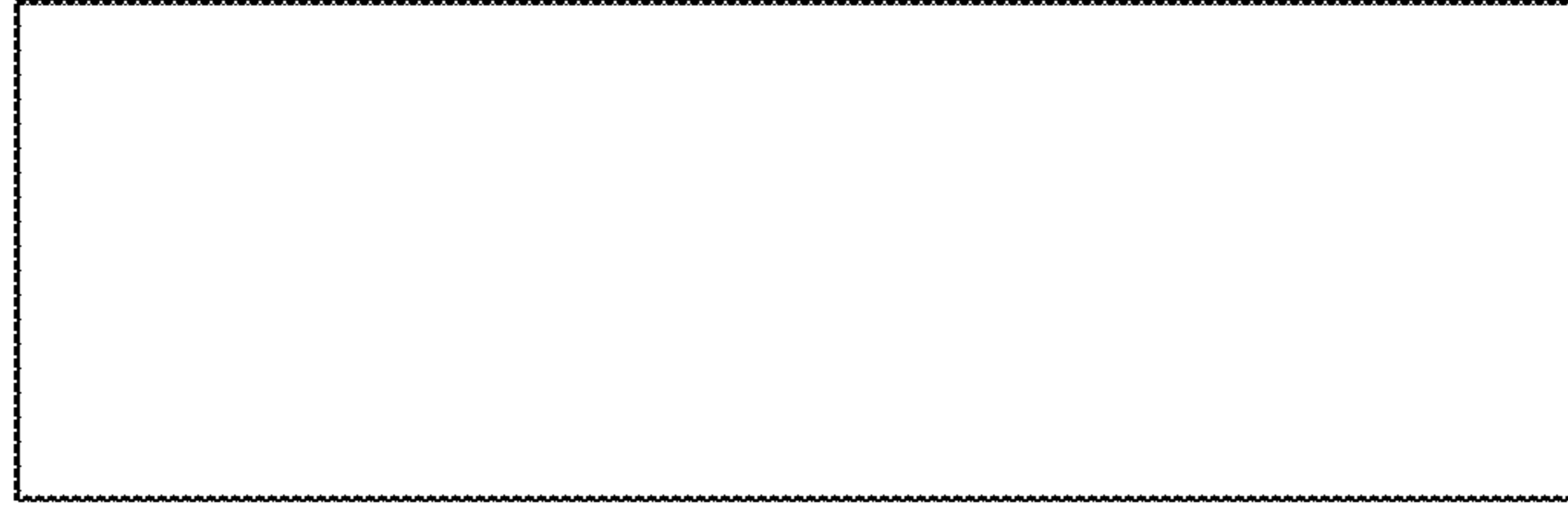

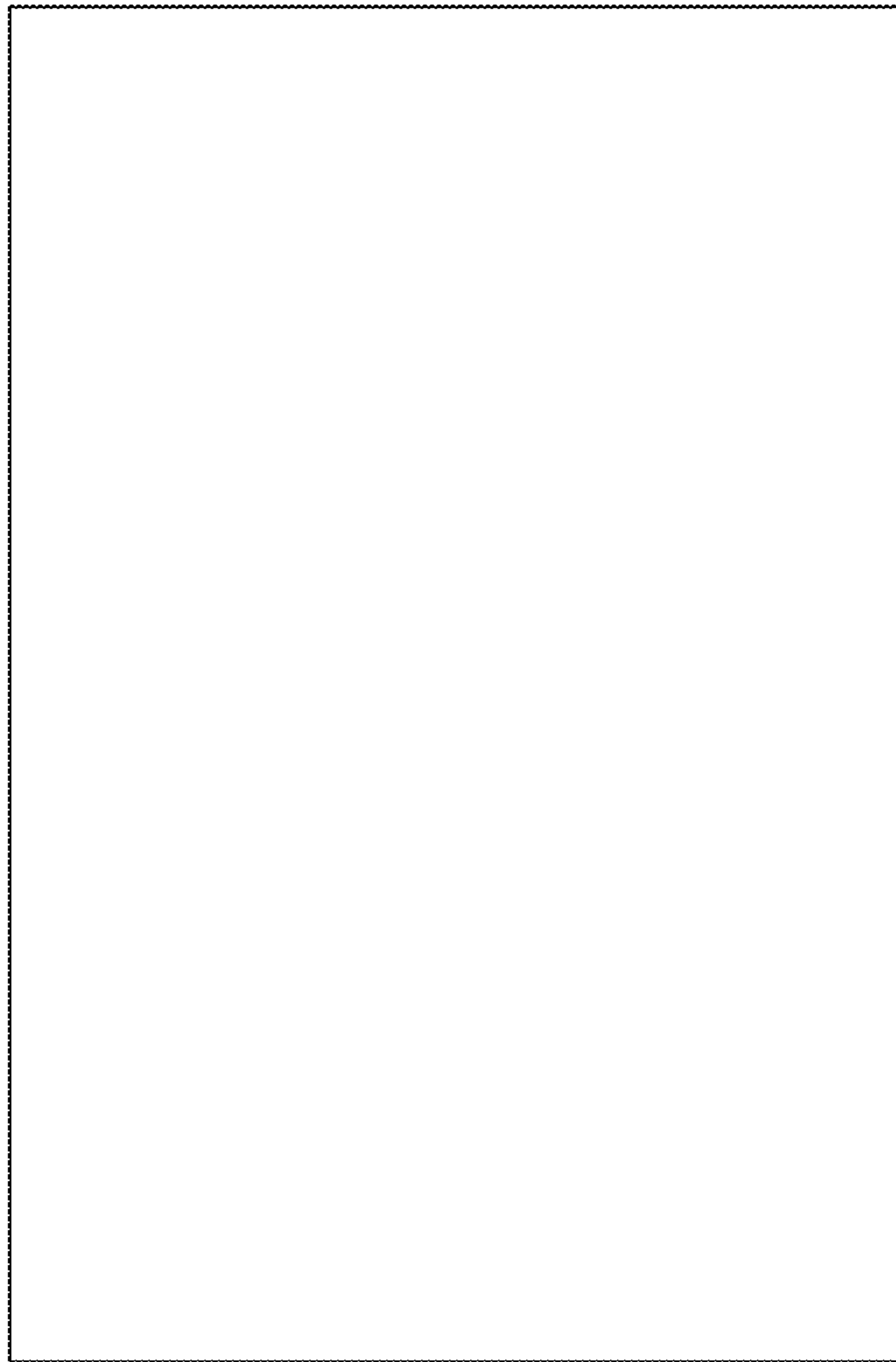

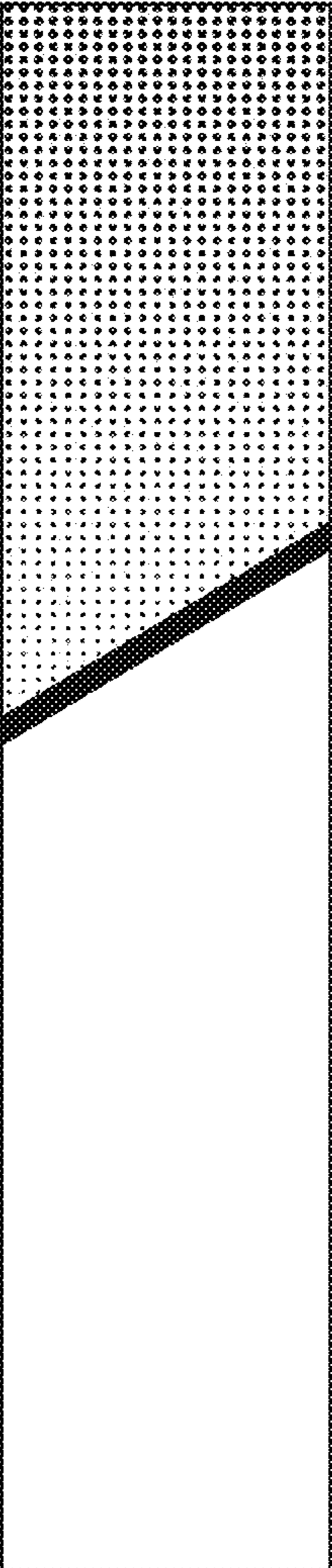

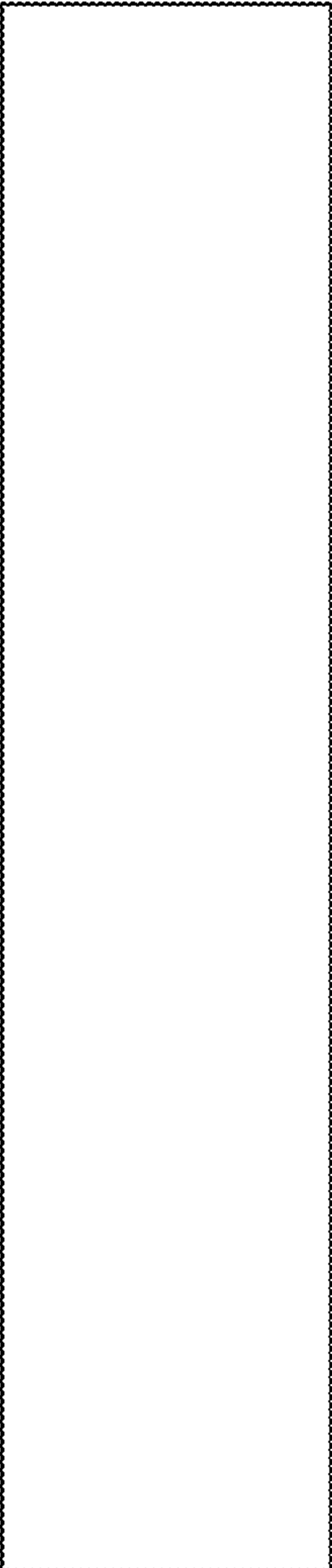
