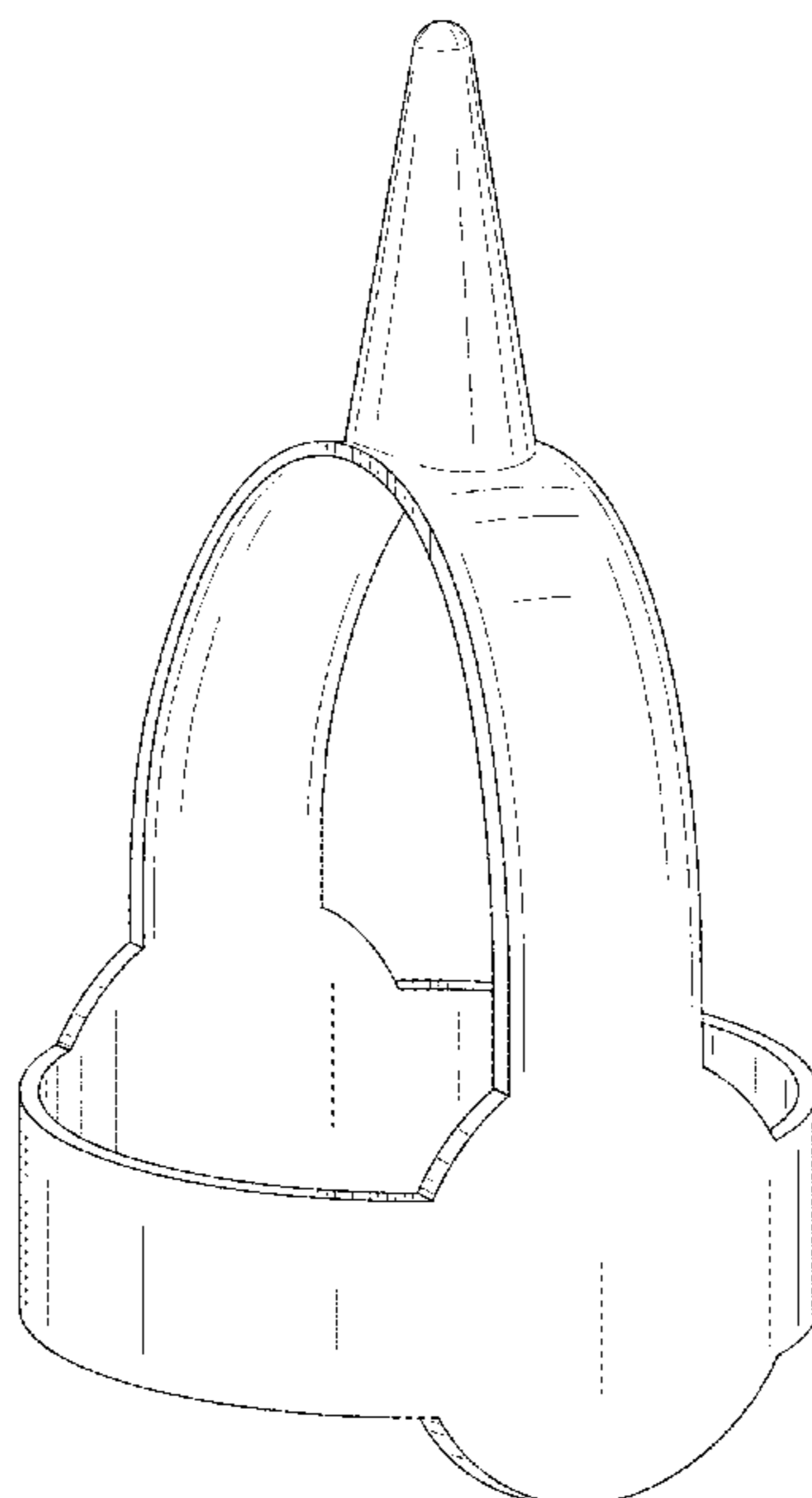
(57) **CLAIM**

The ornamental design for a dispensable tube cap and retention assembly, as shown and described.

DESCRIPTION

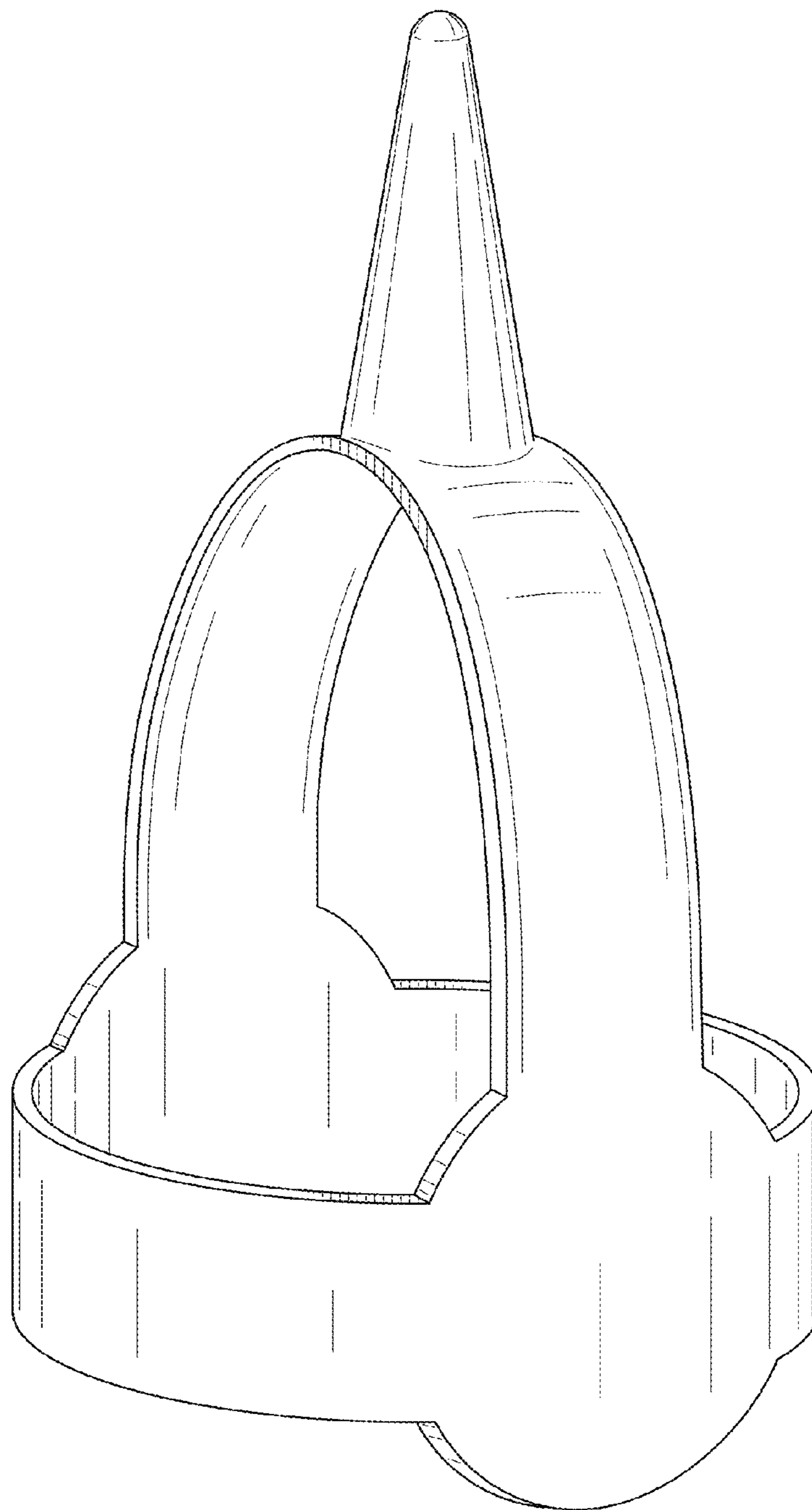

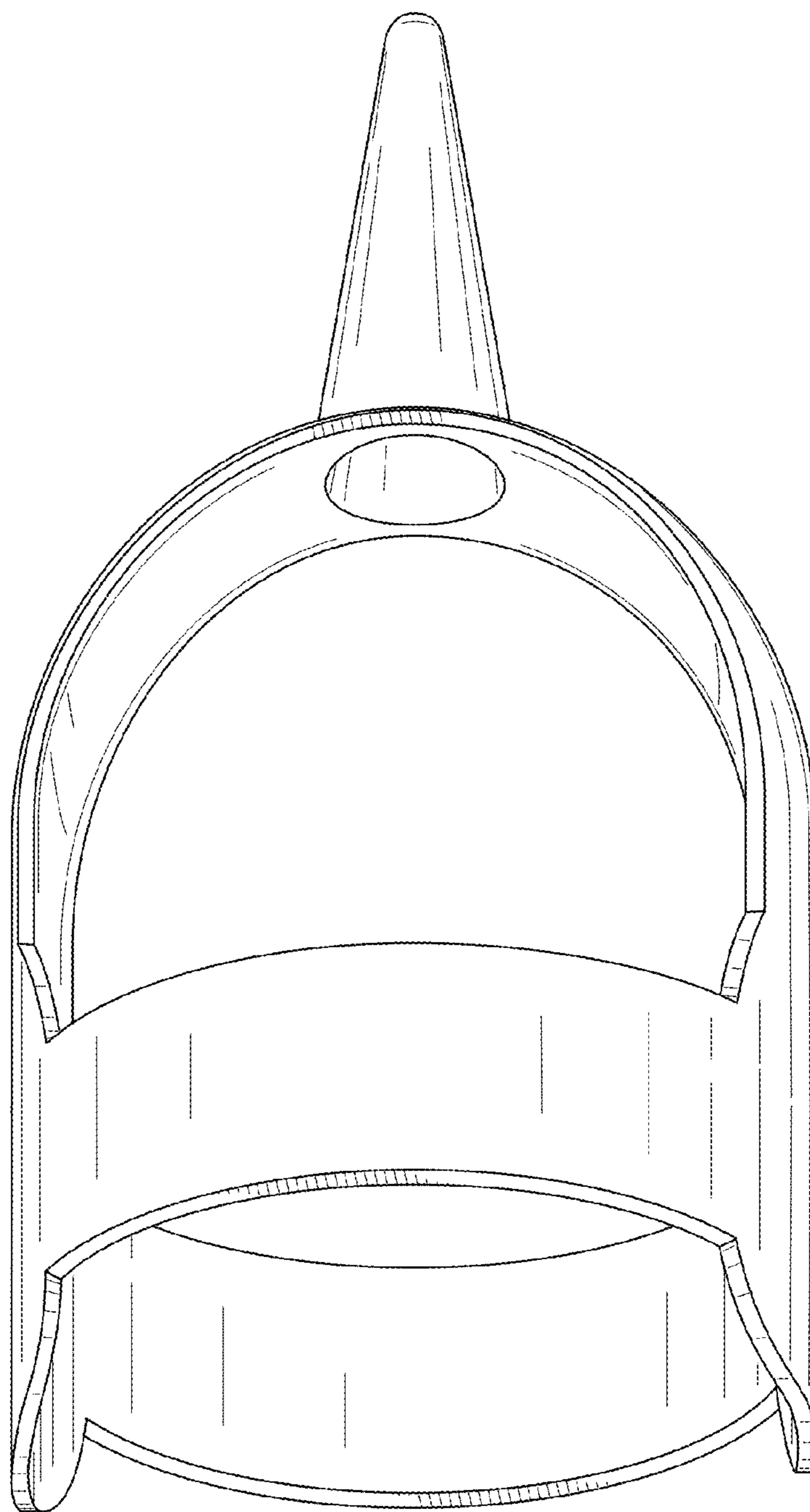

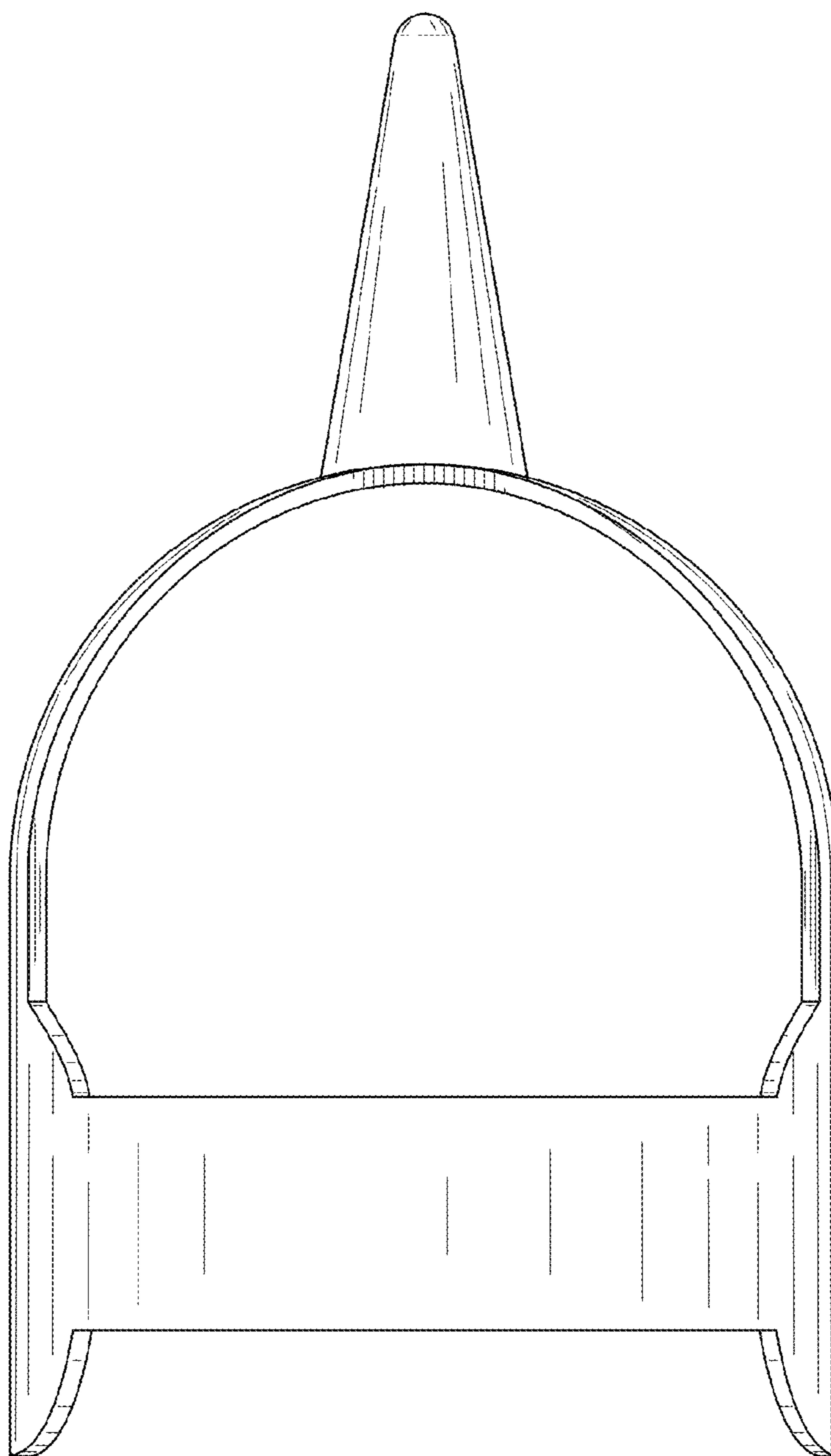

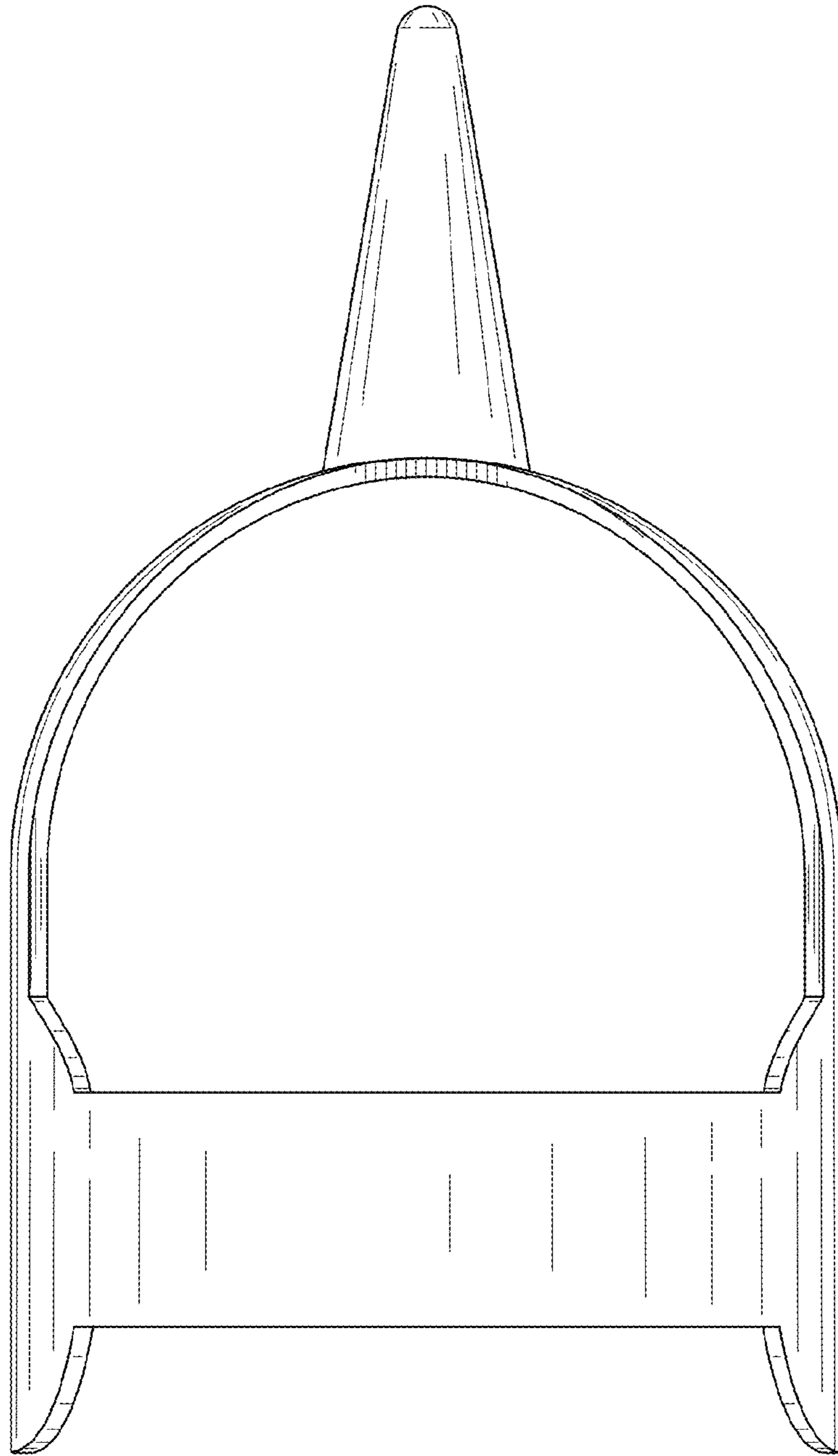

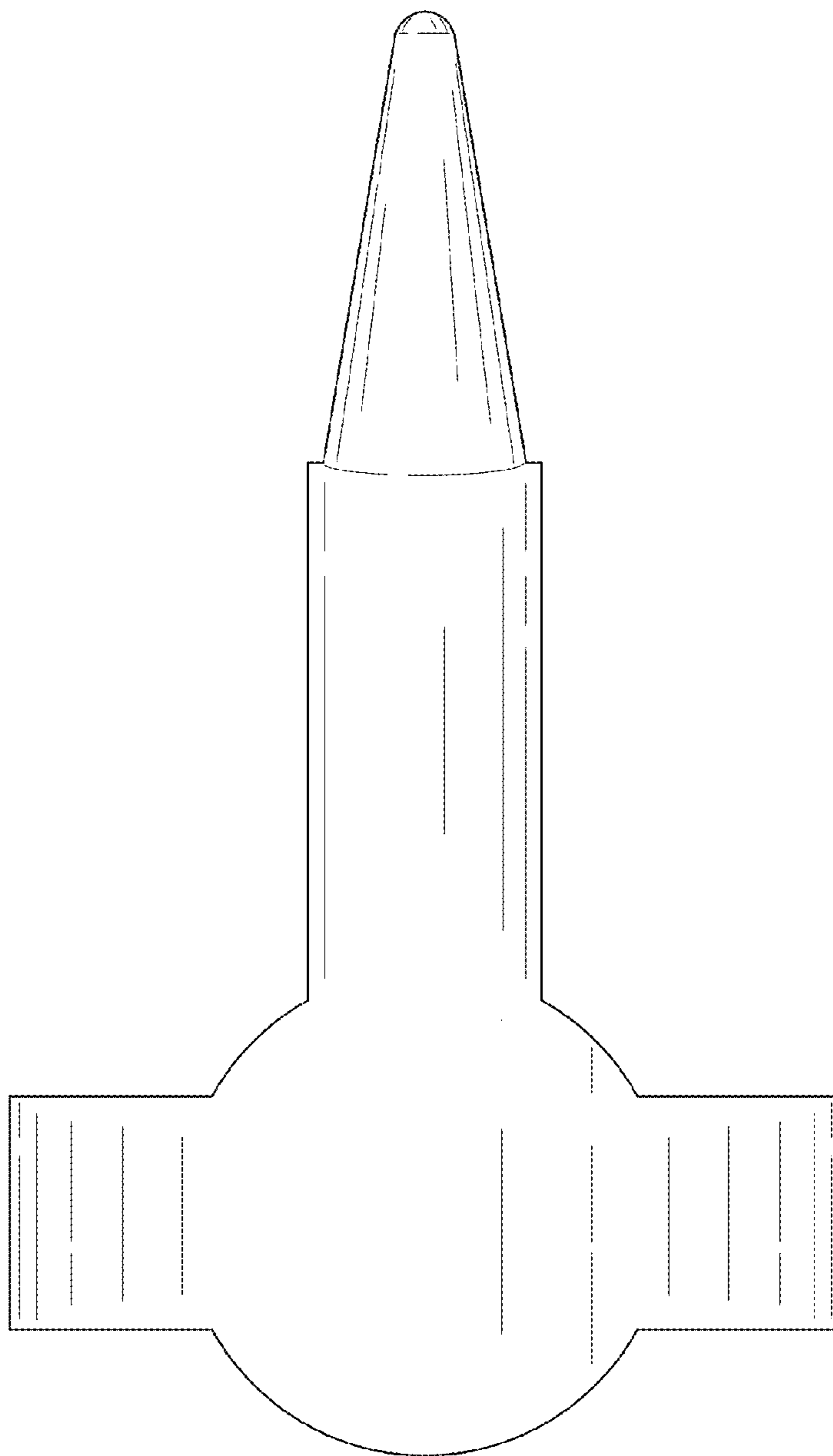

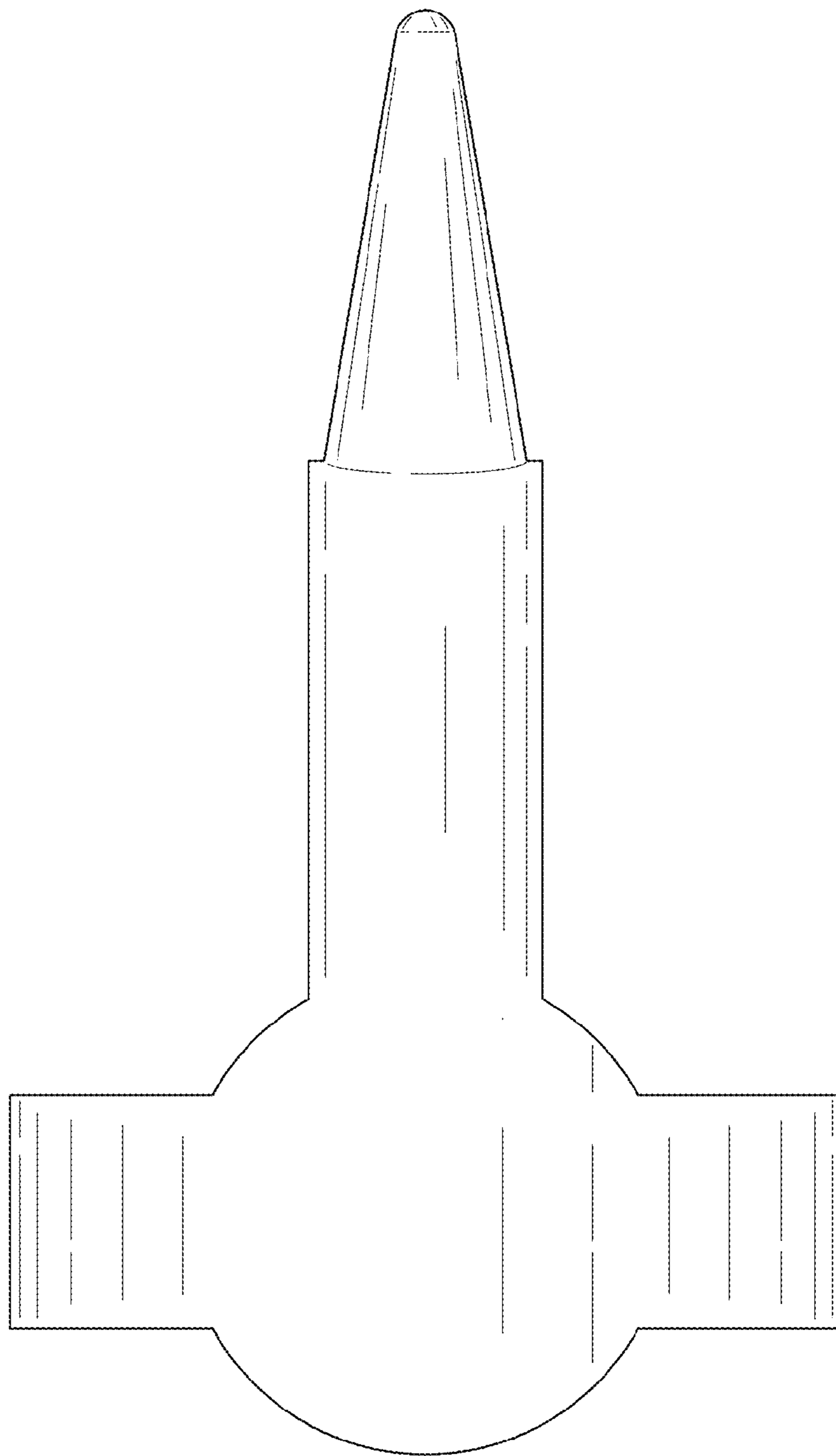

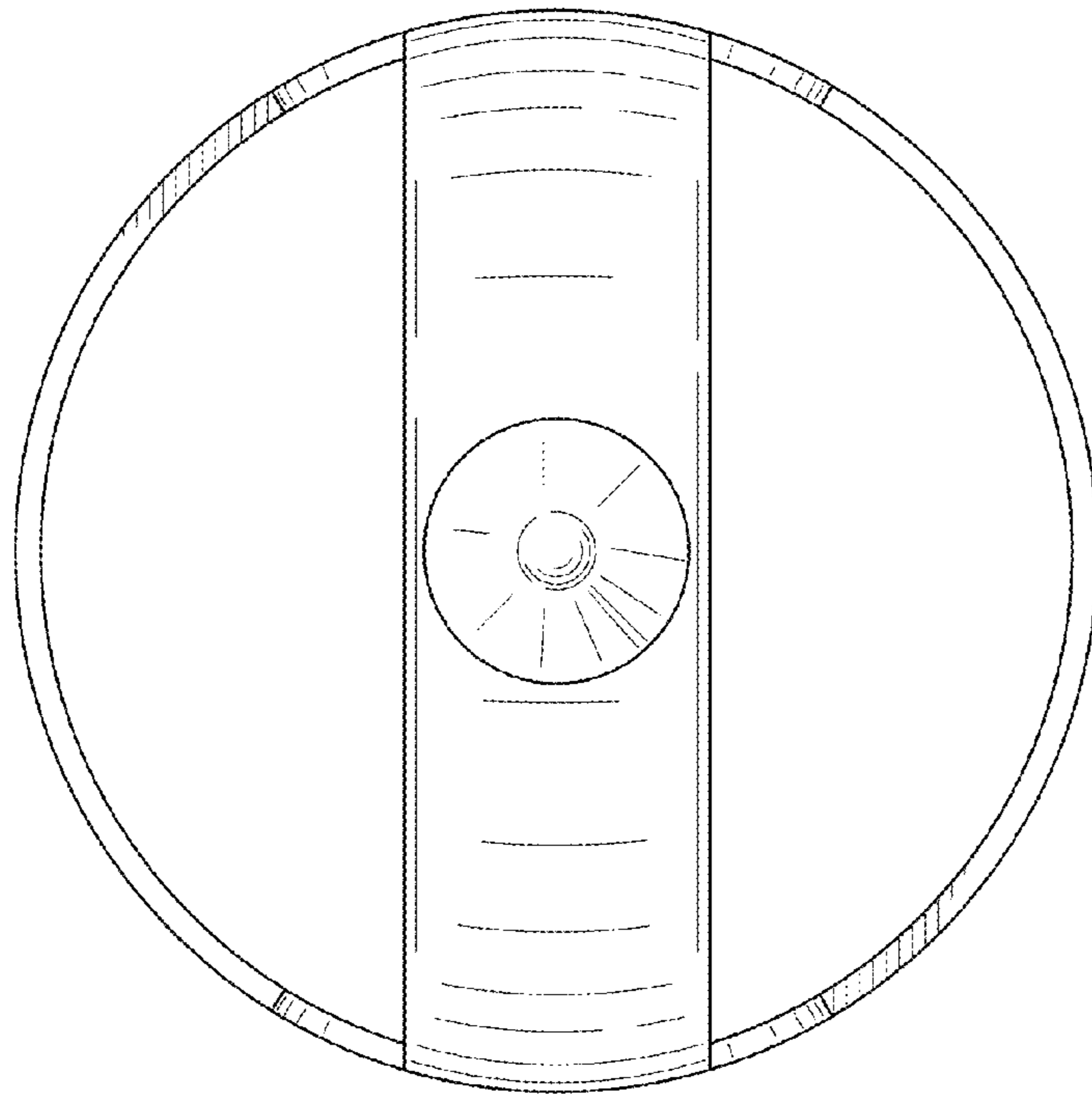

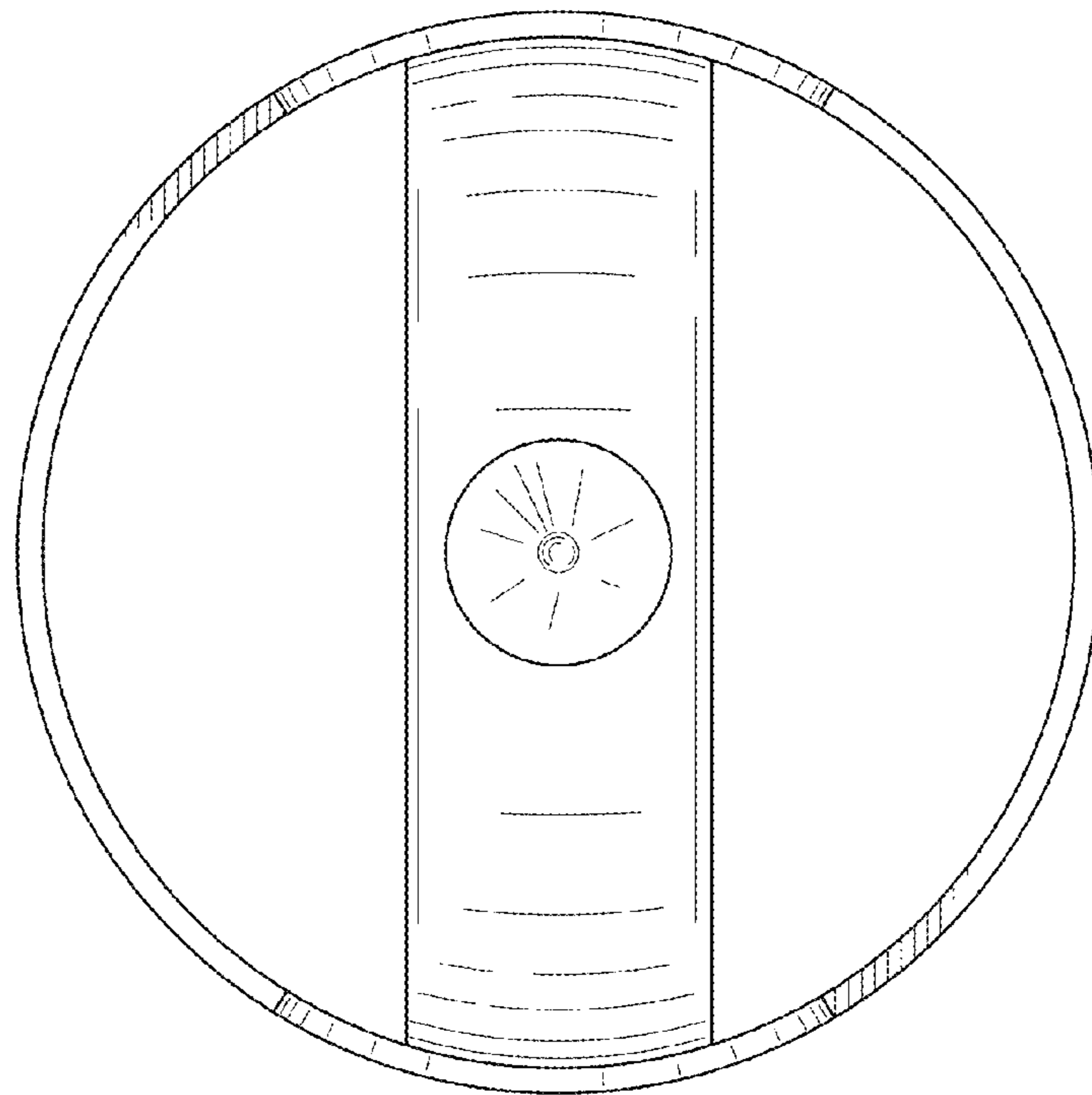
