(57) **CLAIM**

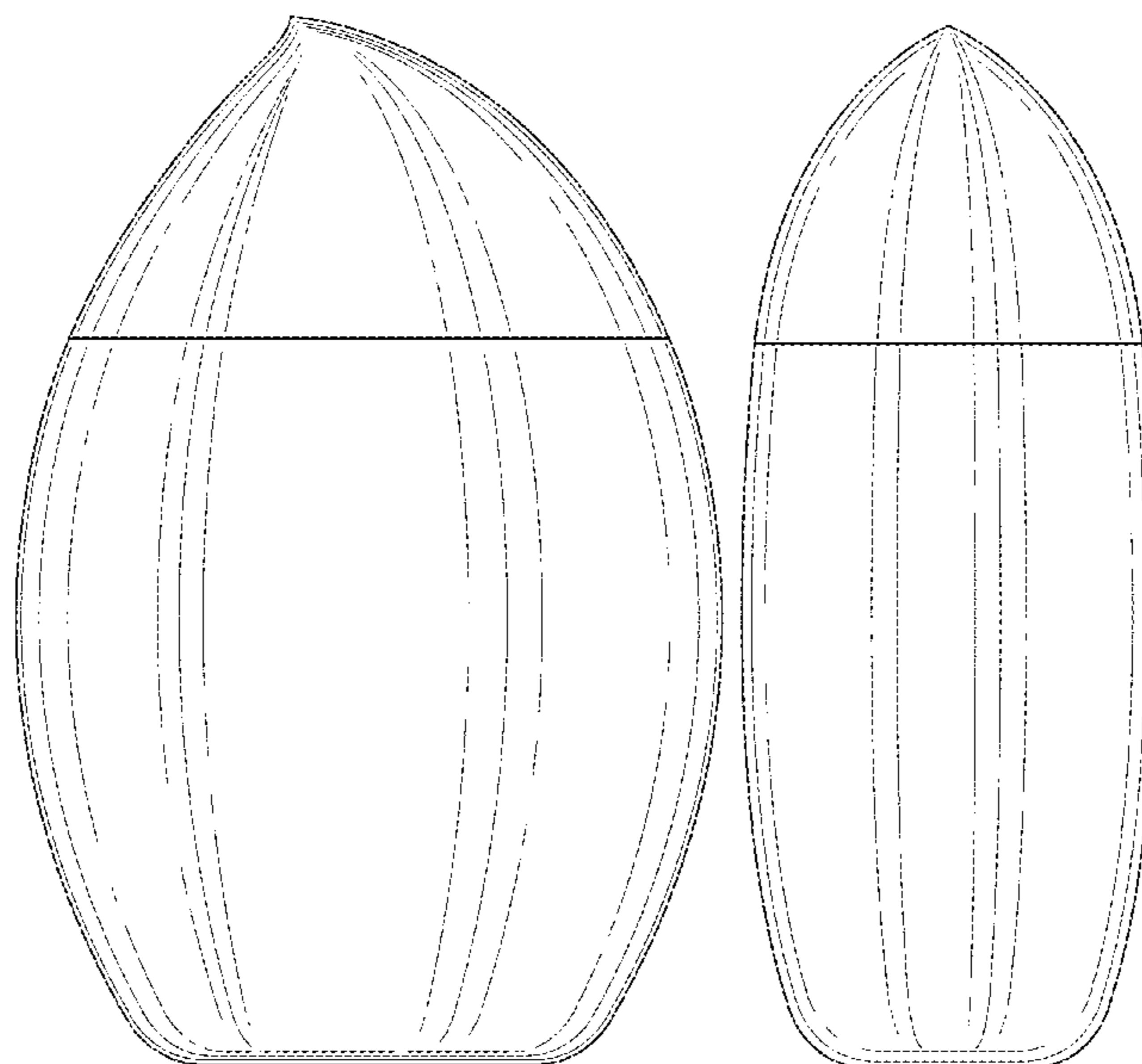
The ornamental design for a bottle, as shown and described.

DESCRIPTION

FIG. 1 is a left, front, top elevation view of the bottle;
FIG. 2 is a rear elevation view of the bottle;
FIG. 3 is a front side elevation of the bottle;
FIG. 4 is a left side elevation view of the bottle;
FIG. 5 is a right side view of the bottle;
FIG. 6 is a top plan view of the bottle;
FIG. 7 is a top plan view of the bottle; and,
FIG. 8 is a left, front, top elevation view of the bottle with lid decoupled from the base.

The broken lines and the unshaded areas within them represent portions of the bottle that form no part of the claimed design.

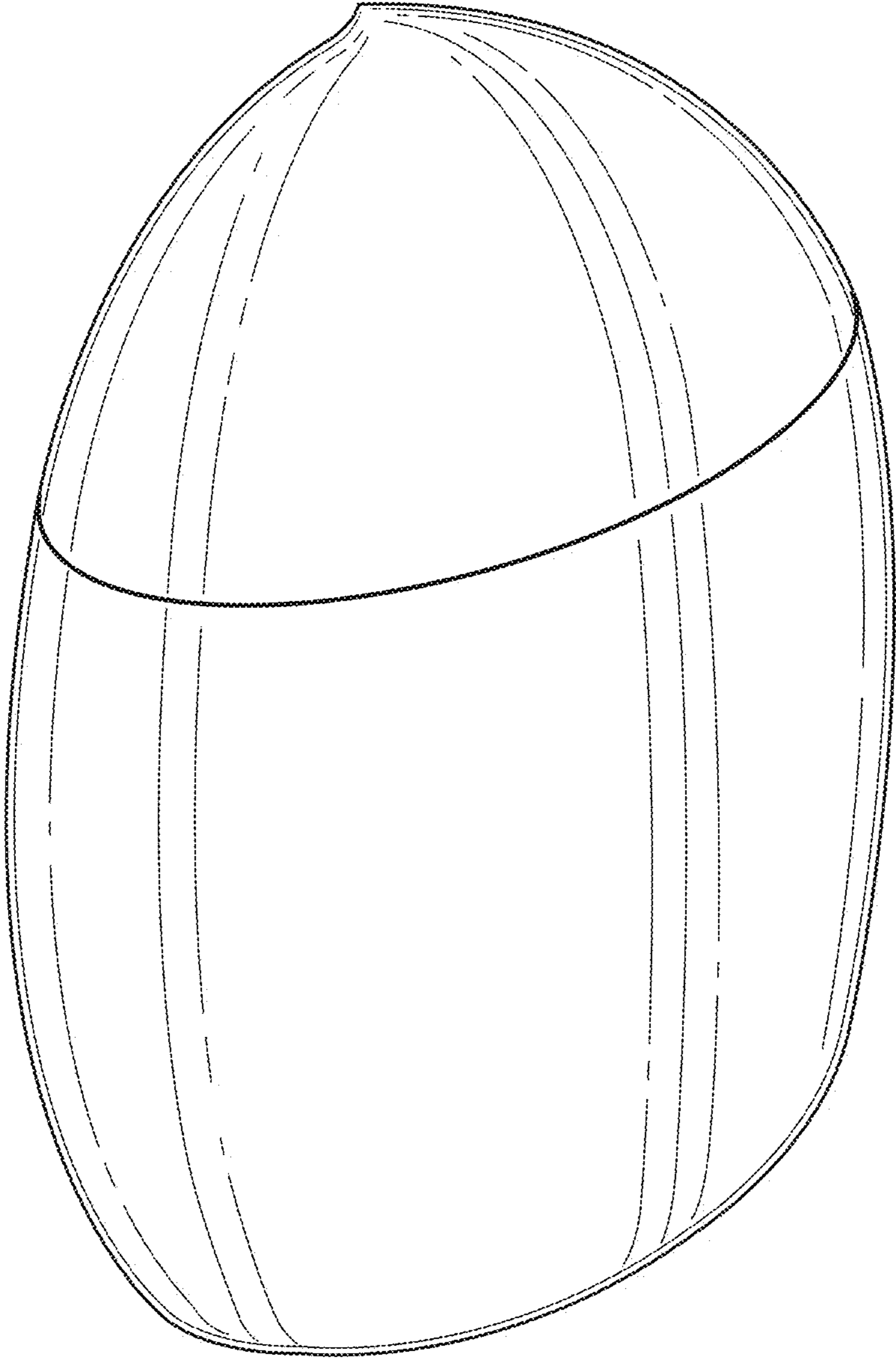

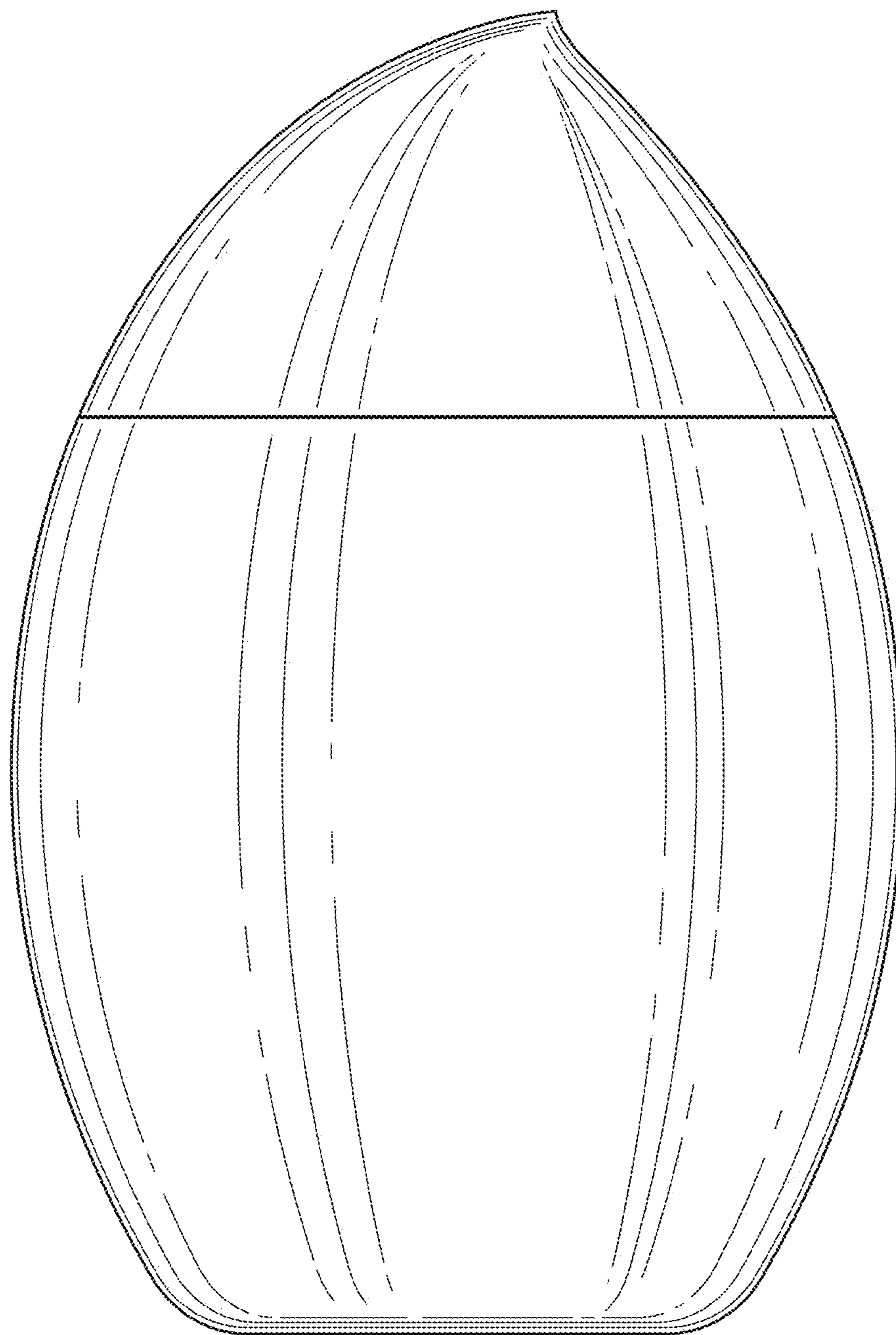

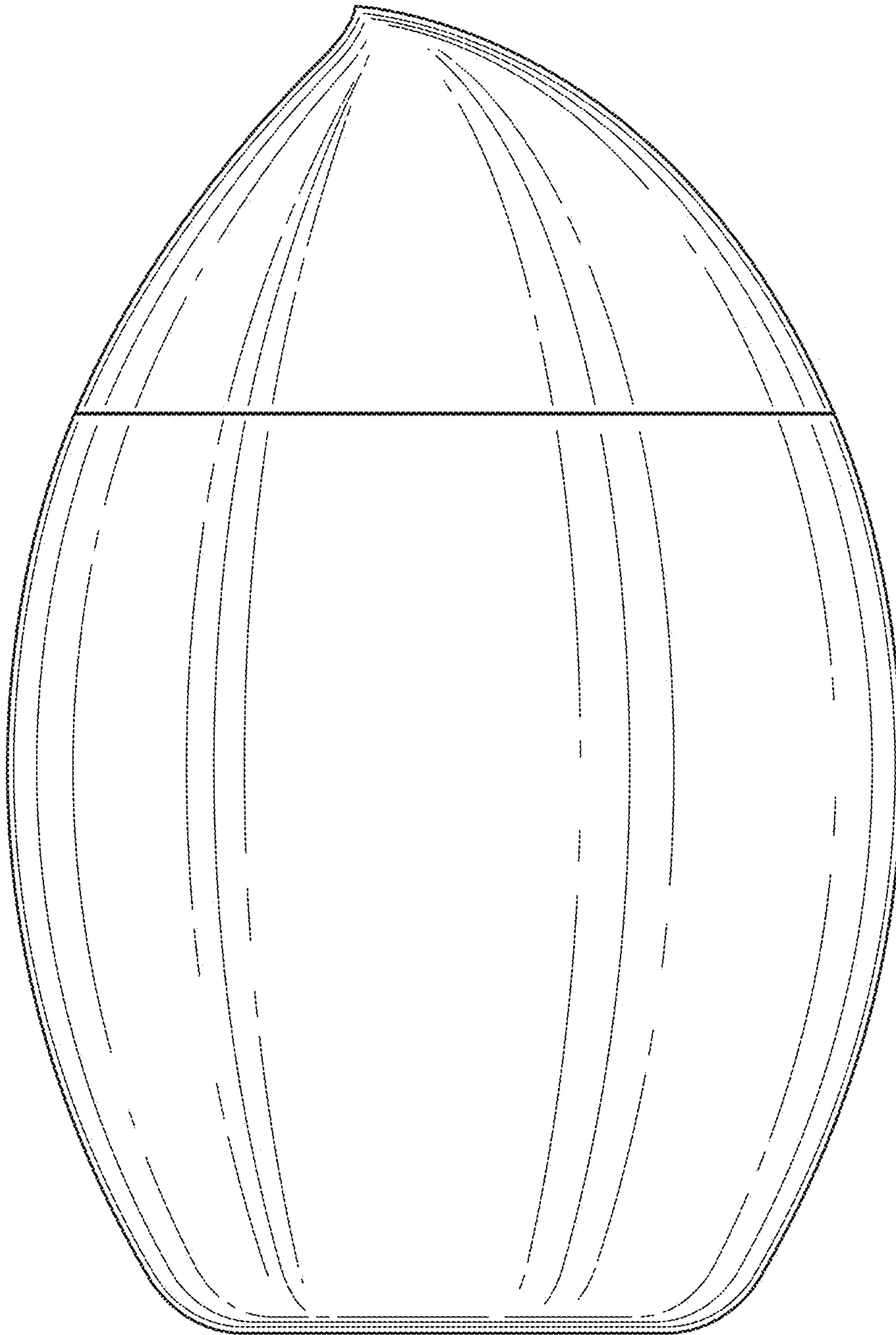

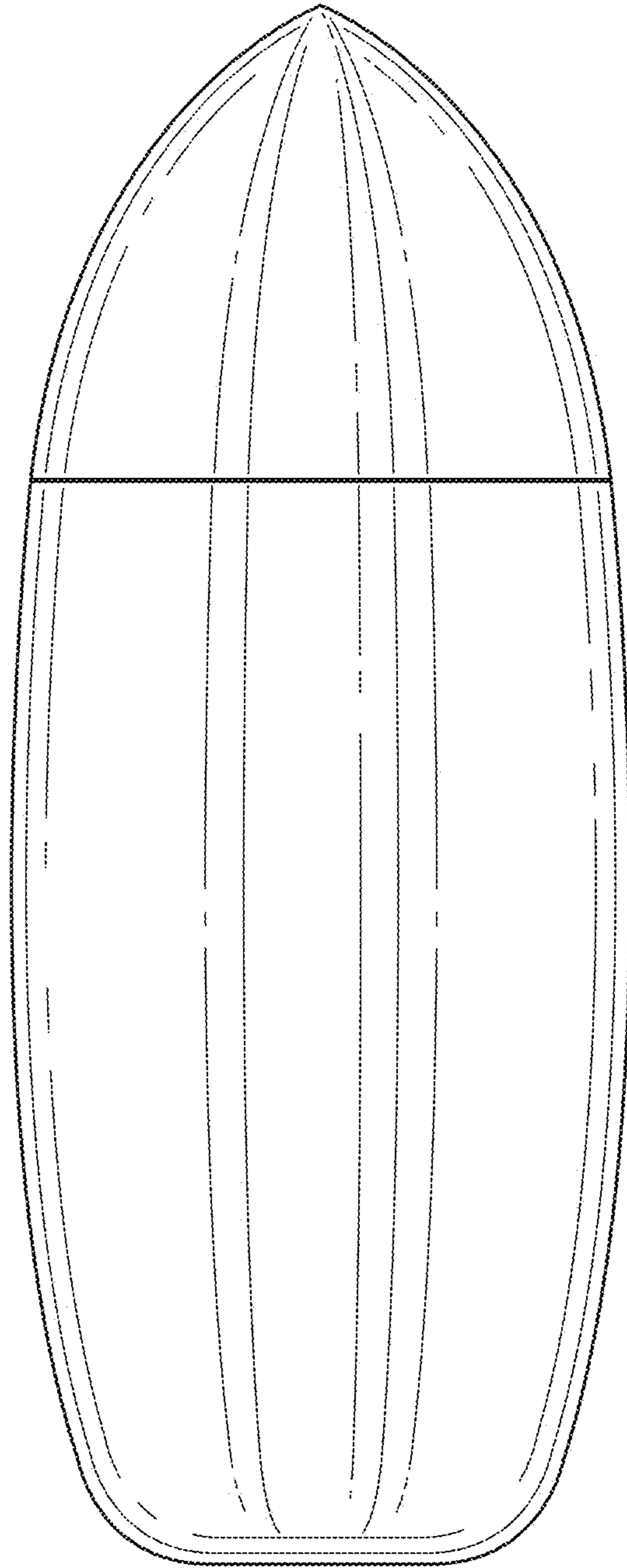

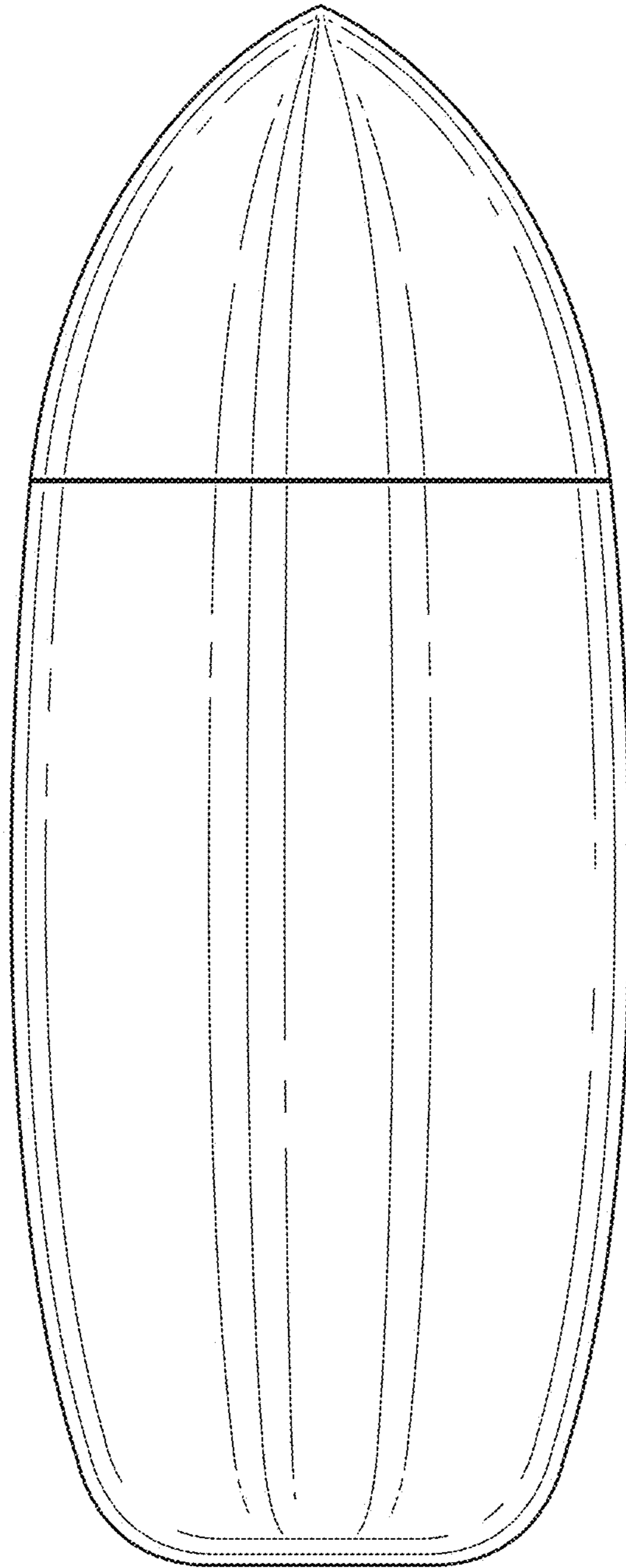

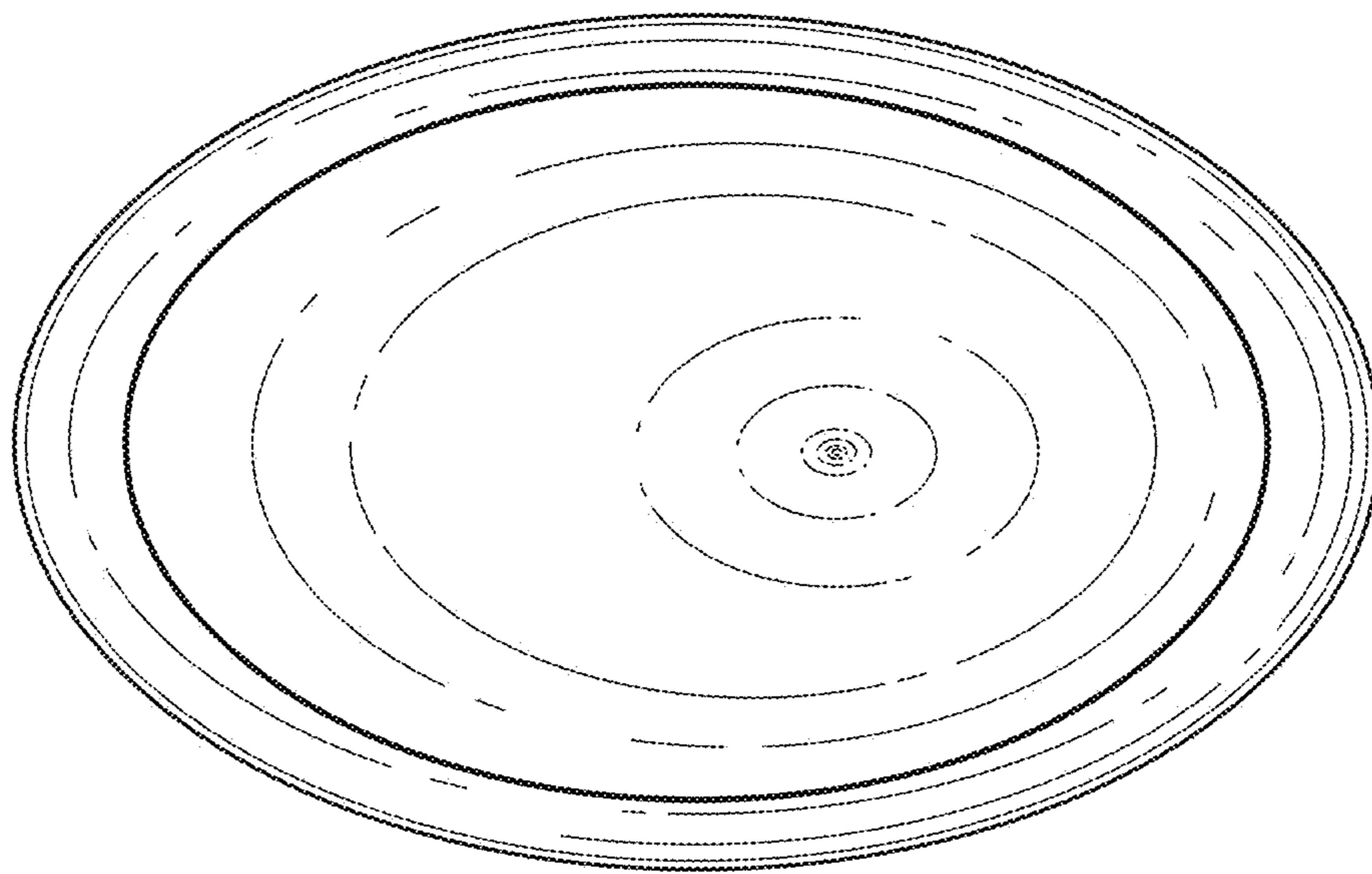

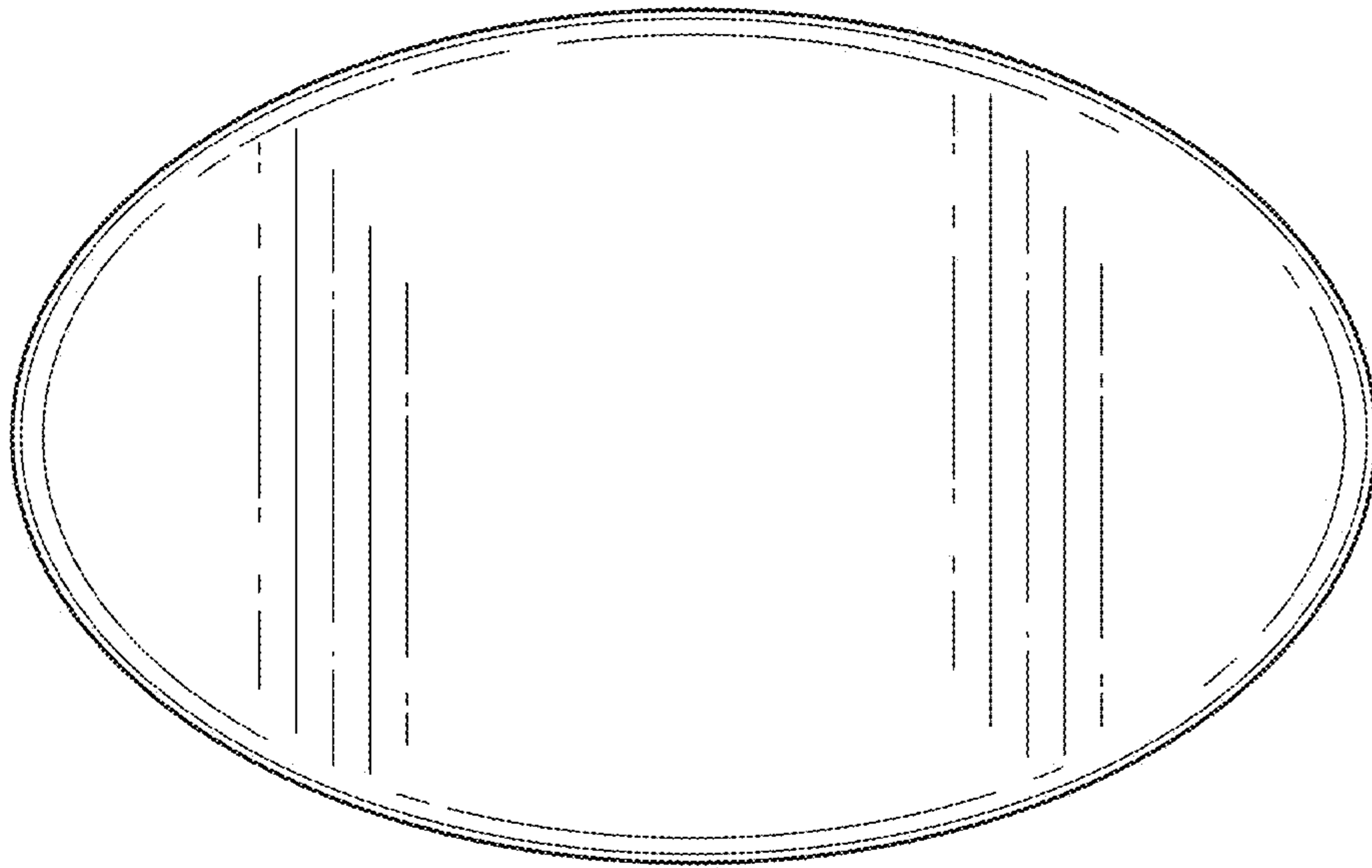

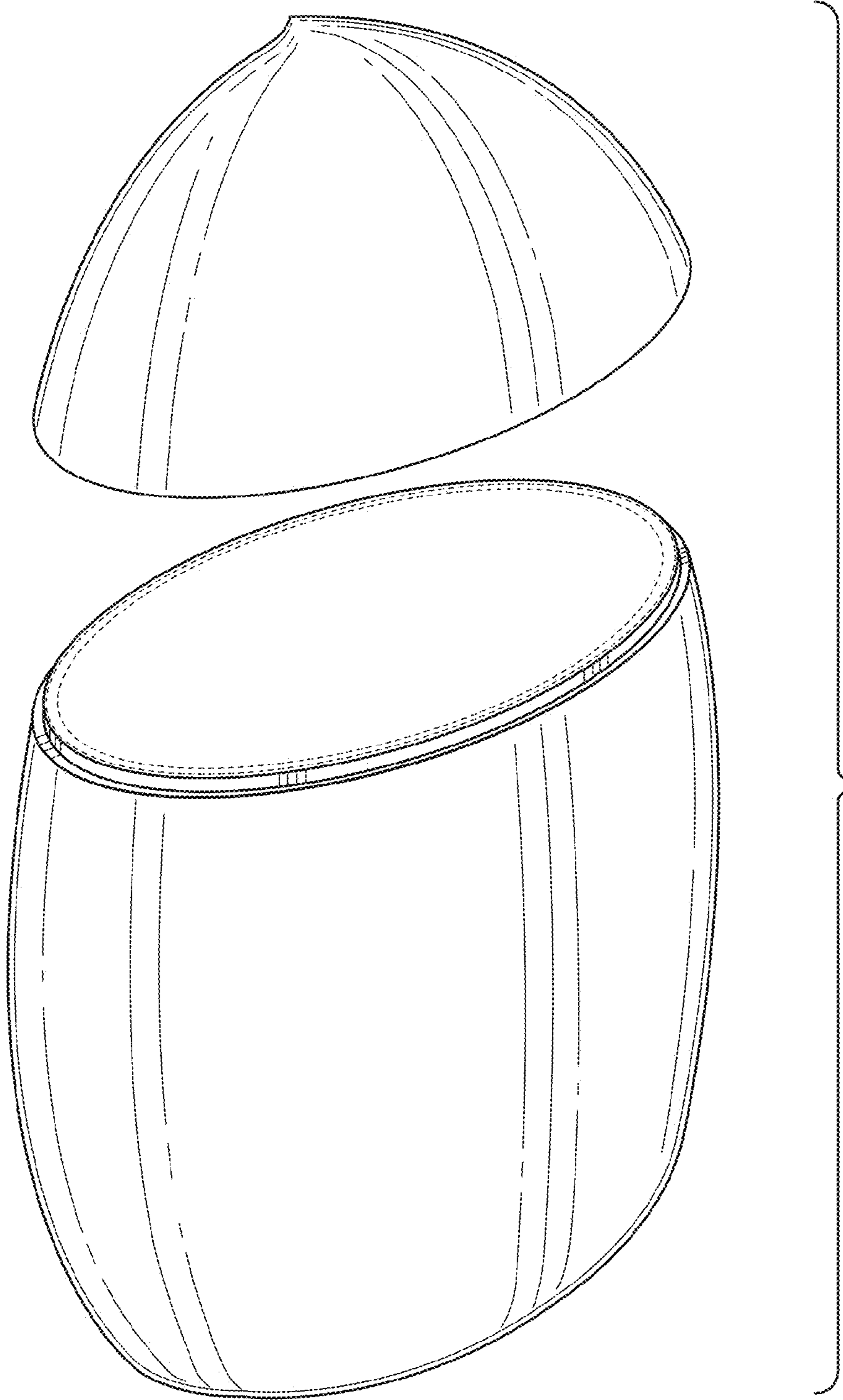
