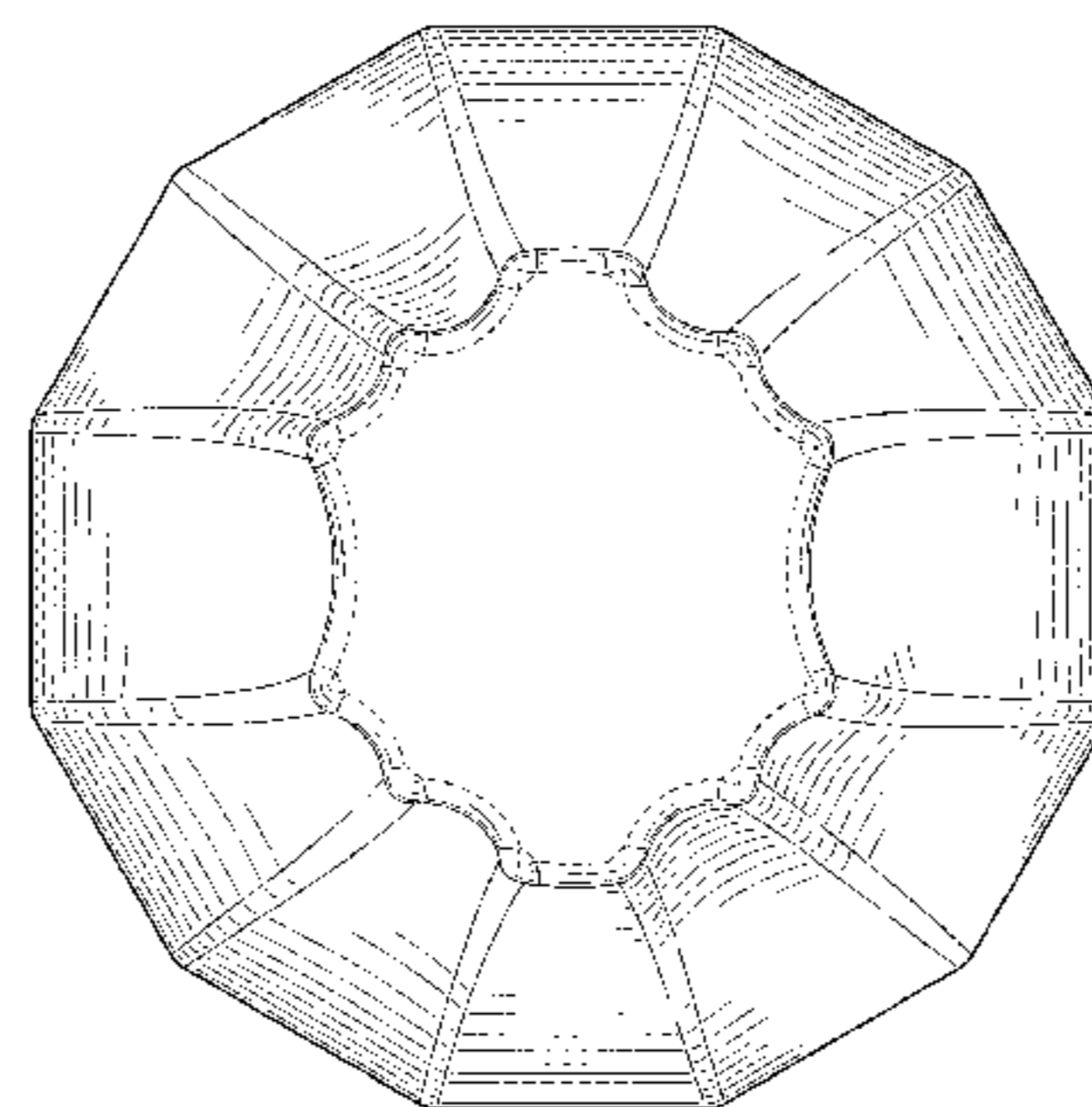
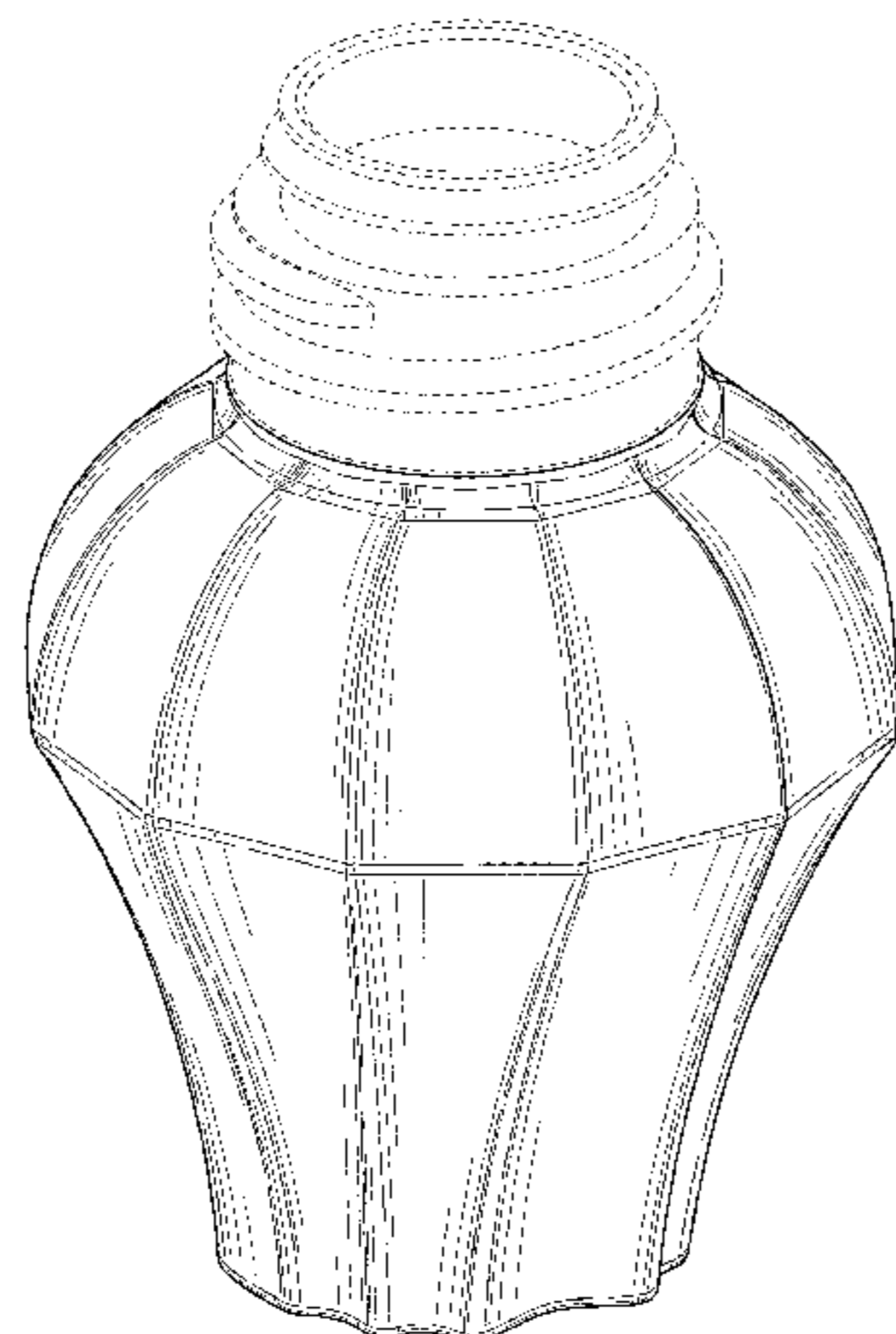
(57) **CLAIM**

The ornamental design for a bottle, as shown and described.

DESCRIPTION

FIG. 1 is a top, front, left side perspective view of a bottle;
FIG. 2 is a front elevational view thereof, the rear elevational view being identical except for the unclaimed threads;
FIG. 3 is a left side elevational view thereof, the right side, elevational view being identical except for the unclaimed threads;
FIG. 4 is a top plan view thereof; and,
FIG. 5 is a bottom plan view thereof.
The broken lines shown in the drawings are included for the purpose of illustrating portions of the bottle that form no part of the claimed design.

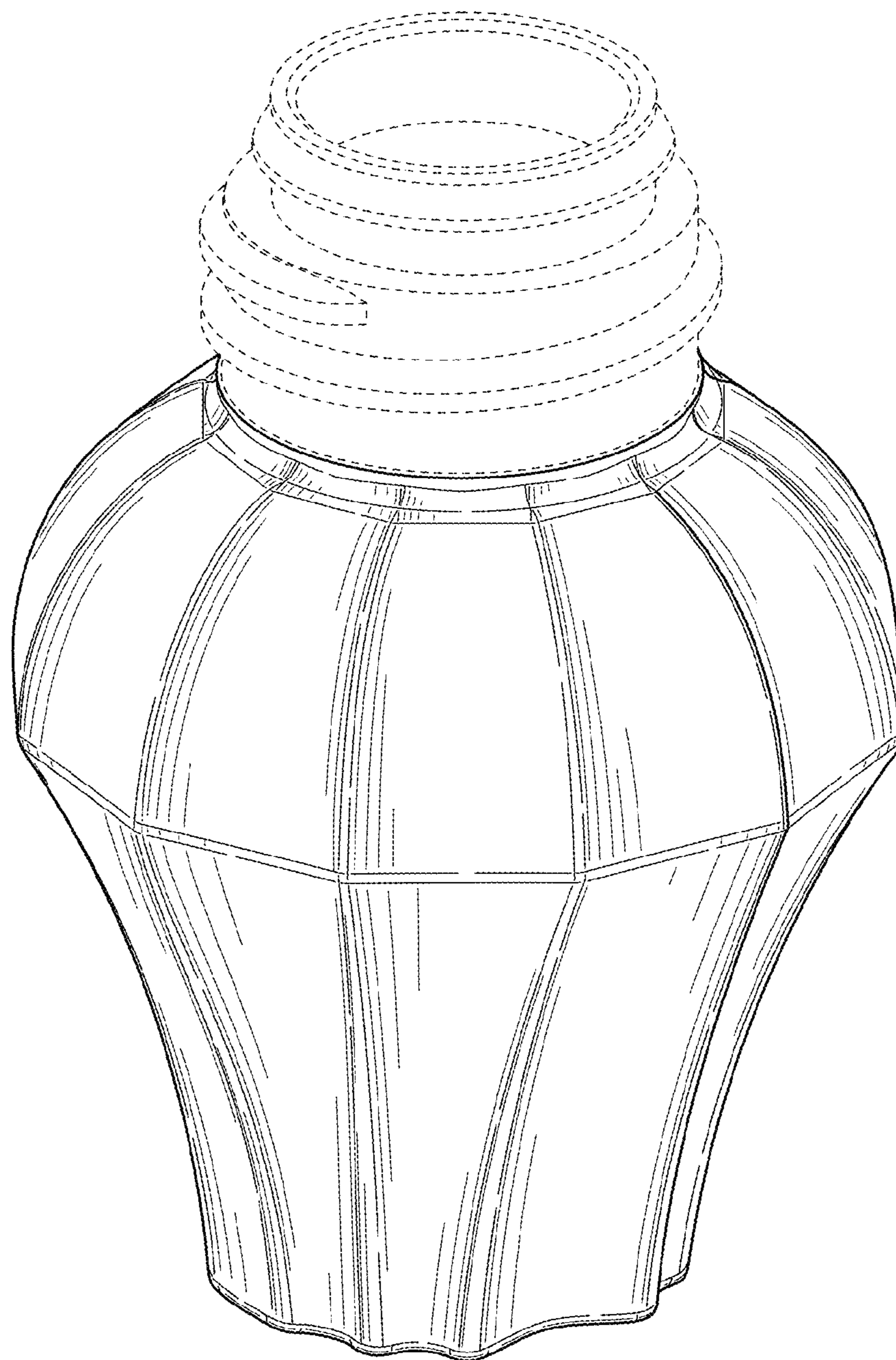

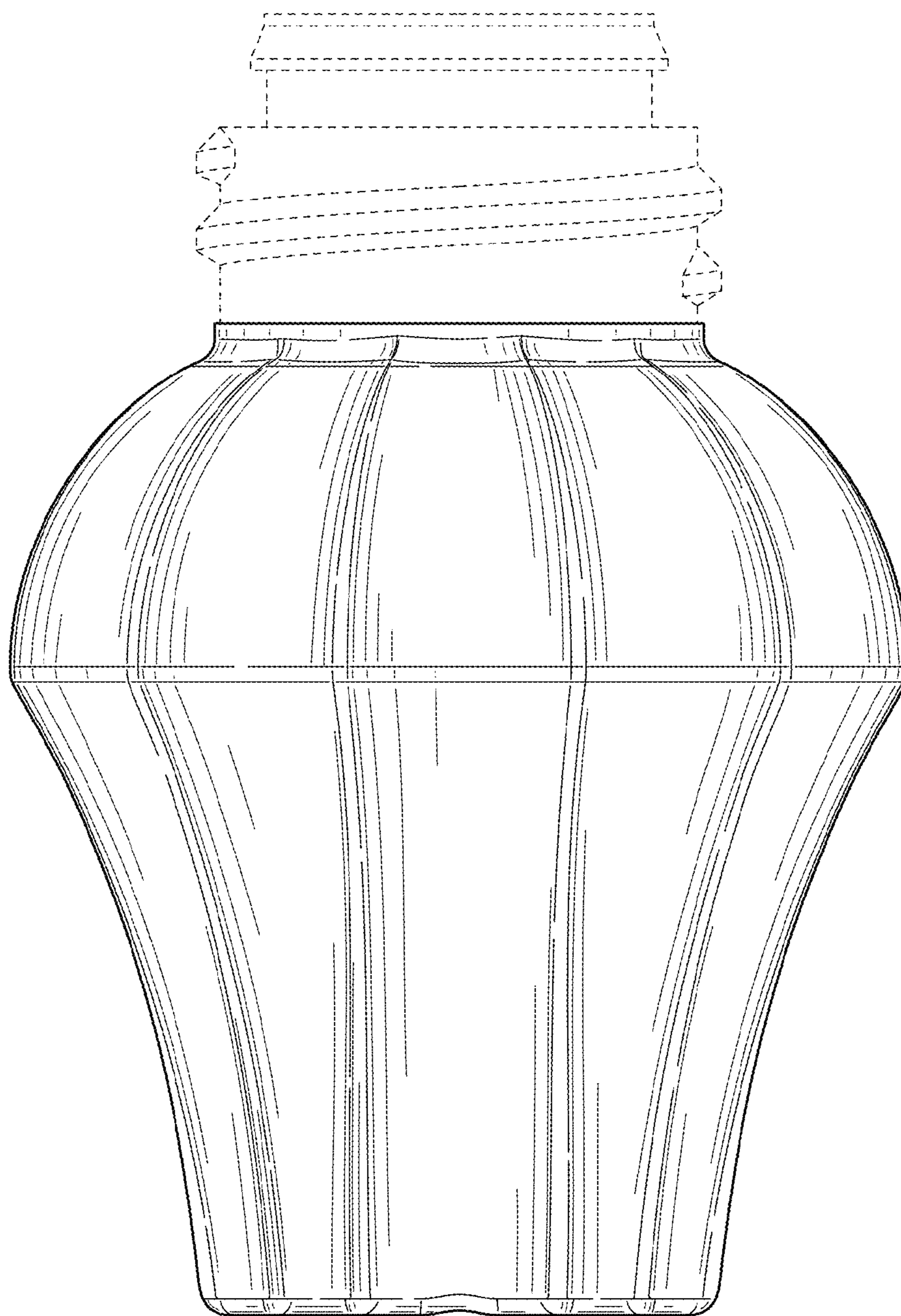

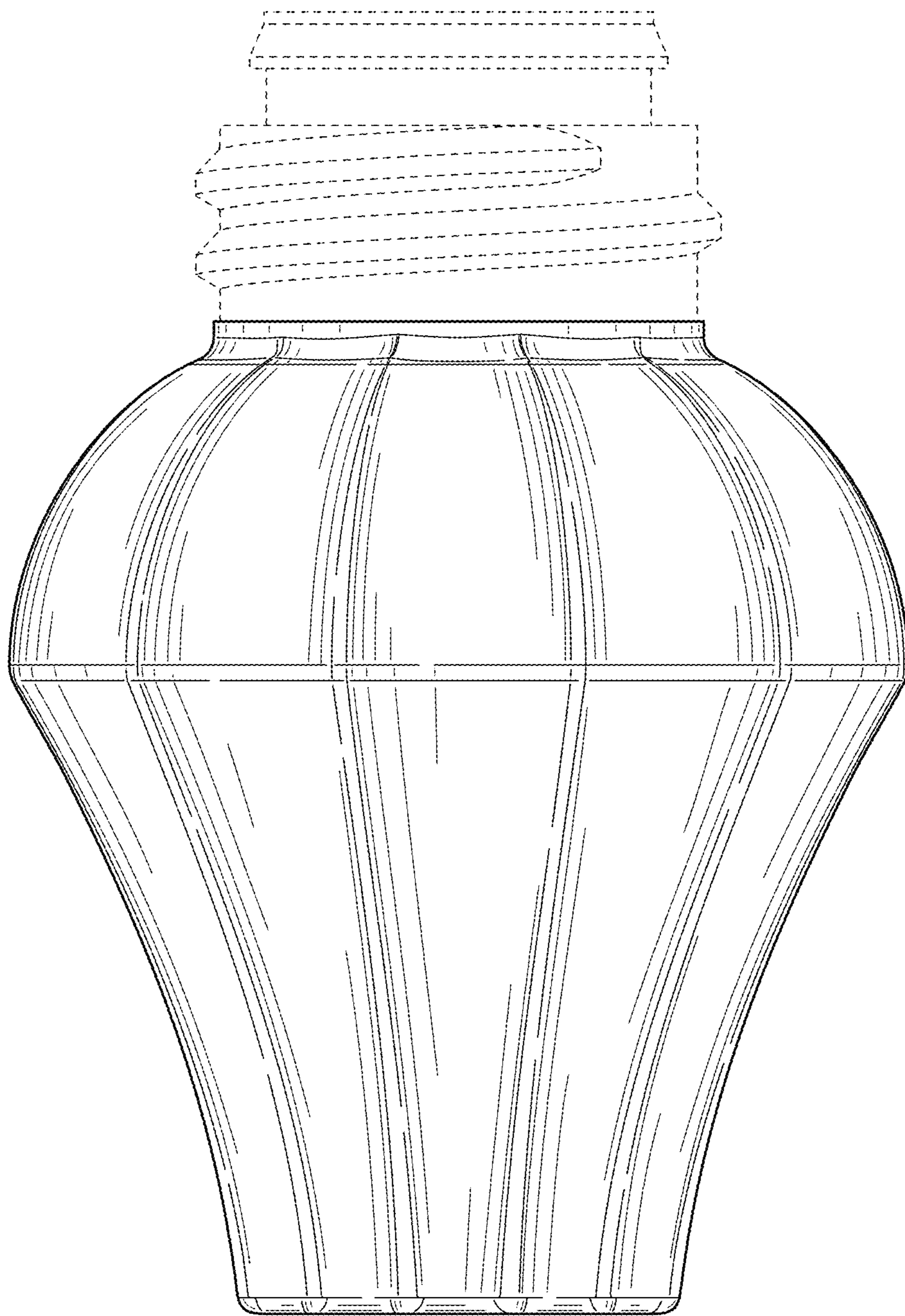

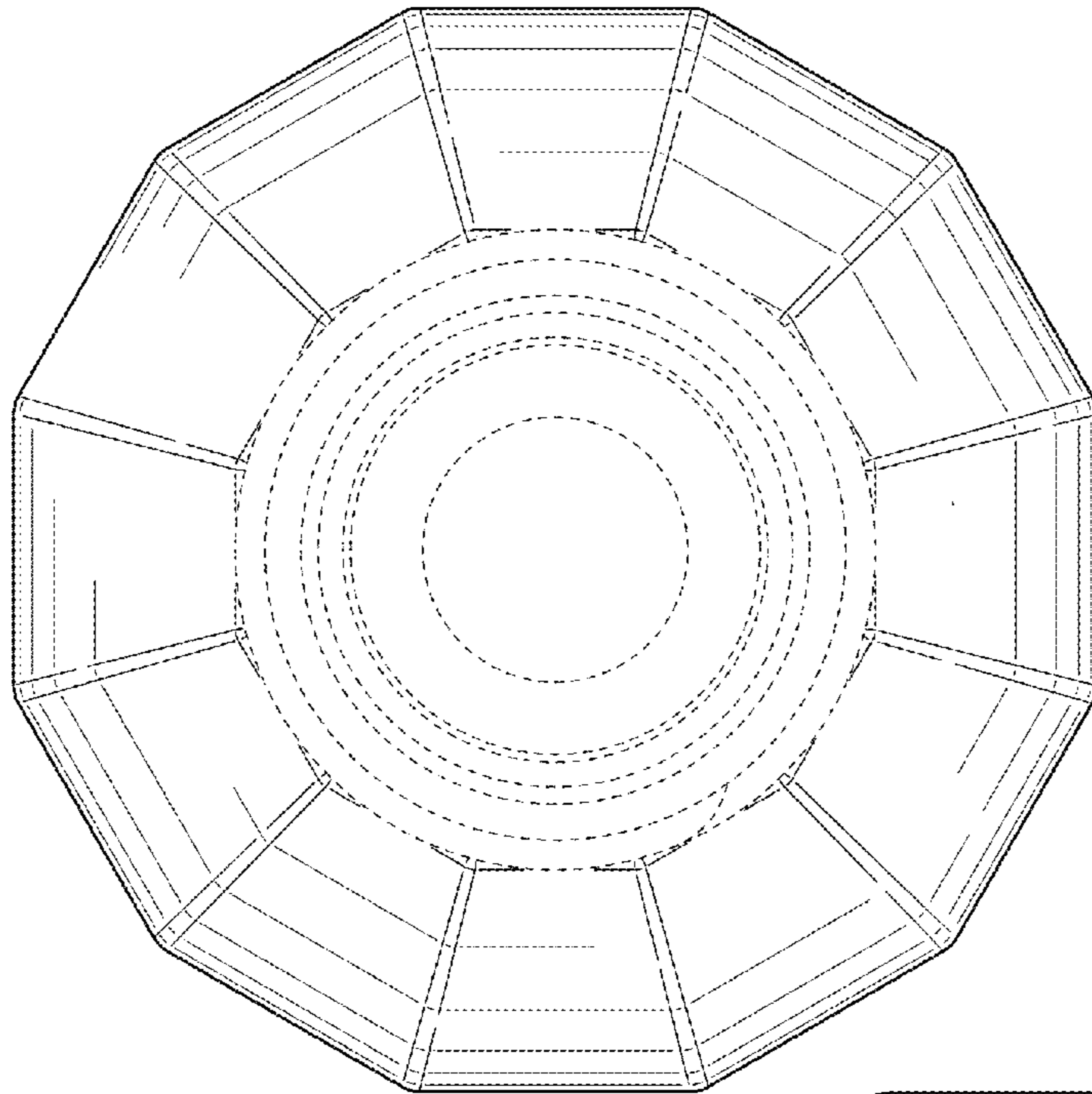

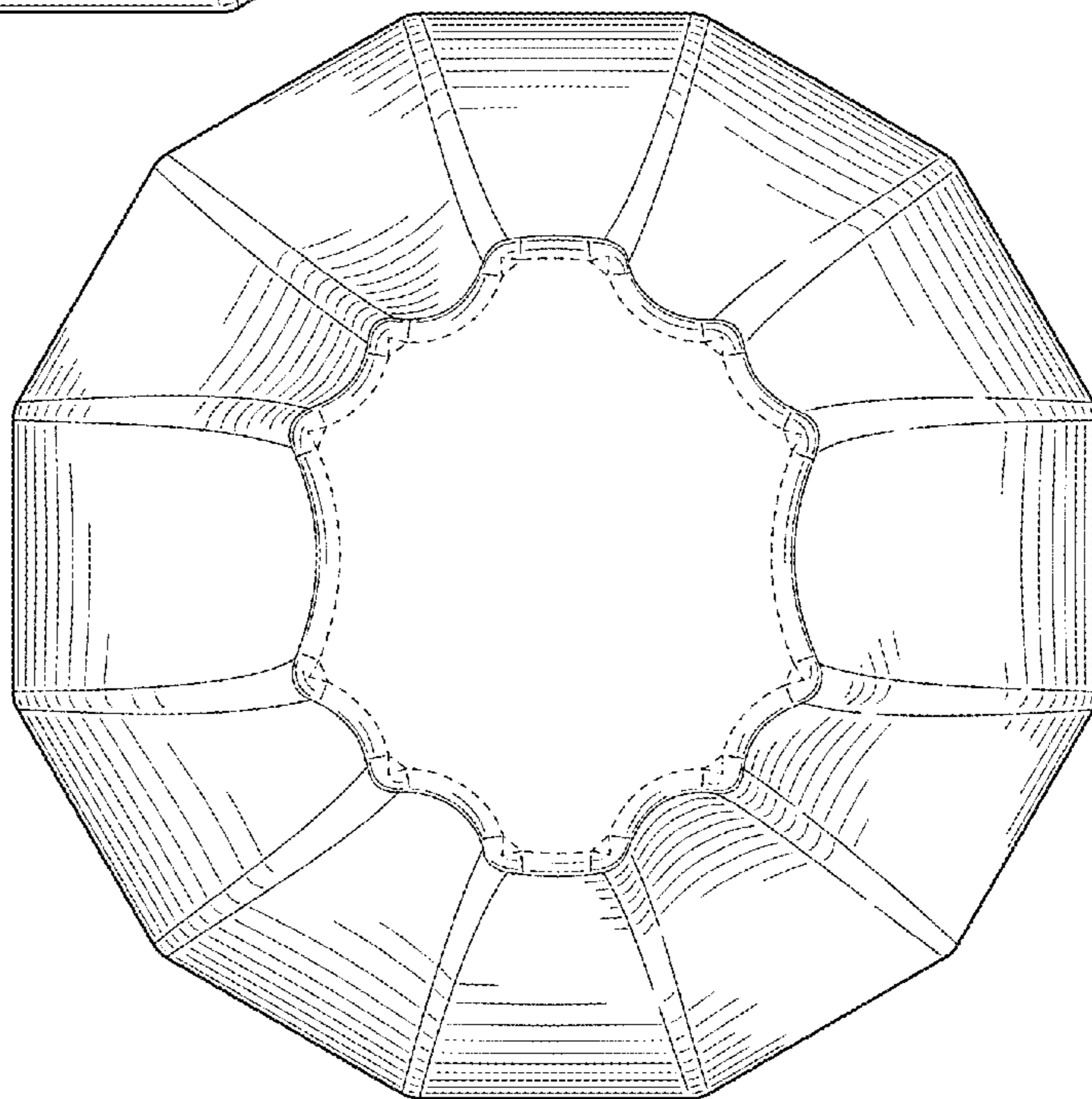
