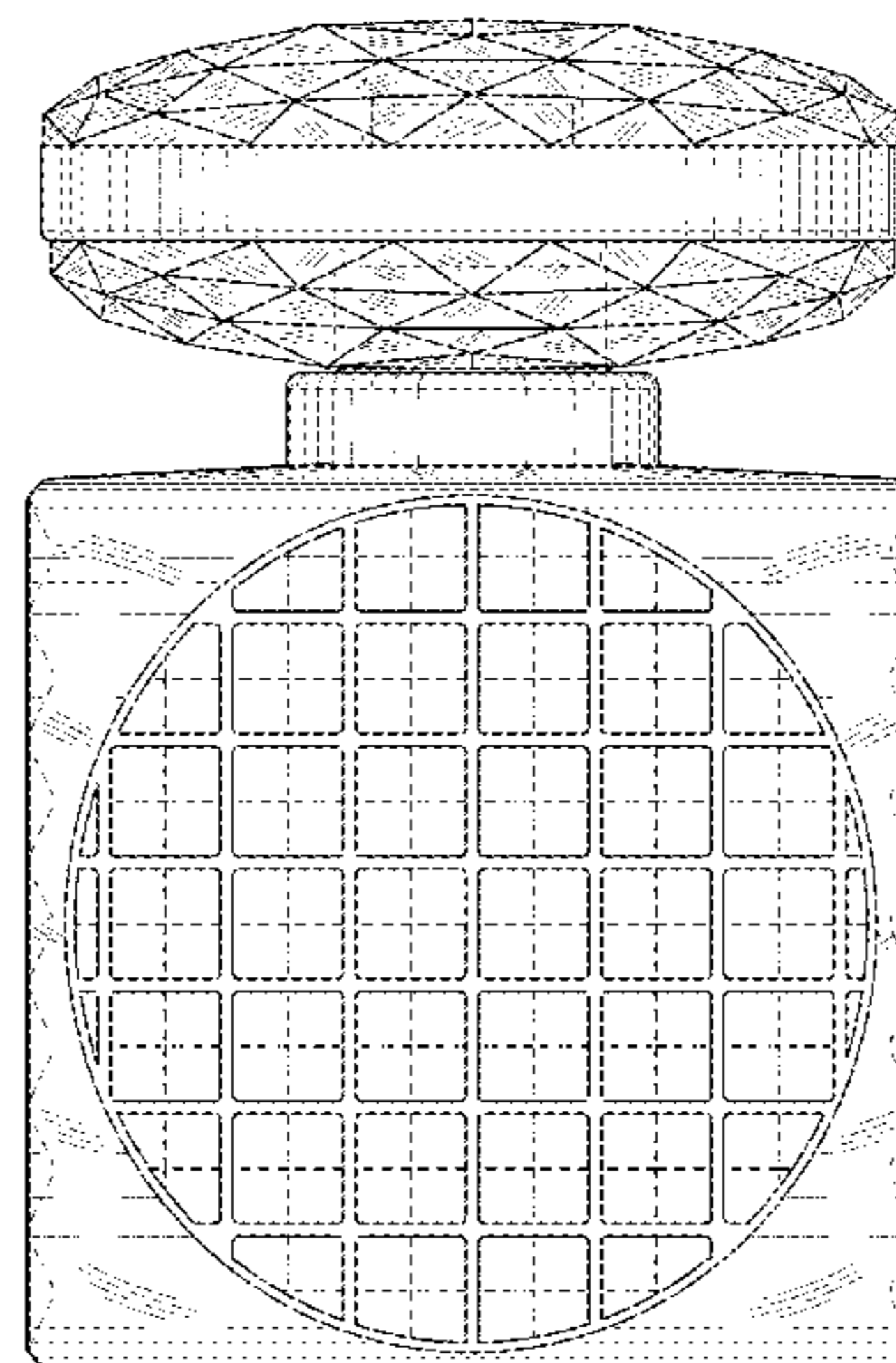
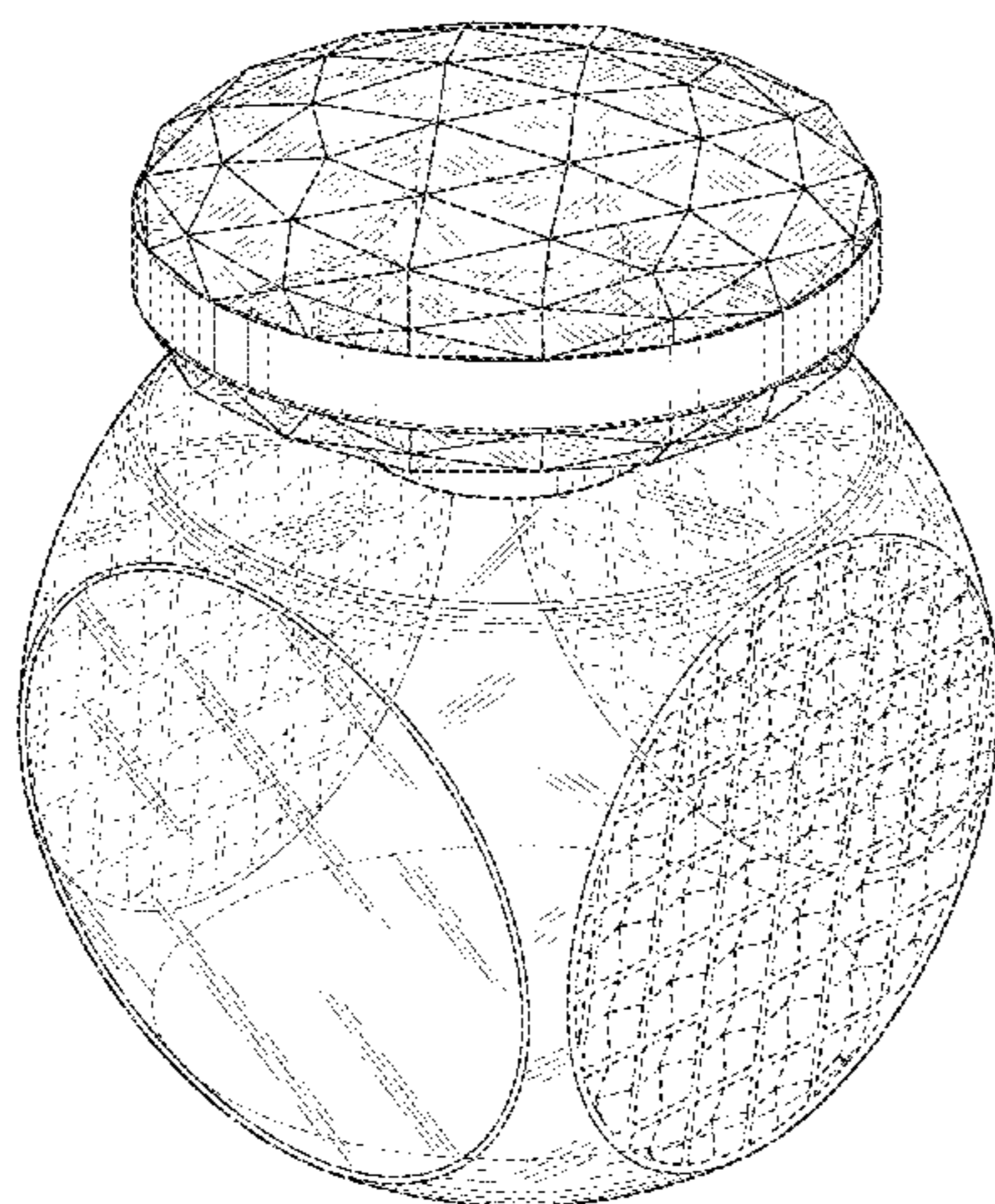
(57) **CLAIM**

The ornamental design for a bottle, as shown and described.

DESCRIPTION

FIG. 1 is a top, front, right side perspective view of a bottle showing our new design;

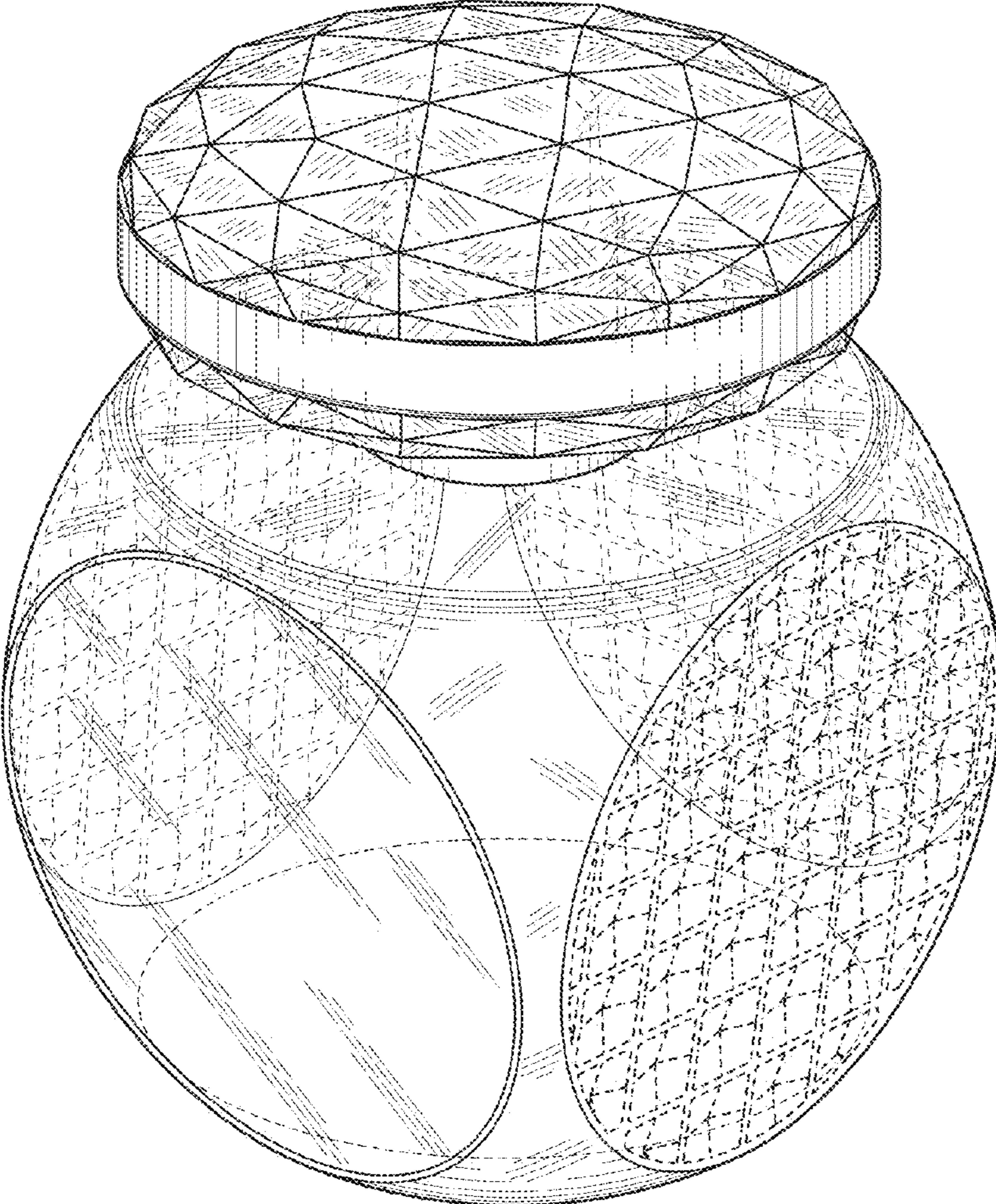

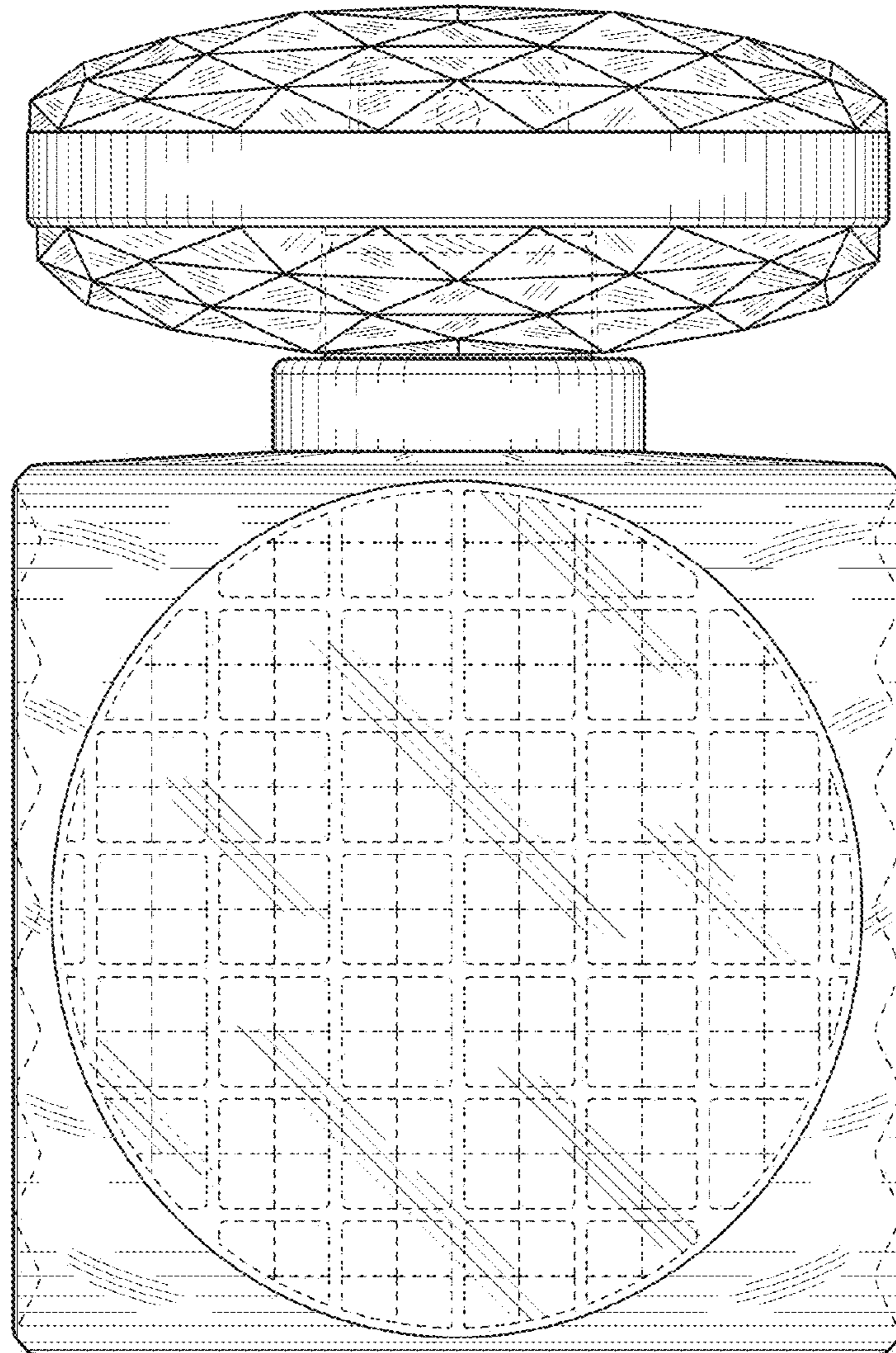

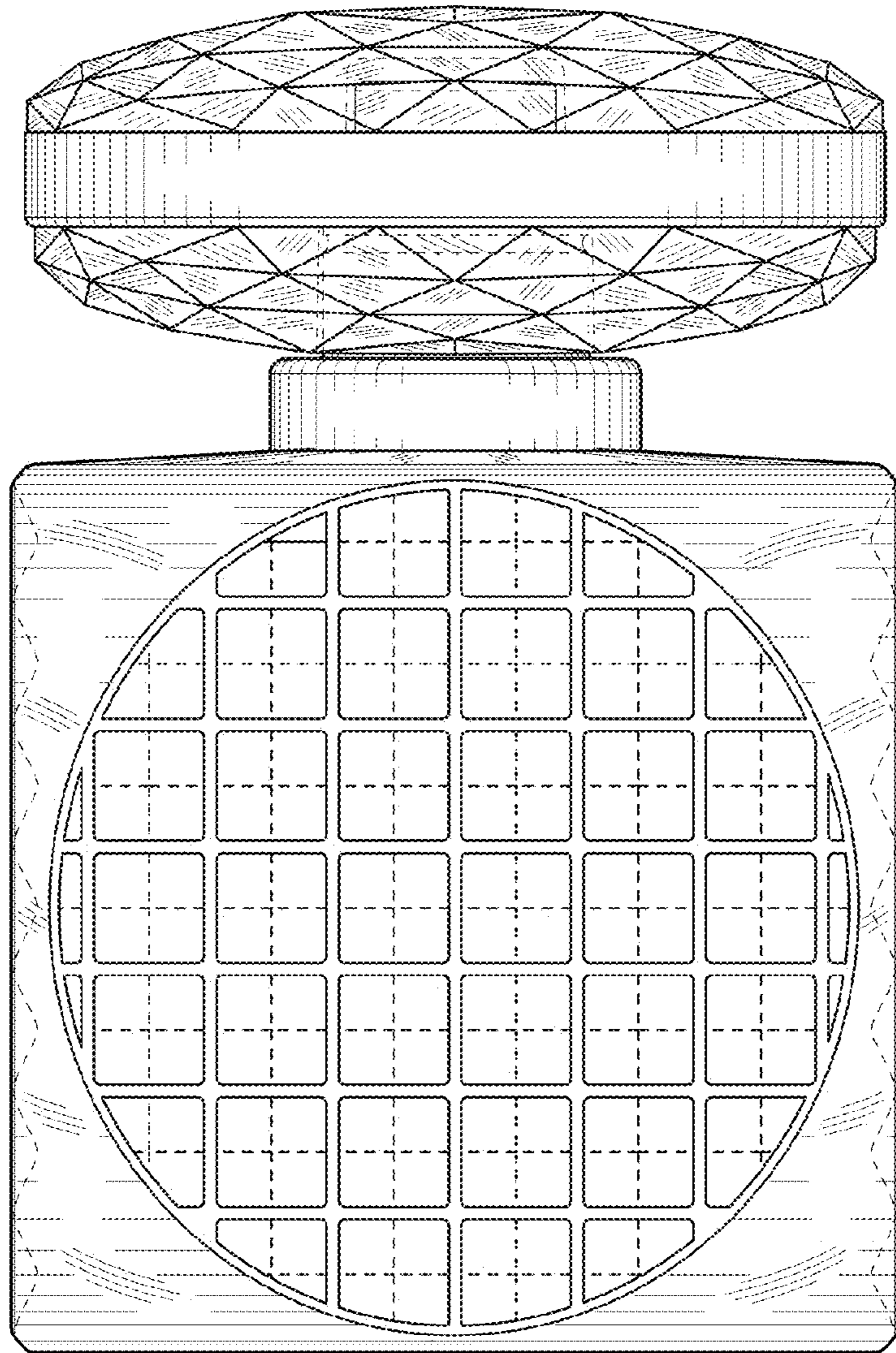

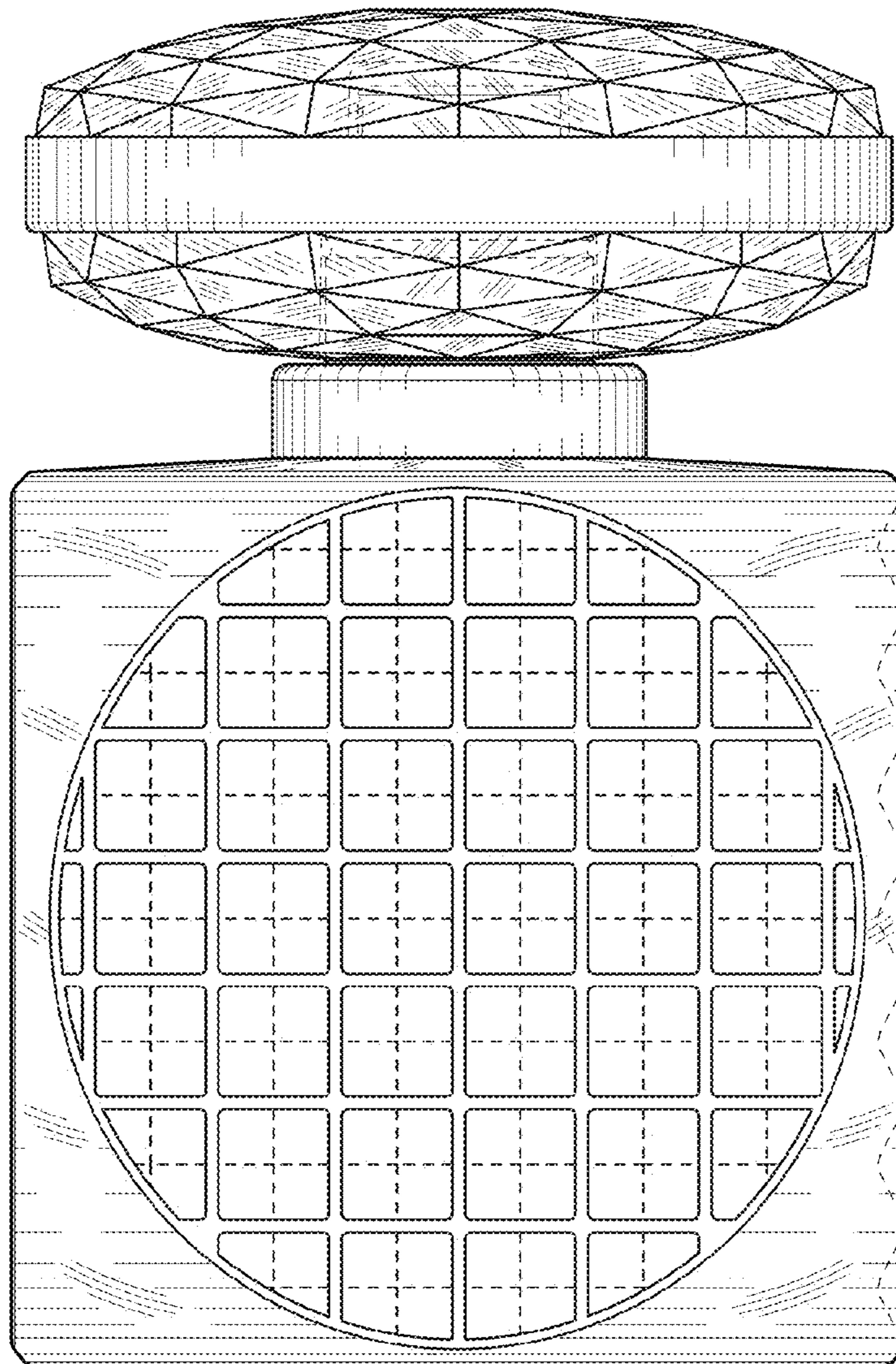

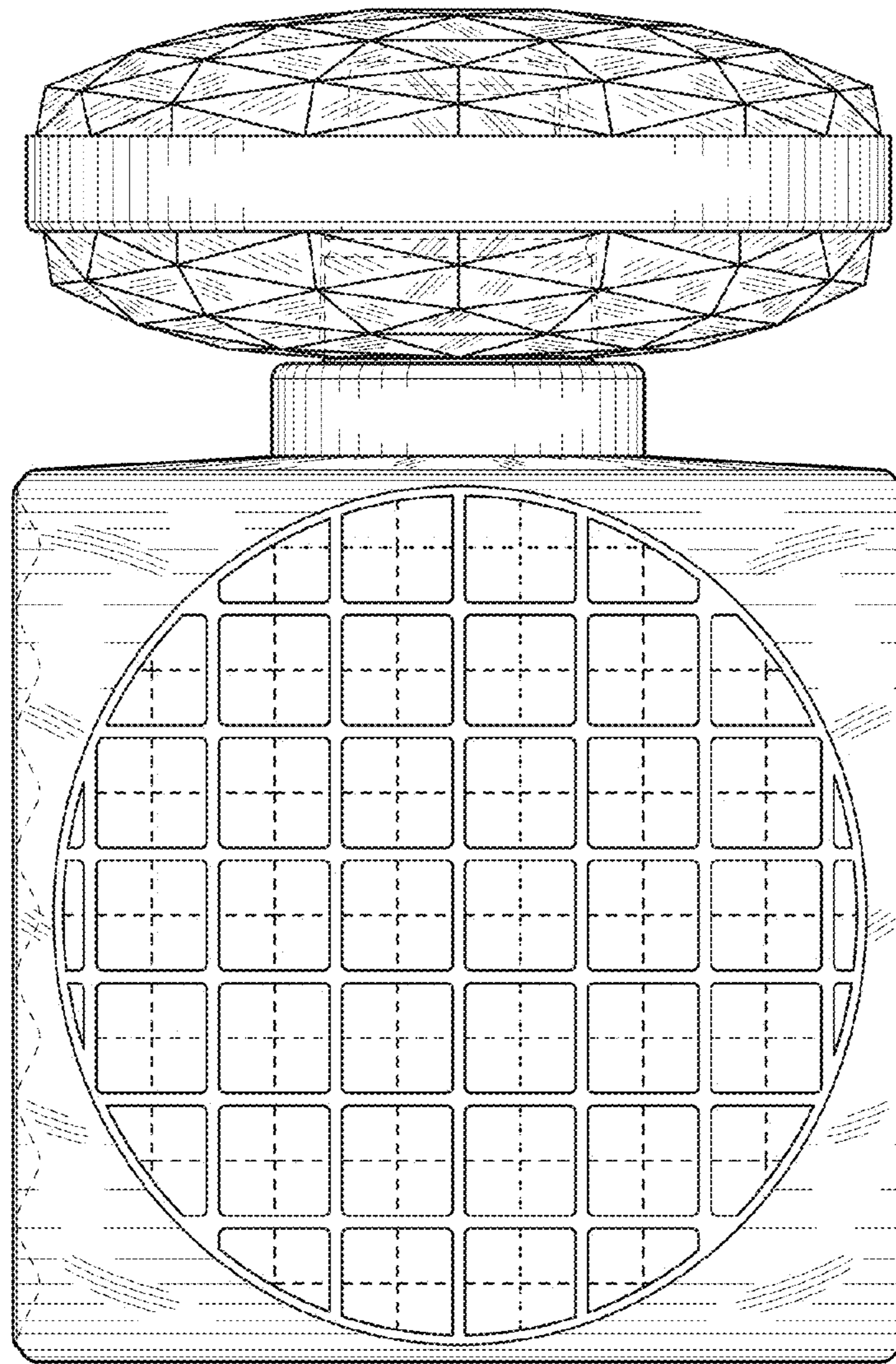

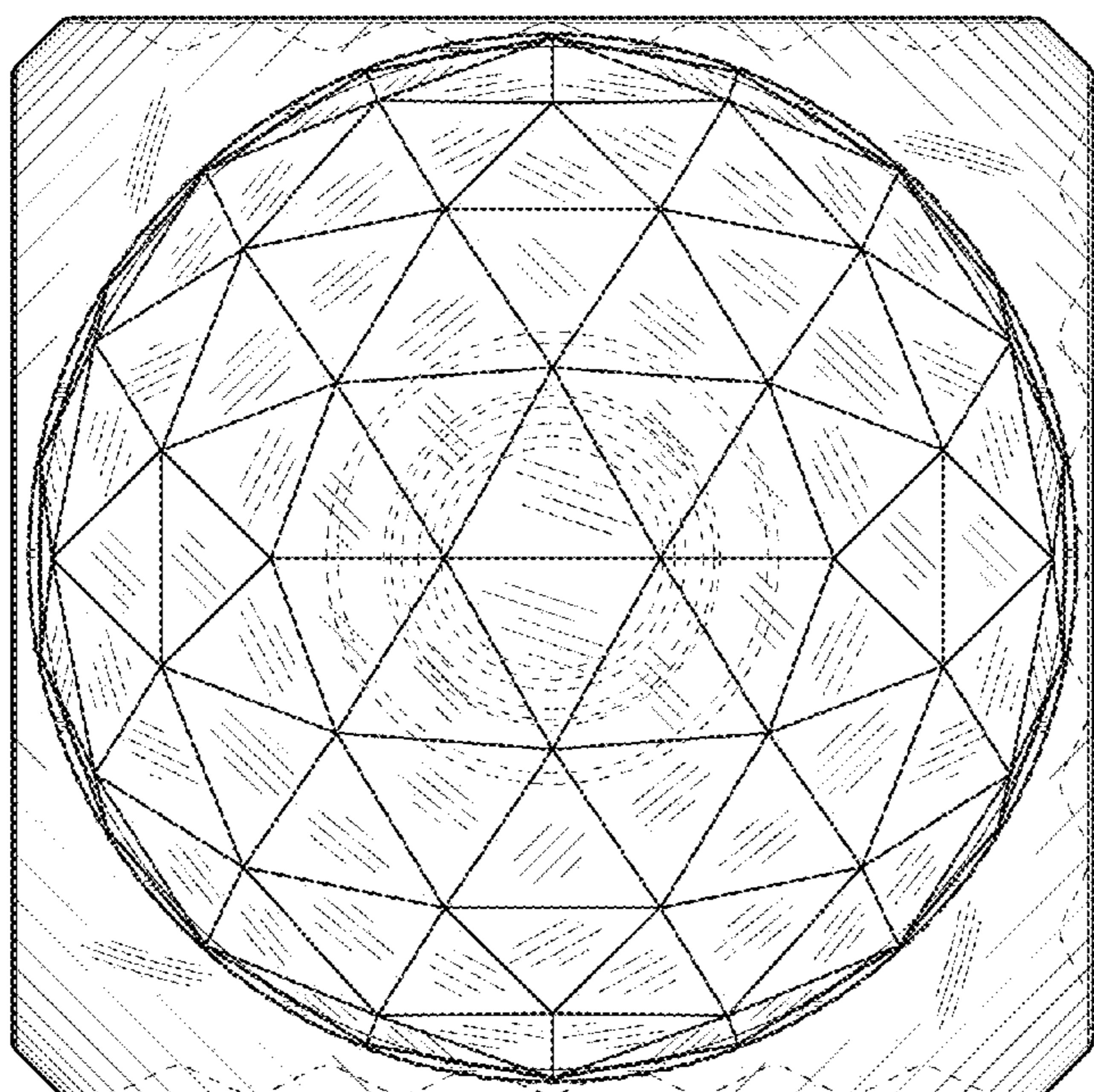

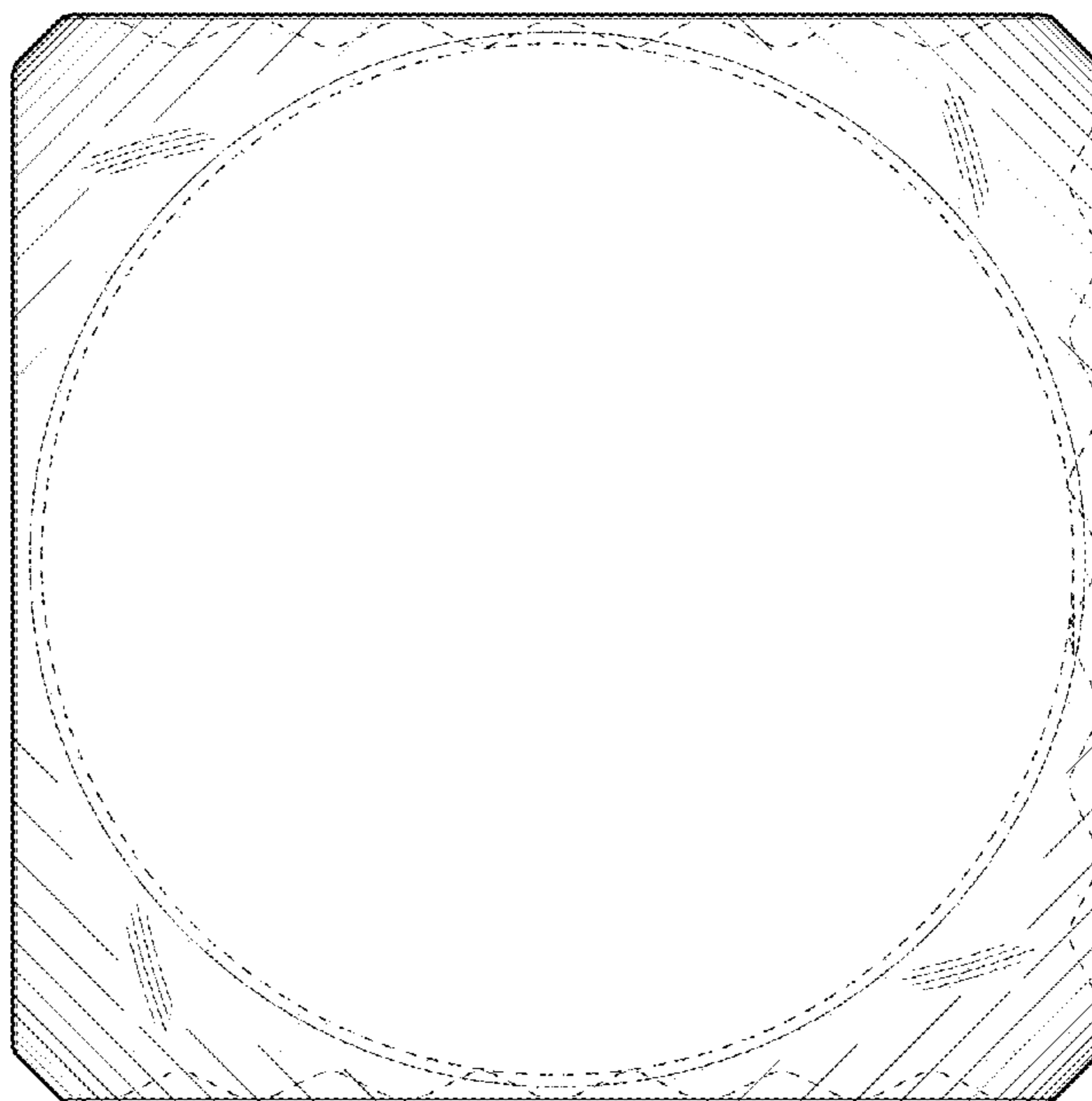

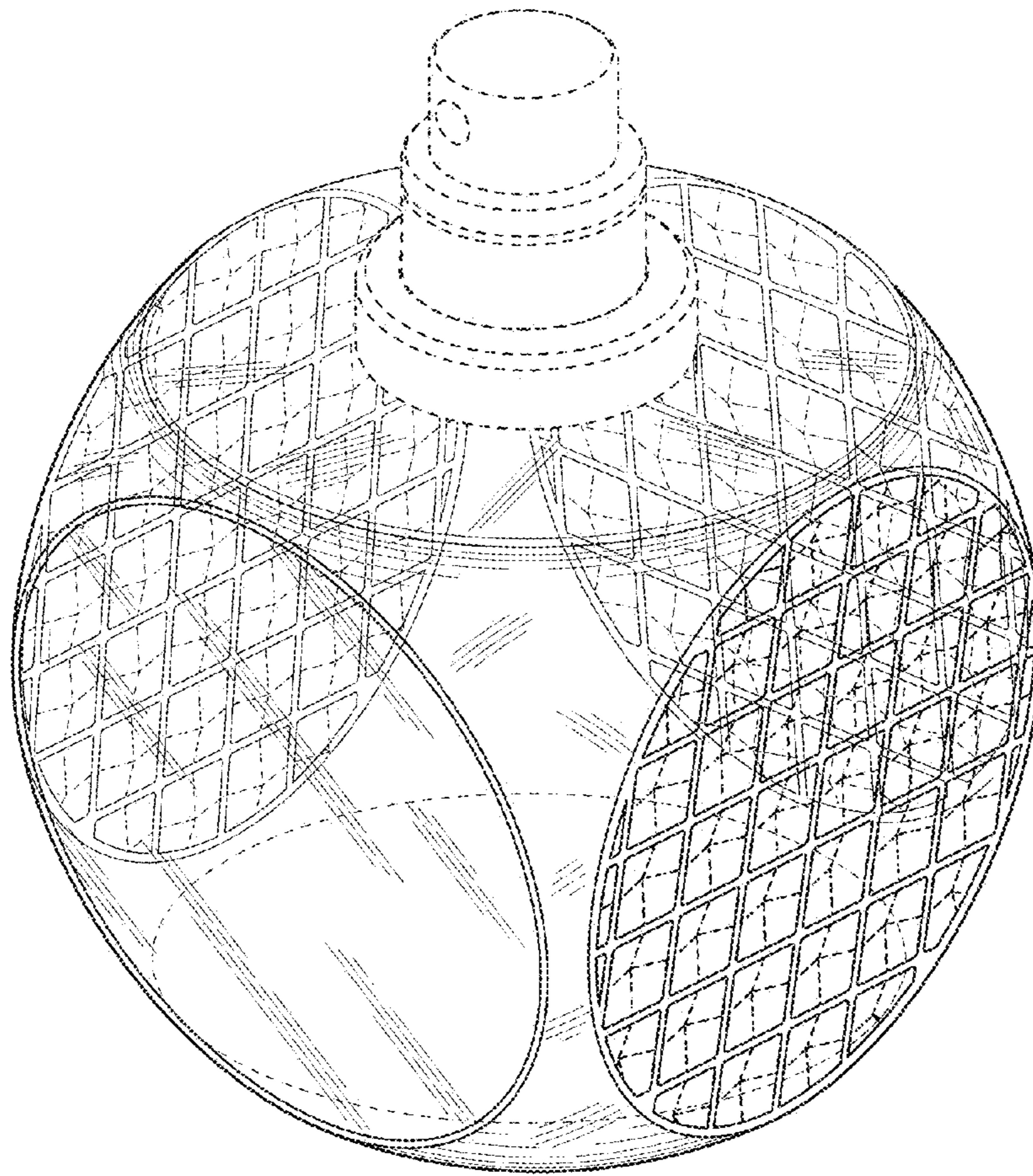

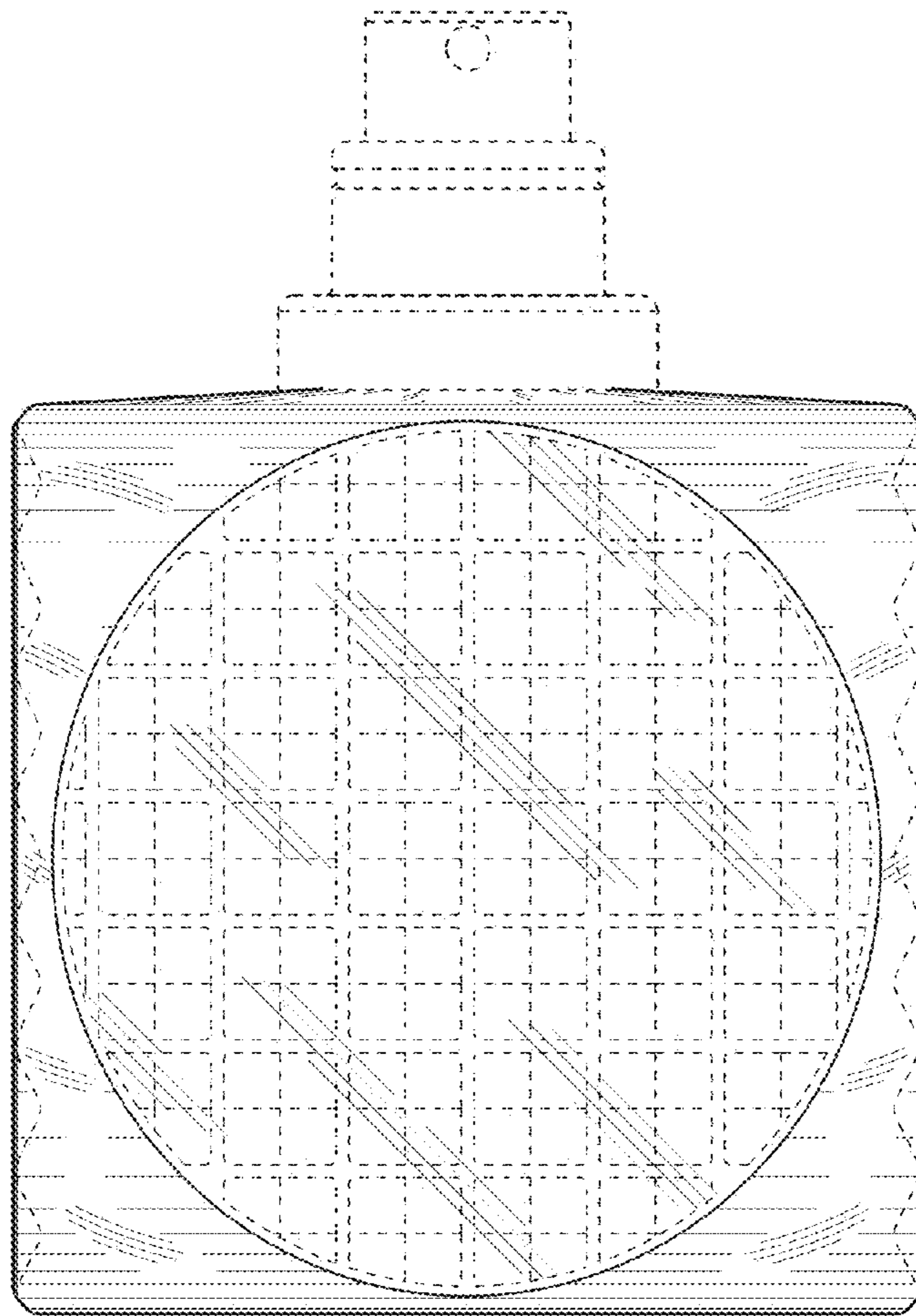

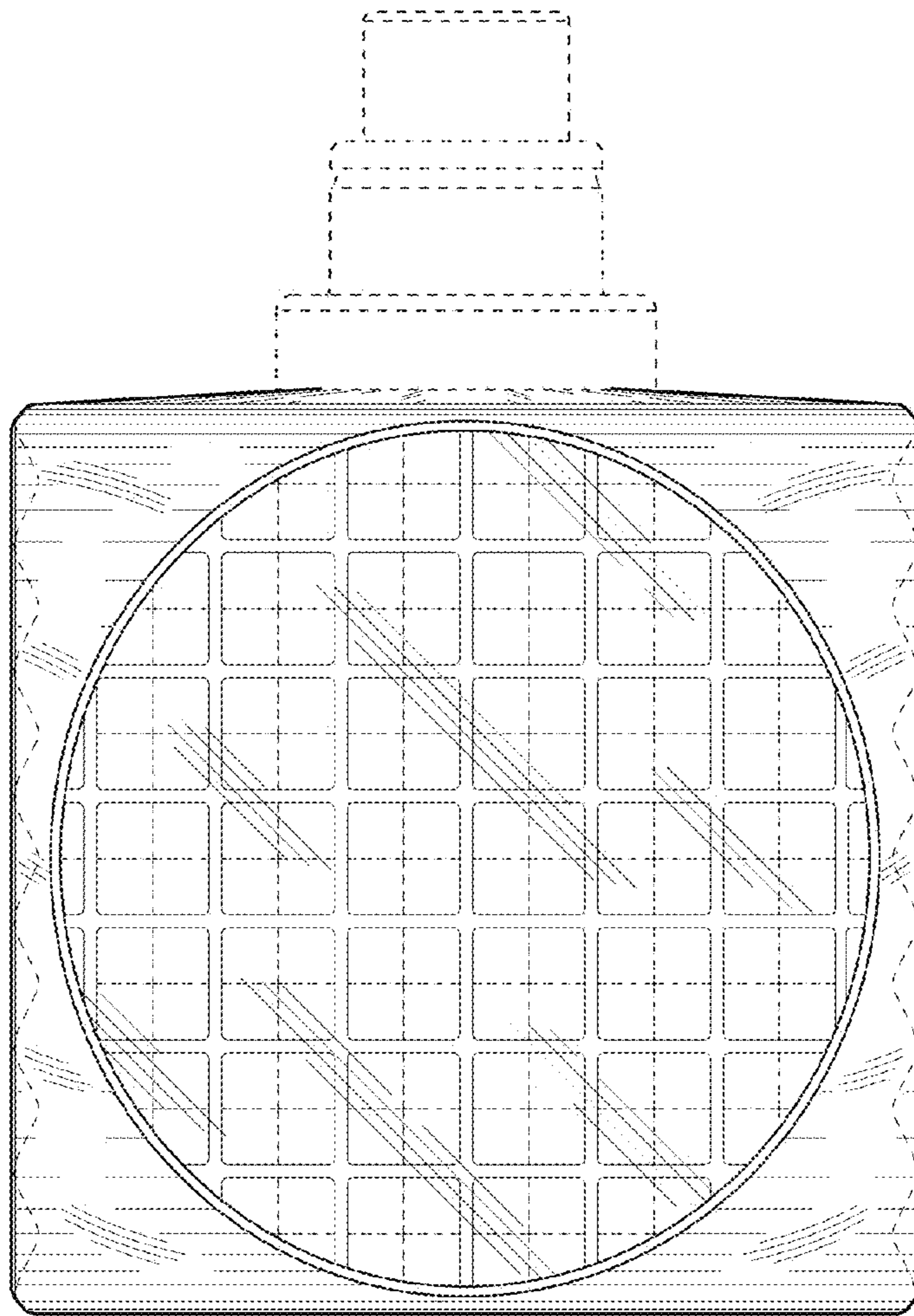

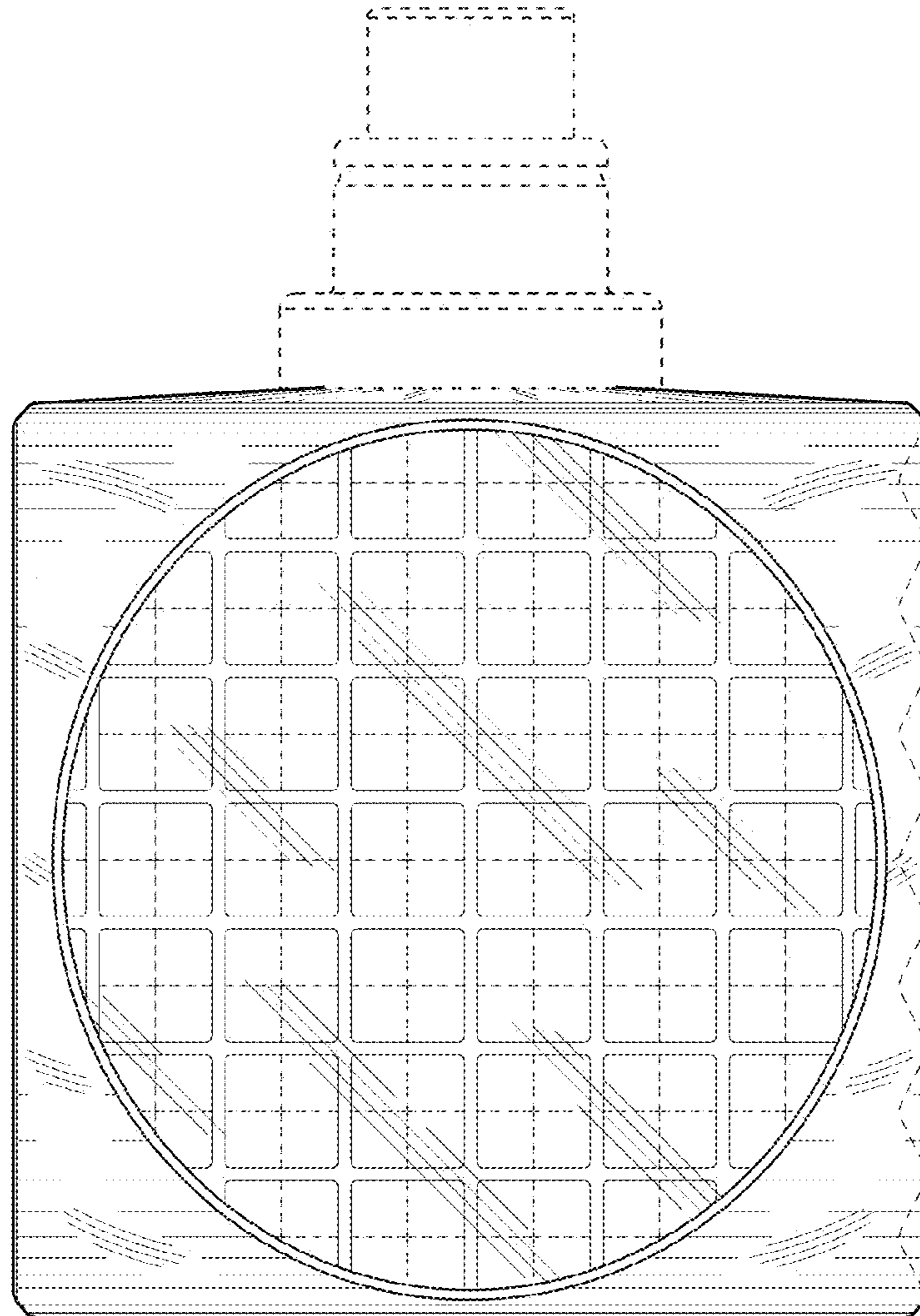

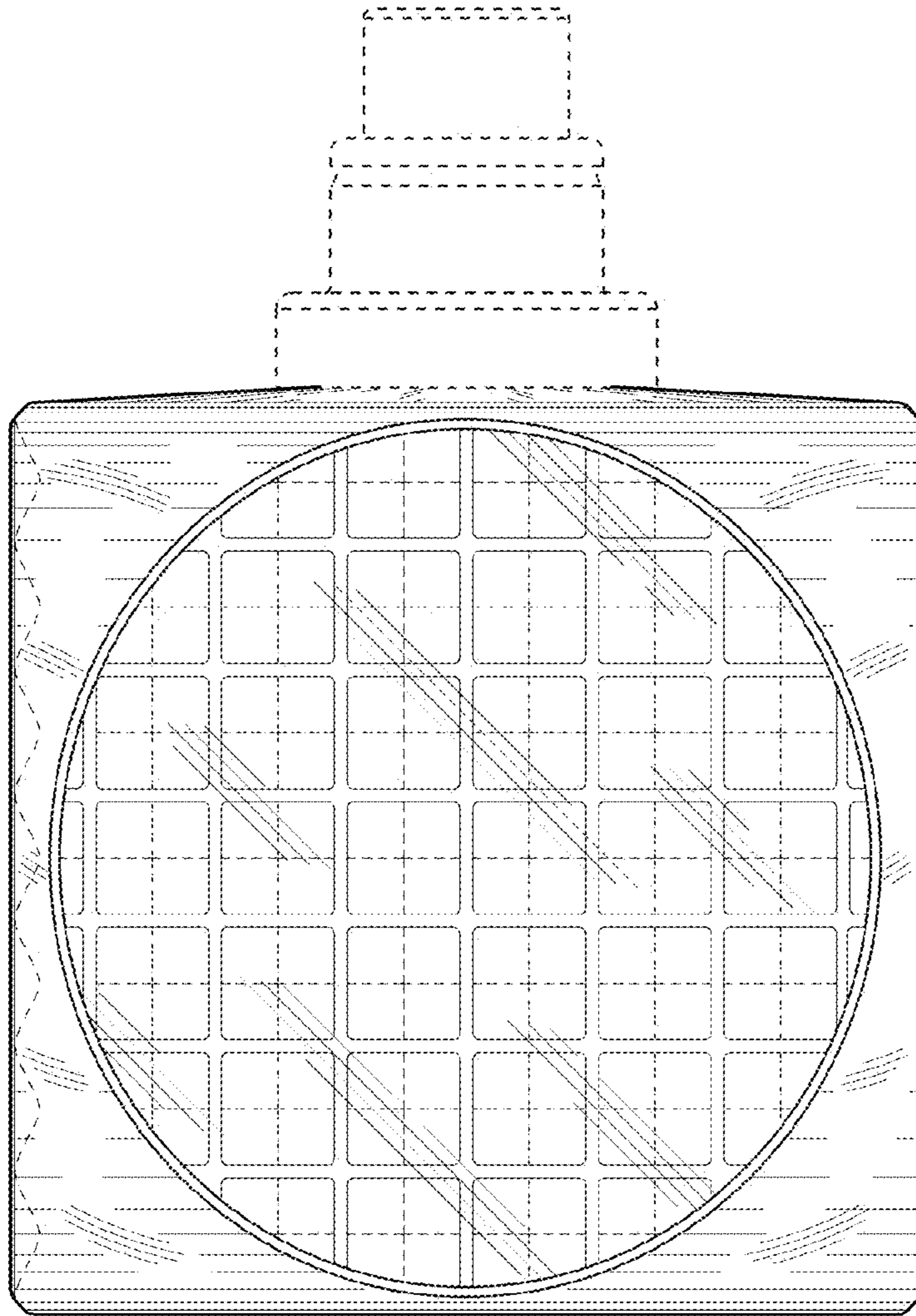

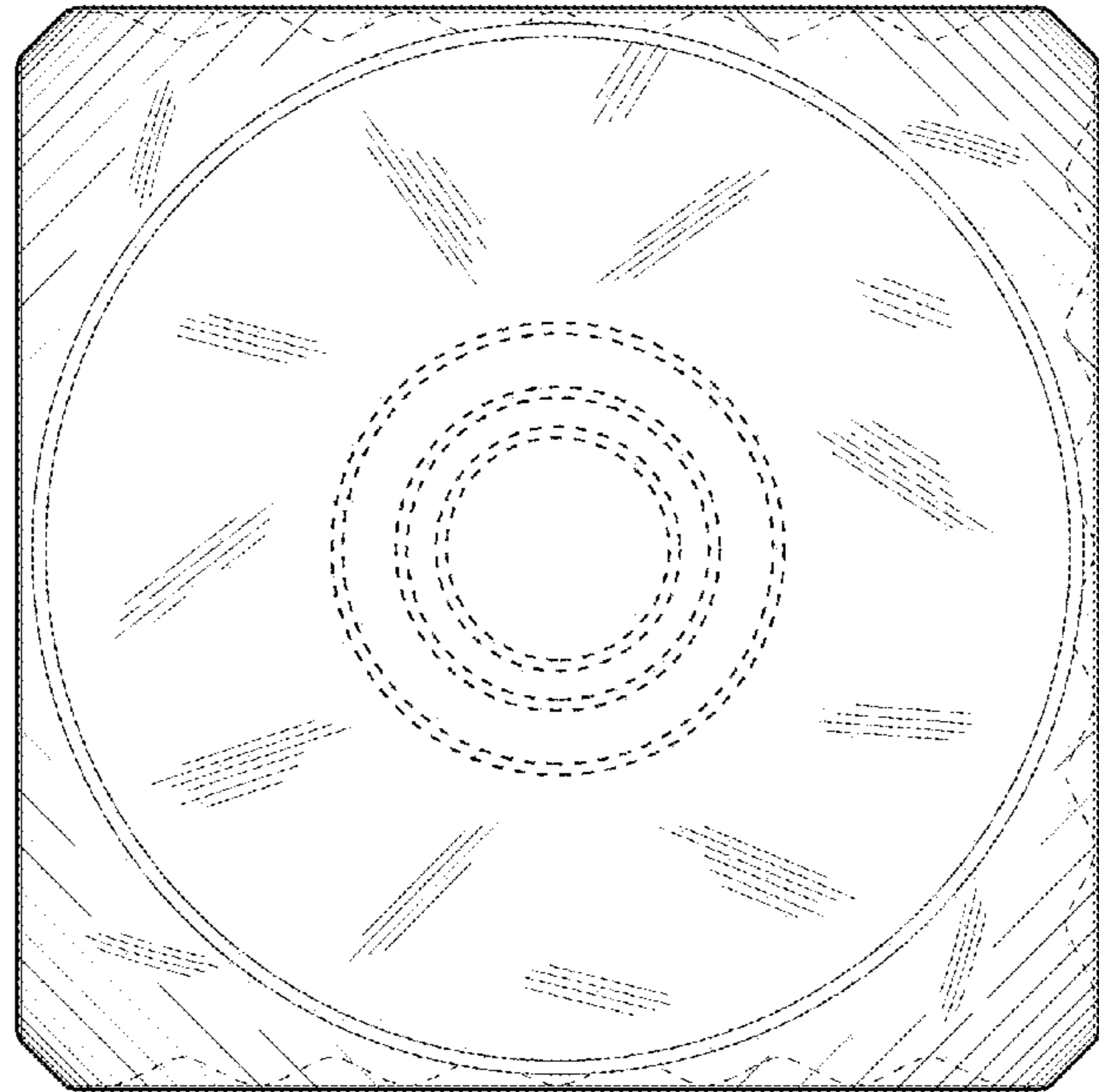

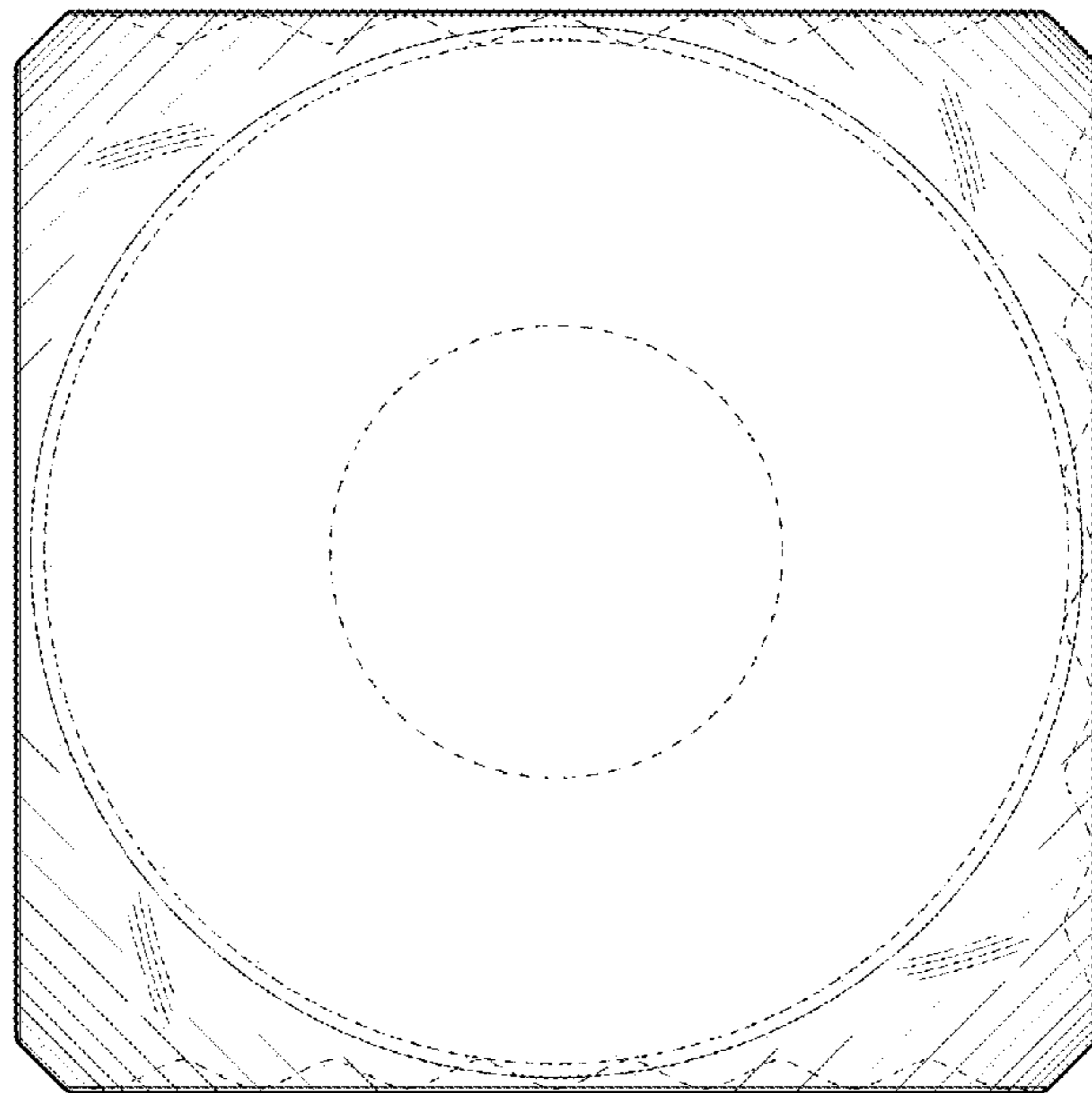

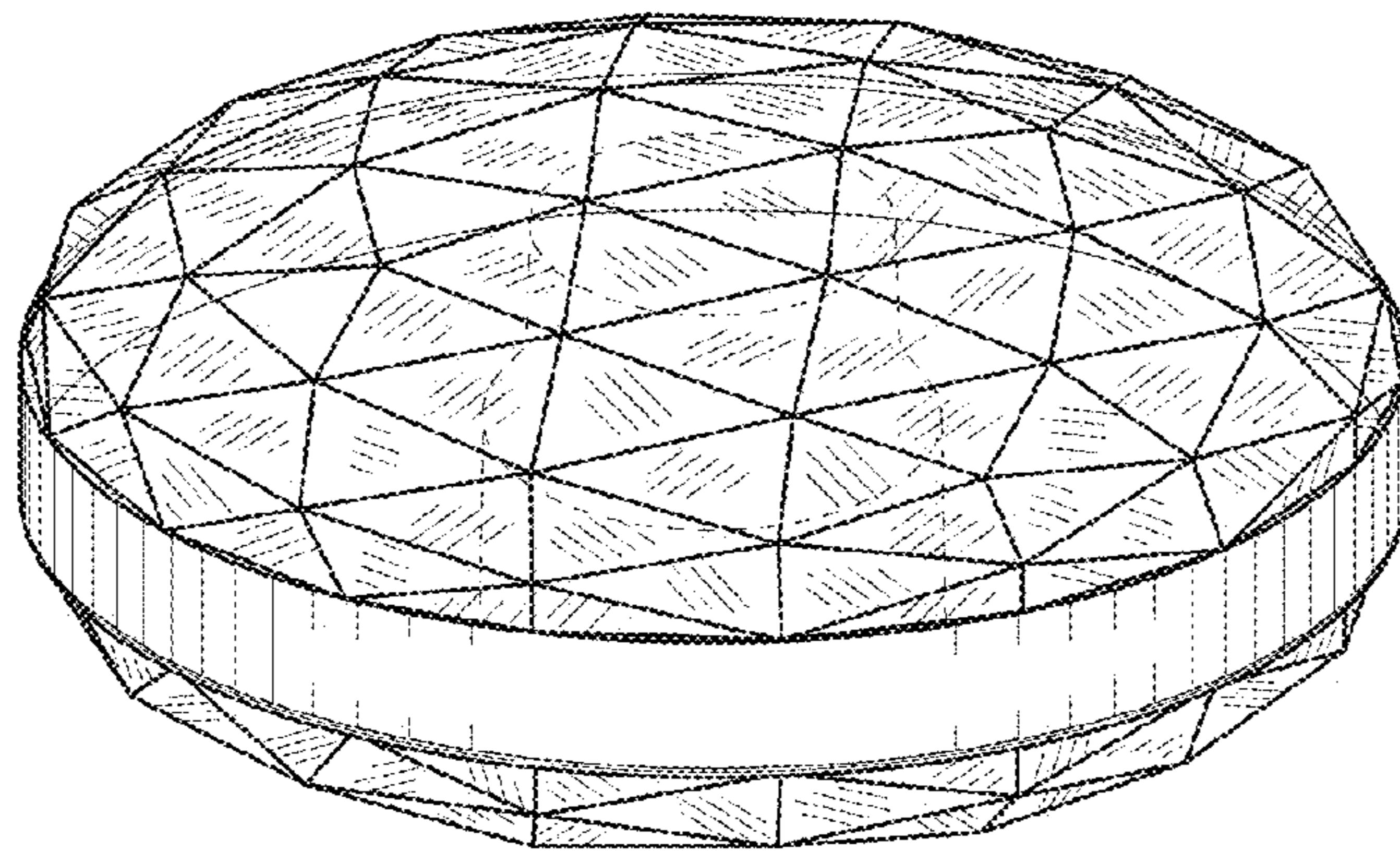

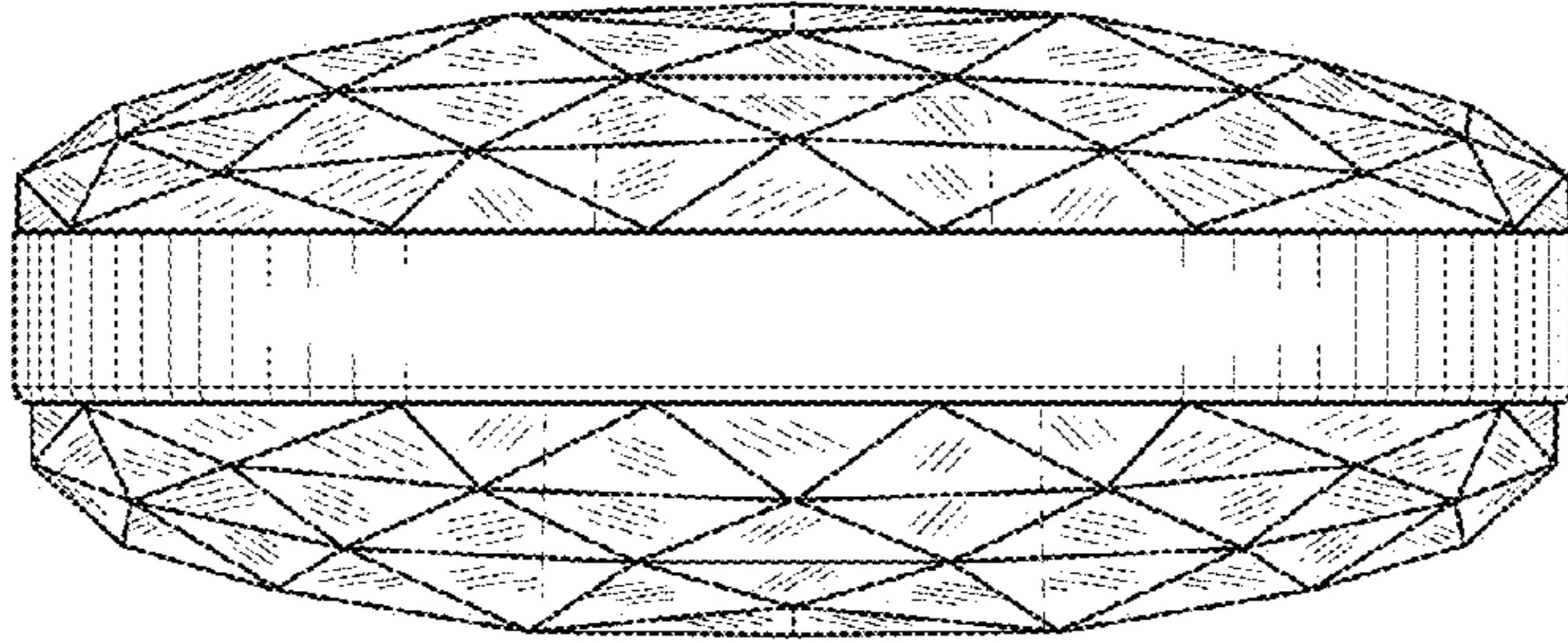

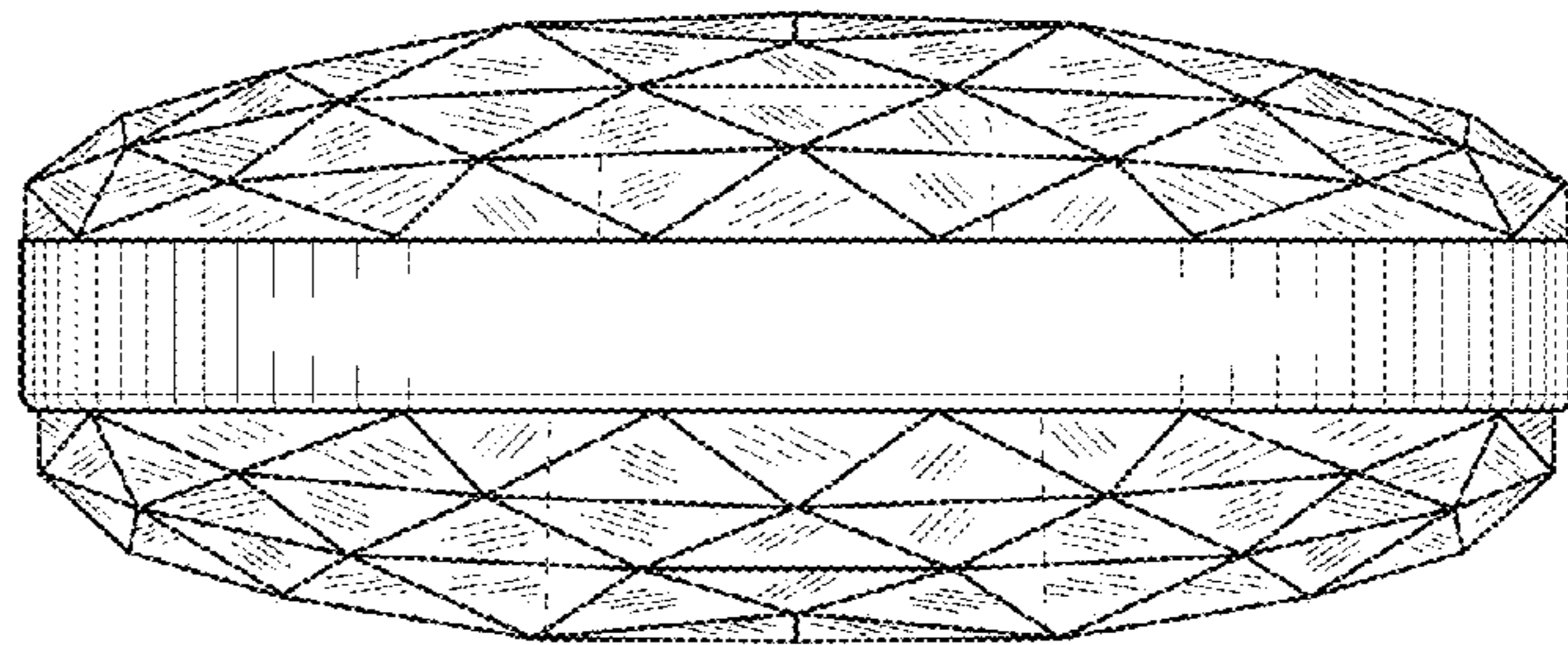

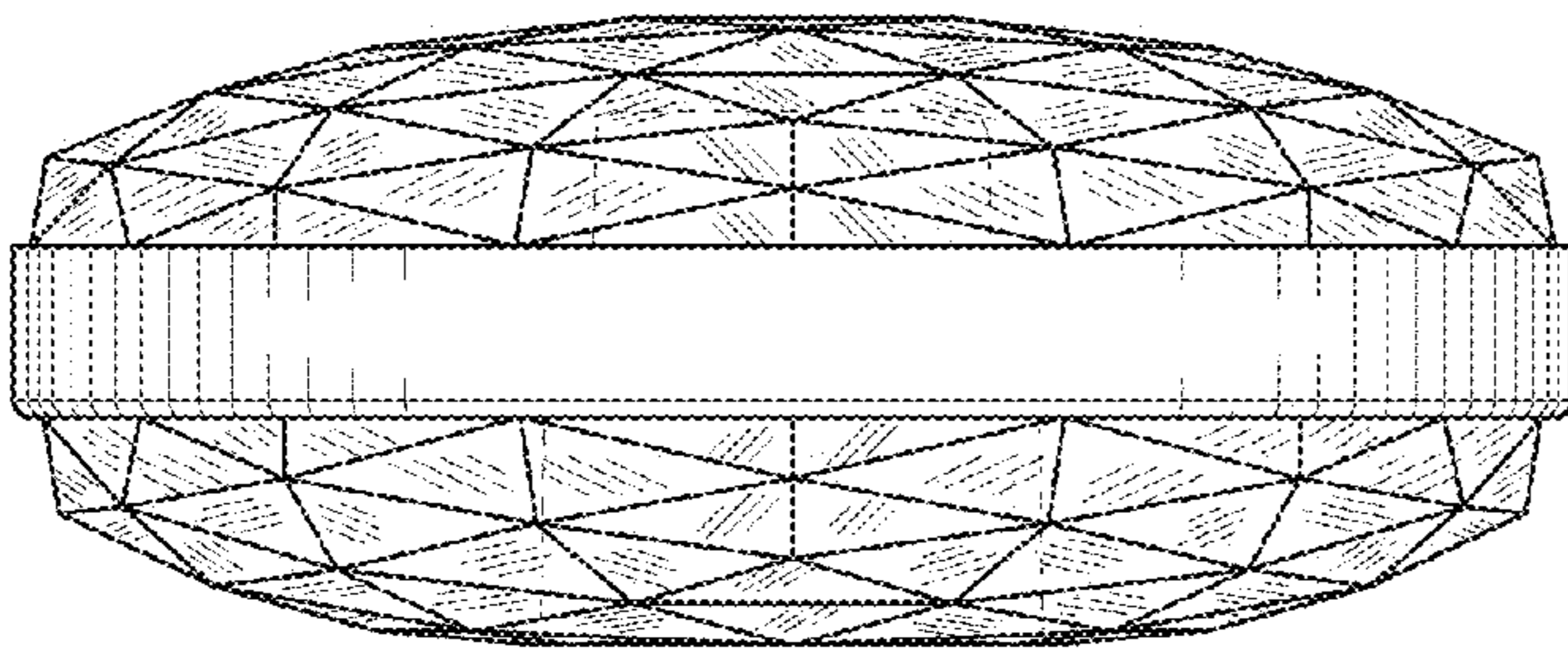

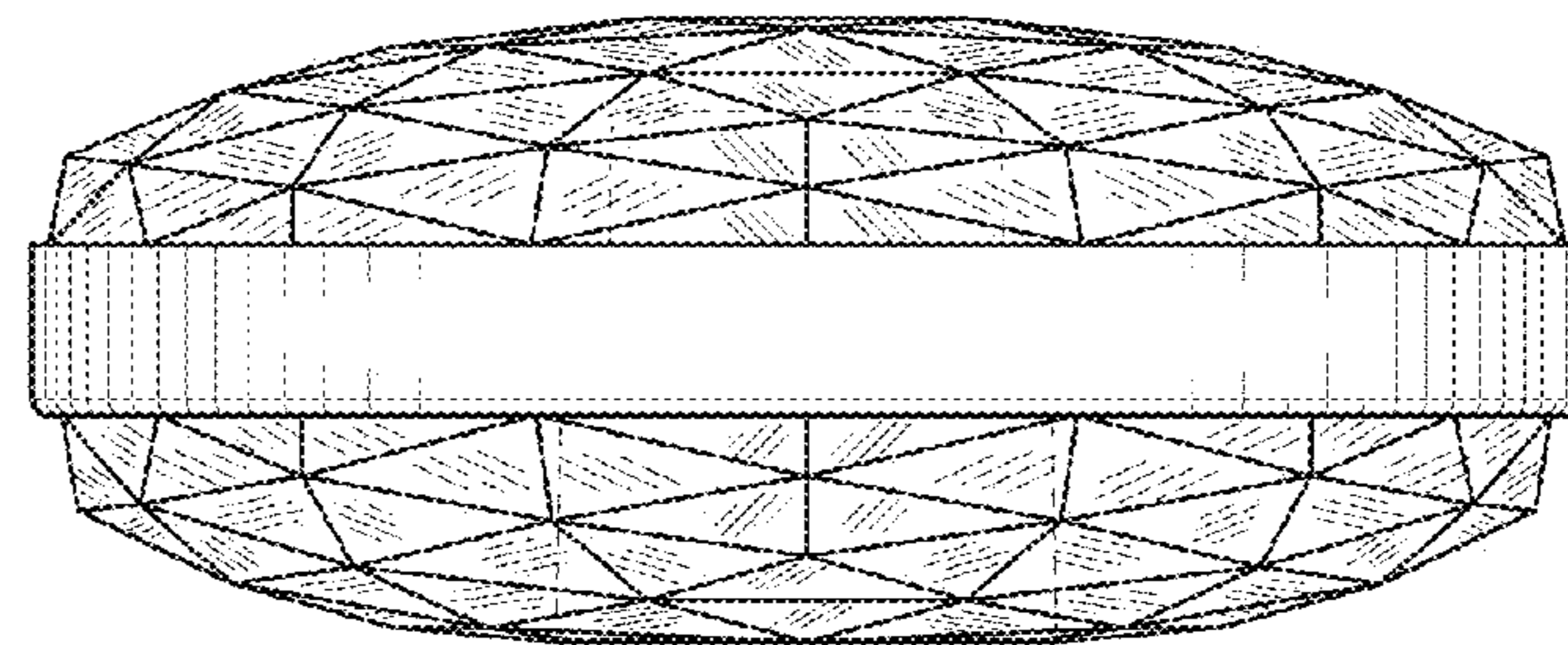

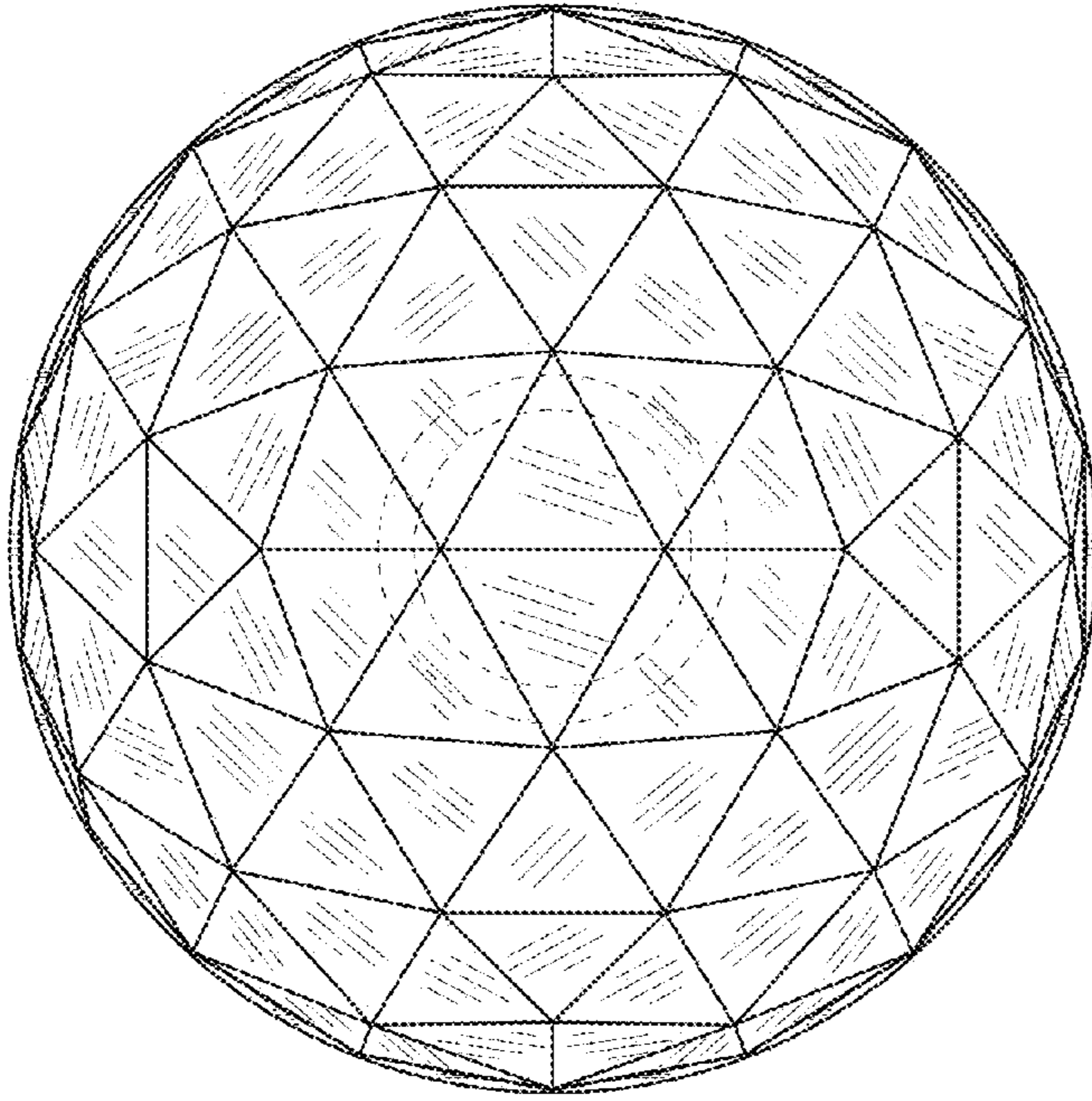

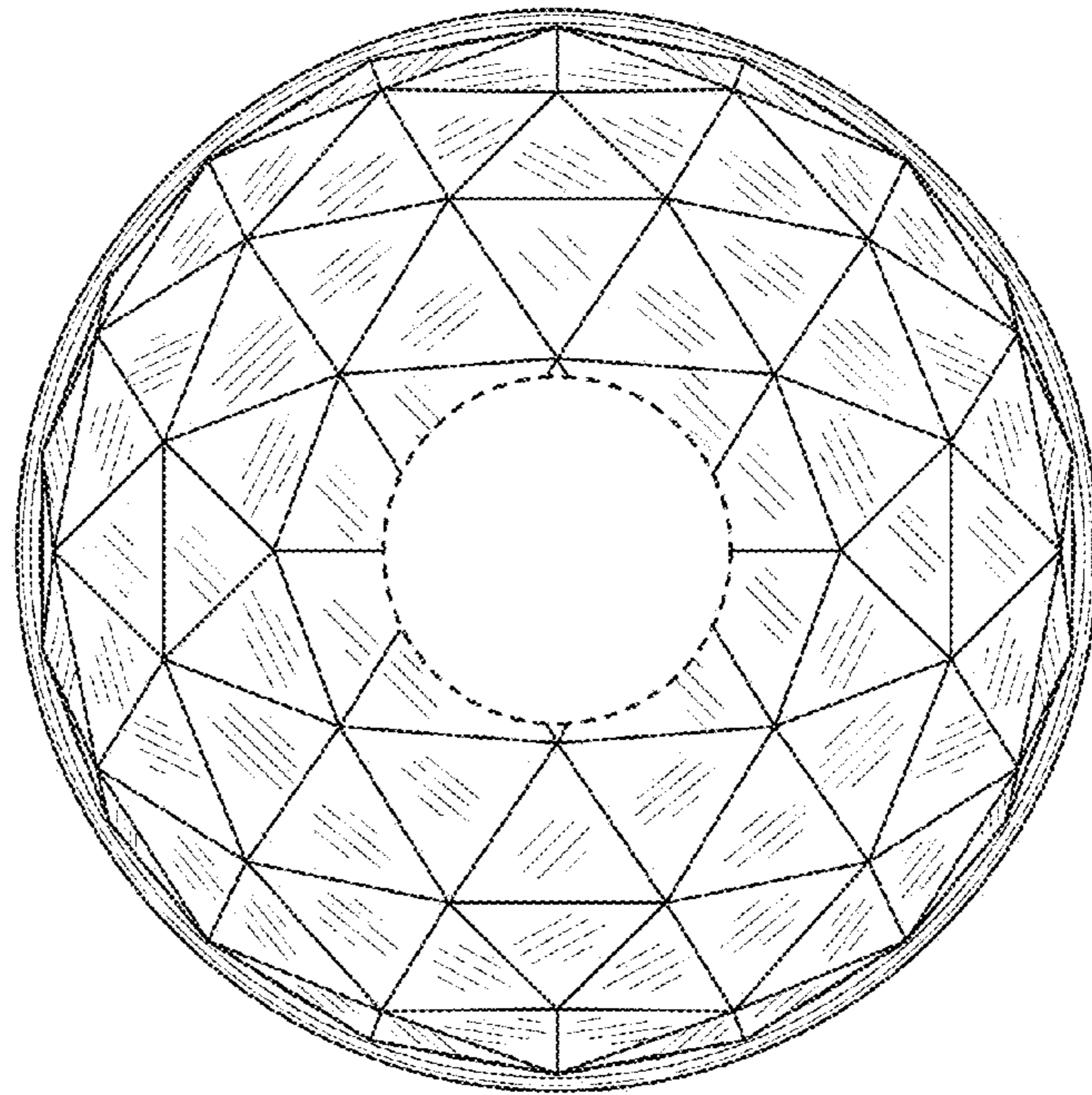
