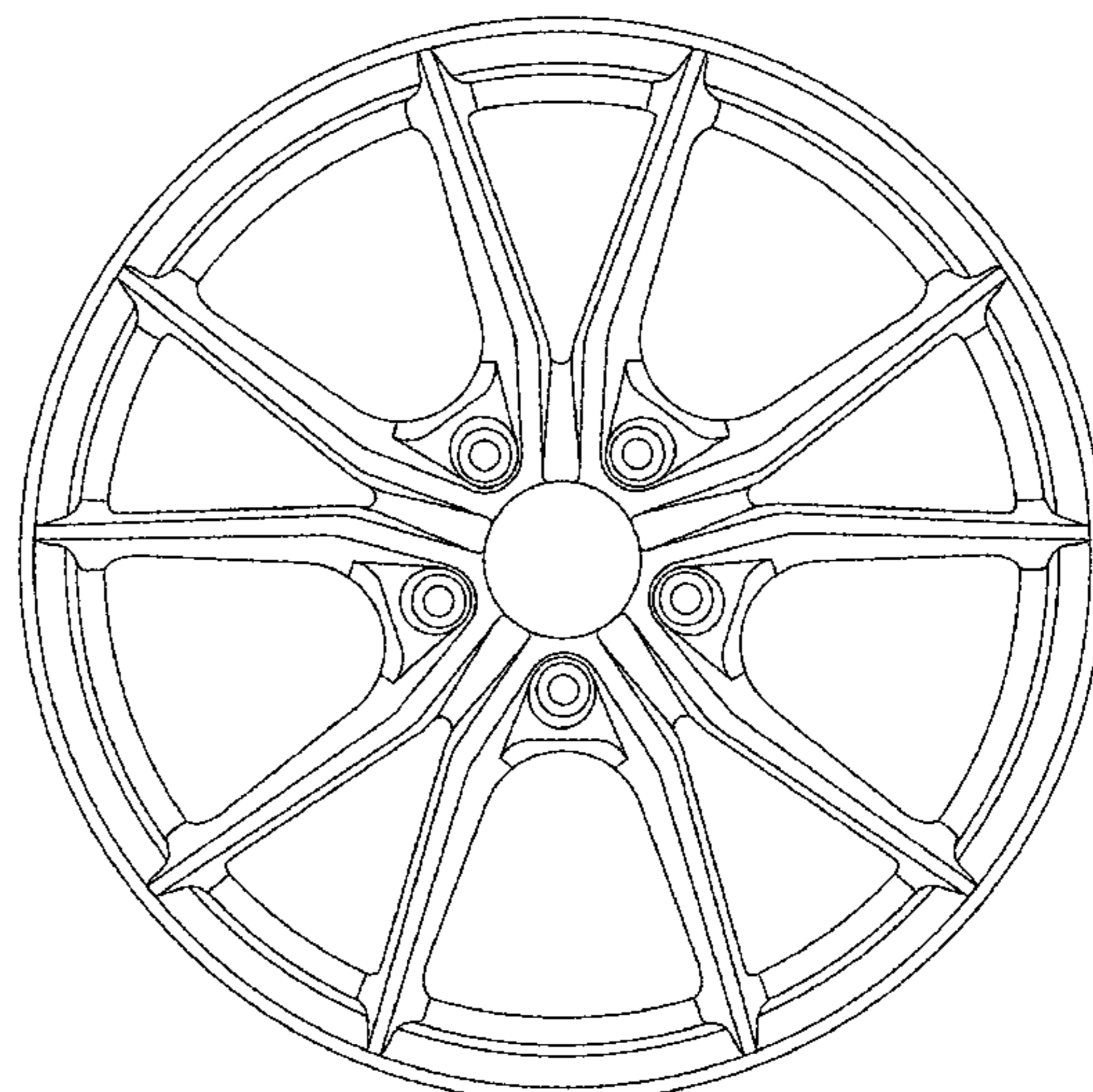
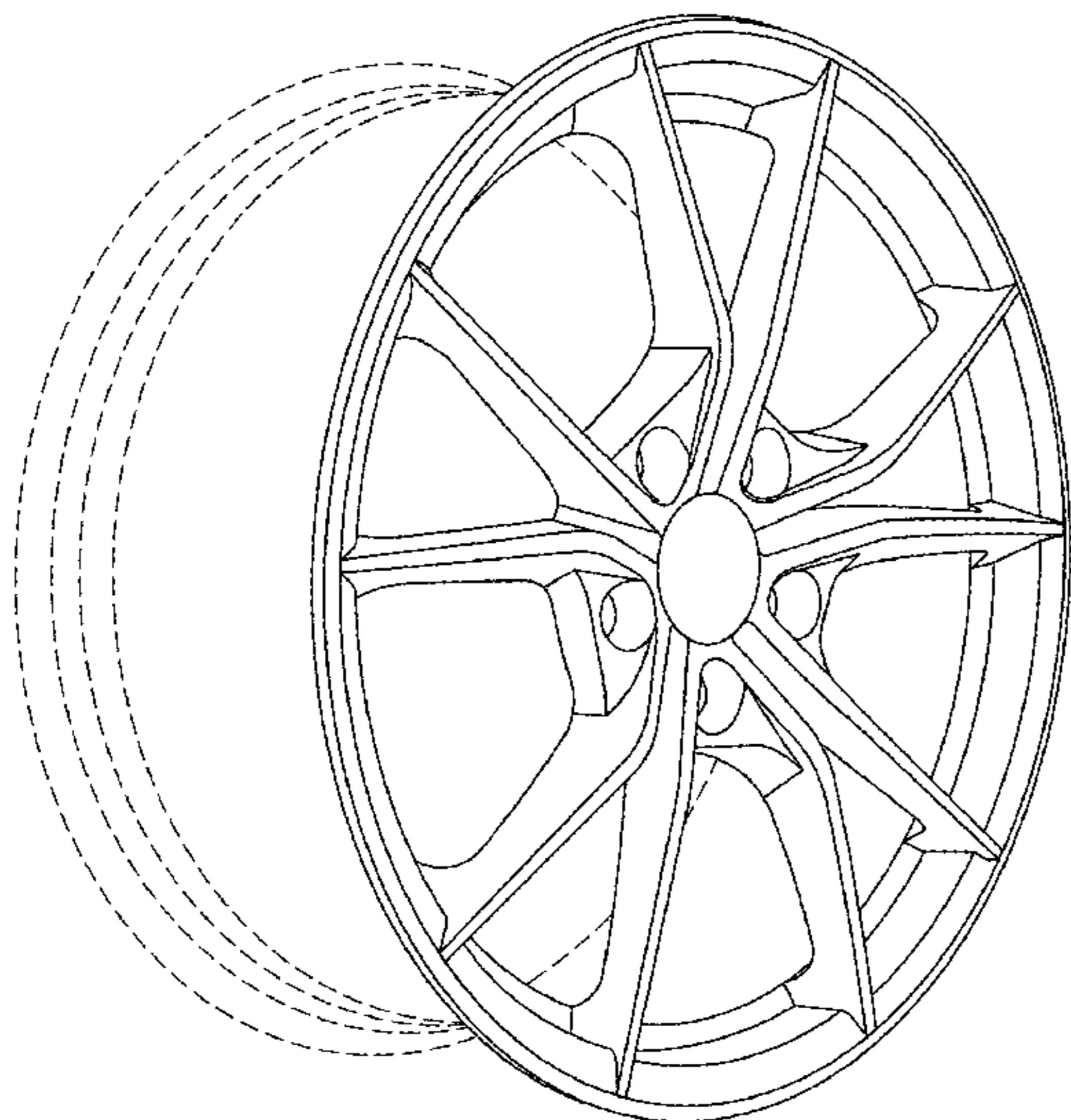
(57) **CLAIM**

The ornamental design of a wheel for a motor vehicle, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a wheel for a motor vehicle in accordance with my design;
FIG. 2 is a front elevational view of the wheel for a motor vehicle of FIG. 1;
FIG. 3 is a top plan view thereof;
FIG. 4 is a left side elevation view;
FIG. 5 is a right side elevation view;
FIG. 6 is a bottom plan view thereof; and,

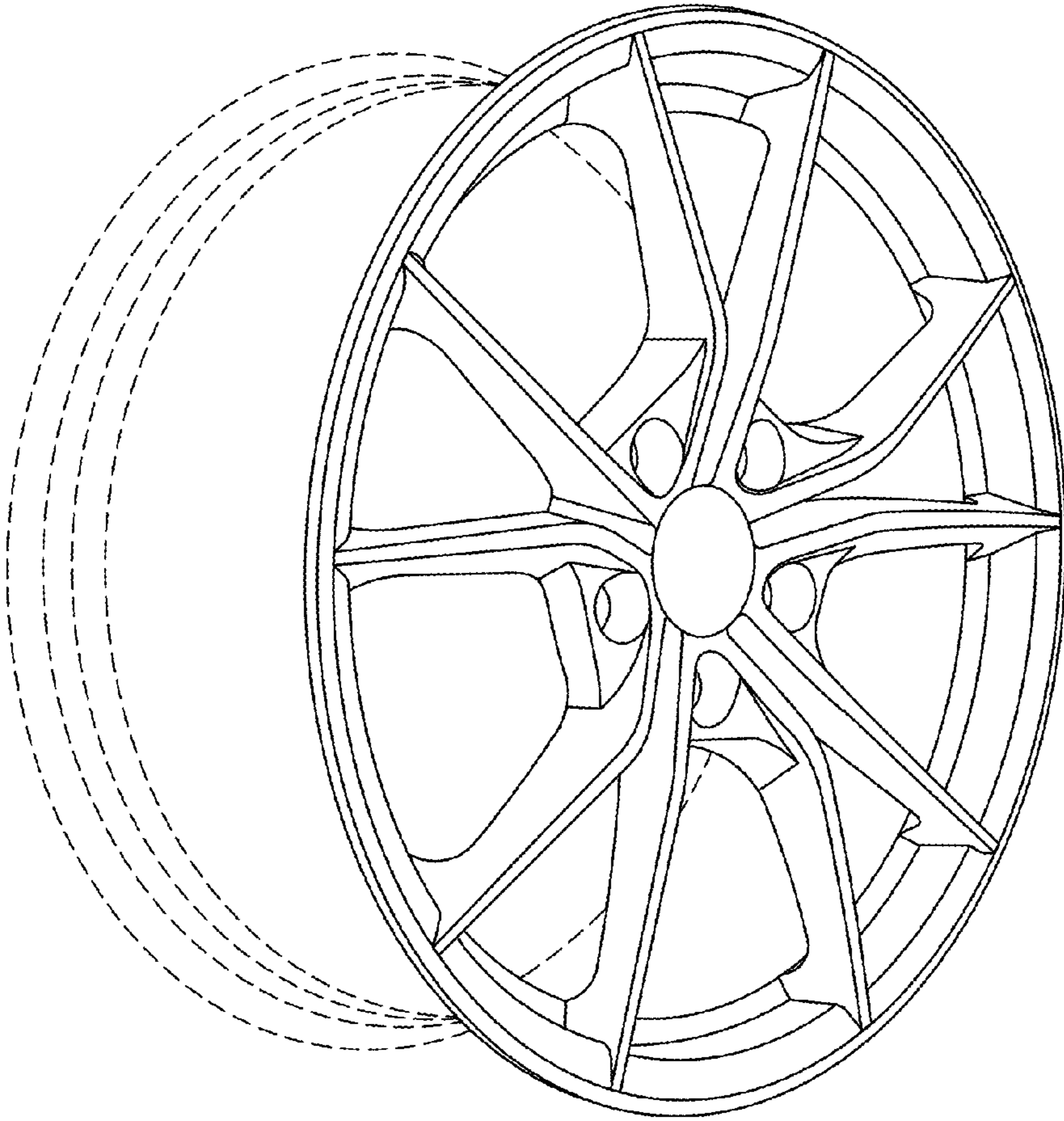

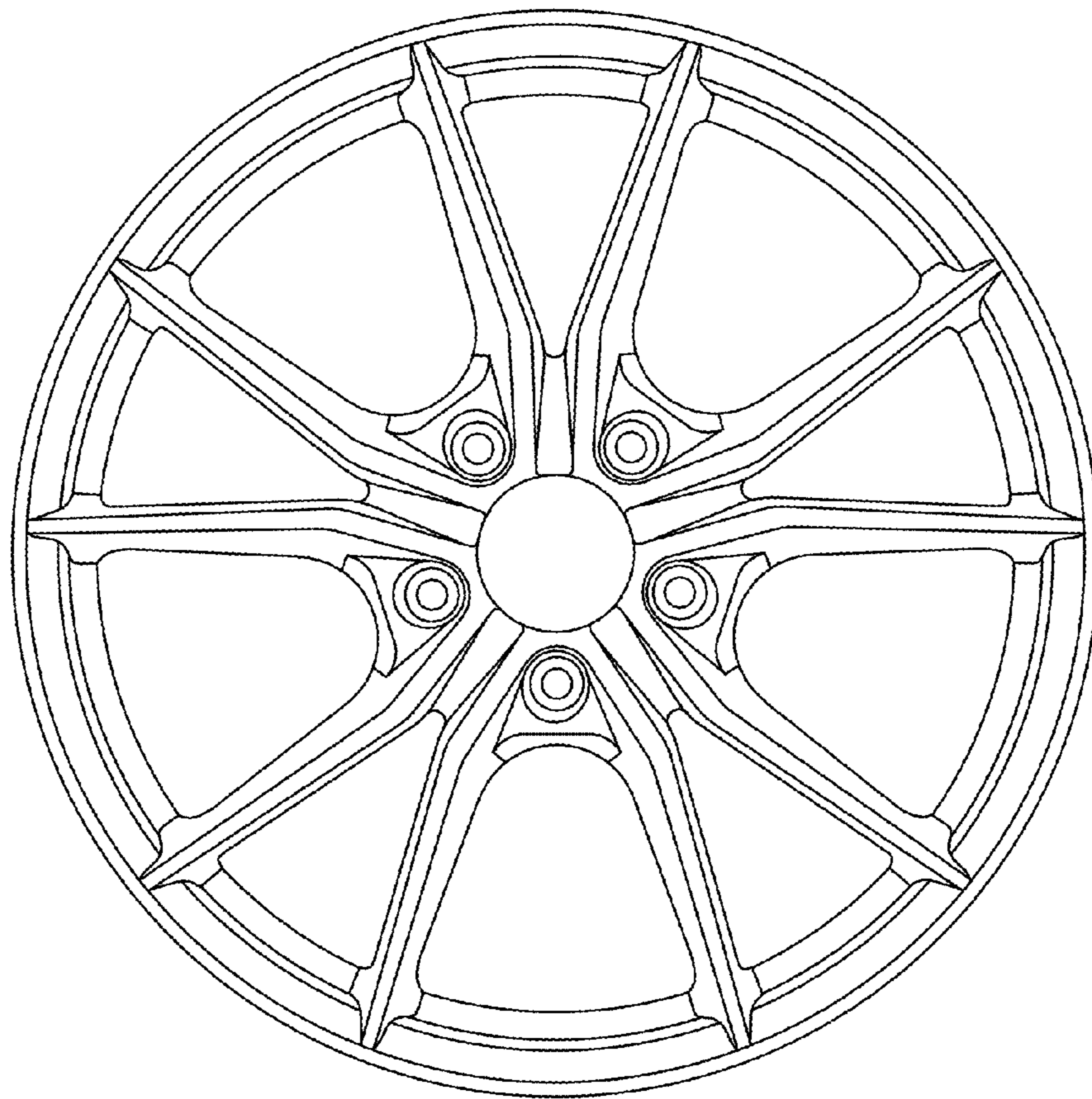

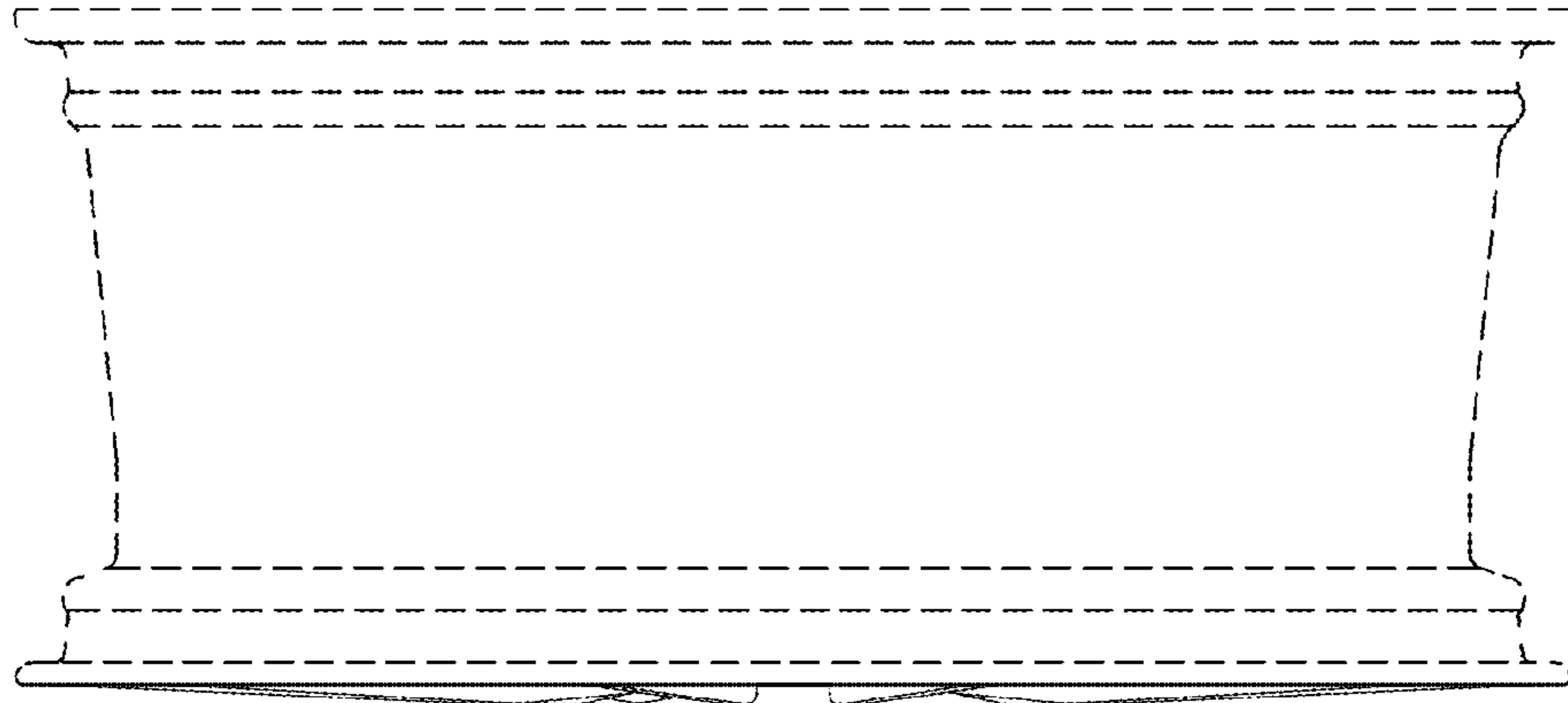

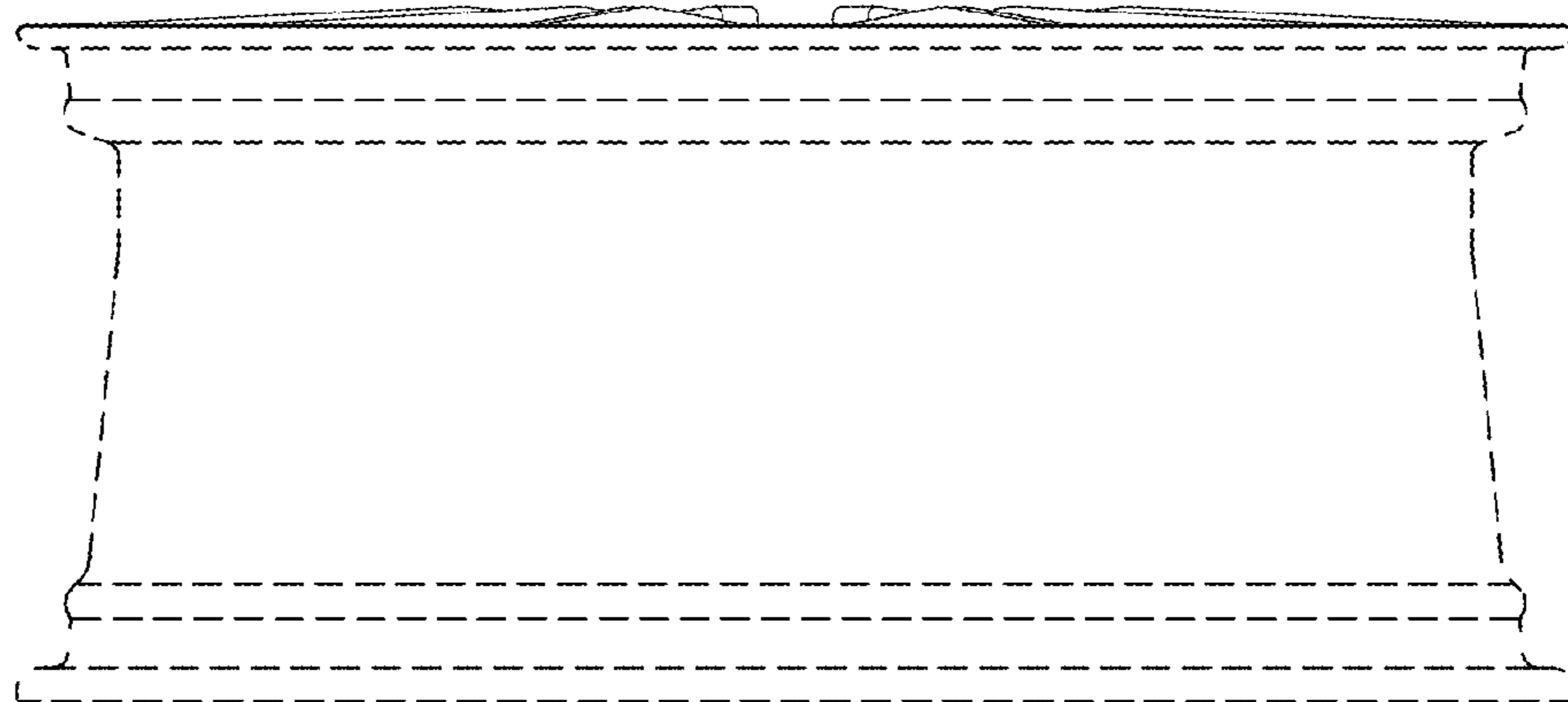

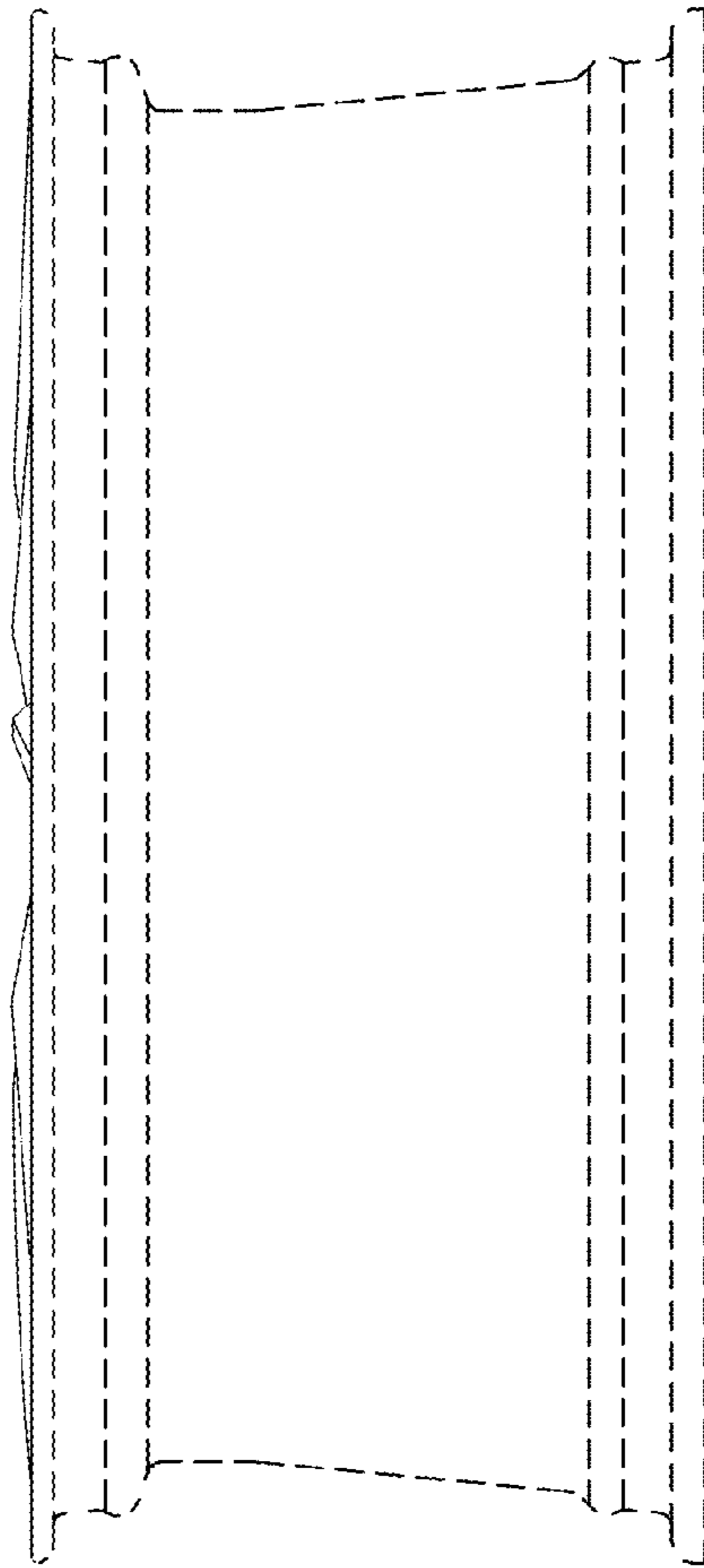

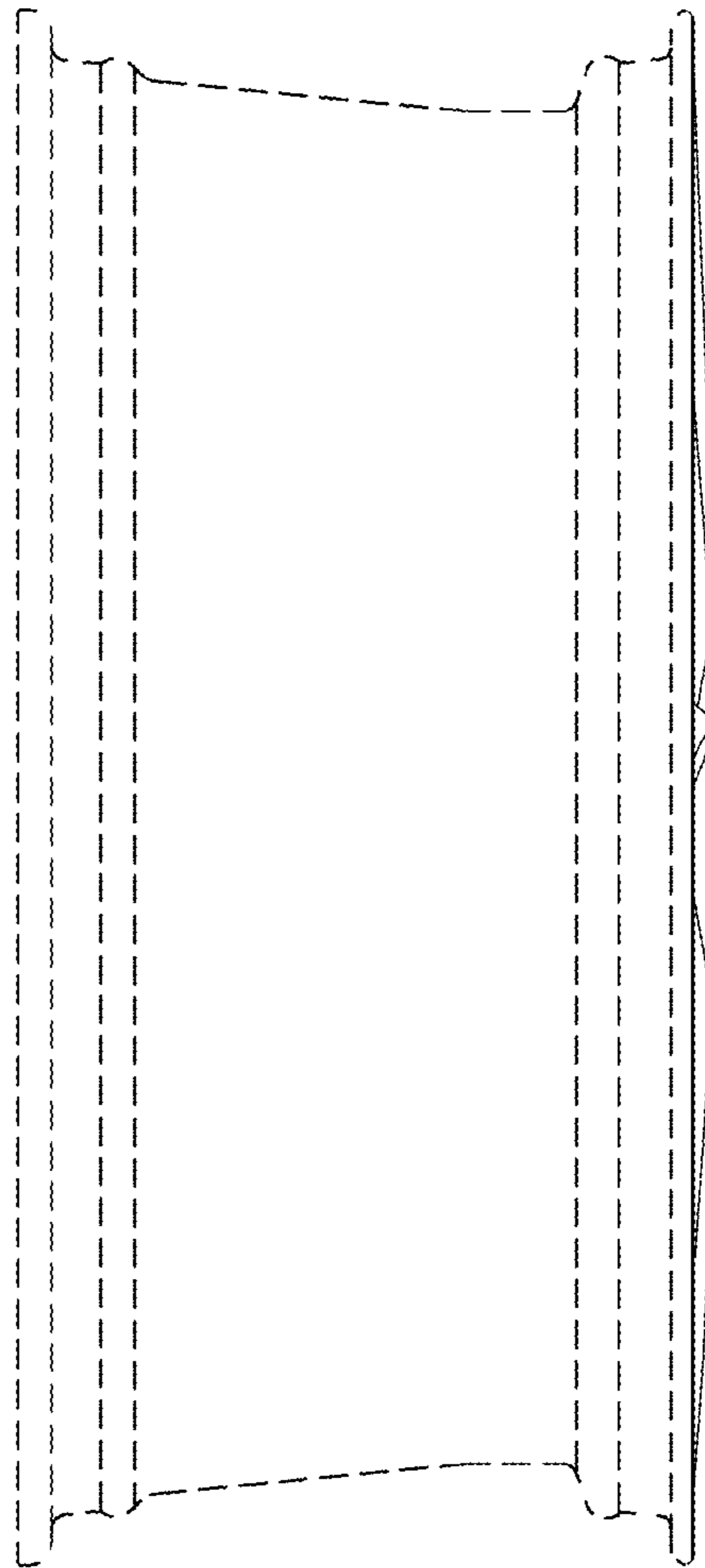

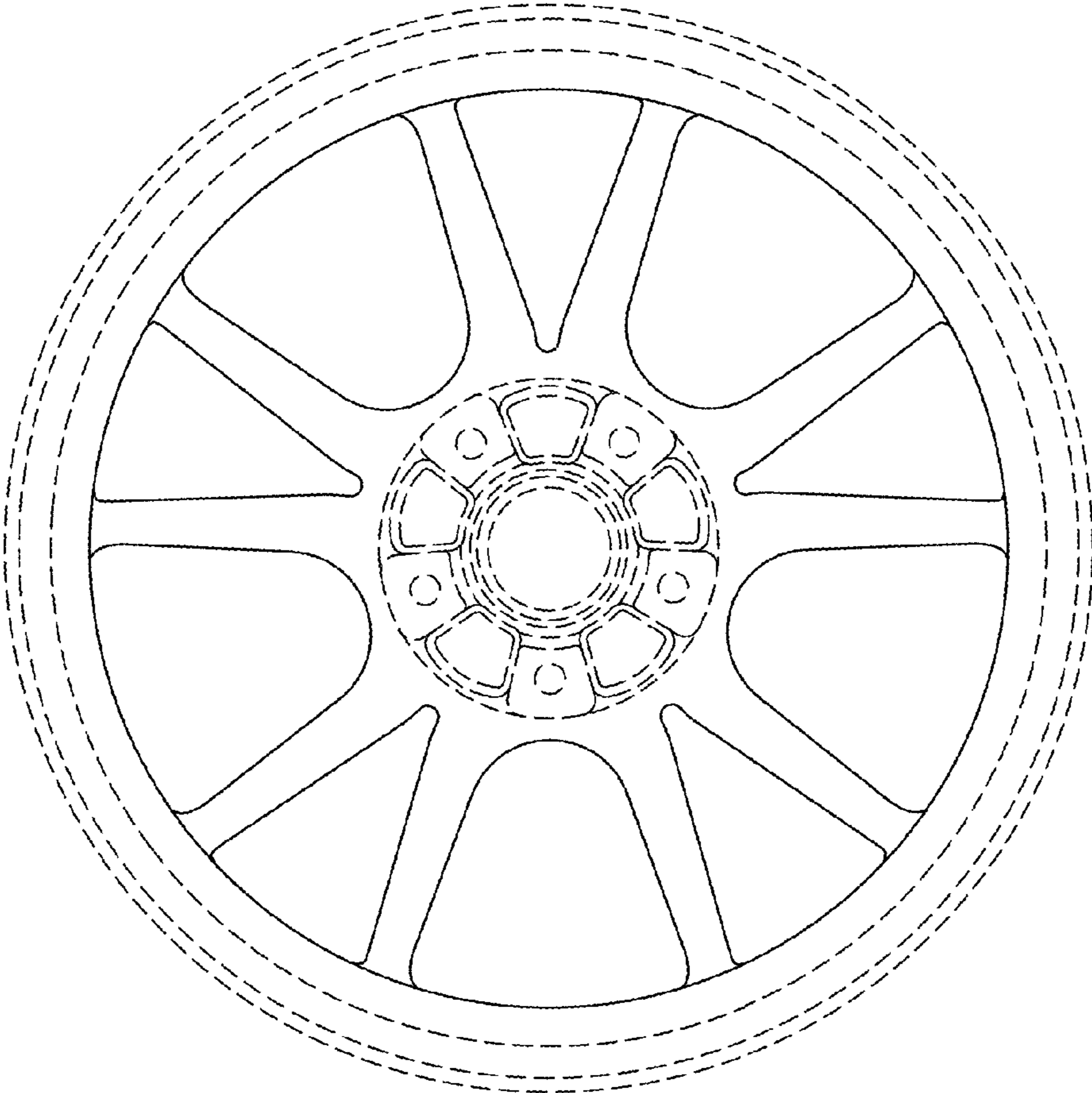
