FIG. 2 is a color front view thereof, in an on green state;

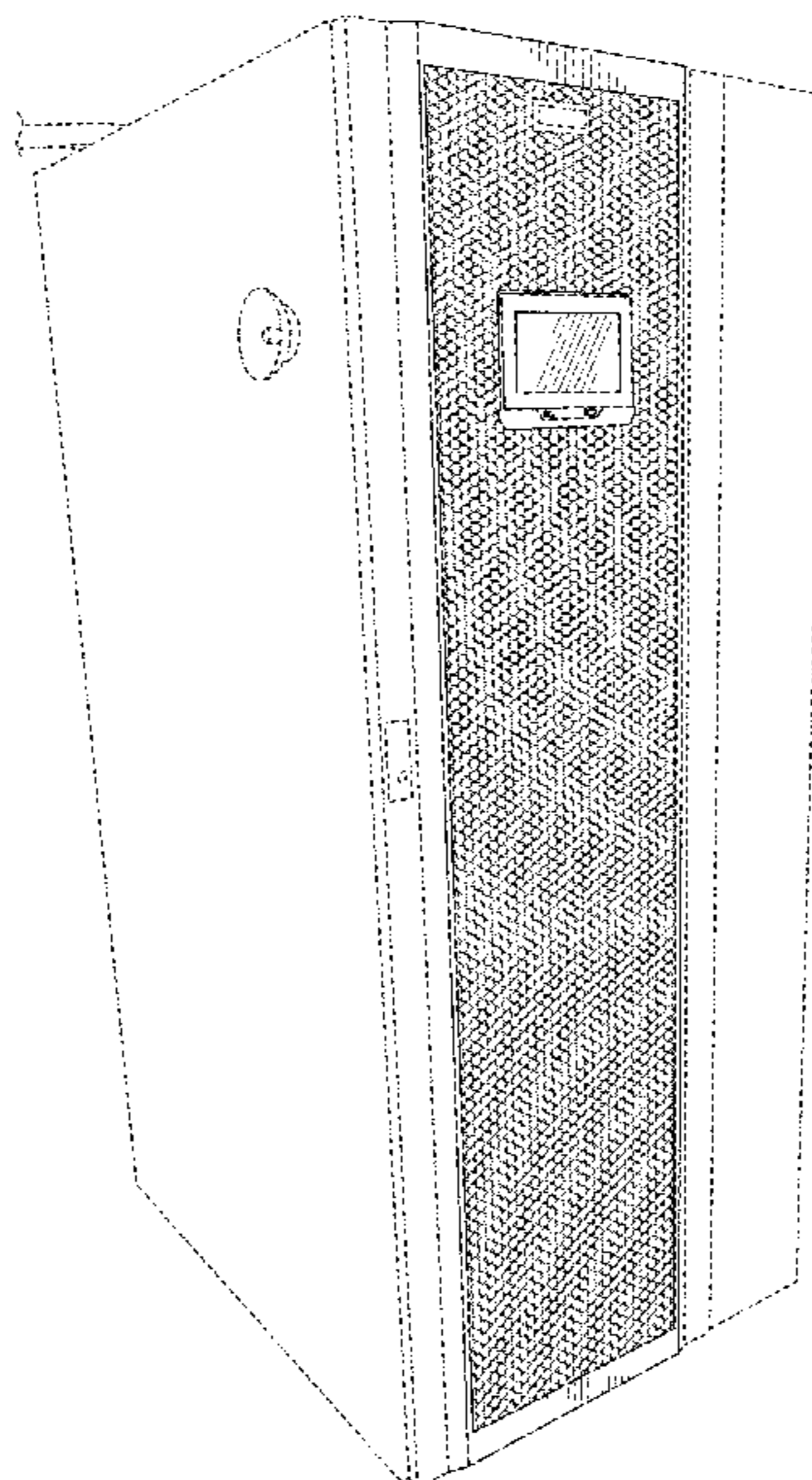
FIG. 3 is a color partial enlarged perspective view thereof, in an on red state;

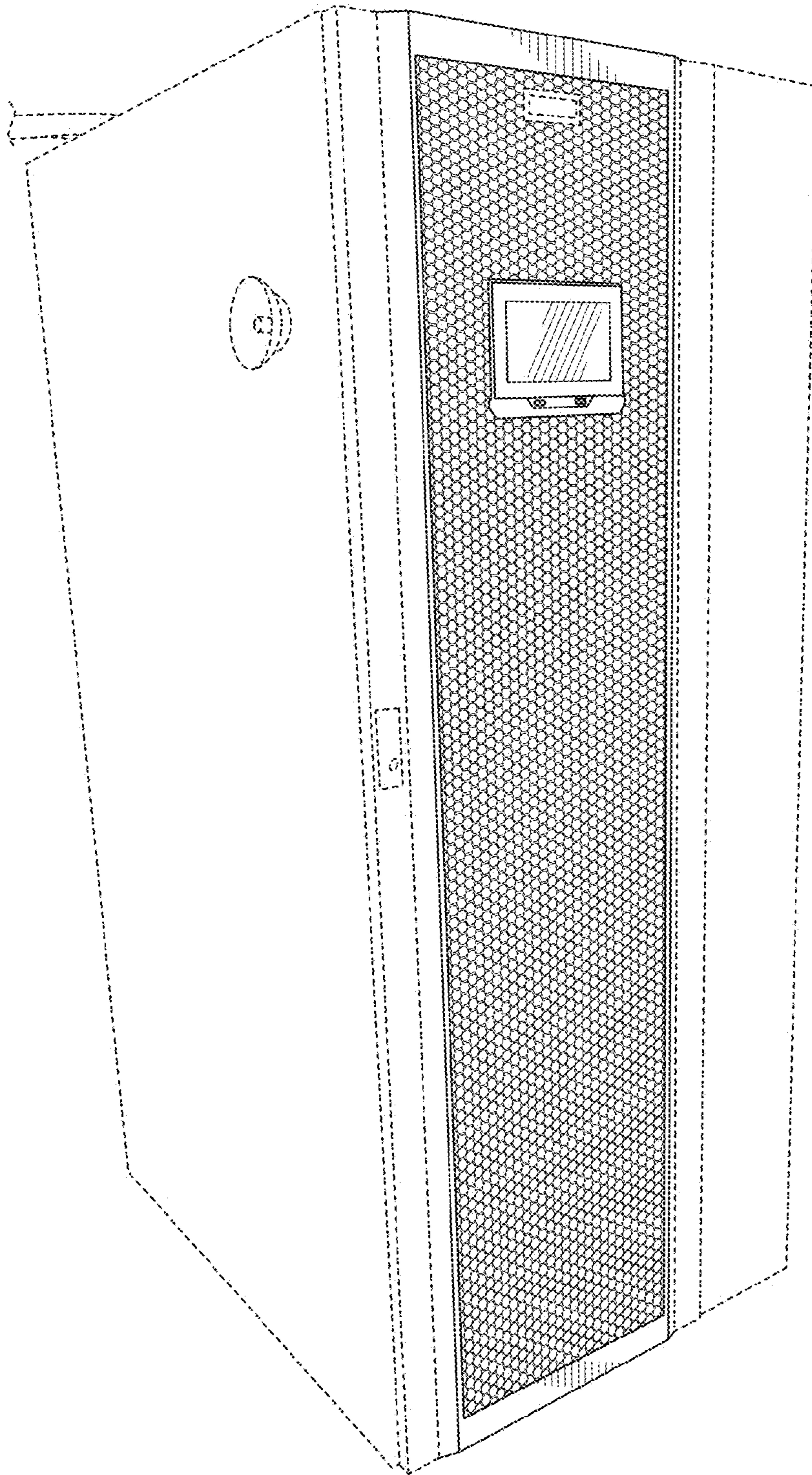

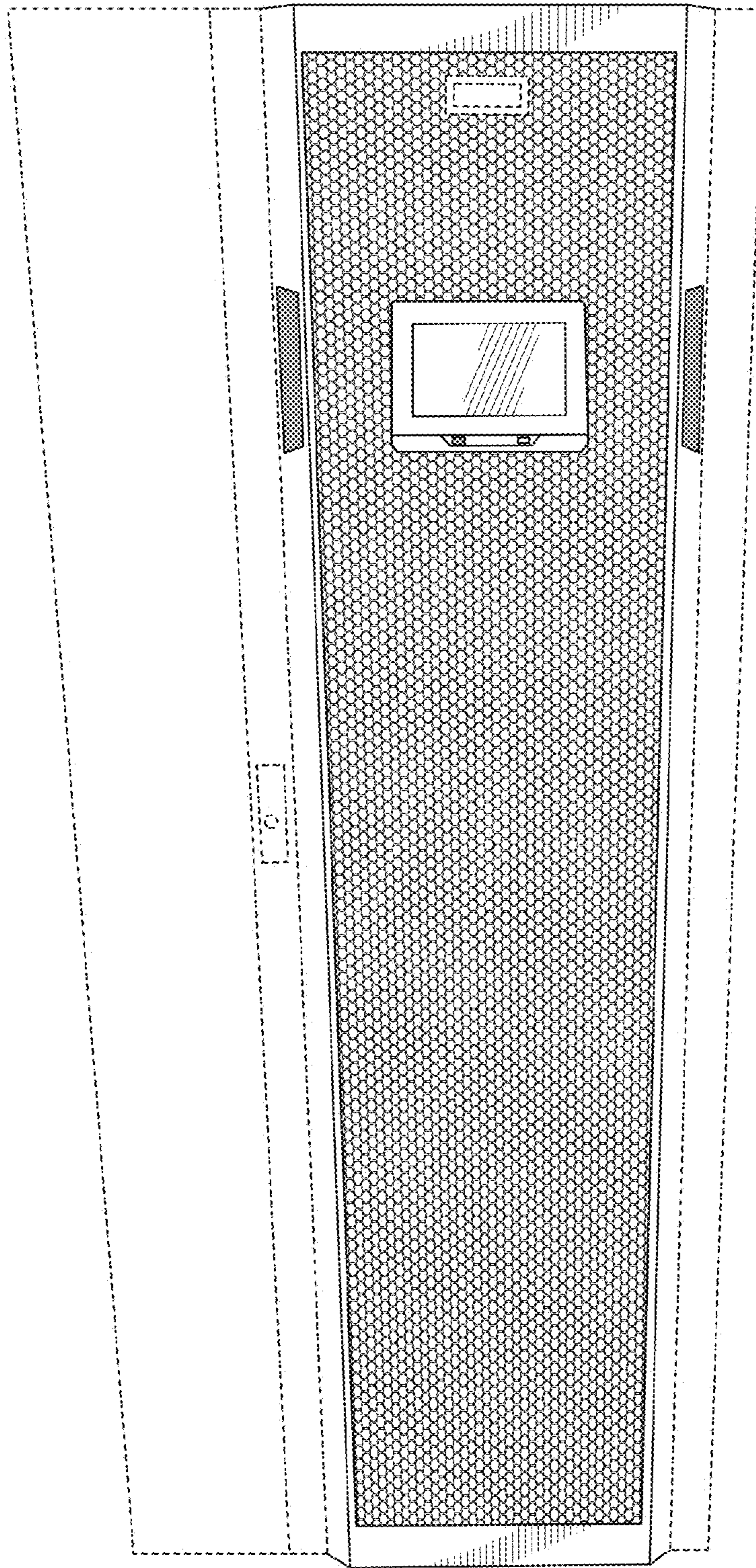

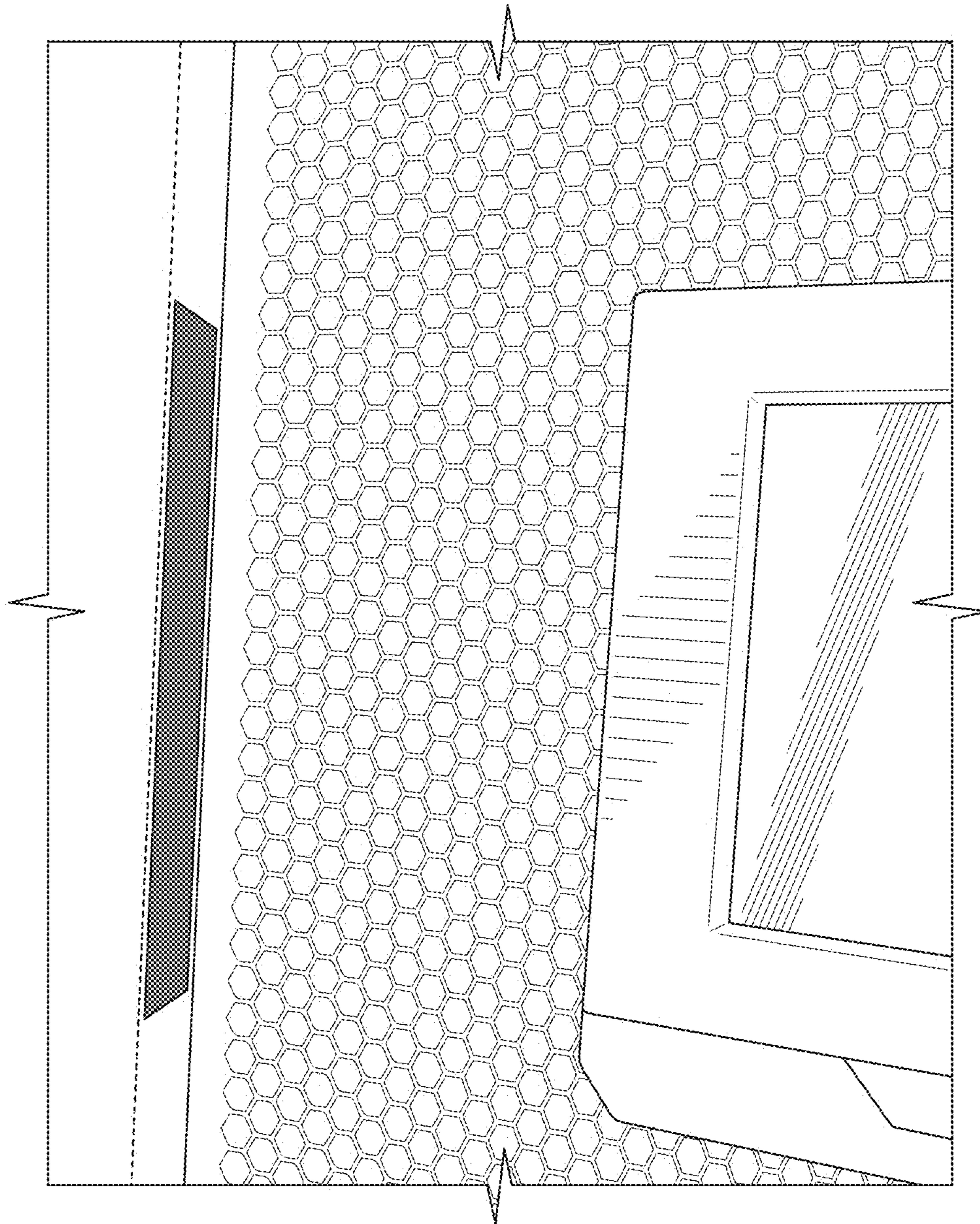

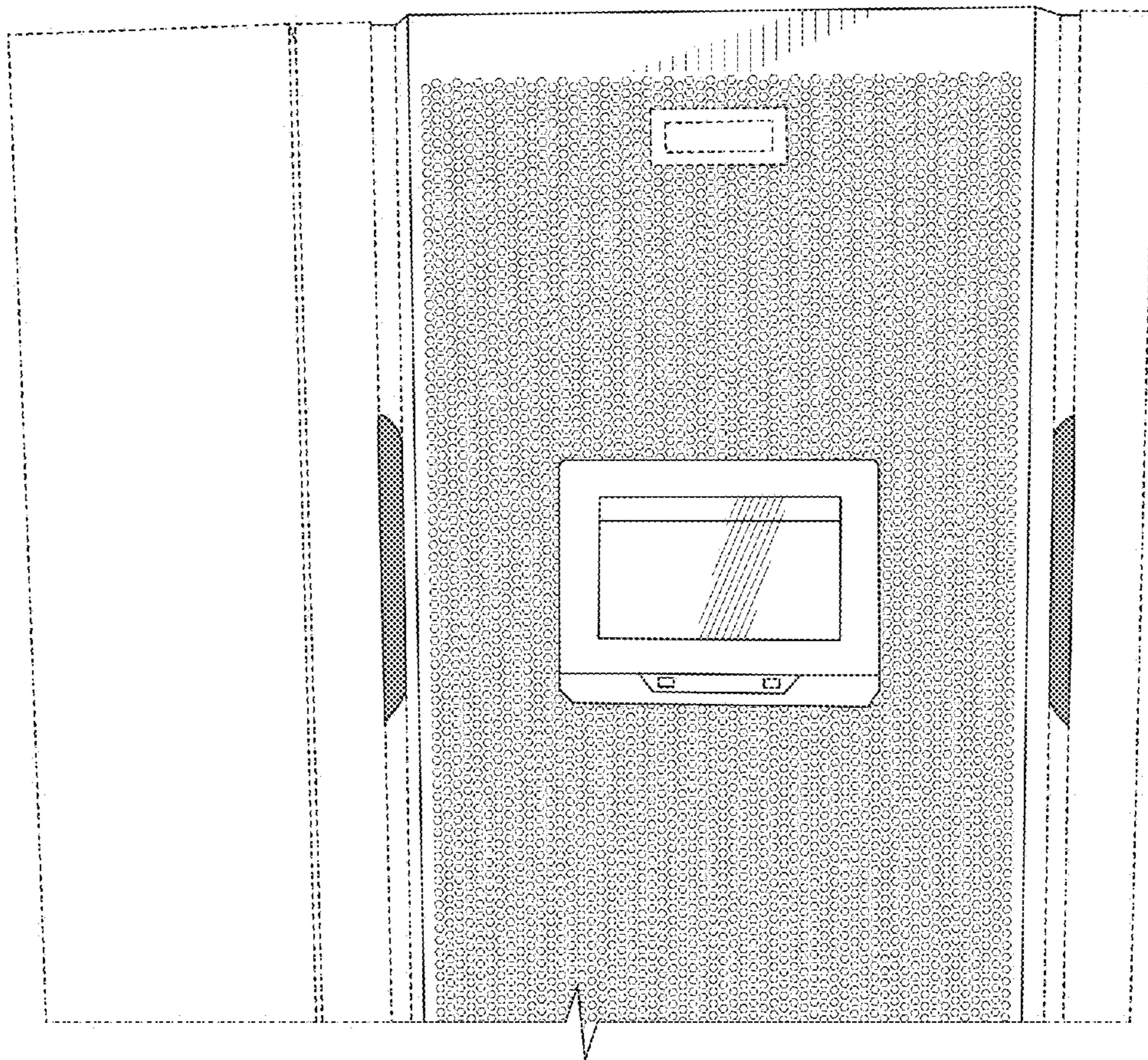

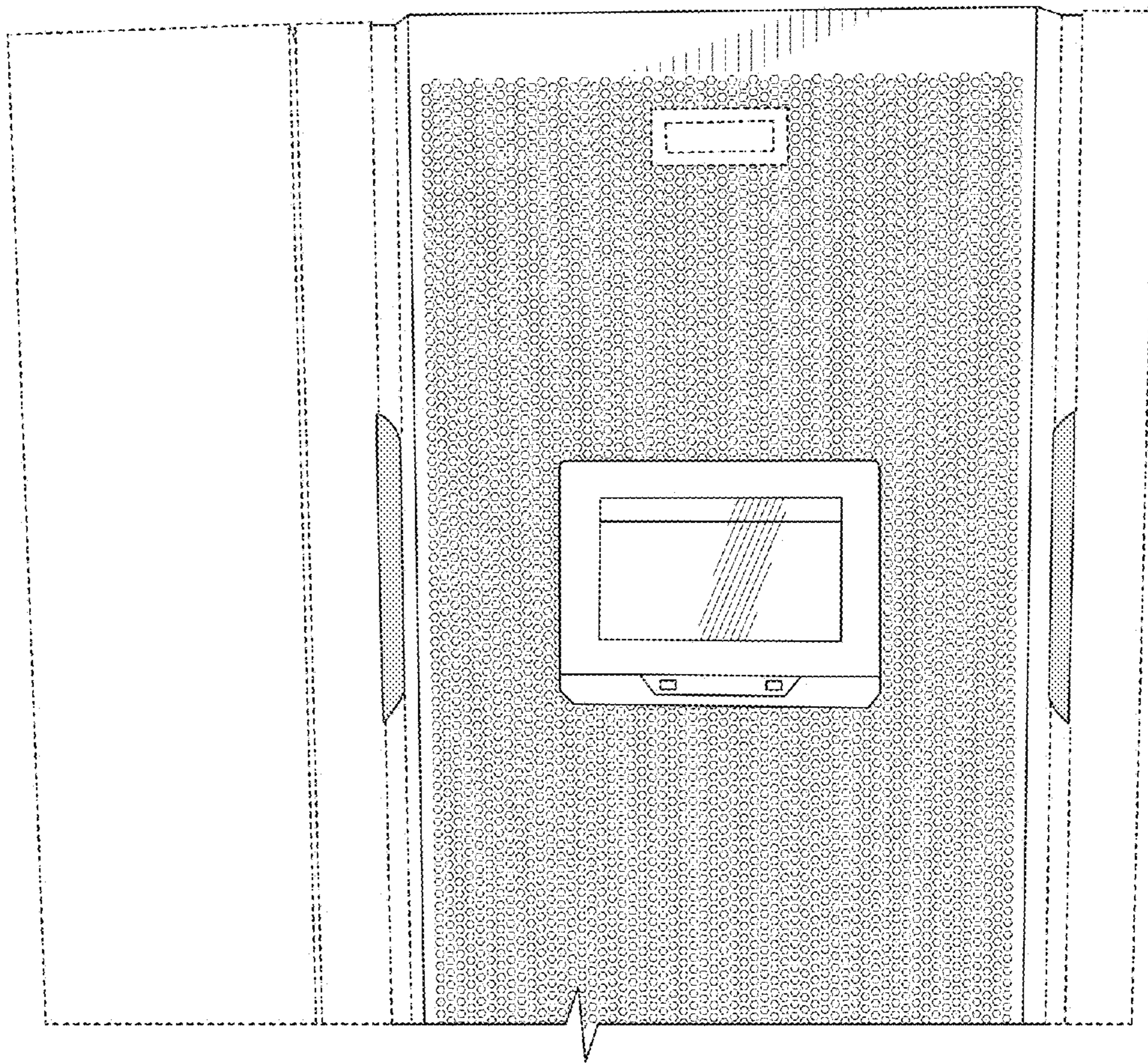
