(57) **CLAIM**

The ornamental design for a protective case and cover for a mobile display device, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a first embodiment of our protective case and cover for a mobile display device showing our new design;

FIG. 2 is a second perspective view thereof;

FIG. 3 is a third perspective thereof;

FIG. 4 is a top plan view thereof;

FIG. 5 is a right side elevational view thereof;

FIG. 6 is a bottom plan view thereof; and

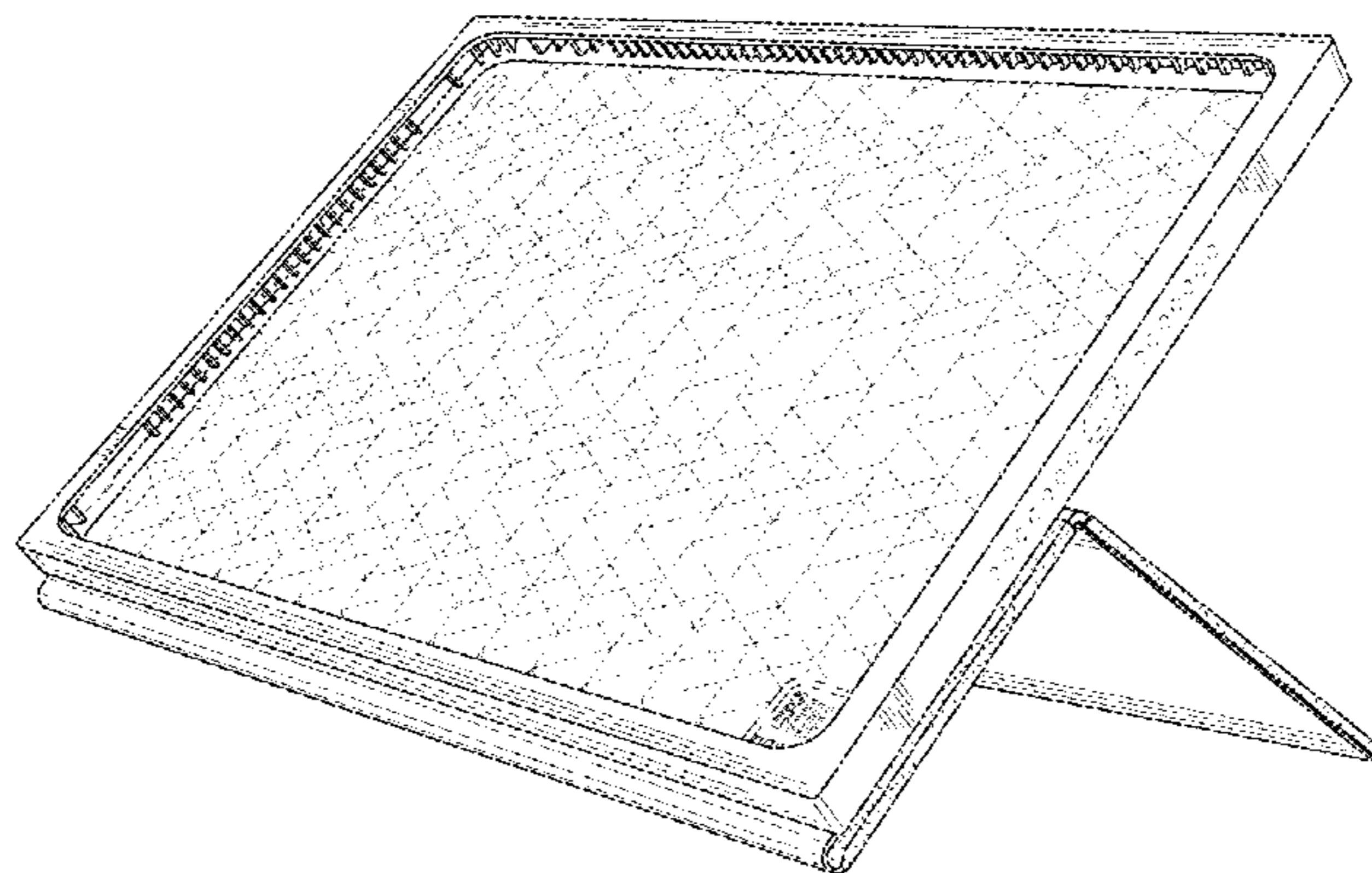
FIG. 7 is a back side elevational view thereof.

FIG. 8 is a perspective view of our protective case and cover for a mobile display device showing a front side of our new design in an open configuration; and,

FIG. 9 is a second perspective view thereof showing the backside.

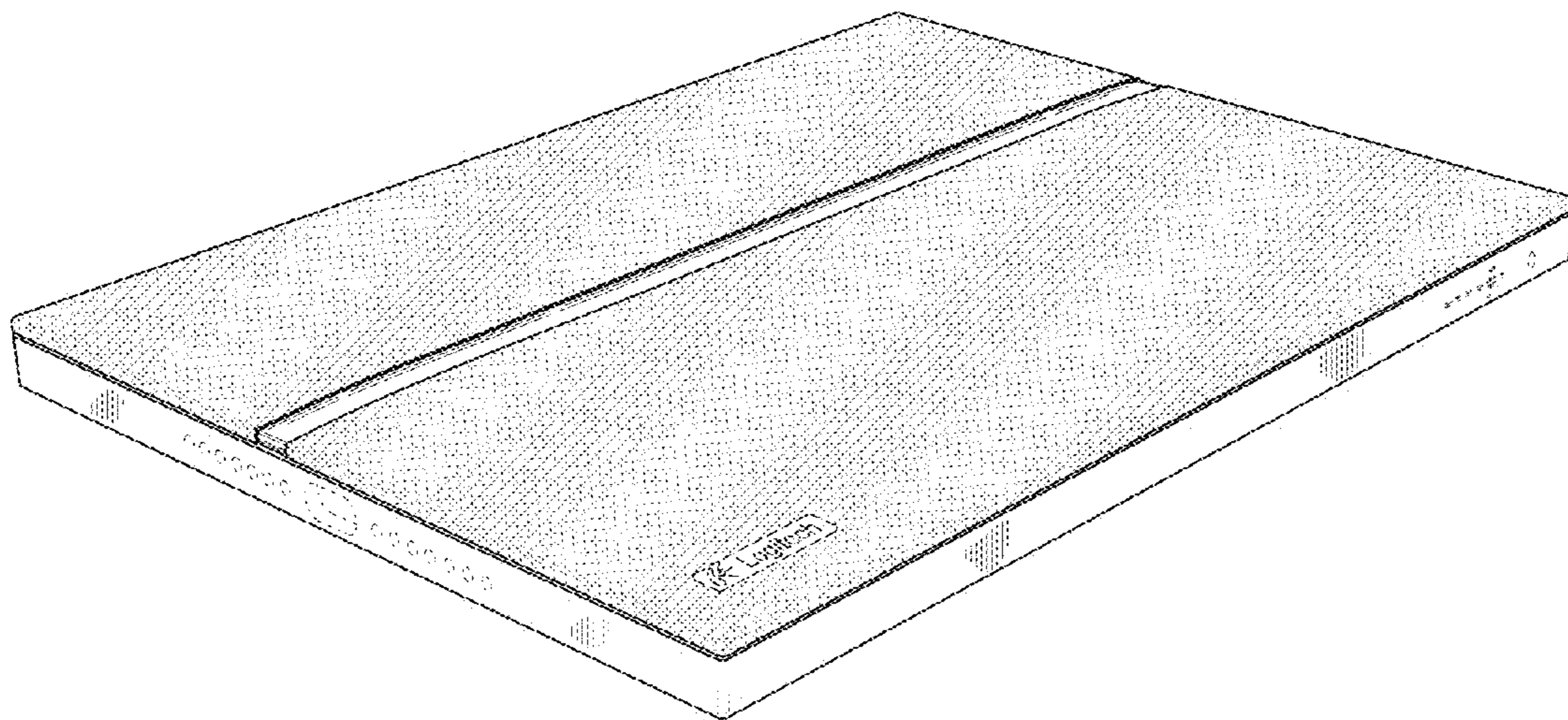

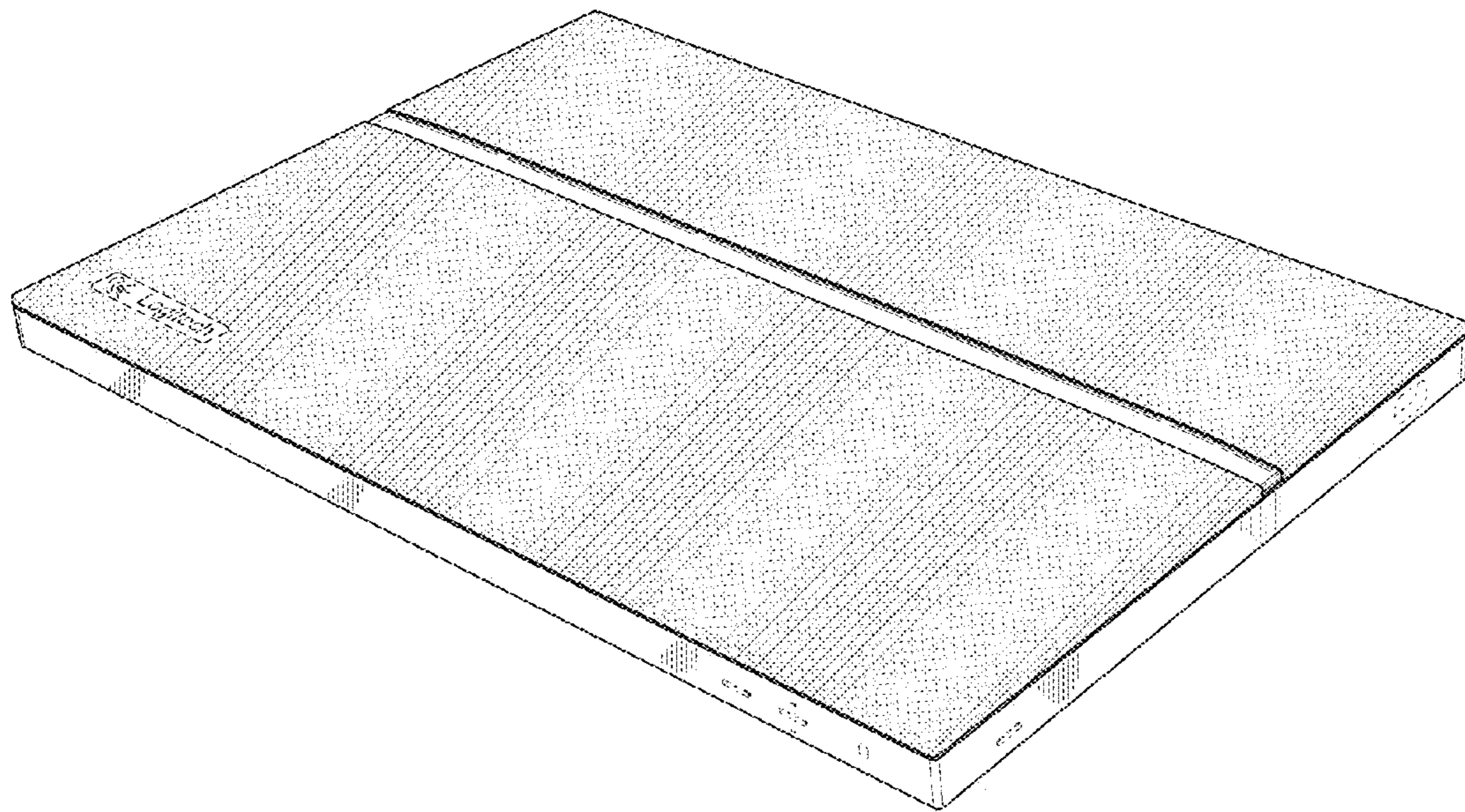

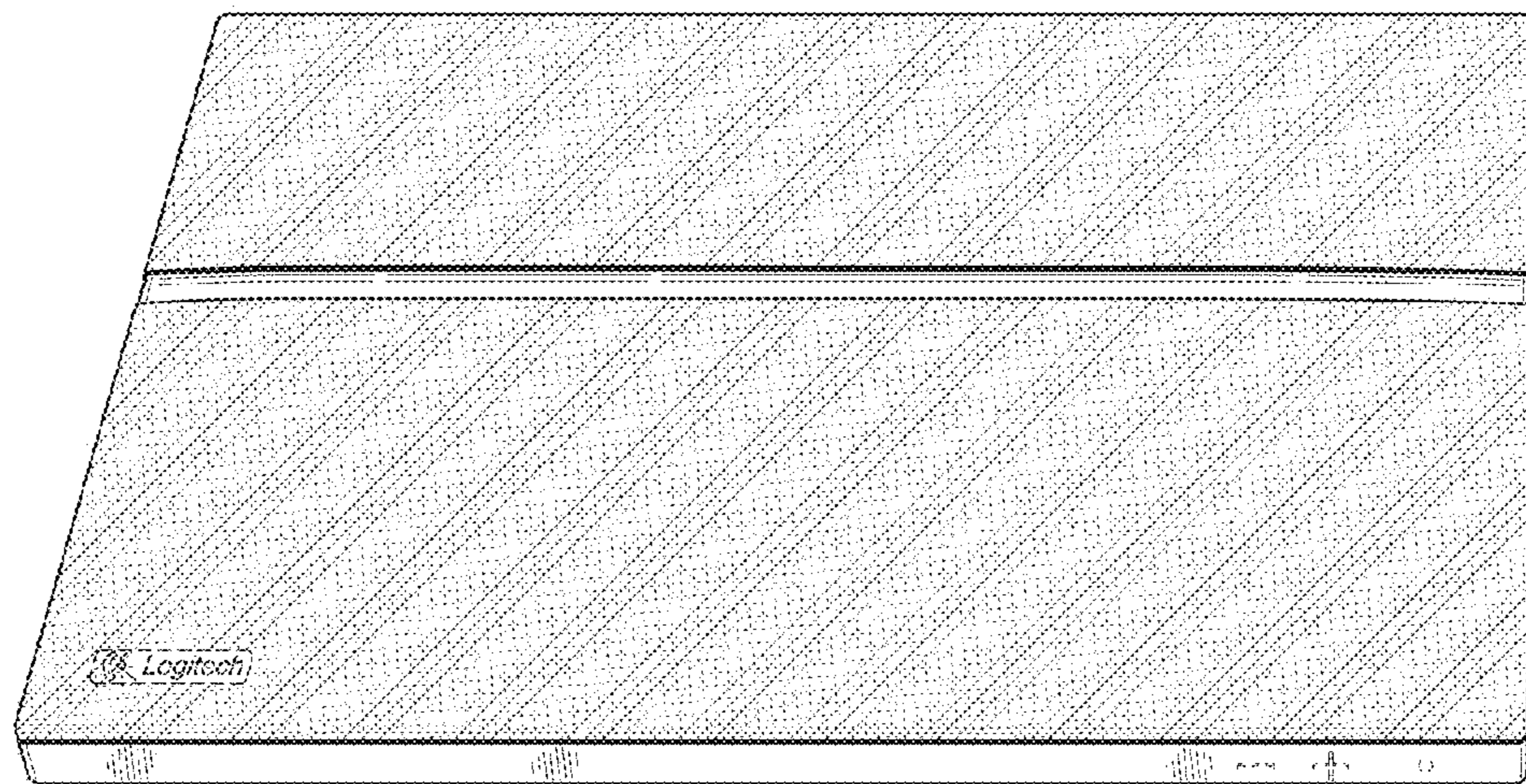

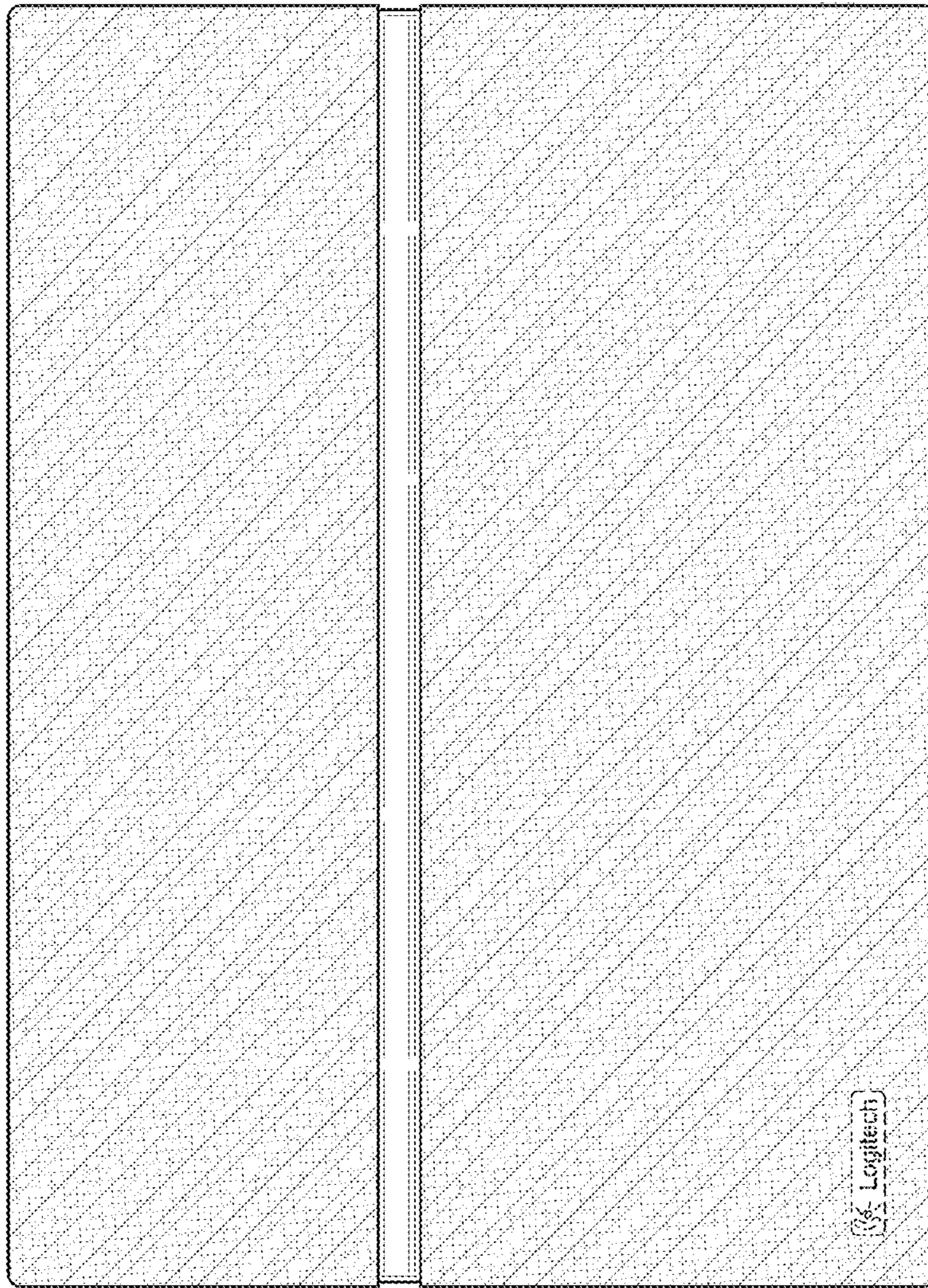

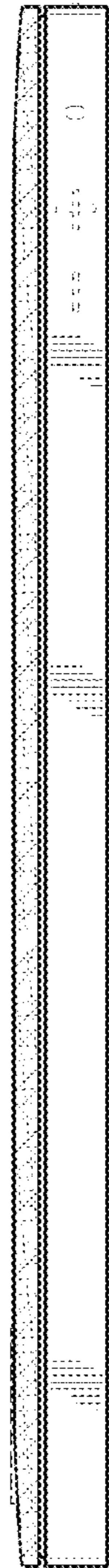

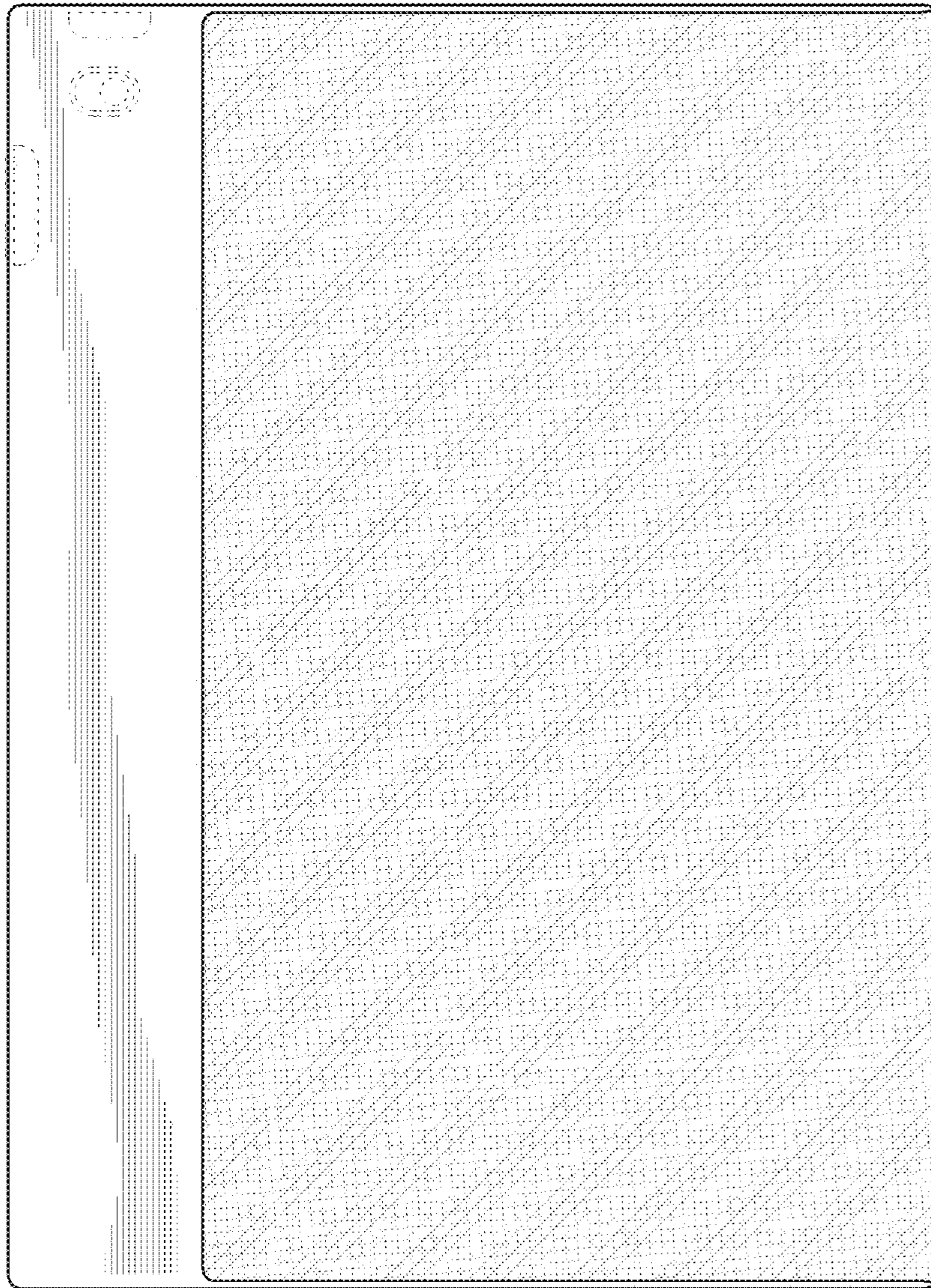

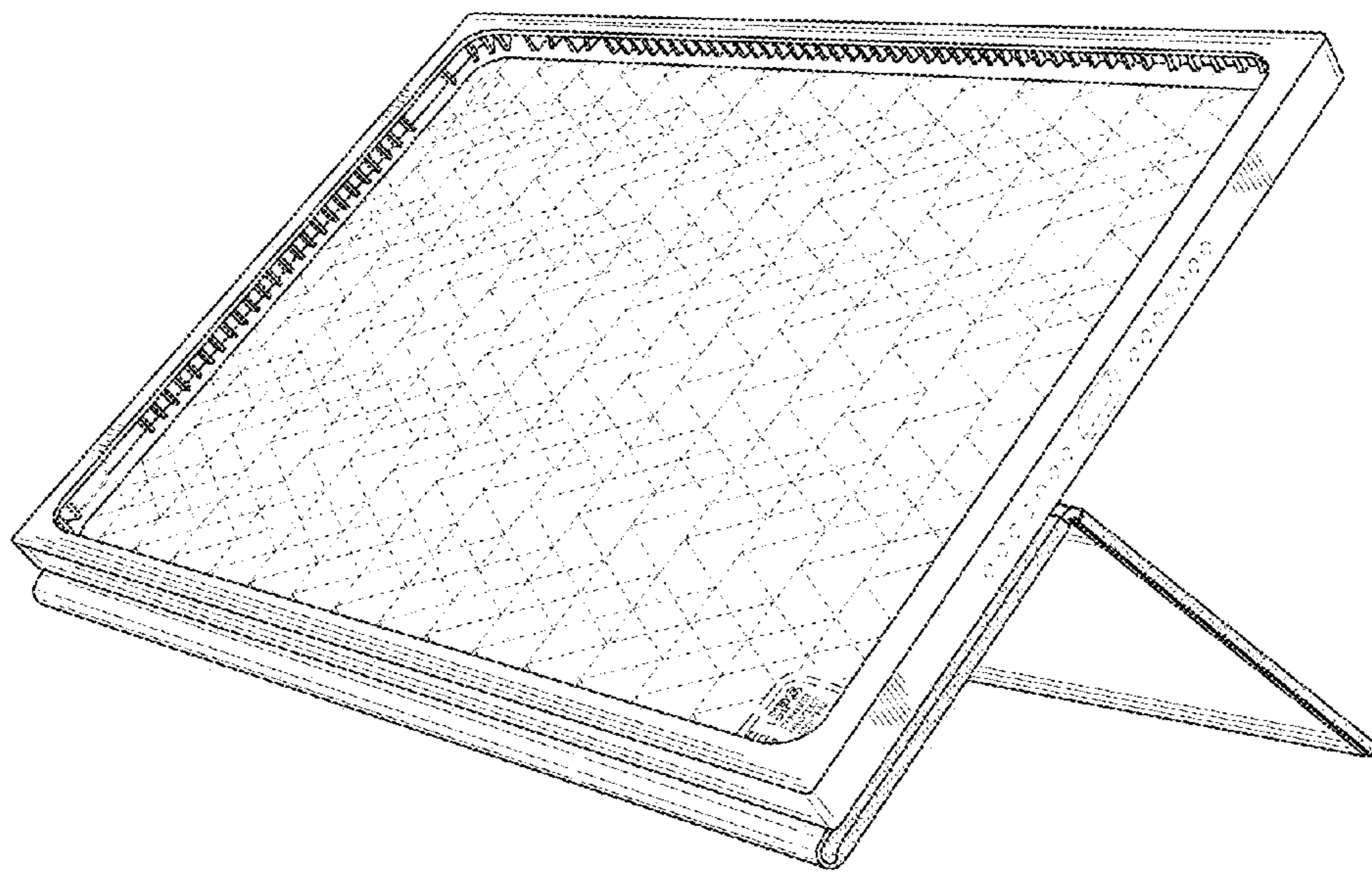

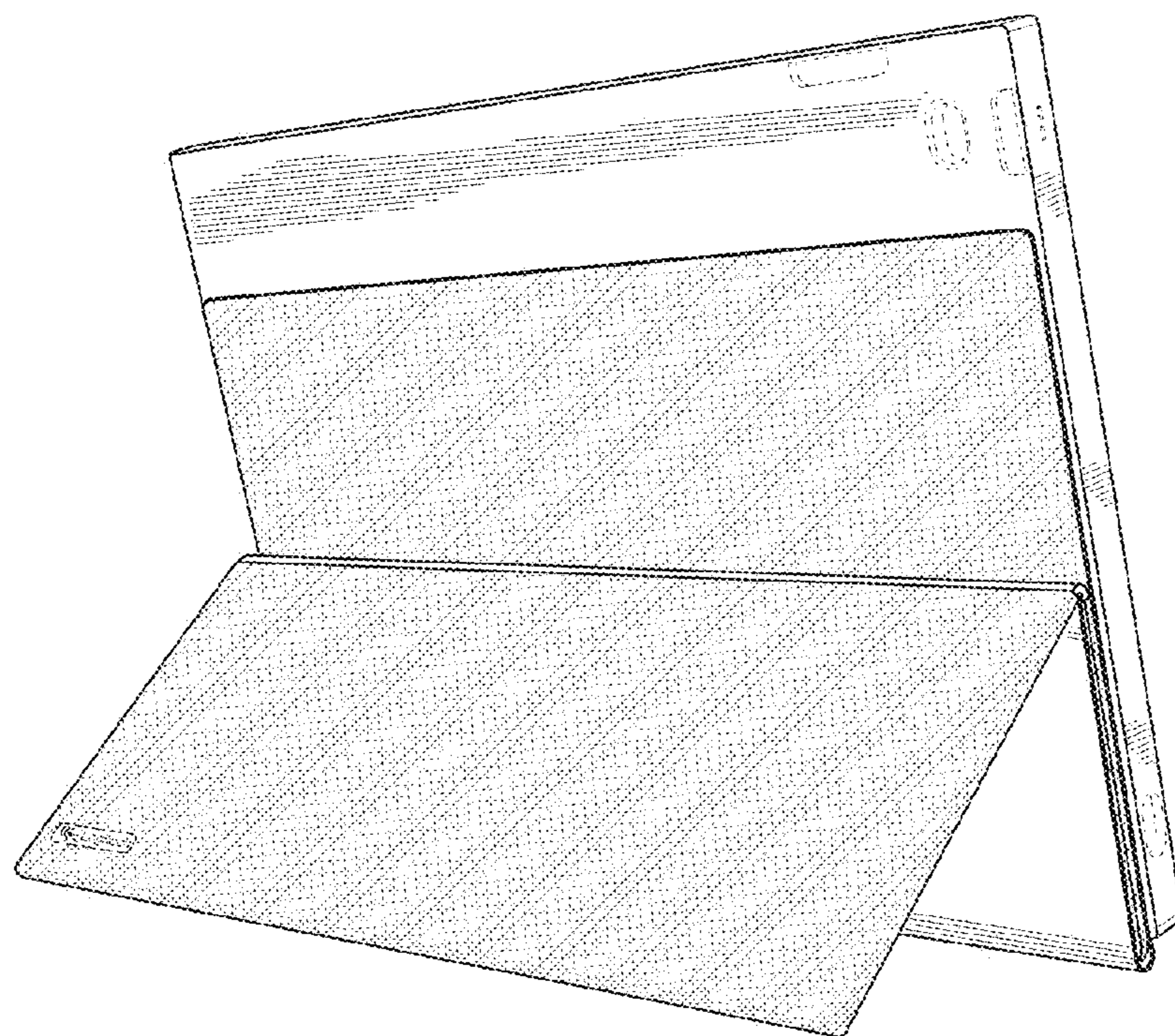
