FIG. 8 is a top plan view of the tablet case with an unclaimed tablet shown in broken lines within the case.

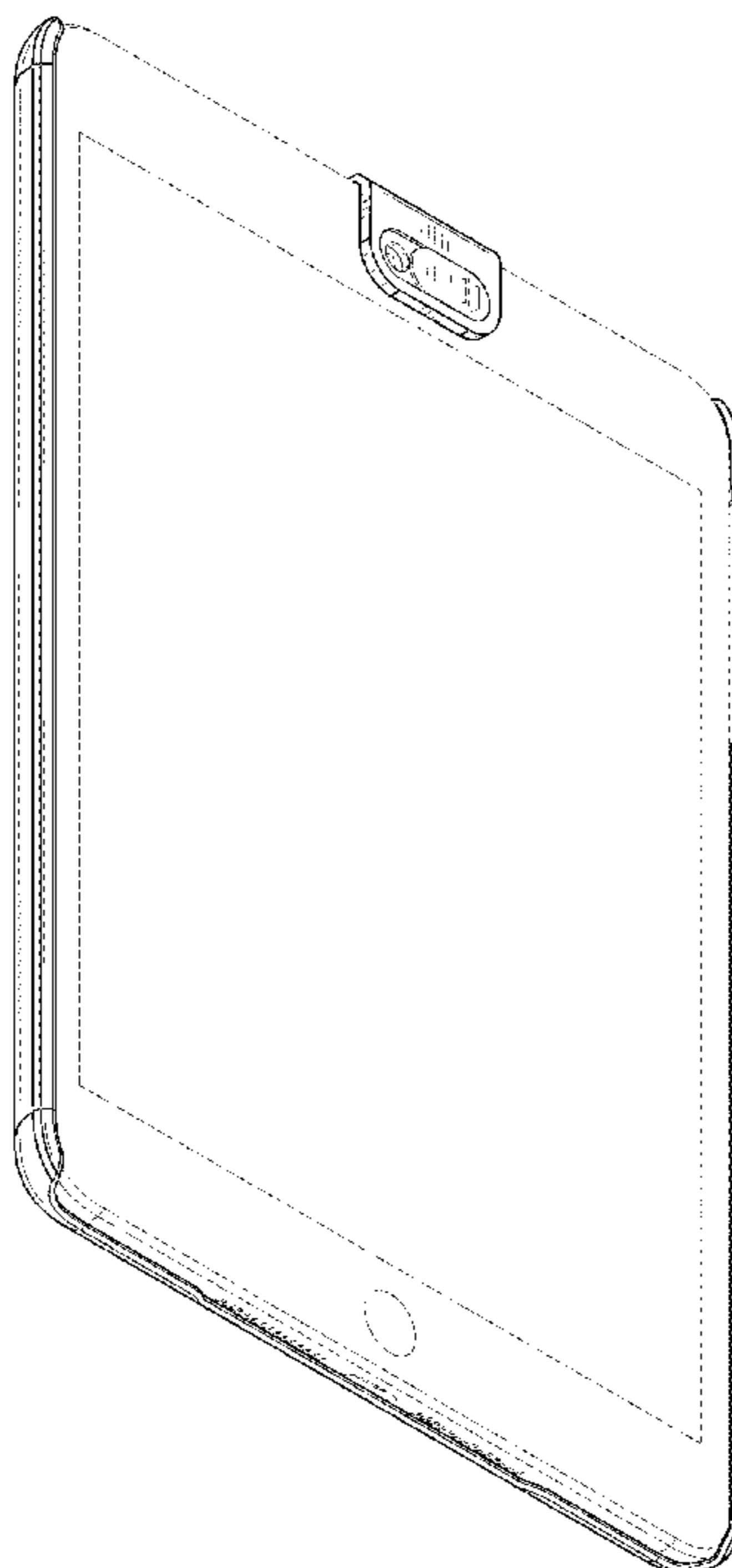

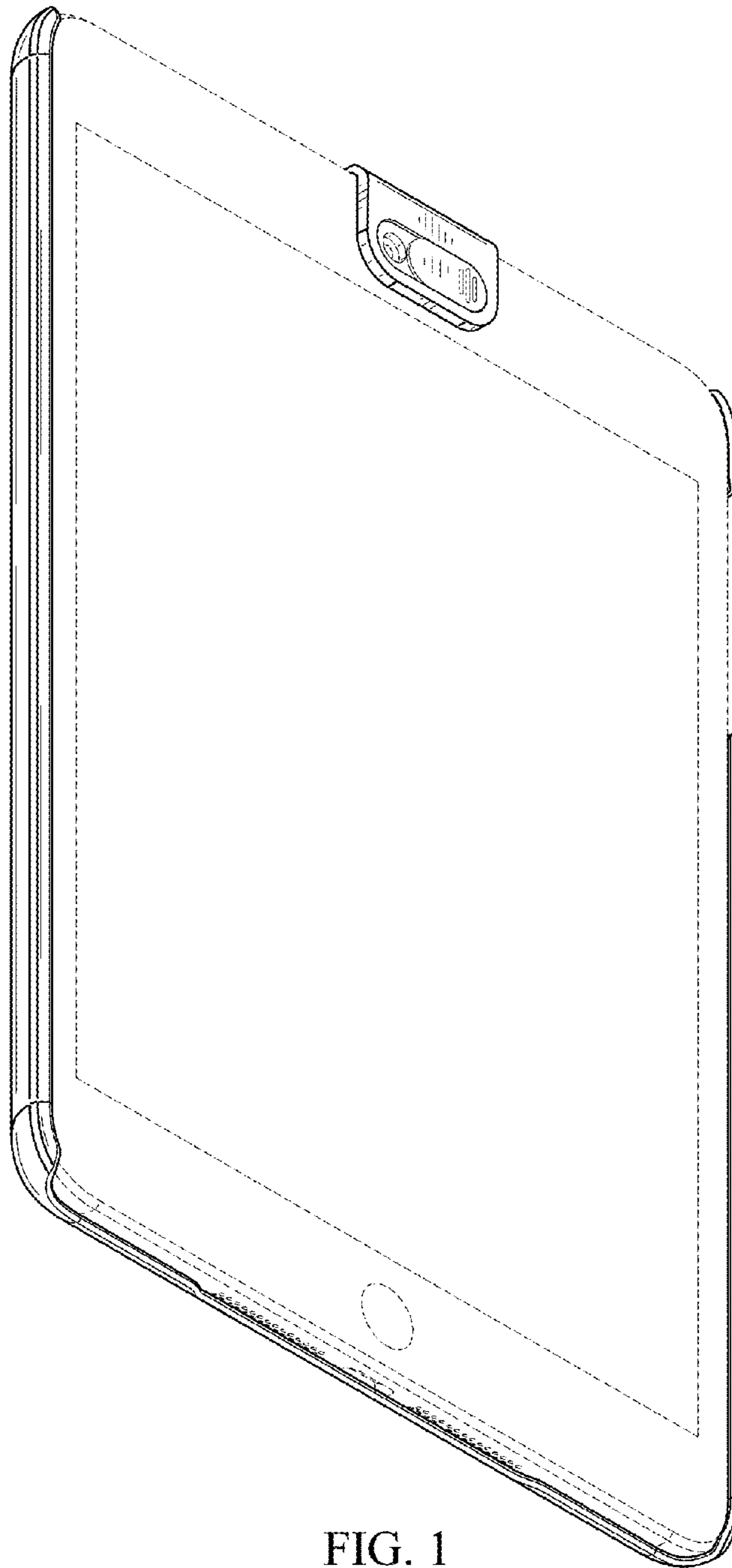

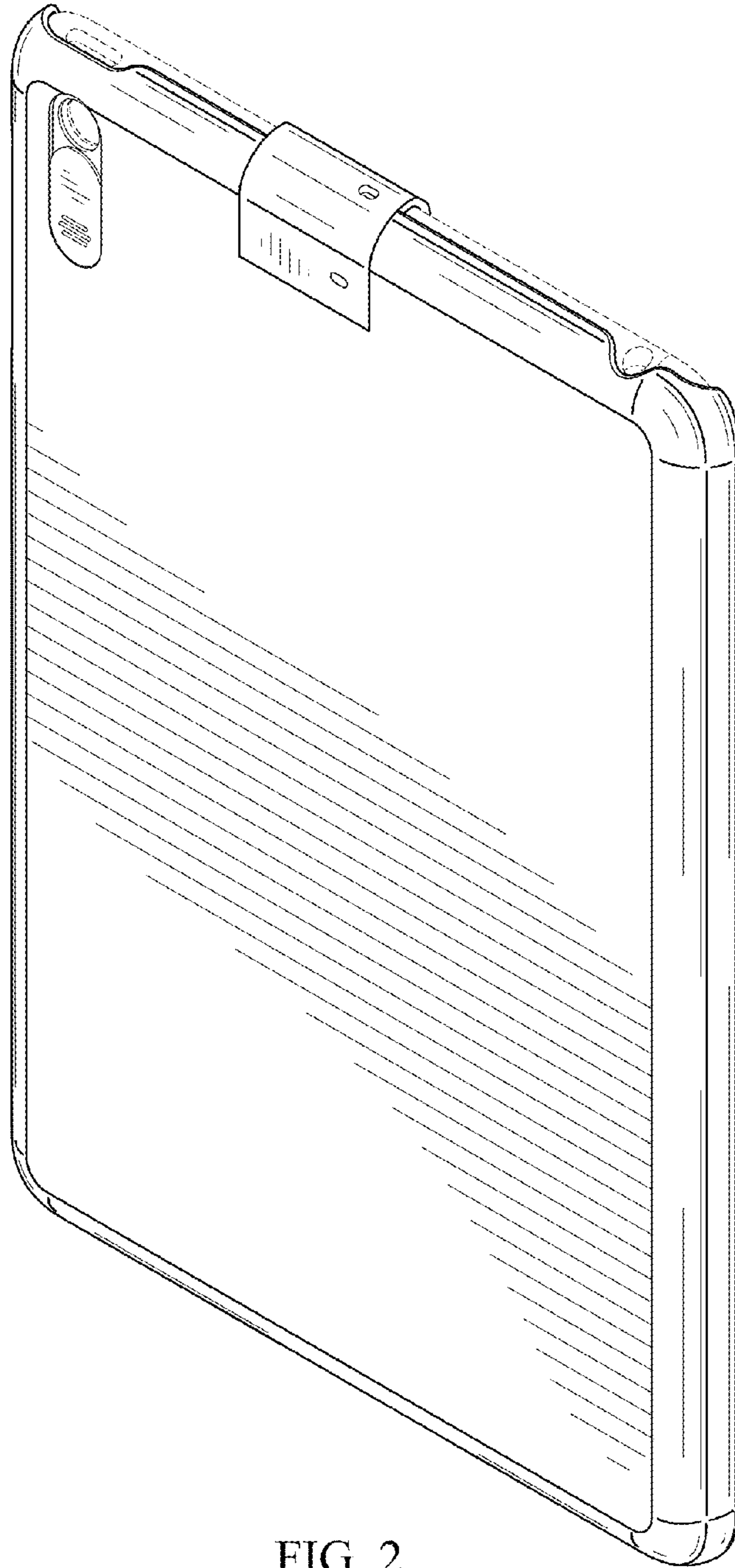

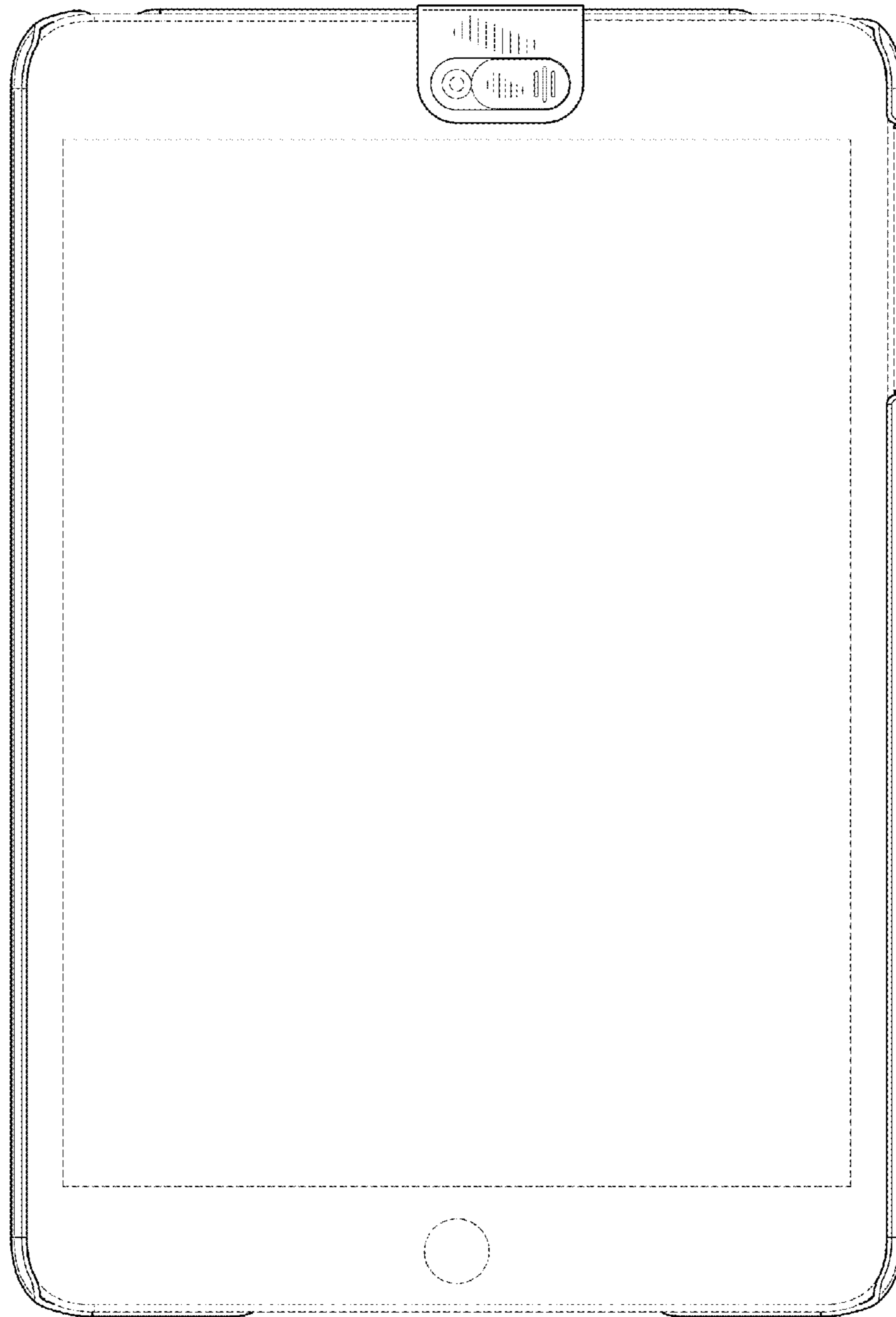

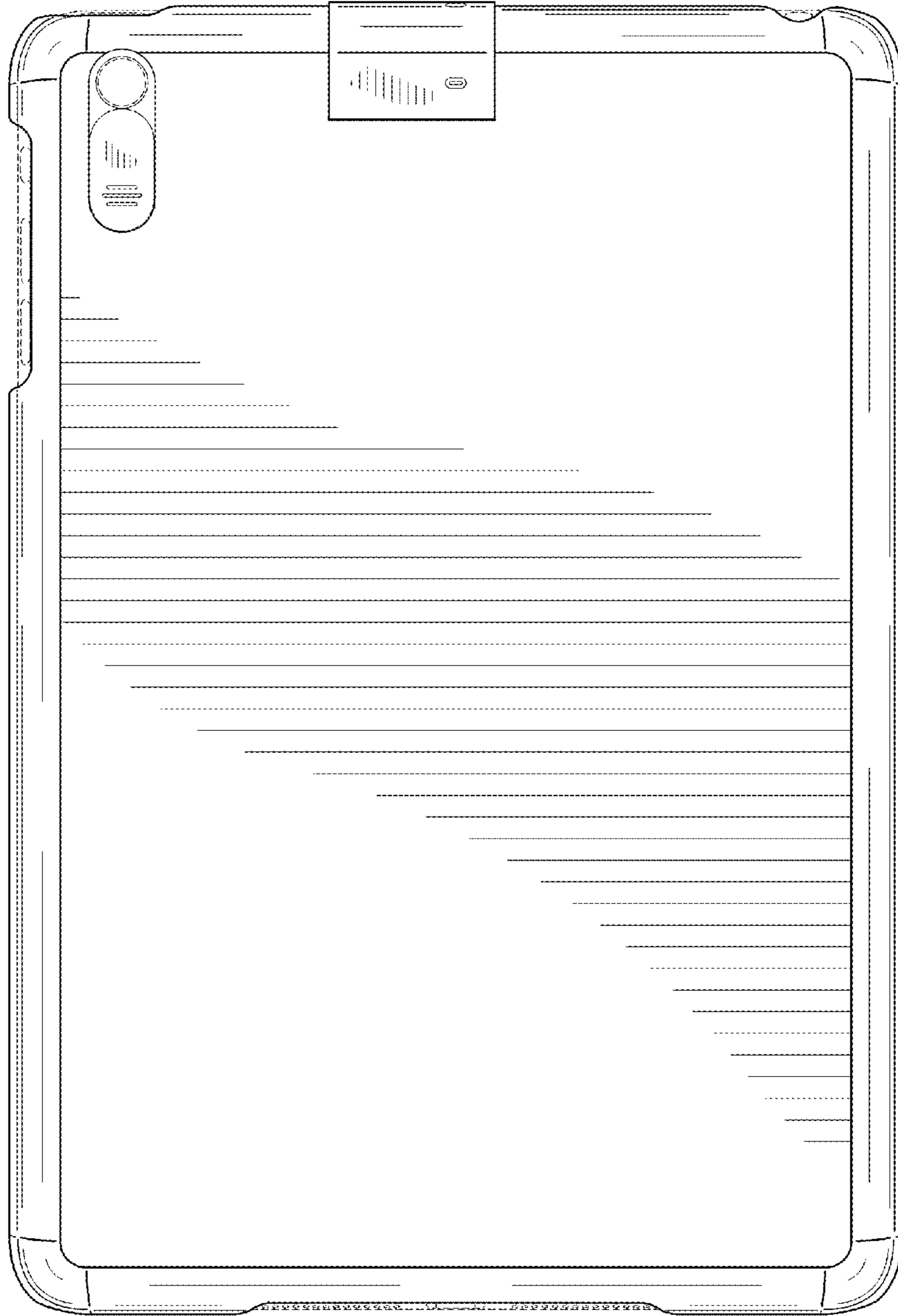

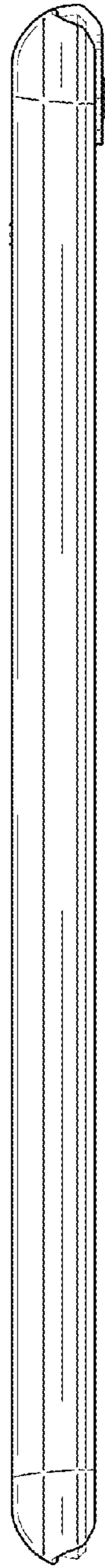

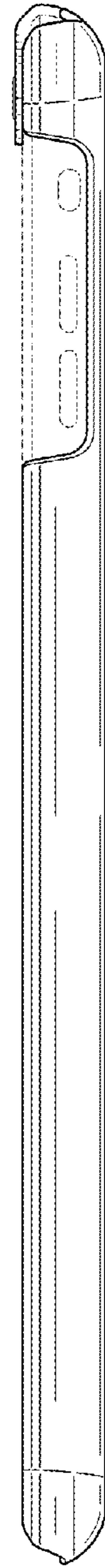

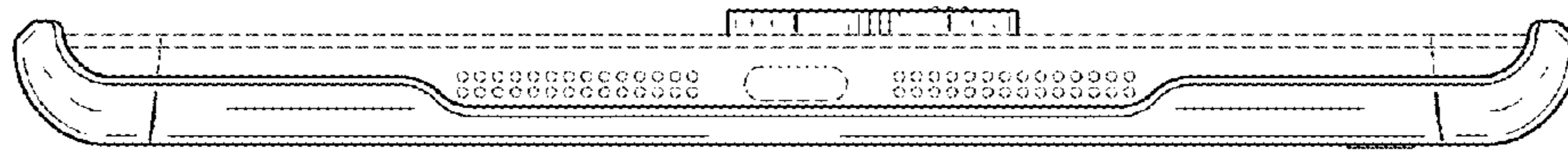

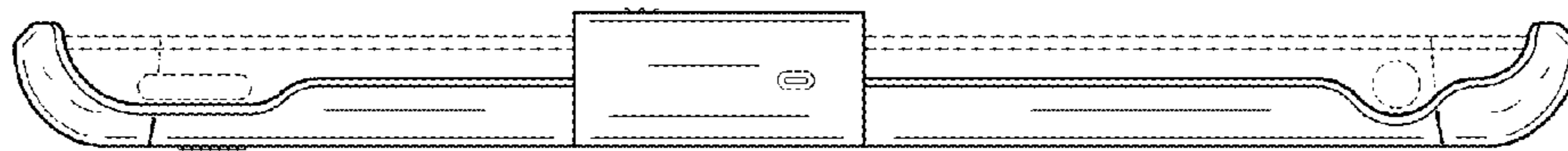
