The broken lines in the FIGURE show a display screen or portion thereof, and form no part of the claimed design.

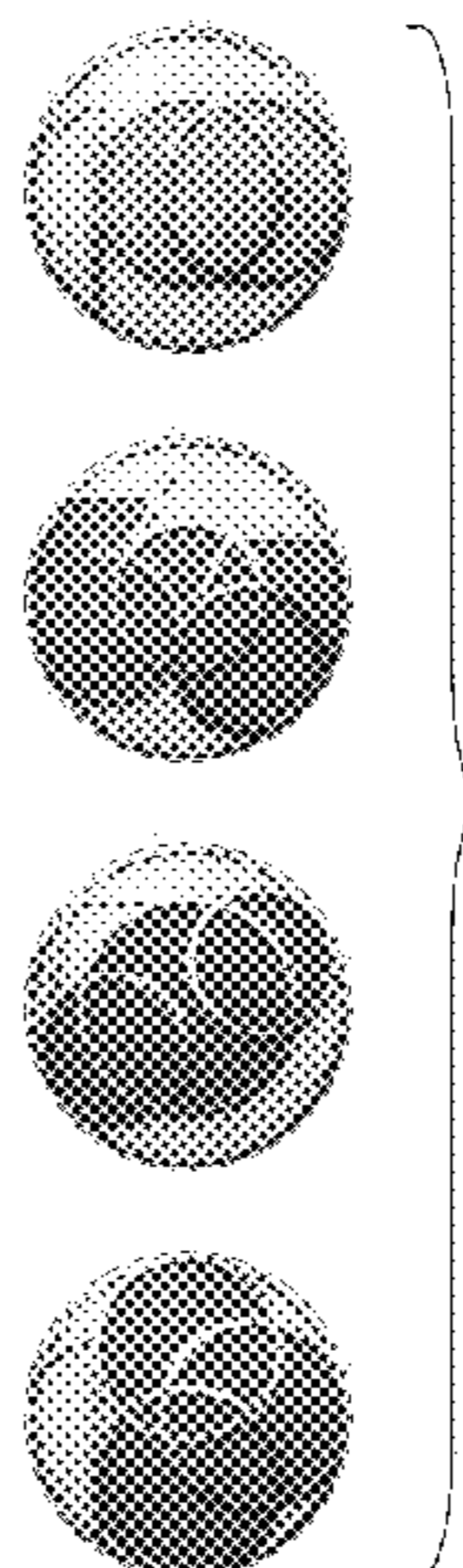
