DESCRIPTION

FIG. 1 is a front view of a motorized wire stripper showing my new design.

FIG. 2 is a rear view of a motorized wire stripper showing my new design.

FIG. 3 is an upper perspective view of a motorized wire stripper showing my new design.

FIG. 4 is a left side view of a motorized wire stripper showing my new design.

FIG. 5 is a right side view of a motorized wire stripper showing my new design.


FIG. 6 is a bottom view of a motorized wire stripper showing my new design.
















